LATTICE CHIRAL GAUGE THEORY W ITH FINELY-GRAINED FERM IONS

Abstract

We discuss the problem of form ulating the continuum limit of chiral gauge theories (GT) in the absence of an explicitly gauge-invariant regulator for the ferm ions. A solution is proposed which is independent of the details of the regulator, wherein one considers two cuto scales, f b, for the ferm ions and the gauge bosons respectively. Our recent non-perturbative lattice construction in which the ferm ions live on a ner lattice than do the gauge bosons, is seen to be an example of such a scheme, providing a nite algorithm for simulating GT. The essential di erence with previous (one-cuto) lattice schemes is clari ed: in our form ulation the breakage of gauge invariance is sm all, O ($\frac{2}{b} = \frac{2}{f}$), and vanishes in the continuum limit. Finally, we argue against 2-D m odels being signi cant testing grounds for 4-D regulators of GT.

Chiral gauge theories (GT) contain very interesting features which make them worth exploring non-perturbatively. The lattice provides an elegant method for gauge-invariant non-perturbative studies of non-abelian gauge eld interactions. Unfortunately, a lattice formulation of GT, suitable for computer simulations, has proven to be elusive, plagued by the infam ous ferm ion doubling problem [1]. The rem oval of the unphysical doubler modes from the spectrum requires explicit breakage of chiral gauge symmetry, or the introduction of new elds carrying the gauge charge. One must then take care to eliminate these undesired e ects in the continuum limit. For theories with a net gauge anom aly in the ferm ion representations this is indeed im possible.

In this paper, we discuss our recent lattice form lulation [2]. We rst explain the essential idea of using a two-cuto regulator, and then brie y review our implementation of this idea in a nite computational scheme. Finally, we compare with other proposals in the literature.

1 Two-Cuto Regulators.

We assume that we have a gauge-invariant regulator that cuts o non-abelian gauge boson momenta above $_{\rm b}$, while the regulator for the ferm ion bops (with cuto scale $_{\rm f}$) breaks chiral gauge symmetry explicitly. It is not in portant for now that the particular cuto method in question is the lattice. (Indeed we do not know of any continuum or lattice ferm ion regulator which is exactly gauge-invariant. The last reference in [1] provides good reasons why this should be so.). The usual choice is $_{\rm b} = _{\rm f}$, but we will soon see the virtue of taking $_{\rm f}$ b.

A fter form ally integrating over ferm ion elds in the path integral, we get

We have written the regulated chiral ferm ion determ inant as the exponential of the ferm ion one-loop e ective action, $_{\rm f}$ [A]. For simplicity we om it sources for external ferm ion lines in this discussion. They are treated fully in ref. [2]. The gauge boson measure is taken to include gauge- xing and ghost term s. On the lattice it is desireable to om it gauge- xing, but it will be easy to account for this once we understand the gauge- xed case.

The presence of the cuto makes $_{\rm f}$ [A] a gauge non-invariant functional of A, whereas gauge-invariance (BRST-invariance) is crucial for maintain-ing unitarity in the continuum limit $_{\rm f,b}$! 1. In particular, divergent

ferm ion loops can induce non-invariant e ects which survive in the lim it $_{\rm f}$! 1. These divergences are local in A and can be legitim ately sub-tracted (we will see that this is only true in a theory in which gauge anom a-lies cancel). We therefore assume that any necessary gauge non-invariant subtractions are already done in dening $_{\rm f}$, so that

How can we view this less familiar two-cuto scheme? In principle, one can integrate out the fermions between $_{\rm f}$ and $_{\rm b}$ only, thereby matching to a theory with a single cuto $_{\rm b}$, with a local elective lagrangian which is not gauge-invariant. However we know from our two-cuto analysis that for $_{\rm f}$ $_{\rm b}$ ($_{\rm f}$ appearing in the couplings of the one-cuto lagrangian now) the non-invariant terms in this elective lagrangian compensate for the gauge non-invariance of the cuto procedure to all orders when calculating amplitudes. In this matching the one-cuto gauge coupling at $_{\rm b}$, $g_{\rm b}$, is one-loop renormalized by the fermions integrated out between the two cuto s, so that

where g_0 is the two-cuto bare coupling in eq. (1). We can rewrite the partition functional in terms of g_b :

where we de ne a 'fully renorm alized' ferm ion e ective action

^R is nite as f! 1 with b xed, because its only divergence with f has been subtracted (the gauge non-invariant ones were already subtracted). In this form it is simple to see how the BRST invariance of the theory emerges in our continuum limit: one rst takes f! 1 so the resulting (nite) ^R is exactly gauge-invariant (since ^R and dier by a gauge invariant term.).

Now let us translate the above discussion to the case where there is no gauge- xing, by putting back the functional integration over the gauge orbits $fA_{\rm c}$ g,

The crucial new feature here is that the gauge-orbit integration has introduced a new eld (without a kinetic term at tree-level) into the partition functional. If $_{f}^{R}$ is not gauge-invariant, then $_{f}^{R}$ [A] is dependent on , and so the eld in general becomes a strongly interacting eld in the theory, as opposed to completely decoupling. Note that one can take the eld to transform under the gauge group, in which case the theory is exactly BRST-invariant, but it is not the BRST-invariant theory we wanted! It contains extra unwanted degrees of freedom. In our two-cuto continuum limit however, does decouple: taking the limit f! 1 first, we obviously get a nite R which is completely independent of .

2 A Lattice Im plem entation.

We implement the two-cuto idea by having the fermions live on a lattice with spacing f 1 = f and the gauge bosons live on a lattice with spacing b 1 = f and the gauge bosons live on a lattice with spacing b 1 = f. With f b. The full details were worked out in ref. [2]. Earlier related ideas were discussed in refs. [4][5]. Our target continuum theory consists of left-handed fermions, f, transforming under the gauge group, and an equal number of decoupled sterile right-handed fermions, R. Therefore the continuum fermion covariant derivative is given by

Our lattice regularization of the partition functional is given by

The lattice action for the gauge elds is entirely standard and gauge invariant: U (s) = e^{ibA} (s) is the gauge eld variable on the link (s;s + ^) of a regular lattice with spacing b, and $S_g[U]$ is the standard W ilson action [8]. We have not used any gauge- xing here. The ferm ions are however treated quite unconventionally. Their f-lattice nely subdivides the b-lattice, and the ferm ion elds action depends on the b-lattice gauge elds through a gauge eld, $u = e^{ifa}$ living on the links of the f-lattice. This f-lattice gauge eld, u, is not an independent degree of freedom in the path integral; it is a careful interpolation to the f-lattice of the b-lattice gauge eld U.

Before looking at the properties of the interpolation u [U], we clarify our de nition of [u] for arbitrary f-lattice gauge elds. The operators appearing in the determ inants are just the naive f-lattice versions of the corresponding continuum ones. The determ inants are then just ordinary nite determ inants (in nite volume). Form ally, if we send f to zero we see that we get the statem ent that the norm of the chiral ferm ion determ inant is just the determ inant for vector-like D irac ferm ions. This is an identity because the norm is the product of determ inants for the desired chiral ferm ions with that for the conjugate chiral ferm ions; the chiral ferm ions and their conjugates add up to a vector-like D irac representation. Thus form ally, as f ! 0 we have $e^{[a]} = det[i\hat{D}]$, as we should. For nite f we have a legitimate regulator [2] which separately regulates R e and Im (m agnitude and phase of e), corresponding to the parity-even and parity-odd parts of the e ective action. Earlier versions of this trick are in refs. [6][5][7]. This allows us to restrict the loss of gauge invariance due to the cuto, because it is well known from lattice-QCD how to gauge invariantly regulate vector-like determ inants while also elim inating the unwanted doubler poles in ferm ion propagators, by the addition of the gauge-invariant 'standard W ilson' term f D² (see [8]). Thus it is only Im that breaks gauge invariance: the doubler poles have been elim inated by addition of a chiral W ilson' term, f Q^2 [9]. Note there is no way to make this term gauge invariant (as expected from general argum ents) because, in the \hat{D} determ inant, $_{\rm L}$ transform s under the gauge group while the $_{\rm R}$ are singlets, and the W ilson term involves a chirality-ip.

An elementary power-counting [2] shows that

This is in agreement with the general considerations of the previous discussion: the term swhich do not vanish as f ! 0 should be local. Furthermore

they are parity-odd, because the parity-even part of has been gaugeinvariantly regulated. The unique such local functional (up to a constant factor, which we simply calculated) is

the relative coe cient between the two terms being xed by the Wess-Zum ino consistency condition [10] (i.e. the requirement that the RHS is a x of something). The consistent anomaly term cannot be eliminated by adding suitably chosen local counterterms to [u] because it is not the result of a x on any local functional. This is the signi cance of the gauge anomaly. The potentially large (O (1)) breakage of gauge invariance will how ever vanish when anomalies cancel among the ferm ion representations in L. We will assume this to be the case from now on, so that

Now let us take into account the fact that our f-lattice gauge eld is to be obtained by interpolating the b-lattice gauge eld. In ref. [2], inspired by ref. [11], we described how to do this, the interpolated eld m inim izing the (f-lattice) Yang-M ills action in each b-lattice hypercube subject to boundary conditions set by the b-lattice gauge eld values. The details are not important here. Instead we just note that the interpolation procedure enjoys the following properties [2]. (i) Gauge invariance: for any gauge transform ation on a b-lattice gauge eld U, there exists an interpolated gauge transform ation ! on u such that

Therefore if [u] is exactly f-lattice gauge-invariant, [u[U]] is exactly blattice gauge-invariant. (ii) Su cient smoothness: Of course [u] is only gauge-invariant up to O (f²), so in order for this to be true of [u[U]], the interpolation procedure must be smooth enough to not introduce powers of 1=f. (iii) Locality: the interpolation does not introduce any spurious singularities in b-lattice gauge eld momenta into [u[U]]. (iv) Lattice spacetim e sym m etries are respected. The existence of this interpolation com pletes our construction of the regulated partition functional in the two-cuto form.

Though we must choose chiral gauge representations with cancelled gauge anom alies, we will typically have global classical sym metries which are anom alous (such as baryon plus lepton number in the standard model). We have checked by a ferm ion one-loop lattice calculation that the associated currents obey the well-known anom abus W and identity up to O (f^2) [2]. The one-loop result becomes exact to all orders in our continuum limit because, again, integrating over gauge boson elds cannot eliminate the f^2 suppression. This is a proof of the non-renormalization theorem for the one-loop anom aly. Such anomalies are the basis for the non-perturbative phenomenon of ferm ion-num ber violation (such as standard model (B + L)-violation) [12]. In our scheme cluster decomposition of the full theory must be carefully used to obtain ferm ion-num ber violating amplitudes from the ferm ion-num ber conserving sector, where external ferm ions are easily treated [2].

In the discussion of section 1, we form ally considered the limit $_{\rm f}$! 1. Mathematically this was perfectly sensible, but in a nite computation we must keep f small but nite. We know that there is a su ciently small value of f=b for any particular amplitude one wants, but the question is how small? We just need to take f small enough so that we are insensitive to the 0 (f²) violations of gauge invariance. For example an induced non-invariant gauge boson mass term should have a coe cient of order f ²=b⁴. To be insensitive to this in a physical volum e L⁴, we need f=b² to be smaller than the infrared cuto , 1=L. We believe this is a reasonably conservative estimate, though it is possible that even for larger values of f=b, the theory is already in the \symmetric phase" in the sense of ref. [16]. This is well worth exploring.

There are two features of our scheme that require greater computational e ort compared with simulating vector-like theories such as QCD. They are the interpolation performed on each b-lattice gauge eld, and the calculation of the determinant of a larger matrix since the fermions live on a ner lattice than the gauge bosons. Since 4-D simulations are dicult, one might in agine that it is possible to test the method in 2-D models. The chiral Schwinger model has often been considered as a test ground for GT regulators [5][7][13][14]. However, we do not believe this provides a signi cant test for higher dimensions. 2-D is a very special case: instead of having gauge non-invariant e ects of O ($\frac{m}{b} = \frac{n}{f}$) as in 4-D, one has $g_0^m = \frac{n}{f}$ to all orders (since the coupling is dimensionful). This implies that all the nonanom alous chiral symmetries get restored in the continuum limit ! 1 in any one-cuto construction satisfying eq. (2).

3 D iscussion.

The essential improvement in our approach is that we have a regulated e ective action where gauge invariance is broken by a small amount. The idea that a small breakage of gauge symmetry should not be important in the continuum limit goes back to refs.[15][4]. Furthermore it has been tested in real simulations for a pure gauge theory [16]. The problem was however to clarify what was meant by a \small" breakage of the gauge symmetry. We have seen that in a one-cuto construction, the breaking at one loop is typically 0 (1= ⁿ), which is not in any sense small for gauge boson momenta of order the cuto. In our two-lattice form ulation, however, $(f=b)^2$ is the small parameter that controls the breaking of gauge invariance and can be made as small as necessary (obviously at some computational expense).

All previous proposals for regulating GT break the gauge symmetry or introduce extra degrees of freedom (eg. Higgs eld). The well-known W ilson-Yukawa models [17] essentially have a construction like eq.(6) with $_{\rm f}$ = $_{\rm b}$. These models have been extensively studied [18], with the result that there is no region in the phase diagram that succeeds in decoupling doublers and has charged chiral fermions in the spectrum. In light of the previous discussion, this is easy to understand: whenever doublers are decoupled, remains strongly coupled and only sterile composites are light. A similar problem a icts the proposal of Eichten and Preskill [19].

The bverlap' formulation of the chiral determ inant [13] satisfies eq. (2). But because the authors take f = b in their lattice proposal, beyond oneloop we expect there to be large deviations from the target theory as one attempts to take the continuum limit.

The so-called gauge xing' approach was introduced by the R om e group [9] and also considered for di erent ferm ion lattice actions in [20][7]. It corresponds to the form of eq.(1) with f = b. The eld is absent because of gauge-xing. The breakage of gauge invariance is not sm all, but a complete set of BRST-violating counterterms is tuned so as to restore the BRST-identities in the continuum limit. The existence of this construction is on a very solid footing to all orders in perturbation theory, but it is not yet clear how the scheme will work in practice, and whether it is truly non-perturbative in the face of G ribov am biguities in the gauge-xing procedure [21].

Recently there has been renewed interest [11][25][24] [14] in the old idea [22][23][5][4] of coupling interpolated lattice gauge elds to ferm ions regulated in the continuum, in an attempt to preserve chiral symmetries. This was triggered by 't Hooff's proposal [11] to preserve global chiral symmetries in vector-like gauge theories, using a Pauli-V illars regulator for the continuum fermions. In this case, the advantage of the Pauli-V illars regulator is clear: it does break the anom alous chiral symmetry, but it preserves the non-anom alous ones (in the context of QCD, for instance, pions would be exactly massless without the need for asymmetric counterterms). We want to stress how ever that, in dealing with GT, the important point in 't Hooff's proposal is not that the fermions live in the continuum, as is offen thought. A fiter all we do not know of any continuum gauge-invariant regulator for chiral fermions either. The point is that it permits the separation of the fermion and boson cuto scales ($_{\rm f}$ >> $_{\rm b}$), in such a way that the ratio of the two scales controls the breaking of the chiral symmetry. $^{\rm z}$

Refs. $[\beta]$ di er from all other proposals in that the gauge elds are regulated by a higher covariant derivative procedure. However the correct two-cuto limit is taken.
