# On the tensor form ulation ofe ective vector Lagrangians and duality transform ations

#### Abstract

$U$ sing two di erent $m$ ethods inspired by duality transform ations we present the equivalence betw een e ective Lagrangians for $m$ assive vector $m$ esons using a vector eld and an antisym m etric tensor eld. This com pletes the list of explicit eld transform ations betw een the various e ective Lagrangian $m$ ethods to describe $m$ assive vector and axial vector $m$ esons.


## 1 Introduction

D ual transform ations have been used to large extent to prove the equivalence of apparently di erent Lagrangian form ulations w th relevant consequences for solid state physics and gauge eld theories' '[i].

Self-duality has been proven form assive vector theories in odd dim ensions [2]; ] and their equivalence $w$ th topologically $m$ assive abelian gauge theory in $(2+1)-$
 mulation of various three-dim ensional eld theories have been studied in ['[4] and Ref. [6] therein.

D ual form ulation of some gauge eld theories in four dim ensions has been also considered [⿹\zh26灬, , ' 1 $[\bar{i}, 1,1 \overline{-1}])$. This was also used to prove the equivalence of the $T$ hirring $m$ odel to a gauge theory [9].]. The latter reference triggered the present work.

Recently, in the fram ew ork of chirale ective theories describing low energy strong interactions, a tensorial form alism to describe an ordinary vector eld has been developed in $[1 \overline{1} 0$ and tensor form ulation was done in [ $\left.\overline{1} \overline{1} \overline{1}_{1}\right]$ for the non anom alous sector of the low energy e ective action and in "[10

Various relations between param eters of the two form ulations were found as a phenom enological consequence of $Q C D$ dispersion relations. The equivalence of all the possible representations for $m$ assive vector elds in chiral Lagrangians was also con jectured in $\left[1 \overline{1} \bar{i}_{1}^{1}\right]$. For those transform ing as a vector gauge eld this was shown in $[1 \overline{1} \overline{1}]$ and the relation to the vector $m$ atter eld used here in ' $[1 \overline{1}]$.

In this letter we prove that a duallyy-type relationship connects the two di erent Lagrangian descriptions of the sam ephysics at the classical level. This im plies that the tensor and vector form ulations give rise to the sam e partition function and the equivalence betw een them holds in the sense of the path integral. Nevertheless, we do not consider the quantum level since in order to describe $m$ assive vector elds in a renorm alizable fashion we need to use the $H$ iggs $m$ echanism.

O ur transform ation also provides a sim ple way to obtain the form of term $s$ in the tensor form alism that are equivalent to those in the $m$ ore standard formulations. D uring the calculation it w ill also becom e obvious that there is no sim ple pow er-counting possible for them assive elds. In ourm ethod we explicitly show how the number of derivatives in interaction term $s$ can be changed. The general approach show s som e sim ilarity w ith the so called rst-order form ulation in which the eld strenght ( $F=@$ for spin 0 and $F=2 @_{[A]}$ for spin 1) is treated as an independent variable.

W e rst describe in detail the m ethod which is m ost easily generalized to term $s$ w ith powers of quark $m$ asses orm ore derivatives and then shortly describe the other $m$ ethod that leads to identical results. W e also present a few short com $m$ ents on phenom enological consequences.

## 2 The equivalence

The theory we are going to use describes an ordinary (not gauge) m assive vector eld interacting w ith pseudoscalar $m$ esons whose Lagrangian is explicitly bocal chiral invariant due to the addition of extemal sources.

W e refer for the nom enclature to the particular case which is thee ective eld theory of low energy QCD w th the inclusion of vectorm esons [İīi], although our derivation can be easily generalized.
$T$ he Lagrangian for the interacting vector eld $V$ is w ritten as follow s:

where < :: > stands for the trace over avour indices. The form alism used here is the one of [ 1112$]$. The current $J$ contains tw o term $S$ w ith couplings $f_{v}$ and $g_{v}$. In principle there are $m$ ore interaction term $s w$ ith extemal souroes which can appear at the leading order (ie. $O\left(p^{3}\right)$ ) and higher orders of the chiral expansion. It w ill be clear at the end how our analysis can be easily extended to a $m$ ore general form of the interaction Lagrangian. The elds $\ddagger$ and $u$ are de ned as

This guarantees that the full vector Lagrangian (ī) is local chiral invariant w ith the inclusion of the $m$ ass term for the vector eld.

In the case of a global chiral invariant form ulation the path integral for the vector Lagrangian (II), where the replacem ent D ! @ has been done, would be

where the transversality constraint @ $V=0$ reduces to three the number of independent degrees of freedom in four dim ensions. The transversality condition on the vector eld in (3+1)-dim ensions guarantees that it adm its a representation in term sof its dual antisym $m$ etric tensor eld as $V=@ H \quad$, which autom atically satis es the constraint @ $V=0$. The extension to bcalchiral invariance is $m$ ore delicate. In this case the correct dual transform ation is the one which does not break the hom ogeneous transform ation properties ( $\overline{\mathrm{B}}$ ) of the vector eld. A choige which reduces to the above one in the absence of other elds and sources is $V$ ' D H , where the tensor eld transform shom ogeneously like in ', ( $\overline{1}$ ).
$T$ he transversality constraint @ $\mathrm{V}=0$ is no longer autom atically satis ed. But at leading order in elds it is still @ $V=O\left({ }^{2}\right) \mathrm{w}$ ith any eld or source. $T$ he condition $V=D \quad H$ thus still rem oves one degree of freedom from the $V$ eld. The $m$ ost general partition function can be wrilten in term $s$ of the $m$ ost generaltransversality constraint (orgauge xing term) as

where $F[V]=0$ is consistent with the dual transform ation V $\quad$ D $H \quad . W e$ notioe that the di erence in the constraints @ $V=0$ and $V=D H$ doesn't a ect the interaction part of $!(1)$, while it acts at higher orders in the derivative expansion.

At the end of this section we brie y form ulate an altemative $m$ ethod to prove the equivalence. The constraint there $w$ ill be consistent $w$ ith the dual transfor$m$ ation of the type $V$ ' D H .

For the dual transform ation of the vector eld there are in fact two possibilities:

W e notioe also that the present dual transform ation is strictly valid only for $m$ assive vector elds where the $m$ ass plays the role of an infrared cuto of the theory. For an altemative $m$ ethod in (2+1)-dim ensions that also works in the $m$ assles case see $\left.{ }_{[1-9}^{[9}\right]$.

The two choioes in ( $\bar{T}_{1}$ ) correspond to two di erent assignem ents of parity transform ation property of the dualtensor eld. The vector eld $V$ is a $J^{P C}=$ 1 state i.e. $\mathrm{V}^{\mathrm{P}}=\left(\mathrm{V}\right.$ and $\mathrm{V}^{\mathrm{C}}=\mathrm{V}^{\mathrm{T}}$. This im plies that in choioe I) the
tensor eld is a vector-like eld for a 1 state, with $H^{P}=($ ) ( ) H and $H^{C}=H^{T}$. W hile in choice II) the tensor eld is an axiallike eld for a state 1 , with $\mathrm{H}^{\mathrm{P}}=(\mathrm{H})\left(\mathrm{Hr}\right.$ and $\mathrm{H}^{\mathrm{C}}=\mathrm{H}^{\mathrm{T}}$. In the case of axial vectors the choige is of course the opposite.

W e present the full derivation of the equivalence for the choige I), while for choice II) we shall point out di erences and the nal result.

For any of the tw o choices, we refer to choice I) from now on, the path integral $(\underset{1}{( })$ ) on the vector eld can be rew ritten as a path integral on the dualtensor eld due to the follow ing identity

At this levelwe have the problem that there is no explicit m ass term for the $H$ eld but there is both a two derivative and a four-derivative kinetic like term. $T$ he latter im plies the naive existence of a second pole. This one is at zero m ass, see below. T he underlying reason for the appearance of the extra pole is the presence of a derivative in the eld rede nition ofí (7). A constant eld H does not contribute to $V$. W e therefore would like to low er the num ber of derivatives in the kinetic term s .

W e can rem ove the rst term in ' $(\overline{1}(\overline{1} \bar{O})$ by adding a new auxiliary tensor eld in a way that leaves the original path integral invariant. This is sim ilar to the rst order form alism for gauge theories. W e can alw ays w rite

The path integral in $\left(\underset{-1}{\overline{1}} \overline{\bar{I}_{1}}\right)$ is equivalent to the one in $\left(\underline{\bar{q}_{1}}\right)$. They di er by an overall nom alization constant given by the gaussian integral over the auxiliary tensor eld $I$. Rede ning $I^{0}$ with a linear transform ation w ith unit Jacobian
the original path integral $(\underset{-}{9})$ is equivalent to the one where we add to $\mathrm{L}_{\mathrm{H}}$ the quadratic term

There is no kinetic term for the auxiliary eld I while it is coupled to the tensor eld $H$ via the last term in the rst line of ${ }^{\prime}(\overline{1}(\overline{1})$. At this stage both the elds H and I interact w ith extemal souroes. P aram eters ; can be chosen in order to elim inate unw anted interaction term s with derivative couplings on the tensor eld H. This im plies the choice

A s can be seen here we can choose to add interaction term s or not to ( $\left.\overline{1}_{\underline{2}}^{2}\right)$. The num ber of derivatives in the interaction term $s$ can thus be easily changed. This show s again that the usualchiralpower counting is not possible form assive elds.

A this point we show that a tw o-steps orthogonal transform ation of the tensor elds perm its to rew rite the two-tensors Lagrangian in term $s$ of rotated tensor elds which sim ultaneously are eigenstates of the kinetic operator and diagonalize the $m$ ass term. Since the jacobian of the transform ation is trivial the nal path integralw ill be equivalent to the original one.

The rst orthogonal transform ation ensures the diagonalization of the kinetic term. De ning the rotated elds as

In (1్̄̄) ve types of term $s$ appear in order: kinetic term $s, m$ ass term $s$, interaction term S for $G$ and $G^{0}$ individually, $G ;{ }^{0} \mathrm{~m}$ ixed term s and local or contact term s w th only extemal elds or the other degrees of freedom. T hese latter term $s$ are precisely the ones that in $[\underline{1} \overline{1} 1 \mathbf{1}]$ w ere required by the high energy constraints. In this approach they appear autom atically.

For a given choige of the rotation angle the kinetic term s of the two elds have opposite signs. T he choige of the correct relative sign ofkinetic and $m$ ass term $s$ is determ ined in the $M$ inkow ski case by the requirem ent that there be no tachyons in the nal theory. Hence, the physical solution has to be the one where the tensor eld w ith the unphysical (\w rong") sign in the kinetic term \decouples" in the sense that it acquires zero m ass and it does not interact w ith any other eld.

Choosing cos2 $>0$, this is alw ays allowed by $\overline{(\underline{1}} \overline{1})$, the rescaled $G$ and $G^{0}$ elds are de ned via the wave function renorm alization constant as:

A s we expected, the tensor eld which is m assive is the one with the correct relative sign for the kinetic and m ass term s (i.e. it has causal propagation), while the tensor eld w th the \w rong" sign assignem ent (ie. it has tachyonic propagation) rem ains $m$ assless and is the artefact expected from the transform ation
( IT1) $_{1}$. At the sam e tim e all the interaction term $s$ of the unphysical eld $I \mathrm{w}$ th extemal currents vanish as a consequence of eq. (2̄3̄) and the nal Lagrangian for the physical tensor eld I becom es

W e have shown that the vector Lagrangian $(\underline{1})$ in equivalent in the sense of the path integral and through the dual representation I) of ( $(\bar{i})$ ) to the tensor Lagrangian ( $(\overline{2} \overline{6})$ for a tensor vector-like eld describing a 1 state, where additional local term s (i.e. term s w ith extemal sources only) are present. T hese term s are precisely the ones whose presence was required by the constraints in $\left[1 i_{1}^{1}\right]$. U sing the values of and given by eq. '(1-14) the follow ing equivalence relation holds

For the choice II) of ( $(\underline{\bar{j}}, 1)$, where the dual tensor eld H is an axial-like tensor eld, we are also able to produce the equivalence of the vector Lagrangian '( $\overline{1}$ ) with a Lagrangian for an axial-like tensor eld describing a 1 state. Exactly the sam e procedure as before can be follow ed but using instead of $I ; I^{0} ; G ;::$ : the eldsI; $\mathrm{I}^{0} \boldsymbol{;}$; :: : w th

The tw o-steps diagonalization proceds as for choice I). E lim ination of unw anted interaction term swith derivative couplings leads again to the constraints ( $\overline{1} \overline{4} \overline{1})$ for and and the elim ination of non diagonal term $s$ induces again contraint $\bar{\prime}(\overline{1})$ on the param eter. Of the two nalm ass eigenstates only $I$ (the onew ith the correct sign of the kinetic term ) gets $m$ assive as before and the nal Lagrangian for the tensor eld $I$ follows

$N$ otice that the structure of the kinetic term corresponds to the case $\mathrm{a}+2 \mathrm{~b}=0$ in Appendix A of [ilill. The choice I) led to the case $b=0$. B oth choices are possible and lead to a good description for a vector $m$ eson. $N$ otioe that because of the opposite instrinsic parity required for case II) the interaction term $s$ also
contain an extra Levi-C ivita tensor. The signs of the interaction term s can also be changed by multiplying the dual transform ations of (īi) by 1 .

In the end we have four possibilities. C ase I) and II) and both w ith an extra $m$ inus sign in ( $(\bar{i}, 1)$. C ase I) corresponds to the case where the com ponents $I^{0 i}$, $i=1 ; 2 ; 3$, propagate in the rest fram $e$. Obtaining the correct parity for these requires I to have positive intrinsic parity as already rem arked above. In case II) are the com ponents $I^{i j}$, with $i ; j=1 ; 2 ; 3$, that propagate in the rest fram $e$. $T$ his in tum requires $I$ to have negative intrinsic parity so that the $I^{i j}$ can describe the propagating com ponents of a vector.

In all cases we proved the equivalence to the original vector Lagrangian in the sense of the path integral w th the addition of the SAM E set of local term s.
$T$ he altemative approach we $m$ entioned before is $m$ ore sim ilar to the well know nst-order form alism. In order to treat $V$ and $V$ as independent elds let us rew rite the partition function $\left(\frac{(\bar{\sigma})}{-1}\right)$ as

$T$ he integration over $V$ can be done sim ply if we integrate by parts in the last term. If the boundary condition ${ }^{R} d^{4} x<D \quad\left(\begin{array}{ll}\mathrm{x} & \mathrm{V}\end{array}\right)>=0$ is satis ed, which is obviously the case, this can be done. Then the integral over V reduces to a gaussian integraland the nalpartition fiunction is the one for a tensor Lagrangian

It is im mediate to verify that the choices $=\mathrm{m}=2$ reproduce choige I) of the previous approach w ith both possible signs for the interaction term S . The analogous procedure for choige (II) of ( $\overline{3} \overline{1} \overline{1})$ ) leads to the tensor Lagrangian of case II) of the rst approach.
$N$ otice that in both $m$ ethods the presence of the $m$ ass term in the original Lagrangian was crucial. In the rst m ethod it directly produced the nalkinetic term and in the second $m$ ethod it produced the quadratic part of the $G$ aussian integral. W ecould of course have expected this since in them assless case there is a singularity of the type $1=q^{2}$ possible while in the tensor form alism this singularity is at most q q = $q^{2}$ in interactions with other elds. In the approach of " $[9]$ the presence at interm ediate stages of inverse derivatives in the Lagrangian show s the sam e problem.

## 3 Some im plications of the equivalence

In $[1] 1 \overline{1} 1]$ relations am ong the param eters of the vector and tensor Lagrangians and constraints on the coe cients of additional local term s necessary to guarantee the equivalence of the two form ulations were found as an im plication of the correct Q CD behaviour through the use of subtracted dispersion relations. A ll the requirem ents found there on a m ore phenom enological ground are here autom atically im plied by the equivalence of the tw o Lagrangians in the sense of the path integral.

W e notioe rst that the two tensor Lagrangians obtained with choice I) or II) in ( $\bar{i}$, ) correspond to the two possible choices $a+2 b=0$ and $b=0$ in the appendix of tio 010 . These two choices of the param eters in the $m$ ost general tensor Lagrangian are all the possible ones which reduce from six to three the propagating com ponents of the tensor eld. In the case $\mathrm{b}=0$, which corresponds to choice I) in our form alism, the usual tensor Lagrangian for vectorm eson elds is w ritten in term s oftw o couplings $F_{v}$ and $G_{v}$ of the tensor eld to the extemal

where only the relative sign betw een $\mathrm{F}_{\mathrm{v}}$ and $\mathrm{G}_{\mathrm{V}}$ is xed due to the arbitrariness in (ī).

The other peculiarity concems the presence of localterm s (ie. term s containing only the other elds and currents) in the Lagrangian ("). It was already notioed in $\left[\begin{array}{ll}101 i_{1}\end{array}\right]$ that the equivalence requirem ent of the vector and the tensor form ulations im plied the presence of additional local term $s$ in the vector Lagrangian, which otherw ise did not reproduce the correct low energy lim it of the
pseudo-G oldstone bosons interactions (Chiral Perturbation $T$ heory). A gain this requirem ent is explained in term s of the path integral equivalence of the vector and tensor eld formulations.

Local term swhich guarantee the path integral equivalence of the vector and tensor Lagrangians are the last three term son the right hand side of $\left(\underline{2} \bar{\sim}_{-1}\right)$. W riting $\mathrm{f}^{+}$and u in term softhe extemal left and right-handed currents and the pseudoG oldstone boson eld as given in '(T) we get som e of the $O\left(p^{4}\right)$ term s of the CHPT Lagrangian $[1 \overline{1} \overline{4}]$ :

$T$ he $P_{i}$ are the usual term s of the $O\left(p^{4}\right)$ chiral Lagrangian $\left.\uparrow \overline{1} \overline{4}\right]$.
Referring to the conventional de nition of the coe cients of the O ( $p^{4}$ ) CHPT Lagrangian $\mathrm{L}_{1} ; \mathrm{L}_{2} ;:::: \mathrm{L}_{10} ; \mathrm{H}_{1} ; \mathrm{H}_{2}$ we nd that the path integral equivalence of vector and tensor $m$ odels a) xes the contribution of vector $m$ esons to som $e$ of the low energy coe cients and b) im plies relations am ong them. Both a) and b) classes of identities have been derived in other ways, but never proven at the form allevelas it is show $n$ here. The structure of the localterm in eq. (3̄à) in plies

The coe cient $\mathrm{L}_{10}^{\mathrm{V}}$ is also the coe cient ${ }_{10}^{\mathrm{II}}$ of $\left.{ }_{10} \overline{1} 1\right]$ of the same local term added to the vector Lagrangian in order to satisfy the equivalence with the tensor one.

The localterm in eq. (3̄7̄i,) can be reduced to a m ore fam iliar form via the use of SU (3) relations for avour traces' $1[1 /[1]$. Its structure im plies

Local term ( $\left.{ }_{3} \bar{O}_{-1}\right)$ xes the vector contribution to the low energy param eter $I_{9}$ (which also corresponds to the coe cient ${ }_{9}^{\text {II }}$ of the same local term in be:

W e thus derive the sam e relations as those obtained earlier.

## 4 C onclusions

In this letter we have shown explicitly the relation between a standard vector eld transform ing as a vector and as a antisym $m$ etric tensor eld. $W$ e can thus
im $m$ ediately obtain the Lagrangians that are exactly equivalent in both pictures. $T$ he relation of the vector representation used here to the $H$ idden gauge $m$ odel and others can be found in [1]in, ilīn].

The present work has added to the list of known eld rede nitions also the one that ends up with the tensor representation. The $m$ ethod here can be easily generalized to term $s$ that contain powers of quark $m$ asses and derivatives beyond those explicitly considered here, as well as to the "anom alous" or abnorm al intrinsic parity sector of vector $m$ eson Lagrangians. The extension to axial vector $m$ esons is sim ilarly trivial.
