Abstract

The p-adic description of Higgs mechanism provides excellent predictions for elementary particle and hadron masses. In this work the construction of p-adic eld theory limit of Quantum TGD is considered. Topological condensate de ned as a manifold obtained by gluing together p-adic spacetime regions with di erent values of p is identi ed as 'quantum average' space tim e de ned as absolute minimum of e ective action S_e associated with Kahler D irac action de ning con guration space geom etry. p-A dic spacetim e topology is ultram etric in accordance with the analogy with spin glass phase im plied by the vacuum degenerary of Kahler action. Symmetry arguments suggest that S_e in presence of ferm ion elds is just the super symmetrized K ahler D irac action. Super sym m etrization m otivated by N = 1 super sym m etry generated by right handed neutrino replaces H-coordinates with their super counterparts and requires color singletness of physical states appears as consistency condition. p-A dic D if $f (M^4)$ and canonical transform ations of C P₂ localized with respect to M 4 are approximate symmetries of the effective action and broken only by the non atness of the induced metric. Super gauge invariances in interior allow only massless many boson states with vanishing electroweak and color quantum numbers including graviton in accordance with the hypothesis that elementary particle quantum num bers reside on boundaries. Boundary components are idealized with world lines and K ac M oody D irac spinors used in m ass calculations describe the conform aldegrees of freedom of the boundary component. Perturbation theory in powers of p converges extrem ely rapidly: UV divergences are absent but natural infrared cuto is present.

1 Introduction

The p-adic description of Higgs mechanism provides excellent predictions for elementary particle and hadron masses (hep-th@xxx.lanlgov 9410058-62). The decription was based on rather general assumptions motivated by Quantum TGD.Canonical correspondence between p-adic and real num bers is an essential element of the model. p-A dic therm odynamics gives mass squared as a therm al expectation value and massivation results from the therm al excitation of Planck mass states. p-Adic length scale hypothesis states that fundamental basic length scales are given by $Lp = \frac{P}{p}L_0, L_0'$ $10^{\rm F}$ G and that physically most interesting primes correspond to 1:824 prim es near prim e powers of two. p-Adic super conform al invariance at boundary components together with the concept of Kac-M oody spinor are also cornerstone of the approach. The four-dimensionality of the algebraic extension allowing the existence of p-adic square root in the vicinity of padic real axis is essential element and this suggests that 4-dimensional padic conform al invariance m ight have key role in the the construction of padic eld theory lim it of TGD but it turns out that the actual approxim ate gauge symmetry in the interior of spacetime contains D if $f^4 (M^4)$ and is therefore much larger than the group of p-adic conform al transform ations $(C \text{ on f } (M^4))$. W hat remained lacking from the spectrum was graviton. This is understandable since only the boundary degrees of freedom of 3-surface were taken into account in the calculation and it is interior degrees of freedom, which correspond to gravitational interaction. The topological description of graviton em ission should be in term s of the decay of 3-surface via topological sum vertex rather than the decay of boundary component as in case of gauge interactions.

The study of the low energy eld theory limit \mathbb{P} itkanen_d] de ned as a second quantized eld theory inside p-adic convergence cube with side L_p provides the practical manner to calculate at energies below P lanck mass. This eld theory limit is essentially the p-adic version of the standard model understood in perturbative sense since gauge group and the spectrum of light states apart from some exotic states are identical. The construction of this theory demonstrates how p-adicity solves the divergence problems of ordinary QFT.

i) The construction of the momentum eigenstates involves elegant number

theory. The discretization of momenta caused by the nite size of the convergence cube implies automatically the absence of infrared divergences. ii) p-A dicity implies automatically the absence of ultraviolet divergences. Perturbation theory fails for certain critical size (L_p) of the p-adic convergence cube if self energy loops contain massless particles. p-A dic planew aves actually make possible to construct p-adic theory of integration and p-adic Fourier analysis, which is a central technical tool in the construction of the

theory.

The second step in the program is the formulation of p-adic eld theory lim it of TGD inside convergence cube of size L_p taking into account only boundary degrees of freedom and treating boundary components as point like objects but taking into account the conformal degrees of freedom of boundary component som ehow. The basic idea is to generalize the p-adic counterpart of the standard m odel to a second quantized eld theory using as basic elds K ac-M oody spinors rather than ordinary nite component elds and to deduce basic vertices from the requirements of gauge and conformal invariance.

The third step would be the formulation of eld theory description in length scales $L > L_p$. This theory is compeletely analogous to nonperturbative QCD describing hadrons as basic objects. An attractive possibility is that this theory can be constructed as second quantized theory in the discrete lattice form ed by p-adic convergence cubes (basic dynam ical objects) and that vertices are essentially the n-point functions of the eld theory inside single converge cube.

The fourth step would be the formulation of quantum eld description for gravitational interaction in terms of the interior degrees of freedom. One should also construct a description for the topology changing reactions p-adic cubes describing for instance hadron reactions.

During the work it has become clear that time is perhaps ripe for an attempt to formulate the general p-adic eld theory including both boundary and interior degrees of freedom. The construction could be based on the following basic ingredients.

a) Field theory limit is de ned as a purely ferm ionic QFT on quantum averaged spacetime de ned as an absolute minimum of e ective action: minimization involves also a variation in the degrees of freedom associated with 3-surface whereas in the de nition of K ahler function the absolute m inim um is de ned for the variations keeping the 3-surface xed. A verage spacetime depends on quantum state. The enorm ous vacuum degeneracy of K ahler action (any surface, which is submanifold of M⁴ Y²), where Y² is Lagrange submanifold of C P₂ having vanishing K ahler form) in plies analogy with spin glass phase and suggests ultrametricity of the elective spacetime topology. A very general realization of ultrametricity is provided by the concept of topological condensate de ned as a manifold obtained by gluing together spacetime regions with dierent values of p-adic prime p. The hypothesis about RG invariance of K ahler action and symmetry arguments suggest that elective action is just the supersymmetrized p-adic counterpart of K ahler D irac action de ning con guration space geometry.

b) Criticality suggests that e ective action allows p-adic conformal transformations of M⁴ as symmetries. A ctually K ahler action allows all dieormorphisms of M⁴ as symmetries in the excellent approximation that induced metric is at. Also the canonical transformations of CP₂ coordinates localized with respect to M⁴ coordinates are symmetries in same approximation in the interior of X⁴. Both symmetries become exact if one requires that the in nitesimal generators of these transformations annihilate physical states.

c) N = 1 supersymmetry generated by right handed neutrino is realized if one assumes that quantized H coordinates contains super part. In CP₂ degrees of freedom super symmetrization is defined in preferred CP₂ coordinates, for which the action of su(2) = u(1) is linear. These coordinates are determined up to a color rotation and internal consistency requires that physical states are color singlets (each p-adic region of spacetime is color singlet). This implies that H coordinate becomes dynamical quantum eld and gauge bosons and gravitons correspond to 2- and 4-ferm ion bound states respectively. N = 1 supersymmetry and closely related K appa symmetry make it possible to extend conform al symmetry to super conform al symmetry on boundaries. D if f (M⁴) and canonical transform ations have similar extension in the interior of X⁴.

d) In the interior of X ⁴ the quantization in ferm ionic degrees of freedom relies on the properties of p-adic planew aves. D if f (M ⁴) and local canonical invariance pose additional constraints on the states. D if f (M ⁴) invariance allow s m assless boson states annihilated by all D if f (M ⁴) generators except translations. G raviton is contained in the spectrum but m any ferm ion states are not possible in accordance with the basic assumption that partons cor-

respond to boundary components. p-A dic perturbation theory is free from UV divergences but infrared cuto is necessarily present.

e) The practical treatm ent of boundary components involves idealization to world line and the use of K ac M oody spinors to describe the vibrational degrees of freedom of boundary component. The assumption that Super V irasoro generators are sums of Super V irasoro generators associated with boundary component time coordinate and with 2-dimensional boundary component explains K ac M oody D irac equation used in the description of H iggs m echanism . C onform also (3;1), so (4) and su (3) are approximate symmetries in boundary degrees of freedom . Second quantization m ust be performed for K ac M oody spinors.

A lthough this rough general form ulation need not yet o er practical calculation receipes and need not even be correct, it makes possible to understand p-adic topology as a property of quantum averaged spacetime and demonstrates that p-adic super conform al invariance on boundaries, crucial for p-adic description of H iggs mechanism, is not in conict with the basic principles of TGD. In principle the form ulation o ers a possibility to derive vertices for simpler p-adic conform all eld theory limit form ulated in terms of K ac M oody spinors only and treating boundary components as point like objects. If the general form ulation is correct then the main unsolved technical problem is the construction of the interaction vertices for N-S and R am ond typer K ac M oody spinors.

The program of the work is following:

- a) The general ideas of Quantum TGD are described.
- b) p-A dic building blocks of the theory are described.

c) The concept of e ective action is de ned and the p-adization of spacetime

in terms of topological condensate concept is described.

d) The symmetries of the theory are discussed.

e) A formulation of eld theory limit in terms of p-adicized Kahler D irac action in the interior of X 4 is discussed in detail.

f) Appendix contains general form ulas for currents associated with symmetries.

2 Quantum TGD and p-adic eld theory lim it

In the following some basic facts about TGD are considered and shown to lead to quite unique general receipe for the construction of Q uantum TGD.

2.1 Construction of conguration space metric and spinor structure

The construction of Q uantum TGD reduces to the construction of geometry for con guration space consisting of all possible 3-surfaces in space H = M_{+}^{4} CP₂. W hat is needed is metric and spinor structure. The construction is based on the assumption that the geometry in question is K ahler geometry. This means that conguration space allows complex structure and metric can be expressed in terms of K ahler function. A further requirement is D if f (X⁴) invariance and this requires that the denition of K ahler function associates to a 3-surface 4-surface at which D if f⁴ can act.

The value of K ahler function for a given 3-surface X 3 is de ned as absolute m inim um of K ahler action in the set of 4-surfaces having X 3 as submanifold is de ned as M axwell action for M axwell eld de ned by induced K ahler form of C P₂. Action contains also C hem-Sim ons term associated with boundaries of 4-surface. D e nition associates to a given 3-surface the absolute m inim um spacetime surface identiable as 'classical history'. O ne interesting feature of the construction is that K ahler function de nes generalized catastrophe theory in conguration space (studied in the third part of the book). K ahler action is analogous to them odynam ic free energy and can have several extrem a and absolute m inim um requirement selects one of the extrem a just as m inim ization of free energy selects the therm odynam ic phase. The properties of absolute m inim um 4-surface can change discontinously along 'M axwell line' just as therm odynam ic phase transition occurs along M axwell line.

The de nition of spinor structure necessitates the de nition of anticom – muting gamma matrices. These are dened for a given X³ as linear superpositions of ferm ionic oscillator operators associated with second quantized D irac action for induced spinors in the classical space time surface X⁴ (X³). The action is just free D irac action on background dened by induced spinor connection in X⁴ (X³).

The proposed m one explicit construction of con guration space m etric is carried on the set of 3-surfaces belonging to 'lightcone boundary' M_{+}^{4} CP₂. The motivation is that D iff (X⁴) invariance dictates the metric from its initial values on light cone boundary. The generalized conform all structure of the light cone boundary having metric dimension 2 plus the assumption that metric allows in nite-dimensional K ac M oody symmetry (Lie algebra corresponds to the group of maps from M_{+}^{4} to su(3)) plays essential role in the construction. The conform all structure of light cone boundary and K ac M oody algebra structure should have some counterparts in the construction of conform all eld eld limit. It is to be emphasized that the construction of conform all eld eld limit. It is to be emphasized that the picture comes from various applications rather than from rigorous mathematical form ulation.

2.2 Som e basic properties of K ahler action

2.2.1 Criticality of the Kahler action

Quantum TGD should de ne a theory of everything. For instance, gauge couplings should be predictions of the theory. Kahler action contains Kahler coupling strength $_{\rm K}$ as free parameter and one should have some principle to determ ine the value of this parameter.

The key observation is that the vacuum functional of the theory is uniquely de ned as exponential of K ahler function from the requirement that two ill de ned determinants, namely the determinant of the conguration spacemetric and the G aussian determinant associated with perturbative functional integration around minimum of K ahler function cancel each other. The vacuum functional is analogous to thermodynamic partition function and K ahler coupling strength is analogous to temperature. Therefore a natural requirement is that the value of K ahler coupling strength $_{\rm K}$ is such that Q uantum TGD describes critical system.

The duality of CP_2 K ahler form supports the criticality hypothesis: in standard complex coordinates of CP_2 the geometric realization of duality transformation is as an orientation changing isometry $_1$ \$ $_2$. In certain N = 1 supersymmetric theories duality transformation relates strong cou-

pling phase for particles with weak coupling phase for magnetic monopoles. In self dual case coupling constant and action must be critical and particles and magnetic monopoles must be equivalent. The so called CP_2 type extrem als [Pitkanen_a] identieed as elementary particles can indeed be regarded as magnetic monopoles in homological sense. What is remarkable is that elementary particles create no long range $1=r^2$ type magnetic eld since magnetic ux ows in CP_2 degrees of freedom: this is possible by to the nontrivial homology of CP_2 . A los magnetic monopoles in ordinary sense are in principle possible but are not favoured by the minimization of K ahler action: magnetic $1=r^2$ eld gives positive contribution to the action whereas electric $1=r^2$ eld gives negative contribution and is therefore favoured.

2.2.2 Coupling constant evolution hypothesis

C oupling constant evolution hypothesis is based on the assumption that K ahler coupling strength is a xed point of coupling constant evolution and on the observation that K ahler action can be interpreted as EYM action for

induced gauge elds (electroweak gauge elds and gluons) and induced metric. Besides this one must include the eld de ned by induced gamma matrices = $_k$ @, which was identieed as a eld describing the presence of fermions in [Pitkanen_a]. It seems that this interpretation is not correct but that new boson eld is in question. The hypothesis gives nontrivial constraints between various coupling strengths in accordance with general features of the coupling constant evolution and p-adic eld theory limit should provide quantum level realization for the coupling constant evolution hypothesis. The criticality is expected to x the value of K ahler coupling strength as a quantity analogous to critical temperature so that in principle all coupling constants come out as predictions.

2.2.3 Vacuum degeneracy of Kahler action and canonical invariance

K ahler action allows enorm ous vacuum degeneracy: any 4-surface with CP_2 projection, which is Lagrange manifold is vacuum extrem al. Lagrange manifold is de ned as a submanifold of CP_2 with vanishing induced K ahler form with dimension d 2. Canonical transformations have K ahler form invariant and are obviously exact dynamical symmetries in vacuum sector.

The vacuum degeneracy in plies that the second variation of K ahler action, whose inverse would de ne propagator in the usual quantization, is highly degenerate. In fact, for the standard in bedding of M⁴ the lowest order term in action is fourth order in the deviation of CP_2 coordinates from constant values so that canonical quantization around at solution is not possible. In Quantum TGD this kind of quantization is not needed. If eld theory limit is de ned as a eld theory de ned on quantum averaged spacetime de ned by elective action this problem is not encountered Since CP_2 coordinates are treated classically they de ne external elds for the quantum theory formulated in terms of fermionic elds only. This is in accordance with the result of Quantum TGD that boson quanta correspond ferm ion-antiferm ion bound states on boundaries. The existence of long range classical gauge boson elds, in particular Z⁰ elds, have many applications in TGD Pitkanen_a] so that the appeareance of these elds in the formulation of quantum theory is a rather satisfactory feature.

The vacuum degeneracy makes TGD wish Universe analogous to spin glass phase. Ferm ions correspond to spins, induced gauge potentials and induced metric correspond to couplings between spins and the presence of vacuum degeneracy in plies that one must take average over a large number of vacuum con gurations with dierent gauge elds. Induced Kahler form is analogous to the frustration eld. Ultrametricity is the basic property of the con guration space for the minim a of elective action in spin glass phase. This suggests that the elective spacetime topology associated with elective action is ultrametric. p-A dic ultrametricy is especially attractive since it makes possible p-adic conform al invariance. The most general form of p-adic topology is obtained by gluing together p-adic regions of spacetime with dierent p-adic p along their common boundaries in a manner to be described later. Topological condensate is p-adic manifold :: < $p_1 < p_2$::: consisting of p-adic surfaces glued together along common boundaries with the property that the sizes of the surfaces form increasing hierarchy.

3 p-A dic building blocks

The construction of p-adic eld theory lim it necessitates the generalization of the basic tools of standard physics such as di erential and integral calculus, the concept of H ilbert space, R iem annian geom etry, group theory, action principles, probability and unitary concepts to p-adic context. The construction of all these tools relies heavily on the canonical identi cation of p-adic and real num bers.

3.1 Canonical identi cation

The canonical identication $x = \int_{m}^{p} x_{m} p^{n} 2 R_{p} ! \int_{m}^{p} x_{n} p^{n} x_{R} 2 R$ of p-adic and real numbers is the cornerstone of p-adic TGD. The success of the elementary particle mass calculations and the possibility to understand connection between p-adic and real probabilities suggests that canonical identication is related to some deeper mathematical structure. The following inequalities hold true:

where j_{R_p} denotes p-adic norm. These inequalities can be generalized to case of $(R_p)^n$ (linear space over p-adic numbers).

where the norm of the vector x 2 T_p^n is de ned in som emanner. The case of Euclidian space suggests the de nition

These inequilities resemble those satis ed by vector norm. The only dierence is the failure of the linearity in the sense that the norm of scaled vector is not obtained by scaling the norm of original vector. Ordinary situation prevails only if scaling corresponds to power of p.

These observations suggests that the concept of norm ed space or B anach space m ight have generalization and physically the generalization m ight apply to the description of highly nonlinear systems such as T G D. The nonlinearity would be concentrated in the nonlinear behaviour of the norm under scaling.

Amusingly, the p-adic counterpart of M inkow skian norm

produces nonnegative norm. C learly the p-adic space with this norm is analogous to future light cone.

3.2 Existence of square roots of p-adically real num bers and 4- and 8-dim ensional extensions of p-adic num bers

The existence of square root plays key role in various p-adic considerations.

a) The p-adic generalization of the representation theory of the ordinary groups and SuperK acM oody and SuperV irasoro algebras exists provided an extension of p-adic num bers allow ing square roots of p-adically real num bers is used. The reason is that the matrix elements of the raising and low ering operators as well as oscillator operators typically involve square roots. A loo the de nition of anticom muting G am mamatrix elds in the representations of SuperV irasoro algebra involves square root function $\frac{1}{Z}$ [Itzykson et al] of algebraically extended p-adic num ber.

b) The existence of square root is a necessary ingredient in the de nition of p-adic unitarity and quantum probability concepts.

c) p-adic R iem annian geom etry necessitates the existence of square root since the de nition of the in nitesim al length ds involves square root.

For p > 2 the m inim ald imension for the algebraic extension allowing square roots is D = 4. For p = 2 the dimension of the m inim al extension is D = 8. This implies that the dimension of the p-adic R iem annian geometries considered in the rst part of the paper is multiple of 4 or 8 depending on whether p > 2 or p = 2 so that p-adic R iem annian geometry gives very deep explanation for spacetime and imbedding space dimensions.

In p > 2 case the general form of extension is

where the condition $2^{2} = x$ for some p-adic number x not allowing square root as a p-adic number. For p m od 4 = 3 can be taken to be imaginary unit. This extension is natural for p-adication of spacetime surface so that spacetime can be regarded as a number eld locally. Imbedding space can be regarded as a cartesian product of two 4-dimensional extensions locally.

In p = 2 case 8-dimensional extension is needed to de ne square roots. The extension is defined by adding $_1 = 1$ i, $_2 = 2$, $_3 = 3$ and the products of these so that the extension can be written in the form

C learly, p = 2 case is exceptional as far as the construction of the conform al eld theory lim it is considered since the structure of the representations of V irasoro algebra and groups in general changes drastically in p = 2 case. The result suggest that in p = 2 lim it spacetime surface and H are in same relation as real numbers and com plex numbers: spacetime surfaces de ned as the absolute m inim a of 2-adiced K ahler action are perhaps identiable as surfaces for which the imaginary part of 2-adically analytic function in H vanishes.

The physically interesting feature of p-adic group representations is that if one doesn't use $p \bar{p}$ in the extension the number of allowed spins for representations of SU (2) is nite: only spins j < p are allowed. In p = 3case just the spins j = 2 are possible. If 4-dimensional extension is used for p = 2 rather than 8-dimensional then one gets the same restriction for allowed spins.

3.3 p-A dic spacetime and topological condensate as generalized manifold

p-A dic topology and di erentiability rather than ordinary topology and differentiability are useful concepts above some length scale L_0 of the order of 10^4 P lanck lengths as suggested by them ass scale argument. The p-adic realization of the Slaving P rinciple suggests that various levels of the topological condensate correspond to di erent values of p-adic prime p: the larger the

length scale the larger the value of p and the course the induced real topology. If the most interesting values of p indeed correspond M ersenne primes the number of most interesting levels is nite: at most 12 levels below electron length scale: actually also primes near prime powers of two seem to be physically important. A coording to the experiences achieved from the study low energy eld theory limit and contrary to the original expectations, $L_p = \frac{P}{p}L_0$ serves as infrared cuto rather than ultraviolet cuto for the p-adic eld theory. If length scale resolution is larger than L_p ordinary real physics should be an excellent approximation.

The existence of p-adic de nite integral (relying on the canonical identication between p-adic and real numbers) and of p-adic valued inner product makes possible to de ne the concept of R iem annian metric and related structures on spacetime surface and the concept of submanifold with induced metric and spinor structure makes sense. Basic symmetry groups (in particular, Poincare group) acting as isometries of the imbedding space have p-adic counter parts. It is possible de ne variational principles for the elds de ned in p-adic spacetime using p-adization of ordinary real action principle and the minimization of the K ahler action leads to the p-adic counterparts of eld equations having same form as in real case.

The p-adic realization of the topological condensate concept requires rather general manifold concept. This manifold has locally p-adic topology but decomposes into regions with di erent values of p-adic prime p. These di erent regions are glued together along their boundaries. The mathematical description of the gluing operation for two p-adic topologies with di erent values of p is based on the use of canonical identication map. W hat is involved is the identication map identifying the boundaries of regions with topologies p_1 and p_2 . A possible manner to perform this identication is via two steps:

a) The points x_{p_1} of $R_{p_1}^n$ (region of boundary is subset of R_{p-1}^n) are mapped via canonical identication to the points of $R^n: x_{p_1} ! (x_{p_1})_R$.

b) These points of Rⁿ are expressed using p_2 -adic pinary expansion and mapped via the inverse of the canonical identi cation map to Rⁿ_{p2}, which is two valued for real numbers with nite number of p_2 -nary digits.

A more general but essentially equivalent manner to describe gluing operation is to map the common boundaries ofp_1 -and p_2 -adic regions to regions of R^n and to identify these two regions of R^n with dimensional invertible map. The possible dimension in the construction are related to the nonuniqueness of the inverse of the canonical identication map in plying that real numbers with nite number of pinary digits have two inverse in ages.

The construction generalizes to the gluing together p-adic submanifolds of H. For p_1 and p_2 imbedding space is regarded as p_1 and p_2 -adic manifold respectively. W hat is required is that the real counterparts for the imbeddings space points associated with identi ed boundary points are identical. This means that the condition

holds true. For large values of palready the lowest pinary digit gives an excellent discretization of the p-adic convergence cube and in this approximation the conditions de ning gluing are rather simple num erically. A nalytically the gluing conditions do not look tractable.

3.4 p-A dic unitarity and probability concepts

p-Adic unitarity and probability concepts lead to highly nontrivial conclusions concerning the general structure of the S-m atrix. S-m atrix can be expressed as

for $p \mod 4 = 3$ allowing in aginary unit in its four-dimensional algebraic extension. Using the form S = 1 + iT, T = 0 (p^0) one would obtain in general transition rates of order inverse of P lanck m ass and theory would have nothing to do with reality. Unitarity requirement in plies iterative expansion of T in powers of p (P itkanen_d] and the few lowest powers of p give extremely good approximation for the physically most interesting values of p.

The relationship between p-adic and real probabilities involves the hypothesis \mathbb{P} itkanen_d] that transition probabilities depend on the experimental resolution. Experimental resolution is defined by the decomposition of the

state space H into direct sum $H = H_i$ so that experimental situation cannot di erentiate between di erent states inside H_i. Each resolution de nes di erent real transition probabilities unlike in ordinary quantum mechanics. Physically this means that the experimental arrangements, where one monitors each state in H_i separately di er from the situation, when one only looks whether the state belongs to H_i. O ne application is related to the momentum space resolution dependence of the transition probabilities. More exotic application [P itkanend] is related to Z⁰ decay widths: the total annihilation rate to excotic lepton pairs (unmonitored) is essentially zero: if one would (could) monitor each excotic lepton pair one would obtain simply sum of the rates to each pair.

3.5 p-A dic therm odynam ics and transition probabilities

The p-adic eld theory lim it as such is not expected to give a realistic theory at elementary particle physics level. The point is that particles are expected to be either massless or possess P lanck masses. The p-adic description of H iggs mechanism documented shows that p-adic therm odynamics provides the proper form ulation of the problem. W hat is therm alized is V irasoro generator L_0 (m ass squared contribution is not included to L_0 so that states do not have xed conform alweight). Temperature is quantized purely number theoretically in low temperature lim it (exp(H=kT) ! $p^{L_0=T}$, T = 1=n): in fact, partition function does not even exist in high temperature phase. The extrem ely sm all mixing of massless states with P lanck mass states in plies massivation and predictions for elementary particle masses are in excellent agreement with experimental masses. Therm odynamic approach also explains the emergence of the length scale L_p for a given p-adic condensation level and one can develop argum ents explaining why primes near prime pow-ers of two are favoured.

In the calculation of S-m atrix therm odynam ics approach should work also. W hat is is needed is therm odynam ical expectation value for transition amplitudes squared over incom ing and outgoing states. In this expectation value 3-m om enta are xed and only m ass squared varies.

3.6 p-A dic cancellation of UV divergences

p-Adic cancellation of the ultraviolet divergences is based on very simple observations. The necessary infrared cuto L_p implies infrared cuto and discretization for momentum: what one has is just quantum eld theory in nite 4-dimensional box. Loop integrals over the loop momenta are replaced by sum mation over momenta and for a given value of the propagator expression one always gets integer valued degeneracy factor N giving the number of momentum combinations giving rise to this particular value of the propagator expression. Since integer has always p-adic norm not larger than one this means that the sum mations over the loop momenta converge trivially provided the integers N are nite.

For standard M ⁴ m etric it was found that for spacelike propagator m om entum P_{in} the degeneracy factor N = N (P_{in};k) is for certain values of propagator m om entum k² in nite as real number and although the p-adic norm of N (P_{in};k) is not larger than one it is ill de ned p-adically. It was found that the gravitational warping of the standard in bedding of M ⁴ (C P₂ coordinates cease to be constant and C P₂ projection of spacetime becomes geodesic circle) to at nonstandard in bedding transforms the induced m etric m to m p²K R²P P, where P is the total m om entum associated with the p-adic convergence cube. Replacing the standard inner product for m om enta with the inner product de ned by the warped m etric the degeneracies associated with the p-adic propagator expression become nite.

The necessity to take into account the gravitational warping of the at spacetime means that one cannot totally neglect the action of the ferm ionic matter on the background spacetime geometry. The back-reactions related to other conserved charges are also expected to be present but one might hope that these e ects are small. In principle one can take into account back reactions exactly by interpreting eld equations as expectation values between various states. In particular, H -coordinates can depend on various conserved charges besides four momentum, boundary components serve as sources of classical gauge elds, etc..

3.7 p-Adic Fourier analysis

The de nition of p-A dic integration is based on two ideas. The ordering for the limits of integration is de ned using canonical correspondence. x < y holds true if $x_R < y_R$ holds true. The integral functions can be de ned for Taylor series expansion by de ning inde nite integral as the inverse of the di erentiation. As far as physical applications is considered this de nition does not seem to be the correct one since p-adic plane waves are not analytic functions exp (ikx) have unphysical properties and orthonorm alization does not have seem any obvious physical meaning. For p-adic planew aves orthogonalization is natural in light of their periodicity properties. Therefore in the sequel all functions are assumed to be expressible as p-adic Fourier series using p-adic plane wave basis whose detailed de nition is given in \mathbb{P} itkanen_d]. In the region 0 x_R (p 1) the basis functions are given by

In smaller regions 0 (x x_n)_R (p 1)=p the same functional form applies expect that p-adic k is scaled to k=p. One can associate with the on coordinate $x_n = n$ of this region p-adic planewave with momentum so that one obtains planewaves with momenta m=p + k, m; k = 0; :::; p 1. This process of going to smaller and smaller length scales can be continued inde nitely and one obtains p-adic planewaves with infrared cuto in momentum. Momentum eigenstate basis has as its real analog so called wavelet basis [C om bes et al]: this basis has been found to be especially e ective in the num erical treatment of wave equations.

p-A dic planew aves satisfy periodic boundary conditions $f_k(0) = f_k(p = 1) = 1.0$ ne can de ne also p-adic planew aves satisfying antiperiodic boundary conditions as square roots of p-adic planew aves for odd values of m om entum k. The square root indeed exists for the extension allow in square root of real p-adic num ber. These two kinds of planew ave basis are essential for the realization of R am ond and N-S type representations of Super V irasoro.

The orthonorm alization of p-adic planew aves gives de nition of p-adic integration in the range (0; p 1). A llother p-adic planew vaves except constant k = 0 planew ave have vanishing integral. Constant planew ave gives integral, which can be chosen to be some constant. This de nition of integration is of central importance in the formulation of variational principles based on Lagrangian density.

A though p-adic planew aves are real they allow com plex conjugation type operation de ned by k ! k.p-A dic planew aves possess infrared cuto and this means that p-adic momentum k can have only a nite number of nonnonnegative pinary digits whereas $k = k (p - 1) (1 + p + p^2 + ...)$ has in nite number of pinary digits. Therefore only positive values of k appear in the Fourier expansion of any function f and the conjugate of f appearing in the de nition of the inner product do not belong to the H ilbert space in question so that Hilbert space and its dual are not identical for p-adic planewaves. For higher dimensional p-adic planewaves all momentum components have nite num ber of pinary digits and this in plies som e new features in quantization. For instance, for ferm ion eld positive energy modes creating ferm ions have p-adic m om enta have $k_i > 0$ for each i w hereas negative energy m odes destructing antiferions have p-adic m om enta $k_i < 0$ for each i. The generalization of positive/negative energy concept to all momentum components makes possible to realize approximate D if $f (M^4)$ invariance in a nontrivial m anner.

There is problem related to the de nition of derivative forp-adic planew ave. p-adic planew ave is not di erentiable in ordinary p-adic sense. The analogy with real planew aves

which how ever does not exist p-adically. There are several manners to avoid the problem . Consider rst the tricky manners:

i) De ne as the p-adic counterpart of real obtained via the canonical

identi cation. The presence of the imaginary unit is troublesom e since padic planew aves are real in the ordinary sense.

ii) D e ne ln (a) as the p-adic counterpart of ln (a_R) de ned by the canonical identi cation. In this case one avoids in aginary units.

N either of these tricks is needed in the form ulation of the p-adic eld theory lim it of TGD since the action is well de ned apart from a proportionality factor ln (a) $^{\rm D}$, D = 4 in interior and D = 3 on boundaries and by de ning the interaction measure dx to be proportional to 1=ln (a) for each coordinate x^k the action becomes independent of ln (a). This is seen by following arguments:

a) For surfaces representable as maps from M 4 to C P₂ (the restriction is not essential) C P₂ coordinates must allow p-adic Fourier expansion and therefore C P₂ part of the induced m etric is necessarily proportional to ln (a)². The sam e must be true for M 4 part of the induced m etric and the imbedding is of the follow ing general form

The form of M⁴ coordinate does not lead to di culties since metric of H does not depend on M⁴ coordinates and m^k appears only in p-adic planewaves $\exp(p_k m^k) = a^{kp_k x^k}$. In M⁴ coordinates p-adic planewaves are form ally sim - ilar to ordinary planewaves.

b) A loo the super symmetrization of K ahler action to obtain elective action is possible by the replacement h^k ! h^k_S h^k + ^k. The supersymmetrized planewaves exp($m^k_S p_k$) are well dened

b) Induced spinor connection is proportional to ln (a) and in D irac operator ln (a) dependences com ing from induced gam m a-m atrices and covariant derivative cancel each other. K ahler D irac action density is proportional to ln (a)^D, D = 4 (3) in interior (boundary) and by de ning coordinate di erential dx^k so that it contains ln (a) factor one obtains com pletely well de ned action density.

4 Length scale hypothesis

p-A dic length scale hypothesis states that the length scales $L_p = {}^p \overline{p} L_0$ associated with primes near prime powers of 2, especially Mersenne primes are physically especially interesting. The results of the mass calculations give convincing support for the hypothesis and explain the emergence of L_p for a given p in terms of p-adic therm odynam ics for Super V irasoro representations. There are also m any arguments giving partial explanation for Mersenne primes and primes near prime powers of two. In the following one of the arguments for believing that primes near prime powers of two are physically most interesting is produced and the physical interpretation of L_p and L_0 is considered.

4.1 Length scales de ned by prime powers of two and Finite Fields

M ersenne prim es ought to be physically especially interesting prim es by argum ents relying on 2-adic fractality. Above M $_{127}$ there is extrem ely large gap for M ersenne prim es and this suggests that there must be also other physically important prim es. Certainly all prim es near powers of 2 de ne physically interesting length scales by 2-adic fractality but there are two m any of them. The rst thing, which com es into m ind is to consider the set of prim es near prim e powers of two containing as special case M ersenne prim es. O ne can indeed nd a good argum ent in favour of these length scales, which play central role in the p-adic description of H iggs m echanism .

TGD Universe is critical at quantum level and criticality is related closely to scaling invariance. This suggests that unitary irreducible representations of p-adic scalings x ! $p^m x, m 2 Z$ should play central role in quantum theory. Unitarity requires that scalings are represented by a multiplication with phase factor and the reduction to a representation of nite cyclic group Z_m requires that scalings x ! $p^m x, m$ some integer, act trivially. In ordinary complex case the representations in question correspond to phase factors $_k (x) = jx j^{(\frac{jk}{m}(p))} = \exp(i\ln(jx)) \frac{k^2}{\ln(p)}), k 2 Z$ and the reduction to a representation of Z_m is also possible but there is no good reason for restricting the consideration to discrete scalings.

a) The Schrodinger amplitudes in question are p-adic counterparts of

ordinary complex functions $k(\mathbf{x}) = \exp(i\ln(j\mathbf{x}))k\frac{jk^2}{\ln(p)})$, k 2 Z. They have unit p-adic norm, they are analogous to planewaves, they depend on p-adic norm only and satisfy the scaling invariance condition

where n(x) is integer (the exponent of the lowest power of p-adic number) and $k = 0;1; \dots; m$ 1 is integer. The existence of the functions is however not obvious. It will be shortly found that the functions in question exist in p > 2-adic for all m relatively prime with respect to p but exist for all odd m and m = 2 in 2-adic case.

c) If m is prime (!) the functions $K = {}_k$ form a nite eld G (m;1) = Z_m with respect to p-adic sum de ned as the p-adic product of the Schrödinger am plitudes

So, if the proposed Schoolinger am plitudes possessing de nite scaling invariance properties are physically important then the length scales de ned by the prime powers of two must be physically special since Schrodinger am – plitudes or equivalently, the p-adic scaling momenta k labeling them, have natural nite eld structure. By Slaving Hierarchy Hypothesis also the p-adic length scales near prime powers of two (and perhaps of prime p > 2, too) are therefore physically interesting.

As shown in Pitkanen_e], for p > 2 only those nite elds G (p₁;1) for which p_1 is factor of p = 1 are realizable as representation of phasefactors whereas for p = 2 all G (p₁;1) allow this kind of representation. Therefore p = 2-adic numbers are clearly exceptional. In p-adic case the functions $_p(x; p ! p_1)$ give irreducible representations for the group of p-adic scalings $x ! p^m x, m \ 2 \ Z$ and the integers k can be regarded as scaling m on enta. This suggests that these functions should play the role of the ordinary m o-m entum eigenstates in the quantum theory of fractal structures. The result motivates the hypothesis that prime powers of 2 and also of p de ne physically especially interesting p-adic length scales: this hypothesis will be of utm ost importance in future applications of TGD.

The ordinary p-adic planew aves associated with translations can be constructed as functions $f_k(x) = a^{kx}$, k = 0; ...; n, $a^n = 1$. For p > 2 these planew aves are periodic with period n, which is factor of p 1 so that wavelengths correspond to factors of p 1 and generate nite number of physically favoured length scales. These planew aves form nite elds for prime factors n of p 1.

There are also additional arguments supporting the special role of primes near prime powers of two.

a) If 2-adicity is fundam ental then 2-adic therm odynam ics in plies tem perature quantization in the form $\exp(1=T)$! 2^n . An interesting possibility is that the allowed 2-adic tem peratures are not only integers but also primes: $n = p_1$. If for p-adic primes p Boltzm ann factor is as near as possible to an allowed 2-adic Boltzm ann factor: $\exp(T)$! $p^n = 2^{p_1}$, one obtains $p = 2_1^p$. b) Fast Fourier transform is fastest, when the number of wavevectors is power of two so that spacetime volume has size $2^m L_0$, where L_0 is discretization interval.

4.2 Physical interpretation of L_p

The tentative interpretation of L_p proposed in Pitkanen_b] was as a lower cuto length scale for p-adic eld theory. The study of the low energy eld theory counterpart of p-adic TGD P it kanen_d how ever dem onstrated that L_p is in fact infrared cuto and UV divergences cancel without any momentum cuto . This results give justi cation for the basic TGD eish picture of the topological condensate. p-A dic convergence cubes of size L_p are the p-adic version of topological eld quanta introduced in Pitkanen, and in certain sense largests 3-surfaces possible at a given p-adic condensation level. The topological condensation at level $p_1 > p$ is possible and at this level these structures become particles perhaps describable using eld theory approach below length scales L_{p_1} . Therefore the original assumption is correct only in the sense that L_p is a natural lower cuto length scale at level L_{p_1} , when extended objects are treated as point particles. One must also consider the possibility that the formation of larger structures by gluing p-adic convergence cubes together by tubes connecting together neighbouring boundaries. Thism echanism is in fact in key role in the suggested hadron physics, nuclear physics and condensed matter applications of p-adic TGD (see the third part of the book). For instance, the color ux tubes connecting valence quarks can be identi ed as pin along boundaries bonds.

There is also a second, purely kinem atical, length scale generation m ech-anism: the construction of p-adic planew aves \mathbb{P} itkanen_d] dem onstrated that there is a preferred set of p-adic wavelengths, which are proportional to the factors of p 1, whose number is relatively small for the physically most interesting primes p.

Length scale hypothesis leads to a picture of the topological condensate as more or less hierarchical structure consisting of almost at 3-surfaces $:::< p_1 < p_2:::obeying e ective p-adic topology so that the size of the surface$ increases with p and has rough order of magnitude given by L_p. This concept of 3-space replaces ordinary 3-space with m any sheeted structure. Forinstance, ordinary m acroscopic bodies can be regarded as 3-surfaces, whoseouter boundaries correspond to the surface of the body and boundaries arepossible even in the astrophysical length scales.

An obvious question is what happens above the length scale L_p . a) p-A dic eld theory description certainly fails. The application of the length scale hypothesis in condensed m atter length scales suggests that upper bound for the size of the 3-surface at condensate level p is typically of order $10^2 L_p$. For nuclei and hadrons the length scale is of order few L_p .

b) The basic condensation level for atom s is p' 2^{k} , k = 131 and L₁₃₁ is about one half of Bohr radius of hydrogen atom. The p-adic counterpart of the hydrogen atom seems to dier in many respects from real hydrogen atom. Coulomb potential contains factor 1=2 coming from the Fourier transform of photon propagator and is not p-adically well de ned since e^2 is certainly rational so that one must work in momentum space and use discrete padic planew aves. Because of the standard expression for the energy levels of hydrogen atom does not make sense p-adically. The p-adic versions of the spherical harm onics do exist (as hom ogenous polynom ials of coordinate variables) and states with de nite J provide a good ansatz for Schrodinger equation. There are number theoretic problem swith the de nition of energy E = ME. The point is that rest mass de ned as the square root of M² therm all expectation value for electron at k = 137 level need not exist: the reduction of p-adic Schrodinger or D irac equation to the standard form however requires this. It is unclear whether the energies are su ciently close to the energies of the real hydrogen atom . All this suggests that real Schrodinger equation provides the correct description of hydrogen atom . d) Q uite generally the success of the real physics in long length scales suggests that p-adicity is not important in length scales above L_p . The generation of lattice structures in condensed matter physics might be regarded as a direct manifestation of underlying p-adicity (basic structural unit being padic converge cube of size L_p) although real physics gives a good description of the situations.

A llthis suggests that although the p-adic condensation levels obey p-adic topology also in length scales $L > L_p$ real physics must provide an excellent description of physics in length scales $L > L_p$ and that p-adicity becomes im - portant only below $L < L_p$. The only manner to avoid contradiction is that ordinary real physics works, when the length scale resolution is L_p , which in num erical practice means discretized physics using rational numbers. In the more form allevel this means that the elective action associated with action obtained by functionally integrating in K ahler action degrees of freedom with real topology. This hypothesis is in accordance with the fact that real conti-

nuity in plies p-adic continuity. The conclusion is in conjict with the original idea that length scale cuto leads to elective p-adic topology and more in concordance with the more standard assumption of p-adic physics that p-adicity becomes important below some cuto length scale lusually assumed to be equal to P lanck length scale. Another manner to say the same thing is that quantum uctuations in spacetime geometry are negligible in length scales larger than L_p so that elective action obtained by averaging K ahler D irac action and integrating over small length scale degrees of freedom is real rather than p-adic.

A n attractive possibility is that p-adic eld theory description at length scales $L > L_p$ can be based on discrete QFT in the lattice form ed by p-adic convergence cubes and that the vertices are given by n-point functions of the convergence cube.

4.3 Physical interpretation of the length scale L_0

The fundam entalp-adic mass scale L_0 can be deduced from the experimental value of electron mass in p-adic description of H iggs mechanism.

corresponds to a sm all correction to the electron m ass com ing from C oulom b energy and topological m ixing of lepton fam ilies. This gives

The de nition of the length scales should not be taken too literally since the de nition necessarily contains som e unknow n num erical factor. R ather rem arkably, the length scale L_0 is of sam e order of m agnitude as the length scale at which the renorm alized standard m odel coupling constants become e equal and some e kind of N ew Physics probably emerges.

The original hypothesis was that that the length scale at which p-adicity sets on is of order $L_0 = 10^{4^{\circ}}$ G. Above this length scale spacetime should begin to look approximately at piece of M inkowski space and the eld theoretic description should make sense. This hypothesis is probably not correct as the following arguments demonstrate.

The basic problem is to understand the appearence of the square root of p instead of the naively expected p in the expression of length scale. The rst idea to come into m ind is that M⁴ coordinate m^k is essentially the square root of p-adic spacetime coordinate x^k. The argument was based on analogy with Brownian motion. M⁴ coordinates as functions of p-adic spacetime coordinates are analogous to the spatial coordinate x of particle in Brownian motion and therefore one has

An elegant Lorentz invariant manner to understand the appearence of square root is to assume that the p-adic version of M 4 metric contains p as a scaling factor.

W hat is remarkable that the shortest distance in the range $m^{k} = 1$; :m 1 is actually $L_{0} = \frac{p}{p}$ rather than L_{0} so that p-adic numbers in range span the entire R_{+} at the lim it $p ! 1 \cdot W$ hat is remarkable is p-adic topology indeed approaches real topology in the lim it p ! 1 since the length of the discretization step approaches to zero. This intepretation is in accordance with the interpretation of p-adic space time as elective spacetime surfaces spanned by m ost probable 3-surfaces and with the intuitive idea that in very long length scales quantum elects become vanishinly small so that elective spacetime surface becomes continuous in real sense.

In TGD the 'radius' R of CP_2 is fundamental length scale and is of same order as Planck length P itkanen_a]. Concerning the formulation of conformal eld theory limit the basic problem is

i) whether one should can take R as basic length scale and predict L_0 or ii) whether the value of L_0 is a prediction of Quantum TGD and must be taken as given in the formulation of eld theory limit.

The general physical picture is in accordance with the latter alternative. This means that in the expression of the induced metric the parameter R must be expressed in terms of L_0 and one has following kind of expression

k is very large num ber, of order 10 6 p. It is illustrative to look how large the contribution of C P₂ m etric to induced m etric is.

i) If the gradients of CP₂ coordinates are of order 0 $\binom{p}{p}$, the contribution of CP₂ m etric to the components of the induced m etric is of order kp², where as the contribution of M⁴ coordinates is of order p. This implies that the

contribution if CP_2 m etric to the distance is roughly a fraction x 10⁶ from the contribution of M⁴ coordinates so that gravitational e ects should be important imm ediately below elementary particle length scales L_p . This is not in accordance with the expectation that gravitation becomes important in P lanck length scales, only.

ii) If the gradients of CP_2 coordinates are of order O (p) then the contribution of CP_2 m etric to the induced m etric is of order O (p) p-adically and in accordance with the weakness and even the size of the coupling strength of gravitational interaction for physically interesting primes p.

5 Topological condensate as m in im um of effective action

The construction of p-adic TGD necessitates a satisfactory answer to the question 'W hy the e ective spacetime topology is p-adic?'. One can consider two di erent answers but only one of them seems to be entirely satisfactory and is based on the observation that observed spacetime is actually some kind of quantum average de ned as minimum of the elective action.

5.1 p-Adicity from length scale cuto ?

Consider ist the wrong answer. The original explanation for the p-adicity of elective spacetime topology was in terms of length scale cuto. The concept of the length scale cuto plays fundamental role in the description of the critical phenomena. The TGD: eish counterpart of this procedure is the smoothing out of the topological details of size smaller than some given length scale L. This procedure should give the 3-space of General Relativity: the presence of details is described by energy momentum tensor and various particle densities. The di culty is that the usual momentum cuto of quantum eld theories doesn't provide a solution to this problem. The geometric description of this procedure provided by various lattice models seems to be more in the spirit of TGD wish description of the cuto procedure.

Sm oothing out procedure (or coarse graining) need not respect di erentiability for the sim ple reason that di erentiability in Planck length scales does not correlate the values of functions at distances much larger than Planck length. This suggests that smoothed out spacetime surfaces obeys p-adic topology instead of real topology. A possible de nition for the smoothing out procedure is as p-adic cuto : replace x_p appearing as the argument of h^k with its rst N pinary digits. This means that all details of the 3-surface related to the higher pinary digits of the expansion are smoothed out: by p-adic continuity these details are the smaller the higher the corresponding pinary digit is. The presence of the details must be described somehow and the use of p-adically di erentiable densities is a natural manner to do this.

This interpretation need not be the correct one.

a) The appearence of the favoured p-adic length scales corresponding to powers of p and also the appearence of the favoured values of p is not in accordance with the arbitrariness of p-adic cuto length scale.

b) p-Adic QFT turns out to be UV nite without any p-adic length scale cuto .

c) Despite several attempts it has not possible to de ne precisely what the concept RG transformation and RG invariance of Kahler action means in this interpretation.

In fact, in light of the interpretation to be suggested below the sm oothing out procedure should lead from p-adic topology to real topology, when the cuto length scale is larger than L_p rather than from real to p-adic!

5.2 p-Adic spacetime as absolute minimum of e ective action

In TGD the geometry of 3-surface and the corresponding unique classical spacetime surface are subject to quantum uctuations and the criticality of the TGD wish Universe suggests that these uctuations are important in all length scales. Therefore the observed 3-space and spacetime should correspond to nontrivial quantum averages. These averages obviously depend on quantum state. p-A dic topology could be one of the basic properties of this average spacetime.

The problem is to formulate the concept of quantum average for 3-space and spacetime. In ordinary QFT the concept of elective action is in decisive role. Elective action is typically obtained by coupling some elds appearing in the action exponential to external currents and by functionally integrating over some elds appearing in the action exponential to get elective action in terms of new eld .

The absolute m in in a of the elective action de ne the vacuum average of the eld (x) in presence of external current J.

In TGD the corresponding construction could proceed as follows. Kahler D irac action de nes con guration space geometry. W hat one is interested in is the integration over con guration space degrees of freedom to get e ective action, whose absolute m inim a would de nep-adic space time concept. The e ective spacetime is characterized by H coordinates h_{new}^k (x) and the simplest coupling of these coordinates to ordinary H-coordinates is obtained by coupling Kahler potential to the external Kahler j_{new} current de ned by h_{new}^k

Here the subscript 'new' means that the induced Kahler eld and induced metric are determined entirely by the new coordinates h_{new}^k . The matrix element of the exponential of the elective action in a given quantum state is de ned as the average obtained by integrating over con gurations space degrees of freedom that is over all possible 3-surfaces. It must be emphasized that the resulting elective action depends on spinor elds since one doesn't integrate over them. Elective spacetime is determined as the absolute minimum of elective action and need not be unique in a given quantum state: in therm odynamics the nonuniqueness means possibility of several phases and criticality suggest the existence of a large degeneracy.

A comment on the treatment of boundary components in quantum averaging is in order. The success of the ordinary QFT suggests that boundary components can be replaced with quantum averages in vibrational degrees of freedom but averaging does not make sense in om degrees of freedom. Quantum averaging should give rise to some boundary 3-surface or a fam ily of 3-surfaces (degeneracy is possible) not depending much on the details of the surrounding spacetime. Degeneracy is indeed expected and corresponds to conform all and modular degeneracy. The idealization of the boundary component with a point like particle boks rather natural so that e ective spacetime contains boundaries as wordlines. K ac M oody spinors provide econom icalm anner to describe conform all degrees of freedom. The coupling of the wordline dynam ics to interior dynam ics is in principle determ ined by the boundary conditions on the boundaries and the conservation of various charges.

W hat can one conclude about the general form of e ective action? a) RG invariance of the e ective action has been one of the basic hypothesis of Q uantum TGD [Pitkanen_a]. The problem is to de ne this concept precisely. For simplest RG invariant actions correspond to free eld theories and for these theories e ective action is identical with the original action. This observation suggests a precise de nition for RG invariance: the e ective action associated with K ahler action in the absence of spinor elds is indeed form ally identical with the K ahler action but the e ective spacetime e topology need not be the real one. The same conclusion is achieved if one assumes that e ective action possesses same approximate symmetries and the characteristic vacuum degeneracy selecting K ahler action uniquely.

b) An attractive possibility is that the elective spacetime topology is that of a hierarchical topological condensate $::: < p_1 < p_2 ::: consisting of pieces pos$ sessing p-adic topology with various values of p. The gluing of two topologi $cally dierent pieces <math>p_1$ and p_2 should be performed along their boundaries. This gluing operation can be performed using canonical correspondence.

c) The enorm ous vacuum degeneracy of the K ahler action and associated exact D if f (M 4) and canonical invariances suggests analogy with spin glass phase in the sense that there exists enorm ously large number of vacuum spacetimes serving as background for ferm ionic dynamics. The averaging over these vacuum spacetimes is completely analogous to the averaging over the bonds strengths in spin glass phase. The basic feature of the con guration space of minima in spin glass phase is ultrametricy. Ultrametricity is the basic feature of p-adic topology and therefore the topological condensate

as a hierarchy of p-adic topologies $p_1 < p_2 < :::$ is perhaps the most general realization of the ultram etricity.

d) W hat about the form of e ective action, when spinor elds are nonvanishing? RG invariance suggests that the general form remains invariant but som ething happens for H-coordinates appearing as argum ents of the action. TGD allows N = 1 supersymmetry generated by covariantly constant right handed neutrino and this suggests the solution to the problem . W hat happens is that H-coordinates are replaced by super coordinates h^k ! h^k + K ^k. The replacement is coordinate invariant only provided one can select preferred coordinates for H . For M 4 the standard M inkow ski coordinates are obviously the preferred coordinates. For CP_2 the complex coordinates for which the action of su (2) u(1) is linear are preferred coordinates. These coordinates are de ned only modulo color rotation and consistency requires that physical states are color singlets. This in plies that each p-adic region each color singlet so that color con nem ent in strong sense results.

The interpretation of the p-adic spacetime as elective quantum spacetime is in principle possible in arbitrarily short length scales and for all spacetime topologies and the approximate symmetries are not essential for this in this respect. Later it will be found that p-adic conformal and canonical invariances seem to be completely general approximate symmetries of the zero action extrem als of the elective action broken by gravitational elects only. Therefore p-adic spacetime concept is not just a convenient approximation working at the at spacetime limit as originally believed but an essential part of Q uantum TGD. The only approximation made in the p-adic led theory limit is the freezing of the spacetime degrees of freedom by using quantum averaged spacetime determined by the elective action and it might be even possible to develop a formalism to calculate the corrections to this approximation.

5.3 The value of the K ahler coupling strength?

The requirement that the elective action is identical with the super symmetrized K ahlerD irac action should at the value of K ahler coupling strength g_K^2 and thus make theory unique. There are two independent heuristic arguments leading to same estimate for the K ahler coupling constant.

a) Coupling constant evolution argument Pitkanena] led to the estimate

b) The experience with the ordinary eld theories suggests that elementary particle mass scale is related to the exponent of the inverse of $_{K}$: $L_{elem} = \exp(c = _{K}) = \overline{G}$, where c is some constant. A generalization of this formula is suggested by two observations:

i) M ensemble prime M $_{127}$ de nes the largest elementary particle length scale and is also a member in the Combinatorial Hierarchy M (n) = M $_{M (n 1)}$ of the M ensemble numbers (possibly all primes) given by 3;7;127;M $_{127}$; ...

ii) The exponent of the Kahler action for CP_2 type extrem als describing elementary particles de nes natural large dimensionless parameter of order 10^{19} and in Pitkanen_a] an explanation of the mass elementary particle mass scale in terms of this number was suggested.

These observations suggest the following form ula for the fundamental length scale L (127) as a prediction of TGD:

The two estimates give identical results if one has $_{em}$ (low) = :9641=137:03604: this assumption is consistent with the electrom agnetic coupling constant evolution and gives $_{K}$ = 137:06. $\frac{1}{_{K}}$ = 137 would give k = 1:77 < 1:824, which is however too small value. In any case, the two heuristic arguments are consistent which each other and internal consistency predicts the sale L_0 correctly. K has a natural upper bound corresponding to $L_0 = \frac{1}{G}$ and given by K :0089. The great task is to understand the generation of the length scale L_0 or equivalently the low energy value of the ne structure constant.

It is quite possible that conform all invariance gives conditions on the value of g_K . The construction of unitary representations of conform all symmetry should lead to a denite value for K ahler coupling g_K (conform all central charge c vanishes). The conform all charges contain parts coming from D irac action and from K ahler action and the part coming from K ahler action depends is proportional to $1=g_K^2$. Therefore the requirement that conform all current commutators contain no anomalies and that vacuum expectation of V irasoro generator L_0 should have quantized value is xed by unitarity, could pose condition on the value of K ahler coupling strength.

5.4 Approximate symmetries of the p-adized Kahler action

The criticality togetherw ith two-dimensional analogy suggests that 4-dimensional conform al transform ations act as approximate symmetries of p-adic K ahler action. Also the existence of p-adically analytic extrem a of p-adic K ahler action suggests the same. A ctually the symmetry group is much larger. When gravitational elects can be neglected D iff (M⁴) acting on M⁴ coordinates is approximate symmetry. Besides this canonical transformations of C P₂ localized with respect to M⁴ coordinates act as dynamical symmetries in the interior of the spacetime surface. The emergence of D iff (M⁴) (M⁴) suggests that the theory does not diler much from what might be called topological eld theory in the interior of spacetime surface. It however turns out that p-adic quantization of D irac action allows massless states, presumably including also graviton. A ctually these states correspond to the representations of certain Super V irasoro algebra with the property that all generators except L₀ annihilate vacuum whereas L₀ gives the energy of the (massless) state.

p-A dic di eom orphism s acting on M 4 via the form u la M $\,$! W (M) and canonical transform ations of C P_2 local with respect to M 4 act as exact sym –

m etries of p-adic K ahler action, when gravitational e ects are neglected. This motivates the realization of these symmetries as exact symmetries by requiring that conform aland canonical charges annihilate physical states.

The change of the action in general transform ation can be decomposed into two parts: $S = S_1 + S_2$ corresponding to the change induced by the change of the induced K ahler form and of the metric.

a) For the extrem als of K ahler action any variation of the action reduces to total divergence, which is the divergence of the current associated with in nitesim al transform ation and the vanishing of this divergence m eans just charge conservation. In present case the total divergence contains only the contribution $S_1 = T$ g coming from the change of the induced m etric since the induced K ahler form remains invariant for both di eom orphism s and canonical transform ations. The contribution coming from the m etric is in general very sm all sm all by the weakness of the gravitational interaction and vanishes in the approximation that CP_2 contribution to the induced m etric is zero.

b) The idea is to pose the vanishing of the total divergence as a quantum condition on the physical states: this condition states that D if f (M⁴) (or perhaps only conform al) and canonical (local with respect to M⁴) charges are conserved. A more stronger condition that these charges annihilate physical states is indeed the basic constraint on physical states in eld theories. The condition makes sense as a condition for the elective action since the minim a of the elective action can be regarded as elective spacetimes associated with quantum states. A loo the breaking of conform all symmetry in the sense that L_0 is conserved but does not annihilate physical states is possible.

The symmetries de ned in question are extremely general symmetries as the following examples demonstrate.

a) D if f (M 4) and local canonical symmetries are exact symmetries in the usual sense for the vacuum extremals: any 4-surface with CP₂ projection, which is Lagrange manifold (having vanishing induced Kahler form). Lagrange manifolds are in general 2-dimensional, which means that a very rich variery of topologies becomes possible for the vacuum s. This vacuum degeneracy implies the analogy between TGD and spin glass. D i ecomorphisms of M 4 are symmetries in the vacuum sector.

b) Spacetimes representable as maps M⁴! CP_2 and carrying nonvanishing Kahler eld and satisfying Maxwell equations j = 0 are examples of
nonvacuum extrem als. An interesting possibility is that also the p-adically analytic m aps M⁴ ! CP_2 to be described in next section de ne actually exact solutions of the e ective action. O ne example of zero action m inim a of K ahler action are so called m assless solutions discussed in Pitkanen_a]. These are de ned as m aps M⁴ ! CP_2

where p is massless four-momentum vector p p = 0 and is polarization vector orthogonal to p: p = 0 and the functions f are arbitrary. In this case canonical transform ations are exact symmetries.

c) String like objects of type X 2 Y 2 M 4 CP₂ are vacuum solutions and suitable deform ations of these objects with vanishing action and nontrivial K ahler form probably de ne nonvacuum extrem als with vanishing action. The identi cation of hadronic strings as objects of this type was suggested in Pitkanen_a]. The hadronic string tension would be generated dynam ically and be due to the presence of ferm ions and nonvanishing K ahler elds. In fact, classical gluon eld is proportional to K ahler eld: G ^A / H ^A J , where H ^A is the H am iltonian of color transform ation. It should be noticed that color symmetries are canonical transform ation so that physical states m ust be color singlets also by the canonical invariance.

d) The so called CP_2 type extrem als obtained by deform ing the standard in bedding of CP_2 so that the M⁴ projection of the surface is light like curve

These surfaces are metrically equivalent with CP_2 and are vacuum solutions. C anonical and conform alsymmetries are exact symmetries for these surfaces. In Pitkanen_a] it was suggested that elementary particles correspond to CP_2 extrem als and that Feynmann diagrams correspond to surfaces obtained by gluing these extrem als together by connected sum operation. The action of these solutions is nonvanishing and these surfaces as such are not absolute minim a of elective action. One can how ever consider more general solutions obtained as a topological sum of CP_2 type extrem al and background spacetime surfaces carrying nontrivial Kahler Coulom billions. contribution to action so that total action and its real counterpart vanishes and one obtains absolute m in im um. The exponent of K ahler action de nes in natural m anner elementary particle length scale as suggested already in \mathbb{P} itkanen_a].

These examples encourage the conjecture that the eld theory limit of TGD de ned as a fermionic eld theory in the average spacetime de ned by the physical state allows local canonical transform ations and D if f (M 4) as gauge symmetries under rather general conditions. The approximate invariances are not needed in the de nition of the super symmetrized Kahler action. The surprising success of the mass calculations based on super conform al invariance also supports the realization as gauge symmetry. It might well be that these symmetries are spoiled 'in large' by gravitational e ects. A purely p-adic feature of these symmetries is however that one can restrict the symmetries to be su ciently small to force the change in the induced metric small enough. This is achieved if the parameter t in the exponential exp(tJ) of Lie-algebra generator has p-adic norm smaller than $p^{n=2}$: these tranform ations indeed form a group for any integer n. In this manner the con guration space decom poses into dispirit blocks and one obtains di erent realization of sym m etries inside each block. This is all what is need to deduce the most important consequences of conform al invariance (such as universality of the mass spectrum). These dispint blocks are clearly analogous to the degenerate vacua of the spin glass phase.

5.5 G ravitational warping

The absolute m inim um of e ective action depends on the quantum numbers of the state. In particular, there is dependence on four-m om enta and various charges of the quantum state. G ravitational warping represents perhaps the simplest dependence on the quantum numbers of the state. G ravitational warping is completely analogous with the existence of in nitely m any imbeddings of at 2-dimensional space E² to E³ obtained by deforming any plane of E³ without stretching it. The physical reason for the warping is the gravitational mass of the p-adic convergence cube. The mass of the p-adic convergence cube deform s spacetime surface and average e ect is momentum dependent scaling of som e metric components. In GRT gravitational warping is gravely does not make any sense. The simplest physical consequence of

the deform ation is that photons propagating in condensate spend in general longertime than vapour phase photons to travelagiven distance \mathbb{P} it kanena].

A rather general nonstandard in bedding of M⁴ representing gravitational warping is obtained by assuming that C P₂ projection of spacetime surface is one-dimensional curve:

Here s is the curve length coordinate, P_k is total four-m om entum and one has K = 1.

The scaling of the metric components has two nice consequences as far as the convergence of the perturbation theory is considered:

a) A sum ing that the spectrum of o -m ass shell four-m omenta for spinors is not changed the propagator expression has no poles since one has always $k^2 = g + k + f = M^2$ in warped metric.

b) For $m_{00} = 1 ! 1$ the expression $k_2^2 = 0$ becomes $k_2^2 = k_0^2$ and this number becomes p-adically very large, when p-adic norm of k_0 increases. This guarantees the convergence of the propagator expression as well as nite degeneracies for all values of P.

G ravitational warping cannot m ake spacetim e m etric Euclidian if boundary contribution to the mass squared is given by the standard stringy mass formula. In the rest frame the deformation of the metric is just $q_{00} =$ $K^2 pM^2$). Stringy mass spectrum is of form $M^2 = kn$, $j_{cj} = 1$ so p(1 that the p-adic norm of the mass squared is not larger than one and the contribution to the metric is of order 0 (p^2) p-adically. It is worth noticing that stringy mass form ula gives upper bound for the mass contained in a region of $p \overline{p} 10^{-3} M_{P1}$. An interesting possibility is that stringy size L_p: M M _{m ax} mass formula might hold true even in astrophysical length scales. For Sun L_{p} is of order of the size of solar system and upper bound for mass is much larger than solarm ass. For neutron star of size of order 10^4 m eters the m ass is not far from its maximum value for L_p 10^4 m.

5.6 Idealization of boundary components with point like objects

In TGD boundary components of 3-surface are carriers of elem entary particle quantum numbers. In particular, the state of elem entary particle depends on modular degrees of freedom of the boundary component. In \mathbb{P} itkanen_a] the so called elementary particle vacuum functionals were constructed and the p-adic description of H iggs mechanism relies on the p-adized version of these functionals. A purely p-adic feature of the construction is the discretization of p-adic moduli space. The route from ordinary modular degrees of freedom of p-adic TGD should take place via the construction of 'e ective' elementary particle functionals by coupling modular degrees of freedom to the p-adic modular degrees of freedom som ehow. How this process is carried out in detail is not considered here.

As already found one cannot perform quantum averaging for the cm degrees of freedom of boundary component and p-adic spacetime surface is the average spacetime obtained by keeping the center of mass positions of boundaries at some reference time xed. The practical treatment of boundary degrees of freedom in the low energy eld theory limit suggests the idealization of boundary component with point like object. This necessitates quantum mechanical averaging over the modular degrees of freedom. This quantum mechanical averaging gives to the mass squared the dominating modular contribution. The modular contribution to mass squared is indeed quantum mechanical rather than thermal average: this issue was left open in the p-adic description of Higgs mechanism.

5.6.1 Induced D irac spinors on the world line

The simplest description of the point like limit is obtained by neglecting totally the vibrational degrees of freedom. The 3-dimensional orbit of the boundary component is replaced with the world line of a point like particle and the D irac action for the induced spinors on the boundary component is replaced with the D irac action on with world line. The induced spinor connection on the world line reduces to a pure gauge with a suitable choice of CP_2 vielbein basis and a suitable gauge for the K ahler potential on world line and one can wonder whether the couplings of the ferm ions to the classical

gauge elds are actually trivial (note that the em ission of a gauge boson corresponds to the splitting of the boundary component world line). This is not probably not the case: the point is that boundary component on degrees of freedom are not frozen and one must treat these degrees of freedom quantum mechanically so that there is no general gauge choice tranforming the gauge potentials away. If the couplings of the fermions to the classical background elds were trivial the problem s associated with the classical long range Z⁰ elds (the possibility large parity breaking e ects) considered in the third part of the book would have an easy solution. Physical intuition and the previous work with TGD how ever suggest that classical background elds are in portant.

The contribution of the modular degrees of freedom to mass squared should be taken into account somehow. The only manner seems to be as a constraint on the elective mass squared of spinors. The D irac equation for induced spinors contains a term proportional to the trace of the second fundamental form of the worldline

H ^k decomposes into M ⁴ and C P₂ contributions and the description of H iggs mechanism proposed in Pitkanen_a] was based on the identi cation of C P₂ part of H ^k as H iggs eld. If H ^k is covariantly constant quantity along the world line. It seems natural to require that the square of C P₂ part S^k of H ^k is equal to the m odular contribution to the m ass squared on the world line

In general S^k is not covariantly constant but one could perhaps add the covariant constancy of S_k along world line as an additional condition:

The use of the constraints is in accordance with the concept of the elective action. W hat constraints express is the state dependence of the average

spacetime surface on quantum numbers. An additional constraint comes from the requirement that electrom agnetic gauge group, which is subgroup of local so (4) u (1) is exact gauge group. This implies that induced W elds mixing di erent charge states of ferm ion vanish on world line. A logether this means that the CP₂ projection of the world line is highly determined: a detailed consideration can be found in context of the symmetries. The motion in M⁴ degrees of freedom is determined by the boundary conditions stating the conservation of four-momenta and other charges.

5.6.2 Generalization of K ac M oody D irac operator to worldline

The simplest point like limit in plies that spinors have only nite number of degrees of freedom and therefore a loss of conform aldegrees of freedom necessary to obtain P lanck m ass excitations. A coording to the m ass calculations elementary particle masses contain besides the dominating modular contribution a contribution from spin, electroweak and color degrees of freedom, which can be calculated using p-adic therm odynam ics with energy replaced with the V irasoro generator L_0 . Therefore it seems to be an overidealization to elim inate totally the conform al degrees of freedom . Of course, one could use the total mass squared including the therm al contribution in the D irac equation for ordinary induced spinors. Probably this is not wise. The mass calculations provide a better solution of the problem : replace H -spinors with the K ac-M oody spinors constructed as representations of Super V irasoro algebra Pitkanenc]. One can de ne the coupling of the world line gauge elds to K ac M oody spinors and also the coupling of H k k is well de ned and due to covariant constancy is combination of the at space gam m a m atrices. The possibility to eliminate neutral gauge potentials by gauge transform ations suggests that in CP_2 degrees of freedom actually no dependence on CP2 coordinates remains and KM spinors in CP2 degrees of freedom behave as at space spinors in cm degrees of freedom .

p-A dic description of H iggs m echanism led to the concept of K ac M oody D irac operator acting on R am ond or N-S type representation. For R am ond type representation the operator is sum of three term s.

The rst term is G₀ acting on Super V irasoro, presum ably acting on conformal degrees of freedom of two-dimensional boundary component de ned as $m^0 = constant$ slice of 3-dimensional boundary. The second term is D irac operator in M⁴ cm degrees of freedom. The third term is mass operator, which is linear combination of CP₂ type gam mamatrices anticommuting with G₀ and is required to give correct conformal weight for states, which should be massless in absence of the modular contribution M²_{mod} to mass squared (second paper of Pitkanen_c). The presence of M_{op} can be interpreted as a breaking of the super conformal symmetry.

W hat is nice is that the tachyonic vacuum weight of L_0 , which remained mysterious in the mass calculations, can be understood in terms of the induced spinor concept. A second great mystery of the mass calculations was the origin of the additional on part in G_0 (tot), in particular mass operator. It would be very nice if G_0 (tot) would actually correspond to Super V irasoro generator. This is indeed the case if Super V irasoro generators for the boundary component idealized to point are de ned as sum s of two terms. The rst term corresponds to the Super conform altransform ations of proper time coordinate for which induced metric g_{tt} is constant. Second term corresponds to the Super V irasoro generators G_n n > 0 annihilate the state autom atically and G_n (tot) reduces to G_n . G (tot;t) de ned as

The mass term M $_{\rm op}$ com es from the fact that induced gamma matrices are = H^{k}_{k} , where H^{k} are the components of the not covariantly constant: D second fundamental form of the world line. The breaking of the conform al symmetry via the generation of a nonvanishing negative (tachyonic) vacuum conform alweight h (vac) requires that M $_{op}$ is nonvanishing. The value of h (vac) is 2 (1) for isospin 1=2 (1=2) ferm ions and 5=2 for bosons. The presence of this term in plies that world line cannot be a geodesic line CP_2 degrees of freedom . In M⁴ degres of freedom accelerated motion causes additional breaking of conform alsym netry and small change in mass squared. If second fundam ental form is covariantly constant then only the mass of the particle changes and higher V irasoro conditions rem ain true. A lthough electroweak doublet Higgs particle is de nitely absent from the mass spectrum of the theory, second fundam ental form however appears in the KM D irac equation in the role of classical Higgs eld so that the original identication of the Higgs eld as the trace of the second fundam ental form is not totally wrong.

The treatment of N-S case proceeds in similar manner. The new feature is that KM D irac operator has conformal weight 1=2 and corresponds to $G^{1=2}$ (tot) for world line containing ordinary conformal part and the part acting on the world line:

If propertime coordinate is used and second fundamental form is covariantly constant equations of motion reduce to V irasoro conditions for L_n , n > 0 and n = 0 term gives breaking of conformal symmetry.

V irasoro conditions are autom atically true if G_n , n > 1=2 annihilates the states autom atically and this must be assumed in order to achieve Super V irasoro invariance. Again the equation of motion implies additional mass squared term with geometric interpretation

5.7 Second quantization of the eld theory lim it and p-adic therm odynam ics

p-A dic eld theory limit is not all what is needed to construct a realistic theory. One must also perform second quantization both in interior and boundary degrees of freedom. A lthough not very much will be done in this direction in this paper it is useful to have rough idea about what is involved.

Consider rst second quantization in boundary degrees of freedom .

a) The basic point is that eld theory inside p-adic convergence cube allows only very few light states for both the interior and boundary components of single convergence cube and in practice the light excitations of boundary components must correspond to elementary particles.

b) In practice single boundary component can in a good approximation be idealized with a point like object described by Kac-M oody spinor in order to take into account the conform aldegrees of freedom. The om coordinates of the boundary components are kept xed in the de nition of the quantum averaged spacetime and these degrees of freedom must be quantized. The experience with QFT suggests that one can second quantize boundary com ponent Super V irasoro representations regarded as quantum elds in the interior of the convergence cube: second quantized N-particle state corresponds to state of N topologically condensed sm all 3-surfaces with boundary. c) The action should be just the generalization of free KM action obtained by minimal substitution to realize gauge invariances. Gauge eld is de ned by N-S representation. Since N-S representation contains bosonic KM D irac operator and its conjugate one obtains polynom ial action fourth order in operators creating N-S states. The di cult technical problem is the construction of vertices that is the action of N-S representation as a gauge potential on Ram ond representations and N-S representations.

d) C lassical background elds de ned associated with e ective spacetime surface are also present and couple to the K ac M oody spinors.

e) The experience with the p-adic counterpart of standard model suggests that in boundary degrees of freedom single p-adic convergence cube with size L_p is the natural quantization volume. The propagators of the theory are apart from additive constant equal to Super V irasoro generators p^k_k , $G_0 + H^k_k$ (ferm ions) and p^2 , $L_0 + h$ (bosons).

One cannot exclude the possibility is that the second quantization of K ac-M oody spinors is directly related to the p-adic nondeterm inism for the dynam ics of boundary components. The world lines of boundary components are determ ined by second order di erential equations, which allow integration constants depending on nite number of positive pinary digits. For instance, p-adic geodesics of M⁴ have m^k and dm^k=ds depending on nite number of positive pinary digits. This nondeterm inism in plies degeneracy of the absolute m inim a of elective action in accordance with spin glass analogy. A

possible manner to treat the situation is to use vacuum functional depending on world line. This functional is analogous to the action exponential for particle and should be essentially equal to the action exponential associated with K ac-M oody spinor and therefore generalized D irac action. The calculation of S-m atrix elements necessitates averaging over the di erent vacuum con gurations and therefore one must perform sum mation over all possible di erent world line con gurations. Since world lines can split these con gurations in fact are counterparts of Feynm ann graphs. It would not be surprising if this sum mation, which resembles functional integration would not give second quantized eld theory for K ac M oody spinors. It seems how ever that this line of argum ent is not correct although the value of the elective action for space time is not expected to depend much on the positions of particle world lines.

Boundary degrees of freedom do not give rise to graviton in the scenario explaining Higgsmechanism and this suggests that graviton must correspond to interior degrees of freedom. The p-adic realization of D if f (M^4) invariance indeed allow sm assless states for the p-adic quantization volum e and graviton and its possible com panions correspond to entire p-adic convergence cube or small cube inside it (recall that localized p-adic plane waves are possible). G raviton em ission corresponds to the em ission of sm all 3-surface via topological sum vertex and the exchange of graviton can occur between di erent p-adic convergence cubes interpreted as particles such as hadron and leptons. The general rules look again quite obvious. Propagators are same as in previous case. Vertices correspond to operators creating a state with the quantum numbers of the emitted particle, say graviton. N-particle vertices are essentially time ordered n-point functions integrated over the interior of the p-adic convergence cube and slashed between initial and nalstates. The vertices describing the emission of several particles via topological sum vertex are possible but probably the rates processes involving several exchanges are extremely low since gravitational coupling characterizes the strength of these interactions.

The description of hadron reactions necessarily involves topology changing processes for p-adic 3-surfaces and p-adic eld theory limit in cube L_p is not all what is needed to describe these processes just as perturbative QCD does not provide full understanding of hadronic reactions. An open problem is how to construct the form alism describing topological particle reactions in

length scales $L > L_p$. Real physics probably gives a satisfactory description for these processes but in a more ambitious approach one should som ehow glue the p-adic QFT is associated with neighbouring p-adic converge cubes together. One possibility is to construct p-adic manifolds from p-adic convergence cubes as Feynm ann diagram type objects. The lines of these diagram s would correspond to the sequences of convergence cubes glued together along their sides. The sum over the Feynm ann diagram s would be reproducible from a second quantization of some eld theory in the discrete lattice form ed by the converge cubes the vertices of the theory being de ned in terms of n-point functions associated with single convergence cube. In Pitkanen, the concepts of p-adic light cone and p-adic manifold (constructed by gluing together p-adic converge cubes) were introduced: in Pitkanen_b] it was suggested p-adic m anifolds m ight be the counterparts of Feynm ann diagram s and a geom etric second quantization for the p-adic conform al eld theory was suggested. In this form alism single line of Feynm ann diagram was supposed to be a part of so called p-adic light cone. As already noticed it seems that only the sequences of p-adic convergence cubes of size L_p are needed and it is possible to perform second quantization in the discrete lattice form ed by these cubes.

p-A dic them odynam ics for boundary degrees of freedom seems to be necessary in order to get predictions comparable with experiments. p-A dic them odynam ics provides an elegant description of Higgs mechanism and consistency requires the thermal averaging of reaction rates, too. It is not clear whether the p-adic version of the standard model, which should provide the practical calculational tool, allows to use thermal masses as such. The technical problem is that p-adic square roots for thermal M² appearing in D irac equation need not be p-adically real number. This problem is avoided if one uses K ac-M oody spinors truncated to spinors of H and introduces mass matrix M^k_k in C P₂ degrees of freedom with the property M_kM^k = M² with respect to Euclidian metric. This mass matrix is just the counterpart of C P₂ contribution to the trace of the second fundamental form .

6 Sym m etries of the theory

In interior of X 2 the basic sym m etnies of the theory broken include D if f (M 4), canonical transform ations localizable with respect to M 4 coordinates and

containing local color transform ations as a subgroup. These symmetries are broken by gravitationale ects only. Point particle limit for boundary components allow sbesides conform alsymmetries and local canonical symmetries localso (4) u (1) broken down to electrom agnetic gauge group and localso (3;1) broken down to local version of the isotropy group of 4-m omentum of world line. All these symmetries posses super extension: fermionic generators are obtained by commuting the bosonic generators with local N = 1 super symmetries and kappa symmetries de ned by covariantly constant right handed neutrino. Localization of symmetries is possible using arbitrary Fourier expandable functions of M⁴ coordinates and D if f M⁴) algebra.

6.1 N = 1 supersymmetry and kappa symmetry

In quantum TGD right handed neutrino generates N = 1 supersymmetry. N = 1 supersymmetry and the related K appa symmetry provide the means for extending p-adic conform allows metry to super conform allows metry: fermionic Super V irasoro generators are obtained by localizing of N = 1 super (R am ond case) symmetry or K appa symmetry (N-S case). The supersymmetrization of local color and local canonical transformations, Lorentz transformations and electroweak gauge transformations is achieved by taking anticommutators with Super V irasoro algebra. This is what is needed since in the papers [Pitkanenc] devoted to p-adic Higgs mechanism p-adic super conformal symmetry together with super versions of color and other symmetries were found to lead to excellent predictions for particle mass spectrum.

6.1.1 De nitions of N = 1 super sym metry and kappa sym metry

The is also a second supersymmetry generated by right handed neutrino analogous to the kappa symmetry of super string models [G reen et al]. This symmetry is needed on boundary components only to construct N-S type representations and is de ned as

This supersymmetry doesn't annihilate on mass shell states as in string model. The action of D irac operator gives the trace of the second fundamental form and this implies analogy with kappa symmetry of string model apart from the presence of normalization factor. Normalization factor and therefore the direction of unit vector n^k is well de ned unless the boundary component in question is minimal surface. For boundary components idealized to world lines the value of H k k is covariant constant de ned by the nonvanishing vacuum weight of K ac M oody spinor so that there are no problem s. K appa symmetry has the properties needed to generate N-S type generators if one assumes that leptons move in integer modes and quarks move in half odd integer m odes.

6.1.2 Supersymmetrization of Kahler Dirac action

N = 1 supersymmetry suggests also a properment of generalize the K ahler D irac action to p-adic context to obtain elective action. D irac action as such transforms by total divergence in supersymmetry, which does not act on H – coordinates. O ne can however extend the super supersymmetry by replacing H -coordinates with super coordinates:

in K ahler D irac action. This replacement breaks general coordinate invariance unless one xes some physically preferred coordinates for H. In M⁴ degrees of freedom the preferred coordinates are just the standard M inkowski coordinates. The simplest candidate are complex coordinates with the property that the action of su (2) u (1) is linear. These coordinates are unique only apart from color rotation and internal consistency requires that physical states are color singlets: note that each p-adic regions is separately color singlets. The nice feature of this choice is that color symmetry is exact and therefore super symmetrization works without any assumptions about the symmetry is in accordance with the recent results of Seiberg and W itten].

The parameter K appearing in the dening formula for the super coordinate must be chosen to be proportional to some positive power of p in order to obtain converging perturbation theory. The convergence of the perturbation theory is extremely rapid for physically interesting values of p. The deviation of the induced metric from at metric must of order K². For K / p this means that the CP₂ part of induced metric is of order O (p²) as it should be. Same applies to the gradients of spinor elds.

6.1.3 W hy supersymmetry is so nice?

Supersym ${\tt m}$ etrization is physically well ${\tt m}$ otivated as the following considerations show .

a) D if f (M 4) sym m etry in plies that the oscillator operators associated with the quantized ferm ion elds create only electroweakly neutralm assless states. G raviton is contained in the spectrum of the massless states. Each boundary com ponent how ever carries its own quantized spinor elds and the total ferm ion num ber of 3-surface can at most be the num ber of its boundary com – ponents. This means that elementary particle quantum num bers reside on boundary com ponents in topological condensate. This is explanation of fam ily replication phenom enon in terms of boundary topology excellent predictions for lepton m asses.

b) Supersymmetrization gives color con nement as a consistency condition:

each p-adic region with xed value of p is color singlet.

c) E km entary bosons other than graviton correspond to boundary components. Boundary component spinor elds are indeed independent degrees of freedom. If CP_2 coordinates are supersymmetrized the induced gauge potentials on the boundaries have ferm ionic quantum parts and in the lowest order gauge boson quanta can be regarded as ferm ion antiferm ion pairs: this is just what physical consideration have forced to conclude years ago. The couplings of the bosonic quanta are automatically of correct form and the interpretation of K ahler action as EYM action generalizes to the quantum context. It is easy to verify that the quantum contribution to the induced metric is automatically of order p so that gravitational interaction strength has correct order of magnitude automatically.

c) In TGD quark color triplets correspond to color partial waves, which are expressions in CP_2 coordinates xed uniquely by group theoretical considerations P itkanen_a]. There is however a problem in at M⁴ background since CP_2 coordinates are constant. One possibility is to allow color partial waves in CP_2 cm degrees of freedom of quark. Second possibility is classical description by xing the classical color charges associated with the world line of point like quark. Supersymmetrization suggests a third manner to overcome the di culty. The partial waves can be constructed using purely quantal CP_2 coordinates K^k and are clearly a purely nonperturbative phenomenon!

6.1.4 Can one reproduce the Super V irasoro representations associated with elementary particles?

A basic test for the tentative scenario is whether it can reproduce the general structure making possible the successfull mass calculations performed in \mathbb{P} itkanen. The previous considerations suggest that K ac M oody spinors correspond to representations of Super V irasoro transformations, which act on world line coordinate t and on the complex coordinate of the boundary component so that generators are simply sum s of the corresponding generators and one can understand string mass formula.

The rules for constructing K ac M oody spinors are following. a) Single two-dimensional spinor corresponds to a p-adic counterpart of a unitary discrete series so(4) representation (c;h) = (0;0) representations [G oddard et al]. K ac M oody counter part of H -spinor corresponds to 4-fold tensor product of these representations, two representations in M⁴ and two representation in C P₂ degrees of freedom. These representations give rise to K ac M oody version of Lorentz group so (3;1) and so (4). To get K ac M oody spinor elds one adds two additional tensor factors. The group U (1) associated with K ahler potential of C P₂ gives rise to additional tensor factor and color su (3) gives further tensor factor. It turned out that su (3) is unique am ong Lie groups in that it allows physically acceptable (c;h) = (0;0) Super V irasoro representation.

b) G auge bosons correspond to N-S type representations in each tensor factor. Quarks correspond to R am ond representations in each tensor factor. Leptons are exceptional in the sense that they correspond to N-S representations in su (3) factor rather than being R am ond type in every tensor factor.
c) The super partners of various particles have quantum numbers of leptoquark in N-S representations so that N-S type super generators transform quarks into leptons and vice versa. In R am ond representations super generators conserve ferm ion number.

Is it possible to reproduce these structures in the proposed scnenario? One can restrict the consideration to boundaries and each boundary component carries its own spinor elds satisfying its own Super V irasoro conditions. a) Right handed neutrino generates N = 1 super symmetry and respects ferm ion number conservation whereas kappa symmetry transforms leptons into quarks. Localizing N = 1 supersymmetry generators using half odd integer or integer powers of M one obtains anticommuting Super V irasoro generator in R am ond and N-S type representations respectively. K appa symmetry has the properties needed to generate N-S type generators if one assumes that leptonsmove in integer modes and quarksmove in halfodd integer modes obtained as square roots of planew aves associated with leptons.

b) A lthough the action of K appa symmetry transforms quarks into right handed neutrino and vice versa, the states of N-S representations are eigenstates of baryon and lepton number: in particular, bosons possess vanishing B and L. The point is that the state, which is created by applying several operators $F_{n+1=2}$ vanishes unless the oscillator operators associated with right handed neutrino and its antiparticle anticom mute pairwise to identity: this in turn implies that the quark number of the state vanishes. G-parity rule stating that only even or odd number of $F_{n+1=2}$ is appear in the operator creating the state in plies that all bosons have B = L = 0.

c) One can construct local canonical transform ations and as a special case color transform ations by multiplying the H am iltonians with an analytic function of M⁴ coordinates. Super symmetrization of the algebra is achieved by calculating the commutators with fermionic super V irasoro generators. d) Local so (4) u(1) is obtained makes sense as broken symmetry, when boundary components are idealized with world lines and localization is achieved by multiplying the generatores with some function basis $f_n(t) = t^n$ world line coordinate. A gain one must assume that leptons and quark type KM spinors on world line correspond to real p-adic plane waves and their square roots respectively.

O ne must keep in m ind that the previous arguments say nothing about the realization of super conformal or D if f (M 4) invariance in the interior. In the interior D if f (M 4) seems to be a more appropriate symmetry and super version of this symmetry for fermions probably involves only R am ond representations and N = 1 symmetry since the kappa symmetry is need not be well de ned in interior (the trace of the second fundamental form is not covariantly constant and can vanish).

6.2 The action of super D if f (M⁴) (conform altransformations)

D if f (M 4) (conform al) transform ation can be regarded as active transform ations in M 4 (boundary components). One must replace the ordinary coordinate h^k with h^k_s in the expression for the in nitesimal generators of the D if f (M 4) (conform al) transform ation

Here subscript F = super=kappa refers to super sym m etry or kappa sym m etry and C to D if f (M 4) (conform al) sym m etry.

It is not at all clear whether kappa symmetry makes sense in interior whereas on the boundaries kappa symmetry is necessary in order to reproduce the physical picture suggested by the mass calculations. The generator of the might-be K appa symmetry is obtained by multiplying u_R in the definition of super symmetry by $K = n_k^{\ k}$, where n_k is the unit vector eld associated with the trace of the super symmetrized second fundamental form. For minimal surfaces n_k is ill de ned. The trace vanishes for the standard in bedding of M⁴ and also for the gravitationally warped surfaces if the C P₂ projection of the surface is geodesic circle. On the boundaries situation is di erent. W hen boundary components are idealized with world lines with the property that S^kS_k = M² (S_k is the bosonic part of the ordinary second

fundamental form) hold true, the unit vector exists. Note that the existence of 1= H^kH_k does not produce problem s if the bosonic part of H^k is nonvanishing. It will be found that the value of H^kH_k on boundaries is completely xed.

The simplest guess is that super D if f (M⁴) (V irasoro) generators are obtained by suitably localizing N = 1 super symmetry and kappa invariance. The explicit form of the generators can be deduced using following arguments. For simplicity the consideration is restricted to conform algenerators on boundary components. The generalization to D if f (M⁴) generators acting on interior is obvious: the only difference is that both quarks and leptons correspond to R am ond type representations in interior and only N = 1 supersymmetry is needed.

a) The square of the supergenerator is lightlike translation $u_R^{k}u_R$ and therefore proportional to the generator L $_1$ multiplied by suitable p-adic number in 4-dimensional extension. Same applies to kappa symmetry. Hence the conformal weight of super and kappa symmetry generators is 1=2. Super generator and kappa generator behave essentially as G $_{1=2}$ and it turns out that the anticom mutators of the local super/kappa symmetry generators how ever contain spin rotation term and therefore also local super generators must contain analogous term, which must vanish for super generator and kappa generator. A little consideration shows that this term must act as vector eld in M ⁴ degrees of freedom.

b) The simplest guess for R am ond generators is following

To see that the ansatz works for a suitable choice of the parameters k_n some calculation is needed. It is enough to study the anticommutator of R am ond generators since the calculation for N-S case is essentially identical. a) Supercoordinate is annihilated by the action of local super symmetries G_n^0 so that only the derivative with respect to or appearing in the fermionic part appears in the anticommutator of local supersymmetries G_n^0 and one has

For this choice the anticom m utator of the oscillator operators associated with covariantly constant right handed neutrino gives c-number term and the action of derivative operator reduces to the action of the light like translation generator and thefore the anticom m utator is proportional to the spin rotation term of L_{m+n} . With a proper choice of k_R and normalization of Super V irasoro generators it is possible to get correct anticom m utation relations. In N-S case one obtains similar result. Note that n = 1 does not produce trouble since spin rotation term vanishes in this case and only the second term in anticom m utator contributes.

The general expressions for D if f (M 4) currents can be deduced from the general form ulas of appendix. The contribution of ferm ions to the conform all current has besides the term proportional to energy momentum tensor also a spin term proportional to ℓ_{1jk} kl . The spin rotation term does not vanish.

6.3 Localcolor sym m etry and localcanonicaltransform ations in interior

Local canonical transform ations are generated by H am iltonians, which have arbitrary dependence on M 4 coordinates

The change in the induced K ahler form is vanishing so that the change in action comes from the change of induced metric and is very small. Conformal canonical transformations are obtained by restricting the functions f to functions M^n . The algebra contains local color transformations as a subalgebra.

In this expression h^k is replaced with k_s^k everywhere. Here the covariant derivative contains also the U (1) part necessitated by the acceptable spinor structure of H and k is integer, whose value is determined by the coupling to K ahler potential and proportional to ferm ion number, which is one third for quarks. H denotes the H am iltonian of the canonical transform ation. The action of the canonical transform ation on spinor connection in plies additional terms in conserved current, which cancels the noncovariant piece proportional to A_k in the conserved current and only the spin rotation term and H am iltonian term are left. H am iltonian term. The variation of gives also a contribution to the current.

C anonical transform ations generalize to supercanonical transform ations just as conform altransform ations do and one obtains R am ond and N -S type representations of super canonical sym m etries. The currents associated with super canonical transform ations are obtained by applying the general receipes of A ppendix.

6.4 Realization of D if (M^4) invariance allow s graviton.

D if f (M⁴) tranform ations and their super counterparts act as approxim ate sym m etries of the theory in the interior of the spacetim e surface. This means that the approxim ate sym m etry group is even larger than the group of p-adic conform al sym m etries and that the theory is analogous to topological eld theory. This is rather satisfactory feature since it gives naljustication for the hypothesis that partons correspond to boundary components. The result how ever raises the question whether the spectrum in the interior contains any D if f (M⁴) invariant states besides vacuum state. Physical intuition suggests that graviton and possibly som e m assless partners of the graviton should be contained in the spectrum (after all, the starting point of TGD was to construct Poincare invariant theory of gravitation!) The problem is to understand how graviton can circum vent the extrem ely tight constraint of D iff (M⁴) invariance. Standard anticom mutation relations for ferm ions seem to imply essentially topological eld theory. It turns out that p-adic m assless of ferm ions allow to circum vent the di culty.

The point is that p-adic planewaves with positive p-adic m om entum k are only needed and k! k de nes com plex conjugate and functions expressible as Fourier series of negative m om enta belong to the dual of the function space. This im plies that ferm ionic creation operators correspond to m om enta k with each $k_i > 0$ and possessing nite number of positive pinary digts. The following m odi ed de nition of ferm ion vacuum so that time and spatial directions are treated in same m anner

On any light like geodesic = 0, with p and parallel, these commutation relations become trivial. The central extension parameter c for D if f (M⁴)

are expected to be vanishing since the only source of c-number terms is normal ordering of the ferm ion generators in the expressions for translation generators J (;0). In the lowest order the only possible source of normal ordering terms is spin rotation term, which however vanishes identically for translations. One can again de ne D iff (M⁴) generators associated with negative p-adic m omenta as H erm itian conjugates of the positive m omentum generators and they act in the dual of the function space.

D if f (M⁴) generators J(; n) and other gauge group generators must annihilate physical states if n is nonzero and n_i are nonnegative:

and it turns out that these conditions allow massless states. Translations correspond to generators J (;0) and these generators cannot annihilate non-vacuum physical states. That complete D if f (M⁴) invariance is not required is in accordance with the fact that D if f (M⁴) invariance broken by gravitation.

Consider now the action of D if f (M 4) generators J ; $_n \, n_i \quad 0$ on a state created by a ferm ionic creation operator with light like momentum p with positive components. The action of D if f (M 4) generator on the oscillator operator is induced from its action on planewave with momentum p and the action m ust be of the form

The action vanishes if and p are parallel or lies in transversal polarization space to p. The action gives annihilation type operator, when n has m om entum component n_{perp} in transversal polarization space of p since n_{perp} has positive components so that states created using only oscillator operators with m om enta in direction of p are autom atically annihilated by these D if f (M⁴) generators. W hen is in light like direction conjugate to p and n is in two-dimensional M inkow skian place spanned by p and its light like conjugate the action is nonvanishing. The resulting oscillator operator is creation type operator for p_3 n_3 0 so that one obtains nite number of conditions. A ctually the conditions are equivalent with the ordinary V irasoro conditions. The representation in question is reducible since there there are several types of ferm ionic oscillator operators labeled by their electroweak quantum numbers. This means that nontrivial solutions of the V irasoro conditions are obtained and the number of the solutions is actually in nite. Therefore there are good hopes of obtaining graviton and its companions as D if f (M⁴) invariant states. A dditional constraints com e from Super D i generators.

There are also additional conditions coming from the canonical invariance of the states. Canonical transform ations induce CP_2 spin rotation and U (1) transform ation on the states and this means that canonical invariants must be constructed as Fourier components with momentum p of spin vector currents

^k invariant under CP $_2$ spin rotations and U (1) rotations. can have either lepton or quark type chirality.

Here ^k is M ⁴ gam m a m atrix and creation operators corresponds to either quark or lepton chirality: spin indices are written explicitely. Canonical invariance drops from consideration m assless one-ferm ion states and only integer spin states with vanishing B and L remain under consideration. The quantities B (p;) can consists of quark or lepton type creation operators.

The constraints coming from Super symmetry are satisfied if one drops from k away the part quadratic in oscillator operators associated with right handed neutrino and replaces M 4 coordinate with its super counterpart in p-adic planewes so that p-adic planewaves become supersymmetric. In a concise form one can express the invariants B as

Only two transversal polarization vectors are needed. The operators B (F;p;) commute with each other and the commutators of D if f (M 4) generators with

operators B are proportional to operators B them selves and D i invariance conditions for state with momentum p = n reduce to V irasoro conditions for L_k , k = 1; :::n. This implies that D if f (M⁴) invariant states form algebra and the problem is to identify the generators of this algebra as monom ials of operators B. The generators are labeled by the numbers N (L) and N (B) of B (L; ::) and B (q; ::) in the monom ial, by polarization tensor $k_{1:::n}$ in transversal degrees of freedom (spin) and by the totalm om entum p. A possible interpretation of the generators is as elementary bosons and the products of generators as m any boson states with collinear m om enta. If this interpretation is adopted one obtains dilaton, antisym m etric tensor (J = 0) and graviton as elementary bosons. H igher spin states can perhaps be regarded as m any boson states.

a) N = 1 states are just zero m on entum spin one states created by B (F; ;0), F = L; q.

b) N = 2 states are of type B (L)B (L), B (q)B (q) and B (L)B (q). For p > 2 states V irasoro conditions allow no solutions and only possible states have p = 0 or p = 1. N = 2 states with zero m om entum are obtained as products of spin 1 generators: also spin two is possible. p = 1 states are possible, when zero m odes are allowed. The states are of the form

 L_1 V irasoro condition is satisfied by antisymmetry under exchange F_1 \$ F_2 . B (L)B (q) states allow dilaton, antisymmetric tensor (J = 0) and graviton. For B (F)B (F) only antisymmetric tensor state is possible.

c) For N = 3 one obtains p = 0 and p = 1 states constructed as products of N = 1 and N = 2 states: the largest spin of this kind of state is J = 3. It seems that no N = 3; p = 1 generating states exist. Spin one state with nonvanishing momentum is possible and this is due to the fact that only two polarization vectors are at use.

d) For N = 4 one obtains products of p = 0;1 generating states. Spin J = 4 is possible for two graviton state. A loo p = 2 graviton and scalar state containing B (L; ; p = 2) is possible in leptonic sector and is constructed using the operator B (L; ; p = 2)B² (L; +;0)B (L; ;0). This state is obtained as a special case of a more general construction procedure.

The states constructed do not include any higher spin exotic states. States with arbitrarily large values of N and p are possible and state space has natural shell structure as the following arguments show.

i) To construct a state containing B (L; ;p = 2) operators construct rst a zero momentum vacuum using the operator B (L; $_+$;0)²BB (L; ;0). This state has spin J = 1 since the lacking right handed neutrino pair acts as a spin 1 hole. This state is annihilated by leptonic creation operators with p = 0. For quarks corresponding state is created by B² (q; $_+$;0)B² (q; ;0) and has vanishing spin. This state satis es gauge conditions and is analogous to full electron shell in atom ic physics. Apply to this state operators B (F; ;2). The resulting states satisfy gauge conditions autom atically by ferm ion statistics. ii) The procedure can be continued. Fill rst p = 1 shell using using 3 (4) leptonic (quark like) operators B (F; ;p = 2 = n). By commutativity of B operators only the p = 1 ferm ionic creation operators are elective in this state. The new vacuum has spin J = 2 (J = 0) for F = L (F = q) and applying B (F; ;p = 4 = 2n) operators one obtains a new shell containing p 2 ferm ionic creation operators.

iii) It it is obvious that the procedure can be continued inde nitely and one obtains in nite number of states. The resulting states can be regarded as many particle states if full shell is regarded as a new vacuum state. The vacuum states in turn can be regarded as many boson states constructed from previous vacuum state and states are just products of leptonic and and quark type states unlike the states obtained directly from the vacuum. This suggests that only the N = 2; p = 1 generators should be regarded as operators creating single particle states. The peculiar consequence of the supersymmetry is the possibility of states possessing arbitrarily large spin consisting of J = 1 holes made from pairs of right handed neutrinos.

6.5 Local so(4) u(1) is broken in standard manner

K ac-M oodyt spinors used in the mass calculations are representations of the local so (4) and u (1) K ac M oody algebras and Q uantum TGD as well as the success of the mass calculations suggests that local so (4) u (1) do not act as gauge symmetry of the K ahler D irac action.

The natural identication of so(4) u(1) is as the gauge group of CP₂ spinor connection. G lobalU(1) is exact symmetry. so(4) rotations are exact

sym m etries only for the surfaces possessing one-dimensional CP_2 projection in plying vanishing of the induced gauge elds. This condition is in general not true. Condition however holds true, when the orbits of the boundary components are idealized with world lines so that global so(4) is good approximate sym metry at parton level, whereas it is broken in the interior of the spacetime surface.

The localized so (4) u (1) transform ations are not exact sym m etries in the point particle lim it. The change of D irac action density in a local gauge transform ation reduces to a total divergence by the conservation of the charges associated with the global transform ations if the the trace of the second fundam ental form vanishes: this is not how ever the case.

Here Q is the generator of the local gauge transform ation. Nonconservation term in general doesn't vanish: it diers from conserved charge in that anticommutator of A and ^t is replaced with commutator and the commutator does not in general vanish.

The term X characterizing local charge nonconservation leads to the standard form of electroweak symmetry breaking. For left handed charges Q (I_L^1 and I_L^2 associated W bosons) it is impossible to nd t commuting with Q. For either purely vectorial or axial generator it is possible to satisfy the commutatitivity condition. Electrom agnetic charge is the only purely vectorial electroweak charge and the vectorial generator t_1 appearing in electrom agnetic charge commutes with t when the condition

The commutativity of ^t with Q_{em} can be taken as additional condition on the time development for the world line of the boundary component in CP_2 degrees of freedom: this condition is equivalent with the conditions stating that the projection of the world line is orthogonal to e^A , A = 1;2:

Here e_k^A are the components of the vielbein vectors of CP_2 and in plies that induced W elds vanish on the world line. This guarantees that di erent charged states for spinor eld are not mixed and electrom agnetic charge conservation results. The conditions imply that in standard coordinates (r; ; ;) (Pitkanen a)) the coordinates and are constant on the world line of the particle. One must however notice that p-adic di erentiability allows and to depend on nite number of positive pinary digits of time variable so that these variables are constant only below some time scale.

It is interesting to exam ine this condition, when M 4 projection of world line is geodesic line. Combining the condition with the requirement that S^k is covariantly constant along world line (this guarantees the condition $S_kS_k = M^2$) one obtains the conditions

where A and B are p-adic constants depending on nite number of pinary digits of the time coordinate. The resulting conditions give two second order di erential equations with 4 p-adic integration constants corresponding to

xing arbitrarily nite number of pinary digits for (r;) and (dr=dt;d=dt) as a function of t. One must notice that conservation laws give constraints, which reduce p-adic nondeterm inism. For instance, p-adic geodesic lines of M 4 should look like ordinary geodesic lines. Furtherm ore, if p-adic derivative is algebraic operation as it is for p-adic planew aves p-adic nondeterm inism is lost.

6.6 Lorentz invariance and local Lorentz transform ations

The rst problem related to the realization of p-adic Lorentz invariance is whether the p-adic convergence cube for square root function is invariant under Lorentz transform ations or its subgroup. Real word geom etric intuition suggests that this is cannot be the case. p-Adic Lorentz group is however quite di erent from its real counterpart. The existence of the exponent for Lie-algebra elem ent requires that the elem ent is proportional to ${}^{p}\overline{p}$ at least. This means that the real conterparts of Lorentz transform ations related continuously to identify are sm alland these transform ations form a group. If the convergence cube has size L_{p} then Lorentz transform ation with generators are proportional to ${}^{p}\overline{p}$ at least leave the convergence cube invariant.

M om entum spectrum is not invariant under small Lorentz transform ations. p-A dic convergence cube in plies infrared cuto in m om entum : choosing scale suitably suitable the m om entum com ponents have the expansion

The cuto is obviously particle in the box e ect. Sm all Lorentz transform ations do not leave this expansion invariant since they induce non allowed p-adic digits to m om entum components: the contributions of these digits to the real counterparts of m om enta are extrem ely sm all. Perhaps one must just accept the noninvariance of the m om entum spectrum under Lorentz transform ations as a physical fact. The lowest order contribution to the energy is given by rest m ass and is of order O ($p^{1=2}$) and Lorentz invariant since sm all Lorentz transform ations induce only O ($p^{3=2}$) correction to energy.

O ne must emphasize that there are also 'large' Lorentz transform ations for which nondiagonal matrix elements are of order O (p^0) . The orthogonoality conditions for the matrix elements of these transform ations give strong number theoretic constraints on the matrix elements of these transform ations. An especially interesting subgroup of Lorentz group is rational Lorentztransform ations. It is impossible to generate them using exponential map since exponent function does not converge for Lie-algebra element having padic norm one. It would be interesting to understand the detailed physical consequences deriving from the factorization of the p-adic Lorentz transformations into a product of large and small transform ations. Perhaps the so called nonrelativistic regime corresponds to small Lorentz transform ations leaving p-adic convergence cube invariant.

Local so (3;1) appears also in the context of K ac-M oody spinors and one can wonder whether these transform ations are local sym m etries for boundary-

components in the point like limit. Exactly the same arguments as before can be carried out as for local so (4) to nd that those local Lorentz transformations for which the charge generator $Q = q_{k1}^{k1}$ commutes with ^t de ne local worldline symmetries broken by gravitation only. Not suprisingly, this group is the isotropy group of four-momentum and for p-adic geodesic lines the group in question is independent of t in su ciently short time scales.

7 KahlerD irac action and general eld equations

In the sequel K ahler action and $% \mathcal{A}$ educations will be discussed in a more detailed form .

7.1 Kahler D irac action

K ahler action density in the interior is given by

In this manner the real counterpart of the p-adic K ahler coupling strength does not deviate too much from its realvalue. K ahler action can contain also a boundary term, which is Chern Sim ons type term, which we do not bother to write explicitly here.

In \mathbb{P} itkanen_a] it was suggested that induced gam m a m atrices describe the presence of ferm ions but it seems that the proper interpretation is as a new bosonic eld. D irac action contains also parts associated with the boundaries of X⁴ and each boundary component carries its own spinor eld so that boundaries become carriers of ferm ion numbers: this is the only m anner to achieve conservation of ferm ion number currents in Q uantum TGD. The D irac action for boundary component has exactly the same form as the interior action and we do not bother to write it explicitely.

Super sym m etrization of K ahler D irac action is achieved by adding Super sym m etric part to the bosonic coordinates. This is in accordance with general coordinate invariance if physically preferred coordinates are chosen for H. The coordinates in question are standard M inkow ski coordinates for M⁴ and complex coordinates of CP₂ transforming linearly under su (2) u (1): as a by product color singletness of physical states emerges as consistency requirement.

7.2 Field equations in the interior

Field equations are interpreted as eld equations for the eld ective action de ning ferm ionic eld theory in average space time associated with a given quantum state. This implies the needed back-reaction from matter to geometry. In particular, for diagonal matrix elements of bosonic eld equations one obtains dierent ferm ionic source term for each state and background spacetime depends on the quantum numbers of the state. It is convenient to allow bosonic solution to depend on maximal number of commuting operators de ning the quantum numbers of the state. In particular, background spacetime depends on various YM charges and on the four-momentum of the state. If boundary components are treated as point like objects, the square for the trace of the CP₂ part the second fundamental form gives modular contribution to the mass squared of ferm ion.

It seems natural to solve the eld equations by starting from the standard in bedding of M⁴, to solve ferm ionic D irac equation and then calculate the change of the space time metric (or deviation of C P_2 coordinates from constancy) by requiring that bosonic eld equation remains true in given state

with momentum P^k. Gravitational warping is in some sense the lowest order backreaction e ect and depends on the four-momentum of the state, only. This e ect is necessary in order to guarantee well de nedness of perturbation series.

The general eld equations of the theory are obtained by varying the action with respect to h^k and . It is convenient to use h_s^k ; h^k and as basic variables and introduces the de nition of super coordinate as a constraint to the action density:

Consider rst the variation with respect to h_S^k in the interior: the eld equations are obtained from the eld equations of nonsupersymmetrized action by replacing h^k with h_S^k and by adding constraining term $_k$ to the right hand side.

The covariant derivatives appering in the various expressions contain both the ordinary R iem annian connection acting on X 4 indices and the R iem annian connection of H acting on H indices.

The functional derivatives of D irac action with respect to H-coordinates are

D ivergence of the energy m om entum tensor com es from the variation of m etric and term proportional to k com es from the variation of induced gam m a m atrix. The term proportional to spinor curvature F_{kl} com es from the variation of spinor connection and divergence of energy m om entum current com es from the variation of m etric.

The resulting interior eld equations have the character of hydrodynam – ical conservation equations. Only four of them are independent by general coordinate invariance and for surfaces representable as maps M⁴! C P₂ the equations can be replaced with equations stating conservation of fourmom entum density obtained by contracting the canonical energy momentum tensor T of K ahler D irac action with the gradients (m^k . Probably the situation is same now since k vanishes for M⁴ indices.

The variation with respect to hk a ects only the constraint term and gives

so that the constraint force $\ ^k$ vanishes in both M 4 and C P_2 degrees of freedom and eld equations associated with H coordinates are just standard equations with h^k replaced with $h^k_{\rm S}$.

The variation with respect to gives the D irac equation for the induced spinors in interior with h^k ! h^k_s replacement and additional source term coming from the variation of the constraint equation

The presence of second fundam ental form implies mixing of M 4 chiralities. The constraint force term vanishes by previous results so that eld equations are of same form as in standard theory.

The vanishing of $\frac{1}{k}$ implies complete decoupling of Kahler and D irac actions as also happens in Q uantum TGD.One just takes the absolute m inimum of ordinary p-adic Kahler action and replaces the H coordinates with their supersymmetrized versions with solved iteratively from D irac equation.

The equations for H-coordinates must be posed as conditions on physical states analogous to and probably equivalent with V irasoro conditions. This means that Super V irasoro condition could well be an approximation to the actual eld equations true only in the limit that CP_2 metric gives no contributions to the induced metric. Same conclusion applies to canonical invariance and its super counterpart.

7.3 Field equations on boundaries

The eld equations on boundaries can be derived straightforward manner. a) D irac equation on boundary reads as

Interior spinors act as a source term for boundary spinors.

b) Field equations for $h^k(x)$ state that the functional derivatives of total action with respect to $h^k(x)$ vanish on boundaries. The functional derivative of totalK ahler action including Chern Sim ons term on boundary is given by

J denotes the dual of induced CP_2 K ahler form. It is assumed that the ratio of the coe cients k_1 and k_2 multiplying M axwell action and Chem Simons term respectively in the de nition of K ahler function equals to $k_1=k_2=1$ (for various de nitions see [Pitkanena]).

c) The functional derivative of the D irac action with respect to $h^k(x)$ on boundary is given by

The index B refers to boundary in the above expressions. F_{k1} denotes the components of spinor curvature.

These equations have counterparts for K ac M oody spinors and should take care of conservation laws besides giving the KM D irac equation.

8 General solution of eld equations

8.1 Perturbative solution

The general solution of the eld equations is obtained by expanding $% \left({{{\bf{n}}_{\rm{s}}}} \right)$ in powers of K / p

and solve $_n$ iteratively power by power. Since the super part of H $\,$ coordinate is proportional to K $\,/\,$ p, one indeed obtains rapidly converging power series in K .

a) The lowest order (K 0) eld equation is in at space case just the ordinary massless D irac equation for the induced spinors and classical eld equations for the extrem als of K ahler action. ^k vanishes in this order.

b) Substituting the solutions of K⁰ equations to eld equations and writing

them in rst order in K one obtains D irac equation for 1 with source term coming from the currents J^k de ned by 0 . ${}_1$ can be expressed as a convolution of propagator with the source term just as in ordinary quantum eld theory.

c) O ne can continue the iteration in sim ilar manner but in practice few low – est orders should give the essentially exact solution for physically interesting values of p of order 10^{38} . The condition for convergence is that gradients of C P₂ coordinates are of order K at most.

8.2 Perturbative construction for the solution of eld equations for nonwarped M 4

F lat space background theory should be all what is needed for the application of the theory in particle physics context. A lthough the gravitational warping of M 4 must be taken into account in realistic theory it is useful to look the construction theory must for the standard in bedding of M 4 .

In the lowest order one obtains just the massless D irac equation in the background determined by the classical induced spinor connection of C $\rm P_2$. In the standard M 4 background one has

The most natural basis for the spinors is the p-adic planew ave basis. The use of planew aves is natural since p-adic convergence cube is the analog of the nite string world sheet obtained by the logarithm icm apping z ! w = ln (z) from in nite complex plane and M⁴ coordinates are just the counterpart of complex world sheet coordinate w = +i.

The next order in p introduces interactions and the D irac equation contains gauge potential term given by the super part of the CP_2 coordinates de ned by $_0$. A loo the induced m etric contains term, which how ever gives only a total divergence to the action in accordance with the idea that gravitional interaction is weak and therefore O (p^2) e ect. One obtains form ally m assless D irac equation for $_1$ so that $_0$ de nes a source term. One can solve $_1$ as a convolution of the free eld propagator de ned by quantized $_0$ with source term. O ne m ust how ever take this argument very cautiously. The norm all ordering of the oscillator operators in the source term gives via anticom mutators a term linear in oscillator operators and that mass term might be generated.

The procedure can be continued. In fourth order in p (order is simply the maximal number of ferm ion currents in interaction term) K abler action density gives nontrivial contribution to the interaction Lagrangian. This contribution can be interpreted also as EYM action for the induced gauge eld and metric as proposed in Pitkanen_a]: the di erence with respect to the standard theory is that quantum gauge elds are ferm ion antiferm ion composites.

There are good reasons to expect that perturbation expansion leads to the replacement of the planewaves f_P with their quantized counterpart obtained by replacing M⁴ coordinate with its super symmetric version. In fact, if one takes M⁴ super coordinates as coordinates instead of M⁴ coordinates one obtains automatically super symmetrized planewaves. The exponential is just the TGD wish counterpart for the standard vertex operators appearing in string m odel and n-point functions for various elds automatically contain this kind of vertex operator.

8.3 The e ect of gravitational warping

F lat space approximation works for the vacuum expectation value of the bosonic eld equations only. The general matrix element of the bosonic eld equation implies the dependence of H coordinates on various conserved quantum numbers. The most important of these quantum numbers is 4-momentum. The previous considerations suggest that standard imbedding of M⁴ is simply replaced with a warped version of M⁴.

G ravitational warping is indeed necessary to make the loop summations appearing in perturbation theory well de ned and to remove propagator poles. This is achieved assuming that

i) propagator is de ned in term s of warped metric

ii) the plane wave state basis is de ned as state basis associated with ordinary massless D irac operator, to which D irac operator reduces in lowest order approximation.

The use of standard planew ave basis is in principle possible. A possible good

reason for using this state basis is that the planewave basis associated associated warped metric does not satisfy the required ortogonality relations unless one scales the sides of p-adic convergence cube in appropriate manner.

For the most general gravitational warping D irac operator contains mass term proportional to second fundam ental form H k :

If this term is covariant constant m ass term can be included in propaator. Covariant constancy means that the CP_2 projection of warped M⁴ can be regarded as a path of particle in covariantly constant force eld in CP_2 . A little calculation shows that second fundamental form is proportional to P² for gravitational warping and therefore vanishes for massless states.

9 Some open questions

It is good to list som e of the open questions not explicitly mentioned in the text.

9.1 Description of hadrons as p-adic string like objects?

The basic assumption of p-adic approach is super conform al invariance for boundary components. Hadron mass calculations of fourth paper of P itkanen_c] are based on general features of Super conform al invariance and doesn't exclude either the description of hadron as 'bag' or as a string. Therefore one must consider also the possibility of more general spacetimes such as string like objects suggested in basic TGD as description of hadrons P itkanen_a]. The form ulation of the p-adic eld theory is form ally possible arbitrary spacetime topology and approximate symmetries are same as in M⁴! CP₂ provided CP₂ contribution to metric is small. A particularly interesting possibility is the description of hadrons as string like objects. In this case the basic vacuum topology would be X² Y² 2 M⁴ CP₂, Y² being Lagrange manifold and X² two-dimensional string like object in M⁴. These surfaces are vacuum extrem als and canonical transform ations produce new vacua of this type. M ore general vacua are obtained as maps X 2 Y 2 to M 4 and physical hadrons should correspond to 'thickened' strings with transversal dimension of order hadronic length. Quarks and gluons would correspond to boundary components for this surface. One obtains string model with dynamically generated string tension coming from the energy associated with the superpart of H -coordinates. W hat is how ever important that the general features of hadronic mass spectrum are determined to high degree from the p-adic therm odynam cis of boundary components and universality for critical systems suggests that the predictions of string model description do not di er much from the predictions of 'bag' model description.

9.2 Kac M oody spinor concept

There are good reasons to hope that the treatment of the boundary components by idealizing them with point like objects and using second quantized K ac M oody spinors provides good practical description of elementary particle physics. The justication of the K ac M oody spinor concept from the properties of p-adicized K ahler D irac action remains however to be found.

The main technical problem related to the second quantization of K ac M oody spinors is the construction of the action of bosonic K M spinors on the ferm ionic and bosonic K M spinors to make possible the concrete realization of m inim all coupling gauge action.

9.3 The values of length scale L_0 and K ahler coupling strength

In this work a consistency argum ent leading to correct values for the length scale L_0 and K ahler coupling strength was represented but the actual deduction of the value of L_0 and K ahler coupling strength from Q uantum TGD remains lacking.

10 Appendix: Conserved currents

The currents associated with conformal and canonical transformation can be deduced using standard formulas. The general form of transformation is given by

The change of spinor eld come from gauge rotation associated with the tranformation. In CP_2 degrees of freedom there is also a term proportional to the Ham iltonian of the canonical transformation acting as U (1) gauge transformation. The details are given in main text.

The change of super coordinate can be derived using the constraint equation $h_S^k = h^k + K$ (h_S^k). A little calculation shows that super part of coordinate su ers a mere spin rotation so that one has

In this formula contains only spin rotation term and H am iltonian term since the term proportional to spinor connection drops from the transform ation formula. Similar formulas can be derived for boundary contributions. The spin rotation term gives ferm ion conform al spin 1=2. Ferm ions possess also canonical spin comming from spin rotation in CP_2 degrees of freedom and canonical u (1) charge, which is essentially ferm ion number (1/3 for quarks).
