CLASSICAL AND QUANTUM MANY-BODY DESCRIPTION OF BREM SSTRAHLUNG IN DENSE MATTER

A bstract

Som e considerations about the importance of coherence e ects for brem sstrahlung processes in non (equilibrium dense matter (Landau - Pomeranchuk - Migdal - effect) are presented. They are of particular relevance for the application to photon and di-lepton production from high energy nuclear collisions, to gluon radiation in QCD transport, or parton kinetics and to neutrino and axion radiation from supernova explosion and from hot neutron stars. The soft behavior of the brem sstrahlung from a source described by classical transport models is discussed and pocket correction form ulas for the in-m atter radiation cross sections are suggested in terms of standard transport coe cients. The radiation rates are also discussed within a eld theory (Schwinger - Kadano -Baym -Keldysh) non {equilibrium quantum form ulation. A classi cation of diagram s and corresponding resum m ation in physically meaningful terms is proposed, which considers the nite damping width of all source particles in matter. This way each diagram in this expansion is already free from the infra{red divergences. Both, the correct quasi{particle and quasi{classical lim its are recovered from this subset of graphs. Explicit results are given for dense m atter in therm alequilibrium. The diagram m atic description m ay suggest a form ulation of a transport theory that includes the propagation of o {shell particles in non {equilibrium dense matter.

1 Introduction

The importance of coherence time e ects on the production and absorption of eld quanta from the motion of source particles in non-equilibrium dense matter has rst been discussed by Landau, Pomeranchuk, Migdal (LPM) [1,2] (and many others later) in the context of brem sstrahlung from ultra { relativistic electrons undergoing multiple rescatterings on C oulom b centers. The st successful measurem ents of the corresponding suppression of brem sstrahlung have been carried out at the Stanford Linear A coelerator C enter very recently [3]. W ith this paper² we like to supplement some quite intuitive and also form al considerations, which illustrate the nature of production and absorption processes in a dense matter environment. The subject is of quite general nature and applies to m any physical problem s, where either a source couples weakly to a wave eld or for the proper determ ination of local gain and loss terms in quantum transport. Examples are the application to photon, or di-lepton production from a piece of dense nuclearm atter or hadron gas form ed in high energy nuclear collisions, for gluon or parton radiation and absorption in QCD transport and its practical in plem entation in parton kinetic models (such problem s are discussed, e.g. in [5,6]), to neutrino and axion radiation from supernovas and neutron-star matter (see [7,8,13,10]), for the soft phenomena in quantum cosm obgical gravity (see [11]) and also for many condensed matter phenomena, as particle transport in metals and sem iconductors, radiation in plasma etc. (see [12,13]). To be speci c, however, we take the example of electrodynamics, considering photon production from a piece of nuclear matter, but when appropriate comment on other cases. Since throughout the paper we discuss the corresponding proper self energy of the produced particle, all considerations given also apply to gain and loss term s of other particles in non-equilibrium dynam ics.

In the context of high-energy nucleus {nucleus collisions [6] for example, it became quite apparent over the last years, that a justi cation of QCD transport (e.g. in term s of a parton kinetic picture) calls for a proper understanding of all soft processes. W ell known is the Rutherford singularity in scattering cross-sections of interactions m ediated by the exchange of zero m ass quanta (photons/ gluons). In dense m atter the exchanged quantum acquires a nite realmass due to Debey-screening. Singularities are also encountered in absorption or radiation processes (brem sstrahlung). Induced by free scattering the rates diverge at vanishing fourm om entum g of the radiated quantum, due to the in nite time scales used in the quasi-free approxim ation. In dense matter, however, due to the nite free propagation time ∞ between successive collisions these rates become regular. In particle physics context, most of the papers on the LPM e ect discuss the brem sstrahlung of some fast charged particle, such as hadron, quark or gluon, which traverses a dense hadron gas or quark (gluon plasm a, e.g. see refs. [14,5], where the role of the matter is reduced to in nitely massive scatterers. In reality all the particles in dense matter which couple to the radiated eld should be treated on equal footing. E ects of the nite mean free propagation time on photon and gluon radiation have been considered e.g. in

refs. [14,16{18,5].

W hile the problem can be quite simply and intuitively formulated and solved in the classical limit, where a classical source couples to a wave eld, e.g. classical charge particles couple to a M axwell eld, considerable conceptual di culties arise for the very same problem, if the source is described as a quantum m any-body system. In fact comm on standard techniques, like perturbation theory or the quasi-particle approximation (QPA) have serious limitations to describe the production and/or absorption rates over the whole range of energies and m om enta, as they completely fail in the soft limit.

Starting from a quantum many-body form ulation in term sofG reen's functions most derivations of transport descriptions employ two essential approximation steps: i) a gradient expansion and ii) the QPA. For simplicity we concentrate on the defects of the QPA in this paper. In the QPA, which is a consistent approximation scheme for low temperature Fermi liquids (Landau - Migdal, see [19,20]), all particles in the medium are treated on-shellwith a well determined energy-momentum relation (dispersion relation) which follows from the real part of the retarded self energy of the particle. To be speci c in this notion, we use the term "on-shell", when the particle follows a sharp energy-momentum relation. Thus the quasi-particle poles of the retarded G reen's function lie just in nitesimally below the causality cut along the real axis in energy. The corresponding approximation scheme in terms of these on-shell states, which have in nite life time, is called quasi-particle approximation (QPA). Due to interactions in dense matter the damping of the quasi-particles may become in portant, the corresponding "quasi-particle" poles of the retarded propagators move into the unphysical sheet below the real axis. As a consequence the mass spectrum of the particles is no longer a sharp delta function but rather acquires a width , and one talks about "o -shell" propagation. In that case one has to leave the standard description in terms of stable single particle states and employ quantum propagators (G reen's functions) with continuous mass distributions. Landsmann [21] has coined the notion of "non-shell particles" in this connection. One thus comes to a picture which unies resonances which have already a width in vacuum due to decay modes with the "states" of particles in dense matter, which obtain a width due to collisions (collisional broadening).

The theoretical concepts for a properm any body description in terms of a real time non equilibrium eld theory have already been devised by Schwinger, Kadano, Baym and Keldysh [22{24] in the early 60^{ies}. First investigations of the quantum e ects on the Boltzm ann collision term were given by Danielewicz [25], the principle conceptual problems on the level of quantum eld theory were investigated by Landsm ann [21], while applications which seriously include the nite width of the particles in transport descriptions were carried out only in recent times, e.g. [12,25{ 35]. For resonances, e.g. the delta resonance in nuclear matter, it was natural to consider broad m ass distributions and ad hoc recipes have been invented to include this in transport simulation models. However, many of these recipes are not correct as they violate som e basic principle like detailed balance [32], and the description of resonances in dense matter has to be improved. The present study also gives some hints on how to generalize the transport picture towards the inclusion of o -shell propagations in dense matter [27,30,31].

In this paper we illustrate the practical in plications of such non-equilibrium concepts at the example of particle production from the dense matter dynamics. Thus all source particles never reach an asymptotic state and naturally have a continuous m ass spectrum . In sect. 2 we derive the basic form ulas for the rate of brem sstrahlung. The classical and general quantum mechanical expressions, the latter in terms of non {equilibrium G reen's functions and self energies, are derived for the case of non { equilibrium dynamics. In sect. 3 we concentrate on the description of radiation from classical sources. We start with the brem sstrahlung from a classical di usion process, and subsequently derive the photon spectrum for a classical random walk (Langevin) process in term s of a completely regular multiple collision expansion. The low energy behavior is discussed and pocket correction formulas for the in {m atter radiation cross sections are suggested in terms of standard transport coe cients. Also nite size corrections are obtained. Then in sect. 4 we use the non {equilibrium G reen's function formalism, see $[22\{25,36,29]$, and formulate diagrammatic resummations where all quantities are expressed through physically meaningful term s. We show how infra-red convergent results can be obtained through the account of the nite dam ping width and discuss the QPA (sect. 4.5) and quasi(classical (QC) (sect. 5) limits from the corresponding in nite series of diagram s. In sect. 6 the lowest order bop diagram s for the production rate from a piece of equilibrium dense m atter are analyzed in the quantum case, both at high and low tem peratures. Conclusions and perspectives are given in sect. 7. Som e form aldetails are deferred to the Appendix.

We use rational units $\sim = c = 1.W$ henever the behavior of some quantity is discussed in the classical limit ($\sim ! 0$), $\sim w$ ill be given explicitly.

2 Basic Form ulas for the Rate of Brem sstrahlung

If the source system couples only perturbatively (to lowest order in e^2) to the electrom agnetic eld, the production or absorption rate of photons can be form ulated using standard text book concepts in terms of Ferm i's golden rule. The corresponding transition amplitude is given by the electrom agnetic current operator between the initial and nal states of the source. For dense matter problems it is more advantage to use a more general concept, where the local production and absorption rates are expressed through the current-current correlation function ³

A lthough j(x) = j(x;t) is a herm it ian operator we distinguish between j and j^y in order to designate the photon creation and annihilation vertex, respectively. The bracket h:::i denotes a quantum ensemble average over the source; quantum states and operators are taken in the H eisenberg picture.

W ith reference to the description of non {equilibrium system s, where it is advantage to use real-time non {equilibrium eld theory concepts, such as the Schwinger – K adano -B aym -K eldysh technique [22{25] we introduce the following notions

which relate the correlation functions to the proper self energies + and + of the photon, which are responsible for gain and loss (c.f. sect. 4.3). Throughout this paper we use the f ;+ g notation, de ned in detail in sect. 4 in the convention of ref. [36], chapt. 10.

The above expressions are the space and time-dependent version of the more familiar golden rule for quantum transitions between exact stationary eigenstates. Note that by de nition, c.f. (4), i is a real quantity; if integrated over phase-space

Such a form alism has been applied in many cases employing the QPA for the equilibrium G reen's functions, c.f. refs. [39,10]. However, the general form alism allows to go beyond this limit and to account for the nite damping width of the source particles due to their nite mean free path, which is the main topic of this paper.

Therefore the current-current correlation function is the central quantity of interest. In graphical form it is determined by the proper self energy diagram of the photon

W hile the n = 2 sum-rule directly follows from de nition (4) and applies to any current even non conserving, the other two use current conservation and partial integrations, known as Siegert's theorem (c.f. [38]), and therefore also require that the system has a nite space extension. (If there are no long range correlations, the n = 2 and n = 1 relations can also be used for in nite matter, if properly taken per volume). For non-relativistic currents the commutator in the n = 1 (Thom as -Reiche - Kuhn) sum-rule just becomes the sum of square charges in the system ip $i(t); J^k(t) = e^2$, where labels the constituents.

For systems in thermal equilibrium production and absorption follow the detailed balance relation (K ubo -M artin -S chwinger [15])

where T is the tem perature. They allow to write the lh.s. of the sum -rules as halfsided integrals, e.g. integrating only the production rate

These rules have been used to estimate the validity of the quasi-free scattering prescription in kinetic models [16,17]. In the classical limit, where ~! ! 0 (c.f. sect. 3.below) the lh.s. of the n = 1 and n = 2 sum -rules coincide in equilibrium, apart from a factor T=2, and the ensuing identity $2S_2 = TS_1$ is a disguised form of the classical equal partition theorem.

A further consistency check for diagram m atic elements which determ ine the self energy can be given in terms of W and identities in the case of conserved currents. Since the space-integral of j^0 gives the conserved total charge Z of the system, one m ay also use that the space integrated density-density correlator is constant in time, i.e.

which applies even in non-equilibrium cases. For isolated systems the motion of the center of mass leads to no radiation. Therefore one normally introduces e ective charges for the dimensional transformation of the source in the standard manner such that the total e ective charge vanishes $Z_{eff} = 0$.

3 Radiation from Classical Sources

In this section we discuss two examples which treat the source as a classical system coupled to a M axwell eld. This limit just amounts to evaluate the current-current correlator on the classical level⁵. We discuss the radiation caused by a single charged particle (the source), which stochastically moves in neutral densem atter. Them otion of the source is described (a) by mesoscopic transport (di usion process) and (b) by a microscopic Langevin process. Since these examples represent the QC limits of the corresponding quantum eld theory cases, we carry on the discussion in terms of the photon self energy $^+$.

3.1 Diusion Process

The motion of a non-relativistic source particle is assumed to be described by a time dependent phase-space distribution f(x;v;t) in space and velocity with convective current density $j(x;t) = e^{R} d^{3}v v f(x;v;t)$. For standard dissipative media in equilibrium the velocity autocorrelation function (integrated over space) decays exponentially in time

with A and B as a function of , q and $\mathbf{v}_0 = \mathbf{v}$ from (16). Here the ensemble average h:: \mathbf{i}_{eq} over the equilibrium distribution f_{eq} keeps only even moments of \mathbf{v} with $h\mathbf{v}^2\mathbf{i} = 3D_x$. The result complies exactly with current conservation, i.e. one veries $\mathbf{e}_0^{0} + \mathbf{i}\mathbf{q}_k^{k} = 0$.

For transverse photons terms proportional to q q drop. The corresponding spatial part of the tensor is shown in g. 1, right part. This correlation function decays exponentially as $e \times at q = 0$, and its width further decreases with increasing momentum q = jqj due to the increase in spatial resolution. The left part shows the corresponding density-density correlation (= = 0), which decays only for non-zero momentum, due to charge conservation.




Fig. 1: Density-density and current-current correlation functions, i_{cl}^{00} +(;q) and i_{cl}^{11} +(;q), normalized to the values at = 0 as a function of time (in units of 1 = x) for di erent values of the photon momentum $q^2 = 3k^2 \frac{2}{x} = \langle v^2 \rangle$ with k = 0;1;2;3.

for transverse photons. Since the correlation functions are properly determ ined from the time structure of the source, they comply with the n = 2 (and n = 1) sum -rule constraints.

There are two limiting cases where simpler analytical forms can be obtained: i) at small momentum transfers where eq. (18) can be expanded in powers of q and rewritten as to provide a propagator type form and ii) for large momentum transfers where from the expf::g part in (17) a short time G aussian behavior emerges. Thus, for small momentum transfers one nds

where obviously the essential contributions come from velocities which satisfy the C herenkov condition j_{Vj} != j_{Vj} . This lim it is independent of the relaxation rate x and coincides with the quantum one-loop diagram result in the corresponding large j_{Vj} jim it, as we shall see in sect. 6.

A lthough the above expressions give the exact solution of the m athem atical problem posed in this section, its physical interpretation has to be done with some care for the following reason. The equilibrium source distribution contains velocity components that exceed the speed of light. Therefore for the physical result m istakes of the order of exp[$3=(2 h^2 i)$] = exp[m=(2T)] are expected. This restricts the application to non-relativistic sources and for large q to space-like photons, where jqj !.

For system s with given xed mean-square velocity $hv^2 i = const$: the exact classical on-shell rate (3) at jqj= ! evidently scales as a function of != x. It properly vanishes at != 0 and at in nity. It is important to note that the rate has an upper bound of $\frac{2}{3}e^2_{0}hv^2 i$, and indeed attains its maximum value around ! x, which is collision-rate independent. For simplicity we quote the closed form obtained in the non-relativistic lim it (19), which coincides with the dipole lim it. There

O ne realizes that the ultra-violet part of the spectrum ! ______x behaves as intuitively expected, g.2: the rate grows proportional to the relaxation rate, until it saturates around ! ______x. For the soft part ! ______x, however, the rate becomes inversely proportional to the collision rate! The higher the collision rate the more suppressed the spectrum. In order to illustrate the non-perturbative character of this soft behavior supposes ______x / g², where g is the strong coupling constant of the source system . One sees that indeed the low -! part with $/ e^2! = x / e^2! = g^2$ represents a genuine non-perturbative result in g, while the large !-part, where $/ e^2g^2=!$, is well described perturbatively.




Fig. 2: Rate of real photons dN = (d! dt) in units of $4 e^2 v^2 = 3$ for a non-relativistic source for x = 50,100,150 MeV; for com – parison the IQ P results (dashed lines) are also shown.




Fig. 3:Current correlation function for the rst term sn = 0;1;2;3 of the Langevin result, eq. (22) and the total sum () for the case that

3.2 Microscopic Langevin Process

For a later comparison with quantum diagrams in sect. 4 we should look into the corresponding m icroscopic picture of classical propagation. There one can consider a classical random process (Langevin process), where hard scatterings occur at random with a constant m ean collision rate . These scatterings consecutively change the velocity of a point charge from v_m to v_{m+1} to v_{m+2} , ::: (in the following subscripts m, n, and l refer to the collision sequence, while superscripts i; k 2 f1;2;3g specify the spatial components of vectors and the self-energy tensor). In between scatterings the point charge m oves freely. For such a multiple collision process some explicit results can be given. They all refer to the case of vanishing photon m om entum q = 0 (dipole approximation) and therefore apply to non-relativistic sources where $hv^2iq^2 = \frac{2}{x}$ or to dilepton production, for example, since only the tim e structure is well known in this case, while the space structure would require an integration of the random classical paths.

For such a Langevin process the modulus of the autocorrelation function takes a sim ple Poissonian form (g.3)

This form, which one writes down intuitively, directly includes what one calls damping and therefore corresponds to a resummation description in the quantum case. This is a genuine multiple collision description for the photon production rate in completely regular terms due to the $(!^{2} + {}^{2})^{n}$ form of all denominators. Each term is regular, since right from the beginning one accounts for the damping of the source particle because of its nite mean time 1= between collisions. The result (24) still accounts for the coherence of the photon eld, now expressed through the correlations $h_{M_{m}} *_{m+n} i_{m}$ arising from the sequence of collisions. Note in particular, that, although the total expression is positive, the n > 0 terms can be negative since they describe the interference of the radiation arising from di erent propagation segments of the source particle. Thus, the terms in (24) de ne partial rates, which later (sect. 5.2) will be associated with speci c self energy diagram s.

As already mentioned, the q-dependence of the self energy cannot be given in closed form in general apart from the n = 0 term (c.f. with n = 0 term from eq. (24))

It shows the typical Cherenkov enhancement at ! = qv. At this level one may be tempted to associate this (n = 0) term with the relaxation ansatz result (13). This however is only true if $\langle v_m | v_{m+n} \rangle_m = 0$ for $n \in 0$, an approximation recently used in refs. [14]. In the general case velocity correlations between successive scatterings exist, and there will be a difference between themicroscopic mean collision rate and the mesoscopic relaxation rate x. Still, for systems, where the velocity is degraded by a constant fraction per collision, such that $hv_m = mv_{\pm n} i_m = mv_m mv_{\pm n} i_m$, one can resum the whole series in (24) and thus recover the relaxation result (13) at q = 0. The macroscopic rate x is then determined by the microscopic scattering properties through $_x = (1)$, or $2h(w_m)^2 i_m _x = h(w_m _{m+1})^2 i_m$. This clari es that the di usion result (18) represents a resummation of the random multiple collision result.

The following relations show di erent reformulations and limits of the Langevin result (24). For instance the invariance of (24) is not directly visible, since absolute velocities enter. Still the perturbation expression (23) can be rewritten, such that except for the zero order term, which drops out in the Fourier transform, only velocity di erences appear

A part from the mean collision time 1= this is an expansion in powers of $(=!)^2$ and therefore represents the perturbation expansion result for the classical source (representing the interaction, while 1=! relates to the interm ediate propagator). This perturbation expansion (27) is interesting since it already displays the main problem : W hile for ! the series converges, if higher order correlations cease su ciently fast, there is no hope to ever recover the correct result (24) for ! . This is so, since i) this series is necessarily divergent (it has to recover $1=(!^2 + 2)$ by a power series in), but also it m isses the know ledge on the even powers in in eq. (26) which essentially determ ine the soft behavior.

The rst term in (27) represents the incoherent quasi{free production rate which for nite q at given polarization reads

It carries the known divergence at the soft point q = 0, c.f. dashed lines in q. 2 and 4. In conclusion: the commonly used IQF prescription fails for soft particle production.

3.3 Finite Size Corrections

For system s of nite spatial extension and conserved currents one can consider the n = 0 sum rule. It dem ands that (q;x) has to vanish at least quadratically with q ! 0. This property survives in the classical limit, where form ally $\sim ! 0$ and the spectrum becomes continuous. Thus, the term of zero order in ! given by $_{1}^{R_{1}} h(v())(v(0))$ has to drop and the ensuing low energy part of the spectrum (24) starts quadratically in !

The simple relaxation ansatz (11) does not full this nite size condition, since it ignores long term anti-correlations on the scale of some recurrence time $1 = _{rec}$. That is the time, where on the mean the center of charges returns to the same point⁶. This defect of the relaxation ansatz may be cured by a more general form which includes such an anti-correlation, e.g.



3.4 Comparison with M onte Carlo Evaluation of Amplitudes

For illustration we like to present a simple model result and compare it to a M onte Carlo method, where amplitudes are calculated by considering the phase of the photon eld along the classical orbits. Thus, one evaluates

along the random straight sections of the classical paths in the cascade m odel. This method also permits to illustrate the nite size corrections discussed above. The dotted line in g. 4. shows the M onte C arlo phase integral result (32) from an oriented random walk, compared to the simple relaxation result (13), dashed line. The example has the property that the m otion is limited to a nite space with hx^2i' 10 $hv^2i=^2$ and $_x = 0.8$. The sharp dip at ! = 0 and the little over shoot around ! 0:3 are due to the nite size of the system. The full line gives the relaxation result including the nite size corrections (30).

Evidently the M onte C arb m ethod is a highly unreliable due to the strong cancelations of terms that are random by generated. The precision in g. 4 is obtained with 200 cascade runs where each path has about 10^3 collisions (simulation codes have by far less statistics!). The analytical result (24) has signi cant computational advantages, provided the random process is of this form. For the same precision already a single representative path with about 10^3 collisions is su cient, while for the relaxation ansatz one only has to determ ine the relaxation rate, i.e. a simple m om ent in time.

3.5 Infra-red D ivergences, C urrent C onservation, G auge Invariance and Identities

In the above multiple collision description with damping (22) all terms have a nite range in time. Thus, they all are void of infra-red divergences and so is any limited sum of terms of them. This is the desirable feature that we are aiming at. In addition the example above illustrates that in many cases only a few rescattering terms are necessary in order to properly recover the correct result for the transverse part of the correlation tensor both at sm all and large !. In fact the number n_x of required rescattering terms is given by $n_x = x$.

The picture is more subtile for the longitudinal components of the tensor, since some particular integrals are conserved (time independent) as they related to the total charge, c.f. eq. (10), sect. 2.1. Thus i 00 + (q = 0;), c.f. g. 1, has to be constant. For the Langevin case this identity holds, since

However, for any nite number of such terms this identity can never be recovered exactly for all times, since the relaxation time of total charge is in nite!

Quite often one is interested in a solution of the problem up to a maximal time t_{max} , and one likes to request charge conservation on the correlator level to be maintained only within this time span or within the corresponding !-range limited to ! > $!_{min} = 1 = t_{max}$. With this limitation a nite number of terms $n_x = t_{max} = !_{min}$ is required for a proper description also of the longitudinal parts of the correlation tensor at q = 0.

The above features have to be contrasted with perturbation theory (c.f. eq. (23)), where the correlation function can be expressed by a power series in in this case and therefore leads to a power series in . Here the zero order term is nite (and trivially constant in time), while the higher order term s cancel out for each given order, c.f. (23). Thus, in perturbation theory current conservation is maintained order by order also for the classical correlator (as one is used to from the quantum case). The price to be payed is that in perturbation theory the infra-red properties are completely ill.

In favor of the nite width description one should realize that any nite width calculation up to a certain order n_x includes the perturbation theory or QPA results up to the very same order n_x . In other words, if one would expand all nite width term swithin the order n_x into powers of one recovers all the QPA or perturbation theory term s up to that order!

Only in the above sense current conservation, gauge invariance and other identities related to them (e.g. W ard identities) can be understood and expected to hold for a nite set of terms. These considerations are general. In particular they also apply to any nite set of self-energy diagram s in the quantum case, which use full G reen's functions with damping as discussed in the next section.

This completes the formal discussion of the classical radiation rate and the corresponding classical expressions for the self energy of the photon.

4 Non Equilibrium Green's Function Description

In this section the production rate or photon self energy (2) is discussed in the context of non-equilibrium quantum eld theory, in terms of G reen's functions and the corresponding non-equilibrium diagram s. Thereby one has to go beyond perturbation theory which is not applicable for strongly interacting systems. The idea to form ulate theory in terms of appropriately de ned physical terms was very fruitful. It resulted in the development of the QPA method, see [19,20], where the changes in the real part of the ferm ion self energy are taken into account substituting the free particle energy $\frac{0}{p}$ by the corresponding QPA energy. This method proved to be very successful for the case of equilibrium matter at rather small temperature (T = F, where F is the Ferm i energy), since higher order corrections lead to additional $(T = F)^2$ factors [39].

Since in the QPA the imaginary part of the self energy (Im_{F}^{R}) is supposed to be negligible in the corresponding G reen's functions it still su ers the same infra{red problem s as the perturbation expansion. Any nite set of diagram s leads to infra{red divergences in the soft limit (q! 0). Even certain resummation methods as the hard therm alloop expansion [40,41] in QCD do not cure the problem . On the other hand the classical considerations of the previous section clarify, that all infra{red divergences disappear, if one properly accounts for the nite collision rate . Thus, one has to avoid the zero-width perturbation theory or QPA and seriously account for the nite damping width = 2Im^{R} of the source particles.

Therefore the simplest and physically most meaningful step is to go to the full G reen's functions G (full lines in diagram s) associated with the in-medium propagation for the constituents of the source. Thus one has to solve D yson's equation in order to include also the damping width of the particles. This is done in sect. 4.2. The derivation of transport schemes is summarized. Further on some physically meaningful resummations of the diagram s are proposed. Various graphical contributions to the self energy diagram (5) are discussed in the QPA, and in the QC lim \pm .

4.1 Vertices and G reen's functions

For a theory of ferm ions interacting with bosons the basic diagram matic elements are the corresponding G reen's functions if (lines) and interaction vertices iV.

For non equilibrium description it makes no sense to discuss am plitudes. Rather one evaluates the time-dependence of the ensemble averaged expectation values of observables. Such expectation values involves standard time-ordered products $(\hat{\Gamma})$ for the evolution of the "ket" j i and also anti{time ordered products $(\hat{\Lambda})$ for the evolution of the "bra" h j in the matrix elements. Both can be summarized to a contour-ordered product [22]. Therefore one distinguishes two types of vertices: the () vertices with value iV pertain to the time ordered part, and the adjoint (+) vertices with value +iV for the anti{time ordered section, in the here used convention [36]. Thereby V is the real interaction vertex of the Lagrangian. C orrespondingly two point functions, like the G reen's functions, have four components, which can be arranged in matrix form (we reserve bold face notation for the two by two f + g matrices)

W ith this extension to the two types of vertices and + and the corresponding four G reen's function components all standard diagram m atic Feynm an rules de ned for am plitudes can directly be generalized. These rules are then again de ned with

respect to the real time (as in zero temperature theory)⁷. For conventions and a detailed explanation of the diagram m atic rules used here we refer to the text book of Lifshitz and P itaevskii [36]. For a given n-point function all n external vertices have a speci ed sign assignment, while one has to sum over all possible sign combinations at the internal vertices.

4.2 Resummations: Dyson - and Kadano - Baym equations

Since diagram m atic elements, e.g. G reen's functions G and self energies are connected at a given vertex, the same vertex type or + appears in both functions and D yson's equation can simply be written in m atrix form

It is important to realize, that the resum m ation to full G reen's functions (bold straight or wave lines in diagram s) reduces the set of all diagram s to a subset of diagram s with skeleton topology, where all self energy insertions are excluded in the diagram s.

4.3 Transport equations

In the presented picture the W igner transform softhe o -diagonalG reen's functions iG ⁺ and iG ⁺ are W igner densities in four space and four momentum for the occupied and available 'single particle states', which now have a nite width and therefore can be o mass shell. We will see that the corresponding non-diagonal components of the proper self energy i are the gain and loss coe cients for the transport description of these W igner densities.

The entry to such transport equations is given by the K adano -B aym equations, which are contained in the set (39). Subtracting the two equations for G^{+} yields

Here S (k) = $k^2 = (2m)$ or S (k) = k^2 m^2 is the W igner form of the Schrödiger or K lein-G ordon operator (36). The rst Poisson bracket on the left side gives the usual V lasov part. On the right side ${}^+G^+$ and ${}^+G^-$ de ne gain and loss term s. This transport equation is quite general and as the original D yson equation still accounts for o -m ass-shell processes, part of which are contained in the peculiar second Poisson bracket according to B oterm and M al iet [27]. W e will see that the account of the nite damping width and the inclusion of higher order diagram s for the self energies (sect. 4.5) are essential to extend the scheme beyond classical transport concepts.

Equation (46) by itself is not yet complete, since it requires a relation a relation between G⁺ and G⁺, which norm ally is provided by a certain physical "ansatz". Under near on-shell conditions, where the W igner densities are well peaked close to a single on-shell energy $_{p}$, c.f. next subsection, one can use the K adano - Baym ansatz or apply the QPA (see Appendix A). Then the integral over reduces (46) to a familiar form [25,29]

The form of the collisional integral in (47) is convenient in m any cases, e.g. to extract stationary solution (cf. next subsection) or for the relaxation time approximation, where $1 = Z_p$ is the corresponding collision time, see (A.4). In the di usion approximation of eq.(47) one easily recovers eq.(14). The usual Boltzm ann-like form of the collisional integral is obtained from the lowest order self energy diagram which in QPA contributes to Im^R (usually second order in the two body interaction), c.f. [25,29] and (66) in sect. 4.8. M ore general schemes beyond QPA are suggested in sect. 4.7. The photon production rate, eq. (3), is a simple case of (47).

4.4 Stationary and Equilibrium Properties

For a hom ogeneous stationary system in W igner (x;p) representation all G reen's functions become space-time independent and the operation reduces to a simple product for the remaining 4-m om entum part in the D yson equation (37). W ith p = (;p) we therefore drop the x-argum ent. Eqs. (40) can then be solved algebraically

In the general non{equilibrium case there are no such simple relations between G reen's functions and self energies as at equilibrium. In order to proceed one may simplify the problem applying so called K adano {Baym ansatz (given in Appendix A) or using the QPA.

4.5 Diagram matic Decom position into Physical Sub-Processes

There have been m any attempts in the literature to eliminate the redundancy in the de nition of the four G reen's function components. We do not like to follow such schemes and rather prefer to keep all four components as they are, since they display a symmetry between the time-ordered and the anti-time ordered parts, i.e. between the "bra" and "ket" parts of the correlator⁹.

In this form ulation physical observables like densities, production rates, etc., are always given by diagram s, where the external vertices appear in conjugate pairs, i.e. with xed opposite signs, just de ning correlation functions. If Fourier transform ed over space-time di erences they have the properties of W igner functions. Special examples are the o-diagonal components of the G meen's functions and self energies, which de neW igner densities and gain or loss rates, respectively. W orking with full G meen's functions such correlation diagram s are given by a sum of all topologically distinguished skeleton diagram s with the xed external vertices of opposite signs. Each diagram of given topology consists of 2 terms, where is the number of internal vertices, due to the + sum mations. These extra sum mations make this approach rather non-transparent. In this section, how ever, we like to suggest a very sim ple classi cation of correlation diagram s and a reform ulation of the corresponding sum, which am ends a sim ple physical interpretation.

W e start with the observation, that at least in one way any correlation diagram of given topology and given sign assignments at all vertices can be decomposed into two pieces, such that each of the two sub pieces is a connected diagram which carries only one type of sign on all its external vertices 10

The reason for such a decomposition is that then each diagram is given by a "product" of two sub diagrams and ⁺ with the same external lines, which one may call amplitude { and adjoint amplitude diagrams. Here and denote amplitude diagrams including sign assignments. The adjoint ⁺ of any amplitude diagram is given by inverting the senses of all propagator lines and inverting the signs of all vertices; the respective values are conjugate complex to each other () = ⁺. For amplitude diagram s only the external vertices have de nite signs, while internal

⁹ In therm al eld theory the "+" vertices are often considered as ghosts. We do not like to support this view point as these conjugate vertices are as physical as the "" ones for the full correlation m atrix element!

¹⁰ For the construction: just deform the diagram such that all + and vertices are placed left and respectively right from a vertical division line and cut along this line. Pieces which then become disconnected are to be reconnected to the other side until two connected subpieces remain. In case that disconnected pieces appear on both sides the result m ay depend on the order of reconnection and consequently di erent decom positions are possible.

vertices have still no sign restrictions. In analytical terms the decomposition (57) can be written as

for space-time hom ogeneous cases (in general corresponding space-time foldings appear). Here if (p_k) or if (p_k) (depending on the line-sense) are the W igner densities of occupied (or available states) for each external line, with o -shell 4-momenta p_1 to p_m , connecting both pieces. When a correlation diagram can be decomposed in more than one way according to rule (57), the picture is not unique and one may assign partial weights which sum to unity to the di erent decompositions¹¹. Applying this decomposition scheme to all skeleton diagrams of the proper self energy leads to a decomposition in terms of physical processes with a varying number m of external "states" $p_1; :::; p_m$ besides the external photon in this case

Here the R $+(p_1;:::;p_m)$ de ne the partial rates for each physical sub process with certain in { and out-states p_1 to p_m , which all can be o -shell. In the sense of crossing symmetry the notion of in and out may be xed by the line sense: incoming or outgoing lines. Naturally for fermions there are as many in { as out-states. It is important to realize that the partial rates

arise from a restricted sum (indicated by the prime at the sum-symbol) over am plitude products times such that each term arises from a given correlation diagram in the original sum . Note in particular that the sum (60) no longer includes all possible interference terms of any two amplitudes! The unrestricted sum over all pair-products of amplitude times () is false and leads to serious inconsistencies, since there are interference terms, which correspond to closed diagram s of non-skeleton type, which have to be om itted! The simplest case to see this is the norm all diagram for brem sstrahlung (left)

¹¹ A simple example for such an ambiguity is the following diagram which permits two decompositions indicated by the thin line: $\frac{t-1}{t-1}$

Its absolute square leads to a diagram with self-energy insertion (61; right), which is not a proper skeleton diagram; rather the corresponding partial rate is already included in the 1-loop diagram with full G reen's functions!

Therefore, only when each term that enters a physical rate (60) originates from a valid decom position of proper skeleton self energy diagrams, then this formulation is void of double counting. It amends a straight forward interpretation in terms of physical scattering processes between certain in { and out-states. These processes occur with partial rates R, which can be positive or negative. The warning to be formulated at this instance is, that if one works with fullG reen's functions which also include the nite damping width , particular care has to be taken. The unconsidered account of certain Feynm an amplitudes together with nite width spectral functions for the particles, as som etim es done heuristically, may lead to serious inconsistencies.

On the other hand the important point to realize at this level is that the so dened decomposition gives rise to a generalized formulation of transport theories, where multi-particle processes can be considered in a well de ned scheme even if one permits for o {shell propagation.Note in particular: for a theory of ferm ions interacting with bosons the contribution with the fewest number of external particles is just three (rather than four as in the Boltzm ann equation). It results from the decomposition a one-loop diagram and allows for one particle in and two out and vice versa, .Thus, in dense matter an o -shell ferm ion can just decay into a ferm ion plus boson or the opposite can happen, e.g. see [29,43]. For these processes it is im portant that all particles have a nite damping width in dense matter, so that creation and decay modes, which are forbidden from energy-momentum conservation in free space, may occur without principle restrictions in dense matter.

P lease note that our decomposition rules are di erent from the standard cutting rules which only apply either to the set of perturbation theory diagrams [44] or to the set of the quasi-particle diagram s [39]. There diagram s are cut across all + lines, each cut providing an on-shell delta function from the zero width spectral functions. D iagram s that can be cut into m ore than two pieces contain a product ofm ore than one delta-function on total energy conservation and therefore show a singular behavior which is not present in the nal correlation function. Therefore all such "multi"-cut diagram s have to cancel out. Such arguments can no longer be given in the case that all spectral functions have nite widths, where the set of diagram s is reduced to the set of skeleton diagram s. Thus, such diagram s have also to be considered in a description with full G reen's functions!

4.6 Three and Four Point Functions

In principle one can stick to the above picture since all infra-red divergences disappear for all diagram s due to the nite propagation times of all G reen's functions. However one may have to consider still quite a num erous amount of diagram s in order to achieve meaningful results. For instance on the QP level we expect, that the proper in-medium current appears at both external vertices in a symmetric fashion. Thus for the convective currents one expects

In diagram matic terms this can be achieved by certain partial resum mation that lead to vertex corrections. Thereby we shall not consider an immediate resum mation to the exact full vertex, since this would am ount to solve the whole problem . Rather we like to stay to a picture where in certain limits like the QPA and QC limit, piece by piece an interpretation in physically meaningful terms can be given.

The considerations in the preceding subsection assigned a particular role to the full + and + G reen's functions as W igner densities. This suggests to apply further resum m ations and to extend the ideas put forward in ref. [39] in the context of quasiparticles now to particles with nite width. Namely, one likes to gather diagram pieces that are void of the W igner densities G + or G+, both for ferm ions and bosons. That is, one likes to resum sub-pieces of skeleton diagram swith given num ber and type of external vertices (3 point or 4 point functions, for example) where all internal and external vertices have only one de nite sign value. The f g diagram s then contain only time-ordered full G reen's functions G and therefore represent a straight forward generalization of the standard zero tem perature Feynm an 3 or 4 point functions now including the full self energies. The f+g diagram s are just the adjoined expressions. This way one can de ne 4 point functions (in-m edium interactions)

Here the thick wavy lines relate to the corresponding G_B {exact boson propagators or two-body potentials in non-relativistic theories with potentials. Since only like sign vertices are permitted, no G^+ and G^+ lines appear in these functions. Such resummed expressions have been proven useful in the low temperature QPA to de ne in-medium interactions and e ective vertices and they appear also quite meaningful in the limit of low densities, as in the classical limit for example. Various approximation levels are possible for the 4-point functions; a detailed discussion would be beyond the scope of this presentation. We mention just a few possibilities:

- a) a ladder sum m ation in the s-channel (horizontal in diagram (63)) for the particleparticle (p-p) and particle-hole (p-h) channels generalizes the B ruckner G -m atrix to non {equilibrium ;
- b) in many practical cases (e.g. Landau M igdal's Ferm i-liquid theory [19,20]) the 4-point functions are approxim ated by 2-point approxim ants in the t-channel (ver-

tical in (63)). Then RPA -type resum m ations are possible [39,10], which iterate p-h "{ {" and "+ + " loops in the t-channel; details are given in Appendix B; where also the scheme of the bosonization of the interaction is presented, cf. [10,48].

d) the ultim ate could be a crossing and exchange symmetric form; in this case one relies on suitable parameterizations.

These like{sign e ective interactions generalize the two-body scattering matrix in matter to non{equilibrium. Thereby one does not only account for the change of the ferm ionic occupations (as already considered in the literature) but also includes the damping of the ferm ions. In this respect it would be interesting to see, how bound states (e.g. the deuteron [49] or the J=) change their properties in dense matter (M ott transition) also due to the damping widths. For consistency these like{sign e ective interactions then also enter the de nition of the in-medium vertices (3 point functions) de ned as

4.7 Key diagram s

For simplicity we con ne the discussion to the case where the 'external' photon just couples to ferm ions. Any generalization to other types of particles (external and source internal) is straight forward. Due to the above considerations from now on the remaining diagram s include the following elements: full ferm ion G reen's functions, like-sign 4-point interactions and the corresponding vertices. P lease notice that this reduces the set of diagram s even further! In particular not all sign combinations are permitted any longer since some of them are already included in the resummed 3 or 4 point functions.

All photon self-energy diagram s can be build up by iterative four point insertions. Thus, the set of diagram s for + reduces to

This set of "key"-diagram s is in portant for all subsequent considerations and therefore deserves further comments.

(1) Each diagram in (65) represents already a whole class of perturbative diagram s of any order in the interaction strength and in the number of loops. The most

essential term is the one-loop diagram 12 , which is positive de nite, and corresponds to the rst term of the classical Langevin result for $_{\rm cl}$ in (24) as we shall show later. The other diagram s represent interference term s due to rescattering.

- (2) C om pared to conventional diagram s, vertex corrections can appear on both sides of one loop as they are separated by f+ g lines (see example given in Appendix B).
- (3) Note that the restriction to like sign vertices for the resummations (64) and (63) are defined with respect to skeleton diagrams in terms of full G reen's functions. "Opened" to perturbative diagrams with thin G⁰ lines, these can still contain alternative signs, since D yson's equation (37) includes all signs in the interm ediate summations!
- (4) In some simpli ed representations (being often used) the 4-point functions behave like interm ediate bosons (e.g. phonons), c.f. Appendix B.
- (5) For particle propagation in an external eld, e.g. in nitely heavy scattering centers, only the one-loop diagram remains, since the one deals with a genuine one-body problem. However, extra complications arise, since translation invariance is generally broken and the G reen's functions then also depend on x.

4.8 Decom position of C losed D iagram s into Feynm an Am plitudes in the QPA

The QPA is quite commonly used concept originally derived for Ferm i liquids at low temperatures (Landau-M igdal, see [19,20]). There one deals with on-m ass-shell ferm ions in matter (quasi-particles) described by the pole part of the G reen's functions, i.e. one assumes that Im $\frac{R}{F}$! 0 in the G reen's function G_F^R . Then with the help of some phenom enologically introduced interaction (particle-hole irreducible) one calculates the values Re R and Im R which now depend on quasi-particle properties. Since in QPA the nite width contributions have to appear in higher order through corresponding Im -insertions the whole set of QPA diagrams de ning the full i $^+$ is by far larger, than set (65).

The QPA has considerable computational advantages as W igner densities ("{ + " and "+ {" lines) become energy {functions, and the particle occupations can be considered to depend on momentum only rather than on the energy variable¹³. Form ally the energy integrals in eq.(5), (65) can be eliminated, in diagrammatic terms just cutting the corresponding "{ + " and "+ {" lines [39]. This way one establishes a correspondence between correlation diagrams (65) and usual Feynm an am plitudes in terms of QPA asymptotic states and QPA G reen's functions. Thus

 $^{^{12}}$ In perturbation theory or QPA the corresponding one-loop diagram usually vanishes for on-shell photons due to conservation law s. Here how ever, with full G reen's and vertex functions it represents a series of perturbative diagram s as the reader can easily in agine. 13 T he later approximation is also often used beyond the scope of the QPA and is then known as K adano {Baym ansatz, see [23] and Appendix A, c.f. [12]

the QPA allows a transparent interpretation of correlation diagrams.

For the dynam ics of the ferm ion transport the rst QPA diagram that contributes to the gain (loss) term

leads to the standard Boltzm ann collision term with corresponding occupation and Pauli suppression factors for the in and out states. Here and below the full blocks denote the e ective two{ferm ion interactions, and thick ferm ion lines denote the QPA states or G reen's functions.

For the here studied photon rates we discuss in detail the correlations diagram s on the right side of (65) with consecutive numbers 1 to 6. Thereby diagram s 1, 2, 4 and 5 describe the brem sstrahlung related to a single in-medium scattering of two ferm ionic quasi-particles and can be symbolically expressed as Feynm an amplitude (67a)

The full circle denotes the elective vertex. One should bear in m ind that the photon m ay couple to any of the external ferm ion legs and all exchange combinations are possible. The one-loop diagram in (65) is particular, since its QP approximant vanishes for real or time-like photons. However the full one-loop includes QPA graphs of the type (67b), which survive to the same order in = as the other diagram s [39]. In fact it is positive de nite and corresponds to the absolute square of the amplitude (67a)), c.f. (61). The other diagram s 2, 4 and 5 of (65) describe the interference of am plitude (67a) either with those where the photon couples to another leg or with one of the exchange diagram s. Thereby for neutral interactions diagram (65.2) is m ore important than diagram 4, while this behavior reverses for charge exchange interactions (the latter is also in portant for gluon radiation from quarks in QCD transport due to color exchange interactions). D iagram s like 3 describe the interference term s due to further rescatterings of the source ferm ion with others. A coording to our rules the diagram (65:3) corresponds to a two-body collision process and describes the interference of am plitude (67c) with that one where the photon couples to the initial leg. Diagram (65:6) describes the photon production from interm ediate states and is given by Feynm an graph (67d). In the soft photons lim it (! $_{\rm q}$ F) this diagram (67d) gives a smaller contribution to the photon production rate than the diagram (67a) in QPA, where the norm albrem sstrahlung contribution diverges like $1=!_{q}$ compared to the $1=_{F}$ (value typical for the coupling to intermediate fermion

lines [45]. However in some speci c cases the process (67d) m ight be very in portant even in the soft lim it. This is indeed the case for so called modi ed URCA process nn ! npe which is of prime importance in the problem of neutrino radiation from the dense neutron star interior, see [43].

Som e of the diagram s, (c.f. the graph shown in footnote 7) which are not presented explicitly in eq.(65) give more than two pieces, if being cut, so they do not reduce to the Feynm an am plitudes.

For the validity of the QPA one norm ally assumes that , where is an average particle kinetic energy (T for equilibrium matter). W ith ${}^{2}T^{2} = F$ for Ferm i liquids, c.f. (A.5), the QPA constitutes a consistent scheme for all therm alexcitations F. However with the application of transport models to higher energies this concept has been taken over to a regin e where its validity can no longer easily be justied. Moreover, our considerations show that the condition is not at all su cient. Rather one has to dem and that also ! in the QPA, since nally energy di erences of order ! appear 14 . In particular, the remaining series of QPA -diagram s is no longer convergent unless ! > , since arbitrary powers in =! appear, and there is no hope to ever recover a reliable result by a nite num ber of QPA-diagrams for the production of soft quanta! W ith full G reen's functions, however, one obtains a description that uniform ly covers both the soft (!) and the hard (!) regime.

5 The Quasi-classical Limit (QC)

In this section we like to discuss, which class of diagrams remains in the quasiclassical limit and how this is to be interpreted.

The QC lim it requires that

- i) all occupations of the source particles are small (m_pi 1) implying a Boltzm ann gas with T and that
- ii) all inverse length or time-scales times ~ are small compared to the typical momentum and energy scales of the source system s.

In particular this implies ~!;~jqj , and a collision rate = ~= $_{coll}$, where is a typical particle kinetic energy (T for equilibrium m atter). To be precise: ! and q of the produced particle are sensitive to the space-time structure of the source, while they are negligible as far as energy and m on entum balances are concerned. The latter fact perm its to prove the K adano {Baym ansatz in this case (see A ppendix A and discussion of eq. (84) below) which considers the occupations of the source particles to dependent only on m on entum $n_p = n_{p_{end}}$ but no longer on energy .

We note in particular that for bosons with chemical potential $_{\rm B}$ = 0, like the produced photon, the equilibrium occupations will be large, $n_{\rm B}$ T=! 1! This fact is of no further relevance, if one excludes internal photon lines in the proper correlation functions (2), ⁺ and ⁺ as we do.

5.1 Time Structure of Green's Functions and Loops in QC Limit

where the resulting proportionality to the proton density ₀ results from + and + G reen's functions next to the external vertices. Here of course we have silently assumed a consistency condition to be full led: namely that the interaction loops which one takes into account also consistently de ne the damping width of the source particles! In particular the extra powers in occupations coming from the + loops are contained in , and therefore do no longer explicitly appear in the nal result. This proves that in the classical limit these diagrams reproduce the term s of the classical Langevin series (24).

5.3 Hierarchy of the QC expansion

The Langevin diagram s (75) have the following properties:

- a) external vertices: the external photon couples to the sam e ferm ion line;
- b) topology: the diagram s are planar, i.e. no crossing of lines occur.
- c) + sign topology: if one cuts them at all + lines they decompose precisely into two pieces;
- d) value: apart from the velocity correlations they all give the same contribution to the soft photon point (!;q) = 0;

W hat remains to be shown is that for the classical problem s discussed in sect. 3 all other key diagram s are disfavored by extra occupation factors n or = which both are sm all compared to unity.

To a): Since in the classical problem s of sect. 3 only a single charged particle (say a proton) in neutral matter is considered, all diagram s with more than one proton line do not occur in this case. To b): Non-planar diagram s, where interactions cross, violate classical time-ordering. Either the two interaction times are interlocked on a time scale 1= and therefore lead to a penalty factor = or restoring the time-ordering one obtains a Z-shape ferm ion line, which gives an extra occupation factor

n. To c): D iagram s that can be cut into more than two pieces can be obtained on various ways: i) by any +-loop insertion which switches signs on the outer proton lines, thus using the right insertion in (76); here one obtains an extra hindrance factor n. ii) extra insertions of or + + blocks linking the outer proton lines; since there are no direct proton-proton interactions these e ective interactions are mediated by the surrounding neutron matter thus containing neutron loops, which also leads to an additional factor n, besides another n factor due to the + proton G reen's function.

6 GeneralQuantum Consideration for Hot and Dense Matter

The considerations above show the following. A proper treatment of an entirely classical problem, namely the coupling of a classical source to a wave (electrom agnetic eld), on the level of quantum many-body theory requires technics, that even now adays are still non-standard, i.e. beyond perturbation theory or QPA. W hile the classical problem can be solved quite conveniently and simple with no problems on the infra red side, the corresponding quantum description requires an appropriate account of the nite damping width of the source particles. The most natural approach in ourm ind is the real-time G reen's function technic, which how ever requires partial resum mation, such that the nite width is included already on the one-body G reen's function level.

In this section we analyze the production rate from hot and dense matter in the quantum case in terms of non {equilibrium G reen's functions. In order to provide some analytical results which easily can be discussed in di erent limiting cases, we employ the following approximation for the full retarded G reen's function. We assume G^R to be given by a simple pole approximation with constant residue

6.1 Qualitative expectations

C om pared to the classical results we expect the following changes:

 a) one looses the classical hierarchy of diagram s, such that m any m ore diagram s contribute in the quantum case; for speci c couplings, how ever, som e diagram s are disfavored or drop due to selection or suppression rules, e.g. non-planar diagram s in SU (n) coupling;

- b) the radiated quantum carries nite momentum and energy (which vanish in the classical lim it), such that additional recoil corrections and phase-space factors e^{!=T} appear; the latter is in portant, since it cures the classical ultra violet catastrophe, where the intensity spectrum is white, leading to a divergence of the radiated energy in the classical case;
- c) the occupations are no longer of Boltzm ann type with n 1, so that Pauli suppression and Bose-Einstein enhancement e ects are signicant;
- d) the duration time of binary collisions $1=_{\rm F}$ mediated by interaction loop insertions (B.7) in the correlation diagram s, are no longer negligible compare to 1= as in the classical case, so that non-markovian memory elects become important [46,47].

Points (b) and (c) can be clari ed using the exact relation between therm al ferm ion and boson occupations

At low temperatures only states close to the Ferm i-surface contribute. The last approximate relation suggests that relative to the classical results of sect. 3 an additional phase-space suppression factor n^{B} (!)!=T appears in the quantum case, which accounts for the nite energy ! carried away by the quantum.

6.2 Contribution of One {Loop D iagram with Full Ferm ion Propagators

In sum mary, for the one loop term the QPA leads to meaningful results only for large space-like !; q (hard therm al loops).

There is hope that even in the quantum case some higher order diagram s can also be resummed and that qualitatively a similar suppression factor emerges like for the diusion result.

7 Discussion and Perspectives

We investigated the production of particles from the collision dynam ics of dense m atter at the example of photon production. Thereby the source of charged particles was described in two ways, a) as a classical system governed by classical transport equations and b) as a quantum system in terms of a real-time non-equilibrium eld theory formulation. The central quantity is the current-current correlation function which relates to the imaginary part of the proper self energy of the produced particle. Under quite general assumptions this correlation function governs the local production and absorption rates in the matter. Since the here discussed features are of kinematical origin, relating space-time scales to the corresponding momentum and energy scales, all conclusions drawn in this study are general and therefore also apply to the in-medium production and absorption rates of any kind of particle.

The problem could be quite naturally formulated and solved in the classical descriptions by means of a macroscopic transport and a microscopic Langevin process. These studies showed that spectrum of produced particles is essentially governed by one macroscopic scale, the relaxation rate $_x$ of the source. For frequencies ! of the produced quantum which are large compared to $_x$ the spectrum can be described by the incoherent quasi-free scattering approximation (IQF) used in most of the transport models. Higher order corrections help to improve the result. Once, how – ever, ! < $_x$ this quantum is "soft". It can no longer resolve the individual collisions in time and therefore the IQF picture fails and produces a false infra-red divergence in the rate. R ather, the correct rate is regular and di ers from the IQF result by a suppression factor

This soft part of the spectrum is genuine non-perturbative. The essential features are summarized in gs. 1 and 2 of sect. 3. For relativistic sources a second scale $\cos q \sin r$, once the wave number jgj of the produced particle exceeds the value of $x = hv^2 i$ due to the increased spatial resolution as shown by the closed form results of the di usion m odel.

On the quantum level new scales come in since now ! and q also correspond to the energy and momentum of the photon which have to be compared with the characteristic energy and momentum scales of the source as given by tem perature T and chem ical potential or the Fermi energy F.A lso the occupations can becom e degenerate and Pauli suppression or Bose enhancem ent e ects are important. For the general form ulation one has to leave theoretical schemes that are based on the concept of asymptotic states like perturbation theory or quasi-particle approxin ation. The proper frame is the real-time non-equilibrium eld theory, where the proper self-energy can be formulated in terms of closed correlation diagram s with general propagators. Thereby the resum m ation of D yson's equation to full propagators which also include the imaginary parts of the self energy and therefore account for the damping of the source particles is the essential step to cure the infra-red problem . Only this way one com es to a convergent scheme. A fler this resum mation the corresponding set of diagram s is then reduced to diagram s with skeleton topology. Using the Keldysh + notations we have addressed a particular role to all + and + lines as 8-dimensional W igner densities of occupied and available "states". This motivated further resum mations which de ne in medium interactions and vertex corrections. The resulting set of diagram s can then be discussed in detail in these physical terms. A decomposition of these correlation diagrams in terms of the interference of two "amplitude" diagrams is suggested, where W igner densities enter as in - and out-states. This perm its a transparent physical interpretation of the correlations diagrams, which may be used to form ulate multi-particle collision processes in matter. They can serve as input for a generalized transport description, which ultimately includes the o -shell propagation of particles and therefore uni es resonances which have a width already in vacuum with all other particles in the dense matter, which acquire a damping width due to collisions.

O noe one has the full propagators and the in-medium interactions it is in principle straight forward calculate the diagram s. However both, the computational e ort to calculate a single diagram and the number of diagram s, are increasing dram atically with the loop order, such that in practice only lowest order loop diagram s can be considered in the full quantum case. In certain lim its some diagram s drop out. In particular we could show, that in the classical lim it of the quantum description only a special set of diagram s survive, which could be associated with the multiple collision term s of the classical random Langevin process. C om paring the lowest order loop diagram s in various lim its to the corresponding QPA diagram s one realizes that also here correction factors sim ilar to (97) appear. Now the characteristic scale is the dam ping width of the source particles. A coounting for higher order diagram s one concludes that also in the quantum case the relaxation rate $_{\rm x}$ is the relevant scale which decides between soft and hard photons. Thus for applications one has to com pare the typical energies of the produced particles with the typical relaxation rates of the source system .

Our considerations are of particular in portance for the theoretical description of nucleus-nucleus collisions at interm ediate to relativistic energies. With tem peratures T in the range of 30 to 100 M eV for dense nuclear m atter, up to 200 M eV for hadronic matter and beyond 150 MeV for the quark gluon plasm a or parton phase m ost of the kinetic m odels that are used infer collision rates for the constituents, which during the high density phase can reach the system's temperature, < T. Such estimates make the use of on-shell concepts already rather questionable. The particles uncertainty in energy is comparable with the mean kinetic energy! In particular the bulk production and absorption rates of all particles with m asses less than T, if calculated in standard IQF approximation, are seriously subjected to the here discussed e ect. Therefore the corresponding quenching factors (97) should sensitively a ect the production rates of quark pairs and gluons during the plasm a phase, of low energy pions during during hadronization and real and virtual photons with correspondingly low energies. Since our discussion was restricted to the production in dense matter, for the particular case of photon production in nuclear collisions one has to consider in addition the radiation caused by the incoming charged ions and outgoing charged fragm ents. Due to Low's theorem [55] the latter give rise to an infra-red divergent 1=! component which interferes with the one discussed here.

In astrophysics neutrinos produced from neutron stars or during super nova collapse have an absorption m ean free path which is long com pared to the size of the radiating system (for review see [7,8,10]). Thus the production rates cannot be estimated by black-body radiation. Rather the microscopic rates are relevant. The mean kinetic energies per neutrino or -pair are about 3T or 6T, respectively [52,53].W ith ${}^{2}T^{2} = F$ mean collision rates of the order of T [54], c.f. eq. (A.5), the production rates can safely be estimated in IQF-approximation for relatively cold neutron stars T 1:5 to 2 M eV . A lready around T 5 M eV the quenching factor (97) is signi cant (0:3) and it may become even smaller during super nova collapse. Then the tem peratures can raise to T 10 30 M eV such that T and the here discussed suppression e ects are relevant for the corresponding neutrino en issivity.

Appendix

A Kadano {Baym Ansatz and QPA

In the general non{equilibrium case one has no simple relations between G reen's functions as in equilibrium. In order to proceed nevertheless one often uses the so called K adano {Baym ansatz [23]. For Ferm ions it reads

where n_{p}^{F} are the ferm ion occupations which now depend on p through the onshell dispersion relation (50) rather than on .0 ne should note that the K adano { Baym ansatz does not directly follow from the properties of the G ⁺ and G⁺ functions, rather it has been introduced in order to recover the Boltzm ann lim it. The correctness of this ansatz has only been proven in the QPA, see [12]. Eqs. (A.1) com plies with the de nition of the particle densities (48), as can be seen by the sum rules (52).

D ealing with dressed particles we consider only diagram s with thick ferm ion lines determ ined from the corresponding D yson equations. Approximation (A.1) is how – ever based on the assumption that Im $_{\rm F}^{\rm R}$ is much smaller than all other energies scales entering the problem.

In particular in the lim it Im $_{\rm F}^{\rm R}$! 0 in the ferm ion G reen's functions one com es to the QPA, where the imaginary part of retarded G reen's function becom es a delta function, e.g. for non{relativistic ferm ions

Here the Z_p factor corrects for retardation e ects, c.f. ref. [29], such that the sum rule (52) remains fulled. For simplicity we employ a quadratic p{dependence for Re^R in terms of an elective fermion mass $p' p^2 = 2m_F$ in the applications.

From the dispersion equations one easily nds the corresponding relaxation times. E.g., for fermions supposing that Im R is small and introducing $_{Ol}$ = 1=2, where we use that $_{F}$ exp(i, i)t), one nds

This value would tend to in nity for Im $_{\rm F}^{\rm R}$! 0. In reality the ferm ion width determ ined by the value Im $_{\rm F}^{\rm R}$ is rather large even at su ciently small temperatures. E.g. for nucleons, applying the QPA for the intermediate nucleon lines, it can be estimated as follows [54]

This estimate shows that \mathcal{J}_{F} jcom es into the order of $_{F}$ already at su ciently small tem peratures T ' $\frac{1}{3}_{F}$ and still increases for higher T. This defers the application of the QPA for a wide range of tem peratures.

B Renorm alization of the Two{Ferm ion Interaction

As an example we consider a theory where non-relativistic ferm ions interact via twobody potentials. A priori this theory has no bosons and the two-body interactions always connect two vertices of same sign, de ning iV and $iV^{++} = (iV)^{y}$, while $V^{+} = V^{+} = 0$. Even if resumed to an elective four point interaction G_{0} according to eq. (63) much like B nuckner G {matrix, one has an elective interaction that connects only like sign vertices.

For the following we approximate G_0 by a two{point function (as for instance in Ferm i-liquid theory, where the residual interaction is supposed to be local and extracted from comparison with experimental data [20,10]), while $G_0^{+} = G_0^{+} = 0$. We also suppose that G_0^{++} and G_0^{-} interactions are particle-hole irreducible in the t-channel (vertical in (63), c.f. [20,10]).

Starting from G_0 and G_0^{++} one can completely bosonize the interaction in the standard way by resumming all intermediate particle-hole loop insertions

This full interaction G has bosonic features, just describing e ective bosons, such as phonons, plasm ons, sigm a mesons, etc. A leo the inclusion of real bosons, like pions in nuclear matter, is possible, giving rise to a picture, where pions couple to pionic particle-hole excitations, see [48,10]. These e ective bosons can be taken on the sam e footing as all other e ective quanta, the ferm ions or other bosons, see [43,39]. Thus, e ective bosons also acquire a spectral function with width and the non-diagonal components of G⁺ and G⁺ are also W igner functions. Consequently one com es to a theory of e ective in-m edium ferm ions interacting with e ective in-m edium bosons.

O byiously the full (anti-)tim e-ordered G (G^{++}) depend on the in-m atter densities G⁺ and G⁺ also via Z. However in an approximation where the value $G_0^{++}A^+$ G_0 A⁺ is small, one has Z['] 1 for renormalization factor (B.5). So, one can simplify further and comes to a scheme like leading logarithm ic approximation in quantum eld theory, namely, a perturbation series over G⁺ (or G⁺) neglecting corrections 1+ O (G⁺ A⁺) in each leading term. Such corrections are proportional to ² (or ²). Thus, one approximately has
