# U ltraviolet $R$ enorm alons in A belian $G$ auge $T$ heories

#### Abstract

W e analyze the large-order behaviour in perturbation theory of classes of diagram s w ith an arbitrary num ber of chains (i.e. photon lines, dressed by vacuum polarization insertions). W e derive explicit form ulae for the leading and subleading divergence as n! 1, and a com plete result for the vacuum polarization at the next-to-leading order in $1=\mathrm{N}_{\mathrm{f}}$. In general, diagram $s w$ th $m$ ore chains yield stronger divergence. $W$ e de ne an analogue of the fam iliar diagram $m$ atic $R$-operation, which extracts ultraviolet renorm alon counterterm s as insertions of higher-dim ension operators. W e then use renorm alization group equations to sum the leading ( $\left.\ln \mathrm{n}=\mathrm{N}_{\mathrm{f}}\right)^{\mathrm{k}}$-corrections to all orders in $1=\mathrm{N}_{\mathrm{f}}$ and nd the asym ptotic behaviour in $n$ up to a constant that must be calculated explicitly order by order in $1=\mathrm{N}_{\mathrm{f}}$.

## 1 Introduction

Perturbative calculations in quantum eld theories involve integrations over arbitrarily sm all distances and typically lead to divergent results. A nite result is obtained, when a theory is rst regulated $\|_{-1}^{L_{1}}$ and counterterm s are added to the bare Lagrangian $L_{0}$. The G reen functions com puted from

have perturbative expansions free from divergences order by order in the renorm alized coupling ( ) so that they are nite in the lim it when the cut-o is rem oved. A justi cation for this rather ad hoc-looking procedure can be obtained from the philosophy of 'e ective eld theories': O nly the renom alized param eters are accessible to low -energy experim ents and the apparently divergent regions of integration are in fact (alm ost) insigni cant.

From the beginnings of renorm alized quantum eld theory it hasbeen recognized that the $G$ reen functions (in the lim it ! 1 ) obtained in this way can not be unam biguously de ned (as certain analytic functions in a neighbourhood of $=0$ ) through their perturbative expansions alone, because they diverge for any \& 0 [ili]. A lthough from a practical point of view one $m$ ay consider these expansions as asym ptotic (to nature), the (non-perturbative) existence of renom alized eld theories rem ains a m athem atically largely unsolved problem, the divergence of perturbative expansions being one face of this problem, the issue of triviality in non-asym ptotically free theories being another.

W thout touching the profound problem of existence, the behaviour of perturbative expansions as form alseries is itself m portant. In considering the perturbative expansion to all orders, one takes in fact a glim pse beyond perturbation theory. Thus, although the questions of triviality and Landau poles in general can not be answered w thout know ledge ofnon-perturbative properties of the theory, som e aspects can be investigated strictly within perturbation theory. In theories where the coupling can becom e large at low energies, the details of the divergence of the perturbation series $m$ ay provide som e hints to selecting the num erically $m$ ost im portant corrections already in m oderately large orders. The dom inant source of divergence (at least w ith present know ledge) was
 with an arbitrary num ber of vacuum polarization insertions into a single gauge boson line in a loop diagram. The sum of these diagram s has the generic behaviour

Here $\underline{p}$ is a collection of extemalm om enta and 0 is the rst coe cient of the -function. W ith the de nition given later, the constant a is integer (and som etim es half-integer). The $n!$ behaviour arises as a consequence of renorm alization and for this reason has become known as renorm alon divergence. Note that the term divergence' is applied

[^1]to the divergence of the perturbation series as well as to the divergences of Feynm an integrals, which are subtracted in the process of renom alization.

In strictly renorm alizable theories the coupling depends logarithm ically on the renor$m$ alization scale and each vacuum polarization loop gives a $\ln \mathrm{k}^{2}={ }^{2}$. This logarithm is large whenever the loop $m$ om entum $k$ is very di erent from. In the present paper we consider only large $m$ om entum regions $k$ and ultraviolet (UV) renorm alons, with $a>0$. The divergences associated with regions of integration over large loop m om enta, like $d^{4} k=k^{4}$ for large $k$, are rem oved by the fam iliar renorm alization procedure. The ultraviolet renorm alons occur when a large pow er of $\ln \mathrm{k}^{2}={ }^{2}$ is integrated over the rem aining ultraviolet regions of the subtracted integrands. In particular, the strongest divergence $(a=1)$ is exclusively due to the rem aining behaviour $d^{4} k=k^{6}$ for large $k$. The fact that UV renorm alons are related to the large $m$ om entum expansion of Feynm an integrands is crucial for their understanding, since it allow s to describe UV renorm alon divergence in large orders in term s of local operators just as explicit divergences in nite orders in the usual fram ew ork of renorm alization. This observation is the basis for $P$ arisi's hypothesis $\left[\begin{array}{l}4 \\ 4\end{array}\right]$ that UV renorm alons can be rem oved by adding higher dim ensional operators to the Lagrangian. In particular, the leading UV renom alon ( $a=1$ ) could be com pensated by an additional term

where the sum runs over all local operators $O_{i}$ of dim ension six. To com pensate all UV renorm alons an in nite series of higher-dim ensional operators would have to be added to the Lagrangian. In this paper we dealexplicitly only w ith the leading UV renorm alon and restrict ourselves to operators of dim ension six.

The fact that the rem oval of ultraviolet renorm alons, as the rem oval of ultraviolet divergences, can be form ulated at the level of counterterm $s$ in the Lagrangian im plies their universality: O nce the coe cients $\mathrm{E}_{\mathrm{i}}$ have been determ ined from a suitable set of $G$ reen functions, the subtraction of the rst ultraviolet renorm alon is autom atic for all G reen functions. A nother consequence is that the $\mathrm{E}_{\mathrm{i}}$ satisfy renom alization group equations, because $G$ reen functions $w$ ith operator insertions satisfy them. These considerations $x$ the constant b in eq. (112] pends on a boundary value which rem ains unconstrained by general considerations and is related to the norm alization $K$ of the renorm alon divergence in eq. (1]ī) .

An altemative approach, based on the Lagrangian at a nite cut-o rather than the renorm alized Lagrangian, has been taken in [1]. The idea is that, since UV renorm alons arise as a consequence of the in nite cut-o lim it, their inform ation is encoded in the large-cut-o expansion. $V$ iewed in this way the com pensation of $U V$ renorm alons bears close resem blance to Sym anzik im provem ent of lattice actions tī్ 1 .

A though the absence of the rst ultraviolet renorm alon as a consequence ofeq. (1, ב. seem s rather obvious from the physical origin of UV renorm alons, it has not yet been rigorously established. M oreover, the diagram $m$ atic intenpretation of eq. (1) is rather unclear: It does not give a clue, which diagram s contribute to the coe cients E i or whether they can be calculated at all in a system atic way. T hese are the questions which we address in this paper.

The diagram $m$ atic study of UV renom alons received new attention only recently, through the work of Zakharov [ī]] and others [8\{11]. The main di culty that the diagram matic approach has to face is that, because the ob ject is to study perturbative expansions in large (that is, to all) orders, there is in fact no natural expansion param eter that would select a m anageable subset of the in nity of all diagram s. In abelian gauge theory it is usefiulto classify diagram s in term s of com plete gauge boson propagators. In rst approxim ation, where only the rst coe cient in the -function is kept, the com plete photon propagator reduces to a 'thain', a string of ferm ion loops. W th few exceptions, previous investigations of $U V$ renorm alons have focused on diagram $s w$ ith a single chain. In $[1 \overline{1}[1]$ it was show $n$ that at this level one could rem ove the rst ultraviolet renorm alon from $G$ reen functions by counterterm $s$ of the form of eq. (1]. com plexity of calculating the nom alization $K$ is already exhibited by diagram sw ith one com plete photon propagator: To obtain the value of $K$, one can not approxim ate the propagator by a string of ferm ion loops (dhain). T he exact photon propagator has to be kept $1\left[\begin{array}{l}10 \\ 0\end{array}, 1\right.$ be calculated exactly.

An im portant new insight com es from the work of Vainshtein and Zakharov $[1 \overline{1} \overline{4}]$, who investigated the dom inant contributions to the large-order behaviour of the photon vacuum polarization from diagram $s w$ ith tw o chains by $m$ aking direct use of the fact that the $U V$ renorm alons originate from the large-m om entum regions in loops. T he diagram $s$ w ith tw o chains display a qualitatively new behaviour, because the four-ferm ion operators that appear in eq. (1] into the photon vacuum polarization, they were found to yield the dom inant large-order behaviour.

In this paperwe approach $U V$ renorm alons from an entirely diagram $m$ atic perspective within the expansion in the num ber of chains, or, to be precise, in $1=\mathrm{N}_{\mathrm{f}}$, where $\mathrm{N}_{\mathrm{f}}$ is the num ber of ferm ions. G uided by the interpretation of $U V$ renorm alon divergence as sim ilar to the usual ultraviolet divergences, we proceed in close analogy w ith the usual renorm alization program. We will see that the analysis of UV renorm alon divergence order by order in the expansion in chains has much in com $m$ on $w$ ith the analysis of UV divergence order by order in the coupling. The UV renorm alon problem then takes a form sim ilar to usual UV divergences: W hile certain properties like locality of counterterm $s$ and renorm alization group equations can be established to all orders (for an arbitrary num ber ofchains), the actual calculation of counterterm $s$ is lim ited to a few rst term s because of the increasing com plexity of integrals. In the present paper we proceed heuristically and do not give proofs w hich could be w onked out as generalizations of standard cum bersom e proofs of renorm alization theory. R ather than giving proofs we describe the properties of regularized Feynm an integrals and subtraction operators which would be essential ingredients to these proofs and illustrate how the extraction of ultraviolet renom alon divergence works in a num ber of exam ples.

Let us $m$ ake a rem ark on the fram ew ork of the expansion in the num ber of chains: It $m$ ight appear inconsequent to replace one expansion (the one in the coupling ) by another. O ur attitude is that this expansion can shed som e light on the organization of UV renorm alon divergence in the sam eway as, for instance, the $1=N_{c}$-expansion in $Q C D$ $m$ ay reveal som e inform ation on the strong-coupling regim e. In addition, we will see
that the dom inant $U V$ renorm alon divergences in each order of $1=\mathrm{N}_{\mathrm{f}}$ can be resum m ed to all orders in $1=\mathrm{N}_{\mathrm{f}}$ by solving the renorm alization group equations. It is possible that the conclusions drawn from the $1=\mathrm{N}_{\mathrm{f}}$-expansion are not valid for any $n$ ite $\mathrm{N}_{\mathrm{f}}$ or valid only in a nite range of $\mathrm{N}_{\mathrm{f}}$. However, in an abelian gauge theory we do not consider this a likely possibility and rather expect a sm ooth continuation from the large $\mathrm{N}_{\mathrm{f}} \lim$ it to $s m a l l N_{f}$.

In Sect. 2 we begin with detailing the expansion in chains. $W$ e introduce the B orel transform as generating function of perturbative coe cients and show how the factorial divergence of perturbation theory is encoded in the singularities of analytically regularized Feynm an integrals. W e collect som e of their properties and classify the subgraphs that can contain the dom inant UV renorm alon. The extraction of the renorm alon divergence then reduces to the extraction of pole parts of analytically regularized Feynm an integrals at certain positions in regularization param eter space.

In Sect. 3 we construct an operation that pidks out the term $s w$ ith the largest num ber of singular factors. The leading large-n behaviour at any order in $1=\mathrm{N}_{\mathrm{f}}$ is then found by successive extraction of pole parts of one-loop integrals. Beyond the leading large-n behaviour it is essential to apply the $m$ ethod of infrared rearrangem ent $[1 \overline{1} \overline{5}, 1 \overline{1} \overline{1}]$. T he operations introduced in this section are ilhustrated by the sim plest exam ple of the ferm ion selfenergy up to two chains. In Sect. 4 we com pute the ferm ion-photon vertex and the photon vacuum polarization including all diagram $s$ w ith two chains and those diagram $s$ w ith three chains that contain an additional ferm ion loop.
$T$ he universality of UV renorm alons becom es $m$ ost transparent by elevating the diagram $m$ atic subtractions to the level of counterterm $s$ in the Lagrangian. W e form ulate the results of the previous sections in this language in Sect. 5 . The renorm alization group equations for $G$ reen functions w ith operator insertions are then used to sum the leading UV renorm alon singularities to all orders in $1=\mathrm{N}_{\mathrm{f}} . \mathrm{W}$ e sum m arize in Sect. 6 and discuss further applications of the form alism .

The derivation of som e results quoted in sections 2 and 3 is collected in an appendix.

## 2 R enorm alons and analytic regularization

In this section we set up the reorganization of the perturbation series in term s of chains and derive the Feynm an rules for the B orel transform of this expansion. W e show how renorm alons are related to the singularities of analytically regularized Feynm an integrals. W e consider only the abelian gauge theory (QED) w ith Lagrangian

Since we are interested in large m om entum regions, we can consider the ferm ions as $m$ assless. $W$ e assum $\mathrm{eN}_{\mathrm{f}}$ species of ferm ions, but do not write the avour index explicitly. Summ ation over repeated avour indioes is understood. The -function is given by ( $=g^{2}=(4)$ )

### 2.1 Chains

C onsider the perturbative expansion of a truncated $G$ reen function $G(\underline{q} ;)$, where $\underline{q}=$ ( $q_{1}:::: ; q_{1}$ ) denotes a collection of extemal $m$ om enta and $=()$ the renorm alized coupling. W e can organize this expansion in term sof diagram swith com plete photon propagators

where $\left(\mathrm{k}^{2}\right)$ is the photon vacuum polarization and the gauge xing param eter. Each such diagram corresponds to a class of diagram $s$ in the usual sense. Let be such a class of diagram s with N com plete photon propagators and let the lowest power of g that occurs in a diagram in be $\mathrm{g}^{\mathrm{e}}{ }^{\mathrm{N}}$. (In the abelian theory, e depends only on the $G$ reen function $G$ and equals the num ber of extemal photon lines.) Then we write the contribution from to the series expansion of $G$ as

$N$ ote that ifw e consider a physicalquantity, wem ay take the com plete photon propagator to be renorm alized. D ue to the $W$ ard identity, no further renorm alization is required and the sum over alldiagram $s$ w ith a given num ber of renom alized photon propagators is nite.

Form ally, the series can be wrilten in the B orel representation

is the B orel transform of the series. The factorial divergence of the series then leads to singularities of the B orel transform at nite values of $u$. For exam ple, the large-order behaviour of eq. (12) results in a singularity at $u=a$ and the constant $b$ determ ines the nature of the singularity. The integral in eq. ( $\left.\overline{2} . \frac{1}{2}\right)$ does not exist due to these singularities. In the present context, we use the Borel transform only as generating function for the perturbative coe cients. We do not consider at all the problem of sum $m$ ation of the pertunbative series (e.g. by use of the B orel transform ).

The $m$ om enta $p_{1}$ are assigned to ferm ion lines and $k_{j}$ to photon lines. The function $I$ is the Feynm an integrand ( w thout the factors $1=\mathrm{k}_{\mathrm{j}}^{2}$ ) of the skeleton diagram, inchuding -functions in m om enta from vertioes. The com plete photon propagators are wrilten explicitly, except for the Lorentz structure ( i) ( $\mathrm{g} \quad \mathrm{kk}=\mathrm{k}^{2}$ ), which is included in I .
 This will be assum ed in the follow ing unless stated otherw ise. T he convolution theorem for $B$ orel transform s can be used to derive the identity

This expression is still too com plicated, because it contains the com plete photon propagators. The com plete propagators can them selves be expanded, if we consider the lim it, when the number of ferm ion avours $\mathrm{N}_{\mathrm{f}}$ is large. Then write

This expansion in chains is depicted in Fig. in in . The dashed line denotes a chain, ie. a photon propagator $w$ th an arbitrary num ber of simple ferm ion loops inserted. C is a subtraction constant for the ferm ion loop, $\mathrm{C}=5=3$ in the $\overline{\mathrm{M} S}$ schem e . Then we use again the convolution theorem to obtain

where $G(u)$ is a schem e-dependent function, whose expression, for exam ple in the $\overline{M S}$ schem e, can be found in Sect. 5 of $\left.{ }_{1}^{1-1} \overline{1} 1\right]$. (N ote that the param eter $u$ there, as in $m$ ost publications that deal mainly w ith infrared renorm alons in QCD, is de ned with an opposite sign com pared to the de nition we use in this paper.) $W$ e will not need an explicit form of $(u)$.

is the skeleton diagram $w$ th analytically regularized photon propagators? ${ }^{2}$ N ote that a di erent param eter is introduced for each photon line and the ferm ion lines are not regularized. For a physical quantity the sum over all skeleton diagram s is nite. For individual diagram $s$ allU V divergences are explicitly regularized by the param eters $u_{i}$, since the only loops w thout any regularization param eter in are ferm ion loops w ith four or $m$ ore photon lines attached, which are UV nite. Since ferm ion lines are not analytically regularized, gauge invariance is preserved.

The factorial divergence of perturbation theory corresponds to singularities of
 to know the singularities of the analytically regularized skeleton diagram. W e collect results on its singularity structure in the next subsection.

[^2]Corrections to the approxim ation of replacing the com plete photon propagator by a chain can be incorporated through the corrections to the rst term in eq. (2, $\overline{1}_{1} \overline{1}_{1}$ ). $B[G](\underline{q} ; u)$ is then expressed as a certain convolution integral of $G\left(\underline{q} ; u_{i}\right)$ and B [ $\left.1^{=}=\right](u)$. Sim ilar expressions follow, if one includes yet further term $s$ in eq. (2, $\overline{1} \overline{1}_{1}$ ). Thus, provided the vacuum polarization is known to the desired accuracy, one can restrict attention to analytically regularized skeleton diagram s.

W hen the com plete photon propagator is replaced by a chain, the calculation of B [G ] (q;u) for a skeleton diagram $w$ th an arbitrary num ber of chains follows from the usual Feynm an rules w th the follow ing m odi cations: T he photon propagator is given by

### 2.2 Singularities of analytically regularized Feynm an diagram s

To characterize the singularities of $B[G](q ; u)$ we use the results and techniques devel-
 $H$ ere we sum $m$ arize the relevant statem ents regarding their analytical structure. D etails can be found in the appendix.

Let F ( $\mathrm{q} ; \underline{\mathrm{m}}$ ) be a Feynm an integral corresponding to a graph. It is a function of extemalm om enta $\underline{q}=\left(q_{1} ;::: ; q_{1}\right)$ and $m$ asses $\underline{m}=\left(m_{1} ;::: ; m_{L}\right)$. Below we really need only the pure $m$ assless case. The Feynm an integral is supposed to be constructed from propagators of the form

$W$ e notice that the strongest divergence, $n!n^{2}$, arises from the forest that contains the box subgraph. The contribution from one chain, shown in $F$ ig. 'zia, produces only $1=\left(\begin{array}{ll}1 & u\end{array}\right)^{2}[-1 \overline{-1}]$. Therefore the diagram $s w$ ith two chains dom inate by a factor of $n$ over the single chain ones [1]ī]. This enhancem ent has a sim ple interpretation in term $s$ of counting logarithm s that are integrated over. In a given order $g^{2}{ }^{n+1}$ in perturbation theory the single chain in diagram (a) gives $n$ logarithm $s$ from $n$ ferm ion loops. O ne additional logarithm is generated from the UV behaviour of the reduced diagram, when the subgraph $f 1 ; 2 ; 4 \mathrm{~g}$ is contracted. The result is $n!\mathrm{n}$. In case of (b), at the sam e order in perturbation theory, we have only $n \quad 1$ ferm ion loops, but the reduced diagram after contraction of the box subgraph contains two UV logarithm s so that the total num ber of logarithm $s$ is the sam e as for (a). H ow ever, there exist $n$ ways of distributing $n \quad 1$ ferm ion loops over tw o photon propagators and the stronger divergence, $n!n^{2}$ arises from this com binatorial enhancem ent. In the follow ing we will see that the singular factors in eq. (2 ${ }^{2} \overline{3}^{\prime}$ ) originate from $d^{4} k=k^{6}$ term $s$ in the expansion of Feynm an integrands in extemal (exceptional) m om enta. This willallow us to associate the box subgraph with a counterterm proportional to a four-ferm ion operator in the sum ofeq. (1].3') and to give yet another interpretation of this enhancem ent.

W hat can be expected from diagram $s$ with more than two chains? Consider the ladder diagram with $N$ chains in Fig. ${ }_{-1} \mathrm{C}$. It is not di cult to see that the strongest singularity at $u=1$ com es from a forest built as follows: Start with the subgraph $\mathrm{f} 1 ; 2 ; \mathrm{N}+2 ; 2 \mathrm{~N}+3 \mathrm{~g}$ and continue by including subsequent ladders to the right. The product of $N+1$ singular factors for $\underline{u}_{0}=(1 ; 0 ;::: ; 0)$ is given by

resulting in the singularity $\ln ^{\mathrm{N}}{ }^{2}\left(\begin{array}{lll}1 & u\end{array}\right)=\left(\begin{array}{ll}1 & u^{3}\end{array}\right)^{3}$. Thus each additional chain yields an enhancem ent only by a factor of $\ln n$ for large $n$, but no additional factors $n$ occur. If we anticipate the association of the box subgraph $w$ th a four-ferm ion operator insertion, we can interpret the dressing by ladders as a renorm alization of this operator. T hus we expect that the series of singularities generated by ladder diagram $s$ (and $m$ any others) can be sum $m$ ed by renorm alization group $m$ ethods and exponentiates according to


This will.be discussed further in Sect. 5.
Beyond the point $u=1$, the Borel transform B $[G](\underline{q} ; u)$ de nes a multi-valued function due to the cuts attached to the singular points. The above analytic properties of $(\underline{q} ; \underline{u})$ im ply that after integration over $\underline{u}$ the singular points in $u$ in the right halfplane occur at integers w ith a cut attached to each such point. W e can therefore conclude that to any nite order in the expansion in chains the only singular points in the right half of the B orel plane are UV renorm alons at integer $u$. W hether this re ects the correct singularity structure of QED, depends on the behaviour of the $1=\mathrm{N}_{\mathrm{f}}$ expansion. For exam ple, the num ber of skeleton diagram s grow s rapidly in higher orders of $1=\mathrm{N}_{\mathrm{f}}$, so that the $1=\mathrm{N}_{\mathrm{f}}$-expansion of the norm alization K of V renorm alons could be com binatorically divergent. Factorial divergence of the perturbative expansion due to the number of diagram $s$ is indeed expected for theories w ith bosonic self-interaction. For theories w ith no bosonic self-interaction such as QED, the P auli exclusion principle enforoes strong cancellations. For QED w ith nite UV cuto , the combinatorial divergence was found

If this com binatorial behaviour persists when it interferes $w$ ith $U V$ renorm alization, the corresp onding singularities occur at $j u j=1$ in the B orelplane. Thus it is reasonable to assume that in QED the conclusions obtained from the chain expansion pertain to the fiull theory in any nite dom ain in the Borel plane.

It is interesting to com pare this w the non-abelian gauge theory. In this case the existence of instantons and bosonic self-interaction leads to singularities at nite values of $u$, connected w ith the value of the action of an instanton-antinstanton pair [2]in]. Because the action is independent of $\mathrm{N}_{\mathrm{f}}$, this singularity does not show up in any nite order in the $1=\mathrm{N}_{\mathrm{f}}$ expansion. (T he sim plest way to see this is to rescale the coupling as $a=N_{f}$ and to write $\exp (S=)=\exp \left(N_{\mathrm{E}} S=a\right)$, which has vanishing Taylor expansion in $1=\mathrm{N}_{\mathrm{f}}$.) Thus, as physically expected (for other reasons as well), a strict $1=\mathrm{N}_{\mathrm{f}}$ expansion is certainly in trouble for non-abelian theories.

## 3 E xtraction of singu larities

W hile the form ulas given in the previous section allow us to derive the n -dependence of the large-order behaviour for a given set of diagram s , we are still lacking a m ethod to com pute the overall norm alization w ithout having to com pute the analytically regularized Feynm an integrals exactly. In this section we rst derive a form ula that allow s calculation of the leading singularity, de ned as the collection ofterm sw ith the axim al num ber of singular factors in eq. (2-23), by consecutive extraction of pole parts of oneloop integrals. The next-to-leading singularity is de ned by the collection of term s w ith one singular factor less than the $m$ axim al num ber. W e shall see that the com putation of the rst correction to the nom alization $K$ of the large-order behaviour requires som e speci c contributions to the next-to-leading singularity and corrections to the approxi$m$ ation of the com plete photon propagator by a chain. T he techniques developed in this section are applied to the ferm ion selfenergy for illustration.

### 3.1 The basic form ula for the leading singularity

A sm entioned above the leading singularity (LS) of the given Feynm an integral is de ned as the sum of term $s$ in eq. ( 2 2d) w ith the $m$ axim al number of the factors ( ) in the denom inator. Eq. (2-2 ${ }^{2}$ ) show sthat this number is equal to or less than the $m$ axim al num ber of divergent subgraphs that can belong to the sam e forest. $N$ ote that divergent' for given $\underline{u}_{0} m$ eans $!_{\underline{u}_{0}}$ ( ) 0 . Suppose that these divergent subgraphs form a nested sequence $1 \quad::: n_{0}$ and let $k_{i}, i=1 ;::: ; n_{0}$, be the loop $m$ omentum of $i_{i}=i_{1}$ ( 0 is de ned to be the em pty set). The singular factors in eq. ( $2.2 \bar{n}^{\prime}$ ) arise when the intemal $m$ om enta of a given subgraph are $m u c h$ larger than the extemal $m$ om enta of this subgraph. T herefore we expect that the leading singularity arises from the strongly ordered region

B ecause ofthis ordering every subgraph appears as insertion ofa localvertex $w$ ith respect to the next loop integration. The leading singularity can then be found from consecutive contraction of one-loop subgraphs and insertion of the polynom ial in extemalm om enta associated $w$ th the localvertex. This fact is succinctly expressed by the follow ing sim ple representation for the leading singularity:

It is implied that these factors are partially ordered and before calculation of the residue res () $F=(u())$ all polynom ials associated w ith the set are inserted into this hext' reduced diagram. N ote also that for the Feynm an integral $F=$ (u ( )) the sum of regularization param eters is $u()$, rather than $u(=)$. It does not $m$ atter into which line of the reduced diagram $=$ the regularization param eter $u()$ is introduced, since the corresponding pole part in this does not depend on this choice. Eq. (3, 3 ) form alizes the expectation that the leading singularities of the B orel transform can be calculated by extracting pole parts of one-loop subgraphs and reduces to the purely combinatorial problem of $w$ riting dow $n$ all $m$ axim al forests for a given diagram

A proof ofeq. (3'2), based on the representation technique to resolve the singularities of Feynm an diagram s , can be found in the appendix. H ere we sum $m$ arize only the $m$ ain points of this approach.

The initial step is to represent the Feynm an diagram as an integral over L positive param eters ${ }_{1}$ corresponding to its lines. Then one perform $s$ a decom position of this representation into subdom ains which are called sectors $s^{T_{1},}$, and correspond directly to one-particle-irreducible subgraphs of the given graph. A fter introducing, in each sector, new variables associated w ith the fam ily of 1P I subgraphs of the given sector, the com plicated structure of the integrand is greatly sim pli ed, and the analysis of convergence and/or analytical structure w ith respect to the param eters of analytic regularization reduces to power counting in one-dim ensional integrals over sector variables. At this point one observes that the singular factors exactly correspond to divergent subgraphs of the given graph.

The leading singularity then appears from the sectors $w$ ith $m$ axim al num ber of divergent subgraphs. To calculate coe cients of the products of these singular factors one uses the local nature of $U V$ divergences. Practically, this $m$ eans that calculation of residues w ith respect to the corresponding linear com bination of analytical param eters reduces to Taylor expansion of the corresponding subdiagram in its extemalm om enta and inserting the resulting polynom ial into the reduced diagram. Eventually one com es to eq. ( $\left.\overline{3}-\bar{z}^{2}\right)$.

An altemative proof could usé, the $m$ ethod of glueing $\underline{\underline{p}} \overline{4}]$ which rests on integration of a given diagram w th an additional (gheing) analytically regularized propagator. $W$ ithin this $m$ ethod, the inform ation about the large $m$ om entum behaviour is encoded in analytical properties of glued diagram $s w$ ith respect to param eters of analytical regularization. In our problem, the idea would be to use an inverse translation of these properties to get the analytical properties of a diagram in the u-param eters from the large $m$ om entum expansion of speci c subdiagram s.

### 3.2 Self-energy: T he leading singularity

In this subsection we exem plify the extraction of the leading singular behaviour by selfenergy diagram $s$ w th two chains. These diagram s are shown in $F$ in. 'lice and d. Diagram e also contributes at the sam e order in $1=\mathrm{N}_{\mathrm{f}}$. (For the counting in $\mathrm{N}_{\mathrm{f}}$ it is useful to think of as being of order $1=\mathrm{N}_{\mathrm{f}}$.) It corresponds to a correction to the photon propagator in eq. ( $\overline{2} . \overline{1} \overline{1} \overline{1})$ and will be dealt with later. For com pleteness, we note that the B orel transform of the leading order diagram Fig.'İ-1 is given by

The selfenergy requires reno alization beyond reno alization of the coupling. In general this requirem int is translated into the necessity to subtract those singularities in the $u_{j}$ that give rise to a singularity at $u=0$ of the B orel transform. (Such a singularity prevents the calculation of oe cients $r_{n}$ of the perturbative expansion as derivatives of the B orel transform at $u=0$, see Sect.2.1.) In the present case, the pole at $u=0$ is absent, because the logarithm ic UV divergence of the one-loop selfenergy cancels in Landau gauge. W hen fem ion loops are inserted in the photon line, logarithm ic overall divergences are present. In term s of the B orel transform their subtraction in a specie ed scheme e am ounts to subtracting an arbitrary function of $u$ w th the only restriction that
it does not have a pole at $u=0$. In the $\overline{\mathrm{MS}}$ schem e this function is entire $[\overline{1} \overline{1}]$ and does not introduce new singularities at any $u$. In general, it is quite non-trivial to determ ine this function in a given renorm alization schem e (for a single chain see [1]ind, appendix A). W e do not discuss this point further, since ourm ain interest concems physicalquantities. In this case all subtractions necessary for UV niteness are im plicitly contained in the de nition of the renorm alized com plete photon propagator.

In the vicinity of the other point, $u_{1}=1, u_{2}=0$, the potential pole $1=u_{2}$ is absent due to niteness of the one-loop selfenergy in Landau gauge as noted above. Thus diagram c does not contribute at all to the leading singularity. N ote that according to eq. ( $\overline{3} \bar{L}_{2}$ ) and the appendix, the regularization param eter associated w th the photon line of the reduced diagram is $u=u_{1}+u_{2}$, rather than $u_{1}$. In other words, the reduced diagram inherits the $u$-param eters from the contracted subgraph, here $u_{2}$. The reason for this is that the singularities in $\underline{u}$ from an elem ent +2 F (in the present example $+=$ ) are determ ined by $u(+)$, rather than $u(+=)$, see Sect. 22. A less form al argum ent com es from doing the subgraph exactly. Sim ply by dim ensional reasons the B orel transform is proportional to $\left({ }^{2}=\left(\begin{array}{ll}Q & k_{1}\end{array}\right)^{2}\right){ }^{u_{2}}$, so that the param eter $u_{2}$ is attached to the ferm ion line of the reduced graph. The singularities of the reduced graph arise in tum from the integration region $k_{1} \quad Q$, so that we $m$ ay neglect $Q$ in this expression and attach the param eter $u_{2}$ to the photon line, where it com bines $w$ ith $u_{1}$ to $u$. $T$ his statem ent is true in general (se the appendix): In calculating the leading singularity, the u-param eters inherited from the contracted subgraph can be attached to an arbitrary line of the reduced graph.

Tuming to diagram $d$, consider the forest $f f 1 ; 3 ; 4 g ; ~ d g$. A gain we have to analyze the points $\underline{u}_{0}=(1 ; 0)$ and $\underline{u}_{0}=(0 ; 1)$. The second one does not contribute tw o singular factors, since the one-loop vertex subgraph $f 1 ; 3 ; 4 \mathrm{~g}$ shown in $F$ ig. 'ī1b is UV nite in Landau gauge, so that no singularity $1=u_{1}$ occurs. In the vicinity of the rst point
we require the singularity of the vertex subgraph at $u_{1}=1$. W th the m om entum assignm ents of F ig. 1 'İb we nd

T he algebraically $m$ ore extensive case of the vertex and vacuum polarization is treated in Sect. 4.

### 3.3 N ext-to-leading singularity and $\mathbb{R}$ rearrangem ent

At this point it is helpfiul to refer again to the large-order behaviour of perturbative expansions, eq. (1-2'). W thin the expansion in the num ber of chains, we write

This distinction is im portant both as far as the physical origin of the singularity is concemed as well as its extraction. Recall that, for exam ple for the contribution from Fig. 'īd to the selfenergy, the leading singularity (two singular factors) com es from the loop $m$ om entum regions

Only in the rst case we obtain $1=\left(\begin{array}{ll}1 & u\end{array}\right)$, because both virtual photons have $m$ om entum larger than the extemalm om entum $Q$, so that the large-m om entum part of the diagram contains all available u-param eters. M oreover, because of this, the residue of the pole is polynom ial in the extemal m om entum. On the other hand, the regions listed in the second line lead to singularities $1=\left(\begin{array}{ll}1 & u_{j}\end{array}\right)$. The residue is no longer local (polynom ial in extemalm om enta), but contains $\ln \left(Q^{2}={ }^{2}\right)$. A smple way to see this is to note that by dim ensional reasons the B orel transform for diagram $d$ is proportionalto $Q\left(Q^{2}={ }^{2}\right)^{u}$. $T$ his im plies that the leading singularity at $u=1$ in fact arises in the com bination

W e also see that if explicit renorm alization (in the usualsense) is needed as in case of the self-energy, the arbitrariness in choosing nite subtractions a ects only the residues of $1=\left(\begin{array}{ll}1 & u_{j}\end{array}\right)$. Indeed, the e ect of such a subtraction is described by (taking $j=2$, so that the logarithm ic $U V$ divergence occurs in the subgraph with photon line regularized by $u_{1}$ )

$T$ he fact that the residues of the singular factors that contribute to the overall norm alization of renorm alon divergence are polynom ial in the extemal m om enta allow s us
 originally developed for and successfiully applied to renorm alization group calculations. In its original form, the $m$ ethod is based on polynom ialdependence of UV counterterm s on $m$ om enta and $m$ asses. It consists of the follow ing two steps: (a) Di erentiation in extemalm om enta and intemalm asses. The problem thereby reduces to the calculation of zero-degree polynom ials. (b) Putting to zero all the intemal masses and extemal $m$ om enta except one. U sually, at step b one puts to zero all the $m$ om enta and $m$ asses and chooses a new $m$ om entum that ow sthrough the diagram in som e appropriate way. $T$ he goal is to $m$ ake this choice in such a way that the diagram becom es calculable. In sim ple cases the problem reduces to calculation of the pole part of prim itively divergent propagator-type integrals or vacuum integrals $w$ th one non-zero $m$ ass. The application in the present context is illustrated in Sect. 3.4.

The argum ents presented above can easily be generalized to the contribution $K^{\mathbb{N}}$ ] to the norm alization $K$ from $N$ chains. For such a contribution we need at least oneé, singular factor of type $1=\left(\begin{array}{ll}1 & u\end{array}\right)$, (w ith $\left.u=u_{1}+:::+u_{N}\right)$. A theough no ordering of loop $m$ om enta is required, all loop $m$ om enta $k_{i}$ have to be $m$ uch larger than the extemal m om enta $\underline{q}$ in order to get such a singular factor. Therefore the residue of these term s rem ains local for any N. Sim ilarly, if U V renom alization is necessary, the arbitrariness in choosing nite subtractions a ects the singularity of the Borel transform only at the level of $\mathrm{ln}^{\mathrm{k}}(\mathrm{l} \quad \mathrm{u})$ (where typically $\mathrm{k}<\mathrm{N}$ ) and therefore m odi es only the $1=\mathrm{n}$ corrections to the asym ptotic behaviour in eq. ( $\overline{3} \overline{1} \overline{1} \overline{1})$. A schem e-dependence enters the overall nom alization only through the subtraction constant C for the ferm ion loop $\left[\begin{array}{l}{[\bar{\sigma} \bar{\sigma}}\end{array}\right]$, see eq. (2.1 10 '). W th the help of $\mathbb{R}$ rearrangem ent, the calculation of $K$ to an arbitrary order in the expansion in chains reduces to extracting pole parts of prim itively divergent propagator-type integrals or vacuum integrals with one non-zero m ass.
$N$ ote that $\mathbb{R}$ rearrangem ent can be applied also to the calculation of $1=n$ corrections to the asym ptotic behaviour. Because of the logarithm $s$ in extemalm om enta that enter in this place, one must apply explicit subtractions in subgraphs, which rem ove these logarithm s . Since the com binatorial structure of eq. (2-23') is com pletely analogous to the one that arises in the context of usual renorm alization, the com binatorial structure of the subtraction operator is equally sim ple. We will retum to this point in Sect. 5.

### 3.4 Self-energy: T he next-to-leading singu larity

In this subsection we illustrate the calculation of $K^{[2]}$ and the use of $\mathbb{R}$ rearrangem ent for this purpose by continuing w ith the fem ion selfenergy. W hen $={ }_{c}$; as ashown in $F$ ig. at u! 1:

This rem aining term can be traced to eq. (3) and then further to the coe cient of the pole of $F(u)$ at $u=0$. It is therefore unam biguously identi ed as the expected correction to b in eq. (112. In $_{1}$ ) due to two-loop evolution of the coupling (see Sect. 5).

The cancellation between vertex and propagator corrections is of general nature and recurs in further exam ples in Sect. 4. It can be phrased as a cancellation between the tw o subgraphs show $n$ in $F$ ig. 'iand for any diagram that contains the left subgraph there is a diagram that contains the right one and vioe versa. A ssum e that these diagram s have N and $\mathrm{N}+1$ chains respectively. The contraction of the left vertex subgraph gives $C=\left(\begin{array}{ll}1 & u_{v}\end{array}\right)$ with som e constant c. N ow consider the other subgraph. C ontraction of the vertex subgraph in the inner box gives $\mathrm{c}=\left(1 \quad \mathrm{u}_{\mathrm{v}+1}\right)$ w th the sam e constant c when $\mathrm{u}_{\mathrm{N}+1}$ is close to one. The subsequent contraction of the second box tums the sim ple pole into a double pole. If one takes into account all factors, including the di erent power of 0 in eq. ( $\overline{2} \cdot 1$ that the coe cient of the double pole is (i)c. A fter this contraction, the lower chain carries regularization param eter $u_{N}+u_{N+1}$. A factor (i) from one photon propagator is obtained from joining the two chains into one (this can be done, since both have the sam e $m$ om entum ). O ne can then $m$ ake use of the fiunction constraint in eq. ( 2 ( $1=1$ From the left diagram we get sim ply

B oth contributions cancel each other up to non-singular term s. A s a result the leading singularity drops out in the sum of the two diagram s that contain the graphs of $F$ ig. $\bar{i}$
as subgraphs. This cancellation does not apply to the next-to-leading singularity of the diagram s.
$F$ inally we note that eq. $(\overline{3} \overline{3} \overline{3} \overline{3})$ is universal and can be used for any $G$ reen function w ith the obvious replacem ent for the corresponding leading order B orel transform .

## 4 Vertex function and vacuum polarization

In this section we tum to the classical exam ple of the photon vacuum polarization. For reasons that will becom e clear it is useful to consider rst the ferm ion-photon vertex function. W e restrict ourselves to the leading singularity at $\mathrm{u}=1$.

The photon vacuum polarization is gauge-independent. O ne can introduce a gauge param eter , so that the Lorentz structure in eq. '(2-1") takes the fam iliar form for covariant gauges. The result must be independent of . In particular, one can take Feynm an gauge and considerably sim plify the algebra connected $w$ th num erators. The price to pay for this sim pli cation is the presence of singular factors like $1=\left(\left(\begin{array}{ll}1 & u\end{array}\right) u_{j}\right)$ in individualdiagram $s$, which are absent in Landau gauge, because the one-loop selfenergy and vertex function are separately UV nite in this gauge. To render each diagram separately nite, one would have to add the usual counterterm s. In practioe we do not have to bother about these subtractions, since we know that all such singular factorsm ust cancel in the nal result. $W$ e have done the calculation for the vacuum polarization in an arbitrary covariant gauge and veri ed independence of explicitly. G auge-dependent interm ediate expressions that follow below are given in Landau gauge, as before.

### 4.1 Vertex function

Seven of the 18 com binations lead to insertions into reduced graphs that vanish. The rem aining eleven ones are described as follow s, according to their subgraph :

The rst line has a sim ilar structure as in case of the selfenergy. The two-loop evolution of the coupling leads to a logarithm ic enhancem ent in the large-order behaviour,
${ }_{0}^{\mathrm{n}} \mathrm{n}$ ! ln n , while being form ally of order $1=\mathrm{N}_{\mathrm{f}}$. T he second line incorporates the contributions from box type subgraphs, which were absent for the selfenergy (at the level of two chains). While this contribution starts at order $1=\mathrm{N}_{\mathrm{f}}$, it leads to an enhanced divergence in large orders, on !n for the reasons explained in Sect. 22 . In the language of operator insertions, introduced in Sect. 1 and pursued in Sect. 5, we can identify this contribution w ith an insertion of the operator $5_{5} \quad 5$ in place of the box subgraph, see eq. ( $\overline{4}-\overline{1})$. The pattem of large-order behaviour for the vertex function $w$ ith two chains is the same as for the vacuum polarization in tī 1 ]. W ith the help of $\mathbb{R}$ rearrangem ent one can also com pute the NLS, i.e. all term s that yield $1=\left(\begin{array}{ll}1 & u\end{array}\right)$. In particular, the contribution from propagator corrections $K_{\text {prop }}$ is the same as for the selfenergy in Sect.3.5.

### 4.1.2 Vertex diagram s w ith one ferm ion loop and three chains

In this subsection we analyze the set of graphs, labelled (1) to (6) in Fig. í diagram s have three chains, but contribute at order $1=\mathrm{N}_{\mathrm{f}}^{2}$, because the ferm ion loop brings a factor $\mathrm{N}_{\mathrm{f}}$. This set of diagram s is separately gauge-independent and we use Feynm an gauge to sim plify the algebra. The leading singularity is determ ined by the contributions $w$ ith the $m$ axim alnum ber of singular factors in eq. ( $\overline{2} \overline{2} \bar{z})$ which is three for the diagram $S$ in $F$ ig. ' the counting in $1=\mathrm{N}_{\mathrm{f}}$ and chains is no longer equivalent beyond a certain order. In general it is the num ber of chains and not the power in $1=\mathrm{N}_{\mathrm{f}}$, which determ ines the strength of the renorm alon singularity and the divergence in large orders of perturbation theory, so that the diagram s in Fig. 'i-1 can be expected to dom inate the large-order behaviour at order $1=N_{f}^{2}$. W e determ ine the singularity at $u=1$ up to term $\operatorname{sln}\left(\begin{array}{ll}1 & u\end{array}\right)=\left(\begin{array}{ll}1 & u\end{array}\right)$. This includes those parts of the next-to-leading singularity that produce $1=(1 \quad u)^{2}$.

A susual, the leading singularity is determ ined by subsequent contractions of one-loop subgraphs. The eight subgraphs that contribute to the singularity at $u=1$ are enum erated (1a) to (6b) in $F$ ig.' lead to vanishing (tadpole-type) reduced graphs. O ther subgraphs like those in the last row of Fig. 'ig have non-vanishing reduced graphs, but do not contribute at $u=1$. For the rst two graphs in that row, the contraction can be seen to correspond to operators ofdim ension eight, which contribute to $u=2$ and higher poles only. In other words, the degree of divergence is! ( ) 3. The last graph need not be considered, because the subgraph contains only ferm ion lines and no u-param eter.

The subgraphs of all eight non-vanishing contributions have the form of boxes or crossed boxes'. W hen each box is com bined with its corresponding crossed box, con-

As in the case of the self-energy, we use the $m$ ethod of infrared rearrangem ent to obtain the coe cient of the singular factor $1=\left(\begin{array}{ll}1 & u\end{array}\right)$ of the two-loop (three chain) fourferm ion graphs. ### 4.2 Vacuum polarization

W ith the results for the vertex function, the results for the vacuum polarization are $\mathrm{m} m$ ediate. A specialty of the vacuum polarization is that the skeleton diagram s corresponding to diagram swith one chain have two loops. This gives an additional factor $n$ in large-orders as com pared to the vertex already in low est order.

### 4.2.1 O ne chain

The diagram swith a single chain are part ofF ig. in . The diagram where the chain form s a self-energy subgraph does not contribute to the leading singularity. The reason is that the only forest that does not lead to tadpole reduced graphs is the one with the selfenergy subgraph. If $p$ is the extemalm om entum of this subgraph, the selfenergy close to $u=1$ is proportional to $p^{2}(9, s e q .(\overline{3}-\overline{3})$, and the insertion of this polynom ial into the reduced graph elim inates any $1=\mathrm{p}^{2}$ from loop lines of the reduced graph. T hus the reduced graph is e ectively a tadpole and vanishes. W e are left w th the rst graph in the second line of F ig. ${ }_{\mathrm{I}}^{\mathrm{I}} \mathrm{I}$. The overall factor tw o accounts for the tw o possible insertions into the left or right vertex. To com pute the $1=n$ corrections one would use $\mathbb{R}$ rearrangem ent w ith additional subtractions of non-local term $s$ in extemal $m$ om enta.

### 4.2.2 Two chains

W e calculate the leading singularity for the diagram $s$ with two chains, see $F$ ig. 'isi. A $m$ axim al forest contains three 1P I elem ents. $N$ ow we encounter for the rst tim e forests, where non-trivial elem ents are disjoint and do not form a nested sequence, for instance for the third diagram in class (IV ). H ow ever, close to $u=1$, such forests do not contribute to the leading singularity, since they produce at $m$ ost $\ln \left(\begin{array}{ll}1 & u\end{array}\right)=\left(\begin{array}{ll}1 & u\end{array}\right)$. W hen the nontrivialelem ents form a nested sequence, the reduced diagram is a tadpole, whenever the sm allest subgraph in this sequence contains one or both of the extemal vertioes.

W ith these restrictions in $m$ ind, let us tum to the diagrams (I) in Fig. ig. The sm allest graph in each non-vanishing $m$ axim al forest is a self-energy subgraph. Close to $u_{i}=1$, where $u_{i}$ is the regularization param eter of this subgraph, it reduces to an insertion proportional to $p^{2} \Phi, w$ ith $p$ the extemalm om entum of the subgraph. A gain this insertion elim inates one denom inator, so that the reduced graph in fact vanishes. O ne can convince oneself that for class (II) a non-tadpole reduced graph alw ays requires contraction of the tw o-loop selfenergy subgraph. We then get the sam e cancellation as for (I). Thus there is no contribution to the leading singularity from the rst seven diagram s.

C onsidering class (III) and (IV), we can divide allm axim al forests into three groups: (i) A forest of type $\mathrm{fF}_{\text {vertex }}$; g , where F vertex is a forest that has already been evaluated for the two-chain vertex ( $F$ ig. ${ }^{\prime} \bar{j} /{ }^{\prime}$ ) and is the entire diagram . (ii) Forests $w$ ith nested 1P I elem ents, not belonging to group (i). (iii) Forests w ith disjoint one-loop elem ents. It tums out that (ii) always leads to reduced graphs of tadpole type and (iii) does not contribute to the leading singularity as noted above. T hus we arrive at the same conclusion as in the case of a single chain that the leading singularity of the vacuum polarization is given by insertion of the result for the vertex function, in the present situation eq. ( $\overline{4}-\bar{L}$ ) $)$ or eq. ( $\overline{4} . \bar{d})$, if one includes already the propagator corrections. A gain, only the term $s$ involving $Q$ contribute for the sam e reason as above. Since such term $s$ do not arise from class (III) diagram $s$, only the nal four diagram $s$ in $F$ ig. 'ïi contribute to the leading singularity. (T his could be deduced without know ing the result for the vertex function, applying the sam e argum ent as to class (I) and (II).) The insertion leads to exactly the sam e integral for the reduced graph as in eq. (including propagator corrections)

The corrections to this result are $O\left(1=N_{f} ; \ln ^{2} n=N_{f}^{2}\right)$ relative to the unity in brackets. The pattem of divergence is the same as for the vertex function in that contractions that lead to four-ferm ion operator insertions are enhanced by a factor of $n$ as discussed in Sect. 22. In analogy w ith the vertex fiunction, Sect. 4.12 , the light-by-light' diagram s w ith three chains and tw o ferm ion loops, not shown in Fig. ' 18 , contribute to the vacuum polarization at subleading order in $1=\mathrm{N}_{\mathrm{f}}$.

Setting the expression in curly brackets to zero, eq. ( $\overline{4} \overline{1} \overline{1} \overline{1})$ ) agrees w ith the corresponding result in the erratum to $[\underline{1}$ by a certain charge assignm ent to the ferm ions. C om pared to the approach taken there, based on the background eld technique, the diagram $m$ atic form alism presented here lacks the elegance ofm aintaining explicit gauge invarianc. This leads to a proliferation
 the conceptual fram ew ork developed in Sect. 3 allow $s$ us to system atically com pute corrections, either from $m$ ore then two chains or contributions subleading in $n$ for large $n$, such as the rst correction to the norm alization $K$ of the large-order behaviour (see the exam ple of the selfenergy in Sect. 3) and thus elucidates the origins and organization of divergence for arbitrarily com plicated diagram $s$. The understanding of the system atics of the chain expansion to all orders is the sub ject of the follow ing section.

## 5 UV renorm alon counterterm $s$ and renorm alization group

The previous exam ples illustrate that diagram s w ith a larger num ber of chains (suppressed by powers of $1=\mathrm{N}_{\mathrm{f}}$ ) lead to stronger divergence in large orders of perturbation theory. Except for an enhancem ent of $n$ due to the new class of box-type subgraphs, the enhancem ent is logarithm ic in $n$. For each additional chain one can obtain at most one $\ln n$, as there is one additional singular factor in the $u$-param eters. The expansion param eter of the chain expansion is in fact $\ln n=N_{f}$ and any nite order approxim ation in $1=\mathrm{N}_{\mathrm{f}}$ does not provide the correct asym ptotic behaviour in n .

The situation is rem iniscent of standard applications of the renom alization group, which allow us to deduce the large-m om entum behaviour of $G$ reen functions, which can not be determ ined from nite-order perturbative expansions in. The key idea
is to prove factorization of the dependence on the variable under consideration and relate this dependence to one on an arti cial factorization scale. In the present case, factorial divergence in $n$ is equivalent to poles in the B orel param eter $u$, whidh in tum are related to the regions of large loop $m$ om enta. Speci cally, fror the contribution from a given forest, the leading singularity could be determ ined from the $d^{4} k=k^{6}-\mathrm{pi}$ iece in the expansion of the sm allest non-trivial elem ent of the forest in its extemalm om enta and thereby associated w ith insertion of a dim ension six operator. G eneralizing this observation, the desired factorization would be sum $m$ arized by the statem ent [4i] that the leading UV renom alon could be com pensated in all $G$ reen functions by adding

to the renorm alized Lagrangian, where $\mathrm{O}_{\mathrm{i}}$ are dim ension six operators and $\mathrm{E}_{\mathrm{i}}(\mathrm{l}$ ()) factorially divergent series in with nite coe cients that depend on the renom alization conditions im plied for the (usual) renorm alized Lagrangian as well as the operators $\mathrm{O}_{\mathrm{i}}$.

Such a statem ent im plies that UV renorm alons are local. Indeed, all explicit results for large-n behaviour given so far were straightforwardly obtained as local quantities (polynom ial in extemal m om entum ). But the expectation to get each time a local result is too naive and logarithm s of the extemal mom enta arise at the level of $1=\mathrm{n}$ corrections $s_{-1}^{1,1} T$ he situation is rather sim ilar to the calculation of V counterterm s . If one does not rem ove subdivergences and calculates the pole part of a diagram in $=(4 d)=2$ (where d is the space-tim e dim ension) the result is inevitably non-local. To get a proper answer one should rst take care of all the subdivergences of the diagram by inserting the corresponding counterterm $s$ which subtract the subdivergences. In the case of $U V$ renorm alons, one should also subtract, for subgraphs of a given graph, the factorial divergence associated with subgraphs. This procedure is of course im plicit in writing eq. (5. ${ }^{\prime}$ ') and the non-trivial assertion is that the rem aining bverall UV renorm alon divergence for the given graph is indeed local. The UV renorm alon subtractions will be organized in the same way as usual subtractions of UV divergences that enter the standard UV R -operation (i.e. renorm alization at the diagram $m$ atical level).

In Sect. 5.1 we illustrate the procedure on the sim plest exam ple, then de ning the general R-operation in Sect. 52. The analogy with the usual $R$-operation suggests eq. (5̄.j.'), but we do not actually prove this result. The resulting com binatorial structure of the R -operation enables us to straightforw ardly translate our result into the Lagrangian language. The best way to establish this property manifestly is to apply form ulae of the so-called counterterm technique [20 ${ }_{2} 9,1$ on com binatorial properties of the $R$-operation and locality of counterterm s . W e shall list the corresponding form ulae in Sect. 5.3. These form ulae do not explicitly give the operators which are added to the Lagrangian in every concrete situation. In Sect. 5.4 we characterize these operators, the corresponding renorm alon counterterm $s$ and derive renorm alization group equations for the coe cient functions $E i_{i}$ that enter eq. (5. $\overline{5}$ I' $)$. The solutions to these equations sum all contributions of order ( $\left.\mathrm{ln} \mathrm{n}=\mathrm{N}_{\mathrm{f}}\right)^{\mathrm{k}}$ and provide the correct asym ptotic behaviour in $n$, up to an overall constant, that can be determ ined

only order by order in $1=\mathrm{N}_{\mathrm{f}}$. For the vacuum polarization, this solution is found in Sect. 5.5.

### 5.1 C ounterterm s: A n exam ple

The simplest case of subtraction of subdivergences, considered already in photon vacuum polarization with a single chain.

Let G ( $\underline{i} ;$ ) represent the perturbation series in , generated by the set of diagram s , such as show $n$ in $F$ ig. '包 for the vacuum polarization. A ssum ing that we know how to extract the factorialdivergence for a given set of diagram s including $1=\mathrm{n}^{\mathrm{k}}$-corrections to the leading asym ptotic behaviour up to som e speci ed value $k_{0}$ of $k$, we de ne an operation $K$ that does this. If the factorialdivergence com es from a branch point in the B orel plane as is generally the case, $\mathrm{k}_{0}$ cuts o the in nite series of corrections to the leading asym ptotic behaviour. If it com es from a pole, as for a single chain, this series term inates by itself. Since there is only one regularization param eter $u$, the singularities at $u$ ! 1 are of the form $1=(1 \quad u)^{2}$ and $1=\left(\begin{array}{ll}1 & u\end{array}\right)$. The residue of the simple pole of the corresponding skeleton diagram w ith analytically regularized photon propagator involves a logarithm of the extemalm om entum. In term $s$ of large-n behaviour, we nd

The insertion of counterterm $s$ for subdiagram s generates new UV divergences. Their subtraction corresponds to a renorm alization prescription for the set of dim ension six operators. Since the u-param eters are not su cient to regularize these UV divergences, we have applied dim ensional regularization. It is straightforw ard to read o the coe cient E ${ }_{4}^{0}$ from the previous equation, so that the vacuum polarization is free from the rst UV renorm alon, if the operators $\mathrm{O}_{3}^{0}$ and $\mathrm{O}_{4}^{0}$ are added to the Lagrangian w ith appropriately chosen coe cients.

For diagram s w ith two chains, the diagram swith counterterm insertions also have to be calculated in the chain expansion. C onsider the diagram shown in Fig.'İ̄a that contributes to the self-energy. Combining results from Sect. 3, the B orel transform of this (set of) diagram (s) in the vicinity of $u=1$ can be represented as

In the $\overline{\mathrm{MS}}$ scheme only the logarithm ic divergences are subtracted, so that $\mathrm{R}\left(\mathrm{u}_{2}\right)$ is analytic except at $u_{2}=0$. It appears that there is also a logarithm ic singularity in $u$ from the other integration boundary, $u_{2}!1$, because $P\left(u_{2}\right)$ is singular at this point. This contribution would be proportional to $Q\left(Q^{2}={ }^{2}\right)^{2}$. H ow ever, we can alw ays choose the series for $\mathrm{E}_{3}^{0}$ to start at som e su ciently large $n$, so that the region $u_{2}$ ! 1 is suppressed by a zero ofB $\left.\mathbb{E}_{3}^{0}\right]\left(u_{1}\right)$ and is non-singular.

It is w orth em phasizing that the non-localterm s are related to logarithm ic divergences of the reduced diagram $s$ (diagram $s$ with insertion of dim ension six operators), while their coe cient is also unam biguously related to the leading singularity of the original diagram. (A s in dim ensional regularization a pole in is accom panied by a logarithm in $m$ om enta.) This property allow $s$ us to sum the leading singularities to all orders in $1=\mathrm{N}_{\mathrm{f}} \mathrm{w}$ th a variant of standard renom alization group techniques.

W e also note that as long as we consider only the rst UV renorm alon at $u=1$, we do not have to consider multiple insertions of dim ension six operators. For instance, for tw o insertions, to be sensitive at once, to the singularity at $u\left({ }_{1}\right)=1$ and at $u(2)=1$, we need at least $u=2$, since the 1 and 2 can not have com $m$ on $u$-param eters. N ote that these extra M S-counterterm $s$ (associated w ith the renorm alization of dim ension six operators) are not inserted in the usualway: W e have counterterm sP accom panied by such counterterm s but do not have these counterterm s alone.

A $s$ in the usual calculation of counterterm $s \mathbb{R}$ rearrangem ent can be used (as in Sect. 3.3) to sim plify the calculation of $P$, i.e. we di erentiate ! W e state w thout detailed proof that the P will indeed be local (polynom ial), so that the corresponding subtractions can be im plem ented in term sof dim ension six operators in the Lagrangian. A com plete proof would follow the sam e strategy as for the usual $R$-operation.

The operation $R$ was de ned at the diagram $m$ atic level. $H$ owever, the com binatorial structure of the $R$-operation, eq. ( $\overline{5}: 1$ enable one to express the renom alization procedure by inserting counterterm s into the Lagrangian. Rem em ber that to absorb the large order behavior into the Lagrangian we restrict ourselves to the dim ension six nite extra counterterm swhile the in nite extra counterterm $s$ serve to renom alize diagram $s$ which are generated by insertion of these dim ension six operators.

### 5.4 R enorm alization group equations

Since we do not necessarily want to $m$ odify the Q ED Lagrangian by higher-dim ensional operators, the $m$ ain relevance of the statem ent that $U V$ renorm alons could be compensated in this way is that it provides inform ation about the large-n behaviour of perturbative expansions in the unm odi ed theory beyond the $1=\mathrm{N}_{\mathrm{f}}$-expansion.

To develop the argum ent it is convenient to adopt a di erent language for the counterterm $s$ (and we stress that the physical content stays the same \{ in particular it is entirely perturbative, although som e expressions $m$ ay not appear so). G iven the Borel transform B [G](u), we can form ally recover G ( ) by

(To obtain the com plete $1=\mathrm{n}^{k}$-corrections to the leading large-n behaviour one has to com pute $\mathrm{G}_{\mathrm{O}_{\mathrm{i}}}$ ( ) to order ${ }^{k}$ in addition.) The initial conditions $\hat{E}_{j}$ provide the overall norm alization, which has to be determ ined, for each operator, from a suitably chosen $G$ reen function. $T$ his calculation can be done system atically only through expansion in $1=\mathrm{N}_{\mathrm{f}}$. A solution of form ( 5 quark e ective theory context. Sim ilar ideas, although in a technically som ew hat di erent set-up, were used by Vainshtein and Zakharov [ī] to nd the asym ptotic behaviour of a current two-point function in a QED-like model.

Let us now discuss the set of operators $\mathrm{O}_{\mathrm{i}}$. Since we consider operator insertions into G reen functions, which can have o -shell extemalm om enta, we keep operators which vanish by equations of $m$ otion as well as gauge-variant operators in the general case. $H$ ow ever, not all operators are of im portance for any given $G$ reen function $G$, since the contribution to $\mathrm{Im} \mathrm{G}^{\text {from }}$ an operator $\mathrm{O}_{\mathrm{i}}$ w ith coe cient $\mathrm{E}_{\mathrm{i}}$ (which is independent of $G$ ) can have additional factors of from $G_{O_{i}}()$, which lead to $1=n$-suppression in the contribution to the large-order behaviour of $G$.

### 5.5 A sym ptotic behaviour

### 5.5.1 Solution to the renorm alization group equation

W e now solve the renorm alization group equations, eq. (5 5 a renorm alization group im proved' form for the large-order behaviour of the vertex function and vacuum polarization which replaces the next-to-leading $1=\mathrm{N}_{\mathrm{f}}$-result given
in Sect. 4. This im proved form sum $s$ all ( $\left.\ln n=N_{f}\right)^{k}$-contributions to all orders in $1=\mathrm{N}_{\mathrm{f}}$ and provides the correct asym ptotic behaviour in $n$ w th corrections being of order $1=n$ or $1=\mathrm{N}_{\mathrm{f}}$. In the case of the vertex fiuction, we consider only the case when the extemal
 be neglected. A s a consequence, eq. ( $\left.5.3 \overline{3} \bar{z}^{\prime}\right)$ exhausts the list of all possible dim ension six operators, since we have to consider zero-m om entum insertions only and restrict ourselves to gauge-invariant quantities.

In the operator basis chosen above, the anom alous dim ension m atrix is block triangular, since the operators that vanish by the equation of $m$ otion do not $m$ ix into those that don't. T he result for the anom alous dim ension $m$ atrix is

A $l l$ entries are given to low est order in for each entry. C orrections of order w ill generate only $1=\mathrm{n}$-corrections to the asym ptotic behaviour in n and we do not consider such corrections. Eq. ### 5.5.2 M atching

It rem ains to determ ine the integration constants $\hat{\mathrm{E}_{i}}$ by $m$ atching the solution to the renorm alization group equation above with the results of explicit calculations in the chain expansion. W e do this interpreting $\mathrm{E}_{\mathrm{i}}(\mathrm{l})$ as factorially divergent series in . Com parison w ith explicit calculation provides a non-trivial consistency check as it must be reproducible $w$ ith four $n$-independent constants $\hat{E_{i}}$.

Four-ferm ion scattering. Since the insertion of $\mathrm{O}_{3}$ and $\mathrm{O}_{4}$ into the four-point function vanishes, the four-point function allow $s$ us to determ ine $\hat{E_{1}}$ and $\hat{E_{2}}$. Asmentioned before, we consider on-shell extemal ferm ion legs. M ost of the ingredients for the calculation of four-ferm ion scattering to next-to-next-to-leading (NNLO) order in $1=\mathrm{N}_{\mathrm{f}}$ are scattered am ong previous results and we quote results only after putting them together.

At leading order, we have a tree diagram with a single chain. It does not yield divergences in large orders. At next-to-leading order, the set of $1 P$ I diagram s consists of

As far as we can tell, our result would coincide w ith [ $\left[\begin{array}{l}\overline{1} \overline{4}]\end{array}\right]$, if the sam e condition were im posed, although our derivation and form alism is technically di erent (but physically equivalent).

V ertex fiunction. Since all $\hat{E}_{i}$ are now xed (to leading order in $1=\mathrm{N}_{f}$ ), we obtain a prediction for the vertex function $w$ thout free param eters. For the three-point function, the 1PR diagram sw ith an insertion of $O_{4}$ into the extemal photon line are not suppressed for large $n$, since $E_{4}()=E_{3}() \quad n$. To obtain the 1PR vertex function, one would have to am putate the extemalphoton line and the corresponding contribution to the large-n behaviour that com es from the photon vacuum polarization.

## 6 C onclusion and outlook

W e have described a system atic approach to factorial divergence in large orders of perturbation theory generated by large-m om entum regions of loop integrations. In this approach we reorganize the full perturbation series in term $s$ of diagram $s$ with a xed num ber of chains, equivalent to an expansion in $1=\mathrm{N}_{\mathrm{f}} . \mathrm{W}$ e can then exploit a standard technique applied for analysis of $U V / \mathbb{R}$ divergences and singularity structure of analytically regularized Feynm an am plitudes to classify the UV renom alon singularities of the B orel transform for any given class of diagram s . The problem of nding the overall norm alization $K$ of the large-order behaviour reduces to calculating the residues of these singularities. T he coe cient of the strongest singularity can be found algebraically by repeated contraction of one-loop subgraphs, but provides inform ation on anom alous dim ensions only. A non-trivial contribution to K requires calculation of part of the next-to-leading singularity. H ow ever this part is local so that it can be obtained w ith the help of infrared rearrangem ent. Still, diagram swith an arbitrary num ber of chains contribute to the overall norm alization.

U sing the sim ilarity of our UV renorm alon calculus w th the analysis of usual logarithm ic UV divergences, we have shown that the contributions from UV renorm alons to the large-order behaviour are naturally characterized as insertions of higher-dim ensional operators into $G$ reen functions, a hypothesis originally forw arded by P arisi [ī]. These insertions assum e the form ${ }_{i} E_{i}() G_{O_{i}}(\underline{q} ;)$, where the $E_{i}$ are independent of extemal m om enta and account for factorialdivergence from loop m om entum regions $\underline{\mathrm{k}} \quad \underline{q}$, where all loop $m$ om enta are $m$ uch larger than the extemalm om enta. O $n$ the other hand higherorder corrections in to the $G$ reen function with operator insertion $G_{O_{i}}(\underline{q} ;)$ take into account subleading contributions in $n$ for large $n$ from loop $m$ om entum regions, where at least one of the loop $m$ om enta is of order of the extemalm om enta.
$T$ his system atic organization com es at a price, the introduction of an arti cialexpansion param eter $1=\mathrm{N}_{\mathrm{f}}$. In particular, diagram $\mathrm{s} w$ ith a larger num ber of chains (and thus suppressed in $1=\mathrm{N}_{\mathrm{f}}$ ) are not suppressed for large n , the order of perturbation theory. $Q$ uite to contrary, they are typically enhanced by a factor of $\ln n$ per chain, so that any nite order in the $1=\mathrm{N}_{\mathrm{f}}$-expansion does not provide the correct asym ptotic behaviour in $n$ in the full theory for any $N_{f}$. H ow ever, just as renom alizability of the theory allow $s$ us to go beyond a nite-order expansion in using renom alization group equations, the fact that UV renom alons can be com pensated by counterterm s of higher-dim ensional operators to any order in $1=\mathrm{N}_{\mathrm{f}}$ allows us to transcend a xed-order expansion in $1=\mathrm{N}_{\mathrm{f}}$, using low-order results only. The application of renorm alization group ideas then leads to resum $m$ ation of $\left(\mathrm{ln} n=N_{f}\right)^{k}$-term $s$ and the correct large-n behaviour is found in term $s$
of anom alous dim ensions of dim ension-six operators (see eq. $\left.(\overline{5} \cdot 5)_{1}\right)$ for the photon vacuum polarization). The overall norm alization is determ ined by $m$ atching order by order in $1=N_{f}$. The behaviour of the $1=N_{f}$-expansion for this constant rem ains a problem that can not be addressed w thin this fram ew ork. Because the overall norm alization rem ains undeterm ined for all practical punposes in the realistic situation $\mathbb{N}_{f} \quad 1$ ), a m odi ed QED w ithout UV renorm alons (quite sim ilar to the suggestion of thīj) \{ and therefore potentially B orel sum $m$ able \{ resembles in e ect a non-renorm alizable theory. For each higher-dim ensional operator an unknown constant $\hat{E_{i}}$ has to be introduced. Of course, this is just the statem ent that for all practical punposes Q ED can be considered as an e ective theory below the Landau pole, not w ithstanding its hypothesized triviality'.

O $n$ the technical side, we have som ew hat glossed over the details of two issues. The rst is the calculation of $1=n$-corrections to the leading asym ptotic behaviour. Here one could also use $\mathbb{R}$ rearrangem ent, provided one properly subtracts the non-local term s that arise from subdivergences. This procedure can lead to a non-trivial interplay of analytic and dim ensional regularizations. A sim ilar interplay a ects the second issue of how to im plem ent the correct $\overline{M S}$ subtractions (or any other) im plied to obtain the renorm alized perturbation series in the rst place. In Q ED this issue concems only the overallsubtractions for the photon vacuum polarization. W hile these subtractions do not involve factorial divergence at the level of a single chain, their insertion as counterterm into $m$ ore com plicated diagram $s$ contributes to factorial divergence at the level of $1=n$ corrections to the leading asym ptotic behaviour of diagram $s w$ th two or $m$ ore chains. T hus both issues m ust be considered when com puting $1=n$-corrections, but do not a ect the status of the overall nom alization $K$, which is independent of subtractions up to the trivial factor $e^{c}$.

There exist several obvious extensions of this work. The techniques developed here are applicable w thout m odi cation to the next UV renorm alons ( $u=2 ; 3 ;:::$ ), which are related to operators w ith dim ension larger than six. H ow ever, one has to cope w ith a signi cant increase in complexity, because multiple insertions of dim ension six (and in general, lower-dim ensional) operators contribute and the Borel transform is a multivalued fiunction. W hen applying the form alism the Heavy $Q$ uark $E$ ective $T$ heory (to be precise, an abelian version of it), ow ing to the di erent power-counting for the static quark propagator, one can obtain singularities at half-integer values of $u$. A special feature of this theory is that the selfenergy is linearly UV divergent. If one repeats the analysis of the heavy quark selfenergy [2̄] ] along the lines of Sect. 3, one nds that the term $\mathrm{SN}_{1}^{\mathrm{c}}$ and $\mathrm{N}_{1}^{\mathrm{d}}$, not com puted in $\left.{ }_{2}^{2} \overline{8}_{1}\right]$, add to zero.

A natural extension would include infrared renorm alons. The corresponding poles at negative $u$ can again be classi ed in term s of singularities of analytically regularized integrals, now from regions ofsm all loop $m$ om entum ow through chains. Them odi cations of our form alism arise only from the di erent notions of irreducibility of subgraphs in the infrared and ultraviolet. T hus 1P I (UV-irreducible) subgraphs in Sect. 3.1 should be replaced by $\mathbb{R}$-irreducible subgraphs $\left[\begin{array}{ll}{[2} & 1\end{array}\right]$, (UV) forest by $\mathbb{R}$ forests etc. For the general structure of large-n behaviour associated w ith diagram sw ith m ultiple chains, we expect little di erence from the ultraviolet case. In the language of counterterm $s$ in the Lagrangian, $\mathbb{R}$ renorm alons would be interpreted as non-local operators renorm alons are localin $m$ om entum space (while UV renorm alons are localin coordinate
space).
The ultim ate goal is stilla diagram $m$ atic understanding ofrenorm alons in non-abelian gauge theories, that is QCD. G iven that even in QED with $N_{f} \quad 1$ there is little to say about the overall nom alization of large-order behaviour, there is little to hope that one could obtain $m$ ore than the exponent $b$ in the expected behaviour

A lready this form poses the challenge to understand, on a diagram $m$ atic level, how the contributions from $m$ any diagram $s w i t h m$ any loops combine to produce the rst $\infty$ e cient $\int_{0}^{\text {NA }}$ of the non-abelian -function, which, contrary to QED, is not related to loop-insertions into the ghon propagator. A though the physics described by non-abelian gauge theories changes discontinuously $w$ ith $N_{f}$ for sure, the structure of Feynm an diagram sdoes not, so that wem ay stilltry to approach the question from large $N_{f}$, provided we consider the expansion in $N_{f}$ as form al. W riting $0_{0}^{\text {NA }}=0+{ }_{0}^{\mathrm{NA}}$, where $0_{0}$ denotes the abelian part, the previous equation is expanded as

so that for each chain (de ned as in the abelian theory as ghon propagatorw ith ferm ion loops) we need an additionalenhancem ent of (rather than $\ln n$ ) that com bines exactly to ${ }_{0}^{N A^{n}}$ to all orders in $1=N_{f}$. In QCD, contrary to QED (where these contributions cancl between various diagram s due to the $W$ ard identity), one also has to take into account the possibility of rst inserting a (usual) UV counterterm and then an UV renorm alon counterterm, in addition to the situation discussed at length where one rst inserts a UV renom alon counterterm and then a (usual) UV counterterm, related to renorm alization of a dim ension-six operator. A m ore detailed investigation reveals that the rst contributions combine to produce the term ${ }_{0}^{\text {NA }} \mathrm{n}$ above, while the others are interpreted in term sof dim ension-six operators just as in the abelian theory.

## A. 2 Sectors

The problem of characterizing the singularities in _ can be reduced to resolving singularities of integrands in the representation which is a problem of algebraic geom etry. A natural approach is to locally introduce new variables in which the original com plicated singularities are factorized. In renorm alization theory how ever one applies a sim ple change of variables to achieve this goal. $F$ irst, the integration dom ain in ( $\bar{A}-\overline{2})$ is decom posed into subdom ains that are called sectors. Second, in each sector new (sector) variables are introduced. In these variables the singularities of all the functions involved are factorized so that the problem reduces to power counting in the sector variables.

W e will not dealw ith $\mathbb{R}$ problems so that it is su cient to introduce sectors and sector variables associated $w$ ith 1P I subgraphs and corresponding to $m$ axim algeneralized forests. Let us calla subgraph UV -irreducible if it is either 1P I or consists of a single line which is not a loop line. A set F ofU V -irreducible subgraphs is called a generalized forest if the follow ing conditions hold: (a) for every pair of 1 P I subgraphs ; ${ }^{0} 2 \mathrm{~F}$ one has either 0 , or ${ }^{0}$, or and ${ }^{0}$ are disjoint (w ith respect to the set of vertioes); (b) if ${ }_{1}:::: ;{ }_{j} 2 \mathrm{~F}$ are pairw ise disjoint $w$ ith respect to the set of lines then the subgraph [ $\mathrm{i}_{\mathrm{i}}$ is one-particle-reducible (1PR). G eneralized forests which do not involve single lines are nothing but forests in the com m on sense.
