M utual consideration of b! s and ! e in supersym m etric SO (10) grand uni cation

Abstract

We compare the branching ratios for b! s and ! e in term s of constraining the parameter space in supersymmetric SO (10) grand unication models where supersymmetry is broken softly near the Planck scale by generationally symmetric operators. We observe two general cases. One with small tan = 2 and the other one with large tan having third generation Yukawa coupling unication at the GUT scale.

We show that for small tan the branching ratio constraints allow only a smaller region of parameter space for > 0 compared to < 0 for gluino mass < 500 GeV. With large tan , we not acceptable regions of parameter space with j j < 1 TeV only for < 0. The dominant constraint on large tan with > 0 parameter space is found to be given by the b! s branching ratio, while for large tan with < 0 it is found to be given by the ! e branching ratio. In many of these acceptable regions, we not that the ! e branching ratio is predicted to be within one order of magnitude

of its current experim ental bound. We also show that the usually neglected gluino mediated diagrams in b!s can not be ignored in some regions of parameter space, especially for large tan scenarios when the gluino mass is near its lower experimental bound.

Recently it has been demonstrated [14] that supersymmetric grand unied theories (GUTs) with soft supersymmetry (SUSY) breaking terms which are generated near the Planck scale can predict lepton avor violating processes with highly signi cant rates. Due to the present experimental limits, this is shown to be especially true for ! e . The ! e decay has been studied for both SO (10) and SU (5) grand unication. It is found that SO (10) grand unication [5] predicts the greater rates of the two as a result of its unifying all elds of a particular generation into one multiplet [2]. The decay has been studied for both small [1,2] and large tan [4], and found in both cases to sometimes rule out parameter space and sometimes predict rates only one or two orders of magnitude beneath the current experim ental lim it. In this paper, we exam ine regions of param eter space for which the ! e branching ratio has interesting values by which it could be a signal for supersymm etric grand uni cation, and test to see if those regions are reduced by consideration of the quark avor violating process b! s . It has also recently been shown [6] in the case of small tan SU (5) grand unication that with the present accuracy in the determ ination of the b! s branching ratio, one can not neglect the e ects of running the soft SUSY breaking param eters above the GUT breaking scale and should include the gluino m ediated deacy am plitude when the gluino mass is not particuarly large. This will be found to be true with SO (10) grand unication as well, and especially true for the large tan case where sometimes the gluinomediated amplitude can be even larger than the standard model (SM) amplitude. We will also not that applying the constraints from both decays simultaneously, as must be done, limits available parameter space much more severely than one of the two constraints alone would. We will be primarilly interested in regions for which the magnitude of , the coe cient of the Higgs superpotentail interaction H_1H_2 , is <1TeV, so as to avoid models requiring a netuning of their parameters [7].

The prediction of signi cant rates for lepton avor decay processes and the increased importance of the gluino mediated b! s decay amplitude are the result of the fact that in GUTs the top is unied with other third generation elds which then also feel the radiative exts of the relatively large top Yukawa coupling. If a universal soft supersymmetry break-

ing condition exists at a scale M $_{\rm X}$ > M $_{\rm G}$, then the radiative corrections in the m asses of these third generation elds' soft SUSY breaking scalar m asses are m anifest as $\ln M_X = M_G$ [8] rather than suppressed as powers of $1=M_G$, where M_G is the GUT breaking scale. Renorm alization causes the soft SUSY breaking masses for the elds unied with the top elds to become lighter than the other two generations of those elds, and leads to a suppression of the GIM mechanism in processes mediated by these scalar elds. The degree to which this occurs depends, of course, on the size of the top Yukawa coupling and M $_{
m X}$ i.e. the larger values these have the greater the suppression of the G IM mechanism is. To understand the subtle points of these e ects and how they lead to a substancial enhancement of the ! e branching ratio in the case of SO (10) over the case of SU (5) grand uni cation, one must exam in the avor changing am plitudes in the interaction basis as discussed in detail in Ref. [2]. We will take $M_X = 2.4 16^8$ GeV through out this paper. Above the GUT scale we will use the one loop renormalization group equations (RGEs) as for example appear in Ref. [2], although we use the convention gaugino mass M! M in the RGEs of that reference for the tri-linear scalar soft breaking SUSY term sA_i so as to be consistent with the convention we will use for our s-particle mass matrices [9]. We will take the SO (10) gauge coupling beta function to be b_G = 3 as an ad hoc choice since our calculation is not very sensitive to its value and we do not know the complete eld content of the GUT model. We will also use $_{\rm S}$ (M $_{\rm Z}$) = 0:121 and M $_{\rm G}$ = 2 1th G eV with the M $_{\rm G}$ scale coupling $_{\rm G}$ = 1=23:9. We will calculate the parameter at the tree level.

soft breaking m ass m atrix and the down quark m ass basis is determ ined by the KM m atrix, which diagonalizes $_{\rm D}$ when in the basis where $_{\rm U}$ is diagonal. On the contrary when tan is large, both the top and bottom Yukawa couplings are large and have important e ects in the RGEs. Hence, if one chooses the soft breaking m ass matrices to be diagonal at the scale M $_{\rm X}$ they will no longer be diagonal at the weak scale since both $_{\rm U}$ and $_{\rm D}$ can not be diagonalized simultaneously.

The SM expression for the b! s amplitude has been derived in Refs. [11,12], and the expressions for the additional M SSM amplitudes have been derived in Refs. [10,13,14]. We will use the expressions given in Ref. [10] because those expressions use the squark mass eigenstate basis derived from the full 6 6 mass matrices, as will be discussed below, and automatically incorporates mixing between \right-handed" down squarks and right-handed down quarks as is inevitable with either large tan or SO (10) grand unication. We will include the W-boson, charged Higgs, chargino, and gluino mediated amplitudes, however we will neglect the neutralino mediated amplitude since we not this to be inconsequential in all viable regions of parameter space. The calculation is performed in the basis where p is diagonal at the weak scale. In terms of the mass eigenstates q and current eigenstates q^0 for quarks, we use $d_{L,R} = d_{L,R}^0$ and $u_{L,R} = V u_{L,R}^0 V_R^T$, where V is the KM matrix and V_R is the analogous mixing matrix for the relative right-handed rotation between d and u. In the SM V_R is not of any physical signing ance, however here it will elect the chargino-quark-squark vertex.

Neglecting the amplitude for $b_L \ ! \ s_R$, the leading-order QCD corrected branching ratio B for b ! s is given by

where B (b! ce) = 0:107 is the experimentally determined value, and (b! ce) = $G_F^2 m_B^5 = 192^{-3} \text{ J/}_{cb} \text{ J}^2 \text{ g} (m_c = m_b)$ with g (m_c = m_b) being the phase space factor and m_c = m_b = 0:316. The inclusive width for the b! s is given by

The QCD corrected amplitude c_7 (m $_b$) is given as

with a_i and b_i being given in ref. [15], $= {}_s(M_W) = {}_s(m_b)$, for which we will use = 0.548. The present experimentally accepted range for this branching ratio is $(1-42)-10^4$ [16] at the 95% C.L.. The term s $c_7(M_W)$ and $c_8(M_W)$ are respectively A, the amplitude for b_R ! s_L evaluated at the scale M_W and divided by the b-m assm_b and A_g , the amplitude for b_R ! s_L g also given in Ref. [10] divided by the factor m_b $m_g = m_g$. The elective interactions for b! s and b! sg are given by

In calculating c_7 (M $_W$) and c_8 (M $_W$), we will use the conventional approximation of taking the complete M SSM to be the correct elective eld theory all the way from the scale M $_G$ down to M $_W$, and hence ignore threshold corrections.

We acknow ledge that since we are working with SO (10) grand unication with M $_{\rm X}$ > M $_{\rm G}$, that there will necessarilly be a gluino mediated contribution to b $_{\rm L}$! $s_{\rm R}$, however we not this contribution to not be of much significance in any of the scenarios which we consider. This is dispite the fact that the gluino mediated contribution to b $_{\rm R}$! $s_{\rm L}$ is often in portant. Three major differences exist between these two contributions to the branching ratio. First of all, the the gluino mediated b $_{\rm L}$! $s_{\rm R}$ contribution does not have an interference term with an appreciable SM amplitude or any other appreciable M SSM amplitude. Secondly, even though the g b $_{\rm K}$ $s_{\rm R}$ and the g b $_{\rm L}$ $s_{\rm L}$ vertexes have the same mixing angles at the GUT scale due to the symmetric nature of the 10-dimensional Higgs, the \righthermoreal numbers and this one can observe the case of small tan , where the g b $_{\rm K}$ $s_{\rm R}$ vertex's mixing angle is given by $y_{\rm ts}$ M $_{\rm G}$) j 0.03 since right-handed quark mixing angles $v_{\rm ts}$ essentially do not run in the M SSM:

as can be summ ised from Ref. [17], while the g b_L s_L vertex's m ixing angle is given by $\dot{y}_{ts} (M_W) \dot{j} > \dot{y}_{ts} (M_G) \dot{j}$. In fact for small tan if one uses 1 $V_{tb} V_{tb} = 0$, the ratio of the two gluino mediated amplitudes may be estimated as follows:

where the functions G_2 ($x_1; x_2;$) are given in Ref. [2] and used for the case of gluino mediated decay in Ref. [6]. Thirdly, even though b_R^c and b_L^c have the same mass terms at the GUT scale, this is not true at the weak scale. With low tan b_L^c sm ass is driven lower than that of b_R^c . A lithough the opposite is true for large tan b_L^c , there the mixing angle for b_L^c b_R^c is further suppressed, due in part to the nature of the boundary condition at b_L^c b_L^c

U sing notation analogous to that used for b! s in Ref. [10], we now give the expressions we use to calculate the ! e branching ratio. ! e has the following e ective Lagrangian:

where we have included helicities. A_1 and A_2 are given by

where the convention $x_{ab} = m_a^2 = m_b^2$ has been adopted and M_{T_k} are the slepton mass eigenstates. The functions F_2 (x) and F_4 (x) are given in Ref. [10] and

where \hat{Y}_1 diag ($_e$; ;) = (g^0), Z is the 4 4 neutralino m ixing matrix on the F; W_3 ; H_1^{0} ; H_2^{0} basis, the fact the 4 4 neutralino mass matrix can have negative eigenvalues must be taken into account [19], and $T_{L,R} = \int_{L,R}^{y} T_{L} As$ explained in Ref. [10], the terms proportional to the function F_2 are small compared to the terms proportional to F_4 in SO (10) grand unication. For small tan , the terms proportional to F_2 provide about a 5-percent correction to the branching ratio. As one would expect, when tan is large we now the difference between the branching ratios predicted for the two possible signs of . The Higgsino-gaugino mediated terms are also found to provide a small correction, about 5-percent, when tan is large. The width is then given by:

The experimental upper limit on the ! e branching ratio is 4:9 10^{1} at the 90 % C L . [18].

The 6 d slepton or squark mass matrix can be written in the 3 d forms having the submatrices M $_{\rm LL}$,M $_{\rm LR}$ and M $_{\rm RR}^2$ as follows:

At a scale M $_{\rm X}^{2}$ near the P lanck scale, the 3 $\,$ 3 blocks acquire the form :

where we have taken the M $_{\rm X}$ scale tri-linear soft SUSY breaking scalar coupling A $^{0}=0$. For simplicity, we will take A $^{0}=0$ in all of the cases that we consider. These 3 3 m ass matrices m ust be run down to the weak scale where one m ust add the mass terms that arise from weak scale gauge symmetry breaking including the weak scale D terms. The weak scale soft SUSY breaking 3 3 m ass matrices may be expressed in terms of the universal soft breaking parameters. Hence, the weak scale 3 3 m atrices may be written as:

where M $_{10}$ is the gaugino mass at the M $_{\rm G}$ scale and the dimensionless coe cients are determined by the numerical solutions of the RGEs [10]. We can write the up and the down squark sectors in the same 6 6 m atrix form with the 3 3 blocks looking like those shown above.

Since we are working with the SO (10) uni cation group, the above equations for the low energy m ass matrices m ay be modified by additional D-terms which are generated at the GUT breaking scale M $_{\rm G}$. A D-term contribution may appear when the rank of the group is reduced due to the gauge symmetry breaking [20{22}]. In the case of SO (10) breaking to the SM gauge group, the rank is reduced by one and the broken generators constitute a U (1) subgroup. In this case, the D term contribution can be described by one additional by parameter, which we will refer to as m $_{\rm D}^2$. The scalar masses get modified [4] at the uni cation scale as follows:

These additional terms lead to an additional term proportional to m $_{\rm D}^{2}$ in the expansion of 3 squark or slepton m ass m atrices M $_{\rm L}$ M $_{\rm L}^{\rm Y}$ or M $_{\rm R}^{\rm Y}$ M $_{\rm R}$ at the low scale. One must rem em ber that when X $_{\rm Y}$ $^{\rm P}$ $_{\rm i}$ Y $_{\rm i}$ m $_{\rm i}$ $^{\rm 2}$ $\stackrel{\rm 6}{\bullet}$ 0 at the M $_{\rm G}$ scale one m ust add an additional term to the soft breaking scalar mass RGEs which scales in a simple fashion (see Ref. [4]). In SO (10) m odels, X $_{\rm Y}$ (M $_{\rm G}$) = M $_{\rm H_{\,2}}^{\,2}$ (M $_{\rm G}$) - M $_{\rm H_{\,1}}^{\,2}$ (M $_{\rm G}$).

In large tan scenerios due to the e ect of the bottom Yukawa coupling now being large as well as the top Yukawa coupling, it is very dicult to make (m $_{\rm H_{\,2}}^2$ + 2) negative so as to break the electroweak sym m etry and yet keep the pseudoscalar m ass-squared m $_{\rm A}^{2}$ = m $_{\rm H~{\scriptscriptstyle 1}}^2$ + m $_{\rm H~{\scriptscriptstyle 2}}^2$ + 2 2 positive, however the introduction of the additional GUT scale D -term s can solve that problem. The requirement to keep the psuedoscalarm ass-squared positive gives a lower bound on the possible size of m_D^2 for a choice of all of the other parameters. An upper bound is in posed on m $_{\text{D}}^{2}\,$ through the requirem ent that all of the down squark and slepton m ass eigenstates remain positive. For small tan since only the top Yukawa coupling is large, we do not have the above mentioned problem. In this case, the lower bound on m_D^2 is 0. For sim plicity and because the presence of a nonzero m $_{\rm D}^2$ raises the value of j j we will take $m_D^2 = 0$ for tan = 2, but we will invoke the parameter in the full allowed range for large tan .

In the high tan cases, we assume the complete unication of the third generation Yukawa couplings. This means that both MSSM Higgs doublets come from the same 10dim ensional representation Higgs eld. This would seem to indicate that all of the Yukawa

coupling m atrices are identical at the GUT scale, which can not produce a realistic ferm ion m ass spectrum and quark m ixing parameters at the low scale. However if one assumes that only the (3;3) entries of the Yukawa matrices are direct couplings to the low mass Higgs eld and the other couplings arise from non-renormalizable operators involving super heavy elds, then it is possible. Maximally predictive Yukawa textures have been developed for this case which use only four operators are as follows [23]:

where $x_i; y_i; z_i$ and $x_i; y_i; z_i$ are C lebsch factors. To determ ine the fourm agnitudes, the phase, and tan , one should use the six best determ ined low energy parameters as discussed in Ref. [23]. From this reference, we choose to use for our example the ansatz which is its M odel 6, which appears to give the most comfortable to the low energy data amongst its models. With that ansatz we will look at two scenarios corresponding to two different values of A $_{\rm t}$ (M $_{\rm G}$). In the rist example, case (i), A = 1 and tan = 57:15 and this gives us the pole mass m $_{\rm t}$ = 182 G eV and the running mass m $_{\rm b}$ = 4:43 G eV. In the second example, case (ii), A = 1:18 and tan = 58:86 and this gives us the pole mass m $_{\rm t}$ = 184 G eV and the running mass m $_{\rm b}$ = 4:35 G eV. In running the single third generation Yukawa coupling A and soft SUSY breaking parameters between M $_{\rm X}$ and M $_{\rm G}$, we make the simplifying assumption that $_{\rm t}$ is the only large Yukawa coupling in the GUT scale model, and that hence the soft breaking matrices remain diagonal as one runs them down from M $_{\rm X}$ to M $_{\rm G}$.

We also assume for low tan that $_{\rm t}$ is the only large tri-linear coupling in the GUT scale superpotential, and at the scale M $_{\rm G}$ we take $_{\rm U}$ and the scalar matrices to be diagonal, and take $_{\rm D}$ = $_{\rm E}$ = V $_{\rm D}$ diag V $_{\rm V}$ with all parameters evaluated at M $_{\rm G}$. We also always take the tri-linear soft breaking parameter matrices A $_{\rm U,D,E}$ (M $_{\rm G}$) to be diagonal, and take the tri-linear couplings to be given by the symmetric combination fA $_{\rm U,D,E}$; $_{\rm U,D,E}$ g=2 at M $_{\rm G}$. (See Ref. [2]) In the low tan scenario as well as in both of the large tan examples, our KM matrix is typically described by the following four parameters: $y_{\rm Us}j=0.22$, $y_{\rm cb}j=0.44$,

 $y_{ub}=V_{cb}j=0.7$, and the Jarlskog CP violation parameter 2.8 10^5 . This provides the ratio, $y_{ts}V_{tb}=V_{cb}j^2=0.96$, relevant to the b! s branching ratio.

Now beginning with low tan = 2, we will discuss the results. We use $_{\rm t}$ (M $_{\rm G}$) = 125, which gives the top quark the pole mass m $_{\rm t}$ = 176 GeV. We forego the M $_{\rm G}$ scale constraint m $_{\rm b}$ = m and give the b-quark a $\overline{\rm MS}$ running mass of 4:35 GeV. We display the ! e rate as \log_{10} (B =4:9 $_{\rm H}$ 0). We plot both branching ratios as functions of the M $_{\rm K}$ scale parameter m $_{\rm O}$ for xed values of the M $_{\rm G}$ scale gaugino mass M $_{\rm H}$ 0, and also as a function of M $_{\rm H}$ 0 for xed values of m $_{\rm O}$, in the Figs 1 and 2. The signi gance of M $_{\rm H}$ 0 for the weak scale gaugino masses is that the gaugino mass M $_{\rm H}$ 1 = $_{\rm H}$ 10 = $_{\rm G}$. As for the other parameter, the universal soft SUSY breaking scalar mass m $_{\rm O}$ is close to the low scale \right-handed" selectron mass, and diers from it only by the renormalization excits of GUT scale gaugino loops and bino loops below the GUT scale.

For negative values of (Fig.1), ! e (Figs 1b and 1e) rules out the smaller values of the gaugino m asses although they are allowed by the b! s branching ratio (Figs 1a, 1d). For any value of m $_0$, M $_{10}$ needs to be around 100 GeV for the allowed regions. Also large values of gaugino m asses and m $_0$ tend to increase the amount of ne-tuning needed in the model, and invite larger values of j j. We note that, roughly j j' 500 GeV when M $_{10}$ is '240 GeV. We also plot, r_{A_g} j $A_g = A_{SM}$ j the absolute value of the ratio of the gluino mediated contribution to the b_R ! s_L amplitude to the SM amplitude, and nd that in the regions allowed by both decays it could be as large as 10%. For example when m $_0$ = 700 GeV and M $_{10}$ = 130 GeV, the ratio is about 0.09. One also observes that, in the ! e plot there are two allowed regions of m $_0$ for each value of M $_{10}$. For example when M $_{10}$ = 225 GeV, we nd that values of m $_0$ between 0-200 GeV as well as values greater than 600 GeV are allowed.

For positive values of , the lower values of the gaugino m asses are disfavored by the b! s branching ratio (Figs 2a, 2d). The branching ratio reduces to m ore acceptable values at higher values of gaugino and scalar m asses. For values of j j < 800 G eV, one also nds that the gluino diagram is never found to contribute m ore than 13% than that of the SM

am plitude. The ! e branching ratio plots (Figs 2b. and 2e) have two regions of allowed m₀ values for a particular value of M₁₀. For example when M₁₀=150 GeV, we not that values of m₀ between 0-160 GeV and also values greater than 450 GeV are allowed.

Now we look at the results for the two previously mentioned high tan cases: case (i) with A = 1, and case (ii) with A = 1.18. For neither case do we not parameter space with acceptable values of the b! s rate for positive < 1 TeV. In fact, roughly be at least 1300 GeV to nd an acceptable rate. For this reason, we only show plots for the cases with negative values of , where we nd the predom inant constraint to com e from ! e rate. When tan is large, the values obtained for the ! e branching ratio $A_{g}=A_{SM}$ jas a function of j jwhen > 0 are virtually identical to those obtained < 0. The plots we show are parametric plots with the parameter m $_{\text{D}}^{2}$ varying over its allowed range. As previously stated, we have chosen to use M odel 6 of Ref. [23]. If we had chosen a dierent model of the type given in that reference, the amount of leptonic avor violation would di er in a predictable way, as discussed in Ref. [4]. In particular, the ! e branching ratio is found to be proportional to $(x_n = 3)^2$, where $x_n = (x_n = 3)^2$ $x_e = (x_d x_u)$. In M odel 6, $(x_u)^2 = 0.36$, however in all nine m odels the factor ranges from 0.1 to 10. Hence, in our plots of \log_{10} (B R (! e)=4:9 10^{1}) although the value of this function being 0 corresponds to the experim ental lim it in the model we use, for all nine models the experimental limit on our plots could correspond to values as low as 0:56 or as high as 1:44.

In Fig. 3a we plot the b! s branching ratio as a function of with m_0 = 1000 GeV for case (i) . The curves are for di erent values of M $_{10}$. In Fig 3b, one notes that values of M $_{10}$ greater than 145 GeV are disfavored by ! e rate though they are allowed by the b! s rate. To not the interesting regions for the signal of ! e , we need to look for the part of the curve which projects on the same space as that done by the b! s curve having the same value of M $_{10}$ and where the ! e branching ratio is within a order of m agnitude beneath the experimental value. To illustrate the gluino contribution we also plot r_{A_g} as a function of for di erent values of the gaugino masses in Fig. 3c. In the

regions allowed by the both the decay processes the gluino diagram amplitude is found to be same or sometimes larger than the SM amplitude. In fact in the interesting regions, the gluino diagram contribution can be as much four times greater than that of the SM diagram.

For case (ii) we need to raise m₀ to about 2200 GeV in order to nd any appreciable regions allowed by the ! e branching ratio. For this example, in the intersesting region allowed by both decays we have that lies between about -136 and -250 GeV as shown in gs 4a and 4b. The gluino diagram contribution (Fig. 4c) is as high as only 8 percent of the SM contribution in this region. The requirement of large gaugino mass for the existence of this parameter space is the cause for a relatively small gluino contribution.

We now summarize the constraints on the parameter space given by considering both decays silm utaneously. For small tan with < 0 one nds that, a large range of gaugino masses for any value of scalar mass is allowed by b! s branching ratio, but the ! e rate is found in general to be more restrictive on the lighter gaugino masses. In the case of > 0 with small tan , it is the b! s branching ratio which provides the more stringent constraint and in general forbids M_{10} to be less than about 180 GeV. For large tan with < 0, b! s allows a larger range of gaugino masses than ! e does, which tends to rule out larger values of j j. On the other hand for large tan with > 0, b! s rules out all the parameter space that has < 1 TeV.

In this letter, we have given rst complete calculation of b! s branching ratio in SO (10) grand unication with avoruniform soft SUSY breaking terms introduced at the reduced P lanck scale, although with this boundary condition the branching ratio for b! s has been calculated for SU (5) grand unication with low tan in the literature [6]. We have performed the calcualtion for both large tan with $_{\rm t}=_{\rm b}$ at the grand unication scale and for low tan = 2. For the purpose of comparison with the constraints provided by muon avor violation, we have also plotted the ! e rate over exactly the same parameter space. As discussed previously in our third and fourth paragraphs and unlike previous SO (10) calculations from the reduced P lanck scale, our calculations use the complete 6 6 squark and slepton mass matrices and include all avor mixing e ects induced through the

one-loop RGEs by the MSSM yukawa coupings, which are important for the large tan calculation since $t = t_0 = t_0$ at the grand unication scale.

In conclusion, if one is to calculate the decay rate for the avor changing processes in a SUSY GUT with SUSY breaking communicated by gravity above the GUT breaking scale in the form of soft breaking mass terms, it is essential to include the GUT scale renormalization group e ects. The mutual consideration of experimental limits on hadronic and leptonic avor violating decays can give strong constraints on parameter space, and gives some preference to negative values of . One then not there are some regions of parameter space which are allowed by both the b! s and the ! e decay rates, and where it may soon be possible to search for the signal for new physics in the form of ! e .












 $m_0 = 1000 \text{ GeV}$


