# Searching for $B_c$ m esons in the ATLAS experiment at LHC

We discuss the feasibility of the observation of the signal from  $B_c$  mesons in the ATLAS experiment at the LHC. In particular, we address the decay mode  $B_c$ ! J= followed by the leptonic decay J= ! + , which should perm it an accurate measurement of the  $B_c$  mass. We performed a M onte Carlo study of the signal and background concluding that a precision of 1 M eV for the  $B_c$  mass could be achieved after one year of running at \low " lum inosity. The sem ileptonic decay  $B_c$ ! J= is also considered for a possible extraction of  $J_{cb}j$ .

#### 1. Introduction

There is a general consensus in the scientic c community [1] that the scope of a future highlum inosity, high-energy hadron collider like LHC should not be restricted to the hunting of the standard m odel H iggs and its extensions, or the search for supersymmetry. O ther topics requiring lower lum inosities like top and beauty physics deserve in their own right a close attention.

In particular, a lot of work has been recently devoted to the observation of the  $B_c$  m eson regarding both the hadroproduction [2] and decay [3] [4] (see references therein). Speci cally, we shall focus on the feasibility of its detection in the ATLAS experiment at the LHC through some decay modes.

2. B<sub>c</sub> signal

At the center-ofm assenergy  $p \overline{s} = 14 \text{ TeV}$ , the cross-section for beauty production is assumed to be 500 b leading to 5  $10^{12}$  bb pairs per yearrun ( $10^7$  s) at a lum inosity of L  $10^{33}$  cm  $^2$  s<sup>1</sup>, corresponding to an integrated lum inosity of 10 fb<sup>1</sup>. The num ber of bottom pairs reduces, how ever, to 2:3  $10^{10}$  by requiring events with a triggering m uon coming from either a b or a b under the kinem atic cuts  $p_2 > 6 \text{ GeV}/\text{c}$  and j j< 2:2 [5].

O n the other hand, assuming that the b-quark fragmentation yields a B<sub>c</sub> or a B<sub>c</sub> with probability of the order of 10<sup>-3</sup> [2], the yield of B<sub>c</sub> m esons (not yet triggered) per year of running would be rough  $\frac{1}{2}$  '  $10^{10}$ .

#### B<sub>c</sub> ! J= channel

This exclusive channel followed by the leptonic decay of the J= resonance into a pair of oppositely charged muons o ers several in portant ad-

vantages. F irst of all, it allow s for the m ass reconstruction of the B  $_{\rm c}$  m eson. Observe also that anyone of the two m uons can trigger the decay. Besides, it is very clean topologically with a common secondary vertex for all three charged particles, two of them (the m uons) with the additional constraint of their invariant m ass compatible with a J= . Furtherm ore, the expected branching fraction is not too small, about 0.2% [6], which combined with the branching fraction of the leptonic decay of the resonance BR (J= ! + )' 6% [7], yields an overall branching fraction for the signal of 10<sup>4</sup>. Thus, the number of such events turns out to be ' 10<sup>6</sup> per year of running.

A study has been performed in order to estimate the signal detection e ciency and background for the B<sub>c</sub> ! J= (! <sup>+</sup> ) channel. The M onte C arlo employed for the signal sim – ulation corresponds to a sample of B<sub>c</sub> ! J= events while for the background we have used a sample of inclusive b m uon decays generated in all the cases with PYTHIA 5.7.

Two types of background were considered:<sup>3</sup>

- a) C om binatorial background due to muons from sem ileptonic decays of bb pairs produced at the main interaction. C ascade contributions such as b! c! are included as well for random com binations with any other muon in the same event.
- b) C ontam ination from prom pt J= 's in com bination with another charged hadron (interpreted as a pion) from the main vertex. (In fact data released by Tevatron on the J= yield point out a production rate quite larger than initially expected [9].) Incorrect tracking may give rise to the reconstruction of a (fake) secondary vertex, becom ing a potential source of a large am ount of background.

In a rst step, we imposed the following cuts on events based on kinematic constraints:  $p_{m in} (trig:) = 6 \text{ GeV}/c ;$   $j_{m ax} (trig:) \neq 2.2$   $p_{m in} () = 3 \text{ GeV}/c ; j_{m ax} () \neq 2.5$   $p_{m in} () = 1 \text{ GeV}/c ; j_{m ax} () \neq 2.5$   $M_{+} = M_{J=} = 50 \text{ MeV}$ 

The two rst cuts correspond to the requirement of the 1st-level B physics trigger leading in our case to an e ciency of 15% in triggering one of the two muons from the J=. We next take into account the detection e ciency for the signalafter applying the rest of  $p_{?}$  and cuts which turns out to be 21%. Setting the e ciency for muon identication as 80% and the track reconstruction as 95% [5] we get a combined detection e ciency of 2% leading to an observable signal of about 20;000 events per year of running.

The last of the cuts described above constrains the two muons invariant mass to be compatible (within two standard deviations [5]) with the nom inal J= mass, thus drastically reducing random combinations. However, background of class b) can potentially pass all the kinem atic cuts by a large am ount, so another type of rejection is required.

To this end, we adapted to our needs the vertex reconstruction (i.e. vertex nding and tting) routines of the LEP experiment DELPHI at CERN [10]. The vertex tting algorithm provides as output the coordinates of the secondary vertex, the track m om enta re-evaluated with the vertex constraint and the goodness of the t by m eans of the total<sup>2</sup> as well as the contribution of each single track to it. In particular, we employed for background rejection the three spatial coordinates and the <sup>2</sup> for each tted secondary vertex form ed by the twom uons and the charged hadron (assumed to be a pion) satisfying the above kinematic constraints. The distance between the reconstructed vertex and the prim ary (pp) interaction point was thereby determ ined. W e shall refer to it as the decay length even for background events of class b).

Hence, candidate (either signal or background)

events were required to pass the following extra cuts:

where  ${}^2_0$ , L<sub>0</sub> have to be optimized to remove the background as much as possible but with a good acceptance for the signal. In our analysis we found  ${}^2_0$  = 8 and L<sub>0</sub> = 350 m.




Figure 1. Reconstructed  $( \ ^+ \ )_{J=}$  mass distribution after cuts. The nom inal value for the B<sub>c</sub> mass was set equal to 6.3 G eV. The solid line corresponds to a linear+G aussian t

Figure 1 shows the reconstructed  $( ^{+} )_{J=}$  m ass distribution for the expected signal above the surviving background once all the cuts have been applied, for an integrated lum inosity of 10 fb<sup>1</sup> [3].

In summary, we have found that the selftriggering weak decay B<sub>c</sub>! J= , followed by the leptonic decay of the J= into two muons, could be clearly observed in the ATLAS detector at LHC. Under rather conservative assumptions, a total num ber of 10;000 signal events could be fully reconstructed after one year run, corresponding to 10 fb  $^1\,$  at \low " lum inosity (  $\,10^{33}$ cm  $^2$  s  $^1$  ). This represents a signal to background ratio of about 0:5 with a statistical signi cance of 20 standard deviations above a nearby almost at background. The foreseen mass resolution (standard deviation) of the B<sub>c</sub> meson is about 40 M eV representing a precision of about 1 M eV for the m ass m easurem ent.

### $B_c ! J = +$ channel

In spite of the fact that this channel does not perm it the m easurem ent of the B<sub>c</sub> m ass, its signature would be quite clean experim entally when the J= decays into a pair of m uons, providing a three m uon vertex. In the following we shall argue that in LHC experiments this decay m ode could provide a reliable extraction of the m ixing m atrix element  $\mathbf{j}_{cb}\mathbf{j}$ .

The expected semileptonic branching ratio '2% [6] together with the leptonic branching ratio for the J= into two muons '6% [7], yields an overall branching fraction of order 10<sup>3</sup>. We

next combine the last BF with the acceptance of the muon trigger' 15% (where the three possible triggering muons per decay have been taken into account.) Besides, the detection of the two remaining particles (i.e. the non-triggering muons satisfying some  $p_2$  and cuts [B]) amounts to an acceptance for signal events of '12%. Finally, we assume an identication e ciency for each muon of 0.8 [5] yielding a combined value of  $0.8^3$ ' 0.5.

Thereby, the expected number of usefulB  $_{\rm c}$  decays  $^4$  could reach several 10  $^5$  per year at low lum inosity.

Such large statistics together with the foreseen precision in the muon momentum measurement [5] should perm it the experimental access to the kinematic region near zero-recoil of charm onium (with respect to the  $B_c$  meson) with a good energy/momentum resolution. Moreover, very stringent cuts can be put on events and hence, expectedly, background could be almost entirely rem oved from the event sample permitting a very

precise determ ination of the B  $_{\rm c}$  lifetime. We explore all these issues in the following section.

## Theory inputs and determ ination of $y_{cb}j$

Next we exam ine in detail the possibility of extracting  $\mathbf{j}'_{cb}\mathbf{j}$  from experimental data. Let us start by recalling that

The di erential branching ratio dB r=dw can be written as

where dN =dw represents the number of sem ileptonic decays per unit of w for a certain integrated lum inosity, once corrected by detection e ciency; N ( $B_c$ ) is the corresponding total yield of  $B_c$ 's produced for such integrated lum inosity. (Notice that could be determined accurately from the sam e collected sam ple of sem ileptonic  $B_c$  decays.)

In order to get N (B  $_{\rm C})$  it will be convenient to compare the B  $_{\rm C}$  production rate to the prompt

where N (  $^{0}$ ! <sup>+</sup> ) stands for the number of prompt  $^{0}$  to be experimentally detected through the muonic decay mode and  $^{\circ}$  denotes its detection e ciency. Contamination from weak decays of B mesons into  $^{0}$  states should be e ciently removed by means of the vertex capability of the inner detector.

Therefore, we suggest norm alizing the  $B_c \operatorname{sam} - p \operatorname{le} w$  ith the aid of the <sup>0</sup> yield through expression

(3). The <sup>0</sup> state is probably preferable to the J= mainly because the form enexpectedly should not be fed down by higher charm online states <sup>5</sup>. Instead, data released by Tevatron shows that the J= indirect production through  $_{\rm c}$  intermediate states may be also in portant. Let us also remark that the production of the <sup>0</sup> resonance in  $p\overline{p}$  collisions is more than one order of magnitude larger than initially expected [13] [9].

At su ciently large  $p_2^{6}$ , one reasonably expects that them ain contribution to heavy quarkonia production comes from the splitting of a heavy quark or a gluon. Indeed, even though the fragmentation process is of higher order in s than the \conventional" leading order diagram s [14], the form er is enhanced by powers of  $p_2 = m_0$  relative to the latter [2] [15]. A lthough the situation is still controversial in the literature, there are strong indications from very detailed calculations (see [16] [17] and references therein) that fragm entation indeed dom inates for large enough p? . In the following, we rst exam ine some color-singlet mechanisms, expected to contribute largely to the high-p? inclusive production of prompt heavy quarkonia.

On the other hand, according to the set of papers in [2], perturbative QCD can provide a reliable calculation for the fragm entation function of a high-p? parton into  $B_c$  states with only few input parameters: the QCD running constant s, the charm and bottom masses, and the square of the radial wave function at the origin  $\Re(0)^2_1$ . Note that the largest uncertainty for normalization purposes comes from the (third power of the) charm mass in the fragm entation function (see [2] for explicit expressions). However, we are only interested in the ratio

where each cross section can be written as a convolution of the parton distribution functions of the colliding protons, the cross section for the hard subprocess leading to the fragm enting gluon or heavy quark and the respective fragm entation function [2]. Thus notice that the fragm entation functions  $D_{\overline{b}! B_c}$ ,  $D_{g! B_c}$  and  $D_{c!} \circ, D_{g!} \circ [18]$ , which them selves are independent of the partonlevel subprocesses, appear combined as a ratio. Therefore, those uncertainties coming from the common overall factor  $m_c^3$  automatically cancel each other. Moreover, those uncertainties introduced by the parton distribution functions also should signi cantly diminish in r as well. Still one must evaluate the ratio

In fact there is the possibility of expressing the above ratio (aside trivial factors) according to the general factorization analysis of [19] in a more rigorous way as

where  $O_n^X$  are local four ferm ion operators<sup>7</sup> and the matrix elements can be evaluated from NRQCD.A sim ilar expression holds for the B<sub>c</sub>. (M oreover, the denom inator can be determ ined from the measured leptonic width of the <sup>0</sup>.)

Recently, an additional color-octet fragmentation mechanism [20] has been suggested in order to reconcile the experimental results on inclusive <sup>0</sup> production with theoretical predictions. This mechanism assumes the creation from gluon fragmentation of a  $\overline{cc}$  pair in a color-octet state, in analogy to <sub>c</sub> production [13]. Then a new nonperturbative parameter H  $^0_{8(0)}$  is required, appearing in r combined as the dimensionless factor

where we remark that it can be computed in term s of NRQCD matrix elements [19]<sup>8</sup>.

Furtherm ore, if we do not neglect the contribution to the total  $B_c$  production of those orbital excitations like P -w ave states, new fragm entation functions  $D_{\overline{b}! \ \overline{b}c(P)}$  com e into play [23]. A coordingly, som e new i factors will appear which can be conveniently expressed, for instance in analogy to Eqs. (6) and (7), as:

where  $\mathfrak{m}$  is the reduced m assofthe b and c quarks. The long-distance H  $_1$  parameter [22] is related to the square of the derivative of the color-singlet wave function at the origin.

Higher  $B_c$  resonances like D-wave states might be further taken into account, introducing new nonperturbative parameters involving higher derivatives of the wave function at the origin, or the NRQCD matrix element analogues.

In sum, the evaluation of such  $_{\rm i}$  parameters would allow one to complete the computation of the ratio r and thereby to obtain from the experimental measurement of the  $^{0}$  yield, the total number of B<sub>c</sub> events for an integrated lum inosity with the aid of expression (3).

On the other hand, the hadronic transition  $B_c! J=$  involves two heavy-heavy systems whereby heavy quark spin symmetry should be still valid as a rst order approach [4] [25]. This

perm its the introduction of the analogue of the Isgur-W ise function for transitions involving doubly heavy hadrons, denoted by  $_{12}$  (v<sub>1</sub> y). At the non-recoil point v<sub>1</sub> = v<sub>2</sub>, we shall write

where  $A = \overline{c}_{5}b$  stands for the axial-vector current and " $_2$  represents the four-vector polarization of the J= .

Following similar steps as in the B decay into D [26], we write

It is ofkey in portance from the theoretical side in our proposal, the existence of a single form factor in the above expression to be determ ined theoretically in a rigorous manner. Note that  $_{12}$  (1) may be interpreted in rst approximation as the overlap of the initial and nalhadron wave functions [4] [24]. Moreover, due to the intrinsic nonrelativistic nature of its heavy constituents, nonrelativistic QCD on the lattice or even re ned potential based models of hadrons, could be applied in order to get  $_{12}$  and its slope at zero recoil in a reliable way.

This fact in conjunction with the presum ed accuracy of the J= m om entum m easurement suggests determining  $\mathbf{j}_{cb}\mathbf{j}$  in a similar way as in the m ethod proposed by N eubert [27] through the  $\overline{B}$ ! D  $\sim$  decay.

For the purpose of illustration, we have depicted in gure 2 some expected typical points and error bars for the decay  $B_c! J= (! + ) + for a de nite prediction of the ratio of production cross sections r in Eq.(4).$ 

Under this condition, let us remark that the uncertainty on w (i.e the horizontal error bars) is of system atic nature, mainly coming from the  $B_c$  ight-path reconstruction. W ith regard to the vertical coordinate  $_{12}$  (w)  $j_c$  j we have assumed that its uncertainty is essentially statistical [3].




Figure 2. Hypothetical  $_{12}$  (w)  $\frac{1}{2}$  jdistributions of the decay  $B_c! J = + for a 500$  events sam ple tentatively assigned to an integrated lum inosity of 20 fb<sup>1</sup> (i.e. two years of running at low lum inosity). It was assumed an spatial resolution for the B<sub>c</sub> ight-path reconstruction of 100 m and its lifetime is allowed to vary in the interval = 0:5 1 ps. Horizontal bars show system atic errors basically lim iting the number of experim ental points. Vertical bars take into account the statistical uctuations of the sam pled events in the bin (distributed according to the expected di erential rate for a pseudoscalar to vector sem ileptonic decay [26]). Points line up with <sup>0</sup><sub>12</sub> set equal to 2. Form ore details see R ef. [28]

It is in portant to stress that the quantity to be experimentally measured with a large accuracy from  $B_c! J = + decays$  can be written as the linear combination:

In sum mary, we suggest to keep an open mind on the possibility of an alternative determ ination of  $\psi_{cb}$  from sem ileptonic decays of B<sub>c</sub> m esons at LHC. Even if at the time LHC will start to run, B factories would have already provided a (still) m ore precise value of  $V_{cb}$  jthan at present via the sem ileptonic B decay, an independent determ ination of it should bring a valuable cross-check. On the other hand, a lot of activity is being devoted to the analysis of inclusive production of prompt charmonium resonances at Fermilab. Therefore we conclude that if the fragmentation approach to describe the production of heavy quarkonia at the large transverse m om entum dom ain is accurately tested (and tuned) from experim entaldata, B<sub>c</sub> sem ileptonic decays could be competitive with the B ones.

A lternatively, one can turn the question round and consider  $\mathbf{\dot{y}}_{cb}$  jas a well-known param eter thus verifying QCD calculations, either at the production or at the weak decay level. Indeed, fragmentation into heavy quarkonia o ers an interesting check of perturbative QCD and a deep insight into the nonperturbative dynamics in the hadronic formation. Besides, a precise know ledge of the B<sub>c</sub> production rate is a necessary condition for the experimental measurement of the absolute branching fraction of any of its decay modes.
