LIM ITS ON NON STANDARD TOP QUARK COUPLINGS FROM ELECTROW EAK MEASUREMENTS

A bstract

We calculate the typical size of loop corrections to electroweak observables arising from non-standard Z $\overline{t}t$ and W to vertices. We use an electroweak Lagrangian form alism based on the electroweak gauge group SU (2)_L U (1)_Y ! U (1)_EM . Limits on the non-standard model top quark couplings from electroweak observables are presented and compared with previously obtained limits.

1 Introduction

The large mass of the recently discovered top quark suggests that the top quark is fundamentally dierent from the velighter quarks. A number of models have been proposed in which the interactions of the top quark are responsible for the SU $(2)_L$ U $(1)_Y$ electroweak symmetry breaking [1,2]. In this note, we make a model-independent study of the limits on the couplings of the third generation quarks to gauge bosons which can be inferred from the LEP and SLC data.

Precision electroweak measurements at LEP and SLC of erawindow into the Ztt and W to couplings since these couplings appear in loop corrections to the Z decay widths. Rare B and K decays such as b! so can also probe the W to coupling β , while in the future, the W to coupling can perhaps be measured to an accuracy of around 30% at the Tevatron through single top production [4].

As has been emphasized recently [5], the determination of $_{\rm S}$ (M $_{\rm Z}$) at LEP is somewhat higher than that obtained from low energy measurements such as deep inelastic scattering. The existence of new non-standard model physics will a ect the extraction of $_{\rm S}$ at the Z pole and in many cases will lower it to be in agreement with the low energy data [6,7].

We consider a picture in which the new physics responsible for the electroweak symmetry breaking is at some high scale, > 4 v - 3 TeV. In this case, the physics at low energy can be written in terms of an electrive Lagrangian describing the interactions of the SU $(2)_L$ U $(1)_Y$ gauge elds with the Goldstone bosons which become the longitudinal components of the W and Z gauge bosons. It is straightforward to incorporate fermions into this picture [4, 8, 9]. We will not concern ourselves with the source of the new physics (it could be supersymmetry, technicolor, top color, or something else entirely. The only important point is that the new physics occurs at a high scale, so that an expansion in powers of M $_Z^2$ is appropriate.

2 E ective Lagrangian

In this note, we assume that whatever is responsible for generating the non-standard model top quark couplings occurs at a high scale (perhaps $3\,\mathrm{T\,eV}$) and so the use of a non-linear electrow eak sector of the theory at low energy. We will assume that only the top quark couplings are non-standard; the case of non-standard b-quark couplings to the Z has been examined by many authors [11]. If we consider the gauge group SU (2)_L U (1)_Y broken to U (1)_{EM}, then there are 3 Goldstone bosons, $!_i$, which eventually become the longitudinal components of the W and Z gauge bosons. The minimal Lagrangian which describes the interactions of the SU (2)_L U (1)_Y gauge bosons with the Goldstone bosons has been given in [12]. This non-renormalizable Lagrangian is interpreted as an elective eld theory, valid below some scale and yields the gauge boson self interactions that we use in this calculation [9].

In a similar way one can write an e ective Lagrangian that describes the interac-

tions of ferm ions to the electroweak gauge bosons. The term s that are needed for our calculation have been described in the literature [8] and in unitary gauge they are:

where we use the standard notation $t_{L,R}=(1-5)=2t$, $L_t=1-4=3s_z^2$, $R_t=4=3s_z^2$. We have assumed that the new interactions are CP conserving and so there are 4 new real parameters to be examined: L_t , R_t , L_t , and L_t . We will use Eq. 1 at one-loop, but we will not consider other anomalous couplings that may act as counterterms to this one-loop calculation. Therefore, our results will not constitute strict bounds on the parameters of Eq. 1, but instead they will depend on the naturalness assumption that contributions from dierent couplings do not cancel each other. For example, we do not discuss possible avor changing neutral current couplings.

3 Lim its from Electroweak data

Possible elects of new physics at LEP and SLC from non-standard t-quark couplings can be parameterized in terms of the 4 parameters S, T, U, and $_{b\bar{b}}$ [14]. The parameters S, T, and U describe the elects of the new physics on the gauge boson two point functions, while $_{b\bar{b}}$ contains the non-oblique corrections to the Z ! $b\bar{b}$ decay rate. The non-standard top quark couplings do not generate non-oblique corrections to decay rates other than Z ! $b\bar{b}$.

We perform a one-loop calculation of these elects and retain terms linear and quadratic in the small parameters ($_{\rm L}$; $_{\rm R}$; $_{\rm L_t}$, and $_{\rm R_t}$). Of course, our form alism is based on the assumption that the new couplings are small corrections to them in imal standard model couplings and thus the linear terms dominate the quadratic terms whenever our formalism is valid. We keep the quadratic terms only because there is one coupling that does not contribute linearly to the processes in question. Since the bounds we obtain are based on naturalness assumptions, among them that there are no cancellations between dierent contributions to the physical observables, they can be applied to this quadratic term as well.

Our one loop calculation including the new couplings is divergent. In the language of elective eld theories these divergences would be absorbed by higher dimension counterterms. We will make use of the divergent terms to place bounds on the couplings by examining the leading non-analytic contribution to the amplitudes as discussed in Ref. [9]. To this elect we retregularize the integrals in n=4 2 space-time dimensions. The coel cient of 1=1 is also the coel cient of the term 1=1 and thus gives the leading non-analytic term. The use of these terms as estimates for the size of counterterms has been emphasized in Ref. [10].

 $^{^2}$ T here are of course non-oblique corections to decay rates such as Z ! $d\overline{d}$ com ing from the Z $t\overline{t}$ vertex, but these are suppressed by small K M m ixing angles, jV_{td} f, and so we neglect them .

The caveats discussed in Ref. [9] apply here as well: our bounds are valid only as order of magnitude estimates. They are also based on the assumption that terms induced by dierent couplings do not cancel against each other. In other words, the LEP observables do not directly measure the coecients in Eq. 1 and it is only from naturalness arguments that we can place limits on the anomalous top quark couplings. For this reason our bounds are not a substitute for direct measurements in future high energy machines.

In order to obtain \lim its we use the t of Ref. [7] to possible \new physics" contributions to S,T,U, and \lim . This tassumes $M_t = 175$ 16 GeV and gives:

The standard model top quark and H iggs boson contributions are not included in the \new physics" contributions. The central values in Eq. 2 are for M $_{\rm H}~=~300~{\rm G\,eV}$, the upper second errors are the di erences when M $_{\rm H}~=~1~{\rm T\,eV}$, while the lower second errors take M $_{\rm H}~=~60~{\rm G\,eV}$.

Refs. [4, 8, 13] computed the contributions of O (M $_{\rm t}^2$ =M $_{\rm W}^2$) to T and $_{\rm b\bar{b}}$. Here we extend that calculation to include all the leading non-analytic term s, even those not enhanced by M $_{\rm t}^2$ =M $_{\rm W}^2$. We $\,$ nd

where $L_B = 1 + 2 = 3s_Z^2$ and $R_B = 2 = 3s_Z^2$. We have not included contributions that are independent of L, R, L, or Rt. These were the subject of Ref. [9].

As discussed in Ref. [9], we choose as input parameters for our renormalization scheme G_F , M_Z and M_Z) = 1=128:8. In this scheme M_W and M_Z are derived quantities. Numerically:

The anom alous couplings are assumed to be small, so we will retain only the linear couplings with the exception of $_{\rm R}$ as mentioned before. We follow the philosophy of Ref. [10] in our use of the leading non-analytic terms. A coordingly, we must choose a renormalization scale below the scale of new physics $_{\rm R}$ 3 TeV in such a way that the logarithms are of order one. With the prejudice that these new couplings are somehow related to the top-quark mass, we choose for our estimates $_{\rm R}$ 2 M $_{\rm t}$. Using M $_{\rm t}$ = 175 $_{\rm R}$ 16 GeV we note the 90% condence level limits:




Figure 1: 90% con dence level bounds from electroweak data with = $2M_{\text{t}}$. The region enclosed by the dotted and dashed lines are the limits from T_{NEW}^{\exp} and $\frac{\exp}{bb_{\text{NEW}}}$ respectively. For $L_{\text{t}}=$ R_{t} , the limit from S_{NEW}^{\exp} is 2< $L_{\text{t}}<$ 1. The region above the solid line is allowed by U_{NEW}^{\exp} . The region allowed by all measurements is shaded.




Figure 2: 90% con dence level bounds from electroweak data with $=2M_{\rm t}.$ The regions enclosed by the dotted and dashed lines are the limits from $T_{\rm N\,E\,W}^{\rm exp}$ and $\frac{\rm exp}{\rm hb,N\,E\,W}$ respectively. The region to the right of the dot-dashed line is allowed from $S_{\rm N\,E\,W}^{\rm exp}$, while the region above the solid line is allowed by $U_{\rm N\,E\,W}^{\rm exp}$.




Figure 3: 90% con dence level bounds from electroweak data with $=2M_{\text{t}}$. The regions enclosed by the dotted and dashed lines are the limits from $T_{\text{NEW}}^{\text{exp}}$ and $\frac{\text{exp}}{b_{\text{DNEW}}}$ respectively. The region to the left of the dot-dashed line is allowed from $U_{\text{NEW}}^{\text{exp}}$, while the region below the solid line is that allowed by $S_{\text{NEW}}^{\text{exp}}$. The region allowed by all measurements is shaded.

In Fig. 1, we take $L_t=R_t$ and show the limits on $_L$ as a function of L_t . Including the limit from $U_{\text{NEW}}^{\text{exp}}$ excludes a considerably larger region of parameter space than would be excluded from $T_{\text{NEW}}^{\text{exp}}$ and $\frac{\text{exp}}{\text{hb}_{n}\text{NEW}}$ alone. If the new couplings modify only the axial coupling to the Z , L t $_5\text{tZ}$, then $L_t=R_t$. We show the limits in this case in Fig. 2 and see that only a small region of parameter space is allowed. This agrees with previous observations that the electroweak data tend to prefer $L_t=R_t$ [4]. In Fig. 3, we set $_L=0$ and show the 90% condence level bounds on L_t and R_t . In this gure, we again see the trend that in the allowed region, $L_t=R_t$. In all three gures, it is interesting to note the role of the limit on $U_{\text{NEW}}^{\text{exp}}$, which is more signicant than the limit from $S_{\text{NEW}}^{\text{exp}}$.

The e ects of a possible right-handed coupling of the W to the b and t $\,$ rst arises at O (2_R) in Z decays. The best lim it com es from $T_{N\,E\,W}^{\,\rm exp}$ and is

This is considerably weaker than the \lim it from the CLEO measurement of \mathbb{B} ! s \mathbb{B}].

4 Conclusions

The increasing precision of electroweak measurements, along with the recent measurement of the top quark mass, allows limits to be placed on the non-standard model couplings of the top quark to gauge bosons. We have updated previous limits by including terms not enhanced by the top quark mass. These additional terms allow a larger region of parameter space to be excluded than in previous studies.

It is interesting to speculate as to the size of these coe cients in various models. If the non-standard couplings arise from loop e ects then they might be expected to have a size - :002, several orders of magnitude smaller than the current limits. In models where the non-standard couplings arise from four-ferm ion operators at a high scale, the coe cients have a typical size [13],

In the top colorm odelofR ef. [13], g_A 4 (:11) and so a scale 2 T eV would yield a coe cient, L_t 10 3 . Unfortunately, unlike the case with the b-quark couplings, the lim its on top quark couplings do not yet seriously constrain model building.
