The Role of Strange and Charm Quarks in the Nucleon Spin Structure Function

Abstract

We perform an analysis of the relation between the factorization scale and the masses of the quarks in the calculation of the hard gluon coe cient in polarized deep inelastic scattering. Particular attention is paid to the role of strange and charm quarks at nite momentum transfer. It is found that for the momentum transfer of the present experiments, the contribution from the charm quark is signi cant.

1 Introduction

In the usual analysis of the proton spin structure function, based upon QCD and the operator product expansion (OPE), the moments of the singlet part of $g_1 (x; Q^2)$ are written as:

with $C_n^q (Q^{2} = {}^2) = 1 + 0$ (_s) the W ilson coe cients for the quark operators, $C_n^q (Q^{2} = {}^2) = 0$ (_s) the W ilson coe cients for the gluon operators. The matrix elements _n (²) and g_n (²) are not determined by perturbative QCD and should be either xed by experimental constraints or calculated

using non-perturbative techniques. Eq. (1) can be inverted, using the inverse M ellin transform ation, and the result is:

where denotes a convolution of the two functions.

Much of the debate on the proton spin in the last few years has been centered on whether or not the spin of the proton receives a contribution from the gluons [1-6]. On the basis of the OPE the picture is clear: there is no twist two gluon operator contributing to the $rst m \circ m \circ m \circ f g_1$, and hence $\int_{0}^{n_1} C^q (x; Q^2 = 2) dx = 0$. This result implies that the rst moment of g_1 is given solely by the rst moment of . If were identied with the spin in the proton carried by the quarks then the gluons would give no contribution. In this scenario, following the parton model language, $n(^2) = N_{f}^P f_n(^2)$, with $f = f_1$ the amount of spin carried by the f quark and N equals 1/9 for three avors, 5/36 for four avors, etc. It cannot be identied with spin because of the axial anom aly. happensthat Indeed, the axial anom aly is at the heart of the disagreem ent between the OPE and the improved parton m odel (IPM) results for the role of gluons in the rst m om ent of $g_1(x; Q^2)$. In this contribution, we are not going to m ake a com plete analysis of the equivalence (or otherwise) of these approaches but will limit ourselves to the analysis of the gluon contribution in the light of the IPM only.

In the IPM the situation is more complicated. One calculates the full, polarized photon-proton cross section and uses the factorization theorem to separate the hard and soft parts:

where ² is the factorization scale, $f_{q(g)=N}$ is the polarised quark (gluon) spin distribution inside the nucleon and _h is the polarized, hard photon-quark or hard photon-gluon cross section. One then could relate g_1 calculated in the IPM, Eq. (3), to g_1 calculated in the OPE, Eq. (2), by identifying the hard, perturbatively calculated, W ilson coe cients with the hard photon-quark and hard photon-gluon cross sections and identifying the matrix element (x; ²) (g(x; ²)) with the factorized quark (gluon) distribution

 $f_{q(g)=N}$. However, as already mentioned, $(x; ^2)$ cannot be identified with the quark spin distribution. The relation between them is beyond the scope of the present work. Instead, we will concentrate on the relation between the W ilson gluon coe cient and the hard gluon cross section of the IPM .A lthough there are excellent treatments of this subject in the literature [2, 6, 7, 8], we think that the present contribution adds signi cantly to the understanding of the behaviour of $g_1(x;Q^2)$ at nite Q^2 .

In section 2 we will develop the basis for the calculation of the hard gluon coe cient in the IPM. The resulting expression interpolates the known limits of $\frac{-a}{2}N_f$ for $m_q^2 << 2$ and 0 for $m_q^2 >> 2$ and overcomes convergence problems found in an early work [22]. The elects of this generalized, hard gluon coe cient are discussed in section 3. In particular, its elect on the contribution to $g_1^p(x;Q^2)$ from up, down, strange and charm quarks is studied. Our results indicate that these corrections are sizable and must therefore be taken into account when extracting the polarized gluon distribution from the proton. We also point out in this section how this anom abus contribution is a ected by nite Q². In section 4 we calculate the am ount of polarized gluon in the proton necessary to explain the available data. We com pare our result with other estimates made using simply the limiting cases for the hard gluon coe cients. Section 5 is used to study the region in x where this contribution is located. In section 6 we sum marise the results obtained in this article.

2 Theoretical Construction

The hard gluon cross section is extracted from the full photon-gluon fusion cross section, v^{g} and is calculated through the box graphs which start at order s. The other contribution from which it must be separated is the quark distribution inside the gluon [7]. M athem atically this is expressed as:

where q^{g} is the polarized quark distribution inside a gluon and $_{h}^{vg}$ is the hard photon-gluon cross section de ned, in the IPM, as the contribution coming from quarks in the box graph with transverse momenta greater than the factorization scale.

The full photon-gluon cross section has been calculated to be [9, 10]:

with $P^2 = p^2$ the gluon virtuality, m_q the quark m ass and $W^2 = \frac{Q^2(1-x)-P^2x}{x}$ the invariant m ass squared of the photon-gluon system. For very large m om entum transfer, $Q^2 >> m_q^2$; P^2 , the full cross section reduces to:

It remains to calculate q^{g} . This is given by computing the triangle diagram or, equivalently, the integral over the transverse momentum of the square of the norm of the light-cone $q\overline{q}$ wave function of the gluon [2, 7, 11]. As q^{g} is a soft contribution, the integral over the transverse momentum has to have a cut o :

E quation (7) is a generalization of previous results [2, 7] including the dependence on the factorization scale for any values of the quark m asses and gluon

virtuality. Its rst moment is zero for $2 << m_q^2; P^2$. If $2 >> m_q^2; P^2$ the rst moment of $q^g(x; 2)$ is 0 for $P^2 >> m_q^2$, while it is $\frac{s}{2}N_f$ for $m_q^2 >> P^2$. Using Eqs. (4), (6) and (7) we can calculate the hard gluon coe cient:

Notice that the rstm om ent of Eq. (8) does not depend on the ratio $m_q^2 = P^2$ in the region $2 > m_q^2$; $P^2 - it$ is a legitim ate hard contribution. Equation (8) is also a generalization of previous results and from its limit, $2 > m_q^2$; P^2 , it may be argued [1] that the gluons contribute to the rstm om ent of $g_1(x; Q^2)$ because $n_q^{R_1} = \frac{v_q}{2}N_f$.

On the other hand, if one calculates the quark distribution inside a gluon through the triangle graph, which we call q_{OPE}^{g} , using a regularization scheme that respects the axial anom aly, it is found that ¹:

where the renorm alization scale in the regularization of q_{OPE}^{g} (using \overline{MS}) has been taken to coincide with the factorization scale in the IPM.

Equipped with Eq. (9) we can understand exactly why the hard gluon coe cient in the IPM has a rst moment di erent from zero. The reason is that in the process of factorization the axial anomaly was shifted from the quark distribution inside the gluon to the hard coe cient. Equation (9) re ects the fact that the regularization of q_{OPE}^{g} respects the axial anomaly while the regularization of q_{OPE}^{g} coes that in the lim it $m_{q}^{2} >> ^{2}$, the discrepancy between the two calculations disappears (at least for the

rst m om ent - the x dependence depends on the regularization m ethod). A

sim ilar phenom enon is found in unpolarized deep inelastic scattering where an analysis by Bass [12] has shown that the trace anom aly induces the sam e sort of shift when a cut o over the transverse squared m om enta of the quarks is used to separate the soft and hard regions.

As a consistency check of our equations, we calculate the OPE hard coe cient, C^g. It is de ned in the same way as h^{rg} in Eq. (4) and calculated with the help of expressions (6) and (9):

This result is independent of m ass and its rst m om ent is always zero, in accordance with the results of K odaira [13] and B odw in and Q in [5].

3 Consequences for the First M om ent of the Hard G luon Coe cient

It is interesting to study the dependence on ² of the rst moment of $_{\rm h}^{\rm vg}$. In an early study on this subject², M ankiew icz and Schafer [22] determined the rst moment of the box graph as a function of the minimum transverse momentum carried by the quarks. Their results for Q² ! 1 agree qualitatively with ours, as will soon be seen. But it was also found in Ref. [22] that for momentum transfers of the order of 10 to 100 G eV², the contribution from light quarks³ (m_q = 10 M eV) is deeply a ected by the choice of them inimum value for the transverse quark momentum. In the method used here, such an ambiguity does not exist for the light quarks and its anom alous contribution for Q² = 10 or 100 G eV² is well de ned and independent of k₂. We use this result to argue that the hard gluon coe cient calculated here is more stable from the point of view of infrared singularities.

Even with the known variations of the anom abus contribution with the factorization scale, it has been widely assumed in the literature [8] that for

light quarks (u, d and s) the rst m om ent of ${}_{h}^{vg}$ is ${}_{s}=2$ and for heavy quarks (like c or b) it is zero (because, for ${}_{q}^{2} >> {}^{2}$, ${}_{h}^{vg}$ reduces to C^g). But it also happens that the gluonic contribution to $g_{1}(x;Q^{2})$ is of the form ${}_{h}^{vg}(x;Q^{2}={}^{2})$ $g(x;{}^{2})$. This means that the scale 2 at which the gluon distribution is calculated (or parametrized) is the same scale 2 that has to be used in the calculation of the hard gluon coe cient, and that it does not make sense to talk about the magnitude of the hard gluon coe cient without specifying the factorization scale. Thus, the heavy quark contribution is calculated at a very low scale com pared with the quark mass.

In Fig. 1 we show the rst moment of $h^{v_{g}}$ as a function of the factorization scale for the u and d quarks ($m_q^2 = 25^{n} = 10^{-6} \text{ GeV}^2$), for the s quark ($m_q^2 = 0.04 \text{ GeV}^2$) and for the c quark ($m_q^2 = 9=4 \text{ GeV}^2$). We see that, as is well known [2, 6, 7, 8], the c quark does not contribute when $m_c^2 >> 2^{-2}$, as one can also verify directly from Eq. (8). However, for reasonable values of ² there is a contribution large enough to be taken into account. Thus, the signi cance of the charm contribution to $q_1(x;Q^2)$ depends on where the polarized gluon distribution is calculated. For instance, calculations have been made in the literature using input polarized gluon distributions at a scale of typically 4 G eV². The authors of these calculations usually disregard the charm contribution. We note in passing that in the region of 2 where polarized charm can be disregarded, the polarized strange quarks yield only half of the contribution given by u and d quarks. A swe see from Fig. 1, the c quark gives around 64% of the contribution of the light quarks for 2 4 G eV 2 and so it should not be disregarded if the gluon distribution is calculated at this scale. We also see from Fig. 1 that the u and d quarks give the same contribution, independent of the factorization scale. We further notice that, for practical purposes, the hard gluon coe cient is independent of the exact value of the gluon virtuality P^2 .

The discussion of the preceeding paragraph was based on the not so realistic assumption that the momentum transfer Q² is in nitely bigger than any other scales in the theory. It implies, for instance, that when integrating the hard cross section we allow x to go from zero to one. But from simple kinematic arguments we know that x has a maximum value of $x_{max} = Q^2 = (Q^2 + P^2 + 4m_q^2)$ and so $x_{max} ! 1$ only when $Q^2 >> m_q^2; P^2$. For the nite Q² of the current experiments, x_{max} never reaches 1 and so the integral in x has a cut o . For instance if one calculates the rst moment of $\int_{h}^{v_{g}}$ for the c quark (m $_{q}^{2} = 9=4$ G eV 2) at $^{2} = Q^{2} = 4$ G eV 2 , using Eq. (8), one nds that its value changes from -0.64, when x is articially allowed to reach 1, to 0.015 when the physical cut o in x is applied. W hat happens is that expression (8) itself was obtained under the assumption of an in nitely large Q 2 . To be more consistent when dealing with nite Q 2 , one should derive the hard cross section from the full cross section w ithout any approximation.

In the general case we then write:

with v^{g} given by Eq. (5) and q^{g} and q^{g}_{OPE} given by Eqs. (7) and (9). W e stress that these equations are the complete result at order $_{\rm s}$. In Figs. 2 and 3 we show the $rstmoment of h^{vg}$, de ned in Eq. (12), as a function of the factorization scale 2 for Q² = 10 G eV² and Q² = 3 G eV², respectively. T here values were chosen because they are the average Q^2 of the EM C [19, 20] and SLAC [21] experiments. The resulting dependence is very interesting. It shows that in the region of interest $(^2 1 \text{ GeV}^2)$ there is no appreciable dependence on the gluon virtuality or on 2 (at least for $Q^2 = 10 \text{ GeV}^2$) but the mass dependence is strong. Remarkably, the contribution from the s quark is never the same as the contribution from the u and d quarks, contrary to what is usually claimed. The scontribution is $0.9 \text{ }_{s}(Q^{2})=2$ for the EMC data and $0.75 \text{ }_{s}(Q^{2})=2$ for the E143-SLAC data. We also nd a nonnegligible contribution com ing from the c quarks. For the EMC data, the c quark contributes with $0.2 \text{ }_{s}(Q^{2})=2$ and for the E143-SLAC data 0:1 $_{\rm s}$ (Q²)=2. Figure 2 is unaltered ⁴ if we go from m²_q = 0 to with $m_{\alpha}^2 = 1$ 10 4 GeV². If we then compare our Fig. 2 with Fig. 2 of Ref. [22] we see clearly that the present approach does not have a convergence problem in Q² and yelds a perfectly unambiguous contribution from the light quarks. Finally, we show in Fig. 4 the Q^2 dependence of the polarized charm contribution calculated with $^2 = 3 \text{ GeV}^2$. This contribution, obviously, tends to the value calculated in Fig. 1 ($0.57 \text{ }_{s}(Q^{2})=2$).

 $^{^4}$ In reality, there is a 1% correction for 2 0.01 GeV 2 . This result is in complete accord with the fact that the anom abus contribution for the u and d quarks goes to zero as 2 goes to zero.

4 Relevance in Analysing the Fraction of Nucleon Spin Carried by Gluons

In term softhe polarized quark and gluon distributions, $g_1^p(x;Q^2)$ for 4 avors is written as:

where $q_3 = u$ d, $q_8 = u + d 2 s$, $q_{15} = u + d + s 3 c$ and = u + d + s + c. For 3 avons the coe cient of the singlet part changes from 5/36 to 1/9 and q_{15} does not exist. To order $_{s}$ (Q²) [13], the rst moment of (13) is:

The coe cients of $_{s}(Q^{2})$ have the following meaning. The 2 indicates that the u and d quarks give the same contribution $\frac{-s(Q^{2})}{2}$, as discussed before. The s_{1} and c_{1} factors give the amount of strange and charm quark contributions, according to Eq. (12) and Figs. 1–3.

To extract the value of $G(Q^2)$ we will closely follow Refs. [15, 17]. For the sake of comparision, we begin with only 3 avors and with the common assumption that the u, d and s quarks give the same anom alous contribution.

Under the assumption that the polarized sea originates exclusively from the anom alous gluon contribution we have, for 3 avors, the following identities:

where the quark spin fractions were expressed in terms of the F and D couplings and corrections from the two loop expansion of the beta function and anom alous dimension were incorporated. In NLO, $_{\rm s}$ is given as the solution of the following transcendental equation:

with $_0 = 11$ 2N_f=3 and $_1 = 102$ 38N_f=3. We use = $^{(3)} = 248$ MeV, determined by xing $^{(4)} = 200$ MeV [18]. Using the experimental values of F and D as given in [17], we determine I_3 and $I_8 + I_0$ at $Q^2 = 10$ GeV² (with $_{s}(Q^2 = 10$ GeV²) / 0:209):

We now use Eq. (14) to determ ine $G(Q^2)$. On the left hand side, we use the experimental result [20]:

On the right hand side we use the results (17), $s_1 = 1$, $c_1 = 0$ and remember that for 3 avors the singlet coe cient is 1/9 and I $_{15} = 0$. The result is:

For 4 avons the analysis is similar. One just has to rede no the integral of $g_1^p(\mathbf{x}; Q^2)$:

We then proceed as before and calculate G using the result for the gluon coe cient as displayed in Fig.2. We see that for $^2 = Q^2 = 10 \text{ GeV}^2$, $s_1 = 0.9$, $c_1 + 0.21$ and $_s (Q^2 = 10 \text{ GeV}^2) = 0.2142$, resulting in:




Figure 1: Hard gluon coe cient as given by Eq. (8), calculated with the assumption of in nite momentum transfer as a function of the factorization scale. For realistic scales ($^2 > 1 \text{ GeV}^2$), the charm contribution is seen to be important.

In passing we notice that if the usual assumption of in nite momentum transfer were used, then according to the results of Fig.1, at 10 GeV 2 s₁ = 1, c₁ ' 0.81 and hence g' 1.89.

5 The x dependence

The exact x dependence of the anom abus contribution is a matter of convention because the freedom in the factorization scheme while calculating $_{h}^{vg}$. Other choices of regularization would result in di erent functions of x. But, as shown by G luck et al. [14], the exact form of the x dependence seem s not to be very in portant. Once we do not know the form of the polarized gluon distribution, the best we can do is constrain it by some general considerations. For instance, there is the positivity condition:

$$jg(x;Q^{2})j g(x;Q^{2});$$
 (22)

where $g(x;Q^2)$ is the unpolarized gluon distribution. A very simple form that satis es the above condition is:

$$(x) = x \quad g(x); \tag{23}$$

where is determined through the normalization of g. For g of Eq. (21), = 0:49. The advantage of using this form to study the x dependence is its simplicity. The problem with Eq. (23) is that it does not have the correct behavior as x ! 0. As proposed by Brodsky et al. [23],

$$\frac{g(x)}{g(x)} ! x; \qquad (24)$$

as x ! 0. From the many ways to satisfy both conditions (22) and (24), we choose:

$$g(x; ^{2} = 9 G eV^{2}) = xg(x; ^{2} = 9 G eV^{2})(1 x)^{3};$$
 (25)

where = 6.92 for g = 2.32. W em ade this choice guided only by the desire of sim plicity and to produce a polarized gluon distribution that resembles an already existing one [15]. For the unpolarized gluon distribution, we use the one given by the NMC [24], determined from inelastic J= production:

$$xg(x) = \frac{1}{2}(+1)(1-x)$$
: (26)

This param etrization is valid for $^2 = 9 \text{ GeV}^2$ and should not be trusted for x 0.01. Again, this choice is based on simplicity and we note that a further param etrization by the NMC [25] group agrees with Eq. (26) for x 0.01. The parameter is = 5.1 0.9. Given these choices, we show in Fig. 5 the form s (23) and (25) for the polarized gluon distributions plus the form s of B rodsky et al. [23] and G ehrm ann and Stirling (G S) [15], calculated at 4 G eV². Our parametrization (25) is slightly higher than that of G S because of the norm alization factor. If we use the sam e norm alization as theirs⁵, both curves would be essentially the sam e. Evolution from 4 to 9 G eV² for the G S distribution also has sm alle ects. The param etrization of B rodsky et al. [23] is much sm aller than the others because in their approach the polarized gluons are not responsible for the sm all experimental value of Eq. (18).

Using the constructed gluon distributions, we can estim ate where in x the anom alous contribution is located. In Fig. 6 we show the anom alous contribution, $\frac{5}{36} = \frac{v^{\circ}g}{h^{\circ}}(x;Q^2; z^2) = g(x; z^2)$, for $g(x) = xg(x)(1 - x)^3$. We see that its contribution inside the experimental region is in portant. To better evaluate its in portance, we calculated the amount of the total gluon that lies inside the region 0:01 x 1. For 4 avors, the contribution from x 0:01 corresponds to about 66% of the total anom alous contribution. In the case of 3 avors, this percentage is 69%. For g(x) = x - g(x) this conclusion is not dram atically altered.

It is also interesting to com pare the anom abus gluon contribution directly with the experimental data. To this end, we plot in Fig. 7 the experimental data [19, 20] for $g_1^p(x)$ together with an early next-to-leading order estimate [26] for the valence quark distribution and the anom alous gluon contribution for the case of 3 and 4 avors. A remark is necessary here. The calculation of the hard gluon coe cient was performed through a cut o on the transverse

 $^{^{5}}$ W e note that in [15], the coupling constant is calculated in leading order rather than in NLO. This would lead to an increase of the total polarization carried by the gluons.

m om enta of the partons in order to regularize the integrals. This procedure is the de nition of the parton model. On the other hand, we calculated the strong coupling constant, and also the evolution of g_1^p in Ref. [26], using the \overline{MS} scheme. In principle, showing the x dependence of two quantities in dierent schemes is not a consistent procedure. However, the problem is not as bad as it boks. First, if we change schemes we can mantain s unaltered by a simple rede nition of the parameter in expression (16). Second, the theoretical curve for $g_1^p(x;Q^2)$ is to be interpreted as a quide of what a parametrization for the valence part of the polarized structure function would give, the regions in which it di ers from the data and where it should be corrected. A proper procedure would be to calculate the quark distribution, the anom alous dimensions and the W ilson coe cients in the same scheme. That said we proceed noticing that the integral over x of the valence contribution calculated in [26] (0:169) is in complete agreement with the estimates calculated previously in Section 4. The two curves below the origin, are the anom alous contributions that should be added to the solid curve for $N_f = 3$ or 4. As we xed the normalization of the total polarized glue for either 3 or 4 avors, there is no noticeable di erence between the two cases. We see that the anom alous contribution is potentially in portant to correct the x dependence of the polarized valence distribution inside the proton.

6 D iscussion

In summary, there is a gluonic contribution to the proton spin when the IPM hard gluon coe cient is de ned through Eq. (12) with q ^g de ned as the quark distribution inside the gluon with transverse squared momentum less than the factorization scale. As a consequence, this anom alous gluonic contribution in the IPM is free of infrared ambiguities. We showed that if we accept the commonly used assumption of an in nitely big momentum transfer, there is a c quark contribution to the spin in addition to the u, d and s quark contributions. The contribution from the massive quarks is dependent on the factorization scale at which the polarized gluon distribution is calculated. The c quark contribution is small only in the region $^2 < 1 \,\mathrm{GeV}^2$, in which case the s quark contribution is also strongly a ected.

We also calculated what would be the possible anom alous corrections

when the momentum transfer is in the region of the present experiments. To perform such a calculation we have to keep all terms in $m_{\alpha}^2=Q^2$ and $P^2=Q^2$ in the full photon-gluon cross section when calculating the hard gluon coefcient. This means that we are including higher twist e ects and, although we use the complete result at order $_{s}(Q^{2})$, possible corrections coming from higher order term s in $_{s}(Q^{2})$ could be in portant and so our calculation is incom plete. Even so, we think that our results are m ore consistent than sim ply using the approxim at eexpression (8) for the hard gluon coe cient in the case of m assive quarks and relatively low Q^2 . The corrections due to nite Q^2 are not sm all and we think they should be taken into account when calculating the amount of spin carried by gluons. When studying the x dependence of the anom alous contribution, we conclude that both 3 and 4 avors give approxim ately the same contribution inside the experim ental region. But the amount of polarized glue needed to t the data is much smaller when charm is included. Moreover, we showed that from the conceptual point of view, it would be wrong not to include a fourth avor.




Figure 2: Hard gluon coe cient as given by Eqs. (5), (7) and (12). The momentum transfer is xed at 10 GeV². It is seen that the strange quark contribution never equals that from the up and down quarks and the charm quark contribution is sizable for $^{2} > 1 \text{ GeV}^{2}$.




Figure 3: Hard gluon coe cient as given by Eqs. (5), (7) and (12). The momentum transfer is xed at 3 GeV^2 . It is seen that the strange quark contributes with approximately 75% of the up and down quarks in the realistic region of $^2 > 1 \text{ GeV}^2$. In the same region, the charm quark gives a 10% contribution.




Figure 4: Hard gluon coe cient for the charm quark, calculated with Eqs. (5), (7) and (12). The factorization scale is xed at 3 GeV 2 and the Q 2 dependence is studied.




Figure 5: C on parison of various polarized gluon distributions considered in the text.




Figure 6: C on parison of the x-dependence of the non-strange, strange and charm quark distributions to $g_1(x)$. The anom alous contribution is given by $\frac{5}{36} \operatorname{h}^{v_{g}}(x;Q^2; ^2) \quad g(x; ^2)$ and it is used the form $g(x; ^2 = 9 \operatorname{GeV}^2) = xg(x)(1 + x)^3$ for the polarized gluon.




Figure 7: EMC [19] and SMC [20] data for $g_{1p}(x)$ at 10 G eV². The theoretical curve for the polarized valence distribution is calculated in NLO and taken from Ref.[26]. The anom alous contribution should be subtracted is to be subtracted from the theoretical curve.
