Photon and Z Induced H eavy Charged Lepton Pair Production at a H adron Supercollider

Abstract

We investigate the pair production of charged heavy leptons via photoninduced processes at the proposed CERN Large H adron Collider (LHC). U sing e ective photon and Z approximations, rates are given for L^+L production due to fusion and Z fusion for the cases of inelastic, elastic and sem ielastic pp collisions. These are compared with the corresponding rates for production via the gluon fusion and D rell-Y an mechanism s. Various and Z di erential lum inosities for pp collisions are also presented. There has been a recent revival of interest in processes mediated via photons at e^+e^- colliders [1]. In the present work we address the question of photon induced production processes at hadron colliders, which have been relatively neglected. Since photons have a universal coupling to charged ferm ions it seems natural to consider ferm ion pair production as a benchm ark process.

Heavy charged leptons are a feature of m any m odels which extend the particle content of the Standard M odel (SM). These include m odels which propose a complete additional generation [2] of heavy quarks and leptons, as well as those like E_6 based superstringinspired m odels [3], which contain extra particles within each generation. The D rell-Y an [4], gluon fusion [5], and weak gauge boson fusion [6] m echanisms for the production of heavy charged leptons in hadron collisions have been investigated in the past. We here consider heavy charged lepton pair production in hadronic collisions via two photon () and Z fusion. In Fig. 1, we show the Feynm an diagram s for the relevant subprocesses. We assume standard m odel couplings for both the and the Z boson to the heavy leptons, L.

The inelastic process pp ! X ! L^+L X (where the photons come from the quarks), the elastic process pp ! pp ! L^+L pp (where the photons come from the protons), and the sem i-elastic process pp ! pX ! L^+L pX, are considered in a W eizsacker-W illiam s approximation [7,8] (W W A). We have previously presented some results for these photon fusion processes [9], as have some other authors [10]. The inelastic process was considered on its own by Eboli et al. [11] also.

Here, we also present heavy charged lepton pair production via Z fusion. In fact, the Z fusion process yields a larger production cross section than the fusion over most of the lepton mass range we consider (m_L of 100 – 700 GeV). Our Z fusion calculation is done within the framework of an elective vector boson approximation [12,13], for both inelastic and sem i-elastic pp collisions. Heavy charged lepton production via Z fusion has been previously considered for the case of inelastic pp collisions by Eboli et al. [11] We do

not agree with their results and discuss the origin of that discrepancy.

The organization of this paper is as follows. We describe in Sec. 2 the details of the e ective photon and e ective Z approximations which we have used. The V (V = ;Z) lum inosities in pp collisions are presented in Sec. 3; these results are of broader interest than just for the particular heavy lepton production considered here. The L⁺L production cross sections are presented in Sec. 4 and we sum marize in the nal section.

II.EFFECTIVE PHOTON AND EFFECTIVE Z APPROXIMATIONS

The central idea of the elective photon or W eizsacker-W illiams approximation [7] is to approximate the scattering cross-section involving a charged particle by a convolution of the equivalent number of photons in that particle with the relevant photoproduction crosssection. The quark-parton m odel has been very successful in describing hadronic interactions at high energies. For inelastic pp scattering a proton may be regarded essentially as a collection of freely travelling elementary constituent quarks and gluons. The W eizsacker-W illiams photon spectrum, $f_{=q}(x)$, from a quark (of charge e_q) is given by [14]

where x is the fraction of the quark energy carried o by the photon. Here t_{max} and t_{min} are the characteristic maximum and minimum photon momentum transfers. For the process under consideration, pair production of heavy charged leptons of mass m_L , we have taken these to be $t_{max} = \$=4$ m²_L, and $t_{min} = 1 \text{ GeV}^2$, with \$ being the center of mass energy in the parton frame. There is some exibility in the choice of t_{max} . However, in agreement with A ltarelliet. al. [15], we have found that our results are not very sensitive to this parameter, within the limits of the W eizsacker-W illiam s approximation. The particular choice of the minimum momentum transfer, t_{min} , guarantees that the photons are obtained from the deep inelastic scattering of protons, when the quark-parton model is valid.

For inelastic scattering the incident proton ceases to exist and the constituents hadronize. However for elastic pp scattering the incident protons remain intact. The photon spectrum from protons for the elastic case, $f_{=p}^{el}$, has been derived by K niehl [8] in a modi ed W eizsacker-W illiam s approximation. It takes the form given below.

Here, $t_{max} = m_p^2 x^2 = (1 \ x)$ while H_1 and H_2 are functions of the electric and m agnetic form factors of the proton of m ass m_p , as given below.

U sing these param etrizations K night has obtained a closed analytic expression [8] for $f_{=p}^{el}$, which we have used in our calculation.

For hadron interactions at very high energies in the multi-TeV range, one can consider the W and Z bosons also as constituents of protons. In analogy with the elective photon approximation, elective vector boson approximations have been developed which considerably simplify calculations involving gauge bosons. However unlike photons, a massive gauge boson has both transverse and longitudinal polarizations and these degrees of freedom must be treated separately. The elective W and Z approximations give the spectra of longitudinally and transversely polarized W 's and Z 's from quarks in the protons.

W ehave done our calculations using two di erent form s for the elective Z approximation, the non-leading order Z distributions of D aw son [13] and those of Johnson et. al. [16]. In the original formulation of the approximation, D aw son [13] presents the distribution function of Z bosons in quarks both in the leading logarithmic (LL) approximation and also gives non-leading order corrections up to 0 (M $_{Z}^{2} = E_{q}^{2}$), where E_{q} is the quark energy. W e used the non-leading order distribution in our calculation. An improved formulation of the elective vector boson approximation has been presented by Johnson et. al. [16]. This formulation does not invoke any kinematic approximations made in the original formulation, and claim s to improve the accuracy and extend the range of applicability of the elective vector boson approximation [16,17]. Dawson presents the distribution of transverse Z bosons averaged over the two transverse polarizations whereas Johnson et. al. derive separately each of the positive and negative helicity polarizations. The distribution expressions are too lengthy to reproduce here [13,16,17].

Johnson et. al., in comparing their vector boson distribution functions with that of the leading logarithm ic (LL) distribution functions of D aw son, nd the LL expressions to be a considerable overestim ate, particularly for sm all x and for the transverse polarization. We here nd rather good agreem ent between our Z lum inosity results using the distribution functions of D aw son including non-leading order corrections and those of Johnson et. al., as we show in the next Section.

III.PHOTON PHOTON AND Z-PHOTON LUM INOSITIES

Using the elective photon and Z approximations described above we present here the two photon and Z -photon di erential lum inosities in pp collisions as a function of (the ratio of the =Z subprocess energy and the total pp energy), for the inelastic, elastic and sem i-elastic cases. These results are useful for adaptation to the production of other particles than heavy leptons.

The V (V = ; Z) di erential lum inosity for inelastic pp collisions is given by,

In the above expression $f_{q=p}$ represents the quark structure functions of the proton, which we have chosen to be the HMRS (Set B) structure functions [18]. For the case V = ananalytic expression can be obtained for the subprocess di erential lum inosity as

No such simple analytic expression is available for the case V = Z using non-leading order Z distribution functions.

The di erential lum inosity for elastic pp collisions is given by,

where the upper limit of integration is given by kinematical considerations to be $x_{max} = (1 \quad 2m_p = {}^p \bar{s}), p \bar{s}$ being the center of mass energy of the elastically colliding protons. The V (V = ;Z) dimensional luminosity for semi-elastic pp collisions is given by,

We present luminosities in Fig. 2, Z luminosities derived with the non-leading D aw son elective Z approximation in Fig. 3, and Z luminosities derived with the Johnson et. al. elective Z distributions in Fig. 4. We consider these results in turn below. The luminosity for the elastic case is independent of the production process, how ever for the other two cases it depends on the production process through the factor t_{max} . In each Figure, the luminosities for inelastic and semi-elastic cases are presented for the case of charged lepton mass $m_L = 200 \text{ GeV}$.

In Fig. 2 we show the inelastic, elastic, and sem i-elastic two photon lum inosities in pp collisions for the proposed CERN Large Hadron Collider (LHC) of center of mass energy of 14 TeV. For comparison purposes we also show the two gluon lum inosity. As can be seen from Fig. 2 the lum inosities are comparable for the three cases but are, how ever, 3-4 orders of magnitude smaller than the gg lum inosity. This can be understood as being due to the fact that the photon lum inosities are suppressed by a factor $(= s)^2$ with respect to

the gluon lum inosity, which is som ewhat countered by the logarithm ic enhancem ent factor present in the photon lum inosities.

In Figs. 3 a, b we show the Z di erential lum inosities for inelastic and sem i-elastic pp collisions, respectively, using the non-leading D aw son form of the elective Z approximation. The solid line corresponds to the lum inosity for longitudinally polarized Z bosons, the dotdashed line to the average over the two transverse polarizations of the Z. The lum inosity corresponding to transversely polarized Z dom inates that for longitudinal Z polarizations. Thism ay be understood as being due to helicity suppression. For both the inelastic and sem ielastic cases, the $\rm Z_{\,I}$ di erential lum inosity is larger than the $\rm Z_{\,L}$ di erential lum inosity 10³ and by an order of magnitude for by a factor of 2-3 for 10¹. Ultimately, however, we will see that the Z_L ! L⁺L cross-section dom inates so it is most important to consider the lum inosity for longitudinal Z bosons here. Com paring the inelastic and sem i-elastic cases, the total di erential Z lum inosity for the inelastic case is larger than that for the sem i-elastic case by a factor of 2-3 for 10^{-3} , but for 0:03 they become equal.

In Figs. 4 a, b we show the results for the Z di erential lum inosities, for inelastic and sem ielastic pp collisions, respectively, using the Johnson form of the elective Z approximation. Here, again, the solid line shows the lum inosity for longitudinally polarized Z bosons. The dot-dashed and dotted lines show separately the lum inosities for positive and negative helicity transverse Z polarizations, respectively. The dashed line corresponds to the sum of the lum inosities for the two transverse Z polarizations, which we will refer to as Z_T as in the D aw son case. One observes essentially the same numerical relationships between the di erent lum inosities show n here, as discussed above for the D aw son form of the elective Z approximation. The Z_L lum inosities agree almost exactly for the two di erent forms of the elective Z approximation, except at very small. The Johnson distribution functions yield Z_T lum inosities slightly larger than those obtained with the D aw son distribution functions. W e will not that the Z process cross section is only large enough to be interesting for heavy lepton m asses above about 600 G eV; in the range of corresponding

to production of such heavy leptons the D aw son and Johnson lum inosities for Z_T agree to 20 % or better. In both the longitudinal and transverse cases, one does expect some disagreem ent between the D aw son and Johnson form ulations. W hile they are both non-leading distribution functions, they are derived under quite di erent kinem atical assumptions; the D aw son derivation includes approximations, such as the small-angle one, which the Johnson derivation does not. In addition, for the transverse Z polarizations, the Johnson form ulation separately extracts the positive and negative Z helicity distribution functions whereas the D aw son form ulation extracts a single transverse Z distribution function from the cross sections averaged over the two transverse polarizations. So, particularly in the transverse case, the agreem ent should not be perfect. W e have shown in Figs. 3 and 4 a detailed com parison of the lum inosities using the two forms of the e ective Z approximation. W e will present the production cross-sections for Z fusion using only the non-leading order D aw son form of the e ective Z approximation in the next Section. This choice is really rather arbitrary. For the longitudinal Z case, which will be of interest, agreem ent between the two form ulations is excellent.

C om paring the two di erent initiating states, we nd that the Z lum inosities are smaller than the lum inosities for small values of , but they do not di er by m ore than an order of magnitude. For 10^{-2} the Z and lum inosities are of the same order of magnitude.

IV.THE L⁺L PRODUCTION CROSS SECTIONS

The matrix elements and cross-sections for the relevant subprocesses, V + L + L, are given in the Appendix. The total cross-sections are obtained by convoluting the subprocess cross sections with the appropriate photon (and/or Z) and quark structure functions and integrating over the two body phase space using M onte C arb techniques.

The cross-section for the V production of a pair of heavy charged leptons in inelastic pp collisions (with center of mass energy p = 0) is obtained by convoluting the cross-section of the V ! L⁺L subprocess, v, with the probabilities of noting the gauge bosons in the

protons as follow s.

Here V represents either a photon or a longitudinal or transverse degree of freedom of the Z boson. The inelastic component of the V spectrum from protons, $f_{V=p}^{inel}(x)$, is given by

In the above equation, the $f_{q=p} (x_2; Q^2)$ represent the quark structure functions for the proton [18], evaluated at the scale $Q^2 = \$=4$, \$ being the parton center of m ass energy squared. We sum over the contributions due to the u;d;c, and s quarks and antiquarks from the protons. The lower limit of integration in the above equations ensures that the V center of m ass energy is su cient for L ⁺ L production.

The cross-section for two photon L^+L production via elastic collisions of protons is obtained by folding the subprocess cross-section, , with the elastic component of the photon spectrum from the protons, $f_{=p}^{el}$.

The upper limits of integration in the above expression are given by $x_{max} = 1$ $2m_p = \frac{p}{s}$, where $p = \frac{1}{s}$ is the center of mass energy of the elastically colliding protons. The lower limit of integration x_{min} has the same signi cance as in the case of inelastic collisions. We have checked this calculation by using an alternative form of the photon spectrum from elastically colliding protons [19]. The cross sections obtained with this alternative form essentially agree with the results presented here using the Knichl form of W WA.

The cross sections for L^+L production via sem i-elastic collisions of protons, induced by and Z are obtained in a similar fashion by appropriately combining the two cases detailed above.

For comparison with the mechanisms considered here, we also present results for the two previously well known production mechanisms for L^+L_- , D rell-Y an and gluon fusion. The

D rell-Y an quark anti-quark annihilation proceeds via s-channel and Z exchange. The gluon fusion proceeds via a quark triangle diagram followed by Z boson or H iggs boson exchange. Expressions for these cross sections can be found in the literature [5,20]. The rates for the other possible processes of weak gauge boson fusion and annihilation are negligible com pared to the D rell-Y an and gluon fusion rates except for the case of very massive heavy leptons, [5] and will not be discussed further.

In our calculations we use $M_W = 80.22 \text{ GeV}$, $M_z = 91:19 \text{ GeV}$. In calculating the two photon production cross-sections we have taken into account the variation of the ne structure constant with the energy scale, e.g., we have chosen = 1=137 in the expressions for W eizsacker-W illiam s photon spectrum, and = 1=128 in the expressions for the subprocess cross-sections. The parameter s, used in the gluon fusion calculation, is evaluated at the two-bop level using its representation in the modil ed m inim al-subtraction (\overline{MS}) scheme [21], and using the value $\frac{(4)}{MS} = 0.19 \text{ GeV}$, consistent with the HMRS (Set B) parametrization. For the gluon fusion mechanism we assume three generations of quarks, with the top quark m ass set at 175 G eV. Results for the inclusion of a fourth generation of heavy quarks can be found in Refs. 2, 19. The Higgs boson m ass for our calculation is chosen to be 200 G eV. There is very little sensitivity to this parameter.

The total cross sections for L^+L production via two photon fusion as a function of the charged lepton m ass, are shown in Fig. 5 for the LHC center of m ass energy of 14 TeV. The dotted and upper solid curves represent respectively the cross sections due to gluon fusion and D rell-Y an m echanism s. The lower solid curve represents the total cross section for the inelastic process pp ! X ! L⁺L X. The dashed and dot-dashed curves show the corresponding cross-sections for the elastic and sem i-elastic cases respectively. The cross-sections for the three cases are comparable to each other over the m ass range of the charged lepton. However they are 2-3 orders of m agnitude sm aller than the D rell-Y an and gluon fusion cross sections.

Hence in general, production rates via two photon fusion at pp colliders are not com – petitive with production via quark or gluon fusion. Only the interesting event topology of

particle production through photon fusion for elastic and sem i-elastic pp collisions m ight o er a chance of distinguishing signals which are otherwise very di cult in a hadronically noisier environment. Both the elastic and sem i-elastic processes should yield clean events with the intact proton (s) continuing in the forward direction. However, the low event rates probably eliminate this as a viable process for L^+L^- discovery. Two recent publications [10] address sim ilar topics for two photon processes as discussed here, and reach essentially the sam e conclusions. D rees et al. point out the additional problem of multiple events at high luminosity; thus, the high luminosity necessary to achieve an interesting rate will destroy the clean liness of the signal.

We now turn to the L^+L production via Z fusion. In the Appendix, we present the matrix element squared for the Z subprocess, without summing over the Z boson polarization. This allows us to obtain separately the contributions from longitudinally and transversely polarized Z bosons. We also give an expression for the subprocess cross-section summed over Z boson polarizations in the Appendix.

For subprocess energies much greater than the Z boson mass the interactions between the longitudinally polarized Z boson and ferm ions can be derived in terms of an elective theory [22] in which z_L is the would be G oldstone boson of the broken SU (2)_L U (1)_Y model. Calculations are greatly simplied in the elective theory since the vector bosons are replaced by scalar bosons. Hence as an additional check on our exact calculation we have calculated the cross-section for the subprocess Z_L ! L^+L in the G oldstone boson approximation. The subprocess cross-section for longitudinal Z bosons dominates since the coupling of ferm ions to longitudinally polarized Z bosons is proportional to the large ferm ion mass in the elective Lagrangian, as given by D aw son [6]

Here l indicates the heavy charged lepton wave function and z_L that of the G oldstone boson. The subprocess cross-section is given in the Appendix. Indeed we nd good agreement between this approximate calculation and our results obtained from the exact calculation.

In Figs. 6 a, b we show respectively the L^+L^- production cross-sections via Z fusion at the LHC for inelastic and sem i-elastic pp collisions. We have used the non-leading D aw son form of the Z distribution function. For reference, the cross sections due to gluon fusion and D rell-Y an mechanism s are again shown as the dotted and upper solid curves, respectively. The dashed and dot-dashed curves represent, respectively, the separate contributions of longitudinally and transversely polarized Z bosons. The solid curve is the total cross section. The Z_T^- cross-section is smaller than that for Z_L^- and also decreases more rapidly with increasing m $_L$. For small values of m $_L^-$ the cross-sections for sem i-elastic pp collisions are smaller than those for inelastic collisions, but they become approximately equal form $_L^-$ 500 G eV.

Our results for Z production of heavy charged lepton are in disagreement with those of Eboli et al. [11] Those authors consider inelastic Z production in pp collisions using the leading logarithm ic result for the elective Z approximation, and using the G oldstone boson approximation for the subprocess cross-section. However, as has been pointed out in Ref. 6, they have chosen the Z_L coupling to quarks in the elective Lagrangian to be proportional to the vector coupling of Z bosons to quarks, whereas it should be proportional to the axial vector coupling. They not the transversely polarized Z boson cross-sections dominating the longitudinally polarized Z boson cross-section. W hile we agree that the Z_T lum inosity is larger than that for Z_L , we not that the Z_L ! L^+L cross-section dominates. As noted above we have good agreement between our exact calculation and the G oldstone boson approximation calculation for the Z_L subprocess.

One can see that the Z inelastic cross-sections are comparable to the inelastic cross-sections for small values of m_L . However the fusion cross-section falls o much more rapidly with increasing m_L compared to the Z fusion cross-section, and for larger values of m_L the Z cross-section is an order of magnitude larger than the cross-section. One may intuitively understand the relative magnitudes of the and Z cross-sections as follows. The ratio of the subprocess cross-sections for Z ! L^+L and ! L^+L for the same subprocess center of mass energy (i.e., same) is almost independent of but depends

only on m_L . The Z subprocess cross-section is approximately an order of magnitude larger than that for for m_L 200 G eV and is about two orders of magnitude larger for m_L 700 G eV. Since the Z dimensional luminosities in pp collisions are about an order of magnitude smaller than the dimensional luminosities for small, and approximately equal for 10², the relative magnitudes of the total cross-sections obtained in pp collisions follow.

The result is that each of the inelastic and sem i-elastic Z production cross sections for L^+L is within about an order of magnitude of the D rell-Y an and gluon fusion cross sections for large values of m_L, beyond m_L about 500 G eV in the inelastic case and som ew hat higher in the sem i-elastic case. For these large lepton m asses, the cross sections for the Z processes are down at the tenths of a fb level, so high lum inosity is again in portant. A one year integrated lum inosity of 100 fb⁻¹ provides about 20 pairs of 600 G eV leptons for each of the inelastic and sem i-elastic mechanism s.

We now discuss qualititatively the possible signatures for L^+L^- pair production at pp colliders via Z fusion and their potential backgrounds. We have discussed the production of L^+L^- so far in a relatively model-independent fashion. The production cross-sections for heavy charged leptons that are predicted within a large variety of models, are either given directly by the cross-section results presented here or can be obtained by a simple rescaling of these results. The decays for heavy charged leptons and their possible signatures depend how ever on other extra particles predicted within the model. Thus a model independent discussion of the observability of L^+L^- pairs is not possible. Previous work on detailed analysis of L^+L^- signal and backgrounds by Barger et. al. [2] and I. Hinchli e [24] assumed a sequential (4th generation) charged heavy lepton and its associated neutrino $_L$. For simplicity we consider the same model here in our discussion of the possible signatures. Depending on the decay mode of charged heavy leptons there can be three possible signatures which we discuss in turn.

If both charged heavy leptons decay leptonically, e.g. $L^+ ! _L l_1, L ! _L l_{p^0}$ (l; $l^0 = e$;), the signature would be an e^+e , or +, or e^- pair and m issing transverse

m on entum. The SM backgrounds in this case are: (a) pp ! Z ! (b) pp ! W ⁺W (c) pp ! ZZ (d) pp ! tt ! bW ⁺bW where the gauge bosons and leptons them selves decay leptonically. There are also additional backgrounds to be considered, the two-photon fusion processes at pp colliders, ! W ⁺W and ! 11. If one heavy lepton decays leptonically and the other hadronically, e.g. L⁺ ! $_{L}qq^{0}$, L ! $_{L}l_{1}$, the nal state consists of an electron or muon, m issing p_{T} and jets. The SM backgrounds for this signature are : (a) pp ! W + jets (b) pp ! W ⁺W (c) pp ! tt ! bW ⁺bW , and the process ! W ⁺W , where for the cases of W pair production, one W boson of the pair decays leptonically and the other hadronically. If both charged heavy leptons decay hadronically the signature is 4 jets and m issing p_{T} . The SM background in this case is pp ! Z + 4 jets, with Z ! .

D etailed M onte-C arlo simulations of the signals and backgrounds for these decay m odes of L, but corresponding to a di erent production m ode, in inelastic pp collisions, have been reported previously [2,24]. For the sem i-elastic Z fusion case, the signals corresponding to the various decay m odes of L considered above would include the additional tag of a single proton. In principle the unique topology of the sem i-elastic Z events could be exploited to observe the signal, for example by using forward spectrom eters. The results presented here are intended as an exploratory survey of the novel signatures that occur in photon and Z induced fusion processes at hadron colliders. D etailed con m ation of the observability of these signatures would require M onte-C arlo simulations of the signals and backgrounds, including considering the detector acceptance, and e ects such as overlapping events at high lum inosities.

V.CONCLUSIONS

We have evaluated the importance of hadron colliders as a source of and Z collisions by considering the production of charged heavy leptons in such colliders. While we have used the pair production of charged heavy leptons as a benchmark process, some of our results are of broader interest. In particular, we have presented and Z lum inosities for inelastic,

elastic, and sem i-elastic pp scattering. The lum inosities for longitudinally and transversely polarized Z bosons were given separately. These results can be used for the consideration of the production of other nal states via the and Z initiating subprocesses.

Our conclusions with respect to the two photon induced heavy lepton production are rather pessin istic, consistent with D rees et al. [10]. The total event rates for induced processes are not competitive with other dom inant production mechanisms, being down by a couple orders of magnitude. The novel mechanism of obtaining photons without one or both of the protons breaking up could, in principle, prove useful in con rm ing signals which are di cult to otherwise distinguish. However, the cross sections are probably too suppressed to exploit the topology of the elastic events.

On the other hand, we nd that Z production of heavy charged leptons overtakes production for lepton m asses above 100 G eV. It rises to within about an order of m agnitude of the dom inating D rell-Y an and gluon fusion processes for m_L of about 600 G eV. This is the same sort of behaviour as seen in H iggs boson production via the gluon and vector boson fusion m echanism s, where the vector boson fusion cross-section ultimately overtakes the gluon fusion cross-section for large H iggs m ass [23]. Hence the Z initiated processes should not be neglected. The inelastic and sem i-elastic processes togetherm ake up about 10 % of the total event rate for m_L of 600 G eV. The cleaner sem i-elastic production could in principle stand out as a distinguishable signal, how ever direct con m ation of that requires detailed detector simulation studies.

We present here expressions for the squared matrix elements and subprocess crosssections for L^+L pair production through and Z fusion.

A ssum ing that heavy charged leptons couple to the photon in the usual way, the sum m ed and averaged m atrix element squared for the 2 photon fusion subprocess is given by

where t and u refer to the exchanged momenta squared corresponding to the direct and crossed diagrams (Figs. 1 a, b) for the two photon subprocess, and the photon coupling is represented by $e^2 = 4$, with the value of the ne structure constant = 1=128 which is appropriate for high energy production processes. 

















