Z₃ TW ISTED CHIRAL CONDENSATES IN QCD AT FIN ITE TEM PERATURES

Abstract

It was recently observed in a lattice QCD measurement that the chiral condensate in the quenched approximation shows dramatically dimensional condensate in the quenched approximation shows dramatically dimensional behavior in the three Z₃-equivalent de-con ned phases. We argue that this phenomenon can be understood qualitatively as an elect of Z₃ twists on fermionic elds. Quarks under these Z₃-twists become elobal anyons and hence display dimenent thermodynamic properties. We further show that the lattice data can be roughly modeled by a Nambu-Jona-Lasinio type Lagrangian with a minimal coupling to a constant gauge eld A₀ = 2 nT=3 (with n = 0, 1), which arises naturally from the non-trivial phase of the Polyakov line.

I. IN TRODUCTION

Understanding chiral symmetry breaking and its restoration at nite temperatures in QCD is of great interest. M any lattice simulations have been performed to study the expected phase transitions [1]. However, the underlying dynamics responsible for these phenomena are still unclear. Hence, it is sometimes useful to explore regions of QCD parameters beyond their physical domain. One such e ort in lattice QCD is to study the fermionic G reens functions in the background dynamics of pure gauge elds. In such a study one ignores all the e ects of internal quark bops. At low temperatures no essential di erence is observed between such studies and those that take into account the e ects of quark bops. How ever, at nite temperatures these e ects can change the physics qualitatively. In the pure gauge theory there is a rst order phase transition between a con ned and a de-con ned phase signaled by a non-vanishing expectation value of the Polyakov line. This is related to a global Z₃ symmetry breaking [2]. On the other hand, inclusion ofm assless quarks breaks this global Z₃ symmetry explicitly and chiral symmetry restoration becomes relevant, with the chiral condensate as the order parameter. The precise nature of the chiral transition depends on the number of avors [3] appearing through internal quark bops.

Interestingly, in lattice QCD one can measure a quenched chiral condensate even after ignoring internal quark loops from the dynam ics. Such a condensate has been measured in the past near the de-con ning transition. A rst order transition was observed in the quenched chiral condensate at the de-con ning temperature [4]. However, no e orts were made to distinguish between the behavior of quarks in the three de-con ned phases labeled by an element of Z_3 . Recently, in an e ort to understand the e ects of internal quark loops near the chiral phase transition, this issue was revived by a careful and precise measurement of the quenched chiral condensate [5]. It was observed that, above the de-con ning transition, the chiral condensate crucially depends on the Z_3 phase in which the gauge dynam ics settles. Even the chiral symmetry restoration appears to occur at dimensition. In this article we present a qualitative understanding of the physics underlying these observations.

In a som ewhat di erent context the e ect of the boundary condition in the G ross-N eveu m odel, with one of the dimension compacties ed, was studied recently [6]. It was found there that the ferm ion, which obeys the usual antiperiodic boundary condition, becomes a global anyon when a non-trivial twist is introduced via a constant background gauge eld. The anyon interpretation is supported by an explicit decomposition of the ferm ion propagator into a sum over winding numbers in the compacties of the G ross-N eveu m odel become statistics transmutation the therm odynamic properties of the G ross-N eveu m odel become sensitive to the value of the twist. We suggest that a similar physical setting is realized in quenched QCD in the various de-con ned phases. The non-trivial phase of the Polyakov line provides a constant background gauge eld in the tem poral direction and turns quenched quarks into global anyons.

In section 2, we show that in QCD one can de ne a chiral condensate with a Z_3 twist in general. The usual chiral condensate is the one where the twist is zero. The other two are new quenched order parameters of chiral sym metry breaking. We then argue that the chiral condensates measured in [5] are related to these Z_3 twisted condensates in the quenched limit. In section 3, we elucidate the meaning of the Z_3 twisted chiral condensate by considering an

e ective action which governs these quenched observables. In section 4, we show that the qualitative features of the lattice data can be obtained by the N am bu-Jona-Lasin io m odel in the large N_c lim it, m inim ally coupled to the suggested constant gauge eld. In section 5, we present som e observations and conclusions.

II. Z $_{3}$ TW ISTED CHIRAL CONDENSATES

The chiral condensate in QCD is the order parameter for chiral symmetry breaking and is dened formally as

where D(A) = (0 i A) is the D irac operator and m_q is the quark mass and S_g is the gauge action. Z is the partition function. The above de nition can be made more precise on the lattice.

We now introduce a chiral condensate with a Z₃ twist , given by

where

with = 0; $\frac{2}{3}$ and T the temperature. The mass in the observable, m, is deliberately chosen to be distinct from the usual quark mass, m_q. Thus h i is a quenched observable and can be measured on the lattice even in the presence of dynam ical fermions. The physical content of this new observable will be elucidated shortly. Notice that D is simply the original D irac operator with the temporal gauge eld shifted by a phase of Z₃. Further note that h i = h i . We can show this by noting that D (A) and D (A) have the same spectra due to a charge conjugation symmetry. However, in general we will have h $\frac{1}{3}$ $\frac{6}{3}$ h $\frac{1}{3}$. This is related to the fact that fermions break the Z₃ symmetry.

In general, the dynam ical quarks in eq. (2), will always pick the phase in which the gauge eld distribution, fA g, m akes the expectation value of the Polyakov line P real and positive, i.e.

The gauge eld distribution of a Z_3 rotated phase would be fA g + T _i. Now the Polyakov line is given by $\frac{1}{2}P$ ij eⁱ. The relevant D irac operator for measuring the chiral condensate is D (A) de ned in eq. 3. Thus measuring the usual chiral condensate in the various Z_3 phases is naturally equivalent to measuring h⁻ i in the quenched limit of the de-con ned phase.

The e ect of similar terms on the therm odynamics has been studied in the past for simple local fermionic eld theories [6]. There it is argued that the term acts like a twist

in the boundary condition for the ferm ions and converts them into global anyons. This conversion then a lects the critical temperature dramatically. We suggest that the same physics also happens in the present context. We anticipate that, if we study h i as a function of the temperature, it is likely that the condensate with = 0 and $= \frac{2}{3}$ will behave dimension in the matricular if there is a phase transition in the model. In the matrix is quite likely that it will occur at dimension temperatures depending on a.

The above discussion then suggests that it is likely that at some tem perature in the decon ned phase $\overline{h}_{0}i = 0$ whereas $\overline{h}_{3} \in 0$, as observed in [5]. However, in the con ned phase the gauge dynam ics is Z_{3} symmetric in the quenched limit. The Z_{3} twist in this phase ceases to be meaningful, since the gauge eld ensemble is no longer clustered around any of the three values there. It is of course still possible to study the Z_{3} chiral condensates, as de ned in eq. 2, even in the presence a dynam ical quark mass m_{q} , because of the relative shift in the D irac operator in the observable and in the internal quark determ inant. In the presence of nite m_{q} the Z_{3} symmetry is broken and thus it is possible to track the three phases into the con ned phase and study their evolution towards the chiral limit. We do not know if such a study is physically relevant since the Z_{3} condensates are in general some quenched order parameters. In the remainder of this article we will be interested only in the quenched limit.

III.AN EFFECTIVE ACTION FOR THE $\ensuremath{\mathtt{Z}_3}\xspace$ TW ISTED CONDENSATES

In this section we suggest a local eld theory which governs the behavior of the Z_3 twisted chiral condensates. Form ally one can rewrite eq. (2), introducing ferm ionic () and bosonic () ghost elds in the spirit of [7],

This enlarged theory contains another chiral symmetry in the limit ! 0 for arbitrary real quark mass m_q. It is now obvious that the order parameter associated with this symmetry is \overline{h} i. One can then formally integrate over the quark elds, the ghost elds and the gauge elds A to generate an elective action for the elds. Thus

We have allowed for the possibility that the else ective action could depend on the tem perature through the couplings apart from the usual anti-periodic boundary conditions in the Euclidean time direction for the elds.

In general $S_{[n_q; \pi_n; T]}^{eff}(;)$ would be arbitrarily complicated and possibly contains nonlocal interactions. It seems hopeless to understand the full structure of the e ective action. However, it may be interesting to obtain some qualitative insight into the essential physics involved by studying a simpli ed model that is motivated phenom enologically and at the same time is tractable.

In the quenched lim it, the chiral symmetry between fermionic G reens functions is govemed only by the dynamics of the gauge elds. Non-perturbative gauge elds can in general produce chiral sym m etry breaking. One im m ediate consequence is that the quenched chiral condensate need not vanish. This feature, in principle, need not have any connection with con nem ent. Thus it is not unnatural to assume that, for some tem perature range, chiral sym m etry breaking happens even in the decon ned phase. Consequently we are led to study chiral sym m etry breaking in the absence of con nem ent. To this end, we assume that the elds is dominated by the lowest dimensional term,

with being some cuto scale specied later. Thus in this model the dependence enters only through the quadratic term shown in eq. 6. We expect this term to produce the di erence between the complex and the realphases as in [6].

A smentioned earlier, in the con ned phase there is no dimensioned between the various Z_3 twisted condensates. This is due to the Z_3 symmetry of the dynamics. Thus the elective action must have no know ledge of . This is in accordance with the fact that the expectation value of the Polyakov line is zero in the con ned phase, it is meaningless to include a term in the con ned phase. Here no attempt is made to construct an elective eld theory that describes the con nement physics also in a natural way. However, as long as we are interested only in a model for the chiral condensate, it may be suicient to drop the term from the elective action in the con ned phase. Additional elects of gauge dynamics are minicked by a temperature dependence of the coupling G (T). Further since the decon nement temperature.

IV . M O D E L IN G O F LATTICE D A TA

To have a sem i-quantitative understanding of the lattice data we start with the Lagrangian

or equivalently

Since this model is non-renorm alizable we consider a momentum cuto in the spatial momentum jpj=. We will solve the model in the large N_c limit and x the parameters in such a way that the model reproduces the lattice data obtained in [5] qualitatively. The elective potential in the large N_c limit is given by

The M atsubara sum can be carried out by the standard contour integral technique, yielding

with $E_p = \frac{q}{p^2 + (m + m)^2}$. In the above equation the anyon behavior is clearly displayed from the modi ed therm o-distribution, which interpolates smoothly from the Ferm i-D irac (= 0) to Bose-E instein (=) distributions.

The gap equation in the large N $_{\rm c}\,$ lim it reduces to

The fulle ective potential can be obtained after integrating eq. 12,

We refer the reader to [6] for a detailed discussion of the e ects of . Here we only try to model the lattice data of [5].

The parameters in the NJL model are xed in a conventional way [8]. Assuming the cuto to be about 1 GeV, we set =T = 5.5 and G (T)=(2²) = 1.163 for T < T_c in order to reproduce the chiral condensate at low temperatures with T_c around 200 M eV. The

term is dropped in the con ned phase for reasons already explained. The current quark mass on the lattice (m), and in the elective action (m) can in general be diment. Here we assume m = Z m. Then Z = 1:48 can be cleanly determined by thing the condensate (= 0) in the chirally symmetric phase. However, in order to reproduce the lattice data quantitatively a non-trivial T-dependence in G (T) needs to be introduced in the decon ned phase. The inst order nature of the de-con ning transition is incorporated by a jump in G (T). Then a simple quadratic form G (T)=(2)² = 1:385 $0:385(T=T_c)^2$ is su cient for T > T_c.




FIG.1. This graph shows the lattice data. The behavior of the condensate in the large $N_c N$ ambu-Jona-Lasinio model described in the text, produces the solid lines. The lattice data corresponds to m a = 0.001, where $a = \frac{1}{T N_t}$ with $N_t = 4$.

The lattice data corresponds to $N_t = 4$ and the lattice spacing is given by $a = \frac{1}{T N_t}$. Then the value of the condensate computed from the NJL model should be compared with the lattice data as

where is obtained from the solution of the gap equation.

The data from lattice simulations [9] and the model are given in gures 1 and 2.² It is seen there that the NJL model, with its parameters properly tuned, is capable of describing the data sem i-quantitatively. However, we would like to stress the fact that the

naloutcom e of the NJL m odel sensitively depends on the precise tem perature dependence. A small change in the num erical value of the coupling G can change the evolution of the com plex chiral condensate drastically. Thus in this regard we did not the model som ewhat unnatural, even though it is possible to capture the qualitative physics.

In gure 2 the current mass dependence of the condensate is compared between the model and the lattice data at $T=T_c = 1.067$. At this temperature the complex phase lattice

data begins to show interesting power law dependence, and the real phase lattice data is essentially linear [9]. The realphase data at $T = 1.067 T_c$ was used to x the constant Z and hence will agree well with the model. However, it is obvious that the present model will not reproduce the power law behavior of the real phase lattice data at lower tem peratures [5]. Sim ilarly we do not expect the model to reproduce the power law behavior of the com plex phase either. In fact we do not know if any universality arguments apply to these data. However, we do see the qualitative di erence between the real and the com plex phases.




FIG.2. This graph compares the behavior of the condensate as a function of the current quark m ass at $T = 1.067T_c$ in the large N_c N am bu-Jona-Lasinio m odel described in the text with the lattice data. This is approximately the temperature where a possible transition occurs in the complex phase. (r) refers to = 0 and (c) refers to = 2 = 3.

V.DISCUSSION AND CONCLUSIONS

In this work we have clari ed the precise meaning of the chiral order parameter considered in a recent lattice study. The observed Z_3 phase dependence of this order parameter in quenched QCD in the decon ned phase has been qualitatively explained. The relevant physical picture is that the non-trivial Z_3 twists in the tem poral boundary condition, due to the survival of expectation value of the Polyakov line, turn quarks into global anyons. The qualitative behavior of the lattice data can be modeled simply by a tem perature dependent NJL model with a minimal coupling to a constant gauge eld $A_0 = T$ with = 0 and 2 = 3.

For m = 0, the NJL model would predict a continuous phase transition when = 2 = 3, in addition to the jump associated with the storder de-con ning phase transition. The present lattice data are consistent with this prediction. The second transition

tem perature is estimated to be about 5 to 10 percent higher than the de-con ning transition tem perature.

As this work was being completed we received an article [10], which discusses the same issue along very similar lines using the NJL model. However, based on our calculation, we would like to point out that, on a quantitative level them odel does not reject one in portant feature of the gauge dynamics. It is clear from gure 1 that the lattice data for the complex phase evolves rapidly above T_c towards a possible second transition at about T = 1.07 (3) T_c . In the above model such a rapid evolution required very in tuning of the coupling G (T). Thus it is very likely that the gauge dynam ics is not naturally captured in thism odel. In fact the rapid evolution just mentioned is also seen in other physical quantities like the entropy density [11] in the same region. Thus an obvious direction to extend the present work, is to obtain a better model including the gauge dynam ics. This may help in understanding the reason for the rapid evolution seen just above T_c .

A swas suggested in section II, the Z_3 condensates as de ned by eq.2 can be studied even in the presence of small dynamical quark masses m_q . A squenched order parameters these may be measured in lattice simulations. However, more theoretical work would be necessary to see if they are interesting. Finally, in this article we have concentrated on the lattice data for SU (3) gauge theories. A similar discussion in the case of SU (2) leads to interesting possibilities since the de-con ming transition is second order in this case. Extensions to SU (N) with N > 3 may also be interesting and has been attempted in [10].
