Photoproduction of neutral pion pairs in the Coulomb eld of the nucleus

Abstract.

The total cross section for C oulom b photoproduction of neutral pion pairs in the reaction A! 0 0 A is estimated within the elective chiral lagrangian approach. The amplitude of 0 0 with one oshell photon is calculated at 0 0 in the momentum expansion; in addition, nuclear absorption is taken into account. Besides its experimental feasibility, the results of the calculation demonstrate that the reaction A! 0 A is a powerful source of information on the process! 0 close to threshold.

1. Introduction

The nucleus Coulomb interaction method is an eective approach to study in highenergy experiments the low-energy electromagnetic properties of pions in the process

! There are two possible ways to realize the Coulomb interaction method in experiment: the radiative scattering A! A of a pion on a nucleus and the photoproduction of pion pairs in the Coulomb eld of a nucleus A! A. The experiments under discussion are based on the fact that for su ciently small momentum transfers the interaction of high-energy particle with nuclei is extremely peripheral and thus dominated by scattering on the virtual photons of the Coulomb

eld of the nucleus. The reaction A! A allows to investigate the! process in the region $m^2 = (p_1 + p_2)^2 < 0$ and to measure the charged pion polarizability [1] at the point $m^2 = 0$, while the reaction A! A occurs in the region $m^2 = 4m^2$ close to threshold. In the case of charged pions the two reactions give complementary information about the process! in both the physical and the non-physical region. In the case of neutral pions the photoproduction of a neutral pion pair in the Coulomb eld of a nucleus provides a new source of the information on the process! 0 , which was measured in the electron-positron experiment by the Crystal Ball Collaboration [2] and is under active discussion in the context of the physical program me at DA NE [3].

The present theoretical interest in the elementary process ! 0 is caused both by experimental data [2] mentioned above and recent progress in Chiral Perturbation Theory (ChPT) [4] up to and including 0 (p⁶). The process

- ! 0 is very sensitive to the higher-order contributions in ChPT since the rst non-vanishing amplitude arises from meson loops at 0 (p 4) without counterterms. However, the one-loop amplitude at 0 (p 4) calculated in paper [5] does not describe the data even near threshold [6]. This is not surprising, as the analysis of the
- ! 0 am plitude based on dispersion relations [7] dem onstrates the importance of unitarity corrections corresponding to higher orders, next to 0 (p^4). In fact, the two-loop calculation at 0 (p^6) carried out in paper [8] gives a considerable improvement of the description within ChPT. For completeness we mention that there is also another consideration of ! 0 up to one-loop order corresponding to 0 (p^5) in the treatment of Generalized ChPT [9].

The contribution from the O (p^6) counterterm swas estimated in paper [8] y from the low-energy meson phenomenology with resonance exchange saturation. In papers [10, 11] the counterterms were weed as elective meson lagrangians with higher-order derivative terms obtained from the bosonization of Nambu {Jona-Lasinio model (NJL). The sensitivity of p^6 to higher-order corrections including Born

contributions from the e ective meson lagrangian at 0 (6) makes this process a valuable source of the experimental information essential for the test of bosonized chiral lagrangians at 0 (6).

In this paper we investigate the possibility of studying the process ! 000 near threshold in the photoproduction of neutral pion pairs in the Coulomb eld of a nucleus. For the 11rst time the reaction A ! A was considered in this context in paper [12] with a one-loop amplitude of ! 000 at 0 (p4). The total cross sections A ! A were estimated for energies of the incident photon at 20 GeV and 40 GeV for momentum transfer cuto s 5 MeV and 10 MeV, respectively. However, due to the large incident energy and small cuto , the nuclear absorption and the o shellness of the virtual photon from the nuclear Coulomb eld were not taken into account.

In this note, we extend and improve the previous calculation [12] in a consistent way: we presents results of a calculation of the nuclear Coulom b photoproduction of neutral pion pairs, where we include in the elementary amplitude ! 0 0 both o -shell corrections for the Coulom b virtual photon and contributions from ChPT up to 0 (p⁶), and where, in addition, nuclear structure and absorption are taken into account in the form factor for the nucleus.

2. Coulom b photoproduction

The photoproduction of a 0 pair in the Coulomb eld of a nucleus is schem atically described by the diagram in gure 1. The virtual photon (q_2) for the interaction of the incident real photon with the stationary Coulomb eld of the nucleus has zero energy and transfers only momentum: $q_2 = (0; q_2)$. Then the amplitude of the reaction $(q_1)A$! (p_1) $(p_2)A$ has the form

where M $_{\rm A}$ and Z are, respectively, the mass and charge of the nucleus. In (1), the nuclear form factor $F_{\rm A}$ ($q_{\rm 2t};q_{\rm 2l}$), which includes nuclear absorption, depends on transverse and longitudinal components of the momentum transfer $q_{\rm 2}$ measured relative to the momentum $q_{\rm 1}$ of the incident photon ($F_{\rm A}$ is normalized to $F_{\rm A}$ (0;0) = 1). T $_{\rm 0}^{(1)}$ is the tensor component of the amplitude of the process ($q_{\rm 1}$) ($q_{\rm 2}$)!

where E_i and p_i (i=1;2) and " are the energies and m omenta of the pions and the energy of incident real photon, respectively. For large energies of the incident real photon and for smallm omentum transfers jq_2 jto the recoil nucleus and neglecting the o shellness of the Coulomb photon and nuclear corrections, the method of equivalent photons [13] allows us to relate the dierential cross section for photoproduction of pion pairs on nuclei to the total cross section for the process!

In this lim it equation (3) enables us to extract model-independent inform ation on the process! from the experimental data on the nuclear C oulomb photoproduction of pion pairs. For a more general kinematics, the nuclear form factor and the oshellness of the C oulomb photon have to be taken into account, however.

The nuclear form factor $F_A(q_{t};q_{2l})$ in (1) can be estimated in the same approximation as in paper [14] since the amplitude of Coulomb photoproduction on a single proton at small q_{t} is { upon evaluating (2) { proportional to q_{t} :

In the approach of paper [14] the nucleus is treated as a completely absorbing sphere, with the form factor

where R is the radius of the nucleus, and J_n and K_n (n = 0;1) are Bessel functions. In our estimates R is chosen to be R = $1.12A^{1=3}$ fm, where A is atom ic weight of a nucleus. The rst two terms in (4) arise from the integration over the three-dimensional space outside a cylinder of radius R of the nucleus. They reject the assumption, that the nucleus is completely black for the outgoing pions for impact parameters b R, resulting in a cut (b) R), in the projection. This drastic assumption is mediated by the correction term F_A (q;q), which arises from the

integration over the three-dim ensional cylinder behind the nucleus and corresponds to the interaction of photons with the nuclear Coulomb eld after passing through the nucleus.

In general, the integrations above can be done only numerically. However, when both (q_1R) and (q_2R) are small compared to unity, the correction F_A $(q_2;q_1)$ can conveniently be expanded to obtain

3. Chiral lagrangians

The calculation of the amplitude of ! 0 at 0 (p^{6}) of the momentum expansion of ChPT involves tree-level, one-loop and two-loop diagrams of a chiral excive lagrangian. The excive meson lagrangian at 0 (p^{6}) can be written in the nonlinear parameterization of chiral SU (2) SU (2) symmetry as

The e ective meson Lagrangian of O (β) is presented in the general form with structure coe cients L_i and H_i introduced by G asser and Leutwyler in paper [4],

where F = 0 A 0 a is the standard electrom agnetic eld strength tensor, and $U_0 = \exp(i'_0 = F_0)$, $i'_0 = \operatorname{diag}(0)$. The lagrangian of equation (8) can be obtained from the most general representation of the full lagrangian of paper [17].

The structure coe cients of the O (p^4) and O (p^6) chiral lagrangians of equations (7) and (8) can be xed either from low-energy meson phenomenology, as in papers [4, 8], or from the bosonization of NJL-type e ective quark models (see papers [15, 16, 10, 11] and references therein).

4. Amplitudes of ! 00

In general, the prediction for the Born amplitude of ! 0 of at 0 (p^6) involves eight structure coe cients d_i of the lagrangian (8). In the NJL model only the structure constants d_1 , d_2 , d_3 get nonzero values and contribute to the amplitude:

In our approach UV divergences, resulting from meson loops at 0 (p^6), are separated using the superpropagator regularization method [18], which is particularly well-suited for the treatment of loops in nonlinear chiral theories. The result is equivalent to the dimensional regularization technique used in paper [8], the dimension that the scale parameter is no longer arbitrary but xed by the inherent scale \sim of the chiral theory, namely, \sim = 4 F₀. For comparison of these two methods, the constants from the UV divergences in the dimensional regularization have to be replaced by a nite term using the substitution

It should be stressed that additional two-loop diagrams, such as box diagrams and acnode graphs, which cannot be evaluated analytically, can be neglected: the numerical estimates in paper [8] indicate the smallness of their contributions in the photoproduction process under consideration.

5. Num erical estim ates and conclusion

M onte Carlo techniques were used to compute the total cross sections for the photoproduction of 0 -pairs in the Coulomb eld of the carbon (Z = 6) and silicon nuclei (Z = 14). It is important to note that for a momentum transfer cuto q_{1ax} $p_{2} p_{1ax}$ ", the elective mass of system varies in the range p_{2ax} p_{2ax} .

The dependence of the total cross section of the reaction A! 0 0 A on the momentum transfer cuto q_{iax} for dierent energies "of the incident real photon is shown in gures 2 and 3. (In the calculation, the additional cuto m 700 MeV was used, corresponding to the range of validity of the chiral theory.) In gure 2 we demonstrate explicitly the in uence of the nuclear form factor: our numerical estimates indicate that the nuclear elects are mainly saturated by the contribution of the two rst terms of equation (4), while the correction F_A does not exceed 10%. For our numerical estimates we used for the parameters L_i and L_i the values from (14) and Table 1 of paper [11] obtained from the NJL model. These values include the resonance-exchange contributions electively taken into account by integrating out the vector, axial-vector and scalar degrees of freedom. Moreover, for numerical comparison with the phenomenological approach to $L_i = 0.0$, we used the structure constants L_i and $L_i = 0.0$ or responding to Tables 1 and 2 of paper [8]. The results of our calculations with the parameters of paper [8] are also shown in quite 2.

The main background for the Coulomb photoproduction of $\,^0$ pairs is the double pion photoproduction reaction on the nucleon $\,N$! $\,^0$ N via the baryon

resonance exchange mechanism [19, 20]. In the photon energy region near " = 1 GeV the total cross sections of the reactions p! 0 0 p and n! 0 0 n are dominated by diagram s in gure 4 with (1232)-isobar and resonance N (1520) [21]. K roll-R udem an diagram dominating in other isospin channels and meson exchange diagram s do not contribute to the photoproduction of 0 0 pairs. The contributions of diagram s j, l, and n of gure 4 to the reaction A! 0 0 A can be canceled by choosing an isoscalar target because of opposite signs of the corresponding am plitudes on the proton and neutron. The amplitude of diagram p in gure 4 is proportional to the dierence of the coupling constants (0 0) (see paper [21] for more details). The corresponding contribution to the process A! 0 0 A on the isoscalar target proves to be also suppressed due to the fact that

The e ect of such self-cancellation of diagrams j, l, n and p from gure 4 is demonstrated in gure 5 where we present the results of our calculation of the total cross section of the double pion photoproduction reaction on the proton, neutron and on the system (proton + neutron). Numerically our calculations are in a good agreement with the results of paper [21] and in a reasonable agreement with the recent experimental data [22].

In gure 6 we also show the photon energy dependence of the total cross sections for the coherent double pion photoproduction on the carbon and silicon nuclei (isoscalar targets) calculated with the Bom nuclear electrom agnetic form factor with sym metrized Ferm i-density [23]:

and the following values of radius of the nucleus R and impact parameter b were used: R = 2214 fm, b = 0.488 fm | for carbon, and R = 3.085 fm, b = 0.563 fm | for silicon. Our results for tot (C^{12}) agree with recent estimates [24].

To estimate the contribution of the reaction N ! 0 N to this part of the phase space which corresponds to the cuto s introduced above for the Coulomb photoproduction of 0 pairs, the additional cuto smust be also taken into account when M onte Carlo simulating the background: m $700 \, \text{M eV}$ and $\frac{p}{\text{t}}$ q_{ax} , where $t_N = (p_1 \ p_2)^2$, p_1 and p_2 are the momenta of nucleon in the initial and nal states, respectively. The photon energy dependence of the cross sections for

the carbon and silicon targets calculated with the cuto s are shown in gure 6.00 ur estimates of the N ! 0 0 N background have shown that in the case of an isoscalar target it is strongly suppressed in the energy and momentum transfer regions under discussion. A coording to the symmetry properties of the background coherent reaction A ! 0 0 A on isoscalar nuclei [24], the two 0 mesons prefer to propagate together in the CMS. The Monte-Carlo simulation shows that the additional suppression of the backgraund to the level lower than the Coulomb photoproduction can be easily achieved using some angle cuto s. To extract the signal of Coulomb photoproduction is possible in the experiment where a silicon detector is used as a sensitive target to develop a trigger on the nucleus recoil momentum.

Sum marizing, we have found that for energies of the incident photon " 4 GeV and form omentum transfers $jq_2 j 200 \text{ MeV}$, 000 pairs with 2m m 700M eV in the reaction A ! 000 A are produced with a cross section of typically 40 pb and 120 pb for carbon and silicon nuclei, respectively. Our results demonstrate that this reaction can be experimentally investigated with presently available photon beams as a new source of the low-energy data on the process! 0000 GeV




Figure 1. Photoproduction of pion pairs in the Coulomb eld of a nucleus.




Figure 2. Dependence of the A! 0 A cross section on the momentum transfer cuto q_{max} for the energy " = 4 GeV of the incident photon. Compared are: L_{i} , d_{i} from the bosonization of the NJL model ([11], full curves) and from phenomenology ([8], dash-dotted curves), without and with a nuclear form factor (indicated by (1) and (2)).




Figure 3.D ependence of the A! 0 0 A cross section on the m cm entum transfer cuto $q_{m \, ax}$ for di erent photon energies, with parameters L_{i} and d_{i} from the NJL model [11].




Figure 4.D om inating Feynm an diagram s for the p! 0 ^{0}p and n! 0 ^{0}n .




Figure 5. Total cross sections of the reactions p! 0 0p (full curve) and n! 0 0n (dashed curve) calculated in the fram ework of baryon resonance model [21] with diagram s of gure 4. Dash-dotted curve corresponds to the total cross section for the sum of the amplitudes on the proton and neutron. The experimental points for the reaction p! 0p were measured at DA NE [22].




Figure 6. Total cross sections of the double pion photoproduction reaction ($_{tot}$) and cross sections calculated with the cuto s p $_{t_{N}}$ 150 M eV and m 700 M eV ($_{cut}$) for coherent processes on the carbon (dashed curve) and silicon nuclei (full curve).
