Abstract

Classical transport theory is used to study the response of a non-Abelian plasm a at zero tem perature and high chem ical potential to weak color electrom agnetic elds. In this article the parallelism between the transport phenomena occurring in a non-Abelian plasm a at high temperature and high density is stressed. Particularly, it is shown that at high densities it is also possible to relate the transport equations to the zero-curvature condition of a Chern-Sim ons theory in three dimensions, even when quarks are not considered ultrarelativistic. The induced color current in the cold plasm a can be expressed as an average over angles, which represent the directions of the velocity vectors of quarks having Ferm i energy. From this color current it is possible to compute n-point gluonic amplitudes, with arbitrary n. It is argued that these am plitudes are the sam e as the ones com puted in the high chem ical potential lim it of QCD, that are then called hard dense loops. The agreem ent between the two di erent form alism s is checked by com puting the polarization tensor of QED due to nite density e ects in the high density lim it.

I. IN TRODUCTION

Quantum Chromodynamics (QCD) undergoes a phase transition at high temperature and/or high density [1]. Above a critical temperature and critical chemical potential, quarks and gluons are no longer con ned. Those extrem e regimes are expected to be found in nature in some cosm ological and astrophysical settings (e.g., in the interior of neutron stars) or in heavy ion collisions. These are the regimes of QCD that we are going to discuss here.

As is well known now, naive perturbative analysis of high temperature QCD fails completely. This was realized when physical quantities, such as the gluonic damping rate, were found to be gauge dependent when computed following the standard rules of quantum eld theories at nite temperature. The connection between expanding in bops and expanding in the gauge coupling constant g is not valid in this regime. As was realized by B raaten and P isarski [2], as well as by Frenkel and Taylor [3], there are one-bop corrections, the hard them alloops (HTLs), which are as in portant as tree amplitudes, and they have to be resummed and included consistently in all computations to non-trivial order in g. Those hard them alloops arise only for soft externalmomenta (gT) and hard internal bop momentum (T), where g 1, and T denotes the plasm a temperature. There is an in nite set of HTLs which possess very interesting properties, such as obeying QED -like W ard identities and being gauge independent [3], [4].

The hard therm alloop resum mation techniques that were proposed in [2] were successful in providing one-bop gauge independent physical answers. Much related work has been done since their discovery (see ref. [5], [6] for a review and references), but here we shallonly review di erent approaches to HTLs.

Taylor and W ong [7] were able to construct an elective action for hard therm alloops just by solving the gauge invariance condition in posed on that elective action. E fraty and N air [8], [9] have related that condition to the zero curvature equation of a Chem-Sim ons theory in (2+1) dimensional space at zero temperature, providing therefore a non-therm all fram ework to study a therm all elect. This identication has been used by Jackiw and Nair [10] to derive a non-Abelian generalization of the Kubo form ula.

O ther derivations of the e ective action of hard them al loops can be found in the literature. B laizot and Iancu [11] could extract the hard them al loop e ective action by studying the truncated Schwinger-D yson hierarchy of equations, after performing a consistent expansion in the gauge coupling constant and obtaining quantum kinetic equations for the QCD induced color current. Jackiw, Liu and Lucchesi [12] have also shown that HTLs can be derived from the Comwall-Jackiw-Tom boulis composite e ective action [13], after requiring its stationarity.

A di erent derivation of the e ective action of HTLs has been given in [14], which doesn't make use of quantum eld theory, as opposed to all previous approaches. Hard therm al e ects are exclusively due to therm al uctuations, and that is why a classical form alism to describe them was developed in [14]. Just by writing the classical transport equations for non-Abelian particles [15], and using an approximation scheme that respects the non-Abelian gauge symmetry of the transport equations, the elective action of the in nite set of HTLs of QCD could be found.

A similar situation may be expected to arise for QCD at high density and zero tem per-

ature [16]. A ctually, HTLs were also studied when a chem ical potential was included for quarks, and it was concluded that the only e ect of the chem ical potential was modifying the D ebye mass by a term proportional to the chem ical potential [17], [18]. Therefore, at very high density or chem ical potential and zero tem perature, one also may expect that naive one-loop com putations are incom plete, as one-loop diagram swith soft (g) external m om enta, and quarks running inside the loop with Ferm i energy, are com parable to tree am plitudes, and therefore they would have to be resummed. We shall call those diagram s hard dense loops (HDLs) in analogy to the therm alcase.

The purpose of this article is to give a derivation of the hard dense loops of gluonic amplitudes of QCD by using the classical transport form alism. We expect that quantum eld computations of QCD at high chem ical potential will reproduce the transport results, exactly as happens in the high tem perature case, although we do not attem pt here to check com plete agreem ent between these two di erent form alism s.

A lthough we study only gluonic amplitudes in this article, it should be expected that hard dense loops also arise for Feynm an diagram swith external quark legs. We do no take into consideration those diagram s in the present article, and refer to a recent publication [19] which considers the one-loop self-energy of the electron for QED at nite density for those kinds of HDLs.

We have structured this article as follows. In Section II we review brie y the classical transport theory for a non-Abelian plasm a. In Subsection III A we study how a cold quark plasm a initially in equilibrium reacts to weak external color electrom agnetic elds, and write the transport equation that the induced color current density obeys. The parallelism between the high tem perature and high density cases is clearly established, and we also comment about the connection between the transport equation in momentum space, using recent results of ref. [20]. In Subsection III C we give the polarization tensor in the quark plasm a, and prescribe how to derive higher-order point am plitudes. A s a check of the agreem ent between the transport approach and the high chemical potential limit of QCD, we compute the polarization tensor of QED due to nite density e ects in Section IV, and from it we extract the HDL corresponding to that graph, which coincides with the one of QCD, up to some color factors. C on plete agreem ent is found between the two di erent computations. On this result, we base our expectation that com plete agreem ent for higher n-point gluonic am plitudes should also be true. Finally, we present our conclusions.

II.CLASSICAL TRANSPORT THEORY FOR A NON-ABELIAN PLASMA

The classical transport theory for the QCD plasm a was developed in [15] and further studied in [14], and here we will brie y review it. Consider a particle bearing a non-Abelian SU (N) color charge Q^a ; a = 1; ...; N² 1, traversing a worldline \hat{x} (). The W ong equations [21] describe the dynamical evolution of the variables x , p and Q^a (we neglect here the e ect of spin):

where f_{abc} are the structure constants of the group, F_a denotes the eld strength, g is the coupling constant, and we set $c = h = k_B = 1$ henceforth.

The main di erence between the equations of electrom agnetism and the W ong equations, apart from their intrinsic non-A belian structure, com es from the fact that color charges precess in color space, and therefore they are dynam ical variables. Equation (2.1c) guarantees that the color current associated to each colored particle,

where $(\hat{x}; \hat{p}; \hat{Q}^{a})$ are solutions of the equations of motion, is covariantly conserved

therefore preserving the consistency of the theory.

The usual (x;p) phase-space is thus enlarged to (x;p;Q) by including color degrees of freedom for colored particles. Physical constraints are enforced by inserting delta-functions in the phase-space volume element dx dP dQ. The momentum measure

guarantees positivity of the energy and on-shell evolution. The color charge m easure enforces the conservation of the group invariants, e.g., for SU (3),

where the constants q_2 and q_3 x the values of the C asim irs and d_{abc} are the totally symmetric group constants. The color charges which now span the phase-space are dependent variables. These can be form ally related to a set of independent phase-space D arboux variables [14]. For the sake of simplicity, we will use the standard color charges.

The one-particle distribution function f(x;p;Q) denotes the probability for noting the particle in the state (x;p;Q). In the collisionless case, it evolves in time via a transport equation $\frac{df}{d} = 0$. Using the equations of motion (2.1), it becomes the Boltzmann equation [15]

A complete, self-consistent set of non-A belian V lasov equations for the distribution function and the mean color eld is obtained by augmenting the Boltzmann equation with the Yang-M ills equations:

where the color current j a (x) for each particle species is computed from the corresponding distribution function as

Notice that if the particle's trajectory in phase-space would be known exactly, then Eq. (2.8) could be expressed as in Eq. (2.2). Furtherm ore, the color current (2.8) is covariantly conserved, as can be shown by using the Boltzm ann equation [14].

The W ong equations (2.1) are invariant under the nite gauge transform ations (in m atrix notation) (2.1)

It can be shown [14] that the Boltzmann equation (2.6) is invariant under the above gauge transformation if the distribution function behaves as a scalar

To check this statement it is important to note that under a gauge transformation the derivatives appearing in the Boltzmann equation (2.6) transform as:

that is, they are not gauge invariant by them selves. Only the speci c combination of the spacial and color derivatives that appears in (2.6) is gauge invariant.

The color current (2.8) transform s under (2.9) as a gauge covariant vector:

This is due to the gauge invariance of the phase-space measure and to the transform ation properties of ${\tt f}$.

III. IN DUCED COLOR CURRENT IN A COLD QUARK PLASMA

A. Transport equation for the color current

In this section we study soft disturbances of a completely degenerate quark plasma. We consider a quark plasma at zero temperature and nite density which is initially in equilibrium . In the absence of a net color eld, and assuming isotropy and color neutrality, the equilibrium distribution function for this system is, up to a normalization constant,

where is the step function, and is the chemical potential. That is, all particle states are occupied with occupancy number one up to the Fermi energy $p_0 = .$

Now we study how the quark plasm a reacts to weak external color electrom agnetic elds. We consider that the chemical potential is large >> $_{c}$, where $_{c}$ is the critical chemical potential, while the color elds are soft or of the scale order F = g^{2} , where g is the coupling constant which is assumed to be small. The distribution function can be expanded in powers of g as:

Notice that a complete linearization of the equation in A^a would break the gauge invariance of the transport equation, which is preserved in this approximation. But notice as well that this approximation tells us that $f^{(1)}$ also carries a g-dependence.

We can get the equation that the color current density J_a (x;p) obeys by multiplying (3.3) by p and Q_a and then integrating over the color charges. For quarks in the fundam ental representation

The total induced current density can be obtained after sum m ing over the di erent contributions due to di erent quark avors. In order to simplify the notation we will not write the quark avor index in the color current, chem ical potentials, m asses, etc., and it should be understood that a sum over quark avors is to be taken in all nalform ulas.

From Eq. (3.6) we see that only quarks which are on the Ferm i surface contribute to the induced color current in the plasm a. Quarks which are inside the Ferm i sea are blocked to react to the presence of external elds due to the Pauli exclusion principle. Furtherm ore, the plasm a only responds to the presence of external color electric elds, and that is why only those get a screening mass in this approach.

In order to solve (3.6), we rst divide the equation by p_0 . Then we integrate it over p_0 and \dot{p} j using the momentum measure dP (2.4). Due to the delta function in the momentum measure and the delta function in the rhsofEq. (3.6), J_a (x;p) is only non-vanishing when $p_0 = \frac{q}{\dot{p} \cdot f + m^2} = .$ Then we can write Eq. (3.6) as

Equation (3.7) has the same structure as the transport equation that the induced color density quantity $J_a^{(T)}$ (x;V) in a softly perturbed hot quark-gluon plasm a obeys [14]

where $m_D^2 = g^2 T^2 (N + N_f = 2) = 3$ is the D ebye m ass squared for a SU (N) non-A belian group, with N_f avors of quarks, and V is a light-like four vector.

Equations (3.7) and (3.11) exhibit a similar structure, although they correspond to two di erent physical situations. In the case of a hot quark-qluon plasm a the contribution to the induced color current comes from both quarks and gluons which are therm alized at a tem perature T. This is released in the coe cient of the r.h.s. of (3.11), the Debye m ass squared. For very high tem peratures, we expect that quarks in the plasm a move very fast, and it is a good approximation to consider that their velocities are ultrarelativistic, as long m, where m is the quark mass, which is then neglected. G luons travel at light as T velocities, how ever, without any approximation. These are the reasons why the vector V in Eq. (3.11) is a light-like four vector. In the zero temperature quark plasm a that we are considering here there are no real gluons, and that is why they do not contribute to the induced color current. Furtherm ore, only quarks with Ferm i energy contribute to that current. For very large chem ical potential, it can be a good approximation to neglect quark m. If quark masses are neglected, then $p_F = ,$ and Eq. (3.7) coincides masses if with Eq. (3.11), except for the the factors m_D^2 and M^2 . We have decided, however, to keep corrections due to quark masses, which is justiled if > m g. Therefore v is not a light-like vector in this more general situation where we are considering massive quarks.

Before solving Eq. (3.7) we would like to comment about the connection between this transport problem and the Chern-Simons eikonal. E fraty and Nair [8], [9] have shown

that the gauge invariance condition for the generating functional of hard them all bops $_{\rm H\,T\,L}$ of QCD can be form ally related to the zero curvature condition of a Chem-Simons theory in a (2+1) dimensional space-time at zero temperature. Furthermore, it has been shown that this condition can be obtained from the transport equation (3.11) after assuming $J_{a}^{(T)}(x) = -\frac{_{\rm H\,T\,L}\,^{\rm A\,I}}{_{\rm A\,^{\rm a}}(x)}$. The same identications can be done for the cold quark plasma, after assuming that the induced color current can be obtained from a generating functional. The same esteps that were necessary to show that identication for the thermal problem can be repeated here with the only main difference that v is not a light-like vector, when quark masses are not neglected.

For completeness we present that identication below. We rest de ne a new current density

which corresponds to the zero curvature condition of a Chem-Sim ons theory in (2+1) Euclidean dimensional space-time, in the gauge $A_0 = 0$.

Solutions of Eq. (3.17) are provided by the Chem-Sim ons eikonal and were studied long ago [22]. The generating functional of the induced color current in a cold quark plasm a can then be expressed in terms of the Chem-Sim ons eikonal, exactly as in the case of the hot quark-gluon plasm a.

In spite of the very interesting connection between these, in principle, unrelated problems, we will not pursue the Chem-Sim ons approach to the transport equations in the remaining part of this article.

B.Solution to the transport equation

Equation (3.7) can be solved after inverting the v D operator and imposing proper boundary conditions. Then the solution of (3.7) is expressed in terms of link operators [7], [11]. In this Subsection, we prefer to solve the transport equation by going to momentum space exactly as has been done for Eq. (3.11) in ref. [20]. Writing

The color current is then expressed as an average over the three dimensional unit vector v, which represents the directions of the velocity vectors of quarks with Fermi energy.

It should be possible to construct a generating functional $_{\rm H\,D\,L}$ that generates this current by solving

It is rst required to check that J_a (x) obeys integrability conditions, as has been done in ref. [7] for the massless and therm alcase.

C.Polarization Tensor

The imaginary part of the polarization tensor describes damping in the quark plasma, explicitly:

Our result of the polarization tensor agrees with the one computed in ref. [23] using classical transport theory for a quark-gluon plasm a at nite tem perature and baryon density in the zero tem perature limit.

Notice that if quark masses are neglected, then $p_F = ,$ and then (3.26) reduces to the same polarization tensor as the one found in a hot quark-gluon plasma [15], [23], [14], with a dimension screening mass.

where the delta function on the r.h.s. of (3.31) accounts for conservation of m om entum, and permutations of indices and m om entum have to be taken.

Due to the fact that the induced color current can be expressed as an in nite power series in the gauge eld A^a , it is obvious that there are n-point gluonic amplitudes, with arbitrary n, from 2 to 1 . All these gluonic amplitudes describe the polarizability properties of the non-Abelian plasma.

IV. THE POLARIZATION TENSOR OF QED AT FINITE DENSITY

In this Section we present the computation of the polarization tensor of QED due to the presence of a background density of electrons, and from it we extract the HDL corresponding to that am plitude in the massless case. This computation has been previously performed by several authors in Euclidean space-time, see ref. [24], [25], [26], [27], and also [28] and [29] for the non-relativistic case. Here we review how this computation is performed in M inkowski space-time when retarded boundary conditions are imposed. We not it more appropriate to carry out this computation in M inkowski space-time to obtain the correct analytic properties of the retarded polarization tensor.

In the presence of a nite density of electrons the usual de nition of creation and annihilation operators for particles and \holes", or antiparticles, of the vacuum has to be modiled [29]. The ground state $j_0 >$ of the system is constituted by the Ferm i sea, that is, by electrons occupying all particle states according to the Pauli exclusion principle up to the Ferm i energy $p_0 =$. Then one de nes a creation operator b^y (p) that acting on the ground

state creates one particle with energy $p_0 > ,$ and the creation operator d^y (p), for $p_0 < ,$ which creates a \hole", which m ay be interpreted as the absence of one electron in the Ferm i sea. The corresponding particle and hole destruction operators annihilate the ground state

since the ground state doesn't contain electrons with energies above the Ferm i energy or holes" inside the Ferm i sea.

The usual averages of products of creation and annihilation operators that are required to compute Feynm an amplitudes are then modiled from their vacuum values, explicitly,

Then one can compute the Feynm an propagator to get [29], [5]

In order to compute the polarization tensor of QED in the presence of a background density of electrons, the propagator (4.3) is needed. Retarded boundary conditions are taken into account by introducing convergence factors e^{x_0} , e^{y_0} , with $! 0^+$, as needed when going from con guration to momentum space (see ref. [9] and [10] for explicit details). Taking that into account, we nd for the chem ical potential dependent part of the retarded polarization tensor in the massless case

V.CONCLUSIONS

In this paper we have used classical transport theory to study the response of a completely degenerate non-A belian plasm a at zero tem perature to weak color electrom agnetic elds. We have used an approximation scheme for the classical transport equations that respects their non-A belian gauge symmetry, and from it we have obtained the induced color current in the non-A belian plasm a.

The study of the transport phenom ena occurring at high density in a quark plasm a that we have carried out here is quite sim ilar to the one that was done in [14] for a QCD plasm a at high tem perature, and we direct the reader to consult that reference. Throughout this paper we have stressed the parallelism that these two di erent problem s exhibit, as well as their di erences.

Both at high tem perature and high density, the color constituents of the non-Abelian plasm a are not con ned, and that is why one can model color degrees of freedom classically.

The transport equations obeyed by the induced color current for a non-A belian plasm a at high temperature and at high density present a similar structure. If quark m assess are neglected, then the two transport equations are essentially the same, except for the following. At high temperature T, both quarks and gluons which are therm alized at the temperature T contribute to the induced color current in the plasma. At high demnical potential, only quarks on the Ferm i surface contribute to that current, as there are no real gluons at zero temperature. Then, in that situation, the only difference between the two transport equations comes from the screening m asses squared which are m $_{\rm D}^2 = g^2 T^2 (N + N_{\rm f}=2)=3$ and M $^2 = g^2 N_{\rm f}^2 = 2^2$, respectively, for a SU (N) theory with N f avors of quarks (and assuming that for all quark avors f =).

We have decided to keep corrections due to quark masses in the present study. The solution to the transport equation can be expressed in terms of an average of a threedimensional unit vector v, which represents the directions of the velocity vectors of quarks which have Ferm i energy.

We have also shown that the solution of the transport equation can be expressed in terms of the Chem-Sim ons eikonal, even form assive quarks. Even though one cannot de ne natural light-cone coordinates when quarks are not consider ultrarelativistic, we have seen that it is still possible to relate the transport equation to the zero-curvature condition of a Chem-Sim ons theory in (2+1) Euclidean space-time. The transport equation only depends on the projections of the vector gauge elds over the four vectors v and v de ned in Subsection IIIA, and this is enough to de nea two dimensional plane where the zero-curvature condition of a Chem-Sim ons theory can be recognized, after proper identic cations.

We have presented a system atic way of computing n-point gluonic amplitudes using the solution of the classical transport equation, and we claim that these results should agree with the high density limit of a quantum eld theory approach. Complete agreement is found for the polarization tensor (n = 2) in the massless case, and complete agreement should be expected for higher n-point functions, although we have not check this statement, not are we aware of the computation of those amplitudes in the literature.

Therefore, we claim that a B raaten-P isarski resum m ation procedure should also be used in QCD with high chemical potential, as was generally expected, although a more detailed quantum eld theoretical study should be carried out to see exactly how this resum m ation is implemented. We think that it is interesting to have this alternative computation of HDLs, specially due to the simplicity and transparent physical interpretation of the classical transport form alism.

Finally, we should mention that although the response theory of the high temperature limit (at zero chemical potential) and the high chemical potential limit (at zero temperature) of QCD seem almost identical, and one could naively conclude that in both situations static color electric elds are exponentially damped (at least at leading order), this is not so. K apusta and Toimela [30] have pointed out that the static potential between two static charges in a plasma at zero temperature becomes oscillatory and vanishes as a power at large distances due to the existence of a sharp Ferm i surface. This elect was known as Friedel oscillation in non-relativistic quantum theory [29].

A further study of the high density lim it of QCD should be carried out, and we postpone that study to a further publication.
