## Vacuum Decay along

### Supersym m etric F lat D irections

#### Abstract

It has been recently realized that within the M inim al Supersymmetric Standard M odel, for certain patterns of superpartner masses, consistent with all the present experimental constraints, the scalar potential may develop at some scale  $Q_0$  unbounded color/charge breaking directions involving the sferm ion elds, and that these patterns are then excluded unless some new physics is invoked at or below the scale  $Q_0$ . We reanalyze this observation and point out that such patterns of superpartner masses at the weak scale are not ruled out when taking into account the probability of decay for the metastable color conserving minimum along these color breaking unbounded directions. It turns out that the present age of the Universe and can survive both quantum tunneling and the e ects of high tem peratures in the early Universe, causing the color/charge breaking e ects to be in practice not dangerous.

### 1. Introduction

There are many good reasons to believe that the Standard M odel is not the ultim ate theory of nature since it is unable to answer many fundam ental questions. One of them, why and how the electroweak scale and the P lanck scale are so hierarchically separated has motivated the M inim al Supersym metric extension of the Standard M odel (M SSM) as the underlying theory at scales of order 1 TeV [1]. A huge number of new parameters appear when considering the M SSM. Some of these new parameters are constrained by the unsuccessful searches of new particles at accelerators. O there may receive severe bounds from the requirement of avoiding large avour-changing neutral currents. M oreover, constraints on the parameter space, which mostly involve the soft supersymmetry breaking trilinear term s A 's, arise from the existence of charge and/or color breaking minima in the scalar sector when looking at some particular directions with nonvanishing vacuum expectation values (VEV's) of the Higgs elds [2].

By considering directions in the eld space which do not interest the VEV's of the Higgs elds, it has been recently pointed out that certain m ass patterns for the superpartners cannot arise at low energy unless there is new physics beyond the M SSM and below the grand uni ed (GUT) scale [3]. Indeed, there are m any at directions in the eld space of the M SSM and it m ay happen that som e combination of the squark and/or slepton m ass-squared parameters get negative at som e scale  $Q_0$  below the GUT scale when running through the R enormalization G roup Equations (RGE's) from the weak scale up. This leads either to the appearance of unacceptable color breaking m inim a or to unbounded from below directions in the extive potential for the squark and/or slepton elds 's, making the color conserving m inim um = 0 m etastable. In such a case, it has been argued in ref. [3] that the corresponding region of the parameter space is either ruled out or there m ust exist som e new physics below the scale  $Q_0$  whose e ects can change the evolution of the m ass-squared parameters with the scale Q [3].

The situation here is fairly analogous to what happens for the elective potential of the SM H iggs eld H : for a top quark m ass large compared to the H iggs and gauge bosons m asses, the one{loop top quark contribution to the elective potential will dom in the the others and drive the coel cient of the quartic term H <sup>4</sup> negative for very large values of

H, thus destabilizing the elective potential and making our vacuum at hH i' 250 G eV a local, but not global, minimum [4]. Nonetheless, the electroweak vacuum need not be absolutely stable. For certain top quark mass M<sub>t</sub> and Higgs boson mass M<sub>H</sub> it may just be instead metastable, as long as its lifetime exceeds the present age of the Universe [5]. The decay of the electroweak vacuum may be driven at low temperatures by quantum tunneling or at high temperatures by therm all excitations. Even if the requirement that our vacuum survives the high temperatures of the early Universe places strong constraints from vacuum stability on the (M<sub>t</sub>; M<sub>H</sub>) parameter space, still values of the top quark and Higgs boson masses for which our vacuum is metastable, but with a lifetime larger than the present age of the Universe, are allowed.

The purpose of the present Letter is to reanalyze the constraints on supersymmetric models discussed in ref. [3], involving some combination of the sparticle masses at the weak scale and imposed to avoid large color breaking VEV's  $\notin$  0 or destabilized elective potentials along some squark and/or slepton directions, and to point out that such limits may be weakened by considerations about the survival of the color conserving minimum. Even if such a minimum may be metastable in large regions of the parameter space of the superpartner masses, its lifetime turns out to be almost everywhere longer than the present age of the Universe. This means that the regions of the parameter space nuled out (unless some new physics appears before a certain scale Q<sub>0</sub>) in ref. [3] may be indeed permitted without any need of new physics.

The paper is organized as follows: In Section 2 we shall brie y review the elds potential along some particular directions of the squark elds showing why it may be destabilized and which are the consequent constraints on the superpartner mass patterns [3]. In Section 3 we discuss the color conserving = 0 decay rate at zero temperature, leaving the nite temperature case to Section 4. Finally, Section 5 presents our conclusions.

# 2. The e ective potential and at directions

Let us consider the same at direction in the squark elds analysed in ref. [3]:  $\alpha_R^r$  =

 $\mathbf{s}_{R}^{g} = \mathbf{B}_{R}^{b} = \overline{2}$ . A long this particular direction the coe cient (Q) of the quartic term <sup>4</sup> is vanishing for all scales Q, and the one{loop e ective potential reads

where  $m^2 = m_{\alpha_R}^2 + m_{\beta_R}^2 + m_{\beta_R}^2$  and  $V_{1 \text{ loop}}$  is the one{loop correction to the elective potential (in the  $\overline{DR}$ -scheme)

where Str counts properly all the degrees of freedom, sum m ing over all the m ass eigenstates which get m ass in the -background eld.

Since the one{loop potential behaves as / ln  $(g_3^2 \ ^2=Q^2)$  for large values of  $(g_3$  is the SU (3) gauge coupling constant), in order that the approximation of neglecting loop e ects be safe one should adopt in the renormalization group improved tree level potential a scale Q '  $g_3$  to make the logarithms small. In practice, we will adopt Q = Q  $\frac{q}{g_3^2} \ ^2 + M \ ^2_3$ , so as to stop the running below Q ' M  $_3$ , and use for the e ective potential

The prescription is trivial: just evaluate the mass parameter m $^2$  at the scale Q ' Q .

The RGE form<sup>2</sup> is given by

where  $g_1$  is the standard U (1) coupling, M<sub>i</sub> are gaugino m asses,  $h_b$  is the bottom quark Yukawa coupling and  $A_b$  is the bottom quark trilinear m ixing parameter, and all param – eters are running. If tan (the ratio of the two H iggs VEV's) is not too large,  $h_b$  is small and the term proportional to  $h_b^2$  in the above Equation can be neglected, leading to the solution [3]

where all masses on the right-hand side are physical (propagator pole) masses and the only underterm ined factors are  $g_1^2 (M_1)$  and  $g_3^2 (M_3)$ , which depend on the full spectrum of the superpartner masses and the initial condition  $_3 (M_2) = 0.12$ . If one takes  $M_1 = M_3$ , as usually results in GUT models, the elects of the term proportional to  $g_1^2$  in Eq. (5) is negligible. To obtain  $g_3 (M_3)$  we have assumed a common supersymmetric threshold at  $M_3$ , but the results are almost unsensitive to this simplifying assumption.

In Fig. 1 we show the contours of  $m^2(Q_0) = 0$  for di erent values of  $Q_0$  in the  $(m = 3; M_3)$  {plane. Portions of the parameter space lying to the right of each contour (for a given scale  $Q_0$ ) are characterized by an elective potential unbounded from below and by a metastable color conserving minimum = 0, unless some new physics capable of modifying this situation is present between the soft supersymetry breaking scale (1) TeV) and  $Q_0^{-1}$ . It is easy to see, from Eq. (5), that for m M<sub>3</sub> one has that the value of the eld  $_0$  for which V ( $_0$ ) = 0 is

In Fig. 2 we draw the running scalar mass m<sup>2</sup> (Q), normalized to its value m<sup>2</sup> for p = 0, as a function of the eld, assuming that  $m = \sqrt{3} = 500 \text{ GeV}$  and for values of M<sub>3</sub> of 1500, 1000, 700 and 600 G eV. The elective potential is just obtained by multiplying the result by m<sup>2</sup> <sup>2</sup>=2. Notice that a barrier will be present in V () separating the metastable vacuum = 0 from the region of very large values of , where m<sup>2</sup> (Q) < 0 and the potential becomes negative and unbounded from below.

From the analysis of the e ective potential one can then conclude that the sparticle m asses at the weak scale must satisfy severe relations among each other to avoid the

color conserving m in in um = 0 becom ing a local m in in um and the potential to develop unbounded directions for large values of the eld .

In the next Sections we shall show that these relations may be relaxed, since in most of the region in the parameter space  $(m = \frac{p}{3}; M_3)$  where the minimum = 0 is metastable, it has however a lifetime longer than the age of the Universe, so that color breaking e ects are in practice not dangerous.

# 3. Nucleation by quantum tunneling

The decay of the m etastable color conserving m in im um = 0 m ay occur by the nucleation of bubbles of the unstable phase. If the bubble is too sm all, it collapses under its surface tension. If the bubble is large enough, it expands classically, eventually absorbing all the m etastable phase. At zero tem perature, the vacuum can decay only by quantum tunneling through the barrier separating the m etastable vacuum from the region of negative values of V (). The W KB am plitude for false-vacuum decay by tunneling m ay be found expanding the Euclidean path integral about the bounce solution to the Euclidean equation of motion [7]

The bounce solution is an O (4) rotationally symmetric solution and solves

where  $s = (t_E^2 + r^2)^{1=2}$ . It takes some convenient value (0) at s = 0 (with  $^0(0) = 0$ ), probing the unstable region of the potential ((0) >  $_0$ , where V ( $_0$ ) = 0), and falls to the false vacuum = 0 as s ! 1 . W hen viewed as a function of the Euclidean time  $t_E$ , the bounce solution interpolates between the false vacuum ( $t_E ! 1 ; r$ ) = 0 and an unstable bubble ( $t_E = 0; r$ ), which is just large enough to expand on its own classically. The Euclidean action  $S_4$  of the bounce solution yields the exponential suppression of the rate for the false vacuum decay per unit volum e

where D  $_4$  is a coe cient calculated from uctuations around the bubble.

The rate for the decay of the m etastable color conserving m inim um = 0 at zero tem perature m ay be found simply by solving Equation (8) num erically, using the elective potential (3) discussed earlier, and computing the Euclidean action. Some qualitative avour of the results can be obtained by noting that, if  $_0$  m and M  $_3$ , the bounce is mainly determ ined by the behaviour of V at large values of , near  $_0$ . Since dV=d j $_0$  / M  $_3^2$   $_0$ , we see from Eq. (6) that the radius of the bounce is M $_3^1$ , and for instance the kinetic energy contribution to S<sub>4</sub> results  $_0^2$ =M  $_3^2$  ' exp ( $^2$ m  $^2$ =(2g<sub>3</sub><sup>2</sup>M  $_3^2$ )), which is quite large unless m M  $_3$ .

To decide whether the m etastable vacuum = 0 would survive the age of the present Universe  $10^{0}$  yr, one has to multiply Eq. (9) by the space-time volume of the past light cone of the observable Universe. The condition that the lifetime of the metastable state = 0 is longer than the present age of the Universe translates into (neglecting the very weak dependence upon the prefactor D<sub>4</sub>)

Fig. 3 shows the contours in the  $(m = 3; M_3)$  (plane for di erent values of  $\log_{10} (S_4)$ , the critical value  $S_4 = 400$  corresponding to the contour labelled by 2.6. Regions to the right of each contour are characterized by an Euclidean action smaller than the value at the contour. A comparison between Figs. 1 and 3 shows that the color symmetric vacuum = 0, although m etastable, has indeed a lifetim e which exceeds the present age of the Universe, in all the regions of the  $(m = 3; M_3)$  (plane, with the exception of a very small wedge at small values of m. From Fig. 1, one sees that in this wedge the vacuum = 0 could become stable only by the introduction of new physics at a scale below  $10^4$  GeV.

From the analysis of the m etastable vacuum decay by quantum tunneling at zero tem – perature we may therefore conclude that apparently dangerous at and unbounded directions in the squark – eld space are indeed safe: the barrier separating the m etastable vacuum from the regions of negative values of V () inhibits the form ation of su ciently large bubbles and the color conserving vacuum = 0 survives the quantum tunneling.

In the next Section we shall analyze the fate of the color conserving m in im um when considering the therm all ects present in the early Universe.

## 4. Nucleation by therm alexcitation

A nother source of energy to cross the barrier is the high temperature of the early U niverse. In the high-temperature plasma, thermal uctuations may excite a bubble su ciently large so as to be able to induce the transition, and the probability of a thermal uctuation of associated energy  $E_b$  to cross the barrier is simply given by a M axwell-Boltzmann suppression factor exp( $E_b=T$ ). One may think that the rate will not be exponentially suppressed at high temperatures, large compared to the barrier energy, but how ever the elective potential, and therefore  $E_b$ , also depends on the temperature making the barrier higher. At high temperatures, therefore, there is a thermal energy to cross the barrier, but the barrier is higher.

We now need to nd the energy barrier for the phase transition. For this we need a bubble corresponding to a static, unstable solution of the classical equation of motion [8]

where V (;T) = V () + V<sub>T</sub> () is obtained by adding to the zero temperature e ective potential the one{loop nite{temperature correction [9] V<sub>T</sub> () V<sub>T</sub> () V<sub>T</sub> (0), with

Here the upper sign is valid for bosons and the lower one for ferm ions, and  $n_i$  are the corresponding degrees of freedom. Notice that substracting  $V_T$  (0) from the elective potential is necessary for computing the bounce action.

It is easy to see that  $V_T(0) = {}^2g T^4=90$ , with  $g = n_b + (7=8)n_F$  counting the degrees of freedom lighter than T. Hence, for T,  $V_T() = {}^2g T^4=90$ , where g counts the particles heavier than T in the presence of the eld and lighter than T in = 0. In our case, g = 60 for T m and M<sub>3</sub>. On the other hand, one has for T ,

where m  $^2$  m $^2$  ( ) m $^2$  (0), so that only the dependent mass term s contribute. In our case V  $_T$  ( ) '  $2g_3^2T^2$  for T , getting its dominant contributions from the

gluons (via seagull terms), the gluinos and the  $u_R^r$ ,  $s_R^g$  and  $b_R^b$  quarks (from the gqg couplings) and the corresponding squarks (via the D {terms), with the exception of the at direction<sup>2</sup>.

Again, we have solved Eq. (11) numerically searching for a solution which probes unstable values of at r = 0 and falls o to the metastable vacuum = 0 as r ! 1. The probability of tunneling per unit time per unit volume is given by

where D<sub>3</sub> is the determ inant factor and S<sub>3</sub> is the three-dimensional action of the solution of Eq. (11). As discussed by Anderson in ref. [5] we should now multiply by the volume our current horizon had when at temperature T, which is V (T)  $(10^{0} \text{ yr})^{3}$   $(3 \text{ K} = \text{T})^{3}$ , and by the am ount of time the Universe spent at temperatures T, which is t  $M_{P1}=\text{T}^{2}$ . Putting this together, one nds that the metastable vacuum = 0 has survived the high temperatures of the early Universe if

For a given choice of m asses m and M  $_3$ , we have computed the m inimum of  $S_3$ =T as a function of tem perature.

The resulting minimum values are shown as contours in the  $(m = \frac{p}{3};M_3)$  {plane in Fig. 4. The interpretation of these results is the following: in the regions where for T = 0 the action  $S_4$  was very large, corresponding to very large values of (0) in the bounce solution, also the nite temperature bounce action is hoplessly large due to the exponentially large values of the bounce at the origin (since the nite T correction  $V_T$  is positive, the value of (0) is even larger in the nite T case). In the remaining region of sm all scalarm asses, where the T = 0 bounce had sm aller values of (0) ( $10^3 \{10^5 \text{ GeV}\}$ , the following is found: for T m and M<sub>3</sub>, the barrier has a height /  $^2T^2$  for < T, while it behaves as g  $^2T^4=90 + m^2(Q_1)^2=2$  for T > , and hence the potential can become negative only for values /  $T^2=\frac{q}{jn^2(Q_1)j}$  T. The width of the bounce

is now  $jn^2(Q)j^{1=2}$ , so that  $S_3=T$  /  $(T = jn^2(Q)j)^3$ . This implies that at large temperatures, it becomes harder to jump over the barrier. In fact, we usually not that the optimum temperature for the transition is 0 (m). As can be seen in Fig. 4, this considerations imply that the lifetime of the metastable vacuum is again larger than the age of the Universe with the exception of the smallwedge corresponding to m M<sub>3</sub> (to the right of the contour labeled 2.4), sim ilarly as in the T = 0 case.

Notice that so far we have been assuming as an initial condition that the scalar eld is always sitting at the origin = 0 at high temperatures. A lithough this is the therm al equilibrium state at large temperatures, it is how ever also possible that the scalar eld

is left initially far from the origin, e.g. at an early epoch near the end of in ation, and m ay then roll towards the unbounded direction before reaching the = 0 m inim um . D ue to the uncertainties connected with the hidden sector and the form of the gravitational couplings at the P lanck scale, it is di cult to determ ine the (m odel{dependent) form of the potential for during in ation [10], specially for large values of the eld, although som e m echanism s which could adjust the initial values close to the origin have been suggested [11]. In this paper we have then assumed that, when the tem perature of the U niverse decreases to the point in which the unbounded direction rst appears in V (;T), the scalar eld is already sitting close to its color conserving m inim um <sup>3</sup>.

# 5. Conclusions

In this paper we have investigated the constraints involving some combination of the sparticle m asses at the weak scale arising from the requirement that the m etastable and color conserving ground state = 0 is stable along at directions where the elective potential V () becomes unbounded from below for very large values of the scalar eld. We have concentrated our attention in the direction in eld space analysed in ref. [3], and a similar analysis may be applied to other dangerous directions considered in the literature [2].

In spite of the presence of large regions of the  $(m = \frac{p}{3}; M_3)$  {parameter space where the elective potential becomes unbounded unless some new physics appears between the MSSM scale and the GUT scale [3], we have pointed out that such constraints are significantly weakened when considering the decay probability for the metastable state = 0 along this unbounded direction. It turns out that the lifetime of this state is longer than the present age of the Universe and that it can survive both quantum tunneling, occuring at zero temperature, and the therm al excitations present in the early Universe. We then suggest that no severe relations among the superpartner masses should necessarily be imposed to avoid disastrous color breaking: the metastable color conserving minimum is protected against jumping towards dangerous squark unbounded directions and this makes the color breaking elects to be in practice not present.
