H adronic com ponent of the photon
spin dependent structure function $g_{1}$ from Q CD

#### Abstract

W e calculate the spin dependent structure function of the polarized virtualphoton $g_{1}\left(x ; Q^{2} ; p^{2}\right)$, especially its hadronic part, using the OPE in the inverse pow ers of the target photon virtuality. Som em odel is accepted to achieve a correct analytical behaviour in the photon squared $m$ ass. This enables extrapolation to the case of a realphoton.


## 1 Introduction

M ore than two decades ago it was observed [ī] that the processes e e! e e X being sum $m$ ed over all hadronic states (see g. 1.) allowed for the study of interactions at high energies. An experim entally favourable situation for m easure$m$ ents of this cross section appears $w$ hen one electron (corresponding to the photon w th m om entum $q$ ) is detected at large $m$ om entum transferred $Q^{2}=q^{2}$ and the other rem ains in a nearly forw ard dom ain $\mathrm{p}^{2} 0$. So, in practioe, it is more appropriate to dealw ith the deep inelastic scattering (D IS) of an electron beam on a real photon target which is characterized by several nonpolarized and polarized structure functions in the sam eway as the usuald IS on a nucleon.

The photon structure functions in the context of the gauge theories have rst been discussed by A hm ed and Ross [2] Since 1977 [1] scattering from a photon target has becom e a new sub ject of intensive theoretical studies in the fram ew ork of QCD. M uch progress has been achieved in this direction [īi]. As was rstly advocated by W itten the nonpolarized structure function $F_{2}(x)$ can be calculated using the perturbative Q CD alone. At that tim e there was considerable optim ism that this process was an excellent test for the perturbative QCD and $m$ ight provide an accurate $m$ easurem ent of $s$. By now the optim ism has waned considerably. This happens because $W$ itten's suggestion is true only for the asym ptotically large probe-photon $m$ om entum transfer squared where a "contact"type term due to the photon operators in the fram ew ork of the $O$ perator $P$ roduct Expansion (OPE) tums out to be dom inant. At sm aller values of $Q^{2}$ the hadronic com ponent becom es sizable, the photon adm its considerable contribution that com es from the nonperturbative region. T he photon has a partonic substructure induced by virtual uctuation into the quark-antiquark pair. T his process receives the short as well as long distance contribution, and the latter is due to the nonperturbative dynam ics that cannot be calculated in perturbative QCD.Only if $\mathrm{p}^{2}$ is in the deep inelastic scattering region, the partonic substructure can be neglected and the photon exhibits itspoint-like nature. For nite $p^{2}$ thetarget photon receives contri-
bution from the hadronic com ponent associated w ith the Vector M eson D om inance （VM D ）of the soft photon．D ue to this contam ination the hope of pure extraction of $Q C D$ from this reaction in a real experim ent fails ow ing to the large uncertainty in the theoretical prediction for this part．T ill recently the only estim ations for the latter have been obtained from the VM D m odels

The rst QCD based calculation of the hadronic part has been initiated by Balitsky $\left.{ }_{[15}^{1}\right]$ ．H ow ever，only a few rst $m$ om ents rather than $x$－dependence of the structure function were found in his paper．Recently a new approach for calculating the photon structure function in QCD has been developed［⿶凵⿱⿱一口⿴囗十刂灬］．It enables one to evaluate the structure function in the region of interm ediate x and was successfully applied to the case of spin averaged scattering．

In recent tim es the polarized photon structure functions have attracted a lot of attention．In ref．［7̄1］OPE and the renom alization group analysis were extended to the polarized sector，while works cited in ref．［8］－1］deal w th the rst mom ent of the spin dependent structure function $g_{1}(x)$ and its sensitivity to the chiral sym $m e-$ try realization．In these papers，as in W Itten＇s one，the hadronic com ponent was com pletely disregarded．H ow ever，the know ledge of the latter is very im portant for com parison of the theoretical predictions w ith a real experim ent．This holds for all presently available or foreseeable values of $Q^{2}$ ．

In the present study we concentrate on the calculation of the polarized structure fiunction $g_{1}(x)$ follow ing the $m$ ethod $m$ entioned above．W e shall start $w$ ith the consideration of the structure function when the target photon virtuality is large and spacelike $p^{2} \quad R_{c}{ }^{2}, R_{c}$ is a con nem ent radius，but $p^{2} \quad Q^{2}$ and apply the OPE to the discontinuity $\left[\frac{1}{[9}\right]$ of the forw ard photon－photon scattering am plitude which results in the expansion in the inverse powers of target photon virtuality． On the other hand，using the analytical properties of the structure fiunction in the photon 0 －shellness $p^{2}$ it is represented via the dispersion relation through the contribution of the vectorm eson and continuum ．C om paring the tw o representations of the sam equantily we can $x$ unam biguously allparam eters ofhadronic spectrum ．

The structure function obtained possesses correct analyticalproperties in the target photon $m$ ass and has no ctitious kinem atical singularities inherent in the perturbative diagram s.
$T$ he sensitivity to the $Q C D$ radiative corrections is poor until very large $Q^{2}$ is attained. Thus, we restrict ourselves to the low est order graphs and to the consideration of light quarks only; the result is correct for interm ediate $Q^{2} \quad 10 \mathrm{GeV}^{2}$. H ow ever, for too low $Q^{2}$ the higher tw ist corrections $m$ ay be im portant.

## 2 OPE for the four-point am plitude

To start w ith we consider the four-point correlation function

where $j={ }^{P}{ }_{q} Q_{q} q_{q} \quad$ is the electrom agnetic quark current. This am plitude is originated from the $T$-product of tw o electrom agnetic currents betw een the photon states and application of the Lehm ann-Sym anzik-Zim m erm ann reduction form ula. The discontinuity across the branch cut on the real axis in the com plex plane of $!=\frac{1}{x}$, where x is the usualB jorken variable, gives us the structure function we are interested in.

N ote that due to the weak coupling of the photon to the hadronic states there is no need to extract the physical state of interest w the help of som e auxiliary procedure, e.g. the B orel transform ation.

In order to nd the polarized spin structure function, we isolate it as a coe cient in front of an appropriate tensor structure, nam ely

where $s=i \quad p$ and is a photon polarization vector. $M$ ore precisely, for the purposes of this paper it is enough to pidk out the antisym $m$ etric tensor ( g g g g ).

As a rst step we have to nd the contribution of the unit operator. This result is well known since the "photon-photon fiusion" process w as calculated even before the advent of Q CD $\left[\begin{array}{ll}{[1]} \\ -1\end{array}\right]$. H ow ever, to reproduce unam biguously the spectral densities in the dispersion representation for the structure function, which require som e interm ediate result, such a calculation has to be perform ed over again. We restrict ourselves to the scaling approxim ation, i.e. to taking into account the rst nonvanishing term in the expansion in powers of $\mathrm{p}^{2}=\mathrm{Q}^{2}$, therefore lim iting to the leading $t w$ ist-2 contribution. T he result is

where hQ ${ }_{q}^{4} i={\frac{1}{N_{f}}}^{P}{ }_{q} Q_{q}^{4}$ is an average of the fourth powers of the quark charges. $T$ his result is tw ice that represented by diagram $s$ in $g$. 2 due to the clockw ise and counter-clockw ise directions of the intemal quark lines, each term in the curly brackets corresponding to graph (a) and (b), respectively. The rst line of this equation willbe used in the follow ing to $x$ the param eters of the hadronic spectrum .

From all power corrections up to dim ension eight we calculate only one due to the ghon condensate $\mathrm{h}-\mathrm{s} \mathrm{G}^{2} \mathrm{i}$. This can be elucidated by the facts that the low est dim ension quark condensate $h$ i cannot appear due to chiral invariance as it is accom panied by the light quark $m$ ass whidh we set equal to zero in all calculations. The contribution of the three-gluon condensate $\mathrm{hg}^{3} \mathrm{fG}^{3} \mathrm{i}$ is usually sm all. The dim ension six four-quark condensate can be om itted because its contribution is proportional to the delta function | (ll $1 \quad \mathrm{x})$ and tums out to be beyond the soope of the $m$ ethod.

To sim plify the calculation of the leading power correction, it is convenient to use the xed-point gauge for the background gluon eld ( $x \quad x_{0}$ ) $B^{a}(x)=0 . W e$ chose the xed point in the vertex of the hard photon em ission $x_{0}=0$. The quark
propagator in this gauge up to the order $\mathrm{O}\left(\mathrm{G}^{2}\right)$ looks like [ilin

The singularity in the gluon condensate contribution shows invalidity of the $m$ ethod in the region of $s m$ all $x$. The applicability region of this form ula, which accounts for the hadronic part, can be found by usual requirem ent that the power corrections would not exceed 50\% of the $m$ ain perturbative term. G oing as low er as to the point $\mathrm{p}^{2}=\mathrm{m}^{2}=0: 6 \mathrm{G} \mathrm{eV}{ }^{2}$ ( m eson is the low est prom inent state in the channel w ith the photon quantum numbers) in eq. (-(̄) the ghon condensate com prises less than $50 \%$ only for $x \quad 0: 6$. The upper lim it of perm itted $x$-values w illbe estim ated below . From these facts it follow s that the present approach could not be used for the calculation of the $m$ om ents of the structure finction.
$N$ ow we are in a position to $m$ ake som e com $m$ ents on the nonlocal condensates.
Introducing the nonlocalghon condensate it is probably im possible to get rid of singular behaviour of the corresponding contribution to the structure function [1] $2 \overline{1}]$; the form er dim inishes the degree of singularity by one power in the $x \quad 0$ region.

H ow ever, the singular type behaviour of the quark condensate contribution can be sm eared over the whole region of the $m$ om entum fraction from zero to unity by introducing the concept of a nonlocal quark condensate. Such an attem pt was $m$ ade in ref. [1] $13-1$ for the spin averaged structure function $F_{2}(x)$. But there are two shortcom ings in this paper. First, the authors claim that the contribution due to the quark condensate im proves considerably the description of experim ental data, though, there is a num erical error in their answer: the coe cient in front of the nonlocal vector quark condensate is three tim es sm aller. The second fact is connected with im proper treatm ent of nonlocal ob jects. The diagram with a nonlocal scalar condensate used in their paper does not exist. The argum ents are as follow s. The philosophy of QCD sum rules is the mutual relationship betw een the resonance and asym ptotic param eters. The leading asym ptotic behaviour is given by perturbative QCD while nonperturbative contributions enter through the power corrections which die out for asym ptotically large $m$ om enta squared of the problem | in the form allim it $\mathrm{p}^{2},{ }^{2}!1$, where we introduce nonzero t-channel m om entum in order to treat the factorization ofsm alland large distances properly. The technique is to extract the coe cient function that can be dealt perturbatively | the part of the diagram with hard $m$ om entum ow, while the soft lines are param etrized via vacuum condensates that accum ulate nonperturbative in form ation. In the diagram in ref. [i] be traced by the fact that in the local lim it it becom es disconnected. To preserve the latter property it is necessary to attach the ghon line connecting the upper and lower parts (se g. 4 (a)). H ow ever, in the sm all ${ }^{2}$ kinem atics, actually, we are interested in the case of ${ }^{2}=0$, the diagram $w$ ill behave as $\frac{1}{2}$ for the localquark condensates or som ething like $\frac{1}{{ }^{2}+\frac{2}{q}}$, where $\frac{1}{q}$ is a correlation length of quarks in the vacuum, for the nonlocalone. For sm all ${ }^{2}$ the use of the bare gluon propagator is no longer reliable as the average virtuality ${ }_{\mathrm{q}}^{2}=0: 4 \mathrm{G} \mathrm{eV}^{2}[\underline{1}[\underline{4}]$ and tums outside the perturbative dom ain. W e expect that for low ${ }^{2}$ the nonperturbative e ect does provide an appropriate infrared ( $\mathbb{R}$ ) cut-o : the perturbative behaviour
$\frac{1}{2}$ is substituted by the $m$ ass of an appropriate $m$ eson $\frac{1}{m_{R}^{2}}$, that is the "natural" scale for the boundary between the non-and perturbative regions. In principle, this program could be traced by reform ation of the originalO PE [5] $]$ to the case when the mom entum $\quad 2$ can be arbitrary $m$ all (even zero). H ow ever, there is an essential di culty as com pared to the form factor problem [15], nam ely, due to the presence of the $t$-channel non-analyticities or singularities in each $m$ om ent of the structure function, we need an in nite num ber of param eters to be found from additional sum rules which enter the $m$ odel of the bilocal pow er corrections. O bviously, this is an im possible task. W e will not go into details here referring the interested reader to the paper [1] the pion. Therefore, lim iting ourselves to the central region in the $B$ jonken variable we discard these term $s$ com pletely. Of course, there are other diagrams (see $g$. 4 (b)) which are regular in ${ }^{2}$ but we believe that the contribution neglected could not a ect seriously the nal result.

## 3 P olarized photon structure function

W e can use the analytical properties in $\mathrm{p}^{2}[\underline{1}[1]$ and represent the structure function via a dispersion relation $w$ ith respect to $p^{2}$ in term $s$ of physical states

To calculate the functions $G_{i}$, we use a standard technique in $Q C D$ sum nules, viz., the sim ple m odel of a low est resonance plus continuum

$w$ here $s_{0}=1: 5 \mathrm{GeV}^{2}$ is a threshold value for the vector $m$ eson channel and $\mathrm{m}^{2}=$ $0: 6 \mathrm{G} \mathrm{eV}^{2}$ is a m eson m ass squared. In other words, we provide a natural cut-o
on the transverse $m$ om entum in the loop $\left(k_{?}^{2} \quad x(1 \quad x)\right.$ 解) attributing the region of sm all $\mathrm{k}_{\text {? }}^{2}$ to the nonperturbative contribution. The continuum threshold $\mathrm{s}_{0}$ has been found from the analysis of two-point correlators for fos eson in the fram ew ork of the QCD sum nules tī

Substituting them back into the dispersion relation $(\bar{T})$ and expanding in the inverse powers of $p^{2}$ we can com pare the resulting expression with the QCD calculated $g_{1}\left(x ; Q^{2} ; p^{2}\right)(\underset{-1}{\bar{\sigma}})$ and $x$ the rem aining unknown functions $G_{1}^{(1)}(x)$ and $G_{2}^{(1)}(x)$, nam ely:

W e com e to the polarized virtual structure function which possesses the correct analytical properties in the photon squared $m$ ass and accounts for the hadronic part:

## 4 Result and conclusion

A s we notioed above, the correction due to the ghon condensate com prises no $m$ ore than $50 \%$ only for $x \quad 0: 6$ at $\quad \hat{p}=m^{2}$. Therefore, for this $x$-values we can ex-
trapolate the polarized virtual structure function given by eq. (īī) to the point $p^{2}=0$. In the large $x$ region, we could not trust our $m$ odel for hadronic spectrum . As was shown in ref. [ $[\overline{-1}]$ as $x$ ! 1 multh hadron states exceed the contribution of single $m$ eson. M oreover, since the function $G_{2}^{(1)}(x)$ given by eq. ( $\left.\overline{1} \overline{\mathrm{O}}\right)$ is related to the polarized structure fiunction of the m esonnill $f$ ( $x$ ) it should reproduce (1 x)-behaviour as x! 1 govemed by the quark counting rules. However, it is easy to check that it does not take place. The upper lim it of accepted $x$-values $m$ ay be estim ated from he requirem ent that the created hadron state should exceed considerably the $m$ eson $m$ ass $M{ }_{x}^{2} \quad m^{2}$. Then from the kinem atical constraint $x=1=\left(1+\left(M_{x}^{2} \quad m^{2}\right)=Q^{2}\right)$ we have the restriction $x<0: 8$. T herefore, the approach for calculating the polarized photon structure function $g_{1}(x)$ is valid in the interval $0: 6 x<0: 8$. This situation is quite sim ilar to that for calculating the polarized proton structure functions in the QCD sum nules fram ew ork where the range of perm itted $x$-values is also very narrow [1]9].

N ote that from the point of view of the QCD sum rules an interpretation of separate contributions to the structure function is di erent from the na ve division of the latter in term s of the perturbative (found from the box diagram s) and VMD parts which inevitably contains double counting. In the language of the present approach the part of the perturbative loop is dual to the lowest resonance w ith corresponding quantum num bers and duality interval $s_{0}$, while the rem aining part of the loop corresponds to the higher states contribution (the continuum). The resonance also receives the contribution from the nonperturbative pow er corrections.

U nfortunately, up to now there are no available experim ental data on the photon spin structure function $g_{1}$ as its $m$ easurem ent is at the lim its of the possibilities of the polarized colliders. Future m easurem ents would provide an im portant insight into the underlying dynam icale ects associated w ith the polarized quark and gluon content of the photon.
