Form Factors for Sem i-Leptonic and Radiative Decays of Heavy Mesons to Light Mesons

To know and understand form factors of hadronic currents is of decisive in portance for analysing exclusive weak decays. The ratios of di erent form factors of a given process depend on the relativistic spin structure of initial and nalparticles. It is shown | assuming simple properties of the spectator particle | that these ratios can entirely be expressed in terms of particle and quark mass parameters. For quark masses large compared to the spectator mass the Isgur-W ise relations follow. The corresponding am plitudes for heavy-to-light transitions show a very similar structure. In particular, the F_0 and A_1 form factors behave again di erently from the F_1 ; A_2 ; V and T_1 form factors.

The subject of this talk concerns exclusive sem ileptonic and radiative decays of heavy mesons. These decays play an outstanding role for the determ ination of the parameters of the standard model, in particular the quark-mixing parameters. They are also an important source of information about the still badly understood QCD dynamics in the con nement region. The dynamical content of the corresponding am plitudes is contained in Lorentz-invariant form factors. The calculation of these form factors requires a non-perturbative treatm ent. M any theoretical tools have been applied for their determ ination: quark models, QCD sum rules, and lattice calculations. Them achinery of sum rules and lattice calculations has the advantage to be directly based on the QCD Lagrangian, but is quite involved. Quark models, on the other hand, are less directly connected with the QCD Lagrangian, but give a vivid picture of what is going on and allow an easy application to di erent processes and quite di erent kinem atical regions. How ever, m odels presented so far lacked full relativistic covariance with respect to quark spins, and it is the spin structure which determ ines the ratio of di erent form factors we are concerned with here. The know ledge of these ratios is of param ount im portance for the analysis of experim entally m easured decays.

The problem of the ratios of di erent form factors is solved in the form all in it where initial and nal quark masses are taken to be in nite. For instance, for $m_c ! 1 ; m_b ! 1$ the two form factors ($F_1;F_0$) describing B ! D transitions and the 4 form factors ($V;A_0;A_1;A_2$) describing B ! D transitions are all related [1],[2]:

Denoting initial and nalmeson masses by m_I and m_F, respectively, the IsgurW ise function (y) connected to F_1 by

depends in this limit on the product of the 4-velocities v_T and v_F only

The prediction of the corrections to the simple relations (1) for the case of nite physical quark m asses are a challenge to quark m odels. The calculation of form factors is even m ore challenging for heavy-to-light transitions such as

The avor and spin symmetries necessary to derive (1) do not apply in this case. Only the scaling property of the matrix elements with respect to the mass m_I can be used. It connects, for example, B ! F with D ! F transitions. But this is of little help since the application is restricted to a limited kinematic region near $q^2 = q_{max}^2$ and holds strictly only in the limit of large masses.

In the following I will use a fully relativistic quark model approach to get form factor relations. These relations follow without a detailed knowledge about quark model wave functions and should, therefore, be valid in the fram ework of a large class of dynamical models. They depend on m ass parameters only and will reduce to eq. (1) in the limit of large m asses of the active quarks.

Let us consider the 4-m om entum of an initial m eson (I) with velocity v_I and divide it into the m om enta of the active quark (i) in this m eson and the spectator (sp)

The dynam ics of the bound state will be described by a momentum space wave function f_{I} (k_{I} ; v_{I}). Its peak is taken to be at $k_{I} = 0$ dening, thereby, the splitting of the meson mass into the two constituent masses. Choosing the simplest internal S-wave structure, the wave function for the decaying pseudoscalarm eson has the form (in coordinate space)

I is a 4 d matrix. The mass values $m_i;m_{sp}$ appearing in the propagators are not necessarily identical with the constituent masses ${}_i^{I}; {}_{sp}^{I}$. Expressions analog to (5,6) hold for the nalparticle (denoted by F) emitted in the decay process. If it is a vector particle | a meson for instance | the D irac matrix ${}_5$ has to be replaced by the polarisation matrix = of this particle.

The I ! F transition amplitude is obtained from the product $_{I F}$. The integration over the space-time coordinate x_2 of the spectator particle leads to momentum conservation of this particle $p_{\rm sp}^{\rm F}$ = $p_{\rm sp}^{\rm I}$ correlating thereby the momentum $~k_{\rm F}$ with $k_{\rm I}$:

The o -shell quark m om enta can thus be written

The wave functions $_{\rm I}$; $_{\rm F}$ contain the propagators of the active quarks and of the spectator. Because the weak current does not act on the spectator, the transition amplitude should contain this propagator only once as is evident from the corresponding triangle graph [3]. Thus, by inserting the inverse propagator of the spectator, the transition amplitude reads

In semileptonic decays stands for $(1 _{5})$; in the calculation of I ! F transitions it stands for $q (1 + _{5})$ (apart from a global factor).

The initial and nalwave functions have their maximum at $k_F = k_I = 0$ with a width corresponding to the particle sizes. The integrand of the transition amplitude, on the other hand, has its maximum at values of k_B and k_F dierent from zero. One can expect this maximum to occur at $k_I = k_I; k_F = k_F$ with

The reason is that, together with (7,8), (11) in plies small and equal o -shell values for all three propagators occuring in the transition matrix element, as well as average quark energies close to their constituent masses in the rest system of the relevant particles: Because the average transverse components of $p_{sp} = K$ vanish, one gets with $_{sp} = (\frac{I}{sp} + \frac{F}{sp})=2$ from (7) and (11)

A coording to (12) the average space velocity of the spectator vanishes in the special coordinate system where $v_F = v_f$ as one would expect. In the following I will assume (12) to hold and to decisively determ ine the structure of the transition amplitude.

Considering the quark momenta (eq. (8)) in the physical region of the variable $y = v_F$ Ivand taking K for K, it is seen that at the maximum of the transition amplitude the decaying and em it-ted quarks carry essentially the same momenta as the mesons they are part of. This is especially true in heavy-to-heavy transitions where m_I;m_F sp, but holds also in heavy-to-light decay processes at least for large values of y (i.e. low q²-values) [4].

The covariant structure of the transition am plitude is obtained from the integral over J(K)in (9). For wave functions with a strong peak in momentum space and a width of order of the constituent mass of a light quark one may replace J(K) by J(K). This replacement saves us from an unfruitful discussion of speci c wave functions or propagators in the con nement region which cannot be reliably calculated at present. But it is certainly an approximation which holds good only for strongly peaked and otherwise smooth wave functions.

It is now a straightforward task to decompose

in terms of covariant expressions and to extract the corresponding form factors. There remains, of course, an undetermined function of the variable y multiplying the form factors. The result can be written in the form

Here T_1 is de ned as the form factor relevant for radiative decays:

The functions $F^{I}(y)$ depend on dimensionless combinations of the masses contained in (14). They all vanish in the lim it

Thus, (15) contains the Isgur-W ise result eq. (1).

For the general case in which (17) does not hold, the functions FI (y) could be written down but are too long to be displayed here.

The constituent quark picture suggests to use in these expressions (for a light quark spectator)




Figure 1. The functions 1 + B for sem ileptonic and radiative B ! decays. Quark m asses according to Eq. (18) and sp = 0.35 GeV.

Then, the functions $F^{I}(y)$ depend, besides upon y and the particle m ass ratio $m_{F} = m_{I}$, upon the

value of $_{\rm F} = _{\rm sp} = m_{\rm F}$ only.¹ Since in B ! D ;B ! and D ! K ;D ! transitions $_{\rm sp}^{\rm I} = _{\rm Sp}^{\rm F} = 0.35$ GeV appears to be a reasonable value, all $_{\rm FI}^{\rm FI}$ functions are predictable using the corresponding values for $_{\rm F}$. As an example the functions 1 + $_{\rm B}^{\rm B}$ (y) for the sem i-leptonic B ! transitions and the function 1 + $_{\rm T_1}^{\rm B}$ are plotted in Fig. 1. ($_{\rm T_1}$ turned out to be identical to $_{\rm F_1}$ independent of the assumption (18)). Because the

curves for $_V$; $_{A_1}$ and $_{A_2}$ run similarly it is seen from (15) that the form factor A_1 di ers in its q^2 dependence from the V and A_2 form factors, like it is the case in the heavy quark limit. It is a consequence of relativistic covariance [5], [4].




Figure 2. Longitudinal polarization of the - meson in semileptonic B ! transitions. Full line: quark masses according to Eq. (18) and $_{\rm sp} = 0.35 \, {\rm GeV}$. Dashed line: without mass corrections ($^{\rm B} = 0$).

In Fig. 2 the longitudinal polarization of the -m eson is shown using again (18) and $_{sp} = 0.35$ GeV. For comparison, the polarization without mass correction (i.e. with $^{\rm B} = 0$) is also plot-ted.

Because of the lack of spin symmetry in the light sector a relation between, for instance, the B ! and B ! form factors cannot be obtained from (15) even though the functions FI are known. The factor FI (y) depends on the particle m asses and on the internal structures of the initial and nalparticles. The explicit dependence on the particle m asses can be taken care of, how ever, by setting

The form factors as obtained from (15) and (19) have now the correct scaling property for xed y. Furtherm ore, for large masses of the active quarks $^{F I}$ (y) de ned by (19) turns into the normalized Isgur-W ise function

For phenom enological applications we can specify $F^{I}(y)$ further:

¹The use of current m ass values, for instance m $_{\rm b}$ ' 4:8 G eV, m $_{\rm u}$ 0 is also conceivable. Choosing in addition m $_{\rm SD}$ 0, eq. (11) of ref. [4] can be rederived.

The rst factor in (21) is necessary to give mass independence of the form factors in the limit m_I=m_F ! 1 at xed q². The second factor is obtained from J(K) by setting m_{sp} = $_{sp}$. It was divided out in de ning the Isgur-W ise limit. The function g^{F I} depends on the variable k²_I = k²_F obtained in (13) and is a increasing function of this variable.

As an illustration of the usefulness of (21) one m ay take a simple dipole form ula which contains then just one parameter:

 g^{FI} , or in the case of eq. (22), the parameter x^{FI} depends on the internal structure of initial and nal states. Only in a hypothetical world where the internal meson wave functions are identical, g^{FI} would be process-independent and FI(y) =




Figure 3. Dierential branching ratio/ $y_{ub}f$ for the semileptonic B ! transition using (y) as described in the text.

(v) a truly universal function describing a large number of form factors. The di erence from this hypothetical world seems, however, not to be a drastic one: Taking x = 0.5, the eqs. (21,22) provide for a reasonable Isqur-Wise function for B! D⁽⁾ decays. Togetherwith (15), (19) one gets for the branching ratio BR (B! De _) 7% consistent with the experim entalvalue [6]. The sam e equations also lead to $T_1 (q^2 = 0)$ 0:36 for the process, a value also obtained in QCD в!к sum rule estimates [7]. Applied to the semileptonic D ! K decay I obtain the branching ratio $BR(D^{0} ! K e^{+})$ 2% also in accord with the data [6]. For the sem ileptonic B^0 ! ⁺ e _e transition the form factors V B ; A_{1}^{B} ; A_{2}^{B} ; A_{0}^{B} at $q^2 = 0$ turn out to be 0.37, 0.32, 0.35, 0.26, respectively, in accord with QCD sum rule results [7] and earlier estim ates [8]. The di erential branching ratio for the B! e transition is plotted in Fig. 3 - taking for the B-m eson lifetime 1.5 psec and dividing by $\mathcal{Y}_{ub}f$. Integrating it one nds the branching ratio $21.1 y_{ub} f$. (The transitions to the light pseudoscalars and K require a m ore detailed treatm ent because the pole position is of greater in portance; (18) is not applicable and $I_{sp} \in F_{sp}$.)

It should be clear that the \results" obtained from the Ansatz (22) and by taking an unjusti ed universal value for the param eter $x^{F\,I}$ serve as an illustration only and are not based on a detailed analysis.
