P henom enological constraints on a scale-dependent gravitational coupling

We investigate the astrophysical and cosm ological implications of the recently proposed idea of a running gravitational coupling on m acroscopic scales. We nd that when applied to the rotation curves of galaxies, their atness requires still the presence of dark matter. Bounds on the variation of the gravitational coupling from prim ordial nucleosynthesis, change of the period of binary pulsars, gravitational lensing and the cosm ic virial theorem are analysed.

1. IN TRODUCTION

The atness of the rotation curves of galaxies and the large structure of the Universe indicate that either the Universe is predom inantly made up of dark matter of exotic nature, i.e. nonbaryonic, and/or that on large scales gravity is distinctively di erent from that on solar system scales, where New tonian and post-New tonian approximations are valid. The former possibility has been thoroughly investigated (see Ref. [1] for a review) and is an active subject of research in astroparticle physics. The second possibility, how ever relevant, has drawn less attention. This is essentially due to the fact that until recently no consistent and appealing m odi cation of Newtonian and post-Newtonian dynamics has been put fow ard. M any of these attem pts [2], although consistent with observations, were most often unsatisfactory from the theoretical point of view. Actually, it has been recently shown that under certain fairly general conditions it is unlikely that relativistic gravity theories can explain the atness of the rotation curves of galaxies [3]. These conditions however do not exclude the class of generalizations of General Relativity that involve higher-derivatives. Quantum versions of these

theories were shown to exhibit asymptotic freedom in the gravitational coupling [4] and one would expect this property to manifest itself on large scales. This possibility would surprisingly imply that quantum e ects could m im ic the presence of dark matter [5], as well as induce other cosm ological phenom ena [6,7]. O ne striking im plication of these ideas is the prediction [6,7] that the power spectrum on large scales would have m ore power than the one predicted by the = 1Cold Dark Matter (CDM) Model, in agreement with what is observed by IRAS [8]. Furtherm ore, due to the increase in the gravitational constant on large scales one nds that the energy density uctuations grow quicker than in usual matter dom inated Friedmann-Robertson-Walkermodels [6,7]. Moreover, one can explain with a scaledependent G the discrepancy between determ inations of the Hubble's param eterm ade at di erent scales, as suggested in [6], and studied in [9].

Nevertheless, independently of the possible running of the gravitational constant in a higher derivative theory of gravity, it is worthwhile analysing the constraints on the scale-dependence of G from astrophysical and cosm ological phenom ena, where such an e ect would be dom inant. On the other hand, in the last few years there has been a revival of B rans-D icke like theories, with variable gravitational coupling, that has led to a num ber of constraints on possible time variations of G. Of course, som e of the constraints

on G- can be written as constraints on G over scales in which a graviton took a time to propagate. For instance, during nucleosynthesis the largest distance that a graviton could have traversed is the horizon distance at that time, i.e. a few ligh-seconds to a few light-m inutes, approxim ately the Earth-M oon distance. Such a distance is too sm all for quantum e ects to become appreciable, as we discuss below. However, those e ects becom e in portant at kiloparsec (kpc) distances and therefore could be relevant for discussing the rotation curves of galaxies. W e shall actually show, for a particular theory [5,6], that the rotation curves of spiral galaxies cannot be entirely explained by the running of G, so some am ount of dark m atter is required, which is still consistent with the upper bound on baryonicm atter com ing from prim ordial nucleosynthesis. O n the other hand, we could impose bounds on a possible variation of G from a plethora of cosm ological and astrophysical phenom ena at large scales, although the lack of precise observations at those scales m ake the bounds rather weak [10]. Of course, a di culty in examining constraints on the variation of G is that in all gravitational phenom ena the gravitational coupling appears in the factor GM , and hence we cannot distinguish a variation in G from the existence of some type of dark m atter.

2. A SYM PTOTIC FREEDOM OF THE GRAVITATIONAL COUPLING

The main idea behind the results of Refs. [5,6] is the scale depedence of the gravitational coupling. The inspiration for this comes from the property of asymptotic freedom exhibited by 1loop higher{derivative quantum gravity models [4]. Since there exists no screening mechanism for gravity, asymptotic freedom may imply that quantum gravitationale ects act on macroscopic and even on cosmological scales, a fact which has of course some bearing on the dark matter problem [5] and on the large scale structure of the U niverse [6,7]. It is in this fram ework that a power spectrum which is consistent with the observations of IRAS [8] and COBE [11] can be obtained [6,7].

We brie youtline this proposal. Removing the in nities generated by quantum uctuations and ensuring renorm alizability of a quantum eld theory requires a scale { dependent rede nition of the physical parameters. Furtherm ore, the rem oval of those in nities still leave the physical param eters with some dependence on nite quantities whose particular values are arbitrary. These can be assigned by specifying the value of the physical parameters at some momentum or length scale; once this is perform ed, variations on scale are accounted for by appropriate changes in the values of the physical parameters via the renormalization group equations (RGEs). Thus, the equations of motion in the quantum eld theory of gravity should be sim ilar to the ones of the classical theory, but with their parameters replaced by the corresponding 'im proved' values, that are solutions of the corresponding RGEs. How ever, since gravity couples coherently to m atter and exhibits no screening mechanism, quantum uctuations of the gravitational degrees of freedom contribute on all scales. One must therefore include the e ect of these quantum corrections into the gravitational coupling, G, prom oting it into a scale { dependent quantity. O ne-loop quantum gravity models indicate that the coupling G ($^2 = ^2$ $r^2 = r^2$) is asymptotically free, where is a reference m om entum, m eaning that G grows with scale [4]. A typical solution for G $(r^2=r^2)$ was obtained in Ref. [5] setting the functions of matter to vanish and integrating the remaining RGEs:

where G_{lab} is the value of G measured in the laboratory at a length scale r_{lab} , and $(r; r_{lab})$ is a growing function of r. In order for the asymptotic freedom of G ($^2 = ^2$) to have an e ect on for instance the dynamics of galaxies and their rotation curves, the function $(r; r_{lab})$ should be close to one for r < 1 kpc, growing signi cantly only forr 1 kpc. A convenient parametrization for $(r; r_{lab})$ from the t of Ref. [5] in the kpc range is the following:

where ' 1=30, ' 1=10 and $r_0 = 10$ kpc.

We mention that a scale dependence of the gravitational constant also arises from completely dierent reasons in the so-called stochastic in ation form alism [12] and that the scaling behaviour and screening of the cosm ological constant was also discussed in the context of the quantum theory of the conform al factor in four dimensions [13].

In what follows we shall use the t (1),(2) in our analysis of the rotation curves of galaxies, and extract a prediction for the distribution of dark m atter. However, before we pursue this discussion let us present some of the ideas developed in Refs. [5-7]. As discussed above, the classical equations have to be 'in proved' by introducing the scale dependence of the gravitational coupling. This m ethod suggests that the presence of cosm ological dark m atter could be replaced by an asymptotically free gravitational coupling. A ssum ing that the Friedm ann equation describing the evolution of a at Universe is the improved one, then:

where a = a (t) is the scale factor, $H = \underline{a}=a$ is the H ubble parameter, m is the density of matter, ' is the com oving distance and ' is some convenient length scale.

From Eq. (2) one sees that the present physical density parameter, $_{0}^{\text{phys}}$, is by construction equal to one. However, the quantity which is usually referred to as density parameter is actually:

where H $_0$ is the present Hubble parameter for a given large scale distance, r = r. This leads to $_0$ as a growing function of scale, which is in agreement with observations for a constant $_{m_0}$.

Furtherm ore, from Eq. (3) one can clearly see the scale dependence of the Hubble parameter [6,7,9]. M oreover, as shown in Refs. [6] and [7], the power spectrum resulting from these considerations is sim ilar to that of a low density C old D ark M atterm odelw ith a large cosm ological constant [14].

3. ROTATION CURVES OF GALAXIES

Let us now turn to the discussion of the inplications of the t (2) for the rotation curves of galaxies. It is a quite well established observational fact that the rotation curves of spiral galaxies atten after about 10 to 20 kpc from their centre, which of course is a strong dynam ical evidence for the presence of dark m atter and/or of non-New tonian physics. The rotation velocity of the galaxy is given by the non-relativistic relation,

which approaches a constant value some distance from the centre, e.g. $v_0^2 = 220 \text{ km/s}$ for the M ilky W ay. A ssum ing that the gravitational coupling is precisely Newton's constant G_N and imposing that the rotation velocity is constant, using the V irialTheorem at r = R 500 kpc, one nds the standard expression for the mass distribution of dark matter:

A ssum ing instead a running gravitational coupling (2), the condition that the rotation velocity is constant yields:

$$M (r) = \frac{0.673}{1 + (\frac{r}{r_0}) \ln(\frac{r}{r_0})} M_N (r) :$$

Equation (7) reveals after simple computation that the running of the gravitational coupling reduces the am ount of dark m atter required to explain the atness of the rotation curves of galaxies by about 44%, assuming that galaxies stretch up to a distance of about 500 kpc. This result [10] (see also Ref. [15]) is a clear prediction of the dependence of the gravitational coupling with scale and, in particular, of the t (2). Furtherm ore, since the possibility that the Galactic halo is entirely made up of baryonic dark matter is barely consistent with the nucleosynthesis bounds on the am ount of baryons [16], the running of G is quite welcome since it reduces the required am ount of baryonic dark matter in the halo. An entertaining hypothesis could be that precisely this e ect is responsible for the reduction in the microlensing event rates across the halo in the direction of the Large M agellanic C bud [17,18] with respect to those along the bulge of our galaxy, as reported by [19].

4. BOUNDSON THE VARIATION OF G W ITH SCALE

In this section we constrain the variation of the gravitational coupling given by the t (2) with bounds from primordial nucleosynthesis, binary pulsars and gravitational lensing and also discuss the e ect that a scale-dependent G has on the peculiar velocity eld [10].

4.1. Prim ordial nucleosynthesis

As mentioned in the introduction, one could obtain bounds on the variation of the gravitational coupling from observations of the light elements' abundances in the Universe. Such observations are in agreement with the standard primordialnucleosynthesis scenario, but there is still some room for variations in the elective number of neutrinos, the baryon fraction of the universe and also in the value of the gravitational constant. For instance, the predicted mass fraction of primordial⁴H e can be parametrised, in theories with a variable gravitational coupling, in the following way [20],

$$Y_p = 0.228 + 0.010 \ln_{10} + 0.327 \log$$

where $_{10}$ is the baryon to photon ratio in units of 10 10 and is the ratio of the Hubble param – eter at nucleosynthesis and its present value, itself proportional to the square root of the corresponding gravitational constant. In the t (8) it is assumed that the elective number of light neutrinos is N = 3 and that the neutron lifetime is $_{n} = 887$ seconds.

By running the nucleosynthesis codes for different values of G, it was shown in Ref. [21] that a variation of G = G = 0.2 on the values of the gravitational coupling was compatible with the observations of the prim ordial D, ³He, ⁴He and ⁷Li abundances at 1 level.

This result will now be used to constrain the running of G in an asymptotically free theory of gravity. In a theory with a scale-dependent gravitational constant, the maximum value of G at a given time is the one that corresponds to the physical horizon distance at that time. During prim ordial nucleosynthesis, the horizon distance grows from a few light-seconds to a few light-minutes, i.e. less than a few milliparsecs. At that scale we nd G=G=0.07, see Eq. (2), which is much less than the allowed variation of G given in [21]. Therefore, prim ordial nucleosynthesis does not rule out the possibility of an asymptotically free gravitational coupling. Of course, a light-second is about the distance to the M oon, and there are similar constraints on a variation of G at this scale coming from lunar laser ranging, G=G < 0.6 [22].

4.2. B inary pulsars

The precise timing of the orbital period of binary pulsars and, in particular, of the pulsar PSR 1913+16, provides another way of obtaining a model-independent bound on the variation of the gravitational coupling [23]. Since the sem in ajor axis of that system is just about a few lightseconds, the resulting limits on the variation of G can be readily compared with the ones arising from nucleosynthesis. The observational limits on the rate of change of the orbital period, mainly due to gravitational radiation dam ping, together with the know ledge of the relevant K eplerian and post-K eplerian orbiting param eters, allow s one to obtain the follow ing limit [23]:

$$\frac{G}{G} < 0.08 h^{-1}$$

where h is the value of the Hubble parameter in units of 100 km /s/M pc. For h = 0.8, [24] one obtains = 0:1 which is more stringent than the nucleosynthesis bound, but is still compatible with the t (2).

4.3. G ravitational lensing

G ravitational lensing of distant quasars by intervening galaxies m ay provide, under certain assum ptions, yet another m ethod of constraining, on large scales, the variability of the gravitational coupling. The four observable param eters associated w ith lensing, nam ely, in age splittings, tim e delays, relative am pli cation and optical depth do depend on G, m ore precisely on the product GM, where M is the m ass of the lensing object. This dependence m ight suggest that lim its on the variability of G could not be obtained before an independent determ ination of the mass of the lensing object. How ever, as the actual bending angle is not observed directly, the relevant quantities are the distance of the lensing galaxy and of the quasar. Since these quantities are inferred from the redshift of those objects, they depend on their hand on G, on the Hubble constant, H_0 , and on the density parameter, 0. However, as we have previuosly seen, a scale-dependent gravitational coupling in plies also a dependence on scale of H₀ and 0, see Eqs. (3) and (4). This involved dependence on scale m akes it di cult to proceed as in Ref. [25], where gravitational lensing in a at, hom ogeneous and isotropic cosm ological model, in the context of a Brans-D icke theory of gravity, was used to provide a lim it on the variation of G:

Since for this limit $_0 = 1$ was assumed, while in a scale-dependent model it is achieved via the running of the gravitational coupling, the bound (10) contrains only residual variations of G that have not been already taken into account when considering the dependence on scale of H $_{0}$ and $_0$. O f course, for m odels where the cosm ological parameters are independent of scale, the bound (10) can be readily used to constrain the variability of G on intermediate cosmological scales. It is worth stressing that this method, besides being one of the few available where this variability is directly constrained at interm ediate cosm ological times between the present epoch and the nucleosynthesis era, it is probably the only one which can realistically provide in the near future even m ore stringent bounds on even larger scales by observing the lensing of light from far away quasars caused by objects at redshifts of order z 1.

4.4. Peculiar velocity eld

Since we expect the e ects of a running G to becom e important at very large scales, one could try to explore distances of hundreds of M pc, where the gravitational coupling is signi cantly di erent from that of our local scales. That is the realm of physical cosm ology where of particular in portance is the study of the peculiar velocity eld. A possible signature of the running of G would be a m ism atch between the velocity elds and the actual m ass distribution, such that at large scales the same m ass would pull m ore strongly. To be m ore specific, in an expanding universe there is a relation between the kinetic and gravitational potential energy of density perturbations known as the Layzer-Irvine equation (see eg R ef. [26]) that can be written as a relation between the m assweighted m ean square velocity v^2 and the m ass autocorrelation function (r),

$$v^{2}(r) = 2 G_{b} J_{2}(r);$$

where b_{R} is the mean local mass density and $J_2(\mathbf{r}) = \int_0^{1/2} \mathbf{r} \, d\mathbf{r}$ (r). The galaxy-galaxy correlation function can be parametrized by (r) $(r=r_0)^{1:8}$ with $r_0 = 5h^{1}$ M pc, while the clustercluster correlation function has the sam e expression with $r_0 = 20h^{1}$ Mpc. This means that the velocity eld (11) should be proportional to $(r=r_0)^{0:2}$, unless the gravitational constant has som e scale dependence. So far the relation seem s to be satis ed, under rather large observational errors (see Ref. [27] for a review). Unfortunately, the errors are so large that it would be prem ature to infer from this a scale dependence of G. Even worse, phenom enologically there is a proportionality constant between the galaxy-galaxy correlation function and the actual mass correlation function, the so-called biasing factor, which is supposed to be scale dependent and could m in ic a variable gravitational constant. However, future sky surveys m ight be able to constrain m ore strongly the relation (11) by measuring peculiar velocities with better accuracy at larger distances and it m ight then be possible to extract the scaledependence of G.

5. CONCLUSIONS

We have seen that the running of the gravitational coupling is compatible with the observational fact that the rotation curves of galaxies are constant provided some amount of baryonic dark matter is allowed, actually about 44% less than what is required for a constant G. This could also explain why we see less m icrolensing events towards the halo than in the direction of the bulge of our galaxy. Failure in reproducing the predicted distribution of baryonic dark m atter would signal either that the approach adopted here is unsuitable or that the t (2) is inadequate. We have boked for possible bounds on variations of G with scale from prim ordial nucleosynthesis, variations in the period of binary pulsars, m acroscopic gravitational lensing and deviations in the peculiar velocity ows. Unfortunately, as observational errors tend to increase with the scale probed, we cannot yet seriuosly constrain an increase of G with scale, as proposed by the asym ptotically free theories of gravity.
