# Integral Transform Technique for $M$ eson $W$ ave Functions

#### Abstract

In a recent paper [1] we have proposed a new approach for extracting the wave function of the $m$ eson ' ( $x$ ) and the $m$ asses and wave functions of its rst resonances from the new QCD sum rules for non-diagonal correlators obtained in [2]. Here, we test our approach using an exactly solvable toy $m$ odelas an illustrating exam ple. W e dem onstrate the validity of the $m$ ethod and suggest a pure algebraic procedure for extracting the $m$ asses and wave functions relating to the case under investigation. W e also explore the stability of the procedure under perturbations of the theoretical part of the sum rule. In application to the pion case, this results not only in the $m$ ass and wave function of the rst resonance ( ${ }^{\circ}$ ), but also in the estim ation of ${ }^{\omega_{\mathrm{f}}}$ ass.

## 1 Introduction

An im portant problem in the theory of strong interactions is to calculate, from the rst principles of QCD, hadronic wave functions (W Fs)' ( x ), ' ${ }_{\mathrm{N}}\left(\mathrm{x}_{1} ; \mathrm{x}_{2} ; \mathrm{x}_{3}\right.$ );::: [3] that accum ulate necessary inform ation about the non-perturbative long-distance dynam ics of the theory. These phenom enological functions naturally appear as a result of applying \factorization theorem s" to hard exchusive processes [3], [4], 5]. It seem s now that only the QCD Sum Rule (SR) approach [6] and lattice calculations [7] can provide inform ation about the form of hadronic W Fs.

Them ost popular set ofhadronic wave functions, due to V .L.C hemyak and A.R . Zhitnitsky (CZ) [8], was produced w th the help of CCD SR for the rst moments ${ }^{N}{ }^{N} i_{h}(\mathbb{N}=2 ; 4$ ) of m esonsW Fs. But the $m$ ethod they used has three $m$ ain drawbacks:

1. reducing the initially non-localob jects to a few localones: hq (0)q(0)i; hG (0)G(0)i;:::, \{ leads to the fast grow th w th N of the pow er corrections in the operator product expansion (see discussion in [12]);
2. the reconstruction of the whole function' ( $x$ ) from just two non-trivialm om ents $h^{2} i$ and $h{ }^{4} \mathrm{i}$ is an unreliable procedure;
3. the phenom enologicalm odel of the spectraldensity, based on localquark-hadron duality, is too crude for QCD SRs for the W F .

Now it is known that the hadronic W Fs are rather sensitive to the structure of the nonperturbative vacuum [9]. Therefore one should use a non-localcondensate like hq (0)E (0;z)q(z)i and/or hG (0)E (0;z)G (z)i [10]which can re ect the com plicated structure of the $\mathrm{Q} C \mathrm{CD}$ vacuum . 3

Them odi ed QCD SR with non-local condensates have been constructed in [9] and it has been dem onstrated that the introduction of the correlation length for condensate distributions produces much sm aller values for the rst m om ents of the pion W F com pared to the CZ values (see also [11], [12]). This leads to a form of the pion W F strongly di erent from the CZ tw o-hum $p$ form and a little wider than the asym ptotic form ${ }^{\text {as }}(\mathrm{x})=6 \mathrm{x}\left(\begin{array}{ll}1 & \mathrm{x}\end{array}\right)$.

In our previous paper [1] we have obtained directly the form $s$ of the pion and its rst resonance $W$ Fs, using the available $s m$ ooth ansatze for the correlation functions of the nonlocal condensates and w ithout any suggestion about the quark-hadron duality for the spectral density. This program hasbeen suggested and realized in [2], and we have developed altemative $m$ ethods of extracting $W$ Fs from this sum rule for a non-diagonal correlator [1]. It should be $m$ entioned that we do not need the principle of stability over the B orel param eter $M^{2}$, and the BorelSR appears only at an interm ediate stage.

Here, we test our $m$ ethod using an exactly solvable $m$ odel as an exam ple (initiated by the two-dim ensional quantum $m$ echanical oscillator). W e dem onstrate the validity of the $m$ ethod and also suggest a pure algebraic procedure for extracting the $m$ asses and $W$ Fs of the particle under consideration. W e investigate the stability of the procedure to perturbations of the theoretical part of the sum rule and obtain som e results to believe that it works well in real QCD SR. In application to the pion case, this results in producing not only the m ass and W F of the rst resonance ( ${ }^{9}$ ) but also to provide an estim ate of the ${ }^{\infty} \mathrm{m}$ ass.

[^1]O ur quantitative results, i.e. the details of the W F shapes and the values of m asses, are dependent on the certain form of the ansatz used for the non-localcondensates. This form $m$ ay be obtained in a future theory of the Q CD vacuum. In the absence of such a theory the form of the ansatz was chosen as a phenom enological \input" (for details see [1]). From this point of view, our calculational schem e m ay be considered as a suitable fram ew ork for connecting the hadronic properties, on one hand, w ith the fiuture theory of the non-perturbative vacuum on the other.

## 2 N on-diagonal QCD SR for pion wave functions and the $M$ ethod of Integral Transform

### 2.1 N on-diagonalQ CD SR

The sum rule forthe \axial" W Fs' ::: (x) ofthe pseudoscalarm esons, based on the non-diagonal correlator of the axial and pseudoscalar currents

has been suggested in [2] and possesses som e rem arkable properties. For the W F s on the lh. s. of (1) one has

On the rh.s. of (1) there appears a single correlation function $f()$ param etrizing the $z^{2}$ dependence ${ }^{4}$ of the non-local quark condensate:

$H$ ere $D$ is the covariant derivative, ${ }_{q}^{2}$ can be treated as the average virtuality of vacuum quarks. Equation (1) dem onstrates in the most explicit $m$ anner that the distribution ' ( $x$ ) of quarks inside the pion over the longitudinal momentum fraction $x$ on the lh.s. of the equation is directly related to the distribution $f($ ) over the virtuality of the vacuum elds on the rh.s..

It should be noted that the sum rule (1) results from the approxim ations both in the theoretical (for a detailed discussion, see [2]) and the phenom enologicalparts (see [1]). These are

1. a reduction of three-point correlators to two-point ones;

[^2]2. a reduction of the quark-quark-ghon distribution function to a quark-quark one;
3. neglecting the contributions of higher non-local condensates, like hqG G qi;hqG G G qi; : : :;
4. a representation of the phenom enological spectral density (s) on $\operatorname{lh} . \mathrm{s}$. of the SR as a sum of very narrow resonances

In the present work we shall use a speci c form of the correlation function $f($ ), given by

A sw as established in our preceding paper [1], this ansatz (A 2-ansatz there) conform sw ith pion physics. A sim ilar form for the ansatz also appears in the fram ew ork of the instanton m odel for the non-perturbative vacuum ${ }^{5}$. H ere, the param eter ${ }^{2} 0.2 \mathrm{G} \mathrm{eV}^{2}$ was extracted from the $m$ eson $Q C D$ SR for the heavy-quark e ective theory [2]; the norm alization constant $N_{q}$ and the param eter are xed by Eq.(4). For the average virtuality of vacuum quarks we take the usualQCD sum nule value ${ }_{q}^{2}$, $0: 4 \mathrm{GeV}^{2}$ [14].

A $s$ is clear from the structure of the rh.s. of ( 1 ), the form of the function ( $\frac{1}{M^{2}} ; x$ ) on the variable x is given by two hum ps (one centered at $\mathrm{x}_{\mathrm{A}}=\mathrm{s}_{\mathrm{A}}=\mathrm{M}^{2}$, where $\mathrm{s}_{\mathrm{A}}$ is the point of $m$ axim um for the ansatz correlation function $f()$, and the other at $\left.x_{A}=1 \quad s_{A}=M^{2}\right) \mathrm{m}$ oving as $M^{2}$ changes. $W$ hen $M^{2}$ increases, the hum ps becom e narrow er, higher and m ore close to the boundary points $x=0$ or $x=1$. H ow ever, ( $\frac{1}{\mathrm{M}^{2}} ; x$ ) is not yet the pion $W \mathrm{~F}$ : the larger $\mathrm{M}^{2}$, the larger the contam ination from higher pseudoscalar states $0, \omega_{;}:::$. D ue to the properties sum m arized in (2), the corresponding W Fs should oscillate (see, e.g., Fig. 11); therefore the function $\left(\frac{1}{M^{2}} ; x\right)$ does not resemble to ${ }^{\prime}(x)$ at not su ciently low $M^{2}$.

At low $M^{2}$, the pion W $F$ dom inates in the total sum ( $\frac{1}{M^{2}} ; x$ ) (how ever, one cannot take too low $M^{2}$ because the operator product expansion fails for $M^{2}<{ }_{q}^{2}$ ). W hen $M^{2}=0: 4 \mathrm{GeV}^{2}$,迬 was observed that $\left(\frac{1}{M^{2}} ; x\right)$ is very close to the asym ptotic wave function of the pion (see [2]). But there is no strict criterion for selecting the value of $M^{2}$ to determ ine the $W$ F of the ground state (pion). O ur m ethod of extracting the W Fs and masses of resonances from (1) allow s one to avoid this problem .

### 2.2 The M ethod of Integral Transform

In what follow s it is convenient to use a new variable $1=M^{2}$ instead of the B orelparam eter $M^{2}$. Therh.s. ofSR (1), i.e., ( $; x$ ) is then de ned for $2\left[0 ; \frac{1}{2}\right]$. Let us consider this function in the whole com plex plane of and de ne the integral transform ation (IT) P ( N ; 0 ; ! ):

[^3]where the integration is perform ed along the vertical line $C=(c \quad i l ; c+i l) w$ ith $c$ lying to the right $w$ th respect to any pole of the integrand, $!>0$ and $02\left(0 ; \frac{1}{2}\right]$.

To obtain the result of this operator action on the initial SR representation (here $i_{i}=m_{i}^{2}$ )

consider its action on a simple exponentiale. Evidently, if! > we can close the contour $C$ to the left and get (due to the well-known residue theorem) the contribution from the pole at $=0$; if $>$ ! we can close the contour to the right and, due to the absence of poles in that part of com plex -plane, obtain 0 ; therefore

W e see that by varying! one can switch on (sw itch o ) successively more and more resonances on the lh.s. of the SR. So, we have obtained a realstep division ( m ooth at $\mathrm{N}>0$ ) of the set of resonances by the param eter ! in (9), instead of the exponential suppression of the whole set of resonances w ith respect to the inverse B orel param eter in (7). A ccordingly, the hadronic characteristics $f{ }_{i} ;^{\prime}{ }_{i}(x) g$ are determ ined by the positions of singularities (and zeros ) of the correlation function $\mathrm{f}(1=)$ in the com plex -plane.

Let us assume now that the $m$ ass values are known $0=0 ; \quad 1=\exp \quad 1: 7 \mathrm{GeV}^{2}$; ::: Then, we can obtain an expression for' (x) by em ploying equation (9) w th the param eter $!=!_{1} \quad 1$ that corresponds to the saturation of the ground state ${ }^{\prime}(\mathrm{x})$

The nal result should not depend on the param eter N strongly. H ow ever, in a real life we don't know the position 1 exactly; therefore we may get contam ination from the next state. $T$ his contam ination becom es sm aller when $N$ increases due to the pow er suppression near the threshold 1 (see lh.s. of Eq. (9)). O ne should also take into account that the $W \mathrm{~F}$ form is saturated sm oothly in the region ! < 1 and its norm reaches unity at the end of the region. The curves corresponding to the function $'(x)={ }_{N}\left(!_{1} \quad 1 ; x\right)$ are shown in $F i g .2$ for di erent values of N . Their form varies very slightly w th $\mathrm{N}=1 ; 2 ; 3$ (the same happens when the param eter 0 decreases from $2: 5$ to $1: 5 \mathrm{GeV}^{2}$, see the discussion in [1]) and is alw ays som ew hat narrow er than the asym ptotic one. N ote that form ula (10) m ay be easily generalized to a state with a nite width (see [1]). The contribution to the pion W F due to nite width e ects is not signi cant num erically.

W e now describe the pure algebraic procedure that allow s one to extract from the SR (9) both the positions ( $i_{i}$ ) and the W Fs ( ${ }_{i}(\mathrm{x})$ ). T he procedure will be based on the sim ple step representation appearing on the lh. s. of (9). Indeed, let us consider the di erence

W e see that the sam e contributions due to $'(x)$ are canclled out and this di erence becom es non-zero just after! > ${ }_{1}$ :

Therefore, this di erence is a trigger for the rst resonance \{ the function $D_{1}{ }_{\mathrm{N}}(!; \mathrm{x}) \mathrm{m}$ ust have a root at ! = 1 that xes the resonance (at xedx). A nalogous trigger-like di erences could be constructed for higher resonances. By induction, let the di erence $D_{n}$ is trigger-like for the $n$-th resonance (i.e., it has a root at $!={ }_{n}$ ) and has the follow ing form

Then the di erence $D_{n+1}$ is de ned recursively by the recurrence relation

H ence, $w$ th the help of these trigger-like di erences one can easily determ ine successively the $m$ asses ${ }_{i}$. A fter that it is straightforw and to determ ine the W Fs ${ }^{\prime}{ }_{i}(x)$ itself, i.e.:

where the value of the param eter ! 2 ( $\left.1_{1} \sum_{2}\right]$ corresponds to saturation of the rst resonance. $O$ ne can try the other form ula for ${ }^{\prime}{ }_{1}(x)$ follow ing from (12), viz.

The function ' ${ }_{1}(x)$ in (17) should not depend on the value of $N$ in an appreciable $m$ anner when the saturation of the resonance is reached.

## 3 A n exactly solvable toy m odel

The above form ulated procedure is based on the understanding of the initial SR (1) as an exact equality. But in the real case the connection between the non-perturbative vacuum distribution $f()$ on the rhs of $S R$ and the pseudoscalar $m$ eson properties re ected on by the spectral expansion ${ }_{i}{ }^{\prime}{ }_{i}(x) \exp (i)$ on the rh.s. of $S R$ is only an approxim ation. To understand the reliability of the suggested technique (IT ) as an approxim ated equality, it should be useful to check it, rst, w ith a model ( ; x) having an exact spectral expansion. A fter that we deform $(; x)$ in som e special way to destroy the exact equality in the spectral expansion w ith the initial W Fs and masses, and apply our procedure again. Follow ing this way, one $m$ ay investigate the stability of the procedure to perturbations and its suitability. W e hope, despite the fact that the exact equality is broken, that the procedure will \work" and that the new extracted param eters $f{ }_{i}^{0} ;_{i}^{0}(x) g$ will be close to the initial values, if the is not too strong. Only in this case our procedure $m$ akes sense.

### 3.1 Form ulating the model

W e should like to test our approach for som e sim ple exactly solvable m odel. W e select one which originates from the 2D harm onic oscillator problem in quantum $m$ echanics (form ore details see ref.[15]). The B orel transform ed Green function M ( ;x) of the 2D harm onic oscillator (w ith $!_{0}=1$ ) in the coordinate representation

The spectrum of this $m$ odel (as one can easily see from the geom etric progression sum $m$ ation form ula) is equidistant w ith a two-fold step

W e can also w rite dow $n$ an explicit analytical form for $M(; r) w$ th $r \in 0$, but there is no need for this, since we shall work, for sim plicity, w ith a m odi ed quantity. To this end, we de ne the function

This toy m odel has a nice feature: all its resonance W Fs are de ned through one W F , nam ely the $W$ F of the rst resonance ${ }_{1}(x)=(x)$ which can be selected at free choice. For our convenience, we take the follow ing form

i.e., the asym ptotic $W \mathrm{~F}$ of the pion (albeit w ith w rong norm alization).

### 3.2 IT technique for the toy m odel

For evaluating ${ }_{\mathrm{n}}(!; \mathrm{x})$ in our toy m odel, we use the well-known residuestechnique. Separating residues (see Fig. 1) from the opole ( $0, \mathrm{~N}$ ) and the poles $n(x)(x)+$ i $_{n}$ w ith ( $x$ ) $\frac{1}{2} \log ((\mathrm{x}))(\mathrm{N})$, we obtain

Saying \exact" we mean, that this $S R$ is valid for all x $2[0 ; 1]$ and for all!. M oreover, it holds also for all choices of the initialW $F$ ( $x$ )! This behavior is shown explicitly in $F$ ig. 3, where the step-like structure on the lh.s. of SR (see (27)) is reproduced by its rh.s. (see (24)). O ur trigger-like di erences exactly determ ine $m$ asses $k=2 k$ and the corresponding $\mathrm{WFS}^{\prime}{ }_{\mathrm{k}}(\mathrm{x})=(\mathrm{x})^{\mathrm{k}}$.

### 3.3 D eform ations of (;x) and the IT-procedure

A $l l$ form ulas of the preceding subsection are exact (they are in som e sense identities). But in reallCD problem s we have no such regular behavior of the theoretical part of the SR and one can use the spectral expansion only approxim ately. M oreover, we cannot be sure about the adequacy of ansatz (5) for the tnue non-perturbative am plitude in the whole region of variables. $H$ aving this in $m$ ind, let us inspect the stability of the suggested procedure under perturbations of the rhs. of (9).

The rst problem here is the follow ing: how can one deform the original function ( x ) while retaining the possibility of controlling the degree of this deform ation?

W e apply the follow ing $m$ ethod. As we know, the fiunction ( $; x)$ can be expanded in a series of poles over the variable :

If we exclude in this expansion a set of poles, we obtain som e deform ed function. It should be stressed that this function does not have the sam e spectral expansion as the original one. Let us consider our IT -procedure w th these deform ed functions. The exact result for the di erence $\mathrm{D}_{1} 1$ is reproduced in Fig . 4. The deform ations we have determ ined will destroy the exact step-structure on the lh.s. of (9) and (13). This procedure proceeds as follow s.

1. At rst we exclude all the poles $n(x) w i t h ~ j i>K$ (the corresponding deform ed $w$ ill be denoted as (! ; $\mathrm{x} ; \mathrm{K})$ ). Fig. 5 contains the curve for $\mathrm{D}_{1} 1(!; \mathrm{x} ; \mathrm{K}=6)$. As we can conclude in this case, the situation is ne: the $m$ ain deviations from (! 2) are located near the origin (! 0:2). The locations of resonances are well-determ ined.
2. At the next step we exclude also the last six poles ( $j \mathrm{j}=3 ; 4$ and 5 ). The corresponding curve for $D_{1}(!; x ; K=3)$ is reproduced in $F$ ig. 6. The situation is still good: though deviations from (! 2) are larger relative to $K=6$, they do not extend over! $0: 2$. The locations of resonances are also well-determ ined and our \triggering" is still valid.
3. The last step is to exchude the sam e poles as in the rst case, but in addition also those w ith $\mathrm{n}=1$. The curve for $\mathrm{D}_{1} 1(!; \mathrm{x} ; \mathrm{K}=6+1)$ is reproduced in F ig. 7. N ow the pattem is changed: deviations form the initial form are large and they reach ! $=1$. Indeed, this new form is rather close to (! 1) : there exists the zero for ! = 1 where the original function has no resonances at all. $G$ oing through the procedure $w$ ith this value ( $1=1$ ) for the $m$ ass of the rst resonance, we obtain the new spectrum $k=k w$ ith the new resonance $W \mathrm{FSf}^{\prime}{ }_{k}(\mathrm{x}) \mathrm{g} \mathrm{E}^{\mathrm{k}}(\mathrm{x})$. The crucial indication for the correctness of
such an interpretation is the sm allness of the de cit of the intialsR

W e evaluate this quantity for the new and for the initial spectra and obtain a clear signal that the new one provides the genuine description of the SR (see Fig. 8 and 9).

A s to the extracted wave functions ${ }^{\prime} k(x)$, we can characterize their evolution under deform ations by the follow ing statem ents:
opposed to the exact solution, $\mathrm{f}^{\prime}{ }_{\mathrm{k}}(\mathrm{x}) \mathrm{g}$ becom e ! -dependent when ! 2 ( i ; i+ 1 ]. They tend to the exact ones $w$ th ! $m$ ore close to the right end of the corresponding interval (see Fig. 10);
the di erence between ${ }_{k}(\mathrm{x})$ and the exact W F of the k -th resonance becom es stronger for higher $k$ (ie. for highly exited states; see F ig. 10).

To conclude these investigations: the $m$ ethod really works, even for strong deform ations of the structure of the initialspectrum as the last exam ple ofdeform ation dem onstrates. M oreover, we see that deform ations of the analytical structure of the intial ( ; x; ) in the complex plane far from (near) them ain pole $=(x)$ produce sm all (large) deform ations of the spectrum and the W Fs. Therefore, the know ledge of the analytic properties of the function (;x) in a region in the com plex -plane when includes the pole $=(x)$ and a few others appears to be su cient for obtaining inform ation on the rst few resonanœes and their W Fs. W e hope that an analogous situation appears in the SR for pion.

## 4 IT -procedure for the pion and its resonances

A pplying the algebraic procedures to the IT of SR (1) we arrive at the follow ing results:

1. For ! $=!=1: 8 \mathrm{GeV}^{2}$, the di erence $\mathrm{D}_{1}(!; 1=2)$ is equalto zero and $w$ ith increasing ! it becom es negative (this $m$ eans that $\left.{ }_{1}(1=2)<0\right)$. This value of the rst-resonance $m$ ass is quite reasonable for the pion case, the experm ental one being ${ }_{1}^{\exp }=\mathrm{m}^{2}{ }_{0} \quad 1: 7 \mathrm{GeV}^{2}$ (at the fullwidth $0=0: 2 \quad 0: 6 \mathrm{GeV}$ ). The pion $\mathrm{WF}^{\prime}(\mathrm{x})$, corresponding to this ! has ben obtained from expression (10) in subsection 22 ( $s e \mathrm{~F}$ ig. g-A 2-123). Its w idth is traditionally characterized by the value of the second $m$ om ent $\left\{h^{2} i_{R_{1}} \quad 0: 17\right.$. A nother characteristic often appearing in form factor calculations is the integral ${ }_{0}^{{ }^{1}}$, $(x)=x d x \quad 2: 8$. N ote that the m ethod does not work properly in the neighborhood of the endpoints $\mathrm{x}=0$ and $x=1$ of the W F.T herefore, to estim ate the above values, one should exclude these regions in the integral.

It should be em phasized that $1(!; x)$ im titates the lh.s. of the SR as a function of ! rather well, despite its di erent origin. N ote here that the position of the root! depends also on the value of $x$ : in the region $0: 35 \mathrm{x} \quad 0: 65$ this dependence is rather weak. W e don't see the step structure on the lh.s. of Eq. (12) \{ the structure is destroyed due to the em ploym ent of too crude approxim ations in the theoretical part of the SR. Follow ing
our experience in the "exactly solvable toy model" considered in subsection 3.3, we m ay hope, nevertheless, that the roots of the few trigger di erences $\mathrm{D}_{1 ; 2 ;:: \text { к (! ;1=2) yield }}$ reliable approxim ations for the $m$ asses.
2. The saturation by the rst resonance is reached near! $3 \mathrm{GeV}^{2}$. The curves corresponding to the resonance ${ }_{1}(\mathrm{x})$ (for ! $3 \mathrm{GeV}^{2}$ ) are show $n$ in F ig. 11 .
3. The last inform ation we can extract in this case is the position of the second resonance: the equation $D_{2} 1(!; x)=0$ gives us the range of values ! $=2=34 \mathrm{GeV}^{2}$, which is converted to the m ass value $\mathrm{m}_{2}=1: 86 \quad 0: 14 \mathrm{G} \mathrm{eV}$. The experim ental param eters for this resonance are still in question in the Particle D ata booklet (A pril 1994). H ow ever, the recent $m$ easurem ents in [17] œertainly provide for the $m$ ass $m \quad 1: 78 \quad 0: 007 \mathrm{GeV}$ (at fiullw idth $\quad \infty=0: 16 \mathrm{GeV}$ ), which is rather close to our estim ate.

## 5 C onclusion

W e have considered a m odelSR for the pion and the pseudoscalar resonance $W$ F sbased on the non-diagonal correlator introduced in [2]. The theoretical side (rh.s.) of this sum rule depends only on the non-local condensate. W e have tested the approach proposed in our recent paper [1], which enables one to extract W Fs and $m$ asses from this SR, using the exactly solvable toy $m$ odel as an exam ple. $W$ e dem onstrated the validity of the $m$ ethod and suggested a pure algebraic procedure for extracting the $m$ asses and $W$ Fs relating to the case under investigation. We investigated also the stability of the procedure under perturbations of the theoretical part of the sum rule. $W$ e obtained as a result that the $m$ ost crucial dom ain in the com plex plane of
$=\mathrm{M}^{2}$ is the neighborhood of the poles lying on the realaxes $\{$ the perturbations near these points essentially reorganize the spectral expansion under investigation. A pplying this $m$ ethod to the pion case and using one of the ansatze given in [1] not only the $m$ ass and $W \mathrm{~F}$ of the rst resonance ( ${ }^{\circ}$ ) have been derived, but also the $m$ ass of ${ }^{\infty}$. O ur results con $m$ the $m$ ain conclusions about the shapes of the W $F$ of the pion and its resonances, obtained in [2].

It should be $m$ entioned that the speci c form of the ansatz for the correlation function f ( ) plays an im portant role in determ ining concrete values ofm asses and shapes of the W Fs corresponding exactly to the pion resonances (on the contrary, the W F of the pion ground state is not too sensitive to the shape of the ansatz). We have chosen our ansatz (5) am ong others (see e.g. [1]) just due to this reason. So, one $m$ ay consider it as a rst step towards solving the inverse problem, nam ely to obtain the vacuum condensate properties from hadron phenom enology.
