Supernatural In ation: In ation from Supersymmetry with No (Very) Small

Param eters

Abstract

M ost models of in ation have small parameters, either to guarantee su cient in ation or the correct magnitude of the density perturbations. In this paper we show that, in supersymmetric theories with weak scale supersymmetry breaking, one can construct viable in ationary models in which the requisite parameters appear naturally in the form of the ratio of mass scales that are already present in the theory. Successful in ationary models can be constructed from the at-direction elds of a renormalizable supersymmetric potential, and such models can be realized even in the context of a simple GUT extension of the MSSM. We evade naive \naturalness" arguments by allowing form ore than one eld to be relevant to in ation, as in \hybrid in ation" models, and we argue that this is the most natural possibility if in atom elds are to be associated with at direction elds of a supersymmetric theory. Such models predict a very low Hubble constant during in ation, of order 10^3-10^4 G eV, a scalar density perturbation index n which is very close to or greater than unity, and negligible tensor perturbations. In addition, these models lead to a large spike in the density perturbation spectrum at short wavelengths.

In ationary models [1] in general require small parameters in the particle theory Lagrangian, to provide the at potential needed for su cient in ation and for the correct magnitude of density uctuations. The need for unmotivated small parameters tends to weaken the credibility of a theory, so one hopes that the origin of these parameters can be understood. It is conceivable, of course, that the explanation lies beyond our present understanding, just as we presently have no accepted explanation of why the Yukawa coupling of the electron is 2 10^6 , or why the weak scale lies 17 orders of magnitude below the P lanck scale. Nonetheless, it would be encouraging to nd that the small parameters required by in ation could be obtained from small parameters are introduced. M odels in which the small parameters arise as ratios of known particle physics mass scales are particularly attractive [2].

From a eld theoretical perspective, it is di cult to see how at direction elds can be present in a nonsupersymmetric theory (with the exception of G oldstone bosons, considered in Ref. [3]) given the elect of radiative corrections. We will assume therefore that the world is supersymmetric, and ask whether an in ationary potential can arise naturally in the context of the mass scales which we expect might be present. Some natural candidates for these scales could be the P lanck scale M $_{\rm p}$ 10⁹ G eV, the GUT scale M $_{\rm G}$ 10⁶ G eV, the intermediate scale M $_{\rm I}$ 10¹¹ G eV, and the supersymmetry breaking scale m $_{3=2}$ 1 TeV.

However, straightforward considerations show that it is di cult to implement this strategy. The magnitude of density perturbations points to the GUT scale as setting the energy density during in ation, since $(M_{GUT} = M_p)^2 = 10^6$. Although suggestive, it is di cult to exploit this high scale in an in ationary model. In Ref. [4] it was argued that the necessity for cancelling the cosm ological constant after in ation provides signi cant restrictions on a model in which the in ation scale is greater than the supersymmetry breaking scale. Models have been suggested in which the energy density in the early universe is well above the low energy supersymmetry breaking scale, and m ight be governed for example by the value of a moduli eld [5,6]. For these models, it must be checked that the constraint of Ref. [4] is satis ed. Beyond this, however, it is di cult to study such models in detail without a concrete realization.

It m ight also be that the in ation scale is generated by GUT physics. An interesting example of this type of model is Ref. [7]. It is however questionable whether the GUT scale exists as a fundam ental scale of particle physics at all in light of the doublet-triplet splitting problem [8]. Furthermore, it is likely that the in atom eld would be charged under the GUT group and the reheat tem perature would be too high (in excess of the gravitino bound).

In the context of supersymmetric models, an attractive scale for the vacuum energy density during in ation would be set by the intermediate scale, $M_{\rm I}$. This scale is very likely to be present in a hidden sector model of supersymmetry breaking. It is also the right energy scale for the potential associated with moduli elds, which might be natural candidates for at directions. The problem here, however, is that simple dimensional analysis arguments (to be reviewed in Sec. 2) show that density perturbations would generically be either far too small [9,4] or far too large, depending on assumptions. For the case of in ation

driven by a single moduli eld, the dimensional arguments show that the requirements of su cient in ation and correct density perturbations imply that 1) the variation of the in atom (moduli) eld during in ation is of order M $_{\rm p}$, and 2) the energy density during in ation is of order M $_{\rm I}^4$ would produce density perturbations too small by about ten orders of magnitude. For the case of a chaotic in ationary scenario, the variation of the in atom is again of order M $_{\rm p}$, but in this case the density perturbations are much too large unless the quartic coupling is about 10 12 .

In this paper, we show that the argument that in ation at an intermediate scale is untenable lacks su cient generality, and can evaporate if one drops the assumption that in ation is driven by a single scalar eld. We describe a class of two-eld models, for which dimensional analysis estimates show that 1) the variation of the in atom is of order M_I or less, and 2) the energy density during in ation is of order M_I⁴. We then go on to illustrate these ideas with models motivated by supersymmetry with soft supersymmetry breaking. We will not that these models not only solve the naturalness problem of obtaining su ciently many e-foldings of in ation, but also generate very nearly the correct size of density perturbations based on the parameters of supersymmetry breaking. We therefore refer to our models as 'supernatural" in ation.

This model contains a similar structure to the \hybrid" in ation models, proposed by Linde and studied by Copeland, Liddle, Lyth, Stewart, and W ands [10]. The fact that the standard dimensional naturalness arguments for the number of e-foldings and for = do not apply, and that the Hubble scale during in ation will be low was also clearly recognized by these authors. Our point here is to emphasize that the most natural scales for successful implementation of two eld in ation of the \waterfall" type are the scales associated with supersymmetry breaking and the Planck scale. Furthermore, our models more accurately recognized by the context of SUSY leads one to the interesting conclusion that the Hubble scale during the in ation which established the density perturbations might have been of order $10^3 \{10^4 \text{ GeV}$, rather than 10^{13} GeV .

In the following section, we present the general arguments for why supersymmetry scales do not work in single eld in ation models. We then review the general idea of \hybrid" or \waterfall" [10] models, and show why the single-eld arguments do not apply to the two-eld case. In Section 3, we present supernatural in ation models, in which we assume the in ation sector consists of at direction elds whose potential is generated through supersymmetry breaking and nonrenormalizable operators. We derive the constraints on parameters consistent with the requisite number of e-foldings and density perturbations. In Section 4 we explore the possibility of a renormalizable coupling between the at direction elds. In the following section we motivate the models of Sections 3 and 4 by brie y considering at direction elds in the standard model, and present an illustration of the model of Section 4 in the context of a GUT extension of the MSSM. In Section 6, we give details of the evolution of the two elds in our models. We analyze the density perturbations that result from this evolution, and discover a novel spike that is predicted to appear at short wavelengths. Such a spike could lead to overproduction of black holes, but we show in Section 7 that existing constraints on black holes are satis ed for the parameters of interest. In

Section 8, we show that the therm alproduction of gravitinos is also not a problem in our models. In the following section we show that successful baryogenesis can be accomplished in the context of late in ation. In Section 9, we discuss m iscellaneous aspects of our models, and in Section 10, we conclude.

II.ONE VS.TW O FIELD INFLATION

We begin this section by reviewing the standard arguments for why the in atom in natural in ationary models varies on the scale M _p and why the scale for the energy density should be larger than the intermediate scale in in ationary models with a single eld.

For the purposes of these dimensional arguments, we rst assume the potential takes the form

where G is a bounded function of order unity. Here we have in m ind for example a m oduli eld, with M M_{I} . If we assume the slow roll equation of m otion $3H = V^{0}$, where H is the Hubble constant during in ation, the number of e-foldings is

There are essentially two possibilities. If G is a bounded function, and G^0 is not very tuned to have very at sections, one is in the regime of what m ight be expected for a moduli type

eld. In this case, the requirem ent of about 60 e-foldings of in ation favors f of order M $_p$ and a change in during in ation at least of order M $_p$. Even when this is satis ed, som e tuning of the potential is required.

The alternative possibility is that one is in a chaotic [11] in ationary scenario, in which case G will be dominated by monom ial behavior for su ciently large eld, and V 0 V=. In this case, f is not de ned, but one would still conclude M $_{\rm p}$.

Density uctuations are also readily estimated under the assumed form of the potential. They are given by

A ssum ing a potential of the m oduli type, with G and G^0 of order unity and f of order M_p, we may that $-\frac{M}{M_p}^2$ favoring M $10^3 M_p$. Detailed calculations m ight change M by an order of m agnitude or so, but it is clear that M 10^{11} GeV M_I is strongly disfavored.

In a chaotic scenario on the other hand, one would conclude that the density uctuations are too large unless there is a sm all parameter. For example, a simple dimensional argument would lead to the conclusion that for $V = \frac{4}{7}$, 10^{12} . W ithout further motivation for these sm all numbers, such a potential seem s unlikely.

So one is led to the conclusion that it is di cult to naturally obtain su ciently m any e-foldings and the correct m agnitude of density perturbations, without invoking either sm all num bers or a new m ass scale.

It is apparent, however, that there is a bophole in the above argument. From Eq. (2) it is clear that the constraints on f and during in ation arise because it is the same potentialV () that controls the in ation rate H and the speed of the in atom eld —. These constraints can be avoided, therefore, if the energy density during in ation is provided from some source other than the scalar eld which rolls and controls the ending of in ation.

The simplest way to implement this idea would be with two elds. This idea is essentially that rst proposed by Linde [10] as \hybrid" in ation or \waterfall" models. There are two elds and . The rst eld, which we call the in aton, has a very at potential. It starts at a large eld value, and slow ly rolls (via its classical eld equations) to the origin.

The second eld, , has a potential whose minimum is far from the origin. In most previous incarnations of hybrid in ation, the scale of variation of this eld is M_I, though in our models the scale will be M_p. When has large eld value, it gives a positive mass squared term in the potential at the origin, so the classical eld equations push to the origin. When gets su ciently small (of order M_I or less in our models), the mass squared of goes negative, and makes the transition from the origin to M_p.

The key feature of thism odel is that the energy density during in ation is dom inated by the potential energy of the eld at = 0. There are no tunings in the potential to get a sm allm ass during in ation and a large m ass afterwards, since its m ass is always sm all, as is its potential energy. Because H depends on the value of and is not determ ined by the eld , which acts as a sw itch to end in ation, the naive estim ates do not apply.

The second key feature of this model is that the ending of in ation is controlled by when the mass squared at the origin changes sign. One can obtain a large number of e-foldings with the variation of the in atom eld much less than M_p . Let us see this explicitly.

W e assum e a potential which takes the form

where M and f are to be determined, the function g is the term responsible for the dependence of the mass, and m is of order $m_{3=2}$.

W e now have

Notice that the scale M in the numerator is independent of the mass and coupling of the eld (in the lim it that the contribution to the energy density is small) so that the previous arguments for one-eld in ation no longer apply. Clearly for in ation to give several e-foldings requires only that changes by an order of magnitude, and that M⁴ > m²M_p². No in aton variation of order M_p is required, and so far, it seems M M_I could be a good choice.

Let us now consider density uctuations under the same assumed form for the potential. We nd

The point is that the numerator H 3 has its scale set by the potential energy while the denominator is determined by the eld. We construct a model so that at the end of

in ation is of the order M_I or smaller. If we also take M M_I, we nd = M_I=M_p or bigger (rather than $(M_I=M_p)^2$ as was the case in single eld models). A lthough the coupling between the elds can have a coe cient which varies by m any orders of m agnitude, as does in eqn. (6), the strong M dependence of Eqn. (6) allows for agreement with the COBE constraint with only a relatively small M variation. This is very promising from the perspective of relating in ation models to real scales of particle physics. To answer the questions of how well these ideas really work, and how constrained the parameters of the models really are, requires a detailed investigation of particular examples of these ideas.

III. SUPERNATURAL INFLATION

We de ne Flat D irection Hybrid In ation (FDHI) models as those motivated by the properties of moduli elds or at directions of the standard model. For moduli elds with no gauge charge or superpotential, the whole potential arises from the Kahler potential once supersymmetry is broken. This potential for and will take the form

where the dimensionless coe cients in f should be of order unity.

However, it is clear that a model of this sort will not give rise to in ation with su ciently large density uctuations, since during the relevant period will typically be of order M_p, and the resulting = will be of order $(M_I = M_p)^2$. We conclude that it is essential to have an additional interaction between and . In this model, we assume the existence of a superpotential which couples and but which is suppressed by a large mass scale M⁰. For standard model at directions, such higher dimension operators are to be expected, with M⁰ equal to M_p, M_G, or some dynam ical scale. In the case of moduli elds, it might be that this scale is of dynam ical origin; one can readily determ ine how the answer changes with the form of the superpotential and the size of the mass scale.

W e therefore assume the presence of a superpotential. The example we take is

We now need to specify the form of the supersymmetry breaking potential. We assume both and have mass of order the soft SUSY breaking scale of order 1 TeV (where we will need to test the consistency of this assumption). We assume that the potential for the eld gives a positive mass squared at the origin, while the eld has negative mass squared at the origin. Furtherm ore, we assume that the cosm ological constant is zero at the minimum of both and . The specie c form of the potential we choose is

where again we assume (and verify for consistent in ation) M M_{I} . When the parameters are motivated by supersymmetry breaking, we refer to our models by the name supernatural in ation. We will see that one very naturally obtains the correct magnitude of density

perturbations, and su ciently m any e-foldings of in ation, using parameters and a potential which are well m otivated in supersymmetric models.

For the purpose of the in ationary model, the scalar eld can be assumed to be real. Dening $(+ i_{I}) = 2$ and a similar equation for , the potential for the real elds becomes

The mass is m and the magnitude of the (imaginary) mass term (at the origin) is m $M^2=f$. During in ation, is conned near the origin. The eld slow ly rolls towards the origin and in ation ends about when $=_{c} = \frac{q}{2M} \, {}^{0}m$. It will turn out that either m = or $M^{0}=M_{p}$ is small, so that during in ation the term m^{2} is small relative to M^{4} . The Hubble parameter during in ation is therefore approximately $H = \frac{q}{8} = 3M^{2}=M_{p}$.

We expect f is of order M_P, or equivalently, m² is of order m²₃₌₂. Although it looks like we took a very special form for the -potential in Eq. (9), the use of the cosine is not essential. As can be seen from a Taylor expansion, only at the very late stages of in ation are terms other than the constant and mass term relevant. We could equally well have specied a potential which is truncated at fith order in the elds, or which has di erent higher order terms. Although both and might be moduli or standard model at direction elds, we assume their potentials are of very di erent form; the particular case we assume is illustrative of how a model could work.

The constraint from density perturbations in the slow-roll regime is [12,13]

where the approximation in Eq. (13) is required if the slow roll conditions are satisfied. Here we have defined = m = H and have measured time in e-foldings away from the time N = 0 when $= _{c}$ (where in ation ends at positive N). It is clear that a lower M⁰ makes the value of at the end of in ation lower, which in turn increases the density perturbations. The exponential in Eq. (12) determ ines the scale dependence of the density perturbations, characterized by the scalar index.

The scalar index $_{\rm s}$ is readily determ ined from the scale dependence of the density perturbations to be 2 =3. This can be seen directly from the form ula for density perturbations above. A lternatively, it is extracted from the general form ula [14]

where dimensionful factors should be compensated by M_p . Notice that the second term is negligible for all models for which the in atom eld value is much less than M_p . This is readily seen from the fourth expression in Eqn. 2, which implies $M_p^V = V = (N M_p)$. The third term is positive in our model, because the in atom eld rolls toward, rather than away, from the origin during the end of in ation.

We see for this model that n is always greater than 1, and is very close to 1 for small




FIG.1. Parameter choices for supernatural in ation with M^0 at the Planck scale. Here is chosen to give the correct magnitude of density uctuations for the minimum consistent with a su ciently rapid end to in aton.

, which is the case for large M 0 . This di ers from the usual prediction for new in ation or chaotic in ation m odels. The current upper bound on n is uncertain as is summarized in Ref. [15]. These bounds, along with the validity of slow roll, prevent too large values of . From Figures 1-3, we see large is permitted only for the smallest value of M 0 , where the bound on n will provide an additional constraint.

The fact that n is greater than or close to 1 is a characteristic feature of our models, which should help them to be distinguishable in the future, when a good measurement of the CMBR is obtained.

Another distinctive feature of these models is that the ratio of the tensor to scalar contribution to the quadrupole

Again this follows from the small value of the in aton eld near the end of in ation.

As we have argued in the rst section, models of in ation which have only a single eld should have the in atom eld taking a value of order M $_{\rm p}$ near the end of in ation if 50 e-foldings are to be obtained without ne tuning. The combination of negligible R and n never below 1 are distinctive features of these models which should help distinguish them from other possible in ationary models in the future.

In Figs. 1{3, we show values of the parameters when M⁰ M_p, M⁰ M_{GUT} and M⁰ M_I respectively. The values shown were found by in posing the correct magnitude of density uctuations and choosing the minimum m =H consistent with a su ciently rapid end of in ation (see Sec. 6). We chose the range of M to optimize parameters. Sm aller M would increase the values of 1= and . Large M would improve (that is, decrease) these ratios but would make the masses uncom fortably large relative to the TeV scale. We not that sm aller M ⁰ gives m ore natural ratios for the mass to the Hubble scale, though in all cases a ratio of less than 100 can be obtained.

These constraints assumed that the contribution of $\$ to density perturbations was small. In order to check the consistency of this assumption, we need to consider the evolution of

and in the late stages of in ation. It will turn out that in ation must end reasonably quickly after reaches $_{\rm c}$ so that perturbations exit the horizon while the eld is still con ned to the origin. This gives a lower bound on $\,$. In Sec. 6, we will investigate the mass constraint in detail.




FIG.2. Parameters for supernatural in ation with M^0 at the GUT scale. The values were chosen by the same criteria used in Fig.1.




FIG.3. Parameters for supernatural in $ation with M^0$ at the intermediate scale.

IV.ANOTHER MODEL

In Section 3, we investigated the possibility that there is a nonrenormalizable superpotential. However, it is frequently the case that at directions lift each other; that is, the renormalizable potential does not permit certain eld directions to be simultaneously at. In this section, we present an alternative model with a renormalizable potential. It will turn out that this model requires a small coupling in the potential. We will motivate this assumption in Section 5, where we consider particular choices of and chosen from the supersymmetric standard model where we will show that the small coupling can actually be related to one of the known small Y ukawa couplings! O noe we assume this small parameter (again an unexplained but perhaps necessary parameter of the M SSM) we will not that and can both be close to unity.

So we take the potential to contain the soft supersymmetry breaking terms as before but to contain a renormalizable coupling between and . Specifically

This model has the essential features of the FDHIm odel of the previous section. The di erence is the value of $_{\rm c}$ which in this model is




FIG. 4. Parameter choices for supernatural in ation with renormalizable couplings, for = 10^4 . Like the previous gures, this graph shows the parameters associated with the minimal allowed value of .

If is of order unity, to satisfy Eq. (18) requires $> 10^3$. However, if 10^4 10⁵, the model works perfectly with and both of order unity. In Fig. 4 we plot the parameters of the model for $= 10^4$, where again we have chosen the minimum consistent with a su ciently quick end to in ation. We see there is virtually no ne tuning, so long as a small exists (!). In the following section, we explain why such a small value for is not necessarily unexpected.

V.EXAM PLES OF \FLAT D IRECTION " INTERACTION POTENTIALS

Up to this point we have considered abstractly how to make a successful in ation model premised on properties motivated by at direction elds. In this section, we motivate the sort of models we have considered by demonstrating examples of at direction elds in the MSSM whose couplings are those required for a successful supernatural in ation model. However, because the eld minimum is not at zero, which in the context of the standard model would imply large gauge symmetry breaking, the minimal standard model is not appropriate. Nevertheless, in simple extensions of the standard model, there are neutral elds which can play the role of the eld. We will present an example of a GUT extension of the MSSM which could contain appropriate $\$ and $\$ elds.

We rst present a few interesting cases of the form of the superpotential which arises in the context of the M SSM . O ther at direction possibilities could motivate further generalizations of the models we have studied. F lat directions of the M SSM were considered in Ref. [16] and a complete analysis was given in Ref. [17]. They can be parameterized by gauge invariant combinations of elds. For example, the at direction $H_u^1 = H_d^2 = w$ ill be denoted as $= H_u^1 H_d^2$ where we have given explicit gauge indices. In each case, it is necessary to explicitly check for F – atness by examining the form of the superpotential.

Example: = $u_1^{-1}d_1^2d_2^3$, = $Q_2^{-1}d_3^{-1}L_2 W$ = $QuQd=M^0$. The superscripts here refer to the color indices and the subscripts to avor indices. We haven't specified the indices in the superpotential where in principle all allowed contractions can appear in different terms. This model would agree with the physics of our instimodel of in ation, except that the superpotential actually takes the form ${}^2 X = M^0 + {}^2 X = M^0$, where X is a eld which is not at and which stays at zero during the relevant stages of in ation. This can be seen by explicitly substituting $u_1^1 = d_1^2 = d_2^3 = {}^2ad_2 = {}^2ad_3 = L_2 = {}^2ad_3 = L_2 = {}^2ad_3 = {}^$

Example: $= LH_{u}$, $= H_{u}H_{d}$

In this example, SU (2) D terms will lift the at direction. This can be seen by solving for the elds in terms of the at directions and substituting into the D terms of SU (2). It can be seen that the D term does not vanish, but can involve a 2 cross term, suppressed only by g_2^2 , where g_2 is the SU (2) gauge coupling. As discussed in Section 4, a model of this sort with a large gauge coupling can work, but requires tuning .

Example: = udd, = LH_u , $W = _uQ_uH_uu$

This example realizes perfectly our scenario with a renorm alizable potential generated by a small Yukawa coupling, but not a large gauge coupling. In fact, if it is indeed the up quark in the eld, the potential works as well as could be hoped, since it depends on $\frac{2}{u}$ ² ² which as we have shown gives and of order unity. In this model, the small size of density uctuations arises as a natural consequence of the small up quark Yukawa coupling!

There are in fact other interactions in this model, with the eld Q_u . However Q_u is not a at direction and is assumed to be zero (or small) throughout in ation, so that it is irrelevant to the analysis.

In fact there are m any examples of the above type. Even with somewhat bigger Yukawa coupling, the correct m agnitude of density uctuations can be obtained at the expense of a larger ratio of . This is probably the nicest possibility for realizing the in ationary scenario we have outlined, because the only small numbers are those already present in the form of Yukawa couplings. There are no unlikely assumptions required for the correct m agnitude of density perturbations and a su ciently rapid exit to in ation.

The problem with the MSSM as the source of in aton candidates, as we have already stated, is that has a nonzero expectation value at the end of in ation. Because in general carries standard model gauge charge, this is not permitted. However, in GUT or other generalizations of the MSSM (or in models with completely independent elds which do not carry standard model gauge charges) one can readily realize the scenario we outlined.

M odel: Consider a generalization of the standard SU (5) GUT theory to SU (6), where now the Higgs elds are in the 6, 6, and 35 (H, H,) representations of SU (6). The matter consists of three generations of $15 + 6 + 6^0$. This model has been well studied in the context of solving the doublet triplet splitting problem [18]. Examples of speci c models with the requisite accidental symmetry were presented in Ref. [19].

Here we assume there is no superpotential for the H and H elds, but that the potential created by the soft supersymmetry breaking terms is minimized at hH i \mathbb{M} i M_p . Notice that this will break SU (6) to SU (5) which can survive to the GUT unit cation scale, and is therefore phenomenologically consistent. The eld acquires a vacuum expectation value of order M_G. We assume that the eld acquires this expectation value through renormalizable interactions, and is therefore not at, and furtherm ore has reached its true minimum at the time of in ation.

Now consider = H^0H^0 and = $15_2^{12}6_1^26_3^0$ where we have labeled the matter according to its generation number (subscript) and according to the SU (6) index (superscript) (where 0 indicates the SU (5) neutral direction).

The superpotential which is required to complete the model can readily be chosen in accordance with the requirement of a small Yukawa coupling. To explicitly write the term is subtle however for two reasons. First, the leading (renormalizable terms) which give mass are the term swhich make the 6° elds heavy and the term which gives the top quark a mass. However to give a renormalizable top quark coupling requires that the top be in a 20 of SU (6). All other masses arise from nonrenormalizable operators, and therefore appear more complicated. However, because of the large expectation values of the , H, and H elds, these terms reduce to ordinary Yukawa couplings.

A toy model which would give the necessary Yukawa coupling would be $W = 15_2H 6_2$, where 10^3 . This example resembles the up quark example. However, this is only a toy model because such a term actually gives the 6^0 a mass, and in fact denes the 6^0 elds. If this Yukawa coupling happens to be small, the density uctuations would be small. Since we know little about the extra quark Yukawa coupling, we give a model involving the known quark mass parameters.

The higher dimension term $W = V_{bc} (20) (\frac{H}{M_p}) 15_2$ can generate them ixing angle between the second and third generation. The elective Yukawa coupling between the at direction elds from this term is $V_{bc} = M_p$ which is about 10⁴ (since the VEV breaks SU (5) to SU (3) SU (2) U (1) at the GUT scale). The density uctuations in this model are then naturally of order 10⁴.

The last model works very well, as is illustrated in Figure 4. It is extremely interesting that the in ation scenario we have devised can be explicitly realized in the context of a known model of particle physics.

VI. AND EVOLUTION

In this section we will discuss the details of the evolution of $\$ and $\$. We can then derive the constraint on the $\$ mass.

A swe have argued, in ation ends at about the time the squared mass changes sign at the origin so that will roll towards its true minimum. However, because the mass is not large compared to H as in previous im plementations of the hybrid in ation scenario [10], a

careful study is required to ensure that in ation ends su ciently rapidly that our form ula for density perturbations applies. W e will see that if in ation ends too slow ly, perturbations will have the Hubble radius when the uctuations are large. In this scenario, if these uctuations were on measurable scales (say greater than 1 M pc and sm aller than 10^4 M pc) either the size of density uctuations or the deviation from a scale invariant spectrum would exceed the experimental bound. By a detailed study of the combined evolution of the elds, we determ ine the necessary constraint on the mass for consistency of our and m odel. However, throughout this section, it should be remembered that this constraint is is small, because it slows the transition which causes the end only very important when is close to unity, values of near unity are also adequate for a rapid of in ation. W hen end to in ation. For this reason, we will focus in the discussion here on the case of sm all W e present in detail the analysis for the model of Section 3, where the constraint is more severe. A similar analysis was done for the model of Section 4 in order to obtain Figure 4. is

We rst consider the time evolution of . The equation of motion for

There are three relevant stages of evolution of the eld. In the early stage of its evolution when the eld is small (and so is ${}^{4}=M{}^{02}$), the eld obeys the slow roll equation of m otion as it evolves towards the origin.

(Here we use the argument t to distinguish the timedependent physical mass of particles from the time-independent mass parameter in the potential.) We de ne $_{c}$ by $_{c}^{2}=2M^{0}=H$.

In our num erical simulations, we replace the time evolution of by the time evolution 4 2 =8M $^{0^{2}}$ in the of its envelope at a time su ciently late that we can neglect the term potential. The envelope e obeys the approximate equation of motion

where (t) is the decay rate, where the time dependence arises from the time dependent m ass. W ithout further know ledge of the identity of the eld the decay rate is an unknow n parameter of the theory. We constrain the model under two reasonable scenarios for the decay. If has renorm alizable couplings to other elds, its decay rate can be as large as b m (t). Of course there are unknown coe cients to this estimate but this probably represents the maximum possible rate. The true rate should lie between b and l, where $_1 = m^3$ (t) = $(M_p = \frac{1}{8})^2$. This latter decay rate assumes no renormalizable couplings, but P lanck suppressed interactions which allow the eld to decay. We evaluate the nal stages of evolution allowing for these two possibilities for the decay rate. A fter the time at which H, the amplitude of the envelope is quickly reduced to zero, and it is only the eld which remains. Notice that m (t) could exceed M $_{\rm p}$ before the end of in ation. However, the eld decays well before this inconsistency in the expansion is reached.

Because of the strong dependence on the eld of m $(t)^2 = m^2 (1 \quad 4 = \frac{4}{c})$, the evolution is critical to determ ining the evolution. In the early stage of the evolution, it can be described by a Fokker P lanck probability distribution P (;t). This distribution will be centered at the origin, but the spread will determ ine the eld ective amplitude of the eld h^2i . Eventually the eld ective amplitude will be su ciently large that the classical equations of motion take over. By considering the exact solution to the Fokker P lanck equation, we determ ine the correct initial condition for the subsequent evolution of the classical educations.

It should be borne in m ind how ever that the Fokker P lanck equation we used incorporated the slow roll equation of m otion, which is valid for N sm all compared to w^2 B ecause it will turn out w is not large, the Fokker P lanck description will be valid only at early times. We therefore use the Fokker P lanck equation to establish initial conditions, and then use the classical eld equations to describe the evolution which we evolve num erically.

While Eq. (28) provides an analytic solution to the di erential equation (27), the qualitative behavior of the solution can be seen by looking at the di erential equation itself. For large negative values of t, m^2 (t) is large and negative, providing a strong restoring force. This period is characterized by quasi-equilibrium evolution, in which the restoring force holds S (t) very close to its equilibrium value, $3H^4=8^{2}m^2$ (t), for which dS=dt would vanish. The spread of this equilibrium probability distribution approaches zero in the asymptotic past, and grows monotonically with time. As t approaches 0, however, this equibrium value of S diverges, and the quasi-equilibrium regime ends because S (t) is not able to keep up. We can estimate when the quasi-equilibrium regime ends by asking when the velocity of the equilibrium value exceeds the di usive velocity, H 3 =4 2 . For small , this happens when w 9=8. Then S (t) starts to grow di usively, increasing linearly in time ac- $N_i =$ Ν cording to the 1st term on the right-hand side of Eq. (27). Neglecting the growth before N = N_i, which, in practice, ghanges the result by a number of order unity, we estimate N_i) = $9=8 H^2 w = 4^2$, which in the limit of small gives an answer S (0) as (H $^{2}=4^{2}$) (N a factor of $\frac{p}{2}$ sm aller than the exact solution.

The diusive regime ends when the second term on the right-hand side of Eq. (27) becom es larger than the di usive term . This nalphase can be called the classical regim e, since the second term represents purely classical evolution. If only this term were included, the Fokker Planck equation would describe an ensemble of classical trajectories. This classical behavior is essential to our treatm ent of the problem , since it allows the description at late tim esto pin sm oothly to the full classical equations of m otion which rem ain valid outside the slow -roll regime. The transition from the di usive to the classical regime can be estimated by the \velocity m atching criterion", which is precisely when the two terms on the right-hand side of Eq. (27) are equal, approximating the solution until this transition by the di usive relation S (t) $_{q}$ H³t=4². In the lim it of small , this velocity-matching condition holds at $N_0 = w^2 = 3^2$ Ν The classical regime can be approximated by constructing a solution to the classical equations for (t), starting from the initial condition $(N_0) = i$. If the asymptotic behavior of this classical solution (in slow-roll approximation) is compared with the asymptotic behavior of \bar{S} (t) as given by Eq. (29), it is found to be smaller by a factor of (8 e)¹⁼⁴ 2:9. In practice, we use the Fokker-P lanck equation to establish the initial condition at N_0 . In our num erical calculations we corrected for this discrepancy by using the initial condition $(N_0) = i = (8 e)^{1-4} i$

We have determ ined the time evolution of and subsequent to the velocity matching time numerically. However, as for , the classical evolution of can be determined very well analytically. Again, we have to divide the analysis into three stages, according to the behavior of .

In fact we have checked that the solution above gives the number of e-folds for in ation to end correct to within 1-3 e-folds.

The reason we require an accurate determ ination of the number of e-foldings required for in ation to end is that it must be that the density uctuations relevant for the observed physical scales have exited the horizon while the eld is in the early quasi-equilibrium stage. As we will now show, the quantum uctuations of the eld during the di usive regime generate a spike in the density perturbation. For the model to be viable, it is important that this spike occurs at short wavelengths, so as to avoid con ict with observations.

One interpretation of the source of density uctuations is that the end of in ation occurs at di erent times at di erent points in space. The time delay function (x), multiplied by H, is of the order of = at the time the wavelength re-enters the Hubble length. For example, if $e^{m^2 N = 3H}$ and H = 2, the density uctuation constraint would be

Since has a more complicated evolution, the calculation of density uctuations at early times is subtle. The problem is to estimate the density uctuations caused by quantum uctuations in [21], whose value at times near t = 0 is determined by the Fokker-Planck di usion equation. Let us not consider the density uctuations in early stages of the evolution. Suppose at a given time t_1 the solution P (;t) is modified by displacing the entire probability distribution by an amount , so that P_{new} (; t_1) = P_{old} (; t_1). Here N $_{\rm fl}$ denotes the time that the initial condition is established, as the wave goes outside the Hubble length during in ation, and N $_{\rm e}$ denotes the time at which in ation ends; both

times are measured in units of e-foldings. This form ula applies for the stype of models; the exponent has a 2 2 N = 3 in the second type.

The e ect of a uctuation is to determ ine the time and the value of at which di usion ends and the classical evolution takes over (N_e) . The direct change in the time at which classical evolution begins translates into a di erence in time at which in ation ends. We expand the above answer for small to get

where N_{fl} is the time at which the uctuation occurs. This falls o from the peak at N_{fl} = 0 like a G aussian with width $9w^2=2$. W hat this tells us is that uctuations form ed su ciently early (or late) will not delay the onset of the classical regime signi cantly and not give a signi cant contribution to density uctuations. However, uctuations form ed during the di usive grow th regime near N = 0 will create far too large density perturbations. These uctuations must be such that they are not relevant to observable scales. We can observe back to about 40 e-folds before the end of in ation, so we require that the uctuations form ed at this time were su ciently small, or that in ation must end by 40 e-folds beyond the time when the uctuations satisfy the experimental bound. From Eqn. 41, one can deduce this time is approximately N_{df} = 5w. It might be thought that another solution is that in ation ends very slow ly, so that 40 e-folds before the end one is in the classical regime. However, when is evolving according to the classical equations of motion, the scale dependence of density perturbations is much too large.

e-folds before the end of in ation. We require that N is less than N_{M pc}. By following through the above calculations, one can see this gives the approximate constraint w 1. The detailed application of the constraint gives the constraints illustrated in Figures 1-3. These plots were made assuming the larger decay rate. The total number of e-folds for the same parameters is generally about 5 larger with $_1$ which can be accommodated with a modest change in .

VII.BLACK HOLES?

Because of the large peak in the density perturbation spectrum on small length scales arising from the contribution, there is a danger too many small black holes being created. There are fairly strong constraints on the fractional mass density in black holes on small scales [15]. We investigate these constraints on our model in this section. First we summarize the constraints. In the paper of Carr, G ilbert, and Lidsey, the constraints are presented in several forms; one constraint is on the parameter which is related to =. In the mass range above 10^{0} gm there are bounds from CMB distortions constraining to be less than about 10^{2} . In the mass range between 10^{30} gm and 10^{10} gm the bound on is approximately $10^{1:5}$. In [15] a bound due to relics is deduced constraining

between about 10^2 and 10^{15} in this mass range. This constraint from relics is perhaps more speculative than robust bounds from not exceeding critical density, or that decaying black holes do not produce too much entropy.

In order to apply these bounds, one needs to know the probability of black hole creation as a function of . Based on [22], the bound is obtained from applying the formula for the probability of a region of mass M form ing a prim ordial black hole

where the equation of state when the perturbation enters the horizon is p = . For the scales which are of interest to us, = 1=3, which we will assume in the equations below.

The above bound com es from considering a spherically symmetric overdense region. The requirem ent is made that when the overdense region stops expanding, it's size S_c exceeds the Jeans radius R_J at this time $t_{c,l}$ in order to collapse against the pressure. To derive requires that this be the precise condition. W ithout solving exact num erical bounds on the full problem explicitly including the pressure e ects near the boundary it is di cult to state precisely the conclusion, which gives rise to some overall uncertainty in the bound. However, one should be able to obtain a conservative bound on through this approximation. However, even using this approximation, we nd num erical discrepancies with the precise production rate which would be predicted. First, the relation between t_c and t_0 (the time at which the perturbation begins to evolve separately from the hom ogeneous background in which it is embedded) should be $t_c = 2t_0^{-1} \frac{1}{q}$ (the 2 being om itted in Ref. [22]) and the relation between R_J and t_c should be $R_J = 2v_s$ $2=3t_c$ rather than $v_s 2t_c$ (in actual fact the 2 was om itted but cancels later on), where v_s is the sound velocity. Overall this translates into the bound $_0 > v_s^2 2 \stackrel{q}{=} \frac{m}{2=3} \frac{m}{m_0} e^{2=3}$ (where the correct relation $S_c = R_0 e^{1=2}$ has been substituted and the ratio $t_0=R_0$ has been replaced by the appropriate mass ratio). The in plication is that the factor $^{2}=2$ in Eqn. 44 should be replaced by 4 2 $^{2}=3$, which in turn by a factor of about 5. This will of course also decreases the strength of the bound on weaken the bound on the scalar index n given in [15].

Our spectrum is not scale invariant on these small length scales which is in portant when calculating from H . However a very conservative upper bound on our spectrum is a scale invariant spectrum starting at a sm all length scale (near the peak of the Gaussian) and which is constant over smaller wavelengths. This spectrum would be a scale invariant spectrum with a cuto at large wavelength, and can readily be compared with the analysis of Ref. [15]. The normalization they use for can be extracted from their Eqs. (42) { (4.4), which express the value of at the COBE scale in term softhe underlying in aton potential. 1, their equations reduce to $= 0.99V^{3=2}=V^{0}$. By comparing with A ssum ing that T=S= H = -= H²=(2 -), one nds that can be related to the uctuations the relation H .We can then apply form ula 40 to nd that (norm alized as above) bv = **:**086H in never exceeds 0.02, in the parameter regime presented in Figures 1-4. Because the quoted

constraint on in [15] appears be too strong by a factor of 5, we conclude that we are consistent with reasonable estimates of the black hole constraint. Therefore, even with a conservative overestimate of , the constraint from black holes is satisfied. However, there can be a sizable fraction of matter in black holes, which would be interesting to study in the future.

As a nalcomment, we remark that the bound from black holes is somewhat weaker if in ation endsmore quickly, which it does for lowerw. In fact, for w 0.5 (corresponding to m about four times larger than assumed) in ation ends in about 10 e-foldings. In this case, only the bounds from relics would apply. As this bound is more speculative, it is possible that even large perturbations on this scale would be acceptable. In reality, smaller w, while decreasing the length of time for in ation to end, also decreases the density perturbations. Larger m always leads to a smaller fraction of the universe in black holes.

In sum m ary, the black hole constraint is a serious constraint and m ust be accounted for. This is another constraint which would forbid large w, since the maximum value of H grows as w¹⁼² (when the dependence of N_e on w is accounted for). However we have seen our model is safely within the bounds given in the literature once we have applied the m bound given in Section 7.

However these bounds are not su ciently precise at present and it would be interesting to do a more accurate calculation of the mass fraction in black holes both for our model and in general.^x The e ects we have discussed should weaken existing bounds.

VIII. GRAVITINO CONSTRAINT

In this two eld model of in ation, the source of entropy and energy in the universe is the decay of the and elds. The eld decays nst, as discussed earlier. We assume the decay products are quickly therm alized, giving an elective temperature T. Sometime afterward the eld reaches them inimum of its potential and begins to oscillate about it. We assume that these oscillations are damped by gauge or Yukawa couplings. As in Ref. [9], the decay can occur through a coupling $g^2 = h$ i d^4 y or through a direct Yukawa coupling $_1$ 2. This leads to a reheat temperature equal to max ($g^{2=3}m^{5=6}M^{1=6}$; m = 1), which is generally of order $10^5 \{10^7 \text{ GeV}$. Since most of the energy of the universe evolves from the coherent oscillations of the eld, this reheat temperature sets the initial conditions for the subsequent evolution. As discussed in Ref. [23], this reheat temperature is low enough to

However, the initial tem perature T of the therm alplasm a of decay products can be as high as 10^{11} GeV, so the production of gravitinos by this plasm a must be exam ined. In this section we show that this constraint is never more restrictive than the constraints already discussed.

avoid the overproduction of gravitinos, even if gravitinos are as light as 100 G eV.

G ravitinos are produced by scattering processes of the therm alradiation, but interact at a rate suppressed by $m_{3=2}^2 = M_p^2$. They are potentially dangerous since they are not therm alrized and have a long lifetime. The most stringent bounds are obtained by considering the

in uence of these late decays on nucleosynthesis. The exact bound depends on the gravitino m ass, but for 100 G eV $\,<\,$ m $_{3=2}\,<\,$ 1 TeV \pm is $T_{\rm R}\,<\,10^{7-9}$ G eV [23].

N eglecting decay when considering gravitino production, one writes the B oltzm ann equation for the gravitino number density as [23]

where n_{rad} is the equilibrium number density of a single species of scalar boson ($n_{rad} = ((3) = {}^{2})T^{3}$), and both the cross sections and the multiplicity of species are accounted for by the factor $_{e}$. In terms of $Y_{3=2} = n_{rad}$, we have

$$\frac{\mathrm{d}Y_{3=2}}{\mathrm{d}t} = \operatorname{e} n_{\mathrm{rad}} : \tag{46}$$

To a reasonable approximation $_{\rm e}$ can be taken as constant, although it does vary as the coupling constants run and as species freeze out from the therm al equilibrium m ix [23]. For the standard case of a radiation-dom inated universe, $n_{\rm rad} / 1=R^3$ (t) $/ 1=t^{3=2}$ (where R (t) is the scale factor), so the total gravitino production can be estimated by integrating Eq. (46) from the initial reheat time t_0 to in nity. This gives $Y_{3=2} = 2_{\rm e} n_{\rm rad;0} t_0 = -e_{\rm nrad;0} = -H_{\rm o} / T_{\rm o}$, where the subscript 0 refers to the time of reheating. To obtain a reasonable estimate of the present value of $Y_{3=2}$, one must divide this value by a dilution factor to account for the production of photons at times much later than t_0 . A coording to Ref. [23], the nal result is

To derive a conservative estimate for the gravitino production of the decay products, we assume that the energy released by the decay is approximately equal to the energy stored in the oscillating eld when in ation ends. A coording to the numerical simulations of our model, the fraction of energy in the eld was generally less than this by a factor of at least 10^4 , except in the case M⁰ = M_p and a slow decay rate, in which case can store a substantial fraction of the energy at the end of in ation. The universe then rapidly become matter-dominated, so R (t) / $t^{2=3}$. Repeating the calculation for $Y_{3=2}$ with this time evolution, one nds $Y_{3=2} = \frac{2}{3}$ energy of 0, essentially the same form use above.

However, in this model there is an additional dilution of the decay products, because the eld behaves as a coherent state of nonrelativistic particles for a time 1^{1} , and then the particles decay to produce radiation. Before the particles decay, the energy density

of the decay particles (assumed to be electively massless) is suppressed relative to the energy density of the eld by one power of the growth of the scale factor between the times t_0 and 1 , which is $1=(t_0)^{2=3}$. When the particles decay to radiation, the number of radiation particles produced exceeds the number of decay particles by $(=)^{3=4}$ $1=(t_0)^{1=2}$. Relating to the reheat temperature T_R 10^7 GeV and taking t_0 1=m, the dilution factor is found to be approximately (M $_P$ m $=T_R^2)^{1=2}$ 10^4 . Incorporating this extra dilution factor into Eq. (47), we not that gravitino production from decay products give

where we have explicitly incorporated our assumption that and initially carry comparable energy.

Thus, a reheat tem perature of 10^{11} G eV produces nom ore gravitinos then a nalreheat tem perature of 10^7 G eV. Thus, we not that no further constraints need to be imposed.

IX . BARYOGENESIS

In the context of late scale in ation, it is worthwhile to investigate the question of how baryons are created. There are essentially two known possibilities. Electroweak baryogenesis [24] is possible since the reheat temperature will generally be above the weak scale. A lternatively, a model in the context of supersymmetry invites investigation into the A eck D ine scenario [25].

In the A eck D ine baryogenesis scheme, a eld which carries baryon number acquires a large displacement relative to its true m inimum somewhere during the early evolution of the universe. If the interactions which drive the eld to the true m inimum are CP and B violating, the eld will store baryon number, and subsequently decay to baryon number carrying particles.

In our model, in principle, the elds or could be the AD elds. However this does not work. The problem is that elds which carry baryon number will generally also carry charge, so that is not a good possibility since charge (or color) would be spontaneously broken by the vacuum. A lthough is in principle a candidate, the ratio of baryon number stored by the eld to entropy will be too sm all.

This can be deduced from a detailed study of the eld. The rst point to observe is that the potentials we have studied to now are B and CP conserving. This is because we have neglected the soft \A " type term s and possible cross term s which can violate CP. W hen these are included, we nd there can cause a sm all change in the detailed evolution of the eld. At the time the A (CP and B violating term s) are large, the eld only carried a sm all fraction of the energy of the universe.

However, a separate at direction which plays the role of the AD eld would work. If the AD eld is independent of the in ation elds, it can then have large expectation value through the nal stages of in ation. If H is somewhat larger than m_{AD} , the analysis is similar to that in Ref. [16] where a much larger H was assumed. The baryon to entropy ratio is approximately

$$\frac{n_{\rm b}}{s} = \frac{n_{\rm b}}{n_{\rm AD}} \frac{T_{\rm R}}{m_{\rm AD}} \frac{AD}{T_{\rm R}^4}$$
(49)

where $n_b = n_{AD}$ gives the baryon to particle number ratio in the AD eld, and should be order unity if the potential for the eld is B and CP violating. The last factor $_{AD} = T_R^4$ is determined by the amplitude of the AD eld at the time it evolves towards its true minimum, which is determined by higher dimension operators in the potential [16]. One can readily obtain acceptable values for the baryon density if the dimension of the operator in the superpotential which lifts the at direction is greater than 4. The lower reheat tem perature expected in these models requires a correspondingly larger factor $_{AD} = T_R^4$, so a dimension 4 operator in the superpotential which lifts the AD eld is insu cient.

X.D ISCUSSION

There are several comments to make about the models we have considered. First there is the fact that we are considering very late in ation. We do not address the question of why the universe has lasted to this point [1]. We have only addressed the question of a late in ationary epoch responsible for solving the horizon and atness problems and for generating the necessary density uctuations.

O ne possible solution is that the initial value exceeds M $_{\rm p}$. In this case, it is possible that chaotic in ation could solve the problem raised above. However, subsequent to this stage of in ation, one would expect in ation as described in this paper which would create density uctuations of the right size.

A nother point we have not addressed is what our models bok like when embedded in supergravity theories. Our point of view throughout this paper is to regard the theory as an elective theory expanded in powers of M $_p$ (and M 0). We have neglected terms which are suppressed by higher powers of the P lanck scale. For the same reason we have assumed a minimal K ahler potential when deriving the potential. From this point of view, any secondary minima which occur in supergravity for eld values exceeding M $_p$ are not to be trusted.

O ne aspect of our models which is important is the requirement of renormalizable couplings of the elds in the direction in order to obtain su ciently high reheat temperature. For this reason we expect it is more likely that the elds and correspond to at directions of a renormalizable theory (along the lines discussed in Section 6) than to true moduli elds (of string theory) [26].

In our models, we saw that there was usually some small but not very small number. E ther M⁰ is M_p in which case and 1= are of order 100, or M⁰ is smaller than M_p which permits and closer to unity. Another possibility is that the small number is related to a Yukawa coupling. We discuss each of these possibilities in turn.

It is well known that there can be H dependent correction to the soft supersymmetry breaking masses at early times when H exceeds $m_{3=2}$ [16,27]. This means that small is necessarily obtained by tuning. Stewart [28] has presented criteria which are su cient for the cancellation of supergravity corrections to the in atom mass, so that even a large ratio is technically consistent. However these conditions will only work when the scale of in ation is above the supersymmetry breaking scale. One therefore needs to invoke a new mass scale. G enerally Stewart chooses the scale of gaugino condensation. It is hard to see how this scale is realized in an actualm odel although it could present an interesting alternative. There is a tradeo between the complexity of the model and the \naturalness" of taking m somewhat smaller than H.

In the models where is small, we found that consistency of the model required that

is large, with the product being a number of order unity. It might be thought that this large value of could be explained as due to large H dependent mass corrections. However, it is not possible to introduce a large without the tuning parameter appearing in some other unnatural feature of the potential. For example, a large H dependent mass could introduce a new minimum for which is closer to the origin so that the VEV of is correspondingly smaller than M_p .

W e have seen how ever that the tuning of m ass ratios is signi cantly reduced if we accept

a higher scale than the conventional interm ediate scale as setting the overall energy density. However if this scale has anything to do with visible supersymmetry breaking, the highest scale possible is probably the gaugino condensate scale. The predictions for n and R would be very similar, so the general test for this class of models would still be valid.

We regard the small tuning of parameters as a necessary aspect of the models with $M^0 = M_p$. The necessary numbers may or may not be present. The tuning is certainly much smaller than in a typical in ation model.

On the other hand, M 0 m ight be smaller. This requires the presence of another mass scale in the theory. If this lower scale exists, one can obtain and closer to unity.

The other possibility is that there is a small Yukawa coupling. This is probably not such a bad possibility. First of all, the necessary coupling is no smaller than known Yukawa couplings and m ight even be related to them as in the model of Section 6 and obvious variants. Second, known Yukawas can be derived as the ratio of mass scales. In the SU (6) m odel we discussed this has been done in Ref. [29,19]. It is not unreasonable to think there m ight be such e ective Yukawa couplings in hidden sectors of the theory, as well as in the single known sector.

In most known hybrid in ation models other than the one we discussed, the eld is very light, while the eld is very heavy, of order M. This is a more serious technical problem since radiative corrections will generally give too large a mass [7]. Even if the model is supersymmetric, supersymmetry breaking during in ation would induce a large mass for . Although at tree level $\operatorname{Str}(M^2) = 0$, this is not su cient to prevent radiative corrections at higher loop order. One can perhaps allow for such a hierarchy, but at the expense of additional complexity and mass scales. A chief advantage of our model is that both m and m are of order the soft supersymmetry breaking scale so this problem does not arise.

We view our model as the simplest illustration that at directions of supersymmetric theories are consistent with the requirements of in ation when one allows form one than one eld in the in ation sector. It is likely that the small parameters which might be required (of order 0.01 to 0.1) are present. A liternatively there might be more subtle mechanisms at work. Either way, one would conclude that the scale of in ation is very low. Even allowing in ation to be determined by the higher gaugino condensate scale, one would conclude that H during in ation is between 10^4 and 10^7 GeV, and tensor perturbations are small.

It is important that there are observational consequences to this type of model. The combination of measuring the scalar index n and T=S should either rule out or encourage belief in the mechanism at work here. As discussed in Section 3,

$$n = 1 \quad 3 \frac{V^{0^{1/2}}}{V} + 2\frac{V^{0}}{V}$$

Because the second term is negligible in models of the sort we are considering, where at the end of in ation is much less than M $_{Pl}$, it is only the last term which causes the deviation of n from unity. If the dependence on a is dominated by a mass term, as in the model of Section 3, the correction to n will be positive (but small). We then expect n greater than or equal to unity, and T=S to be small.

We have shown that with more than one eld it is possible to construct models of in ation with no small parameters. Furthermore, the mass scales which seem to most naturally appear in these models are of order m₃₌₂, about 1 TeV, and M_I, about 10^{11} GeV, leading to a natural association with supersymmetric models. These models give rise to the correctly normalized density perturbations, even though the Hubble constant is quite low, of order 10^4 GeV, because the value of the in atom eld at the end of in ation is much lower than the P lanck scale. The key to producing more such models is a sensitive dependence of the

potential on the value of the eld, so that the motion of the eld can trigger the end of in ation while its value is sm all.

It seems that multi eld models are probably the most natural models which can im plement in ation with weak scale Hubble constant, and that furthermore, these are probably the most natural in ation models in that they involve no new small parameters. The requisite small parameters arise naturally from the ratio of mass scales. These models have the further advantages that they can be explicitly realized and one can calculate the relevant parameters for any particular implementation. They might even occur in simple extensions of the MSSM.

Perhaps the most important property of a model is its testability, and our proposed models have several characteristics that are in principle observable. The scalar index n which characterizes the scale dependence of density perturbations is always greater than unity. It is very close to unity for the model of Sec. III with M⁰ at the P lanck or GUT scale, but for M⁰ at the interm ediate scale or for the model of Sec. IV, it could be as large as 12 for the parameters shown in our plots. In all cases tensor perturbations are negligible. An especially distinctive feature is a large spike in the density perturbation spectrum at present wavelengths of about 1 M pc or less.
