Chargino Production at LEP2 in a Supergravity Model

A bstract

In the fram ework of a particular supergravity model which provides a natural solution to the {problem we show how the discovery of a chargino at LEP2 and the measurement of its mass and production cross{section, together with the measurement of the mass of the lightest neutralino, would determ ine the entire Higgs and SUSY spectrum. We give detailed predictions for the Higgs and SUSY spectrum as a function of the chargino production cross{section, for constant values of the lightest chargino and gluino masses.

Recently LEP1.5 has set a new lower bound on the lightest chargino m ass of about 65 GeV ifm $_{\sim_1}$ m $_{\sim_1^0}$ > 10 GeV [1]. In general LEP2 will be able to bound or discover charginos up to the kinematic limit of the machine. In this paper we explore the possible consequences of chargino discovery at LEP2 within the framework of a well motivated supergravity model.

It is well known that, with the assumption of a universal gaugino m ass M $_{1=2}$, the chargino \sim_i (i = 1;2) and neutralino \sim_i^0 (i = 1::4) m asses and m ixing angles only depend on three unknown parameters: the gluino m ass m $_g$, and tan [2]. In a recent paper [3] we have shown how the discovery of the lightest chargino at LEP 2 and the m easurement of its mass, m $_{\sim_1}$, and production cross-section, (e⁺ e ! $\sim_1^+ \sim_1$), together with the measurement of the mass of the lightest neutralino, m $_{\sim_1^0}$, will enable the basic parameters m $_g$, and tan to be determined, up to certain ambiguities (see also ref. [4]).

In the present paper we shall extend the above analysis from the gaugino sector of the M inim al Supersym m etric Standard M odel (M SSM) [5] to the entire supersym m etric (SUSY) and H iggs spectrum. However, whereas the gaugino sector is completely specified by three parameters, the remaining spectrum depends on very many parameters and without some simplifying principle it is impossible to make progress. Therefore in the present paper we shall explore the consequences of a specific supergravity (SUGRA) model which has suicient predictive power to enable the entire Higgs and SUSY spectrum to be deduced from just the LEP2 measurements m $_{^{-1}}$, (e⁺ e ! $_{^{+1}}^{^{+}} \sim_{^{1}}$), and m $_{^{+0}}^{^{0}}$ { a result which underlines both the importance of LEP2 and the power of supergravity.

The phenom enologically sim plest SUGRA models typically involve universal soft parameters (at the uni cation scale 1): m₀, M₁₌₂, A, B in the usual notation corresponding to the universal scalar mass, gaugino mass, trilinear dimensionful coupling and B H₁H₂ term, respectively. Thus the squark and slepton soft masses are proportional to unit matrices in avor space, and trilinear couplings are proportional to Yukawa matrices at the unication scale. Specic SUGRA models may involve further relationships between the soft parameters, for example the so-called minimal SUGRA model predicts that B = A m₀ [6]. However this model involves an unnaturally small dimensional parameter appearing in the superpotential { the problem. Recently there have been several alternative mechanisms sproposed to solve

the problem [7] and it is a common tendency of such models to predict $B=2m_0$, although it is not clear why such dierent theories should lead to the same boundary condition. Therefore in the present paper we shall focus on SUGRA models which predict $B=2m_0$ which have a stronger theoretical motivation.

A coording to the above discussion, the 5 independent parameters at M $_{\rm X}$ are: B = $2m_0$, $M_{1=2}$, A, , h_{t0} , where h_{t0} is the top quark Yukawa coupling at M_X . W e shall require radiative electroweak symmetry breaking, and impose the usual Higgs m in im isation conditions at low energy. We consider all the supersymmetric mass param eters to be smaller than M $_{SUSY} = 1$ TeV. The order of magnitude of this scale em erges naturally when the model is embedded into a GUT [8]. In addition, to break radiatively the electroweak symmetry without ne{tunning the initial parameters M $_{\rm SUSY}$ cannot be too large [9]. Our 4 input param eters are chosen to be: m $_{\rm t}$, m $_{\rm m}$ and m $_{\rm g}$ which are su cient to specify the 5 independent parameters at M $_{\rm X}$, given the requirem ent of correct electroweak symmetry breaking. The idea behind this choice of input param eters is that the top quark mass is measured at the Tevatron, and the chargino mass may be measured at LEP2. This only leaves the parameters and m q which can in principle be determined at LEP2 from a measurement of (e $^+$ e ! $\sim_1^+\sim_1$) and m $_{\sim_1^0}$, as discussed in our previous analysis [3] except that now the electron sneutrino contribution to the cross-section will be taken into account. The main dierence is of course that now these LEP2 measurements will serve to determ ine the entire Higgs and SUSY spectrum, not just the gaugino sector.

Our detailed procedure is to sst x values of top quark mass, chargino mass and gluino mass. For a given choice of , know ledge of m $_{\rm u}$ and m $_{\rm g}$ enables a determination of tan . W ith m $_{\rm t}$ and tan specied we have a determination of h $_{\rm t}$ (at low energy) and hence $h_{\rm t0}$ (at high energy). W ith $h_{\rm t0}$ known, we choose values of m $_{\rm 0}$ and A and run all the parameters down to low energy (the RG equations do not depend on B). We do not take into account threshold corrections. The tree{level m in im isation condition on the H iggs masses at low energy 2

where m $_1^2$ and m $_2^2$ are the soft SUSY breaking H iggs m asses, will not in general be satis ed, and so we vary m $_0$ until it is. Sometimes there will be no solution for any value of m $_0^2 > 0$, and this condition has a big e ect in reducing the allowed parameter space. Eq. (1) describes the m in imization of the H iggs potential when the one-loop

contributions to the e ective potential are neglected. Having consistently determ ined m $_0$ we then not the low energy value of B using B = $\frac{1}{2}$ m $_A^2$ sin 2 , and run it up to not the high energy value of B . In general the condition B = 2m $_0$ will not be satistic ed, and we iterate the procedure for different values of A until this condition is met, which electively serves to determ ine A . If we have chosen a suitable value of we will then have a successful data point from which the entire Higgs and SUSY spectrum may be calculated, and (e⁺ e ! $\sim_1^+ \sim_1$) computed. We note that there is no ambiguity in the sign of the supersymmetric Higgs mass parameter , as opposed to global supersymetry analyzed in ref. [3], because the high energy relation B = 2m $_0$ together with the low energy constraint m $_A^2$ = 2B = $\sin(2$) > 0 in plies that only > 0 solutions are satisfactory [7] (see also [10]).

U sing the above procedure, contours in the (e⁺ e ! $\sim_1^+ \sim_1$) { m \sim_1^0 plane for a xed values of m $_{\rm t}$, m $_{\rm m}$ and m $_{\rm g}$ are produced by varying over its successful range. These contours are shown in Figure 1. We see four groups of curves corresponding to the choices m $_{\rm m}$ = 60, 70, 80, and 90 G eV . W e have taken m $_{\rm t}$ = 176 G eV and $_{\rm s}$ = 0:116. W e do not $\,$ nd acceptable solutions for m $_{_{^{^{-}1}}}$ = 50, consistent with the LEP1 experim ental lower bound on the chargino mass m $_{\sim}$ > 45 GeV [11, 12, 13]. For each value of the chargino mass, the dierent curves are labeled by the value of the gluino mass. It is clear from the gure that heavier charginos produce smaller total cross sections and, at the sam e time, they are associated with heavier neutralino 1, \sim_1^0 . This neutralino is the lightest supersymm etric particle, or LSP . Since the LSP should be neutral, some curves for the case $m_{ij} = 90 \text{ GeV}$ are truncated at high values of tan because beyond that point the \sim 1 becomes lighter than \sim 1. It can also be appreciated from Fig. 1 that larger m $_{\rm g}$ produce, in general, sm aller cross sections. The reason here is that the sneutrino becomes lighter at larger gluino masses, and since the sneutrino contribution to the total cross section is negative, the total cross section decreases. Note that contours in Fig. 1 are truncated at the upper end (large cross(section end) where tan is small, and at the lower end (small cross(section end) where tan is large, for reasons which will become apparent. Fig. 1 clearly dem onstrates that for a given m $_{\rm t}$, LEP2 m easurem ents of m $_{\rm c}$, (e $^{\rm t}$ e $^{\rm t}$ $^{\rm t}$ $^{\rm t}$ $^{\rm t}$ and m $_{\text{\tiny -1}}$ are su cient to completely specify all the parameters in the theory.

To emphasise that all the basic parameters of the theory, and with them, the whole Higgs and SUSY spectrum, are determined for each point of each contour in Fig. 1, we shall present a series of contours with $(e^+e^-e^+ \sim_1^+ \sim_1^-)$ along the vertical axis and some other determined quantity along the horizontal axis. In Figure 2

we show the set of m $_{\rm m_{\rm g}}$, m $_{\rm g}$ contours corresponding to Fig. 1 but with the basic param eters (a) m_0 , (b) A, (c) tan and (d) along the horizontal axes. For a given chargino mass, the gluino masses we have taken are bounded from above because gluinos heavier than som e value produce solutions with m $_0^2 < 0$ [Fig. 2(a)], and from below because gluinos lighter than some value need values of A larger than 1 TeV [Fig. 2 (b)]. We do not consider constraints form charge and color breaking [14]. The is plotted in Fig. 2 (c), and the most noticeable feature is that many param eter tan curves are truncated at tan 2. The reason is that we are close to the xed point of the top quark Yukawa coupling, and smaller values of tan makes this coupling diverge at scales smaller than the unication scale. In the case of the lightest gluino choice, the xed point of ht is not reached, and the curve is truncated at higher values oftan because the parameter A becomes larger than 1 TeV. For a xed value of m $_{\rm g}$ and m $_{\rm g}$, the parameter $_{\rm is}$ determined by the value of tan $_{\rm g}$ and it is plotted in Fig. 2(d). Typically, the smaller the chargino mass is, the smaller the parameter is. Nevertheless, it never reaches values smaller than 150 GeV.

In Figure 3 we show the contours corresponding to Figure 1 but with (a) the second lightest neutralino m ass, (b) the sneutrino m ass, (c) the lightest charged slepton m ass and (d) the lightest up-type squark mass along the horizontal axis. In Fig. 3(a) we see the production cross section as a function of m $_{\scriptsize 0}$. This mass is strongly correlated with the lightest chargino mass, satis es m $_{\frac{9}{2}}$ > m $_{_1}$, and receives small increases as we increase the gluino mass. Similarly to the lightest neutralino case, the groups of curves corresponding to di erent values of m are well di erentiated, implying that we will have a very good idea of the mass of this particle even if we have large experim entalerrors on the LEP m easurem ents m entioned before. The sneutrino m ass is presented in Fig. 3 (b). Note that it is the electron sneutrino that is of interest to us because it contributes to the chargino production cross section. Nevertheless, the three sneutrino avors are practically degenerated in m ass. The sneutrino m ass always satis es the experim ental constraint m ~ > 41.8 G eV [11, 15] and is represented in the qure by a vertical dotted line. In can be appreciated that the sneutrino contribution to the total chargino production cross section is more important when charginos are light, and that it decouples as m _ increases. In Fig. 3 (c) we plot the lightest charged slepton m ass, which in all cases is \sim_1 . The experim ental LEP1 constraint m $_{\sim_1}~>~45$ GeV [11, 12, 16] restricts the allowed parameter space, and consequently some of the curves (the ones with lighter gluino) are truncated at large tan . The reason for that lies in the left{right mixing of the mass matrix, because it is proportional to tan , and large values of tan produce a large mass splitting between $_1$ and

In the lightest of the up {type squarks is plotted in Fig. 3 (d), which is predom inantly the lightest stop, \mathfrak{T}_1 , with a small component of scharm (in all cases smaller than a percent). At small values of the universal scalar mass parameter m₀, where the total cross section is small, the mass of the lightest up {type squark increases with this parameter m₀. Nevertheless, for large values of m₀ the trilinear mass parameter A also is large, producing a large top squark mass mixing and consequently, a lighter \mathfrak{T}_1 . This makes the curves in Fig. 3 (d) to turn towards the small values of the lightest up {type squark as the total cross section increases. Lighter \mathfrak{T}_1 are obtained when small chargino masses are considered, a combination that produces large corrections to the Z ! bb decay. Nevertheless, we do not not top squarks lighter than about 180 GeV, claimed to be necessary to explain the discrepancy between theory and experiment (see for example [17]).

The Higgs sector of the MSSM [18] is completely specied at tree level by the CP-odd Higgs mass m $_{\rm A}$ and tan . Nevertheless, a strong dependence on m $_{\rm t}$ and m_r is introduced through radiative corrections to the charged Higgs mass [19, 20] and to the lightest neutral CP-even Higgs mass [20, 21]. In Figure 4 we show the corresponding contours of Fig. 1 with (a) the lightest CP-even Higgs boson mass, (b) the CP-odd Higgs boson mass, (c) the charged Higgs boson mass and (d) the value of cos() along the horizontal axes. In this scenario, the lightest Higgs m ass plotted in Fig. 4(a) is always smaller than 103 GeV, with obvious relevance for LEP 2 [22]. The higher values of m $_{\rm h}$ are obtained when tan $\,$ is large, where the tree level contribution to m $_{\rm h}$ is m axim um . On the other hand, at tan 2 the lightest Higgs mass is minimum, with a lower bound of about 80 GeV. In the calculation of m h we include the exact one-loop radiative corrections from top and bottom quarks and squarks and leading logarithms from the rest of the particles, working in an on-shell scheme where the parameter tan is de ned through the A + [23]. We also include the dominant two-loop QCD corrections [24] and we sum all the leading and next-to-leading logarithms with a RGE technique. The mass of the CP-odd H iggs m_A is plotted in Fig. 4(b). It is obtained from eq. (1) which comes from the minimization of the Higgs potential. This particle is in all cases heavier than about 130 GeV, what makes it dicult to be observed at LEP2. The charged Higgs mass, plotted in Fig. 4(c), is strongly correlated to the value of m $_{\rm A}$, because at tree level the relation m $_{\rm H}^2$ = m $_{\rm W}^2$ + m $_{\rm A}^2$ holds. W e include the one-loop radiative correction to thism ass, nevertheless, in the region of param eter space considered here, the correction is smaller than 2 GeV in all cases. Finally, in Fig. 4(d) we plot the) which controls the ZZH coupling. One-loop corrections to parameter cos(

this angle are already taken into account [25]. The fact that this parameter remains small implies that the heavy Higgs boson H is weakly coupled to the Z {boson. At the same time the lightest Higgs h, with a Z Z h coupling proportional to \sin (), has couplings that approach the corresponding Standard Model (SM) Higgs boson couplings. Nevertheless, it is worth mentioning that, if we consider the SM with no new physics below 10^{10} GeV and the MSSM with M $_{\rm SUSY}$ < 1 TeV, the allowed values of m $_{\rm H_{SM}}$ are always greater than m $_{\rm h}$ providing the top quark is su ciently heavy [26].

Finally we return to our original question: what can we learn from this SUGRA model with the detection of charginos at LEP2? The answer is sum marised in Fig. 1. In this gure a group of curves corresponding to a particular value of m are well dierentiated from a group corresponding to a dierent value. This perm its us to check the validity of them odeleven if the experimental errors are so large that it is not possible to precisely dierentiate the curves labeled by the value of the gluino mass. A ssum ing that precise measurements of the total cross section (e[†] e ! $\sim_1^+ \sim_1^-$), the chargino mass m and the lightest neutralino mass are available, it is possible to predict the value of mg, and from Figs. 2{4 the rest of the parameters of the model and the masses of the physical particles can be predicted within this particular well motivated SUGRA model. For example a m prediction of this model is that if LEP2 discovers a chargino then the lightest CP-even Higgs boson must be lighter than 103 GeV and have SM {like couplings.

- Fig. 2. Total chargino pair production cross section as a function of four di erent param eters that characterize the supergravity model. (a) The universal scalar mass m₀, (b) the universal trilinear coupling A, (c) the ratio of the two Higgs vacuum expectation values tan , and (d) the Higgs mass parameter. There is a one{to{one correspondence between the lines in this Figure and those in Figure 1. The line styles for the chargino masses are as in Figure 1. For each chargino mass the gluino masses also correspond to those in Figure 1.
