# B ounds on the light quark $m$ asses

#### Abstract

The corrections to the current algebra $m$ ass form ulae for the pseudoscalar $m$ esons are analyzed by $m$ eans of a sim ultaneous exansion in powers of the light quark $m$ asses and powers of $1=\mathrm{N}_{\mathrm{c}}$. The relative $m$ agnitude of the two expansion param eters is related to the m ass ratio $\mathrm{M}^{2}=\mathrm{M}{ }^{2}$, which represents a quantity of order $\mathrm{N} \mathrm{cm}_{\mathrm{s}}$. A set of $m$ ass form ulae is derived, including an inequality, which leads to bounds for the ratios $m_{u}=m_{d}$ and $m_{s}=m_{d}$.


The low energy properties ofQ CD are govemed by an approxim ate, spontaneously broken sym $m$ etry, which originates in the fact that three of the quarks happen to be light. If $\mathrm{m}_{\mathrm{u}} ; \mathrm{m}_{\mathrm{d}} ; \mathrm{m}_{\mathrm{s}}$ are tumed o , the sym m etry becom es exact. The spectrum of the theory then contain s eight strictly $m$ assless pseudoscalar m esons, the G oldstone bosons connected w ith the spontaneous sym $m$ etry breakdown. Their properties $m$ ay be analyzed by $m$ eans of an e ective Lagrangian, which describes the low energy structure of the theory in term $s$ of an expansion in powers of $m$ om enta and quark $m$ asses $\left[\underline{1} 1\right.$, , ${ }_{2}$

If the num ber of colours is taken large, the quark loop graph which gives rise to the anom aly in the divergence of the singlet axial current is suppressed. In the $\lim$ it $N_{C}$ ! $1, Q C D$ thus acquires an additionalu (1) sym $m$ etry, whose
 The im plications for the e ective Lagrangian are extensively discussed in the literature [ $[\overline{-}]$ ] and the leading term $s$ in the expansion in powers of $1=\mathrm{N}_{\mathrm{c}}$ have been worked out. The purpose of the present paper is to extend this analysis to rst nonleading order and to discuss the consequences for the $m$ ass spectrum of the pseudoscalars.

The relevant dynam ical variable is the G oldstone eld $U(x)$, which lives on the quotient $G / H$, where $G$ and $H$ are the (approxim ate) sym $m$ etry groups of the $H$ am iltonian and of the ground state, respectively. Since $I$ w ish to study the large $N_{C} \lim$ 五, $G$ is the group $U(3)_{R} U(3)_{I}$ and $U(x) 2 U(3)$. The unim odular part of the eld $U(x)$ contains the degrees of freedom of the pseudoscalar octet, while the phase detU $(x)=e^{i 0(x)}$ describes the ${ }^{0}$.

The e ective Lagrangian is form ed with the eld $U(x)$ and its derivatives, $L_{\text {eff }}=L_{\text {eff }}\left(\mathbb{U} ; @ U ; @^{2} U ;:::\right)$. The low energy analysis relies on the sym $m$ etry properties of this function, which follow from the fact that the Lagrangian of QCD is invariant under independent $U$ (3) rotations of the right- and lefthanded com ponents of the quark elds \{ except for the $U$ (1) anom aly which ruins the conservation of the axial singlet current and for the explicit sym $m$ etry breaking due to the quark $m$ asses. In an arbitrary chiral basis, the quark $m$ ass term is of the form $\bar{q}_{\mathrm{R}} m q^{+} \bar{q}_{\mathrm{I}} \mathrm{m}^{\mathrm{Y}} \mathrm{q}_{\mathrm{K}}$. U sing the projectors $P_{R}=\frac{1}{2}\left(1+{ }_{5}\right), P_{L}=\frac{1}{2}(1 \quad 5)$, the $D$ irac operator $m$ ay be $w$ ritten as $D=i \quad D+P_{L} m+P_{R} m^{y}$. The chiral rotation $q_{R}!V_{R} q_{R}, q!V_{L} q_{1}$, $V_{R} ; V_{L} 2 \mathrm{U}$ (3) takes this operator into $D^{0}=V D V$, with $V=P_{R} V_{R}+P_{L} V_{L}$, $V={ }^{0} V^{y}{ }^{0}=P_{L} V_{R}{ }^{Y}+P_{R} V_{L}{ }^{Y} . $T$ he change in the $D$ irac determ inant in e ect adds a term to the Lagrangian proportional to !. So, if a term of this form is allowed for to start $w$ th, $\bar{L}_{Q C D}=L_{Q C D} \quad$, the form of the Lagrangian rem ains the sam e under the fiull set of chiral transform ations, but both the quark $m$ ass $m$ atrix and the vacuum angle undergo a change, $m!V_{R} m V_{\mathrm{L}}{ }^{Y}$, !

This property of $Q C D$ may readily be form ulated at the level of the e ective theory. The presence of an additional coupling constant, , also show sup in the e ective Lagrangian, $\mathrm{L}_{\text {eff }}!\overline{\mathrm{L}}_{\text {eff }}=\overline{\mathrm{L}}_{\text {eff }}$ (U © ©U ;::: ;m; ). Since the phase of the determ inant $\mathrm{e}^{i} 0=\operatorname{det} U$ transform s according to ${ }_{0}^{0}=0^{+}$, the combination $0^{+}$rem ains invariant. It is convenient to replace the variable by this combination, $\overline{\mathrm{L}}_{\text {eff }}=\overline{\mathrm{L}}_{\text {eff }}$ (U;@U;:::;m; ${ }^{+}+$). The above sym $m$ etry relation then im plies that the e ective Lagrangian is invariant under a sim ultaneous rotation of the $m$ atrices $U$ and $m$, at a xed value of the last argum ent. The expansion in powers of derivatives and quark $m$ ass $m$ atrices yields a sequence of invariants which can be form ed with m;U;@U;:::. There are two di erences com pared to the corresponding series of term $s$ which occur in the standard fram ew ork, where the ${ }^{0}$ does not represent a dynam ical variable: the determ inant of $U$ di ers from one and the coe cients of the expansion are not constants, but functions of the

w th $\mathrm{V}_{\mathrm{n}}=\mathrm{V}_{\mathrm{n}}\left(+{ }_{0}\right)$. The expression is valid to all orders in $1=\mathrm{N}_{\mathrm{c}}$. The sym $m$ etry does not constrain the form of the coe cient functions, except that $\mathrm{V}_{0} ; \mathrm{V}_{1} ; \mathrm{V}_{3} \mathrm{~m}$ ust be real and even under parity, $\mathrm{V}_{\mathrm{n}}(\mathrm{x})=\mathrm{V}_{\mathrm{n}}(\mathrm{x})$, while $\mathrm{V}_{2}$ obeys $V_{2}(x)=V_{2}(x)$.

In the large $\mathrm{N}_{\mathrm{c}}$ lim it, the coe cients reduce to constants. The reason is that, in this lim it, the dependence of the various $G$ reen functions and $m$ atrix elem ents on is suppressed ' ' i ]: C om pared to the leading contribution of the QCD Lagrangian, $G^{a} G^{a}=4 g^{2}$, the term $G^{a} G^{a}=32^{2}$ represents a sm all perturbation of order $g^{2} \quad=N_{c}$. w th $\mathrm{p}_{0}=2 ; \mathrm{p}_{1}=\mathrm{p}_{2}=1 ; \mathrm{p}_{3}=0$. In fact, the leading term in the expansion of $\mathrm{V}_{0}$ coincides $w$ ith the ghonic contribution to the vacuum energy, $\mathrm{V}_{0}^{0}(\mathrm{x})=\mathrm{g}_{0}(\mathrm{x})$.
$T$ he above representation show s that the Taylor series of the coe cients $w$ ith respect to $0^{+}$is accom panied by powers of $1=\mathrm{N}_{\mathrm{c}}$, so that only the rst few term sare needed to a given order of the $1=\mathrm{N}_{\mathrm{c}}$ expansion. T he Taylor series of $V_{0}$, e.g., yields $V_{0}(0+)=0+\frac{1}{2}(0+)^{2}+O\left(1=N_{c}\right)$. The rst term $0=O\left(\mathbb{N}_{c}^{2}\right)$ is an irrelevant cosm ological constant, while $=O\left(\mathbb{N}_{c}^{0}\right)$ represents the second derivative of the glionic contribution to the vacuum energy w ith respect to and is referred to as the topological susceptibility.

In the present context, the dependence on is of interest only to incorporate the anom alous $W$ ard identity and to control the expansion in pow ers of $1=\mathrm{N}_{\mathrm{C}}$. The vacuum angle has now served its punpose and can be dism issed, setting $=0$. A lso, I now choose the chiral basis in such a m anner that the quark $m$ ass $m$ atrix is diagonal and real.

The preceding analysis involves a sim ultaneous expansion in powers of $1=N_{c}$, powers of $m$ om enta $p$ and powers of the quark $m$ ass $m$ atrix $m$. It is

[^1]convenient to order this triple series by counting the three expansion param eters as sm all quantities of order $1=\mathrm{N}_{\mathrm{c}}=\mathrm{O}\left(\mathrm{)}, \mathrm{p}=\mathrm{O}\left(^{-}\right.\right.$) and $\mathrm{m}=\mathrm{O}(\mathrm{r}$, respectively. D isregarding the cosm ological constant $m$ entioned above, the expansion then takes the form $L_{\text {eff }}=L_{\text {eff }}^{(0)}+L_{\text {eff }}^{(1)}+:::$, where the rst term is of order one,while the second collects the corrections of $O()$. Setting $V_{1}(0)=\frac{1}{4} F^{2}, V_{2}(0)=\frac{1}{2} F^{2} B$, the explicit expression for the leading term reads

The rst two term sare fam iliar from the standarde ective Lagrangian. They involve the pion decay constant $F=O\left(\overline{\mathrm{~N}_{\mathrm{c}}}\right)$ and the constant $\mathrm{B}=0\left(\mathbb{N}_{\mathrm{c}}{ }^{0}\right)$, which is related to the quark condensate. The third term is characteristic of the extension from $S U(3)_{R} S U(3)_{\mathrm{I}}$ to $U(3)_{R} U(3)_{\mathrm{I}}$. It equips the ${ }^{0} \mathrm{~W}$ th a $m$ ass proportional to the square root of the topological susceptibility.

The follow ing calculation also accounts for the corrections of rst nonleading order. In addition to the term $s$ arising from the Taylor coe cients $\mathrm{V}_{2}^{0}(0) \quad 2 \mathrm{~B} \mathrm{~K}_{1}$ and $\mathrm{V}_{3}(0) \quad \mathrm{K}_{2}$, which both are of $\mathrm{O}\left(\mathbb{N}_{\mathrm{C}}{ }^{0}\right)$, these also involve contributions from higher orders of the derivative expansion, om itted in eq. (īi). Their structure is known from the standard fram ew ork, where the corresponding e ective coupling constants are denoted by $\mathrm{L}_{1} ;::: ; \mathrm{L}_{8}$. The rst three of these do not play any role in the follow ing, because they m ultiply invariants of the type (©U) ${ }^{4}$ and do therefore not contribute to the $m$ asses of the pseudoscalars. The term $L_{4} h @ U^{Y} @ U i r m U^{Y}+m U i$ contains two traces. C ontributions of this structure can only arise from graphs with tw o orm ore quark loops: T he term violates the O kubo-Iizuka-Zw eig rule and is suppressed by one power of $1=\mathrm{N}_{\mathrm{c}}$. The sam e applies to the contributions proportional to $\mathrm{L}_{6}$ and $\mathrm{L}_{7}$. The coupling constants $\mathrm{L}_{5}$ and $\mathrm{L}_{8}$, how ever, are of $O\left(\mathbb{N}_{c}\right)$ and do contribute to the $m$ asses at rst nonleading order of the above expansion. A bsorbing the constant $B$ in the quark $m$ ass $m$ atrix $w$ ith

$T$ he rst line contains the leading contributions of order $\mathrm{N}_{\mathrm{c}} \mathrm{p}^{2} ; \mathrm{N}_{\mathrm{c}} \mathrm{m}$ and $\mathrm{N}_{\mathrm{c}}{ }^{0}$, respectively. Their relative size depends on the relative m agnitude of
the three expansion param eters $1=\mathrm{N}_{\mathrm{c}} \boldsymbol{;} \mathrm{p} ; \mathrm{m}$. The second line contains the corrections of order $\mathrm{N}_{\mathrm{c}} \mathrm{P}^{2} \mathrm{~m}$ and $\mathrm{N}_{\mathrm{c}} \mathrm{m}^{2}$, while the third one accounts for those of order $\mathrm{N}_{\mathrm{c}}^{0} \mathrm{~m}$ and $\mathrm{N}_{\mathrm{c}}{ }^{0} \mathrm{p}^{2}$.

Them ass spectrum is obtained by setting $U=\exp i^{\prime}=F$ and working out the term $s$ quadratic in the $m$ atrix eld '. In this notation, 0 is given by the trace $h^{\prime} i=F$, so that the quadratic tem $s$ are

For those elds which carry electric charge or strangeness, this expression is diagonal and yields

These relations agree with those of chiral perturbation theory $\overline{\underline{Z}}]$, w th two sim pli cations: (i) The coupling constants $L_{4}$ and $L_{6}$ do not occur here, because they are suppressed by one power of $\mathrm{N}_{\mathrm{c}}$. (ii) For the sam e reason, the chiral logarithm s generated by the one loop graphs are absent. Since these graphs are inversely proportional to $F^{2}$, they only show up at the next order of the expansion under consideration.

The above $m$ ass form ulae im ply that the corrections in the two ratios, ${ }_{\underline{3}}{ }^{3}$

 the chiral lim it. The corrections of higher order are discussed in [ $[\underline{[ }, 1,1]$ ]. The corresponding unœertainty in the value of $Q$ is of order $10 \%$.

In the neutral sector, the contributions from $\mathrm{L}_{5}$ and $\mathrm{K}_{2}$ introduce O diagonalelem ents into the kinetic term. The $m$ asses of the neutral particles are thus obtained by diagonalizing this form. The m ixing angles between the ${ }^{0}$ and ; ${ }^{0}$ are proportional to the isospin breaking $m$ ass di erence $m_{d} \quad m_{u}$. These angles are $s m$ all, but play a crucial role e.g. for the transition ! 3 . In the $m$ asses of the neutral particles, however, isospin breaking only generates contributions of order $\left(m_{d} \quad m_{u}\right)^{2}$, which are negligibly $s m$ all. $D$ isregarding these, the ${ }^{0}$ is degenerate $w$ th and the only mixeswith the ${ }^{0}$. The $m$ ass form ulae for the charged particles $m$ ay be used to elim inate the quark $m$ asses in favour of $M_{K}^{2} ; M^{2}$. The coe cients then take the form

Rem arkably, $\mathrm{m}_{1}^{2}$ only involves the samecorrection $m$ which also occurs in the m ass formulae for and K . The term ${ }_{\mathrm{N}}=12 \overline{\mathrm{~K}}_{1}=\mathrm{F}^{2}$, which describes the Zweig rule violating contributions of order $1=\mathrm{N}_{\mathrm{c}}$, only a ects the quantities 1 and $M_{1}^{2}$.

The relation states that the $G$ ell $M$ ann-O kubo form ula, $M^{2}=\frac{1}{3}\left(4 M_{K}^{2} \quad M^{2}\right)$, receives tw o categories of SU (3) breaking corrections: W hile the rst is govemed by the sam e param eter $m$ which also determ ines the corrections in the $m$ asses of the charged particles and is accounted for in the term $\mathrm{m}_{1}^{2}$, the second arises from the $-{ }^{0}$ transition $m$ atrix elem ent of the operator $\bar{q} m q$ and is proportional to ${ }_{1}^{2}$.

The consequences of these m ass form ulae are the follow ing. I rst recall that the relation ( (बَ) constrains the two ratios $x=m_{u}=m_{d}$ and $y=m_{s}=m_{d}$ to an ellipse. Since $Q^{2}$ is very large, the ellipse is well approxim ated by $x^{2}+y^{2}=Q^{2}=1$, i.e. the center is at the origin and $Q$ represents the large sem iaxis, while the sm all one is equal to 1 . To determ ine the individual ratios x; y one needs to know the quantity $M$, which describes the strength ofSU (3) breaking in them ass form ulae and involves the tw o e ective coupling constants $\mathrm{L}_{5} ; \mathrm{L}_{8}$. The form er is known from the observed asym $m$ etry in the decay constants $\mathrm{F} ; \mathrm{F}_{\mathrm{K}}$, but, as pointed out by K aplan and M anohar [ $[\underline{1} \mathrm{I}], \mathrm{L}_{8}$ cannot be determ ined on purely phenom enologigalgrounds. The scattering of the chiral perturbation theory results for the $m$ ass ratios $m_{u}=m_{d}$ and $m_{s}=m_{d}$
 $L_{8}$ as a free param eter, one $m$ ay obtain any value for $m$ and thus reach any point on the ellipse. In particular, the possibility that the $m$ ass of the lightest quark $m$ ight vanish is widely discussed in the literature, because th is would rem ove the strong CP problem [2"2, ]. This possibility corresponds to $m_{u}=m_{d}=0 ; m_{s}=m_{d}=Q$ and requires that the correction is large and negative, $\mathrm{M}=\mathrm{M}_{\mathrm{K}}^{2} \neq \mathrm{M}^{2}=\left(\mathrm{Q}+\frac{1}{2}\right) \quad 1^{\prime} \quad 0: 45$.
I now w ish to show that the fram ew ork speci ed above leads to a lower bound on $m$ which requires $m_{u}$ to be di erent from zero. The bound arises
because the relation $(\underline{1}, \overline{1})$ only adm its a solution for $M^{2}<m_{1}^{2}$, or

$T$ he inequality is an im $m$ ediate consequence of the fact that $-{ }^{0} \mathrm{~m}$ ixing leads to a repulsion of the two levels. A dm ittedly, the hypothesis that the rst two term s of the $1=\mathrm{N}_{\mathrm{c}}$ expansion yield a decent approxim ation for the theory of physical interest, $\mathrm{N}_{\mathrm{c}}=3$, goes beyond solid phenom enology. T his hypothesis, how ever, represents the only coherent explanation of the fact that the $O$ kuboZw eig-Iizuka-rule holds to a good approxim ation and I see no reason to doubt its reliability in the present case.

The large negative value of ${ }_{M}$ required if $m_{u}$ were to vanish violates the above bound. The $1=\mathrm{N}_{\mathrm{c}}$ expansion thus corroborates the conclusion that $m_{u}$ is di erent from zero. As is well-know $n$, the quantity $e^{i}$ detm then represents a physically signi cant param eter of the Q CD Lagrangian. W hy the $m$ echanism which generates $m$ and happens to be such that, to a high degree of accuracy, this quantity is real, represents a well-know n puzzle [ַ It cannot be solved the easy way, w ith $\mathrm{m}_{\mathrm{u}}=0$.

A sim ilar inequality also holds for the $1=\mathrm{N}_{\mathrm{c}}$ correction,

This indicates that Zweig rule violating e ects are not entirely negligible.
As it stands, the $m$ ass form ula (i, ) only determ ines the $m$ agnitude of the $S U$ (3) asym $m$ etry $m \quad\left(m_{s} \quad m\right)$ if the size of the Zweig rule violation
${ }_{\mathrm{N}} \quad 1=\mathrm{N}_{\mathrm{c}}$ is know n and vige versa. O ne m ay, e.g., choose a value for ${ }_{\mathrm{N}}$, such that $m$ saturates the inequality ( (8), . This is the case, how ever, only if 1 vanishes, i.e. if $1+{ }_{\mathrm{N}} \mathrm{m}_{\mathrm{N}}=0$. In other words, the corrections would have to cancel the leading term. It is clear that in such a situation, the above form ulae are $m$ eaningless. A coherent picture only results if both ј м $j$ and $j$ к $j$ are $m$ all com pared to unity. The mass fom ula ( that a negative value of the $S U$ (3) asym $m$ etry $m$ requires exorbitant $1=N_{c}$ corrections. E ven $M_{M}=0$ calls for large Zweig rule violations, ${ }_{N}$ ' $\frac{1}{2}$. The term $\left(l_{+} \mathrm{M}_{\mathrm{N}}\right)^{2}$, which corrects the contribution generated by the singletoctet transitions for e ects of rst nonleading order, would then instead
$m$ odify this contribution by a factor of 4 ifevaluated as it stands, elim inating it altogether if expanded to rst order in the "corrections". The condition

thus represents a generous lower bound for the region where a truncated $1=\mathrm{N}_{\mathrm{c}}$ expansion leads to m eaningful results. It states that the current algebra form ula, which relates the quark $m$ ass ratio $m_{s}=\hat{f}$ to the $m$ eson $m$ ass ratio $M_{K}^{2}=M^{2}$ represents an upper lim it, $\mathrm{m}_{\mathrm{s}}=\hat{\mathrm{m}}<2 \mathrm{M}_{\mathrm{K}}^{2}=\mathrm{M}^{2} \quad$. The corresponding bounds on the two ratios $m_{u}=m_{d}$ and $m_{s}=m_{d}$ depend on the value of $Q$,

If $Q$ is taken from the $D$ ashen theorem, these relations state that the $W$ einberg ratios rated, $\mathrm{m}_{\mathrm{u}}=\mathrm{m}_{\mathrm{d}}>0: 55 ; \mathrm{m}_{\mathrm{s}}=\mathrm{m}_{\mathrm{d}}<20: 1$. Low ering the value of Q to $\mathrm{Q}=22$, the bound on $m_{u}=m_{d}$ becom es slightly weaker, $m_{u}=m_{d}>0: 48$, while the one for $\mathrm{m}_{\mathrm{s}}=\mathrm{m}_{\mathrm{d}}$ decreases to $\mathrm{m}_{\mathrm{s}}=\mathrm{m}_{\mathrm{d}}<19: 2$. The estim ate $\mathrm{m}_{\mathrm{u}}=\mathrm{m}_{\mathrm{d}}=0: 3 \quad 0: 1$ obtained in ref. $\left.1 \overline{1} \bar{T}_{1}, 12 \overline{1} \overline{0}\right]$ from a m ultipole analysis of the transitions ${ }^{0}!\quad{ }^{0},{ }^{0}$ ! is outside this range and is thus not consistent w ith the above argum ents (see also ref. $\left.\left.\overline{[1}_{2}^{1}\right]_{1}\right]$.

To dem onstrate that the observed $m$ ass pattem is perfectly consistent w ith the hypothesis that the corrections of order $1=\mathrm{N}_{\mathrm{c}}$ as well as those of order $m$ are $s m$ all, I note that the contribution from the second term in
 corrections to that term are reduced by the same factor. The only new contribution in the second order formula which does not get suppressed is the one responsible for the di erence betw een $m{ }_{1}^{2}$ and the value of ${ }^{2}$ which follow $s$ from the $G$ ell-M ann-O kubo form ula. Retaining only this term, the second order form ula sim pli es to

N um erically, this gives $m=0: 18$, thus requiring a breaking of SU (3) sym$m$ etry in the $m$ ass form ulae of the sam e order of $m$ agnitude as in the decay
constants. The corresponding value for the $1=\mathrm{N}_{\mathrm{c}}$ correction is also quite sm all, ${ }_{\mathrm{N}}=0: 24$. I repeat, how ever, that the above fram ew ork does not predict the values of the two corrections individually, but only correlates them. In particular, the truncated large $N_{c}$ expansion is also consistent w ith a som ew hat sm aller breaking of SU (3) sym $m$ etry and a correspondingly larger violation of the Zweig rule.
