W ick's Theorem at Finite Temperature

A bstract

We consider W ick's Theorem for nite temperature and nite volume systems. Working at an operator level with a path ordered approach, we show that contrary to claims in the literature, expectation values of norm all ordered products can be chosen to be zero and that results obtained are independent of volume. Thus the path integral and operator approaches to nite temperature and nite volume quantum eld theories are indeed seen to be identical. The conditions under which norm all ordered products have simple symmetry properties are also considered.

1 Introduction

Early developments of them alleld theory were based on a path ordered operator approach [1], and W ick's theorem played a crucial role in the development of its perturbation theory [1, 2]. More recently, other approaches to the subject have been developed { in particular, path ordered m ethods have been extended, offen by using a path integral approach [3, 4, 5, 6], and Therm o Field D ynam ics (TFD) in which a doubling of the states of the system is introduced [3, 4, 5, 7, 8, 9]. It is important to understand to what degree these various approaches are equivalent [3, 4].

However, a closer inspection of the original literature and subsequent standard texts turns out to be rather confusing regarding the issue of W ick's theorem and the expectation value of norm all ordered products. In particular there are claim s that there are nite volume corrections to the standard therm all perturbation theory. If this was true then in some important cases, such as in the study of the quark-gluon plasm a form ed in relativistic heavy ion collision experiments, there would be important new corrections

to some existing calculations. In this paper we concentrate on path-ordered operator approaches and we clarify the confusion found in the literature. These results have a direct translation into a path integral language which we consider in the penultim ate section. In terms of TFD the principles are similar but the implementation is rather di erent. However, the case of TFD is considerably easier because of its similarity with zero temperature eld theory and the literature rejects this. We will consider TFD in our conclusions.

Central to our discussion is Wick's theorem which we refer to as an operator identity rather than a relation between expectation values. It relates time ordered products of elds to norm all ordered products and contractions. At zero temperature, the use of W ick's theorem revolves around the fact that norm all ordered products are de ned such that annihilation operators are always placed to the right of creation operators. This ensures that vacuum expectation values of norm alordered products, N [:::], vanish: h0 N [aay] Di = 0. How ever with the ensemble averages used in them al eld theory, products of elds norm all ordered in the same way are no longer zero: $n e^{n} l \ln ja^{y}a jn i \neq 0$. Since in calculations one considers G reen functions, expectation values of time-ordered functions, it is useful but not crucial to show that them alexpectation values of norm al ordered products are zero: all that is actually required is a relation between G reen functions of di erent orders. It is this 'expectation value version' of W ick's theorem which is proved by Thouless [10] for real relativistic scalar elds. U sing rather di erent techniques, G audin [11] proved the same expectation value version' in a ratherm ore transparent way using the cyclicity of the therm al trace. This is the approach also used in [6, 12, 13]; it avoids the need to discuss norm alordering at all. Volum e does not enter into the argum ent either. In m ore m odern texts [3, 5, 14] which rely on path integral m ethods, the expectation value version of W ick's theorem is inherent in the notation { it is essentially encoded as Schwinger-Dyson equations for the free eld case.

We now return to the issue of norm all ordering which was not properly dealt with in the original paper of M atsubara. The area has been studied in subsequent literature, and seems to be a source of confusion. By using a de nition of norm all ordering di erent from that of standard eld theory, Thouless [10] proves that therm all expectation values of norm all ordered products of non-relativistic ferm ions can be set to be zero. Fetter and W alecka [12] use G audin's argument and claim that \Unfortunately, ::: the ensemble average of norm all ordered products is only zero at zero temperature" contrary to [10]. G ross et al. [15] use the same approach.

The situation is further confused by various authors' considerations of nite volum e corrections. M atsubara [1] suggests that the expectation values of norm all ordered terms may be zero only in the in nite volum e limit. This argument is given in greater detail in Abrikosov et al. [16] and Lifschitz and P itaevskii [17]. If this was true, there could be important corrections to standard perturbation theory, coming from the usually neglected norm all ordered terms, when working with nite volumes systems. As the quark-gluon plasm a form ed in relativistic heavy ion collisions lls a comparatively small volume, such nite volume correctionsm ight be of great in portance in practical calculations. Yet where

are such volume term shiding in the derivations using the properties of the therm altrace [6, 11, 12, 13] and in path integral derivations [3, 5, 14]?

The nite volume argument is worth repeating here for reference later on. For sim-

plicity, consider a non-interacting equilibrium system of relativistic neutral bosons at temperature T lying in a volume V. Let $^{\rm b}(x)$ be the herm itian eld operators in the Heisenberg picture. We wish to calculate G reen functions, and as a speci c example consider the four-point therm al W ightm an function

The angular brackets denote a therm al expectation value (which is dened in the next section), and x_i are dimensional space-time points. In momentum space, W $_{1;2;3;4}$ contains term softhe form

where \hat{a}_k^{Y} and \hat{a}_k are creation and annihilation operators, the k_1 's are discrete m om enta, and Y is a sum of scalar products of 4 m om enta and space-time coordinates. In the literature it is claimed that there are three separate contributions to (1.2) [1, 16, 17]. The rst 2 contributions arise when the momenta are equal in pairs, that is when $k_1 = k_3$,

 $k_2 = k_4$ and $k_1 = k_4$, $k_2 = k_3$. For example, in the form er case (1.2) becomes

The nalcontribution arises when all the momenta are equal:

A coording to some standard texts (for example [16, 17]), \expression (1.3) has a special feature which distinguishes it from (1.4), i.e. the number of factors in 1=V is the same as the number of summations, whereas in (1.4) this number of factors is larger". Thus (1.4) has \an extra factor of 1=V and will vanish as V ! 1 ". These texts conclude that, once the in nite volume limit has been taken, \we can actually average over pairs of operators". The implication is that only in this limit does the four-point G reen function. (or in general an n-point one) split into a sum of products of two-point G reen functions.

In this paper we prove that the above argument is incorrect and that any n-point G reen function can be decomposed exactly into two-point G reen functions, whatever V. We also prove explicitly that therm all expectation values of norm all ordered products of any type of eld m ay always set to zero, contrary to claim s elsewhere [12]. The symmetry properties of norm all ordered products are considered.

The paper is organised as follows. In section 2 we set up our notation and de nitions. This is essential as we will be discussing di erent types of norm all ordering and we wish to track volum e factors very carefully. In section 3 we split leds into two parts at an operator level and de ne norm all ordering and contractions appropriately. We choose a split which guarantees that the therm all expectation value of norm all ordered products of any two led operators is always zero and hence that the norm all ordered products have simple symmletry properties. We then prove in section 4 that this is su cient to ensure that the therm all expectation value of any four-point norm all ordered product also vanishes, independent of volum e. W ith W ick's theorem, this then shows directly that the four-point G reen function decomposes exactly into two-point G reen functions. In section 5 we generalise this result from four-point to n-point G reen functions by using more powerfulm ethods. One is the usual path integral approach to therm all eld theory. The other is based on the cyclic property of the trace which de ness the therm all expectation value [11, 12]. We use these, with W ick's theorem, to show that the therm all expectation value of all n-point norm all ordered products vanish. We also note the symm etry of the n-point norm all ordered products.

2 De nitions and Notation

For simplicity we consider only free eld theories and work in the Heisenberg picture. Our results are completely equivalent to working with an interacting theory in the interaction picture. There the operators evolve according to the free Ham iltonian and the interactions are encoded in the S matrix. W hen expanded, the S matrix leads one to consider time-ordered products which are of the same form as those considered here. At

nite tem perature, one has to be rather m ore careful about the use of an S m atrix, but one can still follow a similar algorithm so that our results can be applied to practical calculations at nite tem perature.

Field operators, b(x), are given in terms of particle and anti-particle creation and annihilation operators, \hat{a}_k^y , \hat{a}_k and \hat{b}_k^y , \hat{b}_k respectively;

The metric is diag (+1; 1; 1; 1) and $\frac{a}{k} = k^2 + m^2$ for relativistic eld theories. For non-relativistic ones $!_k = k^2=2m$, and $\hat{b}_k = 0$. A real relativistic scalar theory has $\hat{a}_k = \hat{b}_k$. For ferm ionic theories, \hat{a}_k and \hat{b}_k implicitly carry spin indices, and there is an implicit sum over spins as well as over momenta. A numbration and creation operators must also be multiplied by the correct solutions to the D irac equation if the theory is relativistic but this does not e ect our results. Likewise, the analysis holds for elds of higher spin, where additional indices have been suppressed, as only the statistics of the eld is relevant to this analysis.

The operators obey the canonical commutation relations,

The $_{a,b}$ are chemical potentials for particles and anti-particles respectively. If we have a U (1) symmetry, as in the case of a complex relativistic eld, then $_{a} = _{b}$. For a real scalar eld $_{a} = _{b} = 0$. The $\hat{N}_{k}^{a,b}$ are conserved number operators whose normalised eigenvectors are denoted by $jn_{k}i$ for particles, and $jn_{k}i$ for anti-particles. They are complete and satisfy

We now split the eld operators arbitrarily into two parts

We call the parts \positive" and \negative" even though in general the split is not into positive and negative energy waves. In order to avoid possible confusion between y and + superscripts, the herm it ian conjugate of an operator is denoted by $= {}^{y}$. We do not assume that the operator and its herm it ian conjugate are split in the same way. That is, we do not assume that $[]^{+} {}^{y} = .$ This means care must be taken with the notation; we always have ${}^{+} = [{}^{y}]^{+}$ rather than it being equal to $[]^{y}$.

To allow for products of m ore than one type of eld operator, we now use the notation

Of course we will often be looking at products where some or all of the operators $b_i(x)$ are equal or related by herm it ian conjugation.

Norm all ordering is de ned in terms of the arbitrary split (2.16), so generalising the traditional T = 0 de nition which is expressed in terms of annihilation and creation operators. We always de ne norm all ordering to strictly mean that all + elds are placed to the right of elds; otherwise the order of the elds is left unchanged. (So it diers from that used for fermions in [10].) For example,

Here 1 and 2 are any two elds with di erent space-time arguments $(t_1; x_1)$ and $(t_2; x_2)$ respectively (which for convenience we usually suppress). The elds may be related, e.g. one often has $_1 = (t_1; x_1)^y$; $_2 = (t_2; x_2)$. For general splits N_{1;2} may not be symmetric; N_{1;2} \in N_{2;1}.

T in e ordering is de ned in the usual way so for the two-point case we have

It is straightforward to generalise this time ordering to path ordering as used in some nite temperature analysis. Then the theta functions of time in (2.19) become de ned in terms of a path in complex time $[\beta]$. As this does not elect the subsequent analysis we will not complicate our notation further.

W ick's theorem is an operator identity. For two-point functions it relates $T_{1;2}$ to $N_{1;2}$ by de ning the contraction D $\begin{bmatrix} 1 & 2 \end{bmatrix} = D_{1;2}$:

W e will only consider splits, (2.16), for which D_{1;2} is a c-num ber { that is splits linear in the annihilation and creation operators. Note that the contraction, and hence the norm al ordered product, is only symmetric, D_{1;2} = D_{2;1}, if

where $j_i(x)$ are sources. Functional di erentiation with respect to these sources gives W ick's theorem, which after using the symmetry properties of the time-ordered product is of the form

The sum takes $a_1;:::a_{2n}$ through all permutations of 1;:::;2n, and p is the number of times one has to interchange pairs of ferm ions in moving from 1;:::;2n to $a_1;:::a_{2n}$ order. The sum over permutations can be simplied (even for non-symmetric normal ordered products and contractions) to give the usual form of W ick's theorem. For four bosonic elds, (2.24) gives the well known result

Once again, we stress that (2.23) { (2.26) hold whatever the decomposition of the elds into positive and negative parts provided the contraction is a c-number. They hold whether or not the contraction is symmetric.

3 Two-point functions

In this section we prove that it is always possible to de nea split $b(x) = b^+(x) + b(x)$ such that $N_{1,2} = 0$. This then ensures that $D_{1,2} = T_{1,2} = D_{2,1}$.

A general linear decomposition of (x) and (x) into positive and negative parts is

First consider (3.7) and (3.8) in the limit T ! 0. They are solved by $f_k = g_k = G_k = F_k = 0$ which is just the traditional T = 0 split as all the annihilation operators are in $^+$ and the creation operators in \cdot . Taking the vacuum expectation value of (2.20), the two-point version of W ick's theorem, we see that for T = 0, $D_{1,2} = h0 \text{ Jr} \begin{bmatrix} 1 & 2 \end{bmatrix} \text{ Ji} = G_{1,2}$ (T = 0), the zero tem perature propagator.

For T > 0, the equations for f_k and g_k , F_k and G_k respectively each have two solutions

where $s^{a,b} = 1$ gives the two solutions in each case. Now, again, the therm all expectation value of (2.20) gives $D_{1,2} = T \begin{bmatrix} 1 & 2 \end{bmatrix} = G_{1,2}(T)$, where $G_{1,2}(T)$ is the therm all propagator.

For large k, we see that $f_k;g_k;F_k$ and G_k all tend to zero. Thus at high energies the split which gives zero normal ordered products at nite temperature is tending to be the same as the usual one used at zero temperatures. This is not suprising as the ultra-violet behaviour of nite temperature eld theory is well known to be the same as zero temperature eld theory.

For bosons, (3.9) and (3.9) give real $f_k; g_k; F_k$ and G_k , but $[]^{+ \frac{y}{6}}$ unless T = 0. For fermions $f_k = g_k$ and $jf_k \hat{j} = jg_k \hat{j} = N_k^a$, and similarly for F_k and G_k . However, in this case, $[]^{+ \frac{y}{6}} = for all T$.

For non-relativistic elds, we just set $\hat{b}_k = 0$. In the ferm ionic case, this recaptures the result of Thouless [10].

For real relativistic scalar elds there is only one type of creation and annihilation operator. As $\hat{a}_k = \hat{b}_k$ and $N_k^a = N_k^b = N_k$, a single Bose E instein distribution, one must have $F_k = g_k$, $G_k = f_k$ in (3.1)-(3.4). This gives a general linear decomposition of a

real scalar eld. Equations (3.5) and (3.6) are now equivalent and their solutions are as above.

F inally we consider the question of the sym metry of the norm all ordered products for the case of two-point functions. On substituting (3.1) to (3.4) into (2.22) one nds that

This means that the split traditionally used in zero tem perature work, where $f_k = g_k = F_k = G_k = 0$, has a symmetric two-point norm all ordered product. However (3.9) and (3.10) also satisfy (3.11). Thus the splits for which the therm all expectation value of two-point norm all ordered products are zero, are guaranteed to have symmetric two-point norm all ordered products.

4 Four-point functions

W e now prove that the them alexpectation value of the four-point norm alordered products N $_{1,2,3,4}$ vanish for the split of section 3. Hence we show that the four-point G reen function decomposes into two-point G reen functions for all V. For simplicity, we consider a real relativistic scalar eld theory. Our results are generalised to other theories in section 5.

Equation (2.25) can be used to relate $N_{1;2;3;4}$ to $N_{1;2;3;4}^{0}$, where in the primed norm all ordered product the operators have been split according to the T = 0 split (i.e. the one for which $f_k = g_k = 0$). The therm all expectation values of these two quantities satisfy

Thus taking the therm alexpectation value of (2.25), the four-point G reen function $G_{1;2;3;4}$ is seen to decompose exactly into two-point G reen functions $G_{1;2}$:

Equation (4.7) shows explicitly how contributions down by a factor of the volume, such as (1.4), which is the last term of (4.4), do in fact cancel. We just have to be careful to exclude the contribution of (1.4) from (1.3) { hence the (1) } term s in (4.4). It is clear from this derivation that there are no volume corrections to expectation value version of W ick's theorem (4.9).

5 n-point functions

We now generalize (4.9) to n-point G reen functions by using more powerful methods, namely the \trace theorem " and the path integral. Both of these methods may be applied to any type of eld operator { bosonic or ferm ionic, relativistic or non-relativistic. The resulting generalized form of (4.9) then enables (4.8) to be generalized to all orders and to all types of elds. We also consider the symmetry properties of n-point norm all ordered products, and nally show how di erent splits may be related.

5.1 The \Trace Theorem "

This is described in detail in [11, 12] and uses the cyclic property of the trace.

Consider again

Here $\uparrow_1(k) = \hat{a}_k$ and $\uparrow_2(k) = \hat{a}_k^{y}$ (we still consider a real scalar relativistic eld theory for notational sim plicity). The therm alexpectation value reduces to a trace over \uparrow operators, which we call $S \coloneqq Tr \ e^{-\hat{H}_0} \uparrow_a(k_1) \uparrow_b(k_2) ::: \uparrow_t(k_n)$. Since the commutation relations of the $\uparrow's$ are known $\uparrow_a(k_1)$ can be commuted through $\uparrow_b(k_2)$, then $\uparrow_c(k_3)$, and so on until it is nally commuted through $\uparrow_t(k_n)$. Then using the cyclic property of the trace, it can be taken to the left-hand side of the expression. Finally, after commuting through $e^{-\hat{H}_0}$ one obtains

Repeated use of (5.3) and (5.4) enable W $_{1;2;...;n}$ to be expressed as a sum of products of the form W $_{1;2;...;n}$ 2W $_{n-1;n}$. Iterating the argument, one obtains a generalisation of (4.9), that is

The sum takes a_1 ;::: a_{2n} through all permutations of 1;::;2n. C learly this argument has no reference to volum e.

5.2 The Path Integral

Equation (5.5) may be obtained by using the path integral approach to thermal eld theory. Let C be a directed path in the complex time plane whose end is i below the starting point, and let T_C denote path ordering of the operators with respect to C. The generating functional is then de ned by

where j(t;x) are classical sources coupled to the classical elds (t;x). This can be rewritten as $[\beta]$

Here $_{C}(\mathbf{x} \quad \mathbf{x}^{0}) = G_{1;2}$ is the two-point therm all G reen function or propagator { it is the G reen function of the classical equation of motion for the elds $(\mathbf{t};\mathbf{x})$ subject to the KMS boundary condition [3]. As usual, the higher order G reen functions are given by

and so (5.5) is once again obtained. A gain there are clearly no volum e corrections of the type m entioned in the introduction.

5.3 Expectation values of norm alordered products

W e now consider them al expectation values of norm all ordered products of any type of eld operators. Since both the path-integral and \trace theorem " can be generalised to all types of eld operators [3, 11], (5.5) can be generalised to give

However, from (2.24) we know the relation between time-ordered products, normal ordered products and contractions. Suppose we work with the splits satisfying (3.7) and (3.8) where the expectation value of the two-point normal ordered products is zero and the contraction is equal to the thermal propagator. Then (5.9), with (2.25) for the four point case, imply that $N_{1,2;3;4} = 0$. This generalises the result proved directly for real relativistic scalar elds in section 4.

Now we combine these results for two- and four-point functions with the six-point versions of (5.9) and (2.24); they imply that $N_{1;2;3;4;5;6} = 0$. Repeating, we see that the splits satisfying (3.7) and (3.8) ensure that the therm alexpectation values of all norm alordered functions are zero,

All of these results are independent of volume.

5.4 Sym m etry of norm alordered products

By de nition the tim e-ordered function has the sym m etry property $T_{1;2;...;n} = (1)^{n}T_{a;b;...;t}$ where a;b;:::;t is any permutation of 1;2;:::;n and p is the number of time pairs of ferm ionic elds are interchanged in moving from an order 1;2;:::;n to an a;b;:::;t order of elds. U sing (3.11) it can be shown that

Thus for both the T = 0 split and that of (3.9) and (3.10), the norm all ordered products have the same symmetry as time ordered products.

5.5 Relating two di erent splits

Equation (2.23) m ay be used to derive a relationship between di erent splits, i.e. between di erent types of norm allordering. Suppose N and N 0 label two di erent kinds of norm all ordering (for which D and D 0 are the corresponding c-num ber contractions). Then from (2.23) they are related by

The di erence between normal ordering is therefore related to the di erence between contractions. Now let D⁰ and N⁰ refer to the usual T = 0 split. Then D⁰_{1/2} = G_{1/2} (T = 0) and N⁰ \notin 0. Thus in calculating the thermal expectation value of a n-point time ordered function using (2.26), the terms containing N⁰ are non-vanishing. (Recall that for this T = 0 split normal ordered products are symmetric, and so the sum over permutations in (5.13) simpli es greatly.)

Now compare the T = 0 split to the splits satisfying (3:7) and (3.8). Let these splits have corresponding normal ordering and contraction labelled by N and D. Then

N = 0, and taking the therm alexpectation value of (5.13) gives

Hence if one works with the usual T = 0 split, the additional terms coming from $N^0 \neq 0$ are accounted for precisely by the therm alcorrections G(T) = 0 to the zero temperature propagator. It may therefore make more sense to work with the splits de ned by (3:7) and (3.8).

We can use the form ula (5.14) to provide a di erent view of several aspects of therm al eld theory. For instance in real-time approaches there is a doubling of the degrees of freedom [3, 4, 5, 6, 7, 8, 9]. It is only the nite temperature corrections to the zero temperature propagators which mix the physical and unphysical degrees of freedom. Thus one could book on the doubling as being necessary only to take account of the norm al ordered products, N⁰, where they are de ned in the usual manner of zero temperature.

6 Conclusion

C ontrary to claim s in the literature, we have proved that for elds of arbitrary statistics there are no nite volum e corrections to the usual relationship between therm al G reen functions (5.9). Thus the operator approaches and path integral approaches to therm al eld theory are indeed consistent in this respect. So in trying to understand the physics of the quark-gluon plasm a form ed in relativistic heavy-ion collisions, we have to look elsewhere to understand how nite volum e a ects the physics.

In proving the above, we have de ned and used a linear split of the eld operators into positive and negative parts such that $N_{1;2;...;2n} = 0$. This split enables usual T = 0 eld theory to be m in idked. By choosing to work with a split where such a result holds, we will simplify practical calculations.

For instance when we are working with unphysical degrees of freedom at nite tem perature, such as appear in gauge theories, one usually therm alises all the degrees of freedom. However, it has been noted that such degrees of freedom need not be therm alised [18]. In the language of this paper, we would say that one m ay choose a di erent split (2.16) for each eld. In particular, we may optim ise the splits depending on how each eld acts on the states in the ensemble. So with unphysical modes and an ensemble average taken over just physical states, the best split, norm all ordering etc. for the unphysical modes is the zero temperature one, whereas we norm all order the physical modes in terms of the usual therm all split of (3.7) and (3.8). This idea can extended to out-of-equilibrium situations where di erent physical degrees of freedom m ay well be present in the ensemble in quite di erent amounts suggesting that we de ne norm all ordering and contractions di erently for each eld so as to ensure that $N_{1:2:::::2n} = 0$ always.

We have referred only to the path-ordered approaches to therm all eld theory, be they real- or in aginary-time form alisms. Another simple method of obtaining (5.9) is to use TFD [3, 4, 5, 7, 8]. There one must norm all order with respect to the \therm all quasi-particle operators"; e; 1 and e! which annihilate the therm all vacuum, as this guarantees that all therm all expectation values of norm all ordered products vanish, for example see [19]. (For de nition of the term inology and notation, see [9], [8].) Equation (5.9) then follows directly from (2.26) whereas in [8] a rather lengthy derivation is given. This argument is also clearly independent of volume easitm in ics the standard zero temperature eld theory case. It is immediately obvious that these comments regarding TFD and norm all ordered products apply to any situation where a Bogoliubov transform ation is used.
