# W ick's Theorem at $F$ in ite $T$ em perature'

#### Abstract

W e consider $W$ idk's $T$ heorem for nite tem perature and nite volum e system s . W orking at an operator levelw ith a path ordered approach, we show that contrary to clam s in the literature, expectation values of nom al ordered products can be chosen to be zero and that results obtained are independent of volum e. Thus the path integral and operator approaches to nite tem perature and nite volum e quantum eld theories are indeed seen to be identical. The conditions under which norm al ordered products have sim ple sym $m$ etry properties are also considered.


## 1 Introduction

Early developm ents of therm al eld theory were based on a path ordered operator approach $[\underline{[1]}]$, and $W$ idk's theorem played a crucialrole in the developm ent of its perturbation theory ${ }_{[1]}^{11}$, i $\left.12 \overline{1}\right]$. M ore recently, other approaches to the sub ject have been developed \{ in particular, path ordered $m$ ethods have been extended, often by using a path integral ap-




H ow ever, a closer inspection of the original literature and subsequent standard texts tums out to be rather confusing regarding the issue ofW idk's theorem and the expectation value of nom al ordered products. In particular there are claim s that there are nite volum e corrections to the standard therm al perturbation theory. If this was true then in some im portant cases, such as in the study of the quark-gluon plasm a form ed in relativistic heavy ion collision experim ents, there would be im portant new corrections

[^0]to some existing calculations. In this paper we concentrate on path-ordered operator approaches and we clarify the confusion found in the literature. These results have a direct translation into a path integral language which we consider in the penultim ate section. In tem s of TFD the principles are sim ilar but the im plem entation is rather di erent. H ow ever, the case of TFD is considerably easier because of its sim ilarity w ith zero tem perature eld theory and the literature re ects this. Wewill consider TFD in our conclusions.

Central to our discussion is $W$ idk's theorem which we refer to as an operator identity rather than a relation between expectation values. It relates tim e ordered products of elds to norm al ordered products and contractions. At zero tem perature, the use of $W$ ick's theorem revolves around the fact that nom al ordered products are de ned such that annihilation operators are alw ays placed to the right of creation operators. $T$ his ensures that vacuum expectation values of nom alordered products, N [: ::], vanish: h0 N $\left[a a^{\mathrm{y}}\right] \mathrm{j} \mathrm{Oi}=0$. H ow ever w ith the ensemble averages used in therm al eld theory, products of elds nom alordered in the sam eway are no longer zero: ${ }^{P}{ }_{n} e^{n!} h_{n} j^{y} a j i \notin 0$. Since in calculations one considers $G$ reen functions, expectation values of tim e-ordered functions, it is usefulbut not crucial to show that therm al expectation values of norm al ordered products are zero: all that is actually required is a relation between $G$ reen functions of di erent orders. It is this expectation value version' of W idk's theorem which is proved by $T$ houless [īq] $\bar{q}]$ for real relativistic scalar elds. U sing rather di erent techniques, G audin $[1]=1]$ proved the sam e expectation value version' in a ratherm ore transparent way
 avoids the need to discuss norm al ordering at all. Volum e does not enter into the argu-
 expectation value version of W idk's theorem is inherent in the notation $\{$ it is essentially encoded as Schw inger-D yson equations for the free eld case.
$W$ e now retum to the issue of nom al ordering which was not properly dealt $w$ ith in the original paper of M atsubara. T he area has been studied in subsequent literature, and seem s to be a source of confusion. By using a de nition of nom alordering di erent from that of standard eld theory, $T$ houless [ī1] proves that them al expectation values of norm alordered products of non-relativistic ferm ions can be set to be zero. Fetter and W alecka [1] average of nom al ordered products is only zero at zero tem perature" contrary to tion G ross et al. [15

The situation is further confused by various authors' considerations of nite volum e corrections. M atsubara $\left[\left[_{1}^{1}\right]\right.$ suggests that the expectation values of nom al ordered term s $m$ ay be zero only in the in nite volum e lim it. This argum ent is given in greater detail in Abrikosov et al. $[\underline{1}-\bar{G}]$ and Lifschitz and $P$ itaevskii $[1 \overline{1} \bar{i} \bar{i}]$. If this was true, there could be im portant corrections to standard perturbation theory, com ing from the usually neglected norm al ordered term s , when working w ith nite volum es system s . A s the quark-ghon plasm a form ed in relativistic heavy ion collisions lls a com paratively sm all volum e, such nite volum e correctionsm ight be ofgreat im portance in practicalcalculations. Y et where are such volum e term shiding in the derivations using the properties of the them altrace滆, '1]

The nite volum e argum ent is worth repeating here for reference later on. For sim -
plicity, consider a non-interacting equilibrium system of relativistic neutral bosons at tem perature T lying in a volume V . Let ${ }^{\mathrm{b}}(\mathrm{x})$ be the herm itian eld operators in the H eisenberg picture. W e w ish to calculate $G$ reen functions, and as a speci c exam ple consider the four-point them alW ightm an function

The angular brackets denote a them al expectation value (which is de ned in the next section), and $x_{i}$ are di erent space-tim e points. In $m$ om entum space, $W{ }_{1 ; 2 ; 3 ; 4}$ contains term $s$ of the form

$w$ here $\hat{a}_{k}^{Y}$ and $\hat{a}_{k}$ are creation and annihilation operators, the $k_{i}$ 's are discrete $m$ om enta, and $Y$ is a sum of scalar products of 4 m om enta and space-time coordinates. In the literature it is clain ed that there are three separate contributions to rst 2 contributions arise when the $m$ om enta are equal in pairs, that is when $k_{1}=k_{3}$, $k_{2}=k_{4}$ and $k_{1}=k_{4}, k_{2}=k_{3}$. A coording to som e standard texts (for exam ple [1] $\overline{1}$, , 1 feature which distinguishes it from (1..1), i.e. the num ber of factors in $1=V$ is the sam e as the num ber of sum $m$ ations, whereas in (1.. $\mathrm{m}^{\prime}$ ) this num ber of factors is larger". T hus (ī.i.) has \an extra factor of $1=\mathrm{V}$ and $w$ ill vanish as V ! 1 ". T hese texts conchude that, onœe the in nite volume lim it has been taken, \we can actually average over pairs of operators". The im plication is that only in this lim it does the four-point $G$ reen function (or in generalan n-point one) split into a sum of products of two-point $G$ reen functions.

In this paper we prove that the above argum ent is incorrect and that any n-point $G$ reen function can be decom posed exactly into two-point $G$ reen functions, whatever $V$. W e also prove explicitly that them al expectation values of norm al ordered products of any type of eld $m$ ay alw ays set to zero, contrary to claim s elsew here $1-2 \overline{2}]$. The sym $m$ etry properties of nom al ordered products are considered.

The paper is organised as follow s . In section 2 we set up our notation and de nitions. This is essential as we will be discussing di erent types of nom al ordering and we wish to track volum e factors very carefully. In section 3 we split elds into two parts at an operator level and de ne nom al ordering and contractions appropriately. W e choose a split which guarantees that the them al expectation value of nom al ordered products of any two eld operators is always zero and hence that the norm al ordered products have sim ple symmetry properties. We then prove in section 4 that this is su cient to ensure that the them alexpectation value of any four-point norm alordered product also
vanishes, independent of volum e. W ith W ick's theorem, this then show s directly that the four-point $G$ reen function decom poses exactly into two-point $G$ reen functions. In section 5 we generalise this result from four-point to $n$-point $G$ reen functions by using $m$ ore powerfulm ethods. O ne is the usual path integral approach to them al eld theory. The other is based on the cyclic property of the trace which de nes the them al expectation
 value of all n-point nom al ordered products vanish. W e also note the sym $m$ etry of the n -point nom al ordered products.

## 2 De n itions and N otation

For sim plicity we consider only free eld theories and work in the $H$ eisenberg picture. O ur results are com pletely equivalent to working with an interacting theory in the interaction picture. There the operators evolve according to the free $H$ am iltonian and the interactions are encoded in the $S \mathrm{~m}$ atrix. W hen expanded, the $S \mathrm{~m}$ atrix leads one to consider tim e-ordered products which are of the sam e form as those considered here. At nite tem perature, one has to be rather m ore carefulabout the use of an $S$ m atrix, but one can still follow a sim ilar algorithm so that our results can be applied to practical calculations at nite tem perature.
$F$ ield operators, ${ }^{\mathrm{b}}(\mathrm{x})$, are given in term s of particle and anti-particle creation and annihilation operators, $\hat{a}_{k}^{y}$, $\hat{a}_{k}$ and $\hat{\mathrm{b}}_{\mathrm{k}}^{\mathrm{y}}, \hat{\mathrm{b}}_{\mathrm{k}}$ respectively;

The metric is diag $(+1 ; 1 ; 1 ; 1)$ and ${ }_{k}^{2}=k^{2}+m^{2}$ for relativistic eld theories. For non-relativistic ones $!_{k}=k^{2}=2 m$, and $\hat{\mathrm{b}}_{\mathrm{k}}=0$. A real relativistic scalar theory has $\hat{a}_{k}=\hat{b}_{k}$. For ferm ionic theories, $\hat{a}_{k}$ and $\hat{\mathrm{b}}_{k}$ im plicitly carry spin indices, and there is an im plicit sum over spins as well as over m om enta. A nnihilation and creation operators must also be multiplied by the correct solutions to the Dirac equation if the theory is relativistic but this does not e ect our results. Likew ise, the analysis holds for elds of higher spin, where additional indiges have been suppressed, as only the statistics of the eld is relevant to this analysis.

The operators obey the canonical com $m$ utation relations,

W e call the parts \positive＂and \negative＂even though in general the split is not into positive and negative energy waves．In order to avoid possible confusion betw een y and + superscripts，the herm itian conjugate of an operator is denoted by $={ }^{\mathrm{y}} . \mathrm{We}$ do not assum e that the operator and its herm itian conjugate are split in the sam e way．T hat is， we do not assum e that []$^{y}=$ ．This m eans care $m$ ust be taken $w$ ith the notation； we alw ays have ${ }^{+}=\left[{ }^{\mathrm{y}}\right]^{+}$rather than it being equal to［ $\mathrm{J}^{\mathrm{y}}$ ．

To allow for products ofm ore than one type of eld operator，we now use the notation

N orm al ordering is de ned in term s of the arbitrary split（ $\left(\overline{2} \overline{1} \overline{\mathrm{~F}}_{1}\right)$ ，so generalising the traditional $\mathrm{T}=0$ de nition which is expressed in term s of annihilation and creation operators．W e always de ne nom al ordering to strictly $m$ ean that all + elds are placed to the right of elds；otherw ise the order of the elds is left unchanged．（So it di ers from that used for ferm ions in［10］［1．）For exam ple，

Here 1 and 2 are any two eldswith di erent space－tim eargum ents（ $t_{1} ; \mathrm{x}_{1}$ ）and（ $\mathrm{t}_{2} ; \mathrm{x}_{2}$ ） respectively（which for convenience we usually suppress）．The elds $m$ ay be related， e．g．one often has $1=\left(\mathrm{t}_{1} ; \mathrm{x}_{1}\right)^{\mathrm{y}} ; 2=\left(\mathrm{t}_{2} ; \mathrm{x}_{2}\right)$ ．For general splits $\mathrm{N}_{1 ; 2} \mathrm{~m}$ ay not be sym $m$ etric； $\mathrm{N}_{1 ; 2} \in \mathrm{~N}_{2 ; 1}$ ．

It is straightforw ard to generalise this time ordering to path ordering as used in some nite tem perature analysis．Then the theta functions of tim e in（ $\left(\underline{1} . \overline{1} \mathbf{g}_{1}^{\prime \prime}\right)$ becom e de ned in term s of a path in com plex tim e［⿴囗玉．］．A s this does not e ect the subsequent analysis we w ill not com plicate our notation further．

W idk＇s theorem is an operator identity．For two－point functions it relates $\mathrm{T}_{1 ; 2}$ to $\mathrm{N}_{1 ; 2}$ by de ning the contraction $D\left[\begin{array}{ll}1 & 2\end{array}\right]=D_{1 ; 2}$ ：

The sum takes $\mathrm{a}_{1} ;::: \mathrm{a}_{2 \mathrm{n}}$ through all perm utations of $1 ;::: ; 2 \mathrm{n}$, and p is the number of tim es one has to interchange pairs of ferm ions in moving from $1 ;::: ; 2 n$ to $a_{1} ;::: a_{2 n}$ order. O nœe again, we stress that $(\overline{2} \overline{2} \overline{3})$ \{ $(\overline{2} \overline{2} \overline{6})$ hold whatever the decom position of the elds into positive and negative parts provided the contraction is a c-number. They hold $w$ hether or not the contraction is sym $m$ etric.

## 3 Two-point functions

In this section we prove that it is alw ays possible to de ne a split ${ }^{\mathrm{b}}(\mathrm{x})={ }^{\mathrm{b}+}(\mathrm{x})+{ }^{\mathrm{b}}(\mathrm{x})$ such that $N_{1 ; 2}=0$. This then ensures that $D_{1 ; 2}=T_{1 ; 2}=D_{2 ; 1}$.

A general linear decom position of $(x)$ and ( $x$ ) into positive and negative parts is

Hence we show that the four-point $G$ reen function decom poses into two-point $G$ reen functions for all V. For sim plicity, we consider a real relativistic scalar eld theory. O ur results are generalised to other theories in section 5.

B oth of these $m$ ethods $m$ ay be applied to any type of eld operator \{ bosonic or ferm ionic, relativistic or non-relativistic. The resulting generalised form of ( $\overline{4}, \overline{1}, \overline{1})$ then enables $(\overline{4}, \bar{d})$ ) to be generalised to allorders and to all types of elds. $W$ e also consider the sym $m$ etry properties of $n$-point nom al ordered products, and nally show how di erent splits $m$ ay be related.

W e can use the form ula (5.14') to provide a di erent view of several aspects of them al eld theory. For instance in real-tim e approaches there is a doubling of the degrees of
 tem perature propagators which m ix the physical and unphysical degrees of freedom. T hus one could look on the doubling asbeing necessary only to take account of the norm al ordered products, $\mathrm{N}^{0}$, where they are de ned in the usualm anner of zero tem perature.

## 6 C onclusion

C ontrary to claim s in the literature, we have proved that for elds of arbitrary statistics there are no nite volum e corrections to the usual relationship between them al G reen functions (5..- $)$. T hus the operator approaches and path integral approaches to therm al eld theory are indeed consistent in this respect. So in trying to understand the physics of the quark-gluon plasm a form ed in relativistic heavy-ion collisions, we have to look elsew here to understand how nite volum e a ects the physics.

In proving the above, we have de ned and used a linear split of the eld operators into positive and negative parts such that $\quad \mathrm{N}_{1 ; 2 ;: ; ; 2 \mathrm{n}}=0$. This split enables usual $\mathrm{T}=0$ eld theory to be m im idked. By choosing to work with a split where such a result holds, we w ill sim plify practical calculations.

For instance when we are working w ith unphysical degrees of freedom at nite tem perature, such as appear in gauge theories, one usually them alises all the degrees of freedom.

H ow ever, it has been noted that such degrees of freedom need not be them alised $[1 \overline{1} \overline{\bar{O}}]$. In the language of this paper, we would say that one $m$ ay choose a di erent splet $(\underline{2}=1$ each eld. In particular, we m ay optim ise the splits depending on how each eld acts on the states in the ensem ble. So w ith unphysicalm odes and an ensem ble average taken over just physical states, the best split, norm al ordering etc. for the unphysicalm odes is the zero tem perature one, whereas we norm al order the physicalm odes in term sof the usual therm al split of $(\overline{3}-\bar{Z})$ and $(\overline{3} \overline{3} . \bar{d})$. This idea can extended to out-ofequilibrium situations where di erent physical degrees of freedom $m$ ay well be present in the ensemble in quite di erent am ounts suggesting that we de ne norm al ordering and contractions di erently for each eld so as to ensure that $\mathrm{N}_{1 ; 2 ;:: ; ; 2 \mathrm{n}}=0$ always.

W e have refered only to the path-ordered approaches to therm al eld theory, be they real- or im aginary-tim e form alism s . A nother sim ple $m$ ethod of obtaining ( $\overline{5}$. d$)$ is to use TFD particle operators" $;^{\mathrm{e}}{ }^{\text {] }}$ and ${ }^{\mathrm{eJ}}$ which annihilate the them alvacuum, as this guarantees that all therm al expectation values of norm al ordered products vanish, for exam ple see
 follow s directly from ( $\overline{2} \overline{2} \overline{\mathrm{C}})$ whereas in $[\overline{\bar{\theta}}]$ a rather lengthy derivation is given. This argum ent is also clearly independent ofvolum e as itm in ics the standard zero tem perature eld theory case. It is im mediately obvious that these com $m$ ents regarding TFD and norm al ordered products apply to any situation where a B ogoliubov transform ation is used.
