# M ultiple H ard P arton Interactions at H E R A

# A bstract

At HERA, the large ux of alm ost real photons accompanying the electron beam leads to the copious photoproduction of jets. Regions of small momentum fractions x of the incoming particles are explored, where the density of partons is high. As a result, the probability for more than one hard partonic scattering occurring in a single p collision could become signi cant. It is well known that this e ect modi es the contribution of jets (minijets) to the total cross section. We discuss the latest HERA data on the total p cross section in this context. The possible e ects of multiple hard interactions on event shapes and jet cross sections at HERA have been studied using M onte C arlo program s. We review some of the available results, which in general indicate that the e ects of multiple interactions should be signi cant and m ay already be manifest in the existing HERA data.

# 1. Introduction

For both protons and photons, QCD predicts a rapid increase in parton densities at low x, where x is the fraction of the beam particle's momentum which participates in the hard' scattering (interaction). In a naive treatment, this rise can lead to a corresponding (but ultimately unphysical) rise with increasing energy of perturbative QCD calculations of the jet contribution to the total cross section. However, the large number of small x partons contributing to jet production can mean that there is a signi cant probability for more than one hard scatter per p interaction. Only the resolved part of the photon can undergo multiple interactions, i.e. the direct part is taken to be una ected. The elects of multiple interactions can provide a mechanism for taming the rise in the QCD cross section [1] in accord with unitarity, as discussed in Sjostrand's talk [2].

Additionally, there are clearly implications for the hadronic nal state. In order to study these e ects eikonal models have been implemented within the hard process




Figure 1: An example of a multiple scattering in a p collision.

generation of several M onte C arb program s [3, 4, 5, 6]. M ultiple parton scattering, as illustrated in Fig.1, is expected to a ect jet rates. The average number of jets per event should be increased when partons from secondary hard scatters are of su ciently high p<sub>T</sub> to give jets in their own right. In addition, lower p<sub>T</sub> secondary scatters produce extra transverse energy in the event which contributes to the pedestal energy underneath other jets in the event. Thus multiple scattering can in uence jet cross sections even when no parton from the secondary scatters is itself of a high enough p<sub>T</sub> to produce an observable jet. By boosting the transverse energy of jets in this way, multiple scattering leads to an increase in jet cross sections for jets above a certain E<sub>T</sub><sup>jet</sup> cut, even though the total cross section is reduced.

The theory ofmultiple scattering is stillnot wellunderstood; therefore phenom enology is based on models with several assumptions and unknown parameters. The elects ofmultiple scattering on the total cross section and on jet/event shapes probe these unknowns in somewhat dierent ways. A lthough they are related, it therefore makes sense to consider the two aspects separately. In sect 2 we outline the framework of models of multiple interactions, in sect 3 we discuss the HERA total cross section data for p quantitatively from the minigt point of view. In sect 4 we present some of the expected elects of multiple interactions on jet cross sections, with reference to existing data, and in sect 5 we give some conclusions.

# 2. M odelling multiple interactions

W hen speaking of multiple scattering (alias multiple interactions), the basic building blocks are the standard 2 ! 2 partonic interaction processes, such as gg ! gg, qq ! qq,  $q\overline{q}$  ! gg and qg ! qg. An event may contain none, one, two or more

such interactions; the novelty of the multiple interactions concept is that the two or more' occurrence may be the norm at high energies rather than a rare exception. The correlations between interactions occurring in the same event may be horribly complicated, but the hope is that it is feasible to approximate this by a simple factorized description in terms of several independent scatterings. This may be made plausible by viewing the incoming hadron and hadronlike photon as two pancakes, attened by Lorentz contraction. W hen these pass through each other, dierent parts are causally separated, so the probability of an interaction between any pair of partons can be assumed independent of what occurs anywhere else. This gives a poissonian distribution in the number of interactions, for a xed in pact parameter between the two colliding hadrons/photons. In central collisions the average number of interactions should be larger than in peripheral ones; it is therefore necessary to introduce a model of how partons are distributed in the pancake. The Eikonalization' procedure, so central to current descriptions, is a combination of these two concepts: a poissonian distribution at each xed in pact parameter plus an impact-parameterdependent overlap function. This form may be integrated over the impact parameter to give the total cross section, the probability distribution of interactions, and even the number of additional interactions underlying a hard interaction.

Several objections can be raised. For instance, scatterings are assumed to be disjoint, i.e. a parton does not undergo more than one scattering. This can be motivated by simple counting arguments: if each hadron contains N partons, the rate of two disjoint 2 ! 2 scatterings is proportional to N<sup>4</sup> but that of two scatterings with a shared parton, i.e. a 3 ! 3 process, is only proportional to N<sup>3</sup>. A counterexample would be the occurrence of hot spots' caused by the cascading of a single parton. This is especially relevant since each 2 ! 2 subprocess is embedded in a larger system of initial and nal-state radiation. C obur correlations between interactions are not well understood, and yet this is of large importance for the structure of the nal event. In summary, current eikonalization approaches can only be viewed as sensible rst approximations, and therefore the existence of several di erent models is an advantage.

M aybe the m ost am bitious approach is the DTU (dual topological unitarization) one. Here a hard pomeron term is given by scatterings with  $p_T > p_{Tm in}$ , a soft pomeron term includes nonperturbative scatterings at small  $p_T$ , and triple-and loop-pomeron graphs are added to incorporate also di ractive topologies in the description. The  $p_{Tm in}$  scale can be changed freely over some range, since the nonperturbative pomeron term can be modelled to compensate for the change in the hard interaction rate. This

approach is represented by the Phojet program [6].

In less ambitious approaches, the issue of di ractive events is kept separate, and unitarization within the soft sector is simplified to allow (at most) one soft interaction. Here  $p_{Tm in}$  is a real parameter of the theory, to be determined by a comparison with data. Of course the use of a sharp cuto in  $p_T$  is only an approximation to what has to be a smooth turn on in reality. Examples include the models found in Pythia [5] and HERW IG [3, 4]. These two are similar in philosophy but differ in the details. For simplicity we therefore concentrate on the latter in the following.

Let us start by considering a p interaction at some xed in pact parameter, b, and centre-ofm assenergy, s. In particular, we suppose the to be hadronlike (i.e. re-solved [7]). We assume that the probability for the photon to interact in such a state is  $P_{res}$  and take the -dominance form, i.e.  $P_{res} = 4 = f^2$  1=300. The mean number of jet pairs produced in this resolved- {p interaction is then

$$hn (b;s)i = L_{partons} \qquad (1)$$

where  $L_{partons}$  is the parton lum inosity and  $^{H}_{H}$  is the cross section for a pair of partons to produce a pair of jets (i.e. partons with  $p_{T} > p_{Tm in}$ ).

The convolution is because the parton cross section depends upon the parton energies. More speci cally,

where A (b) is a function which speci es the distribution of partons in impact parameter. It must satisfy  $$_{\rm Z}$$ 

$$db^2 A (b) = 1$$

in order that the parton lum inosity integrated over all space is simply the product of the parton number densities. Factorizing the b dependence like this is an assumption. In particular we do not contemplate QCD e ects which would spoil this, e.g. perhaps leading to hot spots' of partons. Also  $n_i(x_i)$  is the number density of partons in hadron i which carry a fraction  $x_i$  of the hadron energy. For ease of notation we do not distinguish between parton types and have ignored any scale dependence of the number densities. For the proton, the number density is none other than the proton parton density, i.e.  $n_p(x_p)$   $f_p(x_p)$ . However, since we are dealing with resolved photons, the number density n is related to the photon parton density by a factor of  $P_{res}$ , i.e. n (x ) = f (x )=P\_{res}. Thus, after performing the convolution, we can

write:

where  $\frac{inc}{H}$  (s) is the inclusive cross section for p to jets. Restoring the parton indices, it is given by

In order to investigate further the structure of events containing multiple interactions we need to know the probability distribution for having m (and only m) scatters in a given resolved- {p event,  $P_m$ . In order to do this we assume that the separate scatters are uncorrelated, i.e. they obey poissonian statistics. Thus

This form ula is central to the M onte C arb im plem entation in  ${\tt HERW}~{\tt IG}$  .

We can now ask for the total cross section for p! partons with  $p_T > p_{Tm in}$ .

Since the total inclusive cross section ( $_{\rm H}^{\rm inc}$ ) counts all jet pairs (even ones which occur in the same event) we expect it to be larger than  $_{\rm H}$  by a factor equal to the mean number of multiple interactions per event (i.e. averaged over in pact parameter). This is easy to see. Let hn (s) i be the average number of jet pairs produced in resolved- {p events which contain at least one pair of jets, then

Note that  $_{\rm H}$  must always be less than the total p cross section, whereas  $_{\rm H}^{\rm incl}$  need not be.

In order to study the details of the hadronic nal state in the presence of multiple interactions it is most convenient to use a M onte C arb simulation. The HERW IG M onte C arb generates the required number of hard scatters and the associated initial and nal state parton showering. The outgoing partons and rem nant jets are then fragmented to the hadronic nal state. Two m odi cations are m ade to the simple eikonal m odel in the implementation. Firstly, energy conservation is imposed, i.e. after the backward evolution of all the hard scatters in an event, the energy remaining in the hadronic rem nantsmust be greater than zero. Secondly, if during the backward evolution of the rst scatter the splitting op is arrived at before the evolution cut o scale, the event is classi ed as an 'anom abus' event and no multiple interactions are allowed.

### 3. Total p cross section

The miniger contribution, H (s), is clearly only one contribution to the total cross section. To compare with experiment we must add the soft cross section  $_{T}^{\text{soft}}$ , which is assumed to contain all of the physics below  $p_{Tm in}$ . Furtherm ore there is a (sm all) cross section,  $_{T}^{\text{dir}}$ , for the production of single jet pairs (with  $p_{T} > p_{Tm in}^{0}$ ) by unresolved (i.e. direct) photons. O flem it is assumed that  $p_{Tm in}^{0} = p_{Tm in}$ , but this di ers between models. O f course simply adding together cross sections is only a rst guess.

As an example of multiple interaction approaches to the total p cross section, we take the eikonalized m iniget calculations for  $_{\rm H}$  (s) of ref.[8], which used the parton distribution functions of refs.[9, 10] for the proton and photon respectively, and add to them various choices of parametrisations of  $_{\rm T}^{\rm soft}$ . We adjust  $p_{\rm Tm}$  in and the parameters of  $_{\rm T}^{\rm soft}$  accordingly, and compare to the recent data on  $_{\rm T}^{\rm p}$  [11, 12]. This is similar to what was done in ref.[13], except there the old HERA data were used [14, 15]. For a fuller discussion of this approach and its theoretical uncertainties see refs.[2, 8, 13].

The recent results for the total p cross section at centre of m ass energies of ' 200  $^{\rm p}$  G eV are as follows. The H1 collaboration (HW i = h si = 197 G eV) nd  $^{\rm p}_{\rm T}$  = (165 2:3 10:9) b and ZEUS (HW i = 180 G eV) obtain  $^{\rm p}_{\rm T}$  = (143 17) b. In the H1 case, the rst error is statistical and the second system atic. The ZEUS error has the system atic and statistical errors added in quadrature.




Figure 2: Energy dependence of the total p cross section. See text for the description of the curves.

In the simplest variant,  $T_{T}^{soft}$  is taken to have the form :

$$r_{r}^{\text{soft}}(s) = A + B = s$$

where A and B are constants. This ansatz in plies that the entire rise in  $_{T}^{p}$  at high energies is due to minigets. It has very little theoretical motivation and makes rather an ad hoc separation between hard and soft physics, endowing  $p_{Tm in}$  with great physical signi cance. In g2 we show as the dotted curve the best t to the data that can be achieved with such an ansatz added to the results of ref.[8] for <sub>H</sub> (s), calculated with  $p_{Tm in} = 2 \text{ GeV}$ . We take A = 107:98 b and B = 54:34 b GeV. This leads to an unconvincing description of the the data in the 10{18 GeV range [16], which show evidence of a rise with energy. If one attempts to attribute the low energy rise entirely to the miniget contribution then one would be forced to choose very low values of  $p_{Tm in}$ , in the 1{1.5 GeV range (see ref.[2]), which would lead to much too high a prediction at HERA, as was found in ref.[17]. This is illustrated by the broken

curve in g2, where we take a constant  $_{T}^{soft} = 114$  b and  $p_{Tm in} = 1.5 \text{ GeV}$  in  $_{H}$  (s). Again the need to t the low energy rise leads to a dangerously high cross section at HERA energies (no attempt was made to t the data below ' 10 GeV : any attempt to do so must worsen the t to the higher energy data).

A loo in g2 we show (the solid line) the results of ref.[8] added to the following form for  $T_{T}^{soft}$

The choice A = 78.4 b, = 0.058 and B = 117.05 b GeV, with  $p_{fmin} = 3$  GeV in <sub>H</sub> (s), ensures an excellent t to the low energy data (i.e. W 18 GeV) [16].

This latter approach clearly provides the best description of the data, but is slightly unorthodox in attributing only part (around half) of the rise in cross section to minipts. We could argue that this is a rational view of the situation, less extreme than attributing all of the rise to  $_{\rm T}^{\rm soft}$ , as in the soft Pom eron approach [18]. We emphasize that them inipt question is not a stark choice between the two extremes of eitherm inipts providing the entire rise with energy of the total cross section or being absent: indeed, jets are undeniably produced in both  $\overline{\rm pp}$  [19] and [20], as well as p, reactions. The important issue is whether they make a signi cant contribution to the total cross section at existing energies. In this picture, with  $\rm p_{Tm in} = 3G \, eV$ , they do; H (s) being around 20 b at  ${}^{\rm P}$  s = 200 G eV, although this is very sensitive to the choice of  $\rm p_{Tm in}$ . The increase of the soft cross section could still have its origin in multiple interactions in the region  $\rm p_{T} < \rm p_{Tm in}$ , but then without a simple perturbative description.

#### 4. Hadronic nalstate

In this section we illustrate the possible size and nature of the e ect of multiple interactions on some aspects of jet cross sections and the hadronic nal state at HERA. Here the experiments typically measure jets with transverse energies as low as 6 G eV. To simulate these events with M onte C arlo models, they use values for the minimum transverse momentum of a hard scatter of around  $2 < p_{Tm in} < 3 \text{ GeV}$ . In addition, cuts on the p CM energy are made, forcing it to lie typically in a range of around 120 G eV is 265 G eV. For these choices the mean number of hard scatters per event was found to be at least 1.04 (higher for the lower  $p_{Tm in}$  values), taking the MRS D [21] proton and GRV [22] photon parton densities.

For the events we generate, since the cross section falls rapidly with increasing  $p_T$ , we




Figure 3: The  $E_T$  jet pro le in , for a)  $x^{obs} < 0.75$  and b)  $x^{obs} = 0.75$ . c)  $x^{obs}$  distribution for dijets, at HERA energies, with direct contribution. Including multiple scattering (solid line) and with multiple scattering turned o (broken line).

expect that most of the multiple interactions will have  $p_T = p_{Tm in}$  and so their main e ect will be to increase the mean number of observed jets by boosting the underlying  $E_T$  in the event. Events which contain multiple interactions with high enough  $p_T$  to be observed as jets in their own right are relatively rare, but their observation (they appear as pairs of back-to-back jets) would provide striking evidence in support of the existence of multiple interactions.

Jet nding was perform ed using a cone algorithm with a cone radius R = 1 [23]. Jets have  $E_T$  6 GeV and pseudorapidity 2 <sup>jet</sup> 2. The additional  $E_T$  can be seen directly in the jet pro le, Fig.3 (a), where the  $E_T$  in the jets is plotted against relative to the jet axis. The pedestal energy is increased with the inclusion of multiple interactions. A variable found to be useful at HERA [24] for distinguishing between direct and resolved photon events is the observable x '. It is de ned by

$$x^{obs} = \frac{P_{jets} E_{T}^{jet} e_{T}^{jet}}{2E}$$

and the sum is over the two highest  $E_T$  jets in the event. It is the fraction of the photon's energy manifest in the two jets of highest  $E_T$ , and in leading order is exactly the fraction of the photon energy which enters the hard scatter, i.e. direct events are peaked at  $x^{obs} = 1$  whilst resolved events have  $x^{obs} < 1$ . The x cut isolates the resolved interactions, and as expected multiple interactions have no e ect in the direct case, Fig.3(b). The extra  $E_T$  enhances the inclusive jet rate around  $j^{et} = 1$ , and an increased sensitivity to multiple scattering can be seen in the  $j^{et}$  and  $E_T^{jet}$ 




Figure 4: Jet pro le. The solid circles are uncorrected ZEUS data. Uncorrected transverse energy ow seen in the calorim eter around the jet axis hdE<sub>T</sub>=d i where  $= ^{\text{cell}}$  jet, for cells within one radian in of the jet axis, for jets in the range  $5 \text{ GeV} < E_{T}^{\text{jet}} < 6 \text{ GeV}$  and with  $0 < ^{\text{jet}} < 1$ .

distributions in dijet events, which are shown in ref.[4]. An enhancement at high <sup>jet</sup> and low  $E_T^{jet}$  is seen. All plots in Fig.3 have the direct contribution generated using HERW IG included, hence the rise at  $x^{obs}$  0.8 in Fig.3 (c).

It can be seen from Fig.3 (c) that the e ect of multiple scattering is greater in the low  $x^{obs}$  region. Multiple interactions are more likely to occur here as it is in this region that the higher parton densities occur; also the energy conservation constraint is less restrictive.

In Fig.4 various M onte C arlo m odels are compared to preliminary ZEUS data [25]. The jet prole is shown, and the data are not corrected for detector elects. The simulated events have been passed through a full simulation of the experiment. Jets have  $5 \text{ GeV} < E_T^{jet} < 6 \text{ GeV}$  and pseudorapidities in the range  $0 < ^{jet} < 1$ . These cuts remove the elect of the forward edge of the calorimeter acceptance and allow us to study the elect of the dilerent models on the jet prole independently of the  $E_T^{jet}$  and  $^{jet}$  distribution of the models. The comparison with the various models con rm s the general conclusion m ade by H1 [26] that introducing multiple interactions can improve the agreement between M onte C arb models and the data. However, there is

a large am ount of freedom in the models and, in particular, the e ect of introducing multiple interactions depends strongly on the parton density of the photon (com pare the histogram s for the multiple interaction models using LAC1 and GRV). For further com parisons with HERA data, the reader is referred to the talk of Steve M ax eld [27] and references therein.

# 5. Conclusions

Multiple scattering must occur at some CM energy, in order that unitarity is not violated: the relevant point here is whether it is present at HERA. C learly answering this question using total cross section data is going to be very di cult, given the uncertainties in the soft physics. This point was made very clear by our discussion of sect.3, and in ref.[2].

However, jet cross sections seem to be a more hopeful place to look. In sect *A*, the e ect on the hadronic nal state of multiple parton scattering in p interactions has been simulated by interfacing an eikonal model of multiple parton interactions with HERW IG .M odels indicate that the e ect of multiple scattering is signi cant at HERA energies. For reasonable experim ental cuts, the inclusion of multiple scattering leads to signi cant changes in inclusive and dijet cross sections which should be understood before attempting to unfold to parton distribution functions.
