Is a high P_T m uon of the $e^+p!$ ^+X event observed at HERA a signature of the stop?

A bstract

We investigate the e⁺p! ⁺X event with high transverse m omenta observed at HERA (H1) and show that this event could be interpreted as a signature of the single production of the scalar top quark in a supersymmetric model with R-parity breaking interactions. The event topology of the H1 event is rather characteristic and in fact it can be simulated by our species scenario if we reasonably choose our model parameters to be (i) m (R) 11 TeV [0:8TeV] for $^0_{131} = 0:1$ [0:05] and (ii) m $^0_{120} = 0:05$.

Recently the H 1 group reported that an event with high transverse m omenta had been observed [1] at HERA. The total data sample analyzed at the H 1 group corresponds to an accumulated luminosity of 3 2pb 1 in positron (27.5GeV) { proton (820GeV) collisions and of 0.8pb 1 in electron { proton collisions. The event is characterized by (i) a large transverse m omentum of the single muon $^+$, P_T() = 23.4 2 .4 $^{+7}_5$ GeV, (ii) a small ($^-$ E (1 $^-$ cos)), = 19.2 $^-$ 1.6 $^{+3.0}_{2.1}$ GeV, where E and denote the energy and angle of any detected particle, (iii) a large transverse m omentum of the total hadronic system, P_T (hadron) = 42:1 $^-$ 4.2GeV and (iv) a large m issing transverse m omentum P_T (m iss) = 18:7 $^-$ 4.8 $^{+5}_7$ GeV.

Som e possible interpretations of the event have been given in ref.[1];

- (A) production of high P_T jets
- (B) W production and its leptonic decay
- (C) A avour changing neutral currents (FCNC) or leptoquark production

However, it does not seem to give reasonable explanation of the event characterized by the topology mentioned above [1]. As for the scenario A, the probability for the event being due to the production of two high $P_{\rm T}$ jets, where one jet shows the signature of a muon, is smaller than 10^{-3} . As for the scenario B, the W production and its leptonic decay would give a rather small transverse momentum of the total hadronic system. In fact, the M onte C arbo calculation shows that for $P_{\rm T}$ (hadron) > 40G eV the cross section is reduced to 7fb. That is, with one event seen in 4pb 1 we are left with a 3% probability for this interpretation of the event. As for the scenario C, expected events would have balanced $P_{\rm T}$ and a value of = 2E $_{\rm e}$. This is due to the fact that events originated from the FCNC or leptoquark production would show topologies like neutral current deep inelastic events, but with the nal state positron replaced by a muon. The fact that less than 1% of neutral current events show a value of < 20 G eV disfavours this interpretation.

In this letter, we propose a possible explanation of the single muon event in the fram ework of the m in im alsupersym metric (SUSY) standard model (MSSM). We will show that the high P_T muon could appear from the single scalar top quark (stop) production through an R-parity breaking coupling at HERA.

In the previous work [2], we have already shown that one of the signals of the single stop production to be detected at HERA is characterized by the high P_T spectrum of muons. First, for the sake of convenience we will brie y summarize the basic idea by referring to our previous work [2]. The discussion is based on the MSSM with an R-parity breaking (RB) interaction

where $^0_{131}$ and $^1_{t}$, respectively, denote the coupling strength and the mixing angle of the stops [3,4]. Here $P_{L,R}$ read left and right handed chiral projection operators. The interaction Lagrangian (1) has been originated from the general RB superpotential [5];

where i; j;k are generation indices. The rst two terms violate the lepton number L and the last term violates the baryon number B. If we want to explain such unresolved problems as (i) the cosm ic baryon number violation, (ii) the origin of the masses and the magnetic moments of neutrinos and (iii) some interesting rare processes in terms of the L and/or B violation, the R-parity breaking terms must be incorporated in the MSSM.

The coupling Eq. (1) will be most suitable for the ep collider experiments at HERA because the stop will be produced in the s-channel in e-q sub-processes [2, 6]

Note that the stop cannot couple to any neutrinos via R-breaking interactions. This is a unique property of the stop which could be useful for us to distinguish the stop from some leptoquarks. Production processes of the rst and second generation squarks have been discussed in ref.[7].

Babu and Mohapatra [8] have recently shown that the severe constraint on a product $_{113}^{0}$ $_{131}^{0}$ $^{<}$ 3 10 8 comes from experimental data of the neutrinoless double decays. Here, we will assume $_{131}^{0}$ to be only non-zero coupling parameter in what follows. The upper bound on the strength of the coupling has been investigated through the low-energy experiments [5] and the neutrino physics [9]. The most stringent bound $_{131}^{0}$ $^{<}$ 0.25 comes from the atom ic parity violation experiment [5].

Next we exam ine the decay modes of the stop. In the MSSM, the stop lighter than the other squarks and gluino can decay into the various nal states:

where \mathcal{E}_k (k=1 4), $\bar{\mathbb{W}}_i$ (i=1;2), e and $^{\mathfrak{S}}$, respectively, denote the neutralino, the chargino, the sneutrino and the charged slepton. (a) (g) are the R-parity conserving decay modes, while (h) is only realized through the RB couplings (1).

If we consider the stop with m ass smallenough in the case of the R conserving coupling, the rst ve decay modes (a) to (e) are kinematically forbidden due to the observed top mass m $_{\rm t}$ ′ 175 G eV [10] as well as the model independent lower mass bounds for sparticles; m $_{\rm WE_1}$ 45 G eV, m $_{\rm e}$ 45 G eV and m $_{\rm e}$ 40 G eV. So (f) and (g) survive. Hikasa and K obayashi [4] have shown that the one-loop mode (g) \mathfrak{E}_1 ! c \mathfrak{E}_1 dominates over the four-body mode (f) \mathfrak{E}_1 ! bf f $^0\mathfrak{E}_1$. So we can safely conclude that such a light stop will decay into the charm quark jet plus the missing momentum taken away by the neutralino with almost 100% branching ratio. On the other hand, if we consider the RB coupling $^0_{131}$ > 0.01, which roughly corresponds to the coupling strength to be detectable at HERA, the decay modes (c) to (g) are negligible due to their large power of arising from multiparticle

nal state or one loop contribution. Then only two body decay modes (a), (b) and (h) are left for our purpose.

We have found [2] that if the stop is heavy enough, i.e., $m_{e_1} > m_b + m_{we_k}$ and the RB coupling is comparable with the gauge or Yukawa coupling $^0_{131} = 4$; there is a wide range of parameters where BR (e_1 ! $b\bar{w}_k$) dom in ance over BR (e_1 ! ed) is assumed.

In this case, we should take into account of the process

where the virtual contributions of the sneutrino with the same RB coupling constants $^0_{131}$ have, of course, been considered. The di erential cross section is given by

Here V_{k1} and U_{k1} stand for the chargino m ixing angles [11]. The m ixing angles as well as masses of the neutralinos m $_{\mathfrak{E}_i}$ and the charginos m $_{\mathfrak{W}_k}$ are determined from the basic parameters in the M SSM (;tan ;M $_2$). We can see that the e⁺ beam is more e cient than the e one to distinguish the stop signal from the SM background. This can be understood from the fact that the e⁺ collides with valence d-quark in the proton, while the e does only with sea d-quarks. It is expected that the detectable cross sections $^{>}$ 0:1 pb for heavy stop with mass m $_{\mathbf{e}_i}$ $^{<}$ 250 GeV for e⁺ beam s. As far as e beam s are concerned e p! $b\bar{w}_k X$ would be detectable for m $_{\mathbf{e}_i}$ $^{<}$ 170 GeV. In our model the LSP, the lightest neutralino \hat{z}_1 possibly decays into R-even particles via only non-zero RB coupling $^{0}_{131}$. A typical decay chain will be

Thus, a possible typical signature of the stop production ep! $b\bar{\psi}_1X$ would be bjet+ lepton+ F_T in the case of no LSP decay or 2b-jets+ jet+ lepton+ F_T in the case of the LSP decay via RB coupling. One of the signals to be detected at HERA is characterized by the high P_T spectrum of muons. The lower P_T cut certainly makes the event distinctive from its background. The cross section (e⁺p! e_TX ! $b\bar{\psi}_TX$) varies from 1 to 10pb depending on mass of the stop in the range of 100 150G eV.

Now it is the position to present our calculation for some kinematical distributions in the process (8), which will also be compared to the experimental distributions of the H1 event [1].

First, the P_T () distribution of the expected number of events is shown in Fig.1. In the calculation, we take a typical set of model parameters, (, M $_2$, tan , m $_t$, $_t$, $_{131}^0$) = (300G eV, 50G eV, 2, 175G eV, 1.0rad, 0:1) and the integrated lum inosity 3.2pb 1 . In this case we get the lighter chargino m ass m $_{19}$ = 63G eV and the lightest neutralino m ass m $_{19}$ = 28G eV. For simplicity, the branching ratio BR (1 1 1 1 1 1 is assumed to be 1 12]. The dependence on the branching ratio of the chargino will be discussed later. We not in Fig.1 that rather heavy stop, m $_{19}$ = 100 120, could give a high P_T () event at the present integrated lum inosity.

We show the distribution together with the experimental data in Fig.2. The observed value of is significantly smaller than the allowed maximum value $2E_e$. Such could be obtained only when the LSP does not decay via the RB couplings in the detector. This constraint leads to following important consequences. We can quantitatively present the requirement as c_{E_1} Im, which corresponds to c_{E_1} 10 7 eV. By calculating the 3-body LSP decay width, we get severe constraints, means c_{E_1} 1TeV [0:8TeV] for c_{131} = 0:1 [0:05]. A nother one is that the total transverse hadronic momentum should be supplied by a b quark at the rst vertex in the process (8). In other words, we can take c_{E_1} (b) c_{E_1} (hadron) in our model calculation. Note, moreover, that large masses of sferm ions justify our assumption on the chargino decay, BR (c_{E_1}) c_{E_1}) c_{E_1} c_{E_1}) c_{E_1} When sferm ions are su ciently heavy the dominant contribution to the decay matrix elements comes from the W-boson exchange diagram, which has apparently universal ferm ion couplings.

Shown in Fig.3 is the P_T (b) (' P_T (hadron)) distribution. From the gure, we not that heavier stop is favourable to simulate the large transverse hadronic momentum 40G eV. Note that the maximum value of P_T (b) is determined from the simple kinematics of the two-body decay,

Consequently, we can restrict possible regions in (m_{ψ_1}, m_{ψ_1}) parameter space in terms of the experimental constraint, P_T (b) $^>$ P_T^{exp} (hadron) ' 40G eV.

We present such a experimentally favourable region (shaded area) in Fig.4. Horizontal (dotted) lines correspond to one event with $P_{\rm T}$ () > 20G eV to be expected. It is seen from the gure that constraints have been set on the masses m $_{\rm NP_1}$ and m $_{\rm e}$, if we seriously take into account the present data. For example, the chargino mass is smaller than about 100G eV for $_{131}^0$ $^<$ 0:1 under the condition of $P_{\rm T}$ (b) $^>$ 40G eV . Moreover, $_{131}^0$ should be larger than about 0:05 and the stop mass should be larger than about 100G eV because of the LEP bound on m $_{\rm NP_1}$ > 45G eV . A shas already been mentioned, low energy experiments set the constraint $_{131}^0$ $^<$ 0.25.

We have investigated a possible scenario to explain the H1 single muon event by the single production of the stop with an R-parity breaking interaction in the framework of the MSSM. The event topology of the H1 event is rather characteristic and in fact they can be simulated by our species scenario if we restrict arbitrary model parameters to some

reasonable ranges. In order to work our scenario, we must have (i) m $_{\text{RB},\text{e}}$ > 1TeV [0:8TeV] for $_{131}^{0}$ = 0:1 [0:05], (ii) m $_{\text{RB},\text{e}}$ < 150GeV, 100GeV < m $_{\text{e}}$ < 200GeV and $_{131}^{0}$ > 0:05.

Our scenario would be con $\mbox{ m ed or rejected}$ at LEP2 or next linear colliders through the search for $e^+e^-!$ $\mbox{ \mathbb{H}}_1^+\mbox{ \mathbb{H}}_1^-$. Certainly, the discovery of the chargino could reveal us that the nature is supersymmetric but could give no information as to whether or not the nature does not respect the R-parity. To con $\mbox{ m it}$, we should seek for the stop with the R-parity breaking interaction, e.g., through a search for $e^+e^-!$ edl. Needless to say, for our purpose it would be highly desirable to carry out the high luminosity run at HERA.








