## $U_A$ (1) sym m etry restoration in QCD with N $_{\rm f}$ avors

## Abstract

Recently, there have been reports that the chirally restored phase of QCD is electively symmetric under U (N<sub>f</sub>) U (N<sub>f</sub>) rather than SU (N<sub>f</sub>) SU (N<sub>f</sub>). We supplement their argument by including the contributions from topologically nontrivial gauge eld congurations and discuss how the conclusions are modied. General statements are made concerning the particle spectrum of QCD with light N<sub>f</sub> avors in the high temperature chirally restored phase.

In relation to the exciting possibilities of probing the QCD phase transition in relativistic heavy ion collisions, there have been an increasing number of studies on the nature and physical consequence of chiral symmetry restoration in QCD [1]. Of particular interests are the possible changes in meson properties such as masses, decay width or the spectral density in general as they might be observed directly through particle multiplicity or dilepton spectrum [2].

Recently, there have been reports that the chirally restored phase of QCD is e ectively symmetric under U( $N_f$ ) U( $N_f$ ) rather than SU( $N_f$ ) SU( $N_f$ ) [3,4]. In particular, Cohen [4] has shown, from a general consideration of the QCD partition function, that the two point function of the spin zero multiplet of U( $N_f$ ) U( $N_f$ ), namely ;;; <sup>0</sup> etc., become degenerate if the spontaneously broken chiral symmetry is restored at high temperature. However, it should be noted that the argument in ref. [4] is not complete in the sense that it does not take into account contributions from topologically non-trivial gauge eld con gurations. In this letter, we supplement the work in [4] by including the contributions from the non-trivial topological sectors and give general statements on the nature of chiral symmetry restoration of QCD with light  $N_f$  avors.

Let us start with the Euclidean partition function of QCD.

where  $S_{QCD} = \frac{1}{4}F^2 + \not{D}$ . J could represent an external source or the mass matrix. Here we will neglect the gauge xing and ghost term s which will not be relevant for our discussion. Consider integrating out the quark elds,

where  $S_{YM} = \frac{1}{4}F^2$ . The integration over gauge elds A can have topologically non-trivial con gurations with the topological charge  $= \frac{g^2}{32^2}R^4 d^4xFF' \in 0$ :

$$Z[J] = \begin{array}{c} X \\ Z[J] \end{array} \qquad (3)$$

The con guration with non-zero is always accompanied by  $n_+$  (n) number of righthanded (left-handed) ferm ion zero mode satisfying  $\not 0_0 = 0$ . Furthermore, the index theorem tells that  $= n_+$  n. Our arguments below are not limited to speci c gauge con guration such as the BPST instanton [5]. Topological gauge con gurations ( $\neq 0$ ) have zero measure in the chiral limit (J = 0) as can be seen from the ferm ion determinant in eq.(2). However, in the presence of external source or nite quark mass, these zero-mode con gurations can have non-trivial contribution.

In the presence of one topological charge, the zero mode contribution can be separated out from the ferm ion determ inant and the = 1 sector of the partition function becomes [6]

Here,  $det_{sf}$  stands for the determ inant in the avor space which is denoted by the index s; f = 1; <sub>f</sub>N. The rest of the ferm ion determ inant is denoted by  $D et^0$ , which now does not

have a zero mode contribution.  $_0$  corresponds to the zero mode solution in the presence of a nontrivial gauge eld con guration of = 1. The explicit form of the functional integral for the case of the BPST instanton solution has been worked out by 'thooff [7]. Sim ilar study for the periodic instanton relevant to nite temperature system is given in [8].

Given the tools, we will now study n-point functions at arbitrary tem perature, paying special attention to the contributions from the non-trivial topological sector and its relation to chiral sym m etry restoration.

For simplicity, let us choose  $N_f = 2$ . The case with more avors can be easily generalized, although they have important di erences as we will show later. We will also restrict our form ulas to include only = 0; 1 to clarify the role played by the non-trivial topological sector.

To begin with, the form ula for the quark condensate reads

where  $S(x;y) = hxj(0 + m)^{-1}jyi$ .

One nds that the rst term in eq.(5) gives the Casher-Banks' form ula [9],

$$hqqi = h (= 0)i; \tag{6}$$

if one uses the identity

$$tr[S(0;0)] = \frac{2}{d} () \frac{2m}{2+m^2} \stackrel{m!}{!}^{0} (=0);$$

with () being the density of ferm ion states with eigenvalue ( $\emptyset$  = i ) in the presence of the gauge eld A .

The second term of eq.(5) is from the = 1 sector and gives a correction of 0 (m) to hqqi. Term s with higher have higher powers of m. For general N<sub>f</sub>, the topological correction starts at 0 (m<sup>N<sub>f</sub> 1</sup>). Thus, in the chiral limit, all contributions from the € 0 sector vanish and the Casher-Banks formula becomes exact. Namely the Casher-Banks formula links chiral symmetry breaking to the state density of fermions with nearly zero virtuality (0) coming only from the = 0 gauge con gurations. However, the fact that the exact zero modes in € 0 sector cannot contribute to the formula in the chiral limit does not imply that the topological con gurations are irrelevant to the chiral symmetry breaking. In the = 0 sector, there exists many instanton + anti-instanton pairs which could cause nearly zero modes: this can be explicitly seen in the chiral symmetry breaking in the phenom enological instanton-liquid model [10].

One should note here that the weighting function  $e^{S_{YM}} D et^0 \not\!\!D$  + m ] is positive sem i de nite. Hence, eq.(5) in plies that the restoration of chiral symmetry at high temperature

(i.e. vanishing of hqqi) is possible only when (= 0) vanishes before averaging over the gauge con gurations [4].

Sim ilar analysis with eq.(5) can be made for two point functions and higher. Let us concentrate on the di erence between and two point functions.

$$\begin{aligned} hq(x)q(x) ; q(0)q(0)i & hq(x) {}^{3}q(x);q(0) {}^{3}q(0)i \\ &= \frac{1}{Z} {}^{Z} D [A]_{=0} e^{S_{YM}} D et^{0} [ D + m ] tr[S(x;x)]tr[S(0;0)] \\ &+ \frac{1}{Z} {}^{Z} D [A]_{= 1} e^{S_{YM}} D et^{0} [ D + m ] 4_{0}(x)_{0}(x)_{0}(0)_{0}(0) + O(m) : (8) \end{aligned}$$

Again, the nst term comes from the = 0 sector and the second from the = 1. In this case, the contribution from = 1 part remains even in the chiral limit. At high temperature when chiral symmetry gets restored, S(x;x) / (= 0) = 0 (m). (A more detailed proof of this is given in ref. [4].) From this, Cohen concludes that, when chiral symmetry gets restored, the above di erence vanishes and the and become degenerate. However, as can be clearly seen in eq.(8), the non-trivial topological con gurations do not vanish and the di erence remains. This result is quite general. Consider taking the di erence between two point functions such as  $hJ_1(x);J_1(0)i = hJ_2(x);J_2(0)i$ . Whenever we need a chiral rotation and a U (1)<sub>A</sub> rotation to go from the spin zero current  $J_1$  to  $J_2$ , non-trivial topological con gurations contribute even in the chiral limit, and the di erence do not vanish even when chiral symmetry gets restored at high temperature.

It should be noted, however, that for general N<sub>f</sub>, e ects of  $\frac{6}{0}$  sector would be of  $0 \text{ (m}^{N_f 2})$  and vanish in the chiral limit for N<sub>f</sub> 3. For QCD in the real world, it is proportional to m<sub>s</sub> (150 M eV) and the e ect may not be negligible.

W hen the current  $J_1$  and  $J_2$  have spin-1 or 2, nontrivial topological contributions vanish due to the chirality of the ferm ion zero m ode irrespective of N<sub>f</sub> [11].

For generaln-point functions (n 3) or their di erences, there again is going to be a non-trivial contribution from € 0 sector. Generalization to higher N<sub>f</sub> in this case is also easy. One immediately nds that the topologically non-trivial congurations start to contribute from n-point functions where n=N<sub>f</sub>.

Let us now summarize our main conclusions:

- € 0 sectors do not contribute to two point functions for N<sub>f</sub> 3 in the SU (N<sub>f</sub>) symmetric chiral limit. In this case, the physical spectrum will extively be multiplets of U (N<sub>f</sub>) U (N<sub>f</sub>), as was claimed in [4].
- 2. If  $N_f = 2$ ,  $\notin$  0 sectors do contribute di erently to the two point functions of ; ; ; even in the chiral lim it and even when chiral sym m etry is restored at high tem perature. In this case, argument in [4] does not apply.
- 3. In the real world, SU (3) is not exact and  $m_s$  150M eV. In this case,  $\notin$  0 sectors do contribute with possible non-negligible e ect even at high tem perature.

Q uantitative estimates of the magnitude of 60 sectors in case 2 and 3 at high temperature depend on the density of topological congurations at high temperature. A likely such density could be highly suppressed and  $U_A$  (1) symmetry could be extively restored at

high tem perature, our arguments in this letter show that there is always a nite amount of  $U_A$  (1) symmetry breaking in the particle spectrum even when chiral symmetry restoration occurs at high tem perature.
