# The Top Cross Section in Hadronic Collisions

### A bstract

We reexam ine the top quark production cross section at the Tevatron and LHC, in the light of recent progress on the resum mation of logarithmic soft gluon corrections. We not that resum mation elects are much smaller than previously thought. We also compute Coulombic threshold elects, and not them negligible. We update the discussion of uncertainties due to scale dependence, the value of the strong coupling constant, and the parton density parametrization. Our current best estimate of the top production cross section at the Tevatron and its error is  $(m_t = 175 \, {\rm GeV}) = 4.75^{+0.73}_{-0.62}$ .

## 1. Introduction

We present in this letter a theoretical reassessment of the evaluation of the top quark production cross section in high-energy hadronic collisions. The top quark having been found [1, 2], the comparison between its observed production properties and those expected from the Standard M odelwill be an important probe of the possible existence of new phenomena. One of the most important tests to be performed concerns the total production cross section. This is the most inclusive quantity available, and is a priori the least sensitive to a detailed understanding of the higher order corrections which in uence the evolution of the initial and nal states. Within QCD, one expects the perturbative expansion in powers of  $_{\rm s}$  (m  $_{\rm t}$ ) to be well behaved and to provide an accurate estimate of the total cross section already at low orders. In particular, the stim ates of the total production cross section using the full next-to-leading-order (NLO) matrix elements [3, 4, 5] gave an increase (relative to the Born result) of the order of 30% form asses above 100 G eV. The residual perturbative QCD uncertainty, evaluated by varying the renormalization and factorization scales, was shown to be no larger than 10%. The choice of param etrization for the input parton densities was also shown to give e ects of this order of magnitude, by using the available sets.

It was pointed out in ref. [6] that logarithm ic contributions associated to the em ission of soft gluons from the initial state could signi cantly enhance the NLO result. An independent study of the soft gluon resumm ation in top production has appeared recently [7]. These studies are based on the resum mation formulae obtained in the pioneering works of refs. [8, 9, 10]. Using these form ulae for explicit calculations requires the choice of a prescription in order to bypass the Landau-pole singularity which is exposed by the integration of the QCD running coupling over gluon energies of the order of OCD. In particular it was shown in ref. [6] that, within the proposed form alism, one can get sensible results only by cutting o the soft gluon em ission at scales below 0:1 02 m<sub>t</sub>. The choice made in ref. [7] follows instead a suggestion put forward in ref. [11]. A coording to this prescription the Landau pole appearing in the Mellin transform of the resum med hard cross section should be integrated over in a principal value sense. It was argued in ref. [11] that this prescription results in non-perturbative power-suppressed ambiguities scaling like  $_{QCD} = Q$  in the hard scale Q typical of the process under consideration. The net e ect of gluon resum mation evaluated in ref. [7] amounts to an increase by approximately 10% of the NLO cross

section.

In a companion paper [12] we will show that the approaches of refs. [6,7] overestimate both the gluon resummation contribution and the associated non-perturbative residual uncertainty. This is a consequence of the fact that their resummation formulae introduce unjustimative expansion. In ref. [12] we will also show that a more natural prescription exists, in which these terms are not present. In the following, we will brief you summarize the basis of our criticism and the denition and main properties of the new proposed resummation prescription. We will then present a numerical study indicating that the impact of resummation on the total top production cross section is of the order of a percent, much smaller than previously thought. We will also show that threshold corrections due to higher order Coulombe ects are likewise negligible. We will conclude this study with an updated analysis of the current theoretical uncertainties coming from the scale dependence, from the choice of partonic densities and from the value of  $_{\rm S}$ .

It should be pointed out that this study is perform ed within the strict dom ain of the Standard M odel. Corrections to the top cross section much larger than the Standard M odel QCD uncertainties can be obtained in the presence of new phenomena. For a partial list of speci c examples, see e.g. refs. [13].

# 2. The minimal prescription for the resummation

The heavy avour production cross section in the Born approximation is given by the formula

where m is the mass of the heavy quark, and S is the square of the total centre-ofmass energy. The functions  $F^{(i;k)}$  are the parton densities for parton k in hadron i, and are evaluated at a scale of the order of the heavy quark mass m. Explicit formulae for the partonic cross section ^ can be found for example in ref. [3]. The corresponding N space formula is

where the Mellin transforms are dened in the following way

The integration contour lies to the right of all singularities.

We use the following resummed formula

In form ula (2.5) the strong coupling constant  $_{\rm S}$  is evaluated at a scale of the order of the heavy quark m ass m . The factor  $\ln _{\rm N}^{\rm (ij)}$  resum s all the leading logarithm ic term s  $_{\rm S}^{\rm k} \ln ^{\rm k+1} N$  due to soft gluon em ission. The contour in eq. (2.4) is chosen between the cuts on the negative N axis and the singularity at  $b_0$   $_{\rm S} \log N = 1$ =2, which is a Landau pole. We will call this the minimal prescription (MP). In ref. [12] we will show that this prescription en pys the following remarkable properties:

It is accurate at the leading log level in the threshold lim it.

If we expand the MP formula in powers of (m), the expansion is asymptotic to the full formula.

The power expansion of the M P formula does not have any factorially growing coe cients, and therefore is free of am biguities of the order of powers of =m. The ambiguity associated with the asymptotic expansion of the M P resummation is exponentially suppressed, being of the order  $e^{B(1-)^{\frac{m}{m}}}$ .

We claim that previous calculations of resum mation e ects [6,7] have a corresponding power expansion which does have factorially growing terms. These terms are spurious. They arise either from certain approximations performed when going from the Nepace to the xepace formulae, or from the integration of the running coupling constant down to the Landau singularity.

Our result is consistent with the ndings of ref. [14], indicating that no power-like 1=Q ambiguity emerges from the resummation of multiple gluon emission in D rell(Y an processes.

A full discussion of these issues will appear in a companion paper [12], where we will also study the implications of this prescription for D rell(Yan, heavy quark and jet production in hadronic collisions.

In the present work we will report on results obtained with our MP formula of eq. (2.4), which was in plemented without any further approximation in a numerical program.

## 3. Results

In this section we present the results obtained for a very heavy quark, and in particular for the top cross section. First of all, we rem ind the reader that large soft gluon e ects are present not only in the production cross section, but also in the deep-inelastic processes that are used to determ ine the structure functions. In order to perform a complete study of the resummation one should therefore use resummed formulae also when thing deep-inelastic scattering data, direct photon production data, and in general all phenomena which are used to constrain the parton densities. In the present work we will assume that the structure functions have been properly extracted from data (including the resummation e ects) and assess the signicance of the resummation for heavy avour production. E ects of comparable size may arise from retting the structure functions using resummed formulae. Our conclusions will mostly be based upon the fact that the resummation e ects we not are in fact very small, and can be neglected.

The im portance of the resum m ation e ects is illustrated in g.1 where we plot the quantities




Figure 1: Contribution of gluon resum mation at order  $^4_s$  and higher, relative to the NLO result, for the individual subprocesses and for the total, as a function of the top mass in pp collisions at 1.8 TeV.

where is equal to our M P resum med hadronic cross section (2.4) in which the terms of order  $_{\rm s}^2$  and  $_{\rm s}^3$  have been subtracted, and  $_{\rm NLO}$ ) is the full hadronic NLO cross section [3]. In other words, what we display is the relative contribution to the total cross section coming from corrections of order higher than those accounted for by the full NLO result. We show the results for the qq and gg production channels separately, as well as for the total. The results are shown at  $_{\rm s}^{\rm NLO}$  = 1:8 TeV as a function of the top m ass in the range 100 < m  $_{\rm t}$  (G eV ) < 600. The wide m ass range is chosen for the sole purpose of illustration. We chose a common renormalization and factorization scale = m  $_{\rm t}$ , and parton densities from the CTEQ1 set [15].

The plot clearly indicates that the contribution of soft-gluon resum mation is negligible, unless the top mass approaches the total hadronic energy. This result is consistent with the expectation that the soft gluon enhancement of the production cross sections should be relevant only very close to threshold. For a top mass of 175 GeV the increase due to this e ect is below 1%. We also note that the e ect of resum mation is potentially much larger for the gg channel, because of the  $C_A = C_F$  enhancement in the exponent of the resum mation formula (see eq. 2.6). It turns out, however, that when the gg subprocess becomes important (i.e. for small top masses)




Figure 2: Contribution of gluon resum m ation at order  $^4_s$  and higher, relative to the NLO result, for the individual channels and for the total, as a function of the CM energy in pp collisions.

we are so far from threshold that the resum mation e ect is very small. Conversely, for large masses, the quark component, which has smaller resum mation e ects, dominates.

In g.2 we show the same quantities, at xed top mass, versus the CM energy. We see that at the LHC, where production is dominated by the gg initial state, we are far enough from the hadronic threshold, so that the resummation extra again small. We conclude therefore that the extra of gluon resummation can be neglected at the present stage, as they are much smaller than the uncertainties present in the NLO determination. Note that, due to the dominance of the gg subprocess, the relative importance of the resummation extra at  $\frac{p}{S} = 1.8$  TeV is larger in pp collisions than in pp.

Beside the soft gluon em ission e ects, also Coulombe ects may enhance or deplete the cross section near threshold [16, 17]. We have calculated these e ects in the following way. We have separated the partonic Born cross section formulae into their colour singlet and octet components

We do not include bound state elects, which, as shown in ref. [17], are much smaller. In q.3 we have plotted the hadronic quantity

which (sim ilarly to the case of soft gluon e ects) represents the relative correction due to the resum mation of Coulomb e ects not already included into the NLO results. We see that these e ects are similar in magnitude to the soft-gluon e ects, and fully negligible at the Tevatron. Since at the LHC we are further away from the threshold region, we conclude that also there they will be negligible. Therefore, the following estimates of the top cross section will not include neither soft gluon e ects, nor Coulombic ones. Electroweak corrections to top production in hadronic collisions have been considered in refs. [18]. They range from -0.97% to -1.74% of the born cross section, for a higgs mass of 60 and 1000 GeV respectively [19]. They will also not be included in the following estimates.

We now proceed to review the current theoretical uncertainties that arise at NLO. Uncertainties due to unknown higher-order elects are usually accounted for by varying the renormalization ( $_{\rm R}$ ) and factorization ( $_{\rm F}$ ) scales. In principle, independent variations of the two scales should be considered. In  $_{\rm S}$ , 4 we show the scale dependence of the top cross section. Note that there is compensation of the factorization scale dependence when the different subprocesses are added up. In particular, the gg and  $_{\rm S}$  factorization scale dependence have opposite behaviour. In fact, it is only the combined scale dependence that can be considered an estimate of the neglected subleading corrections. As a second point, we observe that the maximum of the cross section is reached around m  $_{\rm t}$ =2. Thus, the usual choice of the range m  $_{\rm t}$ =2 < 2m  $_{\rm t}$  appears to be particularly justified in this case. As a third point, we observe that the




Figure 3: Contribution of Coulombe ects at order  $^4_s$  and higher, relative to the NLO result, for the individual channels and for the total, as a function of the CM energy in pp collisions.

scale dependence in the cross section goes in the same direction for the two scales, so that, for the purpose of estimating the associated uncertainty, it is su cient to consider the simultaneous variation of  $_{\rm R}$  and  $_{\rm F}$ .

A side from the scale uncertainties, which reject the limitations of the perturbative QCD calculation, there are uncertainties associated to our imprecise know ledge of the physical parameters involved. In particular, the strong coupling constant is determined within a certain accuracy. In the case of top production at the Tevatron, larger strong couplings tend to give larger partonic cross section. However, for larger strong couplings, the Altarelli(Parisi evolution, which occurs along the wide span in  $Q^2$  from the values at which deep-inelastic its are performed ( $10~{\rm G\,eV}^2$ ) to the top mass, softens the quark parton densities, thereby decreasing the cross section. In order to perform a fair estimate of the uncertainty due to  $_{QCD}$ , we need sets of parton densities itted with different values of the strong coupling. The sets of ref. [20] meet our purpose<sup>4</sup>. In g.5 we show the cross section as a function of the strong coupling.

 $<sup>^4</sup>$ The values of  $_4$  that accompany the fortran program for the structure function sets of ref. [20] are not consistent with the values of  $_5$  quoted there, the dierences being of the order of 1%. 


Figure 4: Scale dependence of the top cross section at the Tevatron. Dotted lines are the  $_{\rm F}$  dependence at xed  $_{\rm R}$ , dashed lines are the  $_{\rm R}$  dependence at xed  $_{\rm F}$ , and solid lines are obtained by the simultaneous variation of  $_{\rm R}$  and  $_{\rm F}$ .




Figure 5: Top cross section as a function of  $_s$  (M  $_z$ ). The dotted line does not include the variation of the parton densities due to the change in  $_s$ .

For comparison we also show the  $_{\rm s}$  dependence if the parton densities are kept xed. We see the remarkable reduction in the  $_{\rm s}$  dependence due to the compensation of the rise of the partonic cross section and the decrease of the quark parton densities.

Our results for the top cross section are collected in tables 1, 2 and 3, for values of the top m ass that span the current uncertainties. We also show results obtained with with the recent parametrization derived in ref. [22] by including the CDF jet data. We stress that the numbers in the table are obtained with a standard two-loop calculation. No resum mation elects are included.

Our ranges for the top cross section are thus given by  $7.78^{+1.28}_{-1.06}$  pb,  $4.75^{+0.73}_{-0.62}$  pb,  $2.97^{+0.42}_{-0.38}$  pb for m<sub>t</sub> = 160, 175, 190 G eV respectively, and are adequately tted in this range by the expression

As a central value for our determ ination we have chosen the MRSA $^0$  [23] result with  $_R = _F = m_t$ , in association with a value of  $_5 = 0.152\,\mathrm{GeV}$  (which corresponds to  $_S$  (M $_Z$ ) = 0.1113, according to the standard two-loop formula [21]). For the MRS sets with variable , we have used  $_5 = 0.0994$ ; 140; 190; 253; 328 GeV (which

corresponds to  $_{s}$  (M  $_{z}$ ) = 0:105; 0:110; 0:115; 0:120; 0:125).

In pp collisions at  ${}^{p}S = 2$  TeV we obtain, with the same method, a top cross section of  $10.5^{+1.8}_{-1.4}$  pb,  $6.53^{+1.03}_{-0.86}$  pb,  $4.17^{+0.61}_{-0.53}$  pb for  $m_t = 160$ , 175, 190 GeV respectively. The cross section bands are also shown in g. 6, for S = 1.8 TeV and g. 7 for S = 2 TeV. Because of the high precision of this theoretical prediction, the measurement of the top cross section could become a sensitive probe of new physics [13] [24].

For reference, we also quote the cross section for top production at the LHC.W e get (tt) =  $0.77^{+0.25}_{-0.12}$  nb, for m  $_{\rm t}$  =  $175\,{\rm G\,eV}$  and  ${\rm S}$  =  $14\,{\rm TeV}$ . The error is obtained with the same scale and  $_{\rm S}$  variations we used for the Tevatron cross section.




Figure 6: Top cross section at the Tevatron at  $^p \overline{S} = 1:8$  TeV. The solid line is obtained with MRSA  $^0$  parton density, and the dashed lines correspond to the upper and lower values obtained in tables 1{3. The experimental data are taken from ref. [25].




Figure 7: Top cross section at the Tevatron at p = 2 TeV.
