Som e aspects of therm al in ation: the nite tem perature potential and topological defects

A bstract

Currently favoured extensions of the Standard M odel typically contain 'aton elds' de ned as elds with large vacuum expectation values (vevs) and almost at potentials. If a aton eld is trapped at the origin in the early universe, one expects thermal in ation' to take place before it rolls away to the true vacuum, because the nite tem perature correction to the potential will hold it at the origin until the tem perature falls below 1 TeV or so. In the rst part of the paper, that expectation is con rm ed by an estimate of the nite tem perature corrections and of the tunneling rate to the true vacuum, paying careful attention to the validity of the approxim ations that are used. The second part of the paper considers topological defects which may be produced at the end of an era of therm alin ation. If the aton elds associated with the era are GUT higgs elds, then its end corresponds to the GUT phase transition. In that case, the abundance of monopoles and of GUT higgs particles will have to be diluted by a second era of therm al in ation (or perhaps some non-therm al analogue). Such an era will not a ect the cosm ology of GUT strings, for which the crucial param eter is the

string mass per unit length. Because of the at Higgs potential, the GUT symmetry breaking scale required for the strings to be a candidate for the origin of large scale structure and the omb anisotropy is about three times bigger than usual, but given the uncertainties it is still compatible with the one required by the unication of the Standard M odel gauge couplings. The cosm ology of textures and of globalm onopoles is una ected by the atness of the potential.

1 Introduction

In presently favoured extensions of the Standard M odel, the space of the scalar elds contains m any directions in which the potential is almost at out to large eld values.¹ In some of these directions the m ass-squared is likely to be negative, leading to a nonzero vev whose m agnitude w ill be large because the potential is at. Fields of this kind, with large vevs and almost at potentials, have been called atoms [3], and it has long been recognized that they m ay be cosm ologically signi cant [4, 5, 6, 3, 7, 8, 9, 10, 11, 12].²

Recently a previously almost [8] unnoticed aspect of aton cosmology was studied, and term ed therm al in ation [13, 14]. Therm al in ation is made possible by the atness of the potential, which near the origin allows the (positive) nite temperature contribution to the mass-squared to dom – inate the true (negative) mass-squared long after the therm al contribution to the energy density has become negligible. If it occurs, therm al in ation completely alters the standard cosmology, and one purpose of this paper is to exam ine carefully the features of the nite temperature potential that are supposed to lead to it. Taking into account the validity of the various approximations, we shall verify that therm al in ation indeed takes place, provided that the eld is trapped at the origin and that it has su ciently strong interactions with light elds.

W hen them al in ation ends, and the eld rolls away from the origin, topological defects m ay be produced just as in the more familiar case of a non- at potential. The second purpose of this paper is to see what e ect the atness of the potential has on these defects, and their cosm ology. W e are particularly interested in the case that the GUT higgs particles are atons, so that the defects produced are monopoles and (depending on the GUT)

The renormalizability requirement implies that there are at directions protected to all orders in perturbation theory. ²N ote the etym ology. The term 'aton' refers to the at potential, not to in ation. Conversely, the familiar word 'in aton' refers to the eld which is slow ly rolling during ordinary in ation. The term 'aton' was invented long before it was realized that such a eld can give rise to a di erent type of in ation (thermal in ation).

cosm ic strings, but we shall also study the case of global sym m etry breaking.

Recently it has been pointed out [15] that the interaction of other scalar elds with the aton might cause in ation even without thermalization. In that case the situation is more model dependent and we shall not study it in this paper, though much of our discussion of topological defects will still be applicable.

Them al in ation is expected to take place after ordinary (slow-roll) ination, and to last for fewere-folds. Such a late epoch of in ation can play a welcome role in diluting the abundance of unwanted relics, while leaving unaltered the large-scale density perturbation accounting for the cmb anisotropy and large scale structure. (A swe shall discuss this remark applies whether the perturbation is caused by a vacuum uctuation during ordinary in ation, or by topological defects such as strings or textures.) There can be more than one epoch of therm al in ation, so that a second epoch can dilute relics left over from a rst epoch, and we shall see that this is indeed essential if one is to have a GUT phase transition with a at potential.

Before getting into m ore detailwe need to be precise about what is meant by a 'large' vev, and a potential which is 'alm ost at'. In this paper we take these terms to be dened with respect to the energy scale 10^2 to $10^3 \, \text{GeV}$, which is the scale of supersymmetry breaking as dened by the masses of the supersymmetric partners of known particles [16]. Thus the vev M of a atomeld is much bigger than the above scale, whereas the the energy scale $y^{0.1=2}$ dened by the curvature of its potential is taken to be of order that scale. In particular the mass m of a atom particle is taken to be of that order. Since the potential as well as its rst derivative vanishes at the vev, its value V₀ at the origin is of order m²M².

Each atom is either a gauge singlet or a GUT Higgs eld. A GUT is now adays considered optional because it is di cult to implement, and can perhaps be avoided by appealing to superstring unication near the Planck scale. On the other hand the observed Standard M odel couplings are com – patible with the existence of a GUT, with Higgs vevs of order 10^{16} GeV (plus possible additional intermediate scale vevs [17]). If one accepts the existence of a GUT then it is attractive to suppose that the Higgs elds are atoms because one might then be able to understand the magnitude of the vev without inserting parameters by hand [18].

W hether or not there is a GUT, one expects to nd some atons which are gauge singlets. To understand the possibilities here, note is that each aton will be a complex eld.³. If there is a single aton eld, and it is charged under a global U (1) symmetry, then its vev will spontaneously break that symmetry. The prime candidate for a global U (1) symmetry is the Peccei-Quinn symmetry associated with the axion, and indeed a aton model for that symmetry has been proposed [19]. With more aton elds one can have higher global symmetries, as we mention at the end of Section V in connection with topological defects.

However there is no need for a aton eld to be charged under a continuous symmetry; on the contrary, it is quite reasonable on the basis of current thinking to expect aton elds which are charged under at most discrete sym – metries. For them, the vacuum manifold consists of discrete points instead of an entire circle. The possibilities that we have in mind are of two kinds. The rst are some or all of the moduli elds [4, 20, 21, 22, 23, 24], which are ubiquitous in versions of supergravity motivated by the superstring. For the present purpose, a modulus may be de ned as a eld whose potential is exactly at in the limit of unbroken symmetry. It is widely supposed that one orm ore of the moduli is a aton, with a vev of order the reduced P landk mass $m_{P1} = (8 \text{ G})^{1=2} = 2.4 10^{18} \text{ GeV}^4$ (Lower values may be possible so that GUT Higgs elds may be moduli [18], but for simplicity, the term moduli' will be used in what follows to denote only the case where the vev is of order m_{P1} . It is also possible that moduli have masses much bigger

 $^{^{3}}$ In a supersymmetric theory all scalar elds are complex since the corresponding left-or right-handed spin-half eld has two degrees of freedom.

⁴The origin of a eld is de ned to be a xed point of its symmetries. W ith all relevant elds at the origin the potential has zero slope, where 'relevant' means those elds that are coupled to the one in whose direction the slope is being de ned. We are assuming that this is the situation for the atons (or at least that any couplings to other elds displace the minimum by an amount small compared with the vev). In the case of a modulus there is more than one xed point with the separation between xed points of order m_{P1} . In this context the vev may be de ned as the distance to the nearest x point, and the statem ent that the vev is of order m_{P1} simply means that it is not close to any particular xed point.

than 1 TeV, in which case they are not atons.) Now consider the opposite possibility, of gauge-singlet atons whose potential is not at even in the lim it of supersymmetry [14, 25]. Extensions of the Standard M odel can easily contain such elds, and their potentials will resemble Eq. (4) below, with couplings perhaps or order 1. As a result, their vev is typically much smaller than the GUT scale, perhaps of order 10^9 to 10^{11} GeV.

2 Flaton cosm ology

The cosm ology of atoms is a rather rapidly moving research area at the moment, but we brie y summarize it here following [14, 15, 26]. For simplicity we generally pretend that there is only one atomeld, whose potential is invariant under a U (1) symmetry so that it depends only on the magnitude j j. We also however point to the dierences that can occur in the more realistic case, where there may be several atomelds and a higher symmetry or else no continuous symmetry at all.

In the early universe, the elective potential of a laton eld is modiled by its interaction. If the interaction with light particles is of gravitational strength, then the elective potential is expected to receive an additional contribution of order H²j j² [5, 6, 10, 27]. If it is somewhat stronger one might perhaps expect a contribution ${}^{2}H^{2}j j^{2}$ with signil cantly bigger than 1.0 ne expects gravitational strength interactions form oduliw ith a vev of order m_{Pl}, whereas one expects interactions stronger by a factor perhaps m_{Pl}=M for a aton with smaller vev M. These statements refer to eld values of order the vev, as opposed to values near the origin which we discuss in a moment, and they are based on the idea that the coupling to a light particle is suppressed by a factor / 1=M.

The weak contributions just described can be of either sign. In contrast, if the interaction is strong enough to lead to therm alization then one has the nite tem perature correction to the potential, which at least near the origin gives typically a positive contribution $T^2 j j^2$ to the mass-squared.⁵ For

a aton eld , one expects the therm al contribution to be present in the regim e j j < T because the e ective m ass of particles coupling to the aton eld is of order j j. Section III below is devoted to a detailed study of the therm al contribution.

As a result of these modi cations to the potential, a atom in the early universe will either be at the origin or will have a value which is large but not particularly close to its true vev. We discuss these possibilities in turn.

2.1 Flaton eld initially at the origin

Let us suppose that a positive elective mass-squared holds the aton eld at the origin prior to full reheating after ordinary in ation. Then the nite temperature mass-squared T^2 will typically hold it there until the temperature falls to a value $T_{end} = m_0 = 10^2$ to $10^3 \, \text{GeV}$, where m_0^2 is the true mass-squared of the aton eld at the origin. Only then will it start to oscillate about the true vev. On the other hand, the energy density with the aton eld at the origin is

where g is the elective number of species.⁶ Because T_{end} is so low, the rst term dominates before the aton eld rolls away, leading to an era of thermal' in ation. The era starts when T $V_0^{1=4}$ (m M)¹⁼², and it ends when T = T_{end} m, so the number of e-folds of thermal in ation is of order (1=2) ln (M =m) 9 + (1=2) ln (M =10¹⁰ G eV). As a result, thermal in ation cannot replace ordinary in ation; rather, it takes place if at all after ordinary in ation has ended, at the low energy scale $V_0^{1=4}$ (m M)¹⁼²

⁽These type of terms do not destabilize the potential since + (y) ⁿ eventually stabilizes it.)

⁶T his estim ate does not apply to non-therm alized particles (in particularm oduli) whose energy may come to dominate that of the therm alized particles before therm alin ation commences. In this case we would have an additional contribution to the energy density (the oscillating moduli elds typically behave as massive particles). This would somewhat com plicate our analysis [14] but the qualitative conclusions remain una ected, so we will not consider them.

A fter them al in ation ends the aton eld starts to oscillate about the minimum of the elective potential, so we enter an era of matter domination by the aton particles. (A swe discuss in a moment the minimum might initially be shifted from the true vacuum, but this elect can be ignored because the movement of the minimum will be slow.) If each aton particle decays at the single particle decay rate , this era ends at the time 1 . In typical models one estimates $^{1} = 100 \ ^{1}\text{M}^{2}$ =m 3 where the numerical factor is at most of order 1. At least the bulk of the decay products them alize promptly, so setting 1 equal to the expansion time H 1 where H is the Hubble constant we obtain the temperature just after aton decay to be

where g $\,$ is the elective number of species at tem perature $T_{\,\text{D}}$, set equal to 100 for the num erical estimate.

In fact, the assumption that the atons corresponding to the oscillation decay individually at the one-particle decay rate is not correct, because of non-linear relaxation e ects of which the most studied example is parametric resonance [29, 30, 15, 31, 32, 33] (see also [34, 10]). As soon as the aton eld starts to oscillate at the end of therm al in ation, non-linear relaxation drains o a signi cant fraction of the oscillation, or in other words destroys a signi cant fraction of the corresponding aton particles. They are replaced by m arginally relativistic scalar particles of whatever species have a signi cant interaction with the aton eld, including the aton eld itself.

If nothing happens to the produced scalar particles they will become non-relativistic after a few Hubble times, and are expected to decay at their one-particle decay rate. If, on the other hand, they thermalize then they turn into highly relativistic radiation. At the present time it is not clear whether parametric resonance can really create particles which thermalize successfully. However, it is clear that the aton component of the produced particles cannot thermalize because here one knows that the interaction is too weak. Furthermore, one expects that the energy density of the produced atons will be a signi cant fraction of the total energy density [26]. Thus, even if the other produced particles them alize promptly one expects that a signi cant fraction of non-them alized energy will remain, and that a significant fraction of that energy will be in aton particles.

Any them alized radiation produced by parametric resonance will redshift away, so independently of the details one expects that a few Hubble times after the end of them al in ation the energy density is dominated by non-relativistic scalar particles, including the atons and perhaps other species. Each species will decay at the single-particle decay rate, so we expect eventually to nd only the longest-lived species, which dominates the energy density until it decays. For simplicity we shall assume in what follows that this species is the original aton. Then, the upshot of this discussion is that despite non-linear e ects, the eventual reheat tem perature is still the tem perature T_D calculated from the single-particle decay rate, as given by Eq. (2).

2.2 Flaton eld initially displaced from the origin

Now suppose that the aton eld has a large value in the early universe. In contrast with the rst case, the eld will not now be in therm al equilibrium because its interaction with light particles will be very weak (because otherwise the large value would generate a large mass for the would-be light particle). A very crude model for the evolution of the eld ective potential of a aton eld in the early universe is [14, 26, 35]

where M is the true vev. The second term represents the e ect of interactions in the early universe, and for the present purpose we can suppose that $_0$ M is a constant, so that the only time dependence comes from H.

First suppose that is of order 1, which is the expected value at least for a aton such as a modulus with gravitational strength interactions (corresponding to M m_{P1}). In that case [14], the minimum of V is practically at $_0$ until the epoch H m, after which it moves quickly to the true vev M. The aton will have settled down to the minimum of V before the end

of ordinary in ation, so the conclusion is that if is of order 1 the atom eld starts oscillating about the true vev at the epoch H m, with initial amplitude j₀ M j M.

As soon as the oscillations start, non-linear relaxation e ects will convert a signi cant fraction of the energy in the oscillating aton eld. Provided that the oscillation continues to take place about the true vev, then the qualitative picture will not be altered, just as we discussed already in the case of an oscillation starting out at the origin. However, because the initial oscillation energy can now be bigger than the potential energy V₀ at the origin, there is now the possibility that non-linear relaxation e ects restore the symmetry, so that the oscillation takes place about the origin [15]. In that case the aton eld oscillation might give way to some e-folds of in ation, which might be thermal in ation, before the symmetry breaks [15]. If it occurs, this will happen when the energy density is equal to V₀ (m M \hat{f} , which is much less than the energy density (m m_{P 1})² at the epoch when the oscillation starts.

Finally, consider the case 1. The evolution of the aton eld is now quite di erent [26], because the movem ent of the minimum of the eld is now potential is always slow on the timescale of oscillations around it. As a result the aton is at all times close to the minimum of its eld ective potential, and the cosm ological production of aton elds is strongly suppressed. (To be precise, analytic [35] and num erical [26] estimates show that the amplitude of the oscillation about the minimum is reduced exponentially compared with the case 1.)

2.3 The case of more than one aton eld

So far we have considered only a single aton species. If there are several, then som e m ay be initially trapped at the origin and som e m ay be displaced from it. Those which are displaced start to oscillate rst (when the energy density is $(m m_{Pl})^2$, corresponding to a Hubble parameter H m), while those trapped at the origin give rise to therm al in ation. If several aton elds are trapped at the origin, the sim plest possibility is that they all roll away at m ore or less the same epoch, which seem s reasonable because the

negative mass-squared is of the same order for all atons, and so is the nitetem perature correction. If that happens, we essentially recover the case of a single aton. However, the rolling away of the rst aton (say) might trap the remaining atons at the origin through its interactions. One possibility is that the particles produced by non-linear relaxation promptly thermalize, in which case one may enter a second era of thermal in ation [14]. A Iternatively the remaining atons may be trapped by non-linear relaxation [15], which could also lead to a second epoch of in ation.

In this paper, we are assuming for simplicity that only genuine atons can roll away from the origin. It could happen that a eld with a at potential, and zero true vev, couples to a aton in such a way that itse ective potential acquires a nonzero minimum by virtue of the zero value of this aton. Such a eld could temporarily act as a aton, leading to a more complicated cosm ology [25] which we shall not consider.

2.4 The entropy crisis and its solutions

If a aton comes to dominate the energy density of the universe, then the low 'reheat' temperature Eq. (2) makes it cosmologically fatal if its vev is too large. Indeed, successful nucleosynthesis requires $T_D > 10 \text{ MeV}$, corresponding to M < 10^{14} GeV , and thermalization of a stable LSP requires $T_D > 1 \text{ GeV}$ corresponding to M < 10^{12} GeV . (To have electroweak baryogenesis requires $T_D > 100 \text{ GeV}$, but this requirement is not mandatory especially as thermal in ation itself provides additional possibilities for baryogenesis [15, 25].)

This possible problem is a concern for any moduli which are atons with a vev M $m_{\rm Pl}$, and it is also a concern for GUT Higgs elds if they are atons since the corresponding vev is M 10^{46} G eV. It was originally term ed the entropy crisis' [4], and was widely discussed in the 1980's [5, 6, 7, 8, 9, 10, 11, 12]. More recently, focusing on moduli, it has been term ed the moduli problem [20, 21, 22, 23, 24].

Let us consider the status of the 'm oduli' problem, in the light of the above snapshot of the current status of aton cosm ology. First, it should be emphasized that the problem exists only if the elds in question are actually atons, with masses 10^{2} to 10^{3} GeV. Assuming that this is the case, the status of the problem depends on whether or not the aton in question is initially displaced from the origin. If it is, the problem may not occur at all, because the aton may settle down smoothly to the true vacuum without appreciable oscillations; this may well occur for the GUT Higgs though it is less likely for the moduli [26, 35]. If it does occur it can be solved by a subsequent bout of them al in ation, associated with a aton having a cosm ologically safe vev M < 10^{12} GeV. As we remarked earlier, typical extensions of the Standard M odel indeed contain such atons.

If, on the other hand, the aton in question is initially at the origin, then therm alin ation willoccur and when it ends the aton will certainly oscillate with large amplitude. In that case one needs a second era of therm alin ation [14], again associated with some other aton which has a cosm ologically safe vev. At least naively this in turn requires prompt therm alization of a signi cant fraction of the original aton oscillation energy (with non-linear relaxation presumably rst converting the energy into marginally relativistic particles) and at the present time it is not clear whether this is possible. If it is not possible, then we reach the important conclusion that atons with dangerously large vevs, like moduli and GUT Higgs elds, cannot be associated with therm al in ation. We return to this issue for GUT Higgs elds in Section V.

3 The 1-loop therm ale ective potential

In this section and the following one, we exam ine carefully the nite tem – perature e ects that are supposed to make thermal in ation possible. They were rst described by Yam am oto in 1986 [7], but his account was brief and it did not discuss the validity of the various approximations employed. To our know ledge no subsequent authors have improved on Yam am oto's discussion.

As already remarked, the potential of the relevant aton elds might be invariant under a continuous symmetry such as a global U (1) or a GUT gauge symmetry, or alternatively it might have no continuous symmetry. The computations in this paper will be applied to a simple toy model, in which there is a single aton eld with a U (1) symmetry. Following [13, 14], we take the potential to be of the form

where n is an integer power. Here m₀ is of order 10^3 GeV , and for simplicity we have included only the leading non-renorm alizable term. The magnitude of the coupling _n is model dependent, but for de niteness one can keep in mind a value of order 1. We can parametrize the quantum eld as follows:

where is the classical degree of freedom, which equals to the expectation value of $\overline{2}h$ i, and and are quantum uctuating elds with zero expectation values. The classical part of the elds ective potential can be then written as

From this expression we can easily obtain the mass m of the aton particle given by m² = d²V=d² (= $\frac{p}{2}M$), the vacuum expectation value M = h i₀, corresponding to the minimum of V, and the height V₀ of the potential at the origin which one gets by setting V (M) = 0. The result is

One naively expects $_n$ 1 (n 1) for the couplings, making M 10^{10} GeV. On the other hand, it might be that the Planck scale is replaced by the GUT scale if there is one, which electively increases $_n$ leading [14] to M 10⁰. Finally, $_n$ might be a small mass ratio, which could make M 10^{10} so that it becomes [14] the GUT scale (appropriate if is a GUT Higgs eld) or the Planck scale (appropriate if is a modulus). In this paper we focus on the rst and second cases.

3.1 Coupling to bosons

Now consider the nite-temperature correction to the elective potential. First we will argue that the therm all correction from the led itself is irrelevant in the sense that it can neither trap the led at the origin nor cause a phase transition. Then, in order to cure this we will assume either that couples to another (real) scalar led via a quartic coupling of form g^{y} , or gauge the U (1) by adding the corresponding gauge led. We shall also consider the elect of coupling to a spin-half led since we have in m ind the case of supersymmetry.

The one-loop therm alcorrection of a bosonic excitation with the mass m to the elective potential has the following generic form [36]

Below we will always quote a one bop result form . One should keep in m ind that strictly speaking in order to obtain the one bop therm al correction to the elective potential from Eq. (10) one should use the tree level value for m. In some cases the ring-improved one bop potential (which is a result of resumming certain so-called ring diagrams to allorders) is more accurate. It corresponds to using the one-bop therm all value for the elective mass only for the Singular' term $m^{3}T=12$ in the high temperature expansion.

The one-loop value for them asses follow: $m^2 r m_0^2 + gT^2 = 12$ is them asssquared of the - eld excitations, and $m^2 = m^2$ (T = 0) + $gT^2 = 12 + g^2$ is the mass-squared of . Note that in this approximation m does not acquire a dependent correction. Indeed, the low est order correction to m^2 proportional to 2 occurs at the (n + 1)-loop level and is of order $_nT^2$ ($T = m_{P1}$)²ⁿ, which is minute and hence negligible. We now see from Eq. (10) that the nite tem perature contribution due to the eld excitations is to an excellent approximation a -independent shift in the eld excitations is to an excellent a ect the dynamics of the eld.

The complete e ective potential is now V (;T) = V () + ${}^{P}{}_{i}V_{1}$ (m_i;T), where we are sum ming over all the boson elds. In the regime m_i ${}^{P}\overline{g} >>$

T, the nite temperature correction V₁ is negligible. (A swe remarked earlier, one does not in any case expect therm alization in this regime, since particles with mass memory must couple weakly to [14].) In the opposite regime m_i' ${}^{p}\overline{g}$ T, the correction is V₁' T⁴ $_{4}$ = 2 with $_{4}$ = 4 =90, which is independent of . The conclusion is that at large temperatures T M, the potential has a single minimum at = 0. (Recall that M is the position of the true vacuum, de ned by Eq. (8).) As the temperature drops a second minimum develops. At a critical temperature T_c de ned by V (T_c; = 0) = V (T_c; = $^{p}\overline{2}$ M) the two minima are degenerate.⁷ This temperature is given by

The bump in the e ective potential which causes the phase transition is solely due to the eld excitations. Even though there are two degenerate m in in a the eld will be trapped at = 0, i.e. there will be no phase coexistence since the bump is very large and the tunneling rate is m inute, much smaller than the expansion rate of the Universe. A large bump at the critical tem perature indicates that the phase transition is strongly rst order. As the Universe cools down below T_c, trapped in the false vacuum phase = 0, the false vacuum energy starts dom inating. U sing Eq. (1), this occurs at the tem perature $T_{T\,I}^{\,4}$ ' $V_0^{\ 2}\text{=}3g_4$, at which Therm al In ation begins. The elective number of particle species g is equal 3 in our toy model, two from the eld and one from the -eld. In general g will be of order 10^2 1° . Note that, according to the rough estimate Eq. (1), the tem perature T_c is of the same order of magnitude as the tem perature T_{TI} at which therm alin ation begins.

Therm al in ation ends when the Universe supercools su ciently so that the tunneling rate for creation of the true vacuum bubbles becom es com parable to the expansion rate of the Universe. W e will postpone a more detailed study of the bubble nucleation to the next section.

 $^{^7}N$ otice that this is not the tem perature $T_C\,$ de ned in [13, 14]; in this paper we are denoting that quantity by T_{end} .

So far we have focussed on the coupling to a spin zero particle . If the aton is a GUT Higgs eld there will also be a coupling to gauge particles. A s a toy model, consider the Abelian Higgs model, whose Lagrangian density is L = $F = F = 4 + (D)^{y} (D)$ V, where D = 0 + ieA, A is) the vector eld, and F is the eld strength. The therm al correction to the potential has again the form of Eq. (10) but with the masses squared m_0^2 + (3e²)T²=12 for both the physical excitation and the unphysical $m^2 =$ Goldstone boson of the $-eld_{1}$ and $m_{L}^{2} = e^{2} + (e^{2}=3)T^{2}$, $m_{T}^{2} = e^{2}$ for (one) longitudinal and (two) transverse polarized gauge eld excitations, respectively. At this level som e gauge dependence m ay com e into the play, but we will not discuss this issue here. The above analysis caries through in alm ost exactly the same way, except that the masses in the therm alpotential are now m_L, m_T and m . There are 5 degrees of freedom relevant for the onset of them al in ation, so the temperature at which it begins will be som ew hat low er, as will be the critical tem perature.

W hat about the validity of the one-loop approximation? The squared coupling of the three dimensional theory is $g_3^2 = gT$ for a scalar theory and $g_3^2 = e^2T$ for a gauged theory. Each loop added costs an extra factor gT=M; recall that M ' $p_{\overline{g}}$, M_{T;L}' e, so that we expect the one-loop approximation to break down when $g_3^2 > M$, which means $=T < p_{\overline{g}}$ for the scalar theory and =T < e for the gauge theory. In other words, the one-loop approximation can be trusted as one approaches the critical temperature up to T_{cj} gT; e^{T} . In this case, unlike in the case of the electrow eak theory, the one-loop treatment is accurate. The reason is that the maximum of the electric potential (bum p) is located at

This should be taken only as an estimate since the bump is located where neither the high temperature nor the low temperature expansion is accurate. Nevertheless, this estimate tells us something important about the validity of the one loop approximation: the bump is located in the region of validity of the one-loop approximation (this is, for example, not true in the electroweak theory); it is 1=g times larger for the scalar theory (1=e² for the gauge theory)

than the value of at which we expect the breakdown of the one-loop approximation. We see that, at the local maximum, the 1-loop potential is still a reasonable approximation to the true elective potential and this treatment of the phase transition is quite accurate. One can also evaluate the potential energy density at the bump. To get a feeling for what it is we evaluate it in the high temperature limit and nd V ($_1$) V₀ T⁴ ² (1=90 1=648). Hence we see that the energy density of the bump (T⁴ ²=648) is much smaller than the energy density di erence between the false and true vacua (V₀ T⁴ ²=90). This suggests that the wall of the critical bubble is thick, which will be used in the follow ing section where we study nucleation.

3.2 Coupling to ferm ions

To illustrate what happens in the case of a scalar eld coupling with fermions, we include in the global U(1) potential a Yukawa coupling of the scalar to a spinor eld y_f . We will then have a contribution to the eld ective potential of the form

where the ferm ion mass is $m_f() = y_f$. This yields a critical temperature very close to the scalar coupling case of Eq. (11) with a minor numerical di erence: since each ferm ion contributes to the free energy 7=8 tim es less than a boson, with the same number of degrees of freedom , T_c will be higher by a factor $(8=7)^{1=4}$. The local maximum 1 will also be the same (replacing e by y_f). O ne should note an important di erence between this phase transition and the electroweak phase transition. Since the main reason for the 0 is not the singular cubic term free energy valley at around $m_{\rm f}^3 T = 12$ in the high tem perature expansion of Eq. (10), but the exponential suppression of the population density for the mass m $_{\rm f}$ >> T, the only di erence in studying the cases of coupling to bosons and ferm ions is the trivial one of counting degrees of freedom. The total e ective number of degrees of freedom is g (tot) = $\frac{7}{8}$ g (ferm ion) + g (boson). This remark will be also valid when studying the nucleation problem in the next section.

4 Tunneling

W e are taking the standard route as advocated by C allan, C olem an [37], and Linde [38] in which we assume that the spherical three dimensional action

This is an approximate formula but it is su ciently accurate for our purposes. A more accurate treatment of bubble nucleation can be nd in [39]. The rate in Eq. (15) has to be compared with the expansion rate of the Universe to determine the rate of bubble formation. More precisely [40], assuming a constant bubble expansion velocity, at any given time the fraction of the Universe remaining in the symmetric phase is given by

In order to solve for the nucleation tem perature we expand S_3 about the value when the integrand is about one: $S_3 = S_3 (T_{nucl}) + (t - t) (dS_3=dt)$, where d=dt = (dT=dt)d=dT, dT=dt = TH, and $H^2 = (8 G=3) (^2g (T)T^4=30)$ is the Hubble constant. U sing a saddle point approximation we nd that the integral is of order one when

Since Eq. (18) is analytically intractable, various approximation schemes have been developed. In general when the height of the local maximum is small (large) in comparison to the false vacuum energy, the thick (thin) bubble wall approximation gives a reasonably accurate answer to S₃. First one can show using the thin wall approximation, which is accurate around T_c, that the three dimensional action: S₃ (2 =3) ³=V (0;T)² is indeed huge; here = $\binom{R}{jV(jT) + V(0;T) = 0}$ $\binom{2}{2}$ [V(jT) + V(0;T)]d $\binom{2}{j} = \binom{p}{g}$ is the surface tension of the bubble, and near the critical temperature V (0;T) = $-\frac{4}{2}$ (T⁴_c T⁴) << T⁴_c. When the temperature drops signi cantly below T_c, such that V_{bump} <<

V(0;T), where V_{bump} is the dimension between the maximum of the potential and V(0;T), the thick wall approximation becomes appropriate. Here we present a heuristic discussion. The three dimensional action for the critical bubble can be approximated as follows:

where we assumed that the bubble is supersonic: v 1; this is plausible since supercooling is very large. temperature is about T_{nucl} ' $2m_0$. For som ew hat di erent values of parameters T_{nucl} changes only slightly. To a very good approximation T_{nucl} is proportional to m_0 . (Here we have neglected a logarithm ic dependence of the form $(\ln m_0)^{1=3}$.)

These results are in substantial agreement with that of Yam amoto [7], who found that the bubble action is (up to $\ln m_0$) proportional to $T^4 = m_0^3$. W hat we have done is to look more carefully at the somewhat delicate assumptions which have to be made in order to derive it. We have found that at a reasonable level of condence they can indeed be justiled by carefully considering the regime of validity of the various approximations.

 $^{^8}N$ ote that $T_{\rm nucl}$ for all practical purposes coincides with the tem perature at the end of them alin ation $T_{\rm end}$, discussed in section 2 above.

5 Topological defects with a at potential

Now we come to the second part of our investigation, which is to bok at topological defects associated with a at potential. In the case of a single (complex) aton eld with a U (1) symmetry, which we have focussed on for the sake of simplicity, these are cosm is strings. If instead there is only a discrete Z_n symmetry they are domain walls. Finally, if there are two or more aton elds there could be a higher continuous symmetry, which, depending on the pattern of symmetry breaking, could lead to monopoles and/or textures (or to no defects at all). We shall consider all these cases.

In order for the defects to form, the symmetry has to be restored at early times, which as discussed in Section 2 may or may not happen for a given aton eld. A ssuming that it is indeed restored the defects form when the eld rolls away from the origin, and since we are considering a aton eld this occurs at the end of an era of therm alin ation. Thus, we are considering the form ation of topological defects at the end of such an era.

We shall focus particularly on the case where there is a GUT whose Higgs elds have a at potential, schem atically of the form Eq. (4). As mentioned already such a at potential seems quite natural, because one can then hope to generate the required vev from scales already present in the theory [18]. For example, in Eq. (4), the coupling $_n$ might be of the form $(m_g=m_{Pl})^p$, where m_g is related to vevs arising from gaugino condensation, and p is a positive integer. This paradigm is of course very di erent from the usualone, where the potential of the GUT Higgs is supposed to be non- at so that it has the form

with 1. Such a form is indeed natural for the Standard M odel H iggs where M is only of order the susy breaking scale 10^2 to 10^3 G eV, but it seems far less natural for a GUT. In other words, there seems to be no reason to suppose that the vev of a GUT H iggs is of the sam e order of m agnitude as its m ass.

GUT symmetry breaking with a at potential is completely dierent from the usually considered case. The GUT phase-transition occurs at the end of an era of them alin ation. Just before it occurs, the potential energy density V_0 of the Higgs eld accounts form ost of the energy density in the universe, and after the transition this energy is initially converted into a hom ogeneous oscillation of the Higgs eld (away from any topological defects), corresponding to extrem ely non-relativistic Higgs particles. Through non-linear relaxation e ects this initial era is quickly followed by one in which at least a signi cant fraction of the energy density resides in marginally relativistic scalar particles, of various species including the Higgs particles. There may also be a signi cant fraction in therm alized (and hence highly relativistic) particles, but this question has not been settled at the present time.

Because the potential is at, the GUT H iggs particles are light (m assm 10^2 to $10^3 \,\text{GeV}$), and according to Eq. (2) they decay after nucleosynthesis. In order not to upset nucleosynthesis their abundance must be diluted by a second era of thermal in ation.⁹ Such an era requires the thermalization of a substantial fraction of the H iggs particles, and, taking the fraction to be of order 1, but not very close to it, the abundance of the H iggs particles im m ediately after thermalization is n=s $V_0^{1=4} = (g^{1=4} \text{m})$ 10^6 . From [41], their abundance at the epoch of nucleosynthesis must satisfy n=s < 10^{12} , so the second bout of thermal in ation should dilute the abundance by a factor of at least 10^{18} .

The actual dilution factor actually provided by them alin ation is [14]

In this expression m and M refer to the second era of thermal in ation, as do T_{end} (the temperature at the end of thermal in ation) and T_{D} (the reheat temperature). The quantity 1 is the fraction of energy left unthermalized after non-linear relaxation e ects have occurred after the end of the second bout of thermal in ation, which we set equal to 1.

In making the above estimates we have set $V_0 = m^2 M^2$ and $T_{end} = m = 10^{2.5} \text{ GeV}$ for both eras of thermal in ation. The expected range for the vev of the in atom causing the second bout of thermal in ation is $10^9 \text{ GeV} < M < 10^{10} \text{ GeV}$

 $10^{12} \,\mathrm{G\,eV}$ (with the lower limit coming from the discussion after Eq. (8) and the upper limit from the requirement of decay before nucleosynthesis). Since several parameters have been set equal to ducial values, a second bout of thermal in ation seems wellable to provide the necessary dilution. The only problem is to ensure that it occurs, bearing in m ind the fact mentioned earlier that the possibility of thermalization immediately after thermal in ation ends has not been demonstrated.

A ssum ing that the GUT particles can be somehow diluted, we proceed to a discussion of the defects produced, starting with monopoles.

5.1 Monopoles

It is well known that monopoles form when the vacuum manifold M of a gauge group G contains non-shrinkable 2 surfaces, i. e. when $_2(M) \notin I$, where $_2$ is the second hom otopy group. In the light of a theorem in hom otopy theory, this may be rephrased as: monopoles form whenever a grand uni ed sem is in ple group G breaks down to a group H which has nontrivial fundam ental hom otopy group $_1(H) \notin I$, i.e. H contains non-contractable loops. A sim ple example is an H which contains at least one U (1) as a factor, just like the Standard M odel! It is argued in [42] that since supersymmetry does not change the connected structure of the (super)-Lie group, the sam e consideration as above is valid for a supersymmetric GUT. Since rather generically the symmetry of a low energy theory contains non-contractable loops, one must check what would be the cosm ological in plications of m onopoles' form ation, i.e. whether there is a monopole problem.

It is convenient to specify the monopole abundance $n_{m on}$ as a fraction of the entropy density s, because $n_{m on}$ =s is constant as long as monopoles are not destroyed, except when particle decay (or some other non-equilibrium process) increases the entropy per comoving volume. Consider rst the observational upper bound on the present monopole abundance. The mass of a gauge monopole for a given vev M is not much a ected by the atness of the potential, because it is known that the mass goes to a nite limit as the potential becomes atter and atter (Bogomolny bound) [43]. This leads to a simple and reliable bound on the present monopole abundance of

 $n_{m on} = s < 10^{24}$, coming from the requirement that the monopole density be less than critical. This bound is stronger than that derived from the requirem ent that m onopoles do not a ect nucleosynthesis. The next bound one can derive is based on the requirem ent that the galactic magnetic eld not be dissipated through acceleration of monopoles from the time of galaxy form ation [44]. Strictly speaking this bound applies only to the monopole abundance in galaxies. The original Parker bound is $n_{m on} = s < 10^{24}$. This was argued to be too strong; when the depletion of monopoles, as they get accelerated and ejected from the galaxy, is taken into account [45], the bound becom es $n_{m \ on} = s \ < \ 10^{\ 20}$. A stronger bound was found using the fact that a grand uni ed m onopole catalyzes nucleon decay [46], when captured by a neutron star; the bound is $n_{m on} = s < 10^{30}$ [47]. A more stringent bound can be derived based on m onopole capture and consequent catalytic nucleon decays in the main sequence stars [43]: $n_{m on} = s < 10^{36}$. The atness of the potential is not expected to alter this bound because the strong interaction cross section for the monopole is independent of its radius [46, 48].

In order to nd out whether there is a monopole problem, we ought to com pare the above bounds with the am ount of m onopoles that form at the phase transition. Since we need a second epoch of therm al in ation (to dilute the GUT Higgs particles), a signi cant fraction of the energy density had better therm alize im m ediately after the GUT Higgs phase transition, $(m M)^{1=2}$ leading to a temperature T_{GUT} 10°GeV. (Here m 10 to 10³ GeV is the mass of a typical GUT Higgs particle with a at potential, and М 10^{6} GeV is the vev of a typical GUT Higgs eld.) This is much bigger than the tem perature T m just before therm alization, but it is still far below the tem perature T M which one would obtain after therm alization with a non-at potential. In the case of a non-at potential the tem perature is high enough to initially annihilate the monopoles, so that when annihilation ceases there is of order one monopole per horizon volum e irrespective of the initial abundance. For a at potential this is not the case, and we have to consider the initial abundance.

A lower limit on it is provided by the causality bound which states that on average about p ' 1=8 m onopoles form per causality volume V_c '

(4 = 3)H³, where H¹ is the causality radius. The probability p' 1=8 can be obtained from an argument based on the K ibble mechanism : the eld is uncorrelated on superhorizon scales, and the probability that the random ly oriented eld in di erent correlation volumes will cover more than half of the vacuum manifold is about p = 1=8. This bound gives an initial monopole density n_{mon} ' (3=4) pH³, corresponding to

We have used for the entropy density s' $g^{1=4} \operatorname{_{conv}^{3=4}}(m_0 M)^{3=2}$; here M denotes the GUT Higgs vev, m_0 the curvature of the potential at the origin and $_{conv}$ is the fraction of the energy in the eld that decays and therm alizes. The numerical estimate in (31) is obtained by setting m_0 $10^3 GeV$, and M $10^{6} GeV$.

To obtain an actual estim ate, remember that we have argued that the Universe undergoes a strong supercooling and the phase transition is strongly rst order proceeding via bubble nucleation. An estimate of the typical bubble size at collisions will allow us to estimate monopole production. Since each bubble nucleates with a random phase at the vacuum manifold, when four bubbles collide a monopole (or an antim onopole) form s with the probability p 1=8. The only missing information is now the typical bubble size when they collide. A typical bubble nucleates at the temperature T_{nucl} ' $2m_0$, as specified by (27) and Eq. (28). The typical bubble size can be obtained from Eq. (16) as follows. The integral in the exponent is dominated by bubbles of size

Hence, the typical bubble, when it collides, is about 1/20th of the horizon size 1=H. This means that we have an estimate for monopole production which is about 20^3 10⁴ times above the causality bound in Eq. (31):

A coording to this estimate the dilution factor provided by the second bout of thermal in ation is ample.

In the discussion so far we have supposed that the monopoles are isolated, but in many cases they are connected by cosm ic strings [49, 43]. If this is the case then strong elective forces will be induced by connecting monopoles and antimonopoles with strings which will cause elecient annihilation all the way to the horizon scales, establishing a scaling solution. (In this respect the cosm ology of the strings connecting monopoles resembles the cosm ology of global monopoles discussed below. This does not mean that monopoles connected with strings may a lect structure formation, as it is in the case of global monopoles discussed below, since the ordering eld dynamics of global monopoles is very dilerent than that of the magnetic monopoles. In these models, if any cosm ologically interesting elects exist, they would be produced by the strings.) On scales larger than the horizon causality prevents annihilation. Nevertheless, this annihilation mechanism will suice to keep the monopole density at the level of a few per horizon at all times and hence solve the monopole problem [49, 43].

On the assumption that there is no monopole problem, let us proceed to a discussion of cosm ic strings.

5.2 Cosm ic strings

Cosm ic strings form in the case when the vacuum manifold M of the broken theory contains non-shrinkable loops so that $_1$ (M) \in I. In other words (using som e hom otopy theory), they form if a sem isim ple grand uni ed group G breaks down to a group H which is not connected, i.e. $_0$ (H) \in I. (R ecall that connectedness of a group is not changed by supersymmetry.) Since the symmetry groups of low energy theories are often connected, cosm ic strings are a less generic feature than m onopoles, but they do occur for som e choices of the GUT gauge group [42]. (A s an example, SO (10) m ay break down to the Standard M odel enhanced by an additional matter parity Z₂, which is, of course, not connected.)

On scales below the horizon, the cosm ic string network has a 'scaling' con guration which is more or less independent of its previous history. As a

result, the cosm obgy of the strings will not be signi cantly a ected by the ten or so e-folds of in ation taking place after their form ation. Instead, it will depend mainly on the string mass per unit length . As is well known, the strings are candidates for the origin of both the cmb anisotropy and large scale structure, with some value $(10^{6} \text{ G eV})^{2}$. If this turns out to be the case then will be determined, and in any event one already has an upper bound on . In contrast with the more commonly considered model of a sm ooth, G aussian prim ordial perturbation, the cosm ic string prediction has yet to be accurately calculated over a wide range of scales, but as a guide we may take the prediction for the low multipoles of the cmb anisotropy. Here it is known [50, 51, 52] ' 2 $(10^{6} \text{ G eV})^{2}$, with an uncertainty of perhaps a factor 2 either way.¹⁰ If the e ect is observed and is due solely to strings, one will therefore deduce a value of somewhere in the range

W hat do these results for tell us about the scale of GUT symmetry breaking, as de ned by the vev M? W ith a non-at potential of the form Eq. (29) it is known [51] that ' M^2 . U sing this result, an observed signal in the cmb anisotropy will in ply a value

W e want to know how much this estimate is changed by the atness of the potential, and in contrast with the case of the monopole mass the question is

non-trivial because does not tend to a nite limit as the potential becomes atter and atter.

W e work with the same toy model that we considered earlier, namely the case of a U (1) gauge symmetry and a potential of the form (6) with n = 2 (⁸ coupling). The Lagrangian density of the atom coupled to the U (1) gauge eld is




Figure 1: as a function of

In the usual case, with 1 and the quartic coupling, the integral is close to one (it can actually be shown that it is one when = 1) and the mass scale of the string is given by the vacuum vev [54, 55]. One expects a similar result here, but our coupling is much smaller than usual with 10^{27} . It is not very dicult to estimate the energy per unit length and the prole of these static vortices numerically. Figure 1 shows the results thus obtained for a large range of values of the parameter for both the quartic and ⁸ cases. The energy decreases logarithm ically with small and so the very small coupling changes the value of by only a small factor of two orders of m agnitude. The difference between the two types of potential is also seen to be small (around 20% for 1) and getting smaller with decreasing .

that when is very small, becomes rather insensitive to the value of , with a value (0.09 0.14) M² (to be compared with the value ' M² for a non-at potential with 1). This estimate applies in a rather large range of the coupling 10^{20} 10^{35} . It follows that an observed signal in the cmb, corresponding to the range de ned by Eq. (34), will correspond to

For a given GUT theory, the scale M_{GUT} at which the three Standard M odelcouplings unify is determined by their values measured at low energies.

In simple GUT models, M_{GUT} is found to be around 2 10^{6} GeV, and with a single Higgs eld one would have gM ' M_{GUT} where g is the gauge coupling at the unication point. This coupling in turn is typically given by $g^2=(4)$ 1=25, corresponding to g 1, so that with a single Higgs eld one would have M ' M_{GUT} . However, in a realistic model there will be more than one GUT Higgs eld and all of the analysis in this subsection will require modication.

Taking into account the present uncertainties, the GUT unit cation scale required to make strings a candidate for the origin of large scale structure is consistent with the one deduced from low-energy data, both for a at and for a non- at potential. In particular, the upper limit on the unit cation scale deduced from the onb anisotropy be no bigger than that observed by COBE is consistent for both forms of the potential. On the other hand, it is clear that in the future one or other form of the potentialm ight be preferred, since we have seen (Fig. 1) that the ratio $=M^2$ is significantly different for the two cases.

5.3 G lobal sym m etry defects

A lthough a GUT is initially constructed to satisfy a gauge sym m etry, global sym m etries could occur accidentally and be spontaneously broken by elds with vevs at the same scale 10^{6} GeV. G lobal sym m etries, notably the Peccei-Quinn U (1) sym m etry have also been proposed at lower energies. In addition to the possibilities of m onopoles and strings, there are now the possibilities of dom ain walls and textures. W e discuss textures rst.

5.3.1 Textures

It is known that textures with a vev M 10^{6} G eV can signi cantly a ect the cm b anisotropy and large scale structure [56]. A gain, the central question we want to answer is whether the atness of the potential alters this situation. A s with strings, the con guration approaches a scaling solution so the only thing we have to worry about is the energy of the textures for a given vev M . The scaling solution for textures is characterized by continuous texture form ation on the horizon scales and their subsequent collapse, as governed by the scalar eld ordering dynam ics.

It turns out that the relevant m ass scale is not a ected by the atness of the potential. We will now argue that this is indeed so. The size of the does not matter as long as it is large enough to con ne self-coupling to the vacuum given by j j = M. Since we are interested in the epoch relevant for structure form ation, the relevant scale is T_{dec} leV, which is much below any scale in the microscopic theory. Indeed the 'atness scale' is given by the curvature of the potential at its m in imum $m = V^{(0)} (M)^{1-2}$ $1 \text{ TeV} >> T_{dec}$. A more rigorous argument can be constructed by m o looking at the evolution equation for textures in an expanding Universe. This equation has an e ective self-coupling re-scaled as eff $(a(T)=a_{0})^{2}$ [57], where a is the scale factor of the Universe. At T Idea, the ratio $a(T_{dec})=a_0 ' T_{GUT}=T_{dec}$ is so big that eff $(m_0=T_{dec})^2 >> 1$ is still very large. This means that the e ective coupling for all practical purposes is large and the eld is con ned to j j = M. This implies that the non-linear -m odel [57] is a very accurate description of the texture dynam ics, even for

at potentials. Norm alising to the 10° scales reported by COBE, and using the cosm ological parameters = 1; = 0 and h = 0.5 the result m ay be read o from [52]: M ' 1.4 10^{16} GeV.

A possible realization of a texture model within grand unied theories is proposed in [58] in which the GUT of the form $G = SU(3)_{fam}$ (where $SU(3)_{fam}$ is an additional global fam ily symmetry) has been considered. A supersymmetric GUT group with a at Higgs potential may have a similar form. The fam ily symmetry $SU(3)_{fam}$ breaks with the GUT, so it is plausible to assume that the texture potential is also at.

5.3.2 G lobal m onopoles and dom ain walls

The dynam ics of global eld ordering with SO (3) symmetry (globalm on opoles) can be studied using sim ilar num erical techniques as developed for textures [52]. A loo the ordering dynam ics can be to a good approxim ation represented by a non-linear -m odel [60], [52]. They eventually reach a scaling solution in which in onopoles' form on the scales of the horizon and then collapse to $1=m_0$. Since the interactions between monopoles the core size given by are strong and long range, there will be a strong tendency for monopoleantim onopole annihilation which will keep the number of monopoles (antimonopoles) at the level of order one per horizon at any time. In that respect, the monopole dynam ics resembles the dynam ics of textures, with an in portant di erence of an occasional monopole { antimonopole annihilation event, which will tend to imprint a strong non-Gaussian signal on the ombr. Recalling the assumptions made in their calculation concerning the values of the cosm obgical parameters we have read o from [52] that global m onopoles have an observable signature on large scale structure and/or the om banisotropy for som e vev of order M ' 1 10^{6}GeV .

For walls we can m ake a simple estimate based on the energy per unit area of the wall: $P_{R}^{R} dz [(d = dz)^{2} = 2 + V(z)]$. Making the simple substitutions d=dz 1=1, dz 1, V(z) $P_{V_{0}}^{V}$ ($m_{0}M$)², we have $M^{2}=1+V_{0}$, which is extremized when 1 $M = V_{0}^{P}$ ($m_{0}M$)², we have $M^{2}=1+V_{0}$, which is about M^{3} ($m_{0}=M$), where m_{0} 10 GeV. Compared with the usual case one sees that walls are much fatter, but less massive. However, the

reduction in mass is far too small to allow them to be cosm ologically viable. Instead they had better either not form or disappear harm lessly, which is quite possible since the discrete symmetry leading to their appearance will probably be slightly broken if it is not a gauge symmetry [14].

6 Conclusion

The topics discussed in this paper relate to a considerable body of ongoing research at the moment, whose common theme is the form of the elective potential in the early universe, and the consequent cosm obgical elects of the scalar elds. Some of this research continues to address the traditional, and still very important, question of how to implement an early era of ordinary (slow-roll) in ation. Here we have focussed instead on aspects of them al in ation', which occurs if at all after ordinary in ation and lasts for only a few e-folds.

The elds which can give rise to therm alin ation are 'aton' elds. By de nition, these elds have 'at' potentials and 'large' vevs, where these terms refer to therm ass scale 10^2 to 10^3 GeV. They arise naturally in currently favoured extensions of the Standard M odel, along with the opposite case of elds with 'at' potentials but zero vevs.

A aton eld gives rise to them al in ation if it is trapped at the origin by virtue of the nite temperature correction to its elective potential, after the them al contribution to the energy density has become comparatively small. A coording to a calculation made a decade ago by Yam amoto, this trapping is expected to occur for a at potential (provided that the aton eld is indeed in the vicinity of the origin), with them al in ation ending only when the local minimum of the elective potential at the origin almost completely disappears. Part of our objective was to investigate carefully the rather delicate assumptions needed to arrive at this conclusion, using som elmodern perspectives particularly on the tunneling rate out of the false vacuum. Happily, we con im the conclusion.

The actual cosm ology of aton elds, which determ ines whether a given aton eld will actually nd itself in the vicinity of the origin so that therm al in ation can take place, is at present a rather rapidly moving research area. We have not attempted any new advance here, contenting ourselves with a brief snapshot of the situation as it stands at present. Instead we have addressed a question which has received relatively little attention, which is the nature and cosm ology of topological defects forming at the end of therm al in ation. One would expect a priori that their cosm ology might be signi cantly a ected by the atness of the potential. The answer to this question turns out to depend on the type of defect.

A particular focus for the second part of our investigation has been the possibility that there is a GUT, whose Higgs elds have a at potential. This possibility is quite natural, and it leads to a cosm ology very di erent from the usually considered case of a non-at Higgs potential. GUT symmetry breaking, if it occurs, will be preceded by an era of therm al in ation. The Higgs particles produced at the transition are cosm ologically dangerous because they are light and long-lived, and to dilute them one needs a second era of therm al in ation. This period of therm al in ation will also dilute the monopole abundance su ciently, but will not eliminate cosm ic strings because it lasts only a few e-folds. A simple picture of a string network evolution in an in ationary Universe is as follows. First as the Universe expands the strings will quickly reach the density of about one (long) string per horizon volum e. A fler that the network freezes out since there exists no causal process that could incite nontrivial dynam ics. This means that from then on the average correlation length grows exponentially as the expansion rate, i.e. as (t) = (t) $e^{H(t t_0)}$. This tem perature is far above the relevant scale for onset of an br an isotropies and structure form ation, keeping the strings cosm ologically interesting.

W ith all this in m ind, we expect that cosm obgical relevance of cosm ic strings is specified solely by the mass per unit length of strings. We nd that the GUT Higgs vev needed for the strings to give an observable signature in the cm b anisotropy is a few times bigger than in the case of a non-at potential, but still compatible with the typical estimate ' 2 10^{6} GeV of the scale at which the Standard M odel gauge couplings become unied. Perhaps the main message is that the atness of the potential has surprisingly little e ect on the string cosm ology.

W e also discuss global defects, and in particular focus on the case of global textures and monopoles. We arrive to a rather surprising conclusion that global texture and monopole dynamics is not a ected at all by the atness of the potential. This has a simple explanation: the potential is simply not at enough! The 'atness scale' m $_{0}$ 10°G eV is large in comparison to the scale relevant for cosm oboy: T 1eV, so the at potential su ces to con ne late textures to the vacuum manifold. This leaves both textures and global monopoles as a viable candidate for structure formation with the scales of 10^6GeV symmetry breaking given by M 1:4 10⁶GeV and M 1 respectively. Finally in passing we give an argument that domain walls are still a problem .

In sum mary, the study of elds with at potentials and large vevs is becoming another eld on which particle physics increasingly meets cosmology. Our hope is that either cosmology will put constraints on particle physics models, or particle physics will o er som e interesting cosmological phenom – ena, at best tell us som ething about the origin of structures in the Universe. Since this area of research is developing very fast, it is very likely that in near future one will be able to make more de nite statem ents about the form ation and nature of defects in theories with at potentials, and hence make a more de nite prediction on their cosmological relevance.
