Numerical Approach to CP-V iolating D irac Equation

Abstract

We propose a new method to evaluate the chiral charge ux, which is converted into baryon number in the framework of the charge transport scenario of electroweak baryogenesis. By the new method, one can calculate the ux in the background of any type of bubble wall with any desired accuracy.

1 Introduction

In the scenario of electroweak baryogenesis[1], the chiral charge ux, which is converted to baryon number by the sphaleron process, is one ofkey ingredients. That is supposed to be generated by twom echanisms, both of which depend on the interaction of the ferm ions with the CP-violating background of the bubble wall created at the electroweak phase transition (EW PT). One of the mechanisms is the charge transport scenario, which is quantum mechanical and electric for thin walls, the other is the spontaneous baryogenesis, which is classical and electric for thick walls.

As for the charge transport scenario, the ux is determ ined by the di erence in the re ection coe cients of the left- and right-handed ferm ions, as well as by that in the distribution functions in the broken and the symm etric phases divided by the bubble wall. The rejection coe cients are calculated by solving the D irac equation in the background of the bubble wall, which is accompanied spatially varying CP violation. Cohen, et al.[] rst evaluated the ux by solving the D irac equation num erically, assuming the kinktype pro le for the modulus of the Higgs eld and a function linear in the kink for the phase. On the other hand, we formulated a perturbative method applicable for small CP-violating phase and proved various relations among the relation and transmission coe cients [3, 4]. A lthough it enables us to derive analytical relations, it can actually be applied only to the case in which the unperturbed D irac equation is exactly solved and the CP-violating phase is su ciently small. However the pro le of the bubble wall should be determ ined by the dynam ics of the EW PT.We pointed out, by solving the equations of m otion for the gauge Higgs system, that the CP-violating phase can be of O (1) even if that is small in the broken phase at T = 0, according to the parameters in the e ective potential[5]. For a larger CP-violating phase, we naively expect larger baryon number to be generated. So we need a method to evaluate the chiral charge ux for arbitrary prole of the bubble wall.

In [2], the one-dimensional D irac equation is solved within a nite range $[0;z_0]$ including the bubble wall, imposing the boundary condition in which plane waves are injected at the boundary. Strictly, a plane wave is not an eigenfunction at any nite z, so that the choice of the range will a ect the precision of the results. In this paper, we propose another procedure to solve the D irac equation and to calculate the re ection and transm ission coe cients. A lthough the method is numerical, its precision can be so controlled that one can obtain the results with any accuracy. In section 2, we write down the CP-violating D irac equation and give the expressions of the re ection and transm ission coe cients of the chiral fermions. The procedure of the numerical analysis is given in section 3, and it is applied to some proles, including those which we found in [5] and

that in [2] for comparison, in section 4. The nal section is devoted to summary and discussions.

2 CP-V iolating D irac Equation

2.1 The D irac equation

We consider a ferm ion in the background of a complex scalar, to which it couples by a Yukawa coupling. For the scalar to have a nontrivial complex vacuum expectation value (VEV), we assume it is a part of an extended H iggs sector of the electroweak theory, such as M SSM or more general two-H iggs-doublet m odel. At the electroweak phase transition, the H iggs changes its VEV from zero to nonzero value near the bubble wall created if the phase transition is rst order.

Then the D irac equation describing such a ferm ion is

where $P_R = \frac{1+5}{2}$, $P_L = \frac{1-5}{2}$ and m(x) = fh(x)i is a complex-valued function of spacetime. Here f is the Yukawa coupling. When the radius of the bubble is macroscopic and the bubble is static ormoving with a constant velocity, we can regard m(x) as a static function of only one spatial coordinate:

In our work on the perturbative treatment of CP violation, we used the eigenspinor of 3° , since unperturbative part of the D irac equation contains only 3° . Here we shall use the chiral representation of the -m atrices as in [2]. So the expression of the D irac equation is the same as that in [2], but we write it for self-containedness.

The asymptotic forms of these currents will be used to calculate the transmission and relection coecients.

2.2 Extraction of the oscillating factor

Here, for de niteness, we consider a scattering state in which the incident wave is coming from the symmetric phase region (x 1) so that there is only the transmitted wave (right moving) in the broken phase (x +1). This boundary condition is expressed as

where $=i^{p}\frac{2}{2}$ and a denote the spinor index. Our aim is to nd out the coe cients of the right and left m overs in the symmetric phase region of this state, from which we can evaluate the chiral transmission and rejection coe cients.

For this purpose, we num erically integrate the D irac equation starting from the plane wave in the deep broken phase, x = +1. However it is rather di cult to implement this situation num erically, since preparing the plane wave at x = 1 is impossible, while it is the eigenstate only there. One may think that an appropriate change of the variable which brings x = +1 to some nite coordinate makes the wave function rapidly oscillate near the boundary of the region. To remedy this, we factorize the oscillating part of the wave function.

Before performing the factorization, let us remove the e ect of CP violation in the broken phase by a unitary transformation of the two-spinor. Introducing a unitary matrix

2.3 Re ection and transm ission coe cients

Strictly speaking, these are not independent of x at any nite x. However, we shall use these expressions to calculate the transmission and relection coelected for so large x that they stay almost constant.

Equipped with these coe cients, we are ready to evaluate the transmission and rejection coe cients.

3 Num erical Analysis

To realize the boundary condition (2.22) at x = 1 on a computer, we change the variable of in nite range to another of half-in nite range. For de niteness, we take the following new variable

This transforms $\frac{d}{dx}$? $y\frac{d}{dy}$ so that it brings the singularity at y = 0 into the D irac equation. As we show below, the right-hand sides of (2.23) and (2.24) well behave to cancel such singularity.

which has no real solution > 0. Therefore to avoid any singularity in the right-hand sides, we are left with two possibilities:

In these cases, the lowest order equations determ ine a_0 and b_0 in terms of f_0 and/or g_0 . Needless to say, the same argument also applies to the remaining components of the D irac equation.

Thus the D irac equations in terms of y are free from any singularity, so that they can be num erically integrated by use of a standard algorithm such as the Runge-Kutta method. Now we summarize our procedure to calculate the chiral rejection coecients:

- 1. P repare the potential f (y) and g (y). These would be determined by the model we choose through the equations of motion.
- 2. Integrate the D irac equation

starting from the boundary condition $_{a}(y = 0) = 1$ to large y with a step y. W ithin each step, one can control the precision by choosing su ciently smallmeshes or using quality control algorithm which automatically divides the mesh until the desired precision is reached.

- 3. At the end of each step, evaluate the relection and transmission coe cients.
- 4. Proceed to larger y, until the relative error in the coe cients com es to be smaller than the prescribed precision.

We shall see how this program works in the next section.

4 Examples

Here we take the following potentials to illustrate the calculation of the chiral rejection coecients. The chiral charge ux can be obtained by the procedure outlined in [4] integrating the rejection coecients multiplied by the statistical distribution functions of the ferm ions.

In the charge transport scenario, the generated baryon number density is given by [2]

where N is the model-dependent factor of O (1), g is the radiation degrees of freedom at T_c and is of O (100), $\frac{4}{W}$ is the sphaleron transition rate in the symmetric phase and is of O (10⁶) and u is the wall velocity. stands for the transport time, which is given by the average time the rejected ferm ion spends in the plasma before caught up with the bubble wall. It is expected to be of O (10) O (1000) times the thermal correlation lengths, depending on the wall velocity, if the forward scattering is enhanced. In the original scenario, the weak hypercharge was taken as the chiral charge injected into the symmetric phase. In the following, we mean by the chiral charge ux the dimensionless quantity normalized as

Now we take = . To show how the program in the previous section works, we calculated the rejection and transmission coe cients of the left-handed ferm ion for = 1 and = 12. The result is listed in Table 1 for inst severally. The column unitarity'

means the sum of the two columns left to it. This shows that to get the precision of four digits, it is su cient to integrate the equations up to y = 100, which is amount to $x = \ln 100'$ 4:6052 and is regarded far from the bubble wall. In this case, one can obtain the same data of $R = R_{R!L} - R_{L!R}$ as a function of (;) as shown in Fig. 2 of [2].

For = 0.001, we con med that our numerical method yields the same R as that obtained by the perturbative method in [4]. For = 1, which is equivalent to the prole "#

up to the unitary transformation (2.14), we calculated R by the numerical method developed here. The chiral charge uxes for various mass and wall width are depicted in

Fig.1.

case (ii)

In this case, $_0 = 1$ and the maximum of g(x) is about 0:4, which is comparable with f(x) at the same x. So we did not evaluated the chiral charge ux in [5], using our perturbative method [4]. This prole, which is a solution to the equations of motion to the gauge-H iggs system with the kink-type (x), indicates that (x) is no longer proportional to the kink when $_0$ is 0 (1). This should be compared with the prole (4.4), which satis es the same boundary conditions. We performed the numerical calculation of the chiral charge ux, which is given in Fig. 2. This shows that this prole slightly enhances the ux over the prole employed in [2] by about a factor of 2. The former is about 80% larger near the peak, and decreases more slow ly for large mass or thick wall than the latter. case (iii)

A lthough the maximum of (x) reaches 0:37, the potential f (x) has a kink-like shape and g(x) is su ciently sm all as shown in Fig. 4 of [5]. We expected that the perturbative method is applicable to this case and evaluated the chiral charge ux, depicted in Fig. 5 of [5]. To con m this, we calculated R for several (;). One of the results is given in Fig. 3 for = 0.4 and $m_0 = 1$. This shows that the perturbative method was a good approximation in this case.

5 D iscussions

We proposed a numerical method to solve the scattering problem of the Dirac equation in the background of any CP-violating bubble wall. By use of it, one can evaluate the relection coecients of chiral fermions to any precision. This will be a powerful tool to analyze electroweak baryogenesis based on the charge transport scenario.

W hether the charge transport or the spontaneous mechanism is elective will be determ ined by the dynamics of the EW PT. Recent study of the standard model at nite tem perature[6] suggests that the inst order nature of the EW PT is stronger than that expected from the one-loop calculation of the elective potential. Even though election electroweak baryogenesis requires some extension of the Higgs sector to incorporate spatially varying CP phase, this fact would mean that the bubble wallwould be thinner than naively expected from the lowest order elective potential, so that the charge transport scenario would play a crucial role in baryogenesis.

The profess of the bubble wall which we took in this paper have the kink-type (x). In fact, they should be determined by the dynamics, and we have shown that the modulus of the Higgs could be distorted from the kink, when (x) is not small for the choice of the elective potential which has a kink-type (x) for = 0[7]. For such a prole, we can evaluate the ux precisely, by taking su ciently smalla.




