# $N$ um erical A pproach to $C P-V$ iolating $D$ irac Equation

#### Abstract

W epropose a new $m$ ethod to evaluate the chiralcharge ux, which is converted into baryon num ber in the fram ew ork of the charge transport scenario of electrow eak baryogenesis. By the new method, one can calculate the ux in the badkground of any type of bubble wallw ith any desired accuracy.

## 1 Introduction

In the scenario of electrow eak baryogenesis [i] 1 ], the chiral charge ux, which is converted to baryon num ber by the sphaleron process, is one ofkey ingredients. That is supposed to be generated by tw o $m$ echanism $s$, both ofwhich depend on the interaction of the ferm ions w ith the CP-violating background of the bubble wall created at the electrow eak phase transition (EW PT). O ne of the mechanism $s$ is the charge transport scenario, which is quantum $m$ echanicalande ective forthin walls, the other is the spontaneousbaryogenesis, which is classical and e ective for thick walls.

As for the charge transport soenario, the ux is determ ined by the di erence in the re ection coe cients of the left-and right-handed ferm ions, as well as by that in the distribution functions in the broken and the sym $m$ etric phases divided by the bubble wall. The re ection coe cients are calculated by solving the D irac equation in the background of the bubble wall, which is accom panied spatially varying CP violation. C ohen, et al līn] rst evaluated the ux by solving the D irac equation num erically, assum ing the kinktype pro le for the $m$ odulus of the $H$ iggs eld and a function linear in the kink for the phase. On the other hand, we form ulated a perturbative $m$ ethod applicable for $s m$ all CP-violating phase and proved various relations am ong the re ection and transm ission coe cients applied only to the case in which the unperturbed D irac equation is exactly solved and the CP -violating phase is su ciently sm all. H ow ever the pro le of the bubble wall should be determ ined by the dynam ics of the EW PT.W e pointed out, by solving the equations ofm otion for the gauge H iggs system, that the CP-violating phase can be ofo (1) even if that is sm all in the broken phase at $T=0$, according to the param eters in the e ective potential[్-1_1. For a larger CP -violating phase, we naively expect larger baryon num ber to be generated. So we need a m ethod to evaluate the chiralcharge ux for arbitrary pro le of the bubble wall.

In $[\underset{2}{2}]$, the one-dim ensionald irac equation is solved w thin a nite range $\left[0 ; z_{0}\right]$ inchuding the bubble wall, im posing the boundary condition in which plane waves are in jected at the boundary. Strictly, a plane wave is not an eigenfunction at any nite $z$, so that the choice of the range will a ect the precision of the results. In this paper, we propose another procedure to solve the D irac equation and to calculate the re ection and transm ission coe cients. A though the $m$ ethod is num erical, its precision can be so controlled that one can obtain the results w ith any accuracy. In section 2 , we w rite dow $n$ the
 coe cients of the chiral ferm ions. The procedure of the num erical analysis is given in

that in $\overline{\operatorname{Bin}}$ ] for com parison, in section 4. The nal section is devoted to sum $m$ ary and discussions.

## $2 \quad \mathrm{CP}-\mathrm{V}$ iolating D irac Equation

### 2.1 T he D irac equation

W e consider a ferm ion in the background of a com plex scalar, to which it couples by a Yukaw a coupling. For the scalar to have a nontrivial com plex vacuum expectation value (VEV), we assum e it is a part of an extended H iggs sector of the electrow eak theory, such asM SSM orm ore general tw of iggs-doublet m odel. At the electrow eak phase transition, the $H$ iggs changes its VEV from zero to nonzero value near the bubble wall created if the phase transition is rst order.
$T$ hen the $D$ irac equation describing such a ferm ion is

W hen the radius of the bubble is $m$ acroscopic and the bubble is static orm oving with a constant velocity, we can regard $m$ ( $x$ ) as a static function of only one spatial coordinate:

In our work on the perturbative treatm ent ofCP violation, we used the eigenspinor of ${ }^{3}$, since unperturbative part of the D irac equation contains only ${ }^{3}$. H ere we shall use the chiral representation of the $m$ atrices as in " is the sam e as that in [ī그, but we w rite it for self-containedness.

### 2.2 Extraction of the oscillating factor

H ere, for de niteness, we consider a scattering state in which the incident wave is com ing from the sym $m$ etric phase region ( $\mathrm{x} \quad 1$ ) so that there is only the transm itted wave (right $m$ oving) in the broken phase ( $\mathrm{x}+1$ ). This boundary condition is expressed as

where $=i^{p} \overline{{ }^{2}}$ and a denote the spinor index. O ur aim is to nd out the coe cients of the right and left $m$ overs in the sym $m$ etric phase region of this state, from which we can evaluate the chiral transm ission and re ection coe cients.

For this punpose, we num erically integrate the D irac equation starting from the plane wave in the deep broken phase, $\mathrm{x}=+1$. H ow ever it is rather di cult to im plem ent this situation num erically, since preparing the plane wave at $x=1$ is im possible, while it is the eigenstate only there. O ne $m$ ay think that an appropriate change of the variable which brings $x=+1$ to some nite coordinate $m$ akes the $w$ ave function rapidly oscillate near the boundary of the region. To rem edy this, we factorize the oscillating part of the wave function.

Before perform ing the factorization, let us rem ove the e ect of CP violation in the broken phase by a unitary transform ation of the two-spinor. Introducing a unitary $m$ atrix

## 3 N um erical A nalysis

To realize the boundary condition $\overline{2} \overline{2}$ ) at $x=1$ on a com puter, we change the variable of in nite range to another of half-in nite range. For de niteness, we take the follow ing new variable

Thus the $D$ irac equations in term $s$ of $y$ are free from any singularity, so that they can be num erically integrated by use of a standard algorithm such as the R unge-K utta $m$ ethod. $N$ ow we sum $m$ arize our procedure to calculate the chiral re ection coe cients:

starting from the boundary condition $a(y=0)=1$ to large $y w i t h a$ step $y$. W ithin each step, one can control the precision by choosing su ciently sm allm eshes or using quality control algorithm which autom atically divides the $m$ esh until the desired precision is reached.

[^1]3. At the end of each step, evaluate the re ection and transm ission coe cients.
4. P roceed to larger $y$, until the relative error in the coe cients com es to be sm aller than the prescribed precision.

W e shall see how this program works in the next section.

## 4 Exam ples

H ere we take the follow ing potentials to illustrate the calculation of the chiral re ection coe cients. The chiral charge ux can be obtained by the procedure outlined in [4] integrating the re ection coe cients $m$ ultiplied by the statistical distribution functions of the ferm ions.

In the original scenario, the weak hypercharge was taken as the chiral charge in jected into the sym $m$ etric phase. In this case， $0=1$ and the $m$ axim um of $g(x)$ is about $0: 4$ ，which is com parable $w$ th $f(x)$ at the sam ex．So we did not evaluated the chiralcharge ux in［⿶凵Wi］，using our perturbative $m$ ethod $\lfloor\overline{\overline{1}}]$ ．This pro $l e$ ，which is a solution to the equations ofm otion to the gauge $H$ iggs system w ith the kink－type $(x)$ ，indicates that $(x)$ is no longer proportional to the kink when 0 is $O$（1）．This should be com pared w th the pro le（ $\overline{4} . \bar{A}_{1}$ ），which satis es the sam e boundary conditions．W e perform ed the num erical caloulation of the chiral charge ux， which is given in Fig．2．This show s that this pro le slightly enhances the ux over the pro le em ployed in $\bar{Z}]$ by about a factor of 2 ．The form er is about $80 \%$ larger near the peak，and decreases $m$ ore slow ly for large $m$ ass or thidk wall than the latter． case（iii）
A though the maxim um of $(x)$ reaches $0: 37$ ，the potentialf $(x)$ has a kink－like shape and $g(x)$ is su ciently sm all as shown in F ig． 4 of $[\mathrm{F}] . \mathrm{W}$ e expected that the perturbative $m$ ethod is applicable to this case and evaluated the chiral charge ux，depicted in Fig． 5 of 集．To con $m$ this，we calculated $R$ for several（ ；）．O ne of the results is given in $F$ ig． 3 for $=0: 4$ and $m_{0}=1$ ．This show $s$ that the pertunbative $m$ ethod was a good approxim ation in this case．

## 5 D iscussions

W e proposed a num ericalm ethod to solve the scattering problem of the $D$ irac equation in the badkground of any CP－violating bubble wall．By use of it，one can evaluate the re ection coe cients of chiral ferm ions to any precision．This will be a powerfiul tool to analyze electrow eak baryogenesis based on the charge transport scenario．

W hether the charge transport or the spontaneous $m$ echanism is e ective $w$ ill be de－ term ined by the dynam ics of the EW PT．Recent study of the standard model at nite tem perature［ $[\bar{\sigma}]$ suggests that the rst order nature of the EW PT is stronger than that expected from the one－loop calculation of the e ective potential．Even though e cient electrow eak baryogenesis requires som e extension of the $H$ iggs sector to incorporate spa－ tially varying CP phase，this fact would $m$ ean that the bubble w all w ould be thinner than naively expected from the low est order e ective potential，so that the charge transport scenario would play a crucial role in baryogenesis．

The pro les of the bubble wall which we took in this paper have the kink－type（x）． In fact，they should be determ ined by the dynam ics，and we have show $n$ that the m odulus of the H iggs could be distorted from the kink，when（ x ）is not sm all for the choige of
the e ective potentialwhich has a kink-type $(x)$ for $=00_{[ }^{1}[\bar{i}]$. For such a pro $l e$, we can evaluate the ux precisely, by taking su ciently sm alla.
