

M eson loops in the N am bu-Jona-Lasinio m odel

A bstract

The e ects ofm eson loops in the vacuum sector of the Nam bu {Jona-Lasinio m odel are calculated. U sing the e ective action form alism we take consistently all next-to-leading-order $\frac{1}{N_{\,\mathrm{C}}}$ terms into account. This leads to a sym m etry-conserving approach, in which all features of spontaneously broken chiral sym m etry, such as the G oldstone theorem , the G oldberger{T reim an and the G ell-M ann {O akes{R enner relations are preserved.C ontributions to $h\bar{q}qi$ and F are calculated, and are shown to be substantial, at the level of 30%, consistent with the $\frac{1}{N_{\,\mathrm{C}}}$ expansion. The leading nonanalytic terms in the chiral expansion of $h\bar{q}qi$, F and m have the same form as the one-loop results of chiral perturbation theory.

1 Introduction

Over the last few years the Nambu{Jona-Lasinio model [1] has been used extensively to study numerous features of strong-interaction physics at low energies (for recent reviews on mesons see [2{4], and on baryons see [5,6]). The four-ferm ion point interaction leads to dynamical chiral symmetry breaking which plays a key role for the description of low-energy hadron phenomena. An attractive feature of the model is that having a small number of free

parameters it allows for a unied description of mesons and baryons, with both two and three evors. The resulting hadron spectroscopy has been quite successful: the basic mass relations, the electromagnetic form factors and the electromagnetic polarizabilities are reproduced reasonably well.

A llthe above applications have been performed in the one-quark-loop approximation. The electric action, the meson and quark self-energies, vertex functions, etc., are all generated by a quark-loop. This approximation is justified by the large-N climit, where meson loops are $\frac{1}{N_c}$ -suppressed. However, meson loops cannot always be neglected since in the realworld N c = 3. More importantly, the pions are very light, and in many situations pionic elects, although formally $\frac{1}{N_c}$ -suppressed, are enhanced because of the low pion mass. For example, pionic thermal excitations described by meson loops are dominating in hadronic systems at nite temperature. Meson loops are also required for the proper description of heavier mesons. For example, the or the mesons can split into two pions and this electric again described by pionic loops [7,8].

There have been a number of attempts [9{12] to include meson loops in the Nambu{Jona-Lasinio model. These approaches are based on $\frac{1}{N_0}$ expansion in term s of Feynm an graphs. The sym m etry properties of the system , however, can be easily violated by an inappropriate choice of diagram s. This is the case of Refs. [9{11] where basic symmetry relations, such as e.g. the Goldstone theorem, are violated. The reason for this is that the equation determining the expectation value of the eld and expressions for the meson propagators are not consistent. We show that in order to guarantee the validity of the Goldstone theorem on the basis of a consistent $\frac{1}{N}$ expansion it is crucial to determ ine both the expectation value of the eld and the meson propagators consistently, e.g. using the e ective action including one-meson-loop contributions. M any-body m ethods which preserve the sym m etry properties of the theory are called symmetry-conserving approximations [13,14]. The approach of Ref. [12] is up to our know ledge the only one which preserves the Goldstone theorem at the one meson-loop level. This is achieved by a judicious choice of Feynm an diagram s.

In this paper we extend consistently the N am bu {Jona-Lasinio m odel to next-to-leading order in $\frac{1}{N_{\,\mathrm{C}}}$ which includes the meson-loop contributions. We use the elective action form alism which leads in a natural way to a sym metry conserving approximation. Our approach identies the Feynman diagrams which need to be included to maintain the sym metry properties, at any level of approximation. In our calculation the pion remains massless in the chiral limit and the basic relations following from Ward-Takahashi identities, such as the Gell-Mann {Oaks{Renner relation and the Goldberger-Treiman relation are satised. Furthermore, the leading nonanalytic terms in the chiral expansion of hopi, Fand mand have the correct form, as given by chiral perturbation theory at the one-loop level [15].

We calculate numerically the contributions of meson loops to hopi and F , and nd them to be substantial, of the order of 30%. This is consistent with the N $_{\rm c}\text{-}\text{counting}$ scheme.

The outline of the paper is as follows: In Sec. 2 we recall the model, establish the basic notation and review the formalism of the elective action. We

then proceed to evaluate the e ective action at the quark-loop level (Sec. 3) and at the meson-loop level (Sec. 4), and derive expressions for the quark condensate (Sec. 5), the meson propagators (Sec. 6), and and the pion decay constant (Sec. 7) at the one-meson-loop level. In Sec. 8 we verify explicitly that our expressions have the correct chiral expansion. Section Sec. 9 presents our numerical results. Appendices contain technical details of our calculation.

2 The e ective action

We use the simplest version of the SU (2) Nambu (Jona-Lasinio model [1] with scalar and pseudoscalar couplings only. The Lagrangian of the model is given by

where the point-like four-quark interaction is characterized by the coupling constant $1=a^2$ with the dimension of inverse energy squared, q stands for up and down quarks with N_c = 3 colors, and m is the current quark mass. The partition function of the system is given by the path integral

The integration is over the G rassmann variables q^y and q, and I $(q^y;q)$ is the Euclidean action

The partially bosonized version of the model [16] is obtained by introducing auxiliary meson elds:

The quark elds, which appear in the exponent of Eq. (4) in a quadratic form, can be integrated out, and the partition function becomes

where $\stackrel{R}{\text{D}}$ $\stackrel{R}{\text{D}}$ SDP. The so called bosonized Euclidean action I () is given by

where we use the Dirac operator in the form

with the one-particle Dirac Hamiltonian h given by

The trace in Eq. (7) involves an integration over space-time variables and a matrix trace over the spin and avor degrees of freedom . The trace over color gives a factor N $_{\rm c}$ which we write explicitly. Recalling that the quark propagator in the background meson elds is given by D 1 , we refer to the term N $_{\rm c}{\rm Tr}\ln{\rm D}$ as to the quark-loop contribution .

For sim plicity we use the following notation throughout the paper: the indices a; b; ::: contain the eld isospin indices; ; ::: and the space-time coordinates $x_a; x_b; :::$, i.e. a f; $x_a g$, b f; $x_b g$, etc. Sum m ation/integration over repeated indices is understood.

Generally, the quark-loop contribution N $_{\rm c}$ Tr ln D can have an imaginary part which is related to the anomalous terms. In the case of SU (2) with scalar and pseudoscalarm esons this imaginary part vanishes identically and the one-quark-loop contribution is given by the real part: N $_{\rm c}$ Tr ln D = $\frac{1}{2}$ N $_{\rm c}$ Tr ln (D $^{\rm y}$ D) such that the Euclidean action can also be written in the form

The bosonized action I() is a functional of the elds (x). The elective action in the one-meson-loop approximation is given by [17,18]:

The e ective action (12) has the following properties [18,14]:

At the stationary point of the action, the values of the elds $_{\rm a}$ represent the ground-state expectation values of the eld operators.

The inverse eld propagators L^1 are equal to the second order derivatives of the elective action:

calculated at the stationary point. The same result can be deduced by a resum mation of Feynman graphs, in terms of quark propagators which are dressed by a general static potential [14,19]. We refer to the action I(), which is leading order in N_c, as the one-quark-loop approximation, and to the exctive action (12), including both the leading and next to leading order term $\frac{1}{2} \text{Tr ln} \frac{^2 \text{I}()}{^2}$, as the one-meson-loop approximation. We emphasize that in our approach they are both symmetry conserving approximations.

M ost applications of the N am bu Jona-Lasinio m odelso far, have neglected the contribution of the second term (the m eson loop contribution) to the action (12). The purpose of this paper is to include this contribution in the description of the vacuum and the pion properties.

3 The regularized e ective action in the one-quark-loop approximation

We rst consider the one-quark-loop approximation, in which the second term of the elective action (10) is neglected. In this approximation

The e ective action (14) is ultraviolet divergent and requires regularization. To this aim a ferm ion-loop cut-o $_{\rm f}$ is introduced. Since the model is non-renormalizable, the cut-o $_{\rm f}$ is kept nite and treated as a parameter.

In this paper we use two regularization schemes, namely the proper-time regularization and the covariant four-momentum 0 (4) regularization, as used in Ref. [20]. We will compare results obtained with these schemes. The proper-time regularized elective action is given by

In the O (4) regularization, the four-momentum running in the quark loop is limited by kj < f as explained in App.B 2. In the following we will always use the regularized action and skip the index. The action (15) has a translationally invariant stationary point at f (M);0;0;0)

The stationary point M $_0$ is identified with the vacuum expectation value of the S eld in the one quark-loop approximation. Inserting the regularized elective action (15) into Eq. (16) we get the following equation for M $_0$:

where the function g is de ned in App.B.E quation (17) is commonly referred to as the gap equation since it determines the energy gap 2M $_{\rm 0}$ between the negative- and positive-energy quark states. Obviously, M $_{\rm 0}$ plays the role of thge constituentm ass of the quark.

In the one-quark-loop approximation, the inverse meson propagators (13) are given by the second variation of the action with respect to the elds, taken at the stationary point $(M_0;0;0;0)$:

In m om entum space the inverse m eson propagators are given by [20]

where the function f describing a quark loop with two meson couplings is given in App.B. Since we are evaluating the propagator at the stationary point (M $_0$;0;0;0), we can use the gap equation (17) in order to simplify this expression and obtain the pseudoscalar and scalar inverse meson propagators in the form

where m and m are the on-shell pion and \neg m eson masses. In the chiral lim it (m ! 0), the pseudoscalar mesons are massless Goldstone bosons, as expected. The physical quark-meson coupling constant g $_{qq}$ is given by the residue at the pole of the pion propagator

To end this section we recall the N $_{\rm c}$ -counting rules for quark and m eson loops in the N am bu {Jona-Lasinio m odel. From the gap equation (17) it follows that the coupling constant $\frac{1}{a^2}$ m ust be considered proportional to $\frac{1}{N_{\rm c}}$. Each quark-loop contributes a factor of N $_{\rm c}$, which comes from the trace over color degrees of freedom. Thus, the action I () is of order N $_{\rm c}$. The meson propagators contain a quark-loop in the denominator and are hence of order $\frac{1}{N_{\rm c}}$, as can be seen directly from Eq. (19). From Eq. (25) we not that the physical pion-quark coupling constant g $_{\rm qq}$ is of order N $_{\rm c}$. The physical pion eld (= P = g $_{\rm qq}$) is obtained by rescaling the meson eld P. The propagator for the physical pioneld has the form K ($_{\rm q}$)= $_{\rm qq}$, which is of order N $_{\rm c}$. For each quark {physical pion vertex we have a factor of g $_{\rm qq}$ N $_{\rm c}$. A nalogous relations hold for the sigma eld. This way, N $_{\rm c}$ -counting rules in the N JL model agree with those of Q C D [21,22].

4 The regularized e ective action including the meson-loop contribution

In this section we include the meson-loop contribution to the e ective potential, which is the second term of the expression (12). This leads to corrections which are next-to-leading order in N $_{\rm c}$. We now consider the e ective action in the form (12)

Evaluating the meson-loop term, $\frac{1}{2} \text{Tr ln K}^{1}$ (), we encounter new divergences which arise due to the integration over the momentum in the mesonloop. Let us analyze the meson-loop momentum integrals from a form alpoint of view. In our model, which has only quark dynamical degrees of freedom, the meson propagator at the leading No-level is given by a chain of quarkloops. We have regularized the quark-loop contribution introducing a ferm ionic cut-o param eter f. This regularization, however, does not restrict the fourm om enta of the mesons. Using the asymptotics of the function f at high m om enta it can be easily shown that the leading order eld propagator has the asym ptotic expansion K 1 (q 2) a^2+0 $\frac{1}{q^2}$: Thus, integrating over the meson-loop four-momentum in (26) we encounter a quartic divergence. Sim ilarly, calculating the pion propagator at the one-meson-loop level we will obtain both quadratically and logarithm ically divergent term s. W e regularize the meson-loop integrals introducing a new bosonic cut-o parameter b.We use a covariant O (4) regularization for the meson loop, consisting in cutting o the meson four-momenta in the loop integrals at $Q^2 = \frac{2}{b}$. This is the sim plest possible choice.

The one-m eson-loop e ective action (26) has a translationally invariant stationary point = (M;0;0;0) given by the equation

The stationary point of the one-meson-loop e ective action—is denoted by M , in order to distinguish it from the stationary point M $_{\rm 0}$ of the quark-loop action de ned in Eq. (16).

We note that M does not correspond to the pole of the quark propagator at the one-meson-loop level \mid it is not the quark mass. It is only the local (Hartree) contribution to the quark propagator mass. The quantity M is the expectation value of the S eld when meson-loop e ects included. We may rewrite Eq. (28) in the form

where we have introduced the following short-hand notation for the n-leg quark-loop meson vertices




Fig. 1.D iagram atic representation of Eq. (31): (a) the quark-loop contribution, (b) the meson-loop contribution. The cross denotes the constant term a^2 (1 m = M). The short external lines denote the scalar-isoscalar coupling, the solid line in (a) denotes the (regularized) quark propagator, the dashed line in (b) denotes them eson propagator R denote in Eq. 33, and the led blob denotes the meson vertex S $_{0bc}$, explicitly given in App.A.

For a = 1;2;3, the condition (29) is trivially satis ed with a vanishing pion eld. From the variation over the sigm a eld we obtain

We represent Eq. (31) digram atically in Fig. 1. The set two terms where present at the quark-loop level. The cross is the contact term contribution to S_0 (M), and (a) denotes the quark-loop contribution. The term (b) is the meson-loop contribution. The meaning of symbols is explained in the caption. Using the N_c-counting rules (see Section 3) it can be verified that the meson-loop diagram (b) is of order N_c^0 and hence suppressed by one power in $\frac{1}{N_c}$ compared to the quark-loop diagram, which is of order N_c. The leading-order meson propagators in Eq. (31) K $_{\rm loc}$ (M) are evaluated at the stationary point of the one-meson-loop elective action, M. In momentum space, similarly to Eq. (19), we obtain

Since (M) is exactly equal to the rst term $S_0(M)$ in Eq. (31) we have

which shows that (M) is one order in N $_{\rm c}$ suppressed compared to the full propagators (32) which are of order N $_{\rm c}$. Inserting the decomposition (32) into Eq. (31) we obtain

The third term in this expansion is of order $\frac{1}{N_c}$ and hence one order in N_c suppressed compared to the meson-loop contribution (the second term). Further terms are suppressed by even higher powers of N_c . At the present level of approximation we should therefore keep only the rst two terms in Eq. (36) otherwise consistency in N_c -counting is lost.

The explicit form of Eq. (36) used in numerical calculations has the form

5 Quark condensate

The quark condensate hopi is given by hopi = () = m which from Eq. (26) in mediately gives

C om paring the result (38) with the corresponding expression at the one-quark-loop level, hqqi = a^2 (M $_0$ m), we can see that it is analogous, with M $_0$ replaced by M . We shall compare our theoretical results to the empirical value [23]




Fig. 2. D iagram s contributing to the inverse meson propagator in one-meson-loop approximation: (a) quark-loop contribution, (b(c) meson-loop contributions. The dashed line denotes the meson propagator $\bar{\mathbb{R}}$, and the led quark-loop meson vertices are defined in App. A.

6 M eson propagators

The inverse meson propagators, including the one-meson-loop eects, are equal to the second order variation (13) of the eective action (26) with respect to the elds taken at the stationary point M:

Perform ing the variation in (40) we can express the propagators in one-meson-loop approximation in terms of the functional K (27) and the quark-loop meson vertices (30):

The diagram m atic representation of this equation is shown in Fig. 2. The rst term is the leading-order (quark-loop) contribution K 1 (M). We have to bare in m ind, however, that here it diers from the inverse propagator K 1 (M $_0$) in the one-quark-loop approximation, because it is evaluated at the new stationary point M of the one-meson-loop elective action. This means that the quark propagators appearing in the meson propagator K (M) are dressed by solving Eq.(36). The second (b) and third term (c) are the one-meson-loop contributions to the inverse meson propagator. The dashed lines in the loops correspond to a pion or to a sigma meson. The one-meson-loop contributions are suppressed one order in N $_{\rm C}$, which can be easily shown using the N $_{\rm C}$ -counting rules.

In Eq. (41) M is the solution of the Eq. (36), in which only the rst two terms are retained, so as to be consistent with N_c —counting. It is crucial to maintain

the same N $_{\rm c}$ -counting consistency in the calculation of the meson propagators (41). We include in the inverse propagator L 1 contributions which are of order N $_{\rm c}$ and N $_{\rm c}^{\,0}$. In the rst term K 1 , which is de ned in Eq. (32), we keep both the contributions $^{\,0}{\rm K}$, of order N $_{\rm c}$, and the contribution (M), of order N $_{\rm c}^{\,0}$. In the remaining (meson-loop) terms of Eq. (41), the vertices S are of order N $_{\rm c}$ (because they contain a quark loop) and the leading order of the K operators is N $_{\rm c}^{\,1}$. Therefore N $_{\rm c}$ -counting consistency requires the substitution of K with $^{\,0}{\rm K}$ in the two meson-loop terms. K exping all terms to order N $_{\rm c}^{\,0}$ we obtain the inverse meson propagators in the form

where the propagators \Re ab in the meson loops are given by (33).

Despite the simple form (42) of inverse meson propagators, their numerical evaluation for an arbitrary momentum is quite involved. It requires integration over the meson-loop four momentum Q, over the momenta in the quark-loops as well as over the proper-time (or Feynman) parameters. Even after taking some of the integrals analytically we still end up with many-dimensional integrals that must be evaluated numerically. However, we are rst of all interested in pionic properties. Since the pion is very light, we can determ ine the pion mass and the pion-quark coupling constant from the low-momentum expansion of the pion propagator. This leads to a radical simplication of the numerical calculation. The inverse pion propagator in momentum space can be expanded in the form

Both the constant term , L 1 (0), and the q^2 -term , Z (0), can be expressed as a sum of three contributions corresponding to the diagram s in Fig. 2.

We will now check that the pion remains massless when the $\frac{1}{N_c}$ meson-loop corrections are taken into account. It is crucial for the proof that the expectation value of the Seld, M, is determined from the stationary-point condition for the exctive action. We note that at the one-meson-loop level the stationary point of the exctive action and the quark self energy do not coincide. In the approaches of Refs. [9{11}] where the gap equation at the one-meson-loop level includes the quark self-energy diagram the Goldstone theorem does not hold. It does hold in the work of Ref. [12], where the quark self-energy diagram has been replaced by a tadpole diagram. Thus contributions of the same order in N_c as the calculated meson-loop correction have been excluded in order to full lithe Goldstone theorem. The retained tadpole diagram is exactly the one obtained by dressing the quark propagator by a general static potential and hence in the approach of Ref. [12] one can recognize a symmetry conserving approximation [14].

In order to check the validity of the Goldstone theorem we have to evaluate the leading-order term $L^{\,1}$ (0) in the low-m omentum expansion of the inverse pion propagator. We write the inverse pion propagator at zero momentum as a sum of the contributions of the three diagrams in Fig. 2, in which we have now couplings with zero external pion momentum. This leads to a signicant simplication in the evaluation of the diagrams. The algebra is straightforward but tedious, and we refer the reader to Ref. [24] for details. The result is

Using Eq. (37) in (44) we obtain im mediately

which is analogous to the one-quark-loop result with M $_0$ replaced with M $_0$. In the chiral limit (m = 0) we have L 1 (0) = 0, showing that the pions are massless. Thus, as expected, the Goldstone theorem is satisfied in the one meson-loop approximation. This is a general feature. If we derive both the gap equation and the meson propagators by performing functional derivatives of the elective action, we have a symmetry-conserving approximation. The Goldstone pion relects this.

For non-vanishing quark current mass m the chiral symmetry is explicitly broken and the pion acquires a nite mass. It is given by the position of the pole of the pion propagator. Using the inverse pion propagator we obtain

Since m is very small we can approximate Z (m^2) by its value at zero momentum. Then we can calculate the pion mass in one meson-loop approximation using the results for the low-momentum expansion of the pion propagator




Fig. 3. The routing ambiguity in the meson-loop contributions of Fig. 2, diagram (b), to the inverse pion propagator.

The pion-quark coupling constant can be determined on the one-meson-loop level similarly to (24) as the residue of the pion propagator at its pole

In order to evaluate m and g_{qq} we need, in addition to M which we obtain by solving Eq. (36), the wave-function renormalization Z (0). The steps in this calculation are as follows: We expand various contributions of Fig. 2 in powers of the external m om entum q and isolate the coe cient of q^2 . The m om entum in loops is cut by the mesonic cut-o b. In the case of diagram (b) we have, for this cut-o prescription, an ambiguity in routing the momentum in the loop, as shown in Fig. 3. Depending on the value of the routing parameter , we get dierent numerical results. In this paper we average with equal weights over all from 0 to 1. This prescription is arbitrary, and one could use another one, e.g. choose $=\frac{1}{2}$. As we will see, the choice of routing does not a ect fundam ental properties, such as GMOR relation, or the form of the leading nonanalytic terms in the chiral expansion (see Sec. 8). 0 by iously, it does a ect the num erical value of m and F to som e extent. The algebra and nal expressions for Z (0) are lengthy, and the reader is referred to Ref. [24] for details.

7 The pion decay constant

The pion decay constant is an important quantity in our calculations, since we use its empirical value in order to $\,$ x the parameters of the model. Its evaluation allows us also to check explicitly the Goldberger-Treim an relation for the quarks, which gives the connection between M , the pion-quark cou-

pling constant in the chiral \lim it. The Gell-M ann {O akes{R enner relation then follows straightforwardly.

The pion decay constant F is de ned by the matrix element for the weak pion decay

where $A=q_5=2q$ is the axial current and is the physical pion eld= $P=g_{qq}$. Applying the Lehm ann-Sym anzik-Zimm erm ann reduction form ulawe can relate the pion decay constant $F=F(m^2)$ to the form factor $F(q^2)$, which can be expressed in terms of the expectation value of the time-ordered product

To evaluate this matrix element we couple an external axial source j in the elective action, which gives for the Dirac operator (cf. Eq. (8))

Inserting this operator in the action we obtain the generating functional in the presence of the source j for the external axial eld. Then the matrix element (52) can be expressed as a variation of the generating functional

The rhs of this equation has the same structure as the one-meson-loop pion propagator (40) with one derivative with respect to the meson eld replaced by a derivative with respect to the axial source. Hence, in the one-meson-loop approximation, we obtain contributions to the pion decay constant from diagrams analogous to those contributing to the inverse meson propagators (Fig. 2), but with one of the external meson couplings replaced by an axial coupling.

We calculate F from the low-momentum expansion as we did for the one meson-loop pion propagator, with the same routing prescription. The dierence is that now we pick up the terms linear in the external momentum q. A lso, due to the axial coupling, we obtain dierent spin-isospin structure of the quark-loop functions. The calculation is straightforward but tedious, and details are in Ref. [24]. The nalresult is

In the chiral lim it this reduces to the Goldberger-Treim an relation [25] for the quarks

Using this result and the expressions for the pion mass (48) and the quark condensate (38) at the one-meson-loop level we recover also the Gell-Mann {Oakes {Renner relation [26]:

We have shown that in our elective action approach the Goldstone theorem, the Goldberger-Treim an, and the Gell-Mann {Oakes{Renner relations are valid with the meson loops included. Thus the basic relations following from Ward-Takahashi identities are satisfed in the one-meson-loop approximation. Again, this is a feature of a symmetry-conserving approximation.

8 Chiral expansions

In this section we check that the leading nonanalytic terms in chiral expansion of the quark condensate, the pion mass and the pion decay constant agree with the one-loop results of chiral perturbation theory.

In chiral perturbation theory [15] we have

where $h\overline{q}qi_0$ is the value of the quark condensate in the chiral lim it. We wish to show the same result holds in the NJL model with meson loops. Equation (37), which we may write as G (M; m) = 0, de nes M as an implicit function of m. We have therefore

where we have used the identity dg (M) = 2M f (M;0), and the relation (25). For $\frac{e_G}{e_m}$ the only infrared nonanalytic term is the pion-loop term, the last

one in Eq. (37). Close to the pion pole this piece is

where M $_{\rm m\,=\,0}$ is the value of M in the chiral lim it. From the fact that $k\bar{q}qi=a^2$ (M m) we immediately establish the desired result (58). Note, that for m and F in the above expression we use the leading-N $_{\rm c}$ pieces. The subleading pieces to these quantities are relevant in relative 1=N $_{\rm c}^2$ corrections to $k\bar{q}qi$, which is not considered at the present level of approximation.

Chiral perturbation theory also determ ines the leading nonanalytic terms in the expansion of m and F .D enoting the leading-N $_{\rm c}$ values of the pion m ass and decay constant by m $_{,0}$ and F $_{,0}$ (in the notation of Ref. [15] these are M and F $_{,0}$ the tree-level pion m ass and decay constant), we have

In order to check that these expansions hold in our treatment of the NJL model, we rst look at the chiral expansion of Z (0). There are cancellations occurring between the quark and meson loop contributions, and the nalanswer is

The above result is independent of the routing ambiguity of Fig. 3. Using expansions (63) and (66) in Eqs. (48) and (56) we obtain the desired expressions (64-65).

We emphasize that the agreement of the results of this section with chiral perturbation theory is a direct consequence of the symmetry-conserving approximation.

We have also performed a numerical study in order to check how good is expansion (58) in our case. For typical parameters (a = 162M eV, $_{\rm f}$ = $_{\rm b}$ = 755M eV, $_{\rm m}$ = 0) we not that $h\overline{q}qi$ = $(173.8\text{M eV})^3$, and for same parameter but $_{\rm m}$ = 13M eV, which to the pion mass to its physical value, we have $h\overline{q}qi$ = $(175.9\text{M eV})^3$, i.e. a 5% change. In comparison, Eq. (58) would give 8% with the chiral scale under the log taken to be 1G eV. This shows that the leading nonanalytic correction accounts for a major part of the change of the condensate as one departs from the chiral lim it.

9 Numerical results and discussion

At the one-quark-loop level them odel has the following parameters: the quarkquark coupling constant $\frac{1}{a^2}$, the quark cut-o f, and the current quark m ass m.W ith the meson loop included we have in addition the meson cut-o We use the empirical values for the observables in the meson sector, namely $F = 93 \,\mathrm{M} \,\mathrm{eV}$, and $m = 139 \,\mathrm{M} \,\mathrm{eV}$ in order to x the model parameters. A fter tting the pion m ass and decay constant, we are left with two free param eters. We could x one of them by thing the phenomenological value of the quark condensate hopi. The results of our calculation for hopi, however, are quite sensitive to the cut-o procedure. Furtherm ore, the experim ental range for hqqi is very w ide, $(\frac{1}{2}\text{hqqi})^{\frac{3}{\exp}} = 250$ 50 M eV . For these reasons we do not use the value of the quark condensate to x the parameters. Since we do not know the particular physics underlying the regularization of the theory, QCD cannot be a guide to x the loop cut-o s f and b. In this exploratory calculation we display results obtained for four values of the ratio b = f = 0, 0.5, 1, and 1.5. Using the gap equation we elim inate the coupling constant 1=a2 in favor M, which we treat as a free parameter. Thus all quantities are presented as a function of M for di erent values of the ratio b= f.




Fig. 4. The ferm ionic cut-o $_{\rm f}$ for proper-time quark-loop regularization as a function of M for dierent values of $_{\rm b}=_{\rm f}$. The curves correspond to $_{\rm b}=_{\rm f}=0$, 0.5, 1, 1.5.




Fig. 5. The ferm ionic cut-o $_{\rm f}$ for O (4) quark-loop regularization as a function of M for di erent values of $_{\rm b}=_{\rm f}$. The curves correspond to $_{\rm b}=_{\rm f}=$ 0, 0.5, 1, 1.5 . Note that the curve for $_{\rm b}=_{\rm f}=$ 1.5 has the critical $_{\rm f}$ sm aller than for $_{\rm b}=_{\rm f}=$ 1.

We present the calculations performed in the chiral limit (m = 0). Introducing a nonzero current quark mass meads to small corrections to the calculated quantities. Since at this point we are mainly interested in the general behavior of the quark condensate as a function of the model parameters we nd it useful to start by considering the chiral lim it. The quantity M in one-m eson-loop approximation is given by the solution of Eq. (31). We use this equation in order to determ ine the ferm ionic cut-o f for given values of M and b= f.We plot $_{\rm f}$ as a function of M for di event values of the ratio $_{\rm b}=_{\rm f}$ of the bosonic to the ferm ionic cut-o . The results in the chiral $\lim it (m = 0)$ with proper-time and 0 (4) ferm ion-loop regularization are presented in Figs. 4 and 5, respectively. The pion decay constant F is tted to reproduce the experimental value. For b = 0 we recover the results of the one-quark-loop approximation, so that the di erence between the lowest curve and the other curves is a measure of the m eson loop contribution. For $\,_{\mathrm{f}}$ lower than a critical value we do not have spontaneous breaking of the chiral symmetry and Eq. (17) has no solution. With increasing mesonic cut-o b the critical value of fincreases

and the curve $\mbox{'m oves"}$ up until $\mbox{$_b$= $_f$ reaches}$ 1:5 for the proper-time cuto and 1:2 for the 0 (4) one. For larger values of $\mbox{$_b$= $_f$}$ the m inimal value of $\mbox{$_f$}$ starts decreasing and the curve m oves down with increasing $\mbox{$_b$= $_f$}$. This diers from the results of D m itrasinovic at al. [12] with Pauli-V illars ferm ion-loop regularization where the curves keep m oving towards larger values of $\mbox{$_f$}$ as $\mbox{$_b$= $_f$}$ increases (see Fig. 11 in [12]). For large m esonic cut-o s, $\mbox{$_b$= $_f$}$ over 2 for the proper-time ferm ion regularization and $\mbox{$_b$= $_f$}$ over 3 in the 0 (4) case, we do not have solution of Eq. (36) with F tted to the experimental




Fig. 6.The quark condensate $\frac{1}{2}$ hqqi $\frac{1}{3}$ with propertime quark-loop regularization as a function of M for dierent values of $_{b}$ = $_{f}$. The curves correspond to $_{b}$ = $_{f}$ = 0, 0.5, 1, 1.5. The dashed lines mark the empirical bounds.




Fig. 7. The quark condensate $\frac{1}{2}$ hqqi $\frac{1}{3}$ with 0 (4) quark-loop regularization as a function of M for di erent values of $_{b}$ = $_{f}$. The curves correspond to $_{b}$ = $_{f}$ = 0, 0.5, 1.5, 1. The dashed lines m ark the empirical bounds.

value. Calculations in the baryon sector of the Nambu{Jona-Lasinio model with one quark and zero boson loops [27,28] show that best results for baryonic properties are obtained for M in the range 400{500 MeV, i.e. for values of the quark cut-o near the critical value. A lthough this picture may change when meson-loop e ects are included, we note that the value M for the critical value of the quark cut-o changes very little. For $_{\rm b}$ $_{\rm f}$ the ferm ion cut-o increases by about 30% .




Fig. 8. The ratio of the meson-loop to the quark-loop contribution to hpqi as a function of M obtained with proper-time ferm ion-loop regularization. The curves correspond to $_{\rm b}=_{\rm f}=0.5,1,1.5$.

Comparing the results of the two ferm ion-loop regularization procedures we can see that although the critical values of f, below which there is no spontaneous chiral symmetry breaking are quite dierent, the general behavior of M as a function of the ferm ionic and mesonic cut-o s is very similar.

The quark condensate is given in terms of M and the quark-quark coupling constant by Eq. (38). The results in the chiral lim it are shown in Figs. 6 and 7 for the proper-time and 0 (4) ferm ion-loop regularizations. They are plotted as a function of M for the four dierent ratios $_{\rm b}$ = $_{\rm f}$. The empirical value for the quark condensate is obtained in chiral perturbation theory using the value of the quark current m ass (Gell-M ann {Oakes{Renner relation) [29] or from QCD sum -rules. The phenomenological uncertainty (39) is, however, quite wide. With both the proper-time and O (4) cut-o sthere is a plateau for M between 0.3 and 0.6 GeV and the corresponding value of hopi depends little on b= f.The value in the proper-time case (Fig. 6) is underestimated. This problem is known from the one-quark-loop calculations, where better agreement can be obtained using a generalized two-param eter proper-time regularization function. In the case of the O (4) quark-loop regularization (Fig. 7) our results for the quark condensate are in the phenom enological bounds for values of M in the plateau region. This shows that the quark condensate is sensitive to the particular quark-loop regularization procedure, a feature well known from the calculations in the one-quark-loop approximation.

In Fig. 8 we plot the ratio of the meson-loop to the quark-loop contribution to hqqi as a function of M for the proper-time quark-loop regularization. The relative contribution of the meson loop increases with increasing $_{\rm b}=_{\rm f}.$ For values of the parameters in the range 0:3 < M < 0:6 GeV and $_{\rm b}=_{\rm f}<$ 1 we have hqqi_meson=hqqi_quark < 40% , i.e. of the order of $_{\rm N_c}^{1}$ as expected.

Looking at Figs. 6 and 8 we see that as b = f increases the meson-loop con-




Fig. 9.The ratio of them eson-loop to the quark-loop contribution to F as a function of M obtained with proper-time ferm ion-loop regularization. The curves correspond to $_{\rm b}=_{\rm f}=0.5,1,1.5$.

tribution to the quark condensate increases, while the quark-loop contribution decreases. The sum of the contributions remains roughly constant. Eq. (38) shows that the inclusion of the meson-loops does not signicantly change the four-quark coupling constant $\frac{1}{2}$.

Let us now come back to the N $_{\rm c}$ -counting scheme, which we extensively used throughout the meson-loop calculations presented above. We have calculated the meson-loop corrections to the quark condensate, the pion mass and the pion decay constant, showing that they are one order in N $_{\rm c}$ suppressed. However, the expansion in powers of $\frac{1}{\rm N_c}$ should be used with care since N $_{\rm c}=3$. Furthermore, the meson-loop corrections depend on the mesonic cut-o $_{\rm b}$ and are in nite for $_{\rm b}$! 1 . Hence it is important to check how well does the N $_{\rm c}$ -counting scheme work for the particular values of the parameters.

In the previous section we have compared the meson-loop and quark-loop contributions to logi and found that for reasonable values of the param eters the ratio haqi_{m eson}=haqi_{quark} is in the expected range. Here we com pare the mesonand quark-loop contributions to F. Since we have xed the param eters in order to reproduce the experim ental value of the pion decay constant the sum of both contributions gives F $_{\text{quark}}$ + F $_{\text{m eson}}$ = 93 M eV , but their relative contributions depend on the choice of param eters. The meson-loop contribution is negative. In Fig. 9 we show the ratio f meson=F quarkjwith proper-time quark-loop regularization. The relative contribution of the meson-loop grows with increasing M . It is larger for larger values of $_{\rm b}$ = $_{\rm f}$. As we mentioned in the previous section, the empirical value of F can be only reproduced for b= fless than about 2, which sets an upper bound for the meson-loop cut-o. For values of $_{\rm b}$ in this range and M < 0.6 G eV the m eson-loop correction does not exceed 40% of the N $_{\rm c}$ -leading quark-loop term . This is important because it keeps the $\frac{1}{N_c}$ corrections in the expected range. It justi es a posteriori the use of the N_c -counting scheme. The above observations are also

true for the quark condensate (see Fig. 8) as well as for the O (4) ferm ionic regularization. In the case when $_{\rm b}$ ' $_{\rm f}$ and 0:3 < M < 0:6 M eV we nd that the m eson-loop contributions are of the order of $\frac{1}{N_{\rm c}}=\frac{1}{3}$ com pared to the leading-order contributions.

10 Conclusion

We have shown that thee ective action form alism in the Nambu {Jona-Lasinio model leads to a symmetry-conserving approximation, allowing us include consistently meson-loop e ects while preserving the usual properties associated with spontaneous chiral symmetry breaking (the Goldstone theorem, the Gell-Mann {Oaks{Renner relation, the form of the leading nonanalytic terms in the chiral expansion of various quantities). Indeed, meson-loop e ects will destroy these properties unless both the gap equation and meson propagators are treated consistently. This has already been noticed in Ref. [12], where Feynman diagrams were used. In our approach the conservation of the symmetry properties is a natural consequence of the consistent application of the appreciation. We have found that though meson-loop contributions are $\frac{1}{N_{\rm c}}$ suppressed as compared to the leading-order quark-loop contributions they lead to substantial corrections. For the physically reasonable values of the model parameters the elects of meson loops to the pion decay constant and to the quark condensate are of the expected order of 30%.

A Quark-loop meson vertices

In our meson-loop calculations we need the meson vertices which couple different number of mesons (we need up to four) through a quark loop. They are given by the variations of the elective action with respect to the meson elds. To obtain these we ist expand the action in powers of the meson eld uctuations around the stationary point. We perform the expansion for the proper-time regularized elective action. Using the proper-time expressions we can easily obtain the four-momentum regularized expressions as well.

We start from the proper-time regularized elective action

B Regularization functions

Here we calculate the regularization functions for the quark-loop vertices in the diagram s for the gap equation and pion propagator. We start by evaluating the regulators in the proper-time scheme.
