# The D ipole Form alism for the C alculation of Q CD Jet C ross Sections at N ext-to-Leading O rderi:

#### Abstract

In order to $m$ ake quantitative predictions for jet cross sections in perturbative QCD, it is essential to calculate them to next-to-leading accuracy. This has traditionally been an extrem ely laborious process. U sing a new form alism, in aginatively called the dipole form alism, we are able to construct a com pletely general algorithm for next-to-leading order calculations of arbitrary jet quantities in arbitrary processes. In this paper we present the basic ideas behind the algorithm and ilhustrate them with a sim ple exam ple.

## 1 Introduction

M ost of the recent progress in the understanding of strong interaction physics at large m om entum transfer has been due to the com parison between precise experim ental data and very accurate Q CD calculations to higher perturbative orders $[\stackrel{1}{1}]$.

These higher-order com putations have been carried out over a period of about fteen years, often long after the accuracy of experim ental data has $m$ ade them necessary, because of the di culties in setting up a general and straightforw ard calculational procedure. The physical origin of these di culties is in the necessity of factorizing the long- and short-distance com ponents of the scattering processes and is re ected in the perturbative calculation by the presence ofdivergences.

In general, when evaluating higher-order Q CD cross sections, one has to consider realem ission contributions and virtual-loop corrections and one has to dealw th di erent kind of singularities. The custom ary ultraviolet singularities, present in the virtual contributions, are rem oved by renorm alization. The low m om entum (soft) and sm all-angle (collinear) regions instead produce singularities both in the real and in the virtual contributions. In order to handle these divergences, the observable one is interested in has to be properly de ned. It has to be a jet quantity, that is, a hadronic observable that tums out to be infrared safe and either collinear safe or collinear factorizable: its actual value has to be independent of the number of soft and collinear particles in the nal state (see Sect. 'A'A1 for a form al de nition). In the case of jet quantities, the coherent sum over di erent (real and virtual) soft and collinear partonic con gurations in the nal state leads to the cancellation of soft singularities. The left-over collinear singularities are then factorized into the process independent structure and fragm entation functions of partons (parton distributions), leading to predictable scaling violations. A s a result, jet cross sections are nite (calculable) at the partonic level order by order in perturbation theory. A ll the dependence on long-distance physics is either included in the parton distributions or in nonperturbative corrections that are suppressed by inverse powers of the (large) transferred $m$ om entum $Q$ that controls the scattering process.

Because of this pattem of singularities, Q CD calculations of jet cross sections beyond leading order (LO) are very involved. Ow ing to the com plicated phase space for multiparton con gurations, analytic calculations are in practice im possible for all but the sim plest quantities, but the use of num erical $m$ ethods is far from trivial because soft and collinear singularities present in the interm ediate steps have rst to be regularized. This is usually done by analytic continuation to a num ber of space-tim e dim ensions d=4 2 di erent from four, which greatly com plicates the Lorentz algebra in the evaluation of the $m$ atrix elem ents and prevents a straightforw ard im plem entation of num erical integration techniques. D espite these di culties, e cient com putational techniques have been set up, at least to next-to-leading order ( N LO ), during the last few years.

There are, broadly speaking, tw o types of algorithm used for NLO calculations: one based on the phase-space slicing $m$ ethod and the other based on the subtraction $m$ ethod ${ }_{-1}^{\overline{\bar{Y}}}$. Them ain di erence betw een these algorithm s and the standard procedures of analytic calculations is that only a m inim al part of the full calculation is treated analytically, nam ely only those contributions giving rise to the singularities. M oreover, for any given pro-

[^1]cess, these contributions are com puted in a $m$ anner that is independent of the particular jet observable considered. O nce every singular term has been isolated and the cancellation/factorization of divergences achieved, one can perform the rem aining part of the calculation in four space-tim e dim ensions. A though, when possible, one still has the freedom of com pleting the calculation analytically, at this point the use of num erical integration techniques (typically, M onte C arlo m ethods) is certainly m ore convenient. First of all, the num erical approach allows one to calculate any num ber and any type of observable sim ultaneously by sim ply histogram $m$ ing the appropriate quantities, rather than having to m ake a separate analytic calculation for each observable. Furtherm ore, using the num erical approach, it is easy to im plem ent di erent experim ental conditions, for exam ple, detector acceptances and experim ental cuts. In other words, the phase-space slicing and subtraction algorithm s provide the basis for setting up a general-purpose $M$ onte $C$ arlo program for carrying out arbitrary NLO QCD calculations in a given process.

Both the slicing $\left.{ }_{[1-1]}^{-1}\right]$ and the subtraction $\left[\begin{array}{l}{[\overline{4}]}\end{array} \mathrm{m}\right.$ ethods were rst used in the context of NLO calculations of three-jet cross sections in $e^{+} e$ annihilation. Then they have been applied to other cross sections adapting the $m$ ethod each tim e to the particular process. Only recently has it become clear that both algorithm $s$ are generalizable in a processindependent $m$ anner. The key observation is that the singular parts of the Q CD matrix elem ents for real em ission can be singled out in a general way by using the factorization properties of soft and collinear radiation $\left.\underline{\mid T}_{1}\right]$.

At present, a general slicing algorithm is available for calculating N LO cross sections for any number of jets both in lepton $\left[\frac{[\overline{-1}]}{[1}\right.$ and hadron $[\overline{-1}]$ collisions. To our know ledge, fragm entation processes have been considered only in the particular case of direct-photon production $[\underline{\underline{G}}]$. The com plete generalization of this $m$ ethod to include fragm entation functions and heavy avours is still $m$ issing.

A sfor the subtraction algorithm, a generalN LO form alism has been set up for com put-

 in the particular case of heavy-quark correlations in hadron collisions [1]2̄1].

In this paper, we present the basic idea to set up a com pletely general version of the subtraction algorithm. This generality is obtained by fully exploiting the factorization properties of soft and collinear em ission and, thus, deriving new im proved factorization form ulae, called dipole factorization form ulae. They allow us to introduce a set of universal counter-term sthat can be used for any NLO QCD calculation.

For the purpose of illustration, in this short contribution we describe the im plem entation of our general m ethod to the calculation of jet cross sections in processes with no initial state hadrons, typically $e^{+} e$ annihilation. Full details of the $m$ ethod and its application to all the other hard-scattering processes w ill appear elsew here [i]

We rst recall the $m$ ain features of the subtraction $m$ ethod in Section ${ }_{2}^{2}$. Then in Section 'i了- we present our dipole factorization form ulae, for the case in which there are no incom ing QCD partons. These allow us to calculate cross-sections for an arbitrary num ber of jets in $\mathrm{e}^{+} \mathrm{e}$ annihilation, which we do in Section ${ }_{\text {i }}^{2}$. A fter brie y recapping the resulting
 jets. Finally in Section ${ }_{2}{ }_{-1}$, we give a sum $m$ ary and outlook.

## 2 The subtraction procedure

Suppose we want to com pute a jet cross section to N LO , nam ely

$H$ ere the LO cross section ${ }^{\text {LO }}$ is obtained by integrating the exclusive cross section $d{ }^{B}$ in the B om approxim ation over the phase space for the corresponding jet quantily. Suppose also that this LO calculation involves $m$ partons in the nalstate. Thus, we w rite

where, in general, all the quantities (Q CD m atrix elem ents and phase space) are evaluated in $d=42$ space-tim e dim ensions. H ow ever, by de nition, at this LO the phase space integration in Eq. (2) is nite so that the whole calculation can be carried out (analytically or num erically) in four dim ensions.

N ow we go to NLO. W e have to consider the exclusive cross section $d^{R}{ }^{\mathrm{w}}$ th $\mathrm{m}+1$ partons in the nal-state and the one-loop correction $d$ to the process $w$ ith $m$ partons in the nalstate:

The two integrals on the right-hand side of Eq. ( $\overline{-1})$ are separately divergent if $d=4$, although their sum is nite. Therefore, before any num erical calculation can be attem pted, the separate pieces have to be regularized. U sing dim ensional regularization, the divergences (arising out of the integration) are replaced by double (soft and collinear) poles $1={ }^{2}$ and single (soft, collinear or ultraviolet) poles $1=$. Suppose that one has already carried out the renorm alization procedure in $\mathrm{d}^{\mathrm{V}}$ so that all its ultraviolet poles have been rem oved.

The general idea of the subtraction $m$ ethod for $w$ riting a general-purpose $M$ onte C arlole program is to use the identity

where $d^{A}$ is a proper approxim ation of $d^{R}$ such as to have the sam e pointw ise singular behaviour (in d dim ensions) as d ${ }^{R}$ itself. Thus, $d^{A}$ acts as a local counterterm for $d^{R}$ and, introducing the phase space integration,

one can safely perform the lim it ! 0 under the integral sign in the rst term on the right-hand side of Eq. (훈). Hence, this rst term can be integrated num erically in four dim ensions.

A 11 the singularities are now associated to the last tw o term $s$ on the right-hand side of Eq. (디). If one is able to carry out analytically the integration of ${ }^{A}$ over the one-parton subspace leading to the poles, one can combine these poles with those in $d v$, thus cancelling all the divergences, perform ing the lim it ! 0 and carrying out num erically the rem aining integration over the $m$-parton phase space. T he nalstructure of the calculation is as follow s

and can be easily im plem ented in a partonic M onte C arlo' program, which generates appropriately weighted partonic events $w$ ith $m+1$ nal-state partons and events $w$ ith $m$ partons.

The key for the subtraction procedure to work is obviously the actual form ofd ${ }^{A}$. O ne needs to nd an expression for $d^{A}$ that ful ls the follow ing properties: i) for any given process, $d^{A}$ has to be obtained in a way that is independent of the particular jet observable considered; ii) it has to exactly $m$ atch the singularbehaviour ofd ${ }^{R}$ in d dim ensions; iii) its form has to be particularly convenient for $M$ onte $C$ arlo integration techniques; iv) it has to be exactly integrable analytically in d dim ensions over the single-parton subspaces leading to soft and collinear divergences.

In Ref. $\left[\begin{array}{l}\overline{1} 1\end{array}\right]$, a suitable expression for $d^{A}$ for the process $e^{+}$e ! 3 jets was obtained by starting from the explicit expression (in d dim ensions) of the corresponding $d^{R}$ and by perform ing extensive partial fractioning of the $3+1$-parton $m$ atrix elem ents, so that each divergent piece could be extracted. This is an extrem ely laborious and ungeneralizable task, in the sense that having done it for $e^{+} e$ ! 3 jets does not help us to do this for, say, $e^{+} e$ ! 4 jets or for any other process.

In Ref. $[\overline{[ }]$, the general properties of soft and collinear em ission were nst used (in the context of the subtraction $m$ ethod) to construct $d^{A}$, for one-and two-jet production in hadron collisions, in a way that is independent of the detailed form of the corresponding $d^{R}$.

T he central proposal of our version of the subtraction $m$ ethod is that one can give a recipe for constructing $d^{A}$ that is com pletely process independent (and not sim ply independent of the jet observable). Starting from our physical know ledge of how the $m+1$-parton $m$ atrix elem ents behave in the soft and collinear lim its that produce the divergences, we introduce im proved factorization form ulae, called dipole form ulae (see Sect. us to obtain in a straightforw ard way (see Sect. ', (1, in a counter-term $d^{A}$ satisfying all the properties listed above.

## 3 D ipole factorization form ulae

N otation
In general we use dim ensional regularization in $d=4 \quad 2$ space-tim edin ensions and consider d 2 helicity states for gluons and 2 helicity states for $m$ assless quarks. This de nes the usualdim ensional-regularization schem e. O ther dim ensional-regularization prescriptions can be used, as well [1]

The dim ensional-regularization scale, which appears in the calculation of the $m$ atrix elem ents, is denoted by . In the perturbative calculation of physical cross sections, after having com bined the renorm alized $m$ atrix elem ents, the dependence on exactly cancels and is replaced by the dependence on the renorm alization scale ${ }_{R}$. Therefore, in order to avoid a cum bersom e notation, we set $=R$.

Throughout the paper, s stands for $s($ ), the NLO QCD running coupling evaluated at the renom alization scale. The actual value of the QCD coupling s() depends on the renorm alization schem e used to subtract the ultraviolet divergences from the (bare)
one-loop $m$ atrix elem ent (or, equivalently, from $d$ v in Eq. (了़्ऱ)).

The realcontribution $d^{R}$ to the N LO cross section in Eq. (3]i) is proportional to the treelevelm atrix elem ent $M m+1$ for producing $m+1$ partons in the nalstate. $T$ he dependence of $M m+1{ }^{3}$ on the $m$ om entum $p_{j}$ of nal-state parton $j$ is singular in two di erent phasespace regions: when the $m$ om entum $p_{j}$ vanishes (soft region) and/or when it becom es parallel to the $m$ om entum $p_{i}$ of another parton in $M_{m+1}$ (collinear region). This singular behaviour of $\mathrm{M}_{\mathrm{m}+1}{ }^{3}$ is well-known $[\overline{5}, 1 \overline{1} 5 \overline{1}]$ and universal. Indeed, in the soft and collinear lim its, $\mathrm{M}_{\mathrm{m}+1}$ is essentially factorizable w ith respect to $\mathrm{M}_{\mathrm{m}}$, the tree-level am plitude w th $m$ partons, and the singular factor only depends on the $m$ om enta and quantum num bers of the $Q C D$ partons in $M m$.

W e thus introduce the follow ing dipole factorization form ula:

The $m$-parton $m$ atrix elem ent on the right-hand side of Eq . ( $\overline{1} \overline{5})$ is obtained from the original $m+1$-parton $m$ atrix elem ent by replacing a) the partons $i$ and $j w$ ith a single parton 1 j (which plays the role of em itter) and b) the parton $k w$ th the parton $k$ (which plays the role of spectator). A ll of the quantum num bers (colour, avour) except mom enta are assigned as follow. The spectator parton $\hat{k}$ has the sam e quantum num bers as $k$. The quantum numbers of the em itter parton 1 j are obtained according to their conservation in the collinear splitting process 1 j ! i+ j (i.e. bnything + gluon' gives anything' and quark + antiquark' gives ghon').

$T$ he im portance of these kinem atical features is tw ofold. Firstly, $m$ om entum conservation leads to a sm ooth interpolation betw een the soft and collinear lim its, thus avoiding double counting of overlapping soft and collinear singularities. Secondly, the de nition (ī6i) of the dipole $m$ om enta allows us to factorize exactly the $m+1$-parton phase space into an $m$-parton subspace tim es a single-parton contribution (see qs. (了̄3 $\overline{1}, 1, \overline{3} 2 \overline{2}))$. The rst property allows us to construct a counter-term $d^{A}$ that produces a pointw ise cancellation of the singularities of $d^{R}$ as in Eq. ( $\left.{ }^{(-)}\right)$. The second property $m$ akes this counter-term fully integrable analytically over the subspace leading to soft and collinear divergences.

## 4 The calculation of jet cross sections

The dipole form ulae form the basis for our generalalgorithm for NLO jet calculations, as we describe below . First we de ne the leading order cross section and give a form alde nition of the requirem ents a jet de nition $m$ ust fiul 1 . Then we introduce the subtraction term, which cancels allsingularities of the realm atrix elem ent, and show how it can be integrated in $d$ dim ensions to cancel the singularities of the virtualm atrix elem ent.

The function $F_{J}^{(m)}\left(p_{1} ;::: ; p_{m}\right)$ de nes the jet observable in term softhem om enta of them nal-state partons. In general, $\mathrm{F}_{\mathrm{J}} \mathrm{m}$ ay contain -functions (thus, Eq. $\left.{ }_{-1}^{(2)} \overline{3} \overline{-}\right)$ de nes precisely a cross section), -fiunctions (Eq. '( $\overline{2} \overline{2} \overline{3})$ de nes a di erential cross section), num erical and kinem atical factors (Eq. ( $\left.2 \overline{2} \overline{3}_{1}\right)$ refers to an inclusive observable), or any combination of these. The essential property of $\mathrm{F}_{J}{ }^{(m)}$ is that the jet observable we are interested in has to be infrared and collinear safe. That is, it has to be experim entally (theoretically) de ned in such a way that its actual value is independent of the num ber of soft and collinear hadrons (partons) produced in the nal state. In particular, this value has to be the same in a given $m$-parton con guration and in allm + 1-parton con gurations that are kinem atically degenerate $w$ ith it (i.e. which are obtained from the $m$-parton con guration by adding a soff parton or replacing a parton w ith a pair of collinear partons carrying the sam e total m om entum ). These properties can be sim ply restated in a form alway, as follow s

( $2 \overline{2} \overline{9}$ ) via M onte C arlo techniques is straightforw ard. O ne sim ply generates an $m+1-$ parton con guration and gives it a positive ( $+\underset{m}{ } \mathrm{~m}_{\mathrm{i}}$ 予) or negative ( $\mathrm{D}_{\mathrm{ij} ; \mathrm{k}}$ ) weight. The role of the two di erent jet functions $F_{J}^{(m+1)}$ and $F_{J}^{(m)}$ is that of binning these weighted events into di erent bins of the jet observable. A ny tim e that the generated con guration approaches a singular region, these two bins coincide and the cancllation of the large positive and negative weights takes place.
$N$ ote, also, that the helicity dependence of the splitting kemels $V_{i j ; k}$ in Eqs. $\left(\underline{2} \overline{\mathrm{a}} \bar{n}_{2} \overline{2} \overline{1} \overline{1}_{1}\right)$ is essential if $d^{A}$ is to act as a local counterterm that $m$ akes $\left[d^{R} \quad d^{A}\right]$ integrable in four dim ensions. Indeed, the parton azim uthal correlations due to this dependence are not only essential in the $m$ ost general case when $F_{J}$ explicitly depends on them, but even when it does notiri.

H aving discussed the four-dim ensional integrability of ( $d^{R} \quad d^{A}$ ), the only other step we have to consider is the d-dim ensional analytical integrability ofd ${ }^{A}$ over the one-parton subspace leading to soft and collinear divergences. In this respect, our dipole form alism is particularly e cient and simple. The de nition (1 $\overline{1} \overline{)}$ ), of the dipole $m$ om enta allow s us to exactly factorize the phase space of the partons $i_{i} \bar{j} ; k$ into the dipole phase space tim es a single-parton contribution, as follow s

## 5 Final form ulae

The nal results of the application of our algorithm to the calculation of jet cross sections $w$ ith no hadron in the intial state are sum $m$ arized below .

The fullQ CD cross section in Eq. (ī1) contains a LO and a NLO com ponent. A ssum ing that the LO calculation involves $m$ nal-state partons, the LO cross section is given by
$w h e r e ~ M m$ is the tree-level QCD $m$ atrix elem ent for producing $m$ partons in the nal state and the function $F_{J}^{(m)}$ de nes the particular jet observable we are interested in (see Eqs. (2̄4̄信而) for the general properties that $F_{J}^{(m)}$ has to full). The factor d (m) collects all the relevant phase space factors, i.e. all the rem aining term $s$ on the right-hand side of Eq. ( $2 \overline{3} \overline{3}$ ) $)$. The whole calculation (phase space integration and evaluation of the $m$ atrix elem ent) can be carried out in four space-tim e dim ensions.

A coording to the subtraction form ula, Eq. ( $\overline{(\underline{\sigma})}$ ), the NLO cross section is split into two term $\mathrm{s} w$ th $\mathrm{m}+1$-parton and m -parton kinem atics, respectively. The contribution w th $m+1$-parton kinem atics is the follow ing
where the term in the curly bracket is exactly the sam e as that in Eq. ( $\overline{2} \overline{8}): M_{m+1}$ is the tree-levelm atrix elem ent, $\mathrm{D}_{\mathrm{ij} ; \mathrm{k}}$ is the dipole factor in Eq. The rst term in the curly bracket is the one-loop renorm alized $m$ atrix elem ent squared for producing $m$ nal-state partons. The second term is obtained by inserting the colourcharge operator of Eq. ( $\overline{3}_{\bar{\prime}}^{1}$ ) into the tree-level $m$ atrix elem ent for producing $m$ partons as in Eq. ( $\overline{3} \overline{4} \overline{4})$. These two term s have to be rst evaluated in $d=42$ dimensions. Then one has to carry out their expansion in -poles (the expansion for the singular factors $V_{i}()$ is given in Eq. ( $\overline{3} \overline{\mathrm{G}})$ ), cancel analytically (by trivial addition) the poles and perform the lim it ! 0 . At this point the phase-space integration is carried out in four space-tim e dim ensions.

## $6 e^{+} e$ ! 3 jets

In this Section we consider the sim plest non-trivial application of our algorithm, nam ely the calculation of three-jet observables in $e^{+} e$ annihilation. Thus our form alism can be directly com pared w ith that in Ref. [ī].

The LO partonic process to be considered is $e^{+} e!q\left(p_{1}\right)+q\left(p_{2}\right)+g\left(p_{3}\right)$. The corresponding tree-levelm atrix elem ent is denoted by $M_{3}\left(p_{1} ; p_{2} ; p_{3}\right)$. W e use custom ary notation for the kinem atic variables: $Q^{2}$ is the square of the centre-ofm ass energy, $Y_{i j}=2 p_{i} \quad p=Q^{2}$ and $x_{i}=2 p_{i} \quad Q=Q^{2}$.

AtNLO, tw o di erent realem ission subprocesses contribute: a) $e^{+} e \quad!\quad q\left(p_{1}\right)+q\left(p_{2}\right)+$ $\left.g\left(p_{3}\right)+g\left(p_{4}\right) ; b\right) e^{+} e!q\left(p_{1}\right)+q\left(p_{2}\right)+q\left(p_{3}\right)+q\left(p_{4}\right)$. In addition one has to com pute the one-loop correction to the LO process.

To com plete the N LO calculation we also need the virtual cross section. In the case of un-oriented events, we take the one-loop $m$ atrix elem ent in the $\overline{\mathrm{MS}}$ renorm alization schem e

W e have im plem ented these results as a w orking $M$ onte $C$ arlo program $\bar{N}_{1}^{\prime \prime}$ ! and the results are in good agreem ent w th $R$ ef. $\left[\frac{1}{9}\right]$ for all distributions shown there. A $s$ an exam ple we show the NLO coe cients for the thrust and C-param eter distributions in Fig. 1-1 W e nd that in general, the num erical convergence is sim ilar to the program of Ref. $[\underset{1}{9}]$, except close to the two-jet region in which ours becom es progressively better. M ore details of the $M$ onte C arlo program and the generalization to oriented three-jet events w ill be presented elsew here.

## 7 Sum m ary and outlook

In this letter we have presented the basic idea to set up a com pletely generalalgorithm for calculating jet cross sections in N LO Q CD. By generalwem ean that the algorithm applies to any jet observable in a given scattering process as well as to any hard-scattering process. T he algorithm overcom es all the analytical di culties related to the treatm ent of soft and collinear divergences in the perturbative expansion. T he output of the algorithm is given
 w ith built-in cancellation of soft and collinear singularities. T hese e ective $m$ atrix elem ents can be num erically or analytically (w henever possible) integrated over the available phase space to com pute the actual value of the NLO cross section. If the num erical approach is

[^5]chosen, $M$ onte $C$ arlo integration techniques can be easily im plem ented to provide a generalpunpose $M$ onte C arlo program for carrying out N LO Q CD calculations in any given process.

Starting from the very general idea of the subtraction $m$ ethod, we have discussed how one can autom atically construct a pointw ise and integrable counter-tem $d^{A}$ for the real contribution $d^{R}$ to the NLO cross section. This counter-term is independent of the details of the process under study and can be handled once and for all to de ne the e ective $m$ atrix elem ents $m$ entioned above. W e have shown how this procedure works in practice for processes w ith no hadron in the initial state (typically, $e^{+} e$ annihilation) and any number of jets in the nal state. In this case, the nal result is given by the $m$ aster form ulae in Eqs. ( $\left.\overline{4} \overline{1} \bar{i}_{1} \overline{4} \overline{2} \overline{2}\right)$. W e have provided explicit expressions for both the universal dipole factors $D_{i j ; k}$ and I. Having these factors at our disposal, the only other ingredients necessary for the full N LO calculation, are the follow ing
a set of independent colour pro jection level, sum $m$ ed over parton polarizations, in d dim ensions;
the one-loop $m$ atrix elem ent in d dim ensions;
an additional pro jection of the Bom level matrix elem ent over the helicity of each extemalghon in four dim ensions;
the tree-levelN LO m atrix elem ent in four dim ensions.
These few ingredients are su cient forw riting, in a straightforw ard way, a general-purpose N LO M onte C arlo algorithm . N ote in particular that there is no need to extract a proper counter-term $d^{A}$ starting from a cum bersom e expression for $d^{R}$ in d dim ensions. The $N L O$ matrix elem ent contributing to $d^{R}$ can be evaluated directly in four space-time dim ensions thus leading to an extrem e sim pli cation of the Lorentz algebra.

The key point of our $m$ ethod for constructing the counter-term $d^{A}$ is the dipole for$m$ alism described in Sect. 'i.1. . Starting from the universal behaviour of the QCD matrix elem ents in the soft and collinear regions, we have introduced im proved factorization for$m$ ulae based on a dipole structure $w$ th respect to the $m$ om enta, colours and helicities of the QCD partons. O ur dipole form ulae correctly $m$ atch the well-known singularities of the QCD scattering amplitudes in the soft and collinear lim its. M oreover, these lim its are approached sm oothly, thus avoiding double counting of overlapping soft and collinear divergences. This sm ooth transition is possible because our dipole form alism is explicitly Lorentz covariant and the dipole form ulae exactly ful lm om entum conservation.

In the present paper, these $m$ ain features of the dipole form ulae have been used in the context of NLO com putations of jet cross sections with no initial-state hadron. For lepton hadron and hadron hadron collisions, perturbative Q CD calculations face additional di culties related to the factorization of initial-state collinear singularities. Likew ise, to calculate cross sections for processes in which a nal state hadron is identi ed, the equivalent nal-state collinear singularities $m$ ust be dealt $w$ th. In a com panion paper [1] we show that the dipole form alism overcom es these di culties in a simple and general m anner. Thus we can explicitly provide a set of universal counter-term s or, equivalently, e ective (non-singular) m atrix elem ents that can be straightforw ardly used for any NLO QCD calculation.
${ }^{\mathrm{zz}}$ A ctually, if the total num ber of C CD partons involved in the LO m atrix elem ent is less than or equal to three, one sim ply needs its incoherent sum over the colours (see Sect. ' ${ }^{\prime}$ I') .
