P rospect of H iggs physics at future  $e^+e^-$  linear colliders is reviewed for the weakly-coupled H iggs sector. Several topics related to the determ ination of various couplings of the H iggs boson in the standard m odel as well as in the supersym m etric standard m odel are discussed.

# 1 Introduction

It has been more than twenty years since the basic idea of the standard model (SM) of elementary particle theory was proposed. This theory is based on two fundamental principles, i.e. the gauge principle and the Higgs mechanism. From recent experiments it is now clear that strong and electroweak interactions are described by an SU(3) SU(2) U(1) gauge theory. On the other hand, little is known about mechanism of the electroweak symmetry breaking. To clarify dynamics behind this symmetry breaking in the SM is the primary remaining objective and the most important physics motivation of future experiments at both LHC and  $e^+e^-$  linear colliders.

Exploring the Higgs sector is important not only because the Higgs particle is the only ingredient still missing from the SM, but also because this will be a key to the physics beyond the SM. In the minimal SM the Higgs sector consists of one Higgs doublet, and the only free parameter is the Higgs boson mass. A heavy Higgs boson corresponds to a large self-coupling constant, and a light Higgs boson suggests that the dynamics of the Higgs sector is well described perturbatively. For many extensions of the Higgs sector a similar relationship holds between the Higgs-boson mass and the strength of the interaction which governs the symmetry-breaking dynamics. For example, if we require perturbative unication of the three gauge coupling constants as predicted in Grand Unied Theories (GUT), the Higgs particle cannot be heavier than about 200 GeV. On the other hand, models like Technicolor predict either a very heavy scalar particle or no particle at all which acts as the Higgs boson.

In this talk I will discuss the physics of the Higgs sector at future et e linearcollider experim ents with a center-of-mass (CM) energy ranging from 300 GeV to 1.5 TeV. I restrict myself to the \light Higgs case" where at least one Higgs particle exists below, say, 200 GeV, and the dynamics behind this particle is described by perturbation theory. The strategy to study the strongly coupled Higgs sector in future ete linear-collider experiments is quite di erent from that in the light Higgs case, and it is covered elsewhere in this workshop. From intensive discussions, including those reported in the last workshop of this series,  $^{2;3;4}$  it is now clear that the discovery of such a Higgs particle is easy at an ete linear collider with s 300 500 GeV, if it exists with a mass below 200 GeV and with a production cross-section and decay branching ratios similar to the SM Higgs boson. Therefore I would like to stress subjects which become important after the Higgs particle is discovered. In other words, I would like to consider how various couplings related to the Higgs particle will be measured in future et experiments and what the im pact of these measurements will be on the establishment of the SM and the search for physics beyond the SM . M any of the contributions in the H iggs session in this workshop are related to various Higgs couplings.

In this talk I will rst give a short review of the SM Higgs sector and the Higgs sector in the Minimal Supersymmetric Standard Model (MSSM). Also I will comment on Higgs mass and properties for some extended versions of supersymmetric (SUSY) standard models. Then, I will report four topics discussed at this workshop, all of which are related to measurements of various Higgs couplings.

#### 2 The SM Higgs

In the m inim al SM the H iggs-boson m ass (m  $_{\rm h}$ ) and the H iggs-boson self-coupling constant () from the H iggs potential ( $V_{\rm H~iggs}$  = m  $^2$  j j  $^2$  + j j  $^4$ , (m  $^2$  0)) are related by m  $_{\rm h}^2$  = 2  $^2$ , where (= 246 GeV) is the vacuum expectation value. As a result, the theory behaves quite di erently for small and large values of the H iggs-boson m ass. This situation can be most easily understood by evaluating the running self-coupling constant, , using the renormalization group equations (RGE's). Neglecting Yukawa coupling constants except for the one for the top quark,  $y_{\rm t}$ , the RGE for at the one-loop level is written as




Figure 1: The ow of the Higgs self-coupling constant () in the minimal SM for the several values of the Higgs boson masses. The top quark mass is assumed to be  $170 \, \text{GeV}$ .

$$\frac{d}{dt} = \frac{1}{(4)^2} f24^2 + 12y_t^2 \qquad 6y_t^4 \qquad 12A + 6B g; \tag{1}$$

where  $A=\frac{1}{4}g_1^2+\frac{3}{4}g_2^2$ ,  $B=\frac{1}{16}g_1^4+\frac{1}{8}g_1^2g_2^2+\frac{3}{16}g_2^4$  for U (1) and SU (2) gauge coupling constants  $g_1$  and  $g_2$  respectively and  $t=\ln$  ( is the renormalization scale). Since the input values of the gauge coupling constants and the top Yukawa coupling constant at the electroweak scale can be determined from recent experimental results, we can draw the ow of the running self-coupling constant for each value of  $m_h$  as shown in Figure 1.

From this gure it is clear that the possible scenarios for new physics are di erent for two cases, i.e. (i) m  $_{\rm h}$  m  $_{\rm top}$  and (ii) m  $_{\rm h}$  < m  $_{\rm top}$ . In case (i) the coupling constant becomes very large at a relatively low energy scale, and therefore new physics is indicated well below the P lanck scale ('  $10^{19}~{\rm G\,eV}$ ). On the other hand, the theory can be weakly coupled up to approximately the P lanck scale in case (ii), which is consistent with the idea of grand unication. Of course the low of the coupling constants is dierent if we change the particle content in the low-energy theory, but the upper bound on the H iggs m ass is believed to be about 200 G eV for most G U T models. This is also true for the SU SY G U T. As for the M SSM , however, a stronger bound on the H iggs m ass is obtained independently of the assumption of grand unication.

# 3 The Higgs Sector in the M SSM

Supersym m etry is now considered as the most promising candidate for physics beyond the SM . Recent improvements in measurements of the three gauge coupling constants enable us to distinguish various GUT models, and it has become clear that the supersymmetric version is favored.  $^5$  The particle content of the SUSY GUT below the GUT scale is just that of the MSSM .




Figure 2: The upper bound on the lightest CP-even Higgs mass in the MSSM as a function of the top quark mass for various tan and two large stop mass scales. The solid (dashed) line corresponds to m  $_{\rm stop}=1$  (10) TeV without left-right mixing of two stop states. These masses are calculated by the method with the renormalization group equation.

The Higgs sector of the MSSM consists of two Higgs doublets. The most important feature of this Higgs sector is that the Higgs-self-coupling constant at the tree level is completely determined by the SU (2) and U (1) gauge coupling constants. A f-

ter electroweak symmetry breaking, the physical H iggs states include two CP-even H iggs bosons (h; H), one CP-odd H iggs boson (A) and one pair of charged H iggs bosons (H) where we denote by h and H the lighter and heavier H iggs bosons respectively. A lithough at the tree level the upper bound on the lightest CP-even H iggs boson m ass is given by the Z $^0$  m ass, the radiative corrections weaken this bound. The H iggs potential is given by

where V represents the contribution from one-loop diagrams. Since the loop correction due to the top quark and its superpartner, the stop squark, are proportional to the fourth power of the top Yukawa coupling constant and hence are large, the Higgs self-coupling constant is no longer determined only by the gauge coupling constants. The upper bound on the lightest CP-even Higgs mass (m\_h) can significantly increase for a reasonable choice of the top-quark and stop-squark masses. Figure 2 shows the upper bound on m\_h as a function of top-quark mass for several choices of the stop mass and the ratio of two Higgs-boson vacuum expectation values (tan =  $\frac{< H_0^2 >}{< H_0^1 >}$ ). We can see that, in the MSSM, at least one neutral Higgs-boson should exist below 130 -150 GeV depending on the top and stop masses.




Figure 3: The light (h), heavy (H) CP-even Higgs m asses and the charged Higgs (H) mass as a function of the CP-odd Higgs (A) mass. The top and stop masses are taken as m  $_{\rm t}$  = 170 GeV and m  $_{\rm stop}$  = 1 TeV .

O ther H iggs states, namely the H; A; H, are also important to clarify the structure of the model. Their existence alone is proof of new physics beyond the SM, but we may be able to distinguish the MSSM from a general two-H iggs model through the investigation of their masses and couplings. In the MSSM the H iggs sector is described by four independent parameters for which we take the mass of the CP-odd H iggs boson (m\_A), tan; the top-quark mass (m\_t) and the stop mass (m\_stop). The top and stop masses enter through radiative corrections to the H iggs potential. Speaking precisely, there are left-and right-handed stop states which can mix to form two mass eigenstates; therefore more than just one parameter is required to specify the stop sector. In Figure 3, the masses for the H; A, and H are shown as a function of m\_A for several choices of tan and m\_stop=1 TeV. We can see that, in the limit of m\_A! 1, m\_h approaches a constant value which corresponds to the upper bound in Figure 2. Also in this limit the H; A and H become degenerate in mass.

The neutral Higgs-boson couplings to gauge bosons and ferm ions are determined by the ratio of vacuum expectation values tan and the mixing angle of the two CP-even Higgs particles de ned as

For Higgs-boson production, the Higgs-brem sstrahlung process et e ! Zh or ZH and the associated production e<sup>+</sup> e ! Ah or AH play com plim entary roles. Namely e<sup>+</sup> e ! Zh (ZH) is proportional to cos( ) (s<u>i</u>n ( )), and e e ! Ah (AH) is proportional to sin ( )), so at least one of the two processes has a ) (cos( sizable coupling. It is useful to distinguish the following two cases when we discuss the properties of the H iggs particles in the M SSM, namely (i)  $m_A < 150 \text{ GeV}$ , (ii) 150 GeV. In case (i), the two CP-even Higgs bosons can have large mixing, m A and therefore the properties of the neutral Higgs boson can be substantially dierent from those of the minimal SMH iggs. On the other hand, in case (ii), the lightest CPeven Higgs becomes a SM-like Higgs, and the other four states, H; A; H behave as a Higgs doublet orthogonal to the SM -like Higgs doublet. In this region, cos( ) approaches unity and sin ( ) goes to zero so that e<sup>+</sup> e ! Zh and e<sup>+</sup> e ! AH are the dominant production processes. Scenarios for the Higgs physics at a future et e linear collider are di erent for two cases. In case (i) it is possible to discover all H iggs states with  $\frac{r}{s} = 500 \,\text{GeV}$ , and the production cross-section of the lightest Higgs boson may be quite dierent from that of the SM so that it may be clear that the discovered Higgs is not the SM Higgs. On the other hand, in case (ii), only the lightest Higgs may be discovered at the earlier stage of the et experiment, and we have to go to a higher energy machine to nd the heavier Higgs bosons. Also, since the properties of the lightest Higgs boson may be quite similar to those of the SM Higgs boson we need precision experiments on the production and decay of the particle in order to investigate possible deviations from the SM.

4 The Higgs-boson mass and production cross-section in extended versions of the SUSY SM

A lthough the M SSM is the most widely studied model, there are several extensions of the SUSY version of the SM. If we focus on the structure of the H iggs sector, the M SSM is special because the H iggs self-couplings at the tree level are completely determined by the gauge coupling constants. It is therefore in portant to know how the H iggs phenomenology is dierent for models other than the M SSM.

A model with a gauge-singlet H iggs boson is the simplest extension. This model does not destroy the unication of the three gauge coupling constants since the new light particles do not carry the SM quantum numbers. Moreover, we can include a term W = N H  $_1$ H  $_2$  in the superpotential where N is a gauge singlet super eld. Since this term induces  $^2$  H  $_1$ H  $_2$  in the H iggs potential, the tree-level H iggs-boson self-coupling depends on as well as the gauge coupling constants. There is no de nite upper-bound on the lightest CP-even H iggs-boson m ass in this model unless a further assumption on the strength of the coupling is made. If we require all dimensionless coupling constants to remain perturbative up to the GUT




Figure 4: The upper bound on the lightest CP-even Higgs mass in the SUSY SM with a gauge singlet Higgs (the solid line). The stop mass is taken as 1 TeV. The dotted line corresponds to the upper bound in the M SSM case.

scale we can calculate the upper-bound of the lightest CP-even H iggs-boson m ass.  $^{10}$  In F igure 4, the upper bound of the H iggs-boson m ass is shown as a function of the top-quark m ass. In this gure we have taken the stop m ass as 1 TeV and dem anded that no dimensionless coupling constant m ay blow up below the GUT scale (  $10^6$  GeV). We can see that the upper bound is given by 130  $\,$  140 GeV for this choice of the stop m ass. The top-quark-m ass dependence is not signicant compared to the M SSM case because the maximally allowed value of is larger (smaller) for a smaller (larger) top m ass.

From this gure we can see that the lightest Higgs boson is at least kinem atically accessible at an ete linear collider with 300 500 GeV. This does not, however, mean that the lightest Higgs boson is detectable. In this model the lightest Higgs boson is composed of one gauge singlet and two doublets, and if it is singletdominated its couplings to the gauge bosons are signicantly reduced, hence its production cross-section is too small. In such a case the heavier neutral Higgs bosons may be detectable since these bosons have a large enough coupling to gauge bosons. In fact we can put an upper-bound on the mass of the heavier Higgs boson when the lightest one becomes singlet-dominated. By quantitative study of the m asses and the production cross-section of the Higgs bosons in this model, we can show that at least one of the three CP-even Higgs bosons has a large enough !  $Z h_i^{\circ}$  (i = 1;2;3) process to be detected at production cross-section in the e+e 300 500 G eV<sup>11</sup>. For this purpose we de ne the an e e linear collider with S m in imal production cross-section,  $m ext{ in}$ , as a function of  $m ext{ s}$  such that at least one




Figure 5: M in imal production cross section,  $_{m \text{ in}}$ , for the SUSY SM with a gauge singlet H iggs for the top mass m  $_{t}$ = 150 and 180 G eV and m  $_{stop}$ = 1 TeV .

of these three  $h_i^0$  has a larger production cross section than  $m_{in}$  irrespective of the parameters in the H iggs mass matrix. ### 5 A ZZh anom alous coupling at a TeV linear collider

In order to establish the SM and to search for new physics beyond it, it is fundamentally important to investigate whether or not various couplings among gauge bosons and the Higgs boson are described by the SM. For example, the existence of the self-couplings of gauge bosons are an important feature of the non-Abelian nature of the gauge interaction.

If a Higgs boson is discovered at a relatively light mass scale (< 200 GeV), most probably the physics of electroweak symmetry breaking is described by an

interaction whose strength is not very much dierent from that of the electroweak interaction. In such a case the measurement of the couplings involving the light Higgs boson is interesting in order to look for elects from physics beyond the SM. Assuming that somenew physics exists in the multi-TeV region, we can write down the general form of higher dimensional operators which are induced after integrating out the heavy elds.

where the  $f_i$  are dimensionless couplings, and  $\,$  is the new-physics scale. The O  $_i$  are gauge-invariant operators composed of gauge bosons and H iggs doublet elds as well as ferm ion elds.  $^{13}$ 

In this workshop it was pointed out that the production cross-section in the Higgs-brem sstrahlung process,  $e^+e^-$ ! Zh, is sensitive to one anom alous coupling of this type, i.e.  $\frac{f}{2}$  (D) YW (D), for an  $e^+e^-$  linear collider with a center-of-m assenergy over 1 TeV. In the SM in this energy region the dominant Higgs production process is WW fusion process rather than Higgs-brem sstrahlung. However, as long as the new-physics e ect are concerned, the Higgs-brem sstrahlung process is more important. This is because the relevant energy scale of this process is said the anom alous coupling of ZZh becomes large as the energy scale increases while the energy scale relevant to the fusion process is the Higgs mass scale, not so. Thus, in order to look for new-physics e ects, the measurement of the production cross-section in  $e^+e^-$ ! Zh is more important than the process  $e^+e^-$ ! WW! h.

6 Determination of the heavy Higgs mass scale from branching measurements in the M SSM

It is generally accepted that the SM Higgs boson with a mass less than about 200 G eV will be discovered at the rst stage of an e<sup>+</sup> e linear collider experiment where the CM energy is 300 500 GeV. This is su cient to discover at least one CP-even Higgs boson of the MSSM. If a Higgs boson is discovered, we would like to determ ine whether or not this boson is the SM Higgs boson by studying its production and decays. It is therefore important to investigate to what extent the production cross-section and decay branching ratios can be determined and what the impact of these determinations will be on establishing the SM and searching for physics beyond the SM. 3;4;15;16 In the context of the M SSM, the question can be restated as whether the parameters in the Higgs sector are determined by various observable quantities related to the Higgs boson. A lthough it is possible to discover all ve Higgs states at the rst stage of the linear collider experiment, we may at rst be able to nd only one CP-even Higgs boson. In this situation it is in portant to determ ine in which mass region the other Higgs states exist so that these particles become targets of the second stage of the etechnical linear-collider experiments after the beam energy is increased.

This problem was addressed by K am oshita's talk in this workshop. The free parameters required to specify the Higgs sector in the M SSM can be taken to be the CP-odd Higgs-boson mass ( $m_A$ ), the ratio of two vacuum expectation values (tan ) and masses of the top quark and the stop squark. The latter two parameters ( $m_t$ ;  $m_{stop}$ ) are necessary to evaluate the Higgs potential at the one-loop level. Suppose that the lightest CP-even Higgs boson is discovered such that its mass ( $m_h$ ) is precisely known. Then we can solve for one of the free parameters, for example, tan , in terms of the other parameters. Assuming the top-quark mass is well determined by the time when the  $e^+e^-$  linear collider is under operation, the unknown parameters for the Higgs sector are then  $m_A$  and  $m_{stop}$ . The question is, to what extent these parameters are constrained from observable quantities such as the production cross-section and the various branching ratios.

It has been pointed out that one particular ratio of two branching ratios,

$$R_{br} = \frac{Br(h! cc) + Br(h! gg)}{Br(h! bb)};$$




Figure 6:  $R_{\rm br} = \frac{(B + (h + cc) + B + (h + gg))}{B + (h + bb)}$  as a function of  $m_A$  for several values of  $m_{\rm susy}$  for the lightest CP-even H iggs  $m_A$  as  $m_A = 120$  G eV. The following parameters are used for the calculation of the branching ratios:  $m_t = 170$  G eV,  $m_c$  ( $m_c$ ) = 12 G eV,  $m_b$  ( $m_b$ ) = 42 G eV,  $m_c$  ( $m_c$ ) = 0.12.

is especially useful to constrain the heavy H iggs m ass scale. In the M SSM , each of the two H iggs doublets couples to either up-type or down-type quarks. Therefore, the ratio of the H iggs couplings to up-type quarks and to down-type quarks is sensitive to the parameters of the H iggs sector, i.e. the angles and in Section 3. Since the gluonic width of the H iggs boson is generated by a one-loop diagram with an internal top-quark, the H iggs-gluon-gluon coupling is essentially proportional to the H iggs-top coupling. Then  $R_{\rm br}$  is proportional to square of the ratio of the up-type and down-type Y ukawa coupling constants. Since the up-type (down-type) Y ukawa coupling constant contains a factor  $\frac{\cos}{\sin}$ , (  $\frac{\sin}{\cos}$ ) compared to the SM coupling constant,  $R_{\rm br}$  is proportional to (tan tan )  $^2$ . In Figure 6  $R_{\rm br}$  is shown as a function of m  $_A$  for several choices of m  $_{\rm stop}$ ). From this gure we can see that  $R_{\rm br}$  is alm ost independent of m  $_{\rm stop}$ . In fact, it can be shown that  $R_{\rm br}$  in the M SSM , norm alized by  $R_{\rm br}$  in the SM , is approximately given by,

for m  $_A$   $\,$  m  $_h$   $\,$  m  $_Z$  . M easuring this quantity to a good accuracy is therefore important for constraining the scale of the heavy H iggs m ass. Note that R  $_{\rm br}$  approaches the SM value in the large m  $_A$  lim it. W e can see that R  $_{\rm br}$  is reduced by 20% even for m  $_A$  = 400 G eV .

In Nakamura's talk the experimental determination of these branching ratios was discussed. Although it is very dicult to measure the charm and gluonic branching ratios separately with good accuracy, the sum of the two branching ratios can be determined reasonably well. The statistical error in the determination of R  $_{\rm br}$  after two years at an e $^{+}$ e linear collider with  $^{2}$ s = 300 G eV is 19%. We also need to know the theoretical ambiguity of the calculation of the branching ratios in

h! bb;cc;gg. Uncertainties in the charm-quark and bottom-quark masses as well as in the strong coupling constant are important. At the moment the theoretical error in the calculation of  $R_{\rm br}$  is estimated to be larger than 20% and mainly comes from uncertainties in  $_{\rm s}$  and m $_{\rm c}$ . Both theoretical and experimental improvements are necessary to calculate the branching ratios more precisely.

## 7 Heavy Higgs decays to SUSY particles

The investigation of the properties of the heavy H iggs bosons (A;H;H) is one of main goals of a TeV linear collider. Since the M SSM is a special type of two-H iggs-doublet model, the discovery of these particles as predicted is strong evidence for the M SSM. A lso, the determination of the parameters  $m_A$  and tan of the H iggs sector is in portant in exploring the whole structure of the SUSY model since these parameters are relevant to other sectors of the model in the context of the M SSM and/or supergravity models. If we assume that the mass of the heavy H iggs is larger than 200 300 GeV it is possible that some decay channels to SUSY particles are open. In D jouadi's talk various decays of heavy H iggs bosons including SUSY modes are considered in the context of the SUSY GUT model with Yukawa unication.  $^{14}$ 

Let us rst sum m arize the dom inant decay m odes of heavy H iggs bosons if SU SY decay m odes are not open. Since the coupling of the H and the A to down-type quarks is enhanced for large tan , the H and A dom inantly decay to bb or  $^+$  for tan > 10. The situation is di erent in the smaller tan region where, if the

tt m ode is open, this m ode dom inate over other m odes. Below the tt threshold the  $H ! hh; H ! W W and A ! Z h m odes can be dom inant. For the charged H iggs boson, the <math>H ^ + ! bt$  m ode is dom inant if kinem atically accessible, and otherwise  $H ^ + ! becomes the main decay m ode.$ 

If we allow SUSY decay modes, heavy Higgs bosons can decay to squark-pairs, slepton-pairs and charginos and neutralinos. Of course whether or not these decay m odes are available depends on the mass spectrum of SUSY particles. Here a model based on m in imal supergravity is considered with an assumption of Yukawa coupling uni cation. Requiring that the m h=m ratio is correctly reproduced from the SU (5) SUSY GUT assumption and that the electroweak symmetry breaking is induced from the renormalization elects on the Higgs mass term from the universal SUSYbreaking mass at the GUT scale (the radiative electroweak symmetry breaking scenario), we can reduce the number of free parameters of the model. There are two separate regions of tan according to this scenario, but the so-called small tan solution is interesting where tan ' 1:75. Essentially this model contains two free param eters for which we can take m<sub> $\lambda$ </sub> and M  $_{1=2}$  (a gaugino m ass param eter). Then, for a xed heavy Higgs mass, all superparticle masses are determined as a function M  $_{1=2}$  so that the decay widths including SUSY modes are calculable. The im portance of the SUSY modes is quite dierent depending upon whether or not the H (A)! ttm ode is open. Below the top threshold the SUSY modes can dominate over the SM mode, and the total width can be enhanced by an order of magnitude. This is especially evident if the stop becomes light enough to be a dominant decay m ode. On the other hand, above the top threshold the ttm ode is almost always dom inant, and the SUSY modes play minor roles. This is because the decay width to the tt pair is already large compared to other modes. Only when the stop is light enough can the SUSY modes give a sizable contribution to the total width.

# 8 Multi-Higgs production in the MSSM

There were two talks which covered multi-H iggs production in the M SSM; one deals with various double and triple H iggs production processes at a TeV collider  $^{14;22}$ , and the other focuses on the  $e^+e^-$ ! Zhh process at an  $e^+e^-$  linear collider with  $\frac{P}{s} = 300 - 500 \, \text{GeV}^{23}$ .




Figure 7: The relevant Feynm an diagram's for  $e^+\,e^-\,\,!\,\,$  Z hh in the SM .




Figure 8: The additional Feynm an diagram s for  $e^+\,e^-\,!\,\,$  Z hh in the M SSM .

In the SM the e<sup>+</sup> e ! Zhh process is especially important because this process depends on the triple Higgs coupling (Figure 7). Therefore, information on the Higgs potential is obtained from this process. The production cross-section is, however, not so large. Form  $_h = 100\,\mathrm{G}\,\mathrm{eV}$  it is a few times  $10^{-1}$  fb for  $^{-1}$  s =  $500^{-1}$  TeV; therefore, we need more than a hundred fb  $^{-1}$  to observe this process. In the M SSM case the situation changes in two ways. The ZZh and the  $h^3$  couplings are modiled from the SM couplings, and additionally there are diagram swhich contain heavy Higgs(H;A) in an internal line as shown in Figure 8. In both talks it was noticed that the multi-Higgs production cross-section becomes large only when both




Figure 9: The m  $_{\rm A}$  dependence of the e<sup>+</sup> e  $_{\rm C}$ ! Zhh cross-section in the M SSM (solid) for tan = 2 and 10 at  $_{\rm C}$   $_{\rm S}$  = 500 G eV  $_{\rm C}$   $_{\rm C}$  The top and stop m asses are taken as m  $_{\rm C}$  = 170 G eV and m  $_{\rm Stop}$  = 1 TeV . In this gure the Higgs m ass is given as a function of m  $_{\rm A}$ . For comparison, the SM (dashed) and the NT (dotted) cross-sections with the same Higgs m ass are also shown.

heavy H iggs (H , A) production and the subsequent decay through H ! hh or A ! hZ are kinem atically allowed. In F igure 9, the production cross-section (e<sup>+</sup> e ! Z hh) is given as a function of m  $_{\rm A}$  for tan  $\,=\,$  2 and 10 for the M SSM . Here the top-quark and stop-squark m ass are taken as 170 G eV and 1T eV respectively. In this gure the lightest H iggs m ass varies as a function of m  $_{\rm A}$  (see F igure 3). For comparison the production cross-sections for the SM and for a model without a triple H iggs coupling (NT) calculated with the same H iggs m ass are shown. We can see that, in the region of smallm  $_{\rm A}$ , the cross-section becomes very large compared to the SM value. This corresponds to a region of parameter space where e<sup>+</sup> e ! H Z and H ! hh are possible. On the other hand, there are some regions of parameter space where the production cross-section is much reduced compared to the SM .

When the heavy H iggs boson is directly produced and multi-H iggs production becomes large, an interesting possibility arises for measuring the H-h-h coupling constant.  $^{22}$  If 2m  $_{\rm h}$  < m  $_{\rm H}$  < 2m  $_{\rm t}$ , the heavy H iggs boson H can have a sizable decay branching-ratio both in the H ! hh and H ! W W modes. In such a case the H - h-h coupling constant can be extracted from the ratio of two branching ratios since the coupling of the H to two gauge bosons is determined from the H iggs production

cross section of the fusion process as well as the Higgs-brem sstrahlung process.

#### 9 Conclusions

I have reviewed some aspects of the Higgs physics at future  $e^+e^-$  linear colliders whose CM energy is ranging from 300 GeV to 1.5 TeV. At earlier stage of the experiment with  $^{12}$  s  $^{13}$  300 -500 GeV, it is easy to nd a light Higgs boson predicted in SUSY standard models or GUT. In particular, both in the MSSM and the SUSY SM with a gauge singlet Higgs, at least one of neutral Higgs bosons is detectable. This is in portant because it is known that there is a parameter space in the MSSM where no signal of Higgs bosons is obtained in the LHC experiment.

A dvantage of linear collider experiments is, however, not only the discovery potential of the H iggs particle. M ore importantly, detailed study on properties of the H iggs boson is possible through m easurements of various production cross-sections and branching ratios. Here several examples are discussed: anomalous coupling of Z-Z-h, H iggs couplings to cc/gg/bb in the M SSM , H igss decays to superparticles and the measurement of triple-H iggs-couplings through the  $e^+e^-$ ! Z hh process. C ombining information obtained from the LHC experiment, we will be able to clarify the H iggs sector of the SM and explore physics beyond the SM .
