Two-Higgs-doublet models and the Yukawa process at LEP1 1

A bstract

We investigate the production of Higgs bosons A=h via the Yukawa process Z! ff! ffA=h taking into account QCD corrections and ferm ion masse ects. We estimate the discovery reach of this process and/or bounds on the parameter space of two-Higgs doublet models which can be derived from the analysis of bb + events at LEP1. These limits have important consequences for extended models of electroweak interactions and their experimental verication/improvement are welcome.

1 Introduction

Experim ental searches at LEP1 for the neutral H iggs bosons in the context of extended m odels of electroweak interactions have been performed in the B jorken (Z ! Z h) and pair production (Z ! Ah) processes. However, the Yukawa process (Z ! ff! ffA=h), in which the H iggs boson is radiated o the nal ferm ion, provides an alternative H iggs production mechanism. A lthough the possible importance of this process in the context of two-H iggs doublet models, both in supersymmetric and non-supersymmetric versions, has been pointed out long time ago [1, 2, 3], experimentally it has not been looked for so far.

Recently there has been a renewed interest in the Yukawa process in the context of attempts to explain experimental measurements of R_b , the branching ratio for Z decays to bb [4,5]. In particular, in the paper [4] it has been argued, based on (among others) a bound on parameter space tan M_A derived from the Yukawa process Z! bbA followed

by A ! bb β], that problem of R_b in the supersymm etric model could be explained only for tan 1. This bound has been obtained from the simple assumption that if 20-30 bbA events had been produced at LEP1 it is likely to have been noticed because the QCD background from Z! 4b is small. However, the analyses of 4b-jet events, for example in Z! hA! 4b searches [6], show that the background from Z! bbgg due to misidentication of b-quark jets is much more important. Although the Yukawa process has a dierent topology, similar background problems may appear in its experimental analysis and a denite conclusion can be drawn after a dedicated experimental analysis in 4b channel will have been performed. On the other hand, the bb hannel is almost background free and therefore it can be exploited to estimate limits on the parameters of the extension of the Standard Model.

In this paper we estim ate the param eter bounds and/or discovery reach of the Yukawa process using the bb $^+$ channel. To this end we provide the simple formulae including all ferm ion mass terms for the matrix element for process e^+e^- ! ff for both =h and =A. They may prove useful in constructing M onte C arbo programs in order to include experimental constraints, e-ciencies etc.

In the num erical analysis we also include QCD corrections which turn out to be very important. A ssum ing that no signal events are found we obtain weaker bounds on tan M than in [4]. Nevertheless our results demonstrate the physics potential of the Yukawa process: even if the Higgs boson is not found in this process, the exclusion plot derived from negative search will have interesting consequences for extensions of the Standard Model.

2 Higgs particle production at LEP 1

In the m in in al extensions of the Standard M odel (SM), either supersym m etric (M SSM) or non-supersym m etric (2HDM), two H iggs doublets are employed [7]. In this paper we consider 2HDM of type II in which, like in the M SSM, one of the H iggs doublets couples to up-type, and the other to down-type ferm ions. A fter the sym m etry breakdown there are vephysical H iggs particles: two CP-even neutral scalar H iggs bosons denoted by h and H (we assume that M $_{\rm h}$ M $_{\rm H}$), a CP-odd neutral { A (usually called a pseudoscalar), and a pair of charged particles H . Their experimental discovery and measurement of their couplings provides one of the majorm otivations for and constitues a primary physics goal to be achieved at present and future colliders.

Currently the best experim ental lim its on H iggs boson m asses are obtained from LEP1 experim ents perform ed at the Z boson peak. At the tree level the neutral H iggs bosons h and A can be produced in Z boson decays via three processes:

In the SM the associated H iggs pair production process (2) is absent and the Yukawa process (3) is suppressed by a factor $(m_f = M_W)^2$ with respect to H iggs-strahlung process (1).

Therefore the lower lim it on the H iggs m ass M $_{\rm H_{SM}} > 65.2$ G eV has been derived [8] from the negative search via the process (1) at LEP1.

In the two-doublet extensions of SM the Higgs-strahlung process (1) occurs at a lower rate

because the ZZh coupling is reduced by a factor $\sin^2($), where and are the mixing angles in the neutral and charged H iggs sectors, respectively. The negative search in this process results in the upper limit [9] on $\sin^2($) for a given M_h, for example $\sin^2($) < 0.1 if M_h < 50 GeV. However, for small $\sin^2($) one can exploit the H iggs pair production process (2), if kinem atically allowed, because it is complementary to the process (1) in the sense that

where = $(1 h A)^2 4 h A$, with h i = m 2 M 2. Such a procedure has been adopted at LEP1. An independent contraint on the non-SM contributions to Z decay is obtained from the analysis of the Z-lineshape, where the process (5) also contributes.

In this paper we consider a scenario in which the process (1) is suppressed (small $\sin^2($)) and the process (2) is closed kinematically ($m_h + m_A > m_Z$). Then the Yukawa process (3) becomes a dominant Higgs production mechanism at LEP1. Such a scenario can easily be realized in the 2HDM where the Higgs masses and mixing angles are not constrained theoretically. On the other hand, in the MSSM, due to supersymmetry relations, the Yukawa processmay become dominant only form $_h > 50\,\mathrm{G}\,\mathrm{eV}$ and tan $> 10\,\mathrm{E}$ 1.

The number of expected events crucially depends on hff and Aff couplings: the SMH iggs coupling ($^{-}$ 2G_F)¹⁼²m_f is multiplied by the factors g_{ff} given in Table 1, where D (U) is a generic notation for down-type (up-type) ferm ions, respectively.

Table 1: Higgs boson couplings to ferm ions relative to the SM Higgs couplings.

In the interesting large tan case the couplings of both A and h to down-type ferm ions are strongly enhanced by the same factor tan because small $\sin^2($) implies, to a good approximation, that $\sin = \cos$ tan . In such a case the Yukawa process can be a source of a signicant number of H iggs bosons h or A, whichever is lighter. For example, at LEP 1 one can expect [11] for M $_{h=A}=10~{\rm G\,eV}$ and tan $=20~{\rm a\,few}$ thousand of bbh or bbA events in $10^7~{\rm Z\,decays\,w\,hich}$ corresponds to the Z partial decay width of $1~{\rm M\,eV}$.

3 The Yukawa process

The rate for the process is very sensitive to the ferm ion mass e ects both in matrix elements and in the kinematical limits as demonstrated in our previous paper [11]. The analytical formulae for the matrix element of the process e^+e^- ! ff, including all fermion mass terms, can be written in a compact form. We present them in Appendix, as they may appear to be useful in constructing Monte Carlo programms in order to include experimental e ects.

In this paper we consider the e ect of QCD corrections in the Yukawa process. In the case when the Higgs boson is radiated o the b quark (f = b) and in hadronic decays (! bb) the QCD corrections are included by using the running quark mass m $_f = m_b (M)$) in the Higgs-quark coupling. This has an important election the production cross section. For example, for M = 50 GeV the cross section is reduced by a factor 2 in comparison to xed quark mass case, i.e. neglecting QCD corrections.

We observe that the cross section for the Yukawa process is proportional to \tan^2 . The additional dependence on tan that appears in the branching ratios for dominant Higgs decay modes! + and bb for tan > 5 is very weak and therefore can be neglected³. To derive the limits on tan M (with = h;A) we proceed as follows:

- a) We perform the calculations at the Z pole for 10^7 Z 's produced.
- b) We consider two dierent nal state con gurations: bb(+) and + (bb), where the rst pair denotes the ferm ions produced in e+e collisions which radiate the Higgs boson (either hor A) and the pair in the parenthesis is coming from Higgs decay.
- c) As we discussed, the bb + channel seems to be the most promising both from theoretical (negligible QCD background) and experimental (relatively good e ciency) points of view. For example, the L3 Collaboration [13] quotes the acceptance for signal events from Z! hA! bb + of the order of 5%. We assume that in the analysis of the Yukawa process similar e ciency can be achieved
- d) We assume no signal events and we derive the bounds corresponding to 95% CL.




Figure 1: The tan $\,$ M $_{\rm A}$ exclusion/discovery plot for the Yukawa process for A production. The region above the lines is excluded if no signal in bb $^+$ $\,$ m ode is observed. The solid line represents the results when QCD corrections are accounted for by taking the running b-quark m ass and the dashed line corresponds to $\,$ xed b-quark m ass m $_{\rm b}=4.6$ GeV . For comparison the dotted line shows the region that can be excluded based on 20 events with b-quark jets (using the running b-quark m ass).




Figure 2: The tan M_h exclusion/discovery plot for the Yukawa process for h production. The region above the lines is excluded if no signal in bb^+ mode is observed. The solid line represents the results when QCD corrections are accounted for by taking the running b-quark mass and the dashed line corresponds to xed b-quark mass m $_b=4.6$ GeV. For comparison the dotted line shows the region that can be excluded based on 20 events with b-quark jets (using the running b-quark mass).

The results are presented in Fig.1 for the pseudoscalar Higgs boson A and in Fig.2 for the scalar h. Param eters above the lines are excluded. The solid lines represent the limits obtained with running b-quark mass m $_{\rm b}$ M), and the dashed lines correspond to the case of xed b-quark mass m $_{\rm b}$ = 4:6 GeV, i.e. neglecting QCD corrections. The QCD corrections lower the Higgs-quark coupling and consequently weaker bounds can be established. For comparison the dotted lines delineate the excluded region based on 20 4b-jet events expected.

Note that in the MSSM case the mass range of interest for M $_{\rm h}$ and M $_{\rm A}$ is lying above, say 50 GeV. On the other hand in the 2HDM relatively light Higgs bosons are still not excluded, for example for tan = 20 the Higgs masses as low as 25 GeV, and for tan = 55 m asses of 45 GeV are not excluded.

To sum marise, the Yukawa process provides interesting limits on the parameter space of 2HDM and MSSM. Both QCD and ferm ion masse ects in wence the results considerably.

Although the rst attempt to include the Yukawa process in Higgs searches at LEP1 has been made recently by L3 Collaboration [13] nevertheless this process still awaits a serious experimental investigation.

W e consider the Yukawa process

with f=b or and the corresponding 4-m om enta are given in brackets. The electron mass is neglected $(k_{1;2}^2=m_e^2=0)$ and the nal state ferm ion (pole) mass is denoted by m $(p_{1;2}^2=m^2)$. The Higgs mass is denoted by M and $s=(k_1+k_2)^2$.

The di erential cross section $E_1E_2d = d^3p_1 d^3p_2$ reads

where $E_{1;2}$ and E denote CM energies of ferm ions and the Higgs boson , respectively. The matrix element, averaged over the initial and sum med over nal ferm ion polarizations, can be cast in the following form

The color factor is N $_{\rm c}=3$ for f = b and N $_{\rm c}=1$ for f = . We distinguish the ferm ion mass which enters the coupling, m $_{\rm f}$, from the pole mass m . In the case of the lepton we take m $_{\rm f}=$ m = m . However, in the case of the b-quark, we include QCD corrections by taking the running quark mass m $_{\rm f}=$ m $_{\rm b}$ (M). Q $_{\rm e}$, Q $_{\rm f}$ are electric charges of electrons and ferm ions, respectively (in units of e) whereas a $_{\rm e}$ (a $_{\rm f}$), $v_{\rm e}$ ($v_{\rm e}$) correspond to axial and

vector couplings of electron (ferm ion f) to Z-boson with a = I_{3L} = 2 sin $_W$ cos $_W$ and v = (I_{3L} 2Q sin $_W^2$) = 2 sin $_W$ cos $_W$.

The contributions of the photon, Z-boson exchange and the Z interference are denoted by 2 , 2 and , respectively, and can be written as follows: a)P seudoscalar

In the case of the pseudoscalar production, = A, we have $g_{\text{A}\,\text{ff}}^2=$ tan 2 , M = M $_{\text{A}}$ and

b) Scalar
