A Renorm alization G roup A nalysis of the H iggs Boson with H eavy Ferm ions and C om positeness

Abstract

We study the properties of heavy ferm ions in the vector-like representation of the electro-weak gauge group SU $(2)_W$ U $(1)_Y$ with Yukawa couplings to the standard model H iggs boson. Using the renormalization group analysis, we discuss their elects on the vacuum stability and the triviality bound on the H iggs self-coupling, within the context of the standard model (i.e., the H iggs particle is elementary). Contrary to the low energy case where the decoupling theorem dictates their behavior, the inclusion of heavy ferm ions drastically changes the standard model structure at high scales. We also discuss the interesting possibility of compositeness, i.e., the H iggs particle is composed of the heavy ferm ions using the method of B ardeen, H illand L indner [1]. Finally we brie y comment on their possible role in explaining R_b and R_c.

Enom ous e orts have been made in searching for physics beyond the standard model but up to now a crucial, direct experimental indication is still illusive. One of the most important motivation to explore heavy fermions above the energy accessible by current accelerators is to bok for extra building blocks of nature beyond the three families of the standard model. For this purpose it may be adequate to bok at fermions in vector-like representations of the electro-weak gauge group with a large bare mass term, rather than the conventional chiral doublets. The main reason for this is from the strong experimental constraint on the S parameter [2]. While the experiments favour a negative value of S [3], a standard chiral doublet of heavy fermions (degenerate in mass) contributes to the S parameter as 1=6. On the contrary, for fermions in the vector-like representation of the electro-weak gauge group a large bare fermion mass M completely changes the low energy properties of the heavy fermions. As a consequence of the decoupling theorem, heavy fermions contribute to the S and T parameters as¹,

where m (m⁰) is the mass parameter generated by the Yukawa coupling responsible for the electro-weak symmetry breaking (weak isospin violation), v (= 246 G eV) is the vacuum expectation value of the Higgs particle. The interesting aspect of the vector-like heavy ferm ions is not that they are safe at low energies, but most in portantly, because they may have some interesting role in physics beyond the standard model. For example, they may be responsible for a dynamical generation of light ferm ion mass matrix [4], they are natural consequences of many grand uni cation models, and they may even be the constituents of the electroweak Higgs particle [5]. Therefore it is in portant to investigate the fundam ental properties of the heavy vector-like ferm ions and this is the purpose of the current paper. The model we will study in this paper is the minimal standard model plus these hypothetical heavy vector-like ferm ions with Yukawa interactions to the Higgs boson. In most cases bosons have just the opposite property to that of ferm ions. To be speci c, in this paper we assume no elementary boson exists except for the known gauge bosons (and m aybe the H iggs particle), in particular we assume no super-symmetry.

Recently there has been a renewed interest in understanding the structure of the standard m odel at high energies, even up to P lanck scale [6, 7, 8]. A powerful tool is to use the renorm alization group equations to trace the evolution of the coupling constant of the $^4\,$ self-interaction of the H iggs particle. A ssum ing the standard m odel remains valid up to certain scale , an upper bound (the triviality bound, obtained by requiring not to blow up below) of the H iggs boson m ass, m_H, can be obtained. M eanwhile, requiring the stability of the

electro-weak vacuum, we can also obtain a lower bound on m_h. For the later purpose, in principle one needs to consider the renorm alization group improved e ective potential [9] and require it bounded from below. But in practice this turns out to be equivalent to the requirement that the Higgs self-interaction coupling constant does not become negative, below the given scale (see [6] and ref. therein). It is remarkable to note that for the given experimental value of the top quark mass (here we use m_t = 174G eV), there is an allowed range for the Higgs boson mass, 130G eV m_H 200G eV, for which the standard model may remain valid up to P lanck scale.

For the purpose of having a qualitative understanding of the in uence of heavy ferm ions to the above analysis, it is enough to consider the follow ing sim ple Lagrangian,

In above Lagrangian we introduced four vector-like ferm ions, Q is a SU (2)_W doublet and U and D are singlets. We assume they participate in strong interactions and are in fundamental representations of SU (3)_C. They are equivalent to one family of chiral quarks plus a left{right conjugated chiral quark family. We call them one family of vector-like quarks. The subscript d (s) in the covariant derivatives denotes that the corresponding ferm ion is a SU (2)_W doublet (singlet) and

denotes the standard H iggs doublet. W e further expect the Y ukawa couplings $(g_Y \text{ and } g_Y^0)$ to be of order 1. For sim plicity we take all the bare ferm ion m asses to be equal.

W hen heavy ferm ions are included the structure of our world changes drastically at high scales, even though vector-like ferm ions are essentially decoupling below their thresholds. At scales much higher than the threshold whether the ferm ion eld is chiral or vector-like does not make any qualitative di erence. The picture obtained from the following analysis also holds for Yukawa couplings between chiral quarks or between chiral and vector-like quarks.

The correction to the e ective potential from the heavy ferm ion is

As is well known, because of the negative sign, ferm ions turn to destabilize the vacuum. At a scale $_{\rm c}$ < M one can expand the above expression in powers of $_{\rm c}^2$ =M 2 and it is easy to verify that heavy ferm ions decouple from the elective potential as a consequence of the decoupling theorem. Far above the threshold there is no di erence between chiral and vector-like ferm ions. The only essential ingredient is the number of independent Yukawa couplings (notice that $_{\rm c}QU$

and $_{c}UQ$ are counted as di erent).²

In the following we list the relevant renormalization group equations (for simplicity we neglect the SU $(2)_W$ U $(1)_Y$ couplings g_2 and g_1 , since their e ects are relatively sm all and do not change the qualitative picture):

where g_t is the Yukawa coupling of the top quark ($g_t = 2m_t = v$) and g_s is the strong coupling constant. The beta function for top quark Yukawa coupling is the same as the standard model one at 1 loop we therefore do not list it here. We take $g_Y = g_Y^0$ for simplicity. The renormalization group equations are written in a more general case: $4N_d$ is the number of independent Yukawa couplings. $4N_c$ is the number of colored heavy ferm ions. For example $N_d = 1=2$ corresponds to setting g_Y (or g_Y^0) in eq. (2) to zero. We use a simple step function = (t $\log (M = M_z)$) to model the heavy ferm ion threshold e ects. All the g_Y

couplings in above renorm alization group equations are understood as multiplied by \cdot .

In g.1 we plot the vacuum stability bound and the triviality bound on the Higgs mass as a function of the scale for some typical values of the parameters of the heavy fermions. We see that the inclusion of heavy fermions drastically change the Standard m odel structure at high energies even though they decouple from the low energy world. They always tighten the bound on the mass of the Higgs boson as a function of the cuto scale . Notice that in principle (in terms of one loop renormalization equations) the upper line (triviality bound) and the low er line (vacuum stability bound) never meet each other. We now study the interesting possibility of considering the Higgs particle as a composite object of the heavy vector-like ferm ions. A ssum ing the dynam ical symmetry breaking occurs through a mechanism a la Nambu{Jona-Lasinio (via a four{ferm i interaction) or through an elective Higgs{Yukawa interaction, it is proven in [5] that, after integrating out the heavy ferm ion degrees of freedom,

the model is completely equivalent to the standard model at low energies and the Higgs boson'sm as has nothing to do with the bare ferm ion m ass, even though the Higgs boson is composed of heavy ferm ions. Applying the above renorm alization group analysis to the composite model leads to some interesting results which we present below. We follow the method proposed by Bardeen, Hill and Lindner (BHL) [1] originally developed for the top quark condensate model. The basic idea of the BHL method is the following: Using the collective eld method the four{ferm i interaction Lagrangian is rewritten into an e ective Higgs{Yukawa interaction Lagrangian at the cuto scale (the coupling strength of the fourferm i interaction is $G = {}^{2}$, where G is a dimensionless coupling constant). The e ective Yukawa interaction Lagrangian is identical to the standard m odel at the cuto scale, but with vanishing wave function renorm alization constant of the Higgs eld ($Z_{H} = 0$) and vanishing Higgs self-coupling (= 0). Below the m odel is equivalent to the standard m odel and therefore the coupling constants of the e ective theory run according to the standard m odel renorm alization group equations. However the vanishing of Z_{H} at the scale = leads to the following boundary conditions of the renorm alization group equations:

where ^r and g_Y^r are the renorm alized H iggs self-coupling and Yukawa coupling, respectively. W ith the renorm alization group equations and boundary conditions, one can predict them assofthe H iggs boson and the ferm ion m ass (or the Yukawa coupling) at its infra-red xed point value. In the present paper, of course, the \standard m odel" often refers to the standard m odel plus heavy ferm ions and the \infra-red xed point" value of g_Y refers to its value at the heavy ferm ion threshold.

The minimal top quark condensate model has already been ruled out by experiments. In order to generate the electroweak symmetry breaking scale v, the top quark mass is required to be at least as large as 218 GeV (corresponding to $= 10^{19}$ GeV, i.e., Planck scale). The experimental bound on the top quark mass (180 13 GeV [10]) indicates that the top quark Yukawa coupling does not diverge up to Planck scale in the standard model and therefore does not meet the compositeness condition of BHL (see however [11]). Since in the present model there is no strict experimental constraint, the compositeness condition is easily and naturally achievable. In g. 2 we plot the composite Higgs particle's mass³ and the Yukawa coupling g_Y at the infra-red xed point, as a function of . For a large num ber of colored fermions there is a problem with non-asymptotic freedom of the strong gauge coupling. Non-asymptotic freedom already happens with 3 vector-like quark families. However for $N_c = 3$ the strong coupling constant behaves middly up to P lanck scale and causes no problem. For simplicity we set all the Yukawa couplings to be equal.

From g.2 we see that the allowed range for the Higgs mass is rather narrow against the wide range of the cuto scale, the bare ferm ion mass and the number of families except when the heavy ferm ion bare mass M is close to the cuto . A lower bound on the Higgs masscan be obtained: $m_{\rm H}$ 145 GeV. When M is getting close to the cuto scale our results become unstable and are sensitive to the input num erical values of the boundary conditions. In such a situation the scale is not large enough for the couplings to reach the infra-red stable point. However it is estim ated that the Higgs mass will not exceed 450 GeV, otherwise the whole mechanism become unnatural (in the sense that the Yukawa coupling constant at electroweak scale also becomes substantially larger than 1).

In g.3 we plot a typical example of the Higgs mass for a given cuto scale $_{\rm c}$ and N $_{\rm d}$ (N $_{\rm c}$). We also plot the triviality bound and the vacuum stability bound using the Yukawa coupling constant at its infrared xed-point value as the initial boundary condition, which is determ ined uniquely by the parameter M, $_{\rm c}$ and N $_{\rm d}$ (N $_{\rm c}$) in the compositeness picture. It is very interesting to notice that $m_{\rm H}$ and take the values where the curves of triviality bound and vacuum stability bound (practically) meet each other. This is the unique feature of BHL compositeness picture. The reason behind this is very simple: The infra-red attractive xed point corresponds to the ultra-violet unstable xed point. In the sense of ref. [11], this picture can be disturbed. However in most cases the infra-red{ultra-violet xed point structure is in uential and rather stable against perturbation. From the above analysis, it is clear that the Higgs particle's m assolutions obtained in a composite m odel will not contradict 4 the triviality bound obtained from its low energy theory. W ithout a renorm alization group analysis, the obtained Higgs mass in the limit of large number of colors like the relation $m_{\rm H} = 2m_{\rm t}$ in top condensation model or that $m_{\rm H}$ equals to the mass splitting between heavy vector-like ferm ions in the current model does often contradict the triviality bound⁵.

Recently several authors [13] have suggested that a proper mixing between heavy vector-like ferm ions and the b;c quarks m ay resolve the R_b ($_b=_{hadron}$) and R_c ($_c=_{hadron}$) crisis. In the second model of C hang, C hang and K eung's paper in ref. [13], one weak singlet, charge 2/3 heavy quark which mixes with the charm quark is introduced to reduce R_c , and a vectorial SU (2)_W doublet with weak hypercharge 5=3 mixing with the down (type quarks is introduced to increase R_b . The in uence on R_c and R_b depends on the mixing angle between the vectorial and the chiral quarks. The mixing angle, $q_t v = \frac{2}{2}M$ can be determined from the experimental value of R_b and R_c . For su ciently large M, for example, M 1 TeV ⁶, a rough estimate indicates that the Yukawa

⁶M cannot be taken too large in order to be consistent with the experim ental constraints on the T param eter. Fixed mixing angle requires the increasing of the Yukawa coupling when

coupling is already large enough to meet the compositeness condition (i.e., the running Yukawa coupling blows up below the Planck scale.). However a more quantitative analysis requires considering also the running of g_2 and g_1 couplings.




Figure 1: Vacuum stability and triviality bounds on the Higgs mass as a function of . The solid lines are the standard model case (in the absence of g_2 and g_1 , we take $_s = 0.118$); The dot-dashed lines correspond to $N_d = 1=2$, $N_c = 3=4$ (i.e., without \U " or \D " quark in eq. (2)) and $M = 10^3$ GeV; The dashed (dotted) lines correspond to $N_d = 1$, $N_c = 1$ and $M = 10^3$ GeV ($M = 10^{10}$ GeV), respectively. The Yukawa coupling $g_Y = 1$.




Figure 2: IR xed point value (at M $_{\rm Z}$) of M $_{\rm H}$ and $g_{\rm Y}$ as functions of the compositeness scale. The solid line: N $_{\rm d}$ = 1=2, N $_{\rm c}$ = 3=4; the dashed line: N $_{\rm d}$ = N $_{\rm c}$ = 1; the dotted line: N $_{\rm d}$ = N $_{\rm c}$ = 3. The value of M in the gure is in unit of G eV.




Figure 3: IR {UV xed point structure and compositeness. In the $_{c} = 10^{5} \text{ GeV}$ case, $N_{d} = N_{c} = 3$; In the $_{c} = 10^{10} \text{ GeV}$ case, $N_{d} = N_{c} = 1. \text{ M} = 10^{3} \text{ GeV}$.
