# THREE FLAVOR NEUTRINO OSCILLATION ANALYSIS OF THE KAM IOKANDE MULTI-GEV ATM OSPHERIC NEUTRINO DATA

#### A bstract

U sing the published K am iokande data of the multi-G eV atm ospheric neutrinos, we have searched the optim um set of the neutrino oscillation parameters among three avors. It is found that  $^2$  is minimized for (  $m_{\,21}^{\,2}$ ,  $m_{\,31}^{\,2}$ ) = (3.8  $\,10^2$  eV  $^2$ , 1.4  $\,10^2$  eV  $^2$ ), (  $_{12}$ ,  $_{13}$ ,  $_{23}$ ) = (19,43,41) with  $_{\rm min}$  = 3.2 (42% CL). The sets of parameters (  $m_{\,21}^{\,2}$ ,  $m_{\,31}^{\,2}$ ) = (0 (10  $^{11}$  eV  $^2$ ) or 0 (10  $^{5}$  eV  $^2$ ), 0 (10  $^{2}$  eV  $^2$ )) which are suggested by the two avor analysis fall within 0.7 .

There has been much interest in atm ospheric neutrinos [1] [2] [3] [5] [4] [6], which m ight give us an evidence for neutrino oscillations. While NUSEX [4] and Frejus [5] have reported consistency between the data and the predictions on atm ospheric neutrino ux [8] [7], K am iokande, IMB and Soudan-2 have reported discrepancy. In particular, the K am iokande group claimed that their multi-G eV data suggests the mass squared dierence of neutrino is of order  $10^{-2}$  eV  $^2$  [2].

People have studied neutrino oscillations among three avors [9], and it has been shown recently [10] that them ass squared dierences and them ixing angles have strong constraints from various experiments. The analysis of the multi-GeV atmospheric neutrino data by the Kamiokande group [2] was based on the fram ework of neutrino oscillation between two avors, and it is in portant to see what happens if we analyze the data in the three avor fram ework. In this paper we will analyze the published multi-GeV data [2] of the Kamiokande atmospheric neutrino experiment, taking into account m ixings am ong three avor neutrinos. Unlike other works in Ref. [10], we will take the matter e ect [13] into consideration, and evaluate the number of events by sum ming over the energy and the zenith angle of neutrinos, to reproduce the original analysis by the Kamiokande group as much as possible. Throughout this paper we will restrict our discussions only to the multi-GeV data by the K am iokande group, not only because the M onte C arlo result for the neutrino energy spectrum is available only in Ref. [2], but also because this is the only data which gives both the upper and the lower bound on the m ass squared di erence of neutrinos.

We start with the Dirac equation for three avors of neutrinos with mass

Here E  $_{\rm j}=\frac{{\rm q}}{{\rm p}^2+{\rm m}_{\rm j}^2}$  is the energy of the neutrino, (x)  $({}_{\rm e}$  (x); (x); (x)) $^{\rm T}$  is the wave function of the neutrinos in the avorbasis, A (x)  ${}^{\rm p}_{\rm 2G_F\,N_e}$  (x) stands for the e ect due to the charged current interactions between  $_{\rm e}$  and electrons in m atter [13].

with  $c_{ij}$   $\cos_{ij}$ ;  $s_{ij}$   $\sin_{ij}$  is the orthogonal mixing matrix of neutrinos, and we will not discuss the CP violating phase of the mixing matrix here for simplicity  $^3$ .

The number of the expected charged leptons ' (' = or ) with energy q from a scattering e!  $_{\rm e}$  ' is given by

Here F (E; ) is the ux of atmospheric neutrino with energy E from the zenith angle ,  $n_T$  is the e ective number of target nucleons, (q) is the detection e ciency function for charged leptons ', d (E;q)=dq is the di erential cross section of the interaction e!  $_{\rm e}$ ' (= e or ), P (!

where R is the radius of the Earth, h 15Km is the altitude at which atmospheric neutrinos are produced.

To reproduce the analysis of the multi-GeV data by the Kamiokande group, one needs the quantity

for each E and , which is not given in [2]. However, the quantity

which is obtained by integrating (5) over , is given in the Fig 2 (d) { (f) in Ref. [2]. The zenith angle dependence n (E; ) of the atmospheric neutrino ux for various neutrino energy E has been given in Ref. [7] in detail. Here we multiply the quantity g (E) by the zenith angle dependence in Ref. [7] with suitable normalization, and adopt the quantity

instead of the original quantity f (E; ) used in [2]. (7) is the important assumption of the present analysis. (7) is not exactly the same as f (E; ) in the original analysis [2], but this is almost the best which can be done with the published data in [2].

We have solved (1) numerically for each E (10  $^{1=20}$  GeV E  $1\dot{0}$  GeV) and evaluated the number of events for a given range of the zenith

Several groups [8] [7] have given predictions on the ux of atm ospheric neutrinos but they dier from one another in the magnitudes, and the K am iokande group assumed that the errors of the overall normalization 1+ and the relative normalization 1+ =2 are = 30% and = 12%, respectively. Here we regard these factors and as free parameters of the theory, and adopt the following  $^2$  [14]:

where N  $_{\rm j}$  ( = e; ;1  $_{\rm j}$  5) is the data for each zenith angle  $_{\rm j}$  < <  $_{\rm j+1}$ . The theoretical prediction X  $_{\rm j}$  ( = e; ;1  $_{\rm j}$  5) depends on seven free parameters ( m  $_{\rm 21}^2$ , m  $_{\rm 31}^2$ ;  $_{\rm 12}$ ,  $_{\rm 13}$ ,  $_{\rm 23}$ ; , ), where m  $_{\rm ij}$  m  $_{\rm i}^2$  m  $_{\rm j}^2$ , so (9) is expected to obey a  $^2$  distribution with 10  $^7$ = 3 degrees of freedom . The number of degrees of freedom in the present analysis is smaller than the original one by the K am iokande group (5  $^8$ + 5  $^2$ = 83).

We could not reproduce exactly the zenith angle distributions in Fig. 3 in Ref. [2]. In particular our prediction for e-like events near cos 1 has a larger di erence with the data than K am iokande's does, and this di erence

seems to be important to discuss the magnitude of <sup>2</sup> later<sup>4</sup>. P resumably this discrepancy arises not only because the data that we are using is dierent from the original one in Ref. [2], but also because the Kamiokande group has taken into account the smearing election of the resolution of the angle (15 20) and the elects of backgrounds [2] [15]. Throughout this paper we discuss the goodness of tand the condense level of set of the parameters etc. based on our calculation with (7).

The value of  $^2$  is a ected to some extent by the presence of matter, and it is necessary to take into consideration the contribution of the second term in (1). Evaluation of  $^2$  requires a lot of CPU time of a computer since one has to solve (1) numerically for each E and and plug it into (9). We have meshed each parameter region into tenpoints ( $m_{ij}^2 = 10^{5+\frac{1}{2}}$ ;  $i_{ij} = 10^{5+\frac{1}{2}}$ ) and the evaluated the value of  $^2$ . Furthermore, using the gradient-search method described in Ref. [16], we have found that  $^2$  has the minimum value for

with  $\frac{2}{m \text{ in}}=32$ : Note that the deviation of the two normalization factors 1+ and 1+ =2 from unity is within the errors = 30% = 12% assumed in Ref. [2]. We have also calculated the value of the modilled chi square  $e^2$   $e^2$   $e^2$   $e^2$   $e^2$   $e^2$   $e^2$  with the weight for the errors = 30% = 12%, and we have found that the conclusions in the following discussions do not change very much with  $e^2$  instead of  $e^2$ .

The zenith angle distributions of the e-like events, the -like events and the double ratio R (=e)<sub>lata</sub>=(=e)<sub>MC</sub> are given in Fig.1 and Fig.2 for the optim um set of param eters.

The degrees of freedom of our analysis is 3, so the value of the reduced chi square is 1.1, which corresponds to 42 % con dence level. This suggests that our tin the present analysis is not particularly good, but as we mentioned earlier, this is probably due to the fact that the data from which we start is poorer than the original one by the K am iokande group [2].

The region of the param eter space which is allowed at 90 % CL is given by  $^2$   $^2_{m \, in}$  + 12 for seven free param eters. However, because it requires a lot of CPU time of a computer to solve (1) numerically, we could not give sets of contours in the parameter space. In fact, since the value  $_{m \, in}$  is rather large, if we project the allowed region onto the  $m_{21}^2$   $m_{31}^2$  plane, it is conceivable that we have disjointed regions on this plane, and the calculation would be extremely tedious. So we restrict our analysis to a special case of particular interest here.

We have evaluated  $^2$  for the sets of parameters, which are suggested by the solutions for the solar neutrino problem [13] [17]. In order not to spoil the success of these scenarios [13] [17] based on the two avor fram ework, we consider only the case in which  $jJ_{e3}j$  is small, since we have the formula which relates the probability  $P^{(3)}(_e!_e!_e)$  in the three avor analysis to  $P^{(2)}(_e!_e)$  in the two avor one [18]:

We note in passing that the constraint for  $J_{e3}$  jalso comes from the reactor experiments [19], which suggests  $J_{e3}$  =  $s_{13}^2 < 10^{-1}$  or 1  $J_{e3}$  =  $c_{13}^2 < 10^{-1}$ 

for  $m_{31}^2$  a few  $10^2 \text{ eV}^2$ .

Irrespective of whether we consider the vacuum solution (  $m_{21}^2$  O ( $10^{11}$  eV  $^2$ )) or the M SW solution (  $m_{21}^2$  O ( $10^5$  eV  $^2$ )) for the solar neutrino, the m ass squared di erence  $m_{21}^2$  is negligible compared to the contribution of the matter e ect A (x) in (1) and the other mass squared di erence  $m_{31}^2$ , which should be at least of order  $10^2$  eV  $^2$  to account for the zenith angle dependence of the K am jokande multi-G eV data. Thus we consider the case

Deviation of each parameter in this case is (  $^2$   $_{\text{m in}}^2$ )=7 = 0.9, so we conclude that this set of parameters falls within 0:7 for all three cases in (12). In fact we observe that any set of the parameters with the constraints (13) falls within 0:7 as long as  $m_{21}^2$   $m_{32}^2$  <  $m_{31}^2$  is satisfied (arbitrary 12 is allowed in this case). In (13) the error of is a little too large compared to

what the Kam iokande group assumed, but even if we take = 3:0 10<sup>1</sup> with all other parameters the same as in (13), we not that the solution falls within 0:8. The reason that we have weaker constraints in this analysis than in Ref. [2] is because we have larger numbers of free parameters, but this is inevitable as long as one assumes the general mixings among three avors of neutrinos.

In this paper we have analyzed the multi-GeV atmospheric neutrino data by the Kamiokande group based on the framework of three—avor neutrino oscillations, and have shown that the best—t is obtained for the set of parameters  $m_{21}^2 = m_{31}^2 = 0 (10^2 \, \text{eV}^2)$ . We have also shown that the popular set of parameters ( (  $m_{21}^2; \sin^2 2_{12}$ ) = (  $m_2^2; \sin^2 2_1$ ), (  $m_{31}^2; \sin^2 2_{13}$ ) = (0 (10  $^2 \, \text{eV}^2$ ), 0 (1)),  $m_{13}^2 = m_{13}^2 = m_{13$




