Heavy quark-meson mass gap from spectroscopy

#### A bstract

U sing a quite accurate avour-independence of nS-level m ass differences in heavy quarkon is and a corresponding quasiclassical expression for the heavy quark binding energy, one shows that experimental data on masses of mesons with heavy quarks allow one to make the estimate = 0.63 0.03 GeV.

## Introduction

The QCD dynam ics makes a screen in observation of pure electroweak e ects in heavy quark interactions. One of powerful tools in theoretical studies of hadrons with a single heavy quark, is HQET [1], where the heavy quarkmeson mass gap = m (Qq) m  $_{\rm Q}$  + O (=m  $_{\rm Q}$ ) has a signicant meaning. In the expression given above, m (Qq) denotes the heavy-light meson mass m (Qq) = (3m  $_{\rm V}$  (Qq) + m  $_{\rm P}$  (Qq))=4, averaged over the spin-dependent part of interaction and correspondingly expressed through the masses of vector and pseudoscalar states, and m  $_{\rm Q}$  is the heavy quark pole mass related to its "running" mass [2].

At present, is evaluated in the following ways. The rst one is the = 0:5HQET sum rules giving 0:1 GeV [3]. The second is the full QCD sum rules for heavy quarkonia [4], where the pole or "running" masses of heavy quarks are determined from the experimental data on the heavy quarkonia m asses and leptonic constants, so that = 0:6 0:7 GeV [5]. A special way is the nonrelativistic version of QCD sum rules for bottom on ium [6], where one can use a region of moderate values of the spectral function mom ent numbers, so that the nonperturbative contribution given by the gluon condensate can be still neglected and the Coulomb corrections can be quite accurately taken into account. Voloshin M . has found the " -independent" b quark pole m ass m  $_{\rm b}$  = m  $_{\rm b}$  0:56  $_{\rm s}$  ( ) = 4:639 0:002 G eV, corresponding to = 0:62 0:02 G eV . N ext, one considers the inclusive sem ileptonic width

of a heavy-light m eson in a way allowing one to take into account hard gluon corrections to the weak current of quarks, so that one inserts light quark loops into the gluon propagator. The comparison of the calculated width with the experimental value gives the "running" mass of heavy quark. Its value depends on the lnumber of the light quark loops. In the in nite llimit, one nds = 0.25 GeV [7]. However, the latter estimate of hard corrections is generally based on the spectator mechanism assuming the neglecting of the heavy quark binding into the meson. Despite the renormalon ambiguity in the heavy quark mass determination [8], one should not straightforwardly conclude that there is a deep disagreement between the sum rule estimates of and the evaluation in the decay analysis, since the latter is based on the consideration of isolated, but dressed heavy quark, whereas the sum rules handle with exactly de ned quantities involving no additional assumptions like the spectator picture. Moreover, the sum rule analysis is made for a nite number of loops.

Further, the nonrelativistic sum rule consideration of bottom onium can give a quite accurate value of b quark m ass at the m oment numbers, where the gluon condensate gives a negligible contribution. In the sum rules at high numbers of the spectral m oments, the gluon condensate contribution determines the binding energy in the 1S-state and, hence, the dierence between the double quark m ass and the level m ass. However, to use experimental data on the excited level m asses and leptonic constants is enough to extract the quark m ass at the moderate values of the spectral moment numbers. Therefore, the information on the excitation masses can allow one to determ ine the heavy quark masses.

In the present paper we use the experimental regularity in the heavy quarkonium spectra, where one nds a quite accurate avour-independence in the S-wave level spacing. This approximate independence results in a number of explicit relations between the quark masses, excitation numbers and binding energies [9]. These equations compose a complete system, which allows one to determine the heavy quark-meson mass gap of high accuracy

### 1 Basic relations

Determ ine the heavy quark pole mass

$$m_Q = m (Q q)$$

where  $^2$  is the average square of quark momentum inside a heavy-light meson. In the following we put

$$^{2} = 2hT i_{OG}; \qquad (2)$$

where  $_{Q\,q}$  is the reduced mass of the Qq system, and T is the kinetic energy of quarks. The reasonable choice of  $_{Q\,q}$  is [1,10].

The m (Q q) values for Q = b; c and q = u; d are known experimentally [11]

with the accuracy better than 5 MeV.

By the Feynm an -H ellm ann theorem for the Q  $_1$ Q  $_2$  system

$$\frac{dE}{d_{12}} = \frac{hT i}{12}; \quad _{12} = \frac{m_1 m_2}{m_1 + m_2}; \quad (4)$$

the avour-independent spacing of heavy quarkonium levels is reached if hTi = T is the constant value. Relation (4) xes the quark mass dependence of the binding energy in heavy quarkonia. To complete the system of equations, we use the Bohr - Sommerfeld quantization of nS-states at the constant hTi in the avour-independent logarithm ic potential




Figure 1: The experim ental values of the nS bottom onium (solid dots) and charmonium (empty boxes) mass dierences (n) = M (nS) M (1S)=M (2S) M (1S)] and the dependences in the present model (curve 1) and in the WKB approximation (curve 2).

where C is a avour-independent constant. Eq.(5) gives the excitation number dependence of the binding energy in the heavy quarkonia. Note, that the semiclassical WKB approximation of 3-dimensional potential problem leads to the substitution of n 1=4 for n in (5). However, the latter substitution does not result in the better description of experimental data (Fig.1). To isolate the n dependence, we consider the ratio (n)

in the current model or

The comparison of model approximation (6) with the experimental values [11] and WKB modication is shown in Fig.1. One can see that the applied

m odel is m ore suitable for the accurate description of M (nS) values with the accuracy up to 30 M eV, so that the parameter T is equal to

$$T = 0.43 \quad 0.02 \,G \,\text{eV} \,.$$

Note, that in contrast to the analysis in [9], we use the excitation masses averaged over the spin-dependent part of a potential, this procedure is more reasonable. In addition, the analysis of heavy quarkonium spectra performed in [9] under the WKB approximation results in the smaller value of T=0.37 GeV. The mass of nS-level is determined by the following

For the sake of convenience we introduce the "initial" value  $n_i(\ _{12})$  depending on the reduced mass and related to the avour-independent constant C in (5)

Let us use the experimental data on the heavy quarkonium spectra

which are valid with the 30 M eV accuracy. These equations can be rewritten down as  $^2$

where  $n_{th}$  (bb) = 4,  $n_{th}$  (cc) = 3. From eq.(8) one can nd

Combining (2), (9-11), one gets

where the dependence on the T parameter is hidden in explicit relations for the quark m asses through the heavy-light m eson m asses and  $\ .$ 

Eq.(12) can be solved num erically, and it gives<sup>3</sup>

As for the quark masses in the rst order over  $1=m_0$ , one nds

$$m_b = 4.63 \quad 0.03 \, \text{GeV}$$
,  $m_c = 1.18 \quad 0.07 \, \text{GeV}$ .

The additional uncertainty in c quark mass estimate is related to the replacement =m (Qq) ! = (m (Qq) ) + O ( $^2$ =m $_Q^2$ ) in the heavy quark mass expression, i.e. it is caused by terms of the second order over the inverse heavy quark mass.

The  $^2$  param eter is equal to 0:54  $0:08 \text{ G eV}^2$  [1, 10, 14].

The perform ed calculations allow one to predict the nS-levelm asses of bc family below the BD pair threshold

$$m_{B_c}(1S) = 6.37 \quad 0.04 \, \text{GeV}, \quad m_{B_c}(2S) = 6.97 \quad 0.04 \, \text{GeV}.$$

The 1S-level position is slightly higher than in previous estimates in the fram ework of potential models [15]. This deviation is basically caused by the greater value of T parameter, but not by the dierence in the quark mass

values, since the bc level m asses are not very much sensitive to the quark m ass variation. Using the estimate of spin-dependent splitting of 1S -level in bc system, m (1) m (0) 60 70 M eV [15], one gets the mass of the basic pseudoscalar state

$$m_{B_c}(0) = 6:32 \quad 0:05 \text{ GeV}$$

### C on clusion

U sing the regularity of heavy quarkonium spectra described within the quasiclassical approach, we have evaluated the heavy quark-meson mass gap = 0.63 0.03 GeV, as well as the pole masses of b and c quarks. The B  $_{\rm c}$  meson mass can be predicted m  $_{\rm B_c}$  = 6.32 0.05 GeV.
