THE STRUCTURE FUNCTIONS OF LONGITUD INAL VIRTUAL PHOTON AT LOW VIRTUALITIES

A bstract

The structure functions F_1^L and F_2^L of longitudinal virtual photon at low virtualities are calculated in the fram ework of chiral pertubation theory (ChPT) in the zero and rst order of ChPT. It is assumed that the virtuality of target longitudinal photon p^2 is much less than the virtuality of the hard projectile photon Q^2 and both are less than the characteristic ChPT scale. In this approximation the structure functions are determined by the production of two pions in collisions. The numerical results for F_2^L and F_1^L are presented (the upper index refers to longitudinal polarization of the virtual target photon). The possibilities of measurements of these structure functions are briefy discussed.

1 Introduction

As was mentioned in Ref's[1,2] the structure function of longitudinal virtual photon $F_2^L(x;p^2)$ in massless QCD is nonvanishing, when photon virtuality p^2 is going to zero. This unusual circum stance is caused by the fact that the imaginary part of the forward scattering amplitude (box diagrams with quarks in the loops), determining the photon structure function, has a pole $1=p^2$ in the virtuality of the target photon. A ffer multiplication by the product of longitudinal photon polarizations in the initial and nal states, proportional to p^2 ($e_1^Le_1^L$ / p^2), this results in nonvanishing $F_2^L(x;p^2)$ at p^2 ! 0.

The seem ingly nonvanishing interaction of longitudinal photons at p^2 ! 0 in m assless theories does not result [3,4] in any inconsistency of the theory: the arising problem s in the gedanken experiments with longitudinal photons are solved by exploiting the concept of the formation zone [3]. There are nonpertubative elects which are important for determination of the longitudinal photon structure function $F_2^L(x;p^2)$ at low p^2 . For this reason it is impossible to not it basing on QCD now. Even the approach, using the operator product expansion in $1=p^2$ and the analytical continuation in the domain of low p^2 ,

which was succeful in the determ ination of structure function of real and virtual transverse photon [2,5] is not working here: the extrapolation to low p^2 appears to be impossible.

At low virtualities and energies of all initial and nalparticles in the given process QCD is equivalent to the ChPT: the theory of alm ost massless particles—pions (for reviwes see [6-8]). Therefore we may expect that the peculiar properties of longitudinal photon in massless QCD will manifest them selves in ChPT with massless pions. This idea was proposed in Ref.[1].

The goal of this paper is to perform the quantitave calculations of the longitudinal photon structure functions at low p^2 basing on ChPT. In order to be in the fram ework of ChPT it is necessary to assume that not only virtuality of target (soft) photon p^2 is less than the applicability $\lim_{n \to \infty} f(n) = 0.6 \, \text{GeV}^2$, but also that the virtuality of the probe (hard) photon $p^2 = q^2$ in scattering is below this $\lim_{n \to \infty} f(n) = 1.0 \, \text{m}^2$.

There is the essential di erence in the photon structure functions at high and low virtualities Q^2 of probe (hard) photon. At high Q^2 the structure functions which are transverse in the polarization of the hard photon are dominating for the case of longitudinal, as well as for transverse polarized soft photon. This is a direct consequence of the fact that at high Q^2 the scattering proceeds through the scattering on quarks. At low Q^2 and P^2 the scattering cross section is determined by the production of pions. It is known [9], that in the virtual photon scattering on free spinless boson the cross section of the longitudinally polarized photon is dominating. This means, that at low Q^2 and P^2 the longitudinal structure function will exceed the transverse one, P_1 $P_2=2x$ P_1 .

The expansion parameter in ChPT is M 2 = C 2 F 2 , where F = 93 M ev is the pion decay constant and C is the constant depending on process and in this case it is about 6. Let us assume that Q 2 =M 2 , p 2 =M 2 and p 2 =Q 2 are the parameters of expansion and restrict ourselves by the rst order terms in these ratios. For the value of s = (p+q) 2 the more weak limitation is imposed: s < M 2 because s explicitly enters only in the small corrections to the results. The pion mass—will be partly accounted: no assumption $\dot{p}^2\dot{j}$ is used but corrections proportional to 2 =Q 2 and 2 =s are neglected, besides the overall phase space factor.

In the section 2 the results of calculations of F_2^L , F_1^L and F_L^L in the zero order of ChPT are presented. In section 3 the rst order terms in ChPT are calculated. In the section 4 the numerical results for the structure functions are given and the possibilities of the measurements of these structure functions are briefy discussed.

2 Calculation of the Structure Functions in the zero order of ChPT

In order to get the structure function F_2^L of the longitudinal target photon the im aginary part of forward scattering amplitude Im T (p;q) must be multiplied by the product of longitudinal photon polarization in the initial and nal states

where = pq and indexes; and; refer to hard and soft photon correspondingly. In the nalanswer the terms proportional to pp must be separated

In the zero order of ChPT the proportional to p p term of imaginary part of forward scattering amplitude Im T (p;q) is determined by the two box diagram sFigs. 1a,b, corresponding to standard scalar electrodynamics. It is easy to see that the diagrams of Fig. 2, where two photon interact with two pions at one point – the diagrams arising from A^2 term in Lagrangian of scalar electrodynamics do not contribute to (2) because their contributions into imaginary part of amplitude have no terms proportional to pp. (The contributions of the second terms in the brackets in (1) vanish due to current conservation at the soft photon vertex.)

The imaginary part of the amplitude is connected with discontinuity of the amplitude in sby:

The calculation of the diagram s of Fig.1 gives: for the direct diagram:

and only the rst order terms in the ratio $p^2=Q^2$ are retained. As follows from (4) in the theory with massless pions (2 ! 0) the direct diagram results in nonvanishing longitudinal photon structure function at p^2 ! 0, i.e. for quasireal photon. In this aspect the situation in the ChPT resembles the situation in the massless QCD [1,2]. In the real world at p^2 ! 0 F₂^L is going to zero proportionally to p^2 starting from the values of p^2 of order $p^2=x(1-x)$. If $p^2=x(1-x)$ is less than $p^2=x(1-x)$ as we suppose, in this region of $p^2=x(1-x)$ the terms, proportional to $p^2=p^2=x(1-x)$ become of importance, as well as the terms of the rst order in ChPT

As is well known (see e.g. [9]), for any target the structure function F_2 is proportional to the sum of scattering cross sections $_T$ + $_L$ of virtual transverse and longitudinal photons. If the scattering proceeds on free massless ferm ion only $_T$ survives, $_L$ = 0. For the scattering on free massless boson the situation is opposite: $_T$ = 0, $_L$ $\stackrel{\leftarrow}{\bullet}$ 0. Therefore, in the zero order in ChPT the nonvanising contribution to F_2^L comes from the scattering of longitudinally polarized hard probe photon and it is reasonable to calculate also F_L^L (p²;Q²;x) – the structure function, corresponding the case, where both photons are longitudinally polarized. The structure function F_L^L is related to F_1^L and F_2^L by:

The structure function $F_L^L(p^2;Q^2;$) is expressed through the imaginary part of the forward —scattering amplitude by:

where e^L (q) e^L (q) is given by (1) with substituion !, ! and p \$ q. In the case of F_L^L ; unlike F_2^L , the diagram s of g2 are also contributing.

Due to simple relation (8) between F_2^L , F_1^L and F_L^L only results for F_2^L and F_1^L will be represented. The results of the calculation for F_1^L in the scalar electrodynam ics are the following:

As is seen from (10) in the F_1^L there is not zero order term in the $p^2=Q^2$ expansion.

3 The First Order ChPT Correction to Longitudinal Photon Structure Functions

The general m ethod of calculation of ChPT corrections is exposed in Ref's [6-8]. We will m ainly use the results of G asser and Leutwyler [6] which are presented in the form m ost convenient for the present calculations.

From the general form of ChPT e ective Lagrangian it can be easily shown that in the rst order in ChPT only the two pions intermediate states can contribute to the imaginary part of the forward — scattering amplitude.

To calculate corrections to the structure functions F_L^L and F_2^L in the rst order of ChPT one should consider the general expression for elective Lagrangian which contains all terms permitted by chiral invariance in the order (momentum)⁴.

In the leading order of ChPT the e ective Lagrangian has the form

The space components of U are expressed through the pion els, U $\mathrm{^i}$ = $\mathrm{^i}$ =F. The ChPT expansion corresponds to the expansion in inverse powers of F $\mathrm{^2}$. where $L^{\text{scalelec}} = (0 + iA)^+ (0 + iA)^-$. Second term in $L^{(2)}$ corresponds to the four pion interaction and leads to appearance of the loop corrections to the structure functions which are proportional to $1=F^2$.

In the order $(m \text{ om entum})^4$, i.e. $1=F^2$, there are two terms in the general elective Lagrangian of ChPT [6], which are essential for us

where L_5 and L_6 are expressed in the terms of , $^+$ and A : L_5 and L_6 serve as the counter terms for the renormalization of loops: the in nities arising in loop calculations are absorbed in L_5 and L_6 , and as a result the nite values L_5 and L_6 arise.

For the calculation of the $\,$ rst order ChPT corrections to the structure functions we should calculate e ective $\,$ and $\,$ vertices, substitute ones in all zero order diagram s of ChPT and collect term s proportional to $1=F^2$.

At rst let us consider e ective vertex. In the chosen param eterization of U there are three diagrams which contribute to this vertex in the rst order of ChPT (Fig.3). First diagram corresponds to vertex of interaction in the scalar electrodynamics, the second comes from L_6 and the third is the loop (unitary) diagram. To renormalize the loop diagram it is convenient to use the dimensional regularization. The contribution of this diagram to the vertex can be divided into nite part and divergent part which contains the in nite factor, where is:

In the sum of the diagram s the divergent part will be absorbed into l_6 and the following result for elective vertex in the rst order of ChPT was obtained [6]:

k and k^0 are the pion initial and nalm omenta, q is the photon momentum, $k=k^0+q$: The numerical value of l_6 was found in Ref. [6] from the data on electromagnetic charge radius of the pion:

After substuting this e ective vertex in zero order diagrams in all cases the following combination appears

where $r^2 = q^2$ or p^2 . The term proportional to 2 in (26) arises from the loop correction – the diagram Fig. 3c. It is much smaller numerically (about 10 times) than l_6 and in what follows the dierence between the values of R $_6$ (q^2) and R $_6$ (p^2) will be neglected.

In the case of $\,$ e ective vertex there are six diagram s (g. 4): rst diagram com es from scalar electrodynam ics, second and third ones correspond to L_6 and L_5 , respectively, and the other diagram s are loop (unitary) corrections.

In principle we can write out the tensor structure of this vertex at once:

This equation follows from the fact that total amplitude for scattering must contain the factor R_6 multiplyed by tensor structure which is transverse in q and p simultaneously. This conclusion can be checked by direct calculation.

To simplify the calculation of this vertex we multiply by (p+q) (p+q). A fter this procedure the term proportional to R_6 comes out. Taking into account that cutting pion propagators implies that these pions are on mass-shell and substituting vertex for four-pion interaction into diagrams 4 (d-f), one can get the following expression for B

As usual, using dimensional regularization and absorbing the pole contributions, arising from the loop diagram s,by in nite constant l_5 we obtain the nite answer for B:

The absolute value of does not exceed 3 and it is much less than l_5 but the corrections due to l_5 and l_6 have a di erent sign and almost equal values and therefore the account of is necessary.

Substituting these e ective vertices into all zero order diagrams and collecting the terms proportional to 1=F 2 we get the nal results for ChPT corrections to structure functions F $_2^{\rm L}$ and F $_1^{\rm L}$ of longitudinal photon:

4 Discussion

Collecting all terms we can write nal results for structure functions F_2^L :

At Q 2 0:1 0:2G eV the large rst order ChPT correction comes from the factors in the square brackets in front of the rst terms in the rh.s of eq.'s (34). These factors have the meaning of the squares of pion form factors in the vertices of the diagram sFig. 1. Therefore, the accuracy of eq. (34) may be improved, if these factors would be represented in the standard form of pionic form factors (1 + R₆Q 2 =96 2 F 2) 2 . In the numerical calculations we use such a procedure.

The numerical results of the calculation at few values of parameters are represented in Fig. 5. In the Fig. 5 one can see the p^2 -dependence for F_2^L function. Since the pion mass is rather small we could expect before calculations the following behaviour the structure functions at low p^2 : in the region $p^2j > 0.1$ G ev 2 the pion mass is inessential and structure functions have to be close to the constants. In the region of less p^2 the pion mass in the Born terms starts to work and structure functions have to go to zero sharply.

In fact the situation is dierent from this expectations. A fter adding to the Born term the ChPT corrections the structure functions become very close to straight lines and one can not observe the peculiar behaviour of these function at low p^2 . ChPT corrections have negative sign and result to decreasing of F_2^L at all p^2 and x.

The x-dependence of F_2^L structure function is represented in Fig. 6. The existance of (1 2x) factor strongly supresses the zero order term in the $\hat{p}=Q^2$ expansion, so the term s $\hat{p}=Q^2$ are important here.

The Q 2 dependence of F $_2^{\rm L}$ is plotted at the F ig. 7. The decreasing of F $_2^{\rm L}$ with increasing of Q 2 is caused mainly by the factor in the square bracket at the rst and second terms in the rhs. in eq. (34), corresponding to the pionic form factor at the vertices of the F ig. 1 diagrams. At F ig. 8 the p 2 -dependece for the structure function F $_1^{\rm L}$, determined by eq. (35) is plotted. It is seen, that F $_1^{\rm L}$ is about order of magnitude less than F $_2^{\rm L}$. In this

aspect the photon structure function at low virtualities strongly di ers from ones at high Q^2 . (Recall, that at high Q^2 , $F_1 = F_2 = 2x$.) The small values of F_1^L can be explained by absence of zero order term in the $p^2 = Q^2$ expansion and strong numerical compensation (accidently, the numerical value of L 3). For this reason the next order corrections can be important and the results for F_1^L are less reliable than for F_2^L .

Let us now discuss the accuracy of the obtained results. Since only two terms in ChPT were calculated, only the general arguments, referring to the convergence of ChPT can be used. A coording to these arguments the expansion parameters are the ratios of all invariants entering in the problem $-Q^2$, \dot{p}^2j and s, to the characteristic ChPT scale M 2 $^\prime$ 0:6G eV 2 . In our case at Q 2 $^\prime$ 0:1 0:2G eV 2 , \dot{p}^2j 0:1G eV 2 and this ratios are of order 1=5 1=3.

The total energy senters only in the correction to the l_5 due to four pion interaction and at x > 0.15 does not contribute to the structure functions more than 40%. In the case of $p^2 = Q^2$ corrections one can indicate that in almost all cases the real expansion parameter is $p^2 = .$ So, one may expect that the accuracy of obtained results is about 30 is 50%. The accuracy is better at intermediate x = 0.2 = 0.3 and worse at x = 0.15 because the ratio s=M 2 became as large. For this reason there is no condence in the results at x < 0.15.

The comparision of the obtained results with experiment would be very important. The considered above phenomena is a new eld in the application of ChPT and the comparision of the theory with experiment in this eld can shed more light on ChPT, its applicability domain, the role of higher order ChPT corrections, etc.

Experim entally, the photon structure functions at low virtualities can be studied in several ways. One possibility could be the experim ents of 2 production at high $ux e^+e$ colliders (-factories):

The another way could be the 2 pion production in electron scattering on heavy nucleous:

If the \underline{m} om entum transfer to the nucleous is very \underline{sm} all, less than the inverse nucleous radius, $\underline{j}^2\underline{j}<1=R$ ' 50M eV for intermediate nuclei (Z 50), than the scattering on the nucleous is elastic and the suppression factor in comparision with pion electroproduction is (Z) =Zf, where f characterizes the suppression of two pion electroproduction at low energies. In this case one of colliding gammas is Coulombic, i.e. it is longitudinal. Since the cross section of collision in this domain of \underline{p}^2 is proportional to \underline{p}^2 and it is \underline{m} ultiplied by the square of Coulombic photon propagator / $\underline{1}=\underline{p}^4$, one \underline{m} ay expect a strong enhancement of this elect at low \underline{p}^2 . May be there are some chances to \underline{m} easure the process (37) in the case, when the nal nucleous is exited, or even spallation process occurs. The enhancement of the elect at \underline{sm} all \underline{p}^2 will also persists here. But in this case in order to have the proper normalization, the observation of the process (37) \underline{m} ust be accompanied by the measurement of electroexitation of nucleous

The third possible way is the observation of + production in ep collisions:

but this production of two pions in collisions is hidden in the large background, arising from usual electroproduction. In order to get rid of this background it is necessary to separate the events with very small momentum transfer to the proton.

- Fig.8-The structure function F_1^L as a function of p^2 at $x = 0.15 GeV^2$, x = 0.15 and x = 0.2.
















