Chiral Sym metry Breaking in the Dual Ginzburg-Landau Theory

Con nement and chiral symmetry breaking are the most fundamental phenomena in Quark Nuclear Physics, where hadrons and nuclei are described in terms of quarks and gluons. The dual Ginzburg-Landau (DGL) theory, which contains monopole elds as the most essential degrees of freedom and their condensation in the vacuum, is modeled to describe quark con nement in strong connection with QCD. We then demonstrate that the DGL theory is able to describe the spontaneous break down of the chiral symmetry.

1 Introduction

In Quark Nuclear Physics (QNP), the most essential phenomena are con nement of quarks and gluons and the chiral symmetry breaking. Quarks are not found in free space, while they are seen in deep inelastic scattering. Quarks are present in hadrons and hence the understanding of con nement is essential for the sizes of hadrons.

The chiral sym m etry is found in the QCD lagrangian. In the u-d sector, the current m ass is considered negligible (5M eV) as compared to the hadron m ass (1G eV), and hence the chiral sym m etry is to be realized with high accuracy. We expect then the chiral partners, saying simply parity doublets, to be degenerate in the u-d m eson spectrum. The nature, on the other hand, shows that the pion (0) has 139M eV and no 0^+ partner is found. The rhom eson (1) is 500M eV apart from its chiral partner, the alm eson (1^+). The same feature is found also for the baryon spectrum. This property of hadron spectra tells us that the chiral sym metry is broken spontaneously and the pion appears as its Goldstone particle. This chiral symmetry breaking should be understood for full description of QNP. Chiral symmetry breaking would provide the constituent quark masses and even the small mass pions, which are responsible for N-N interaction.

How do these phenomena happen? For this let us see the QCD coupling strength $_{\rm S}$, which runs with relevant momentum scale obeying the renormalization group of QCD [1]. At large momenta, $_{\rm S}$ diminishes and the theory becomes asymptotic free, and hence the momentum dependence of deep inelastic scattering is calculable perturbatively. At small momenta, where con nement and chiral symmetry breaking are expected, $_{\rm S}$ blows up and

hence we face highly non-perturbative processes. We ought to not the essential degrees of freedom to get the insight of these phenomena.

2 Dual Ginzburg-Landau theory

It is Nambu, who introduced an interesting view on color con nement in 1974 [2]. Suppose we insert a superconductor in a magnetic eld. The superconductor does not allow the magnetic eld to pass through. If it were to allow the magnetic eld, in the superconductor of second kind, the magnetic eld should be con ned in a vortex-like con guration. This is known as the Meissner electric eld should look like the one of the Coulomb potential between a positive and a negative color charges. If the vacuum is superconductor-like (dual superconductor), then the vacuum dislikes the electric eld to pass through and hence the color electric ux ought to be con ned in a vortex-like con guration. This is then named as dual Meissner electric monopoles. In the superconductor, the charged object, Cooper pair, is to condense, while in the QCD vacuum, the magnetically charged object, color magnetic monopole, to condense.

"t Hooft was the one, who demonstrated the natural appearance of color magnetic monopoles in QCD [3]. In the non-abelian gauge theory like QCD, he introduced a particular gauge named abelian gauge, to reduce it to the abelian gauge theory like QED. From a topological argument, color magnetic monopoles appear naturally in the abelian space. This work then supports the idea of Nambu for connement. Hence, QCD naturally reduces to QED with magnetic monopoles, which is the Maxwell equation with magnetic charges and currents, studied by Dirac[4]. This Maxwell equation has the duality symmetry, which naturally arises in the special gauge of QCD.

It took then about 10 years before the above idea was form ulated in the form of lagrangian [5]. The dual G in zburg-Landau (D G L) theory is expressed with the following lagrangian,

Here, L_{dual} denotes the dual version of the gauge eld tensor, q is the quark eld and is the monopole eld. \hat{D} is the dual covariant derivative, \hat{D} = 0 + igB . B is the dual gauge eld and g is the dual coupling constant, which satis es the D irac condition, eg = 4 . The last term is the Higgs term to cause monopole condensation, where and v

are the param eters of the DGL lagrangian. It is important to note that this DGL lagrangian is derived from the QCD lagrangian by assuming the existence of the monopole eld and the abelian dominance [5]. It is at the same time supported by the recent lattice QCD calculations [6]. This is the dream lagrangian of Dirac, which ought to appear in some nonabelian gauge theory like QCD.

The rst application is the qq static potential by putting qq pair with distance r[7]. The potential comes out to have a Yukawa term and a linear conning term. We can x the parameters of the DGL lagrangian by thing to the phenomenological potential. As for the glueball mass, which appears in the DGL theory and has a strong connection with the QCD vacuum and connement, it turns out M (0^+) 1.5 GeV. Its appearance of the linear potential is not surprising, since it is modeled in the DGL theory. It is worthwhile to stress, however, that there are no other models, which are able to realize connement of colors and at the same time have a strong link with QCD. The real challenge is now the chiral symmetry breaking, which is discussed next.

3 Chiral sym metry breaking

Chiral symmetry breaking is directly related with the quark mass generation in the QCD vacuum. How quarks then behave in monopole condensed vacuum? It corresponds to solving the Schwinger-Dyson equation, where quarks get the self-energy corrections due to the non-perturbative interaction with gluons[7]. This seems, however, unphysical, because quarks are conned. It means that whenever a quark is present, there should be an anti-quark or a di-quark to make the system color-singlet. In principle, therefore, we ought to solve multi-body system to talk about a single quark. Suppose we have the Schwinger-Dyson equation as schematically written as,

The quark, which is conned, should be seen from the position of anti-quark. Then, the probability to not the quark is nite only within the distance of the hadronic scale; 1 fm. Therefore, gluons cannot travel freely any distance. Rather, it is conned also within the hadronic distance. This indicates that there should be the infrared cut-o, which is of order of the inverse of the conning distance R as $q > q_c = \frac{1}{R}$. Hence, the SD equation is modified simply to

We show in Fig.1 the result of chiral symmetry breaking, expressed in terms of the quark mass M (p). It becomes nite with increasing the strength of monopole condensation. We not also the pion decay constant and the quark condensate to have the numbers close to the sem i-experimental values. This calculation demonstrates that monopole condensation is the source of both the connement and the chiral symmetry breaking [8].

We discuss also the recovery of the chiral symmetry at nite temperature [9]. We can formulate this in the imaginary time formalism. We in fact not the recovery of the chiral symmetry as indicated in Fig 2 by the ratio of quark condensate at nite and zero temperatures $hqqi_T$. $hqqi_T$ decreases with temperature and eventually drops to zero, indicating the recovery of the chiral symmetry. We note that the temperature of the phase transition; $T_c=0.11 G\,\text{eV}$ seems smaller than the results of lattice QCD. This dierence would be caused by the use of temperature independent parameters in the Higgs term. Since this term is introduced at zero temperature, it is likely that they depend on temperature as the case of the superconductor. In addition, the hadronic scale should also depend on temperature. Here, the point of showing this result is merely to demonstrate that the DGL theory provides phase transition to the normal phase at nite temperature.

We can even talk about the con nement-decon nement phase transition at nite temperature [10]. In the quenched approximation, we can write the DGL lagrangian in terms of the dual gauge elds by integrating out the gauge elds; A. It amounts to calculate the partition functional and we can derive the elective potential; the theodynamical potential. The result is shown in Fig.3, where the elective potential is plotted as a function of the monopole condensate, .

The absolute minimum appears at nite value of in the lower temperature side and jumps to = 0. This indicates decon nement phase transition of rst order. We can calculate the string tension as a function of temperature, the result of which is shown in Fig. 4. Adjusting as a temperature dependent parameter so as to reproduce the critical temperature at 0.2GeV, we not the string tension to reproduce the lattice QCD results[11].

It is interesting to mention that lattice QCD is also doing a very interesting development. The qq potential calculated with full lattice QCD agrees with the result of only the abelian part. This agreement indicates that the connement physics is describable in terms of only the abelian gluons. O ther quantities in this direction are being done by several groups [12, 13]. All these results indicate that the low momentum phenomena could be described by the abelian gauge gluons (abelian dominance), when the abelian gauge is suitably chosen. At RCNP, we have started numerical experimental program with the use of lattice QCD [14].

The largest task is to predict the properties of the glueballs[15] associated with con nement, particularly the decay properties for experimental identication.

4 Conclusion

Quark Nuclear Physics (QNP) is the eld to describe nucleons, mesons and nuclei in terms of quarks and gluons. The most essential phenomena in QNP are connement of quarks and gluons and the chiral symmetry breaking. The connement is modeled as due to the dual Meissner elect and is expressed in terms of the dual Ginzburg-Landau theory, where the QCD monopoles and their condensation in the QCD vacuum are the essential ingredients. We have demonstrated in this paper that the DGL theory is able also to describe the chiral symmetry breaking. We have then discussed the recovery of these symmetries at nite temperature. Now the DGL theory is ready for exciting experimental phenomena of QNP.





$V_{\text{eff}}(\chi;T)$ [fm⁻⁴]



k(T) [GeV/fm]


