The MSW solution to the solar neutrino problem in the presence of random solar matter density perturbations

We present the evolution equation describing MSW conversion, derived in the framework of the Schrodinger approach, in the presence of matter density uctuations. Then we analyse the elect of such uctuations in the MSW scenario as a solution to the solar neutrino problem. It is shown that the non-adiabatic MSW parameter region is rather stable (especially in $\,\mathrm{m}^2$) for matter density noise at the few percent level. We also discuss the possibility to probe solar matter density uctuations at the future Borexino experiment.

1. The present de cit of solar neutrinos seem s to disfavour any "astrophysical solutions" [2] whereas it points to neutrino oscillations. In particular the resonant conversion due to neutrino interactions with constituents of the solar material (the M ikheyev-Sm imov-W olfenstein (M SW) e ect) [3] is the most elegant and viable explanation for the existing solar neutrino data. It provides an extremely good data t in the small mixing region with m^2 10 5 eV 2 and $\sin^2 2$ 10 3 10 2 [4,5,8].

Here we investigate the stability of the MSW solution with respect to the possible presence of random perturbations in the solarm atterdensity.

The existence of matter density perturbations at the level of 1% or so cannot be excluded either by the Standard Solar Model (SSM), which is based on hydrostatic evolution equations, or by the present helioseism ology observations [11].

Let us rem ind that in Ref.[7] the e ect of periodic matter density perturbations added to an average density $_0$, i.e. $(r) = _0[l+h\sin(r)]$ upon resonant neutrino conversion was investigated. In that case parametric resonance in the neutrino conversion can occur when the xed frequency () of the perturbation is close to the neutrino oscillation eigen-frequency and for rather large ampli-

tude (h 0:1 0:2). There are also a number of papers which address similar e ects by dierent approaches [9,10].

In the present discussion we consider "white noise" matter dentity perturbations (as in Ref. [10]). Namely we assume that the random eld has a -correlated Gaussian distribution:

In (2) the lower bound is dictated by the hydrodynam ical approximation used later on, $l_{\rm free}$ = (n) 1 being the mean free path of the particles in the solar matter 1 . On the other hand, the upper bound expresses the fact that the scale of uctuations have to be much smaller than the characteristic matter oscillation length $_{\rm m}$, as indeed the -correlated distribution in eq. (1) requires.

2. According to the standard Schrödinger equation approach, we derive now the most general neutrino evolution equation in random matter density. The evolution of a system of two

Here is the neutrino m ixing angle in vacuum , m 2 the mass squared di erence, E the neutrino energy and the matter potential for the $_{\rm e}$! $_{\rm x}$ conversion reads

where m $_{\rm p}$ is the nucleon m ass and Y $_{\rm e}$ is the electron number per nucleon.

The above system can be rewritten in terms of the following equations:

where $P = j_e \hat{j}$ is the $_e$ survival probability, $R = Re(_x _e)$ and $I = Im(_x _e)$, with the corresponding initial conditions $P(t_0) = 1$; $I(t_0) = 0$; $R(t_0) = 0$.

The Eqs. (6) have to be averaged (see [1] for more details) over the random density distribution, taking into account that for the random component we have:

In terms of the averaged quantities de ned as hP(t)i = P(t), hR(t)i = R(t), hI(t)i = I(t), we can write the variant of the set (6) as:

This system of equations³ explicitly exhibits the noise parameter . It is now possible to outline the main e ects due to the presence of the random eld upon the resonant neutrino conversion. The M SW resonance condition remains unaltered, i.e. A_{ex} (t) = V_{ex} (t) $m^2 \cos 2 = 2E = 0$ due to the random nature of the matter perturbations. Due to the condition L_0 $_{\rm m}$, the noise param eter (cfr. Eq.(8)) is always smaller than A ex (t) except at the resonance region. As a consequence, (see Eqs. (9)) the perturbation can show its maximale ect just at the resonance provided that the corresponding noise length 1= obeys the following adiabaticity condition at the resonance layer r

This condition is analogous to the standard M SW adiabaticity condition at resonance $_{\rm r}$ = $_{\rm r=(\ _{\rm m}\)_{\rm res}}>$ 1 $\beta]. For de niteness, we have taken L <math display="inline">_{\rm 0}$ = 0:1 $_{\rm m}$. The two adiabaticity param eters are related as

Therefore due to the restriction (2) and for the range of param eters we are considering, 10^2 , $\tan^2 2$ 10^3 10^2 , we have $\sim_{\rm r}$ $_{\rm r}$.

As a result of (11), in the adiabatic regime $_{\rm r}>1$, the e ect of the noise is enhanced to the extent that the mixing angle is small. Furthermore, the MSW non-adiabaticity $_{\rm r}<1$ always brings to $_{\rm r}<1$. As a result in our discussion the uctuations are expected to be ine ective in the non-adiabatic MSW regime. Finally, it can be shown that the matter noise weakens



the M SW suppression in the resonance layer, exhibiting somehow the role of a friction.

3. In view of the qualitative features just outlined, we discuss the implications of noisy solar matter density in the M SW scenario for the solar neutrino problem. We have solved numerically the coupled dierential Eqs. in (9) for the $_{\rm e}$ survival probability, using as reference SSM them ost recent B ahcall-P insonneault model (BP) [6].

The 2 analysis has been performed taking the latest averaged experimental data of chlorine [12], gallium [13,14] and K am iokande [15] experiments: $R_{\text{C}\,1}^{\,\text{exp}}=$ (2:55 0:25)SNU; $R_{\text{G}\,a}^{\,\text{exp}}=$ (74 8)SNU 4 ; $R_{\text{K}\,a}^{\,\text{exp}}=$ (0:44 0:06) $R_{\text{K}\,a}^{\,\text{B}\,P}$.



The results of the tting in the m^2 ; $\sin^2 2$ param eter space, are shown in Fig. 1, where the 90% con dence level (C L.) areas are drawn for dierent values of . One can observe that the small-mixing region is almost stable, with a slight shift down of m^2 values and a slight shift of $\sin^2 2$ towards larger values.

The large m ixing area is also pretty stable, exhibiting the tendency to shift to smaller m^2 and $\sin^2 2$. The smaller m^2 values compensate for the weakening of the M SW suppression due to

the presence of matter noise, so that a larger portion of the neutrino energy spectrum can be converted. The = 8% case, considered for the sake of dem onstration, clearly shows that the small m ixing region is much more stable than the large m ixing one even for such large value of the noise. M oreover the strong selective ⁷Be neutrino suppression, which is the nice feature of the M SW effect, is som ehow degraded by the presence of matter noise. Consequently the longstanding con ict between chlorine and K am iokande data is exacerbated and the data t gets worse. Indeed, the presence of the matter density noise makes the data ta little poorer: $\frac{2}{m \text{ in}} = 0:1 \text{ for } = 0,$ it becomes $\frac{2}{m \text{ in}} = 0.8 \text{ for} = 4\%$ and even $\frac{2}{m \text{ in}} = 2 \text{ for } = 8\%$.

In conclusion we have shown that the M SW solution exists for any realistic levels of matter density noise (4%). Moreover the M SW solution is essentially stable in mass (4 $10^6~{\rm eV}^2<{\rm m}^2<10^5~{\rm eV}^2$ at 90% CL), whereas the mixing appears more sensitive to the level of uctuations.


4. Let us also stress the fact that the solar neutrino experiments could be viable tools for providing information on the matter uctations in the solar center. In particular, the future Borexino experiment [16], aiming to detect the ⁷Be neutrino ux could be sensitive to the presence of solar matter uctuations, as the ⁷Be neutrinos are those mostly a ected by the presence of matter noise.


In the relevant M SW param ter region for the noiseless case, the B orex ino signal cannot be denitely predicted (see Fig. 2a). Within the present allowed C L. regions (dotted line) the expected rate, $Z_{Be} = R_{Be}^{pred} = R_{Be}^{SSM}$ (solid lines), is in the range 0.2 0.7.

On the other hand, when the matter density noise is switched on, e.g. = 4% (see Fig. 2b), the minimal allowed value for Z_{Be} becomes higher, Z_{Be} 0:4. Hence, if the MSW mechanism is responsable for the solar neutrino decit and Borexino experiment detects a low signal, say $Z_{Be} \le 0.3$ (with good accuracy) this will imply that a 4% level of matter uctuations in the central region of the sun is unlikely.

Once more, the solar neutrino detection turns

out to be an important approach for studying the solar physics.
