Consistency Condition for the Pinch Technique Self-Energies at Two Loops

## ABSTRACT

A simple and testable necessary condition for the gauge independence of the Pinch Technique self-energies at two loops is discussed. It is then shown that, in the case of the Z and W self-energies, the condition is indeed satis ed by the Papavassiliou-Pilaftsis formulation.

The Pinch Technique (PT) is a convenient algorithm that automatically rearranges S-matrix elements of gauge theories into modiled, gauge-independent self-energies, vertex, and box diagrams. In turn, the new corrections exhibit very desirable theoretical properties. For these reasons, the PT has been frequently employed in recent discussions of QCD and Electroweak Physics [1]. A temporary drawback is that the approach has been fully developed only at the one-loop level. Very recently, however, Papavassiliou and Pilaftsis (P-P) proposed a method to construct PT self-energies at higher orders [2].

Calling <sup>b</sup> and the PT and R transverse self-energies, respectively, and focusing on the Z case, one has

where the \pinch part" ( $^{ZZ}$  (s)) $^{P}$  has the structure

In Eq.(2) the bare mass M<sub>0</sub> is assumed to be defined in a gauge invariant manner, tadpole contributions are included in  $^{ZZ}$  (s),  $V^P$  (s) and  $B^P$  (s) are the pinch parts from vertex and box diagrams, respectively, and  $R^{ZZ}$  (s) is a residual amplitude of 0 ( $g^4$ ) proposed in Ref.[2]. It is discussed in detail later on at the 0 ( $g^4$ ) level. Because of the limited knowledge currently available concerning multi-loop amplitudes in gauge theories, a general proof that  $^{b^{ZZ}}$  (s) is gauge invariant in higher orders is not presently available. One of the aims of this report is to note that by judiciously restricting the domain of s to lie in the neighborhood of s, the complex-valued position of the propagator's pole, one can obtain an expression for which the gauge independence can be tested on the basis of current knowledge. Specifically, we consider the neighborhood is sj 0 ( $g^2$  is), which roughly includes the resonance region. Recalling that s  $M_0^2 = 0$  ( $g^2$ ), through 0 ( $g^4$ ) Eqs.(1,2) become

where the indices i=1;2 denote 0  $(g^2)$  and 0  $(g^4)$  contributions. Through 0  $(g^4)$  the rst two terms in the rhs. of Eq.(3) equal the one-loop PT self-energy  $b_1^{ZZ}$  (s), which is

independent. Its explicit expression [3] is:

where  $c_w^2$  is an abbreviation for  $\cos \frac{2}{w}$  , i (i = W ; Z; ) are the R gauge parameters and

On the other hand,  $\frac{Z}{2}$  (s) in Eq.(4) is expected to be gauge dependent. Although this amplitude is not fully known, its gauge-dependent part can be isolated by a simple argument. Recalling that the pole position  $s = M_0^2 + \frac{ZZ}{2}$  (s) +  $\begin{bmatrix} Z \\ Z \\ Z \end{bmatrix}$  (s)] is gauge invariant, through O ( $g^4$ ) we have

where  $b_1^{ZZ}$  (s) is dened in Eq.(4). The amplitude  $c_1V_1^P$  (s) can be gleaned from Eqs.(12b,16d) of Ref.[3]:

where  $_{W}$  (s) is a  $_{i}$ -dependent function de ned in Eqs.(2-6) of Ref.[4]. Recalling s M  $_{0}^{2}$  =  $_{1}^{ZZ}$  (s)  $j_{,=1}$  + O ( $g^{4}$ ), we have

On the other hand, using Eq.(8) of Ref.[4], one  $\,$  nds for general  $_{\rm i}$

Combining Eqs.(6,8,9) we obtain

The term s proportional to  $_{W}$  1 and  $(_{W}$  1) $^{2}$  in Eq.(10) represent the  $_{i}$ -dependent parts of  $_{2}^{ZZ}$  (s). It follows that, if the residual contributions  $R_{2}^{ZZ}$  (s) are not included,

Eq.(3) is gauge-dependent in O ( $g^4$ ). Next we evaluate  $R_2^{\ Z\ Z}$  (s). Following the P-P m ethod [2],  $R_2$  is the contribution that must be added to the chain of R transverse one-loop self-energies and corresponding pinch parts (Fig.1 (b-d)), in order to convert it into the chain of one-loop PT transverse self-energies (Fig.1a). The explicit construction of  $R_2^{\ Z\ Z}$  (s) in the  $_1$  = 1 gauges has been given in Ref.[5]. We must now generalize this procedure to a general gauge. The chain of one-loop PT self-energies is by de nition independent and gives a contribution proportional to

where we have employed Eqs.(16d,16b) of Ref.[3]. On the other hand, using the results of Refs.[3], [4] and neglecting O ( $g^6$ ), one nds that for s=s and general  $_i$  the chain of R one-loop self-energies and pinch parts contributes

The two rst terms arise from the self-energy contributions in a general R gauge [4] through O ( $g^4$ ), while the third involves the contribution of self-energies and pinch parts (Fig.1 (b-d)) in the same approximation. Setting  $s = s = M_0^2 + \frac{ZZ}{1}$  (s) + ::: in Eqs.(11,12) and subtracting the two expressions we obtain

Comparing Eq.(10) with Eq.(13) we see that the  $_{\rm W}$  dependent contributions cancel in the combination  $_{\rm Z}^{\rm ZZ}$  (s)  $_{\rm Z}^{\rm ZZ}$  (s). Thus, Eq.(3) is indeed gauge—independent through 0 ( $_{\rm Z}^{\rm Q}$ ) if  $_{\rm Z}^{\rm ZZ}$  (s) is evaluated according to the P-P m ethod. In the neighborhood is sj 0 ( $_{\rm Z}^{\rm ZZ}$ ), Eq.(3) becomes

For s = s, Eq.(14) reduces to Eq.(3.16) of Ref.[5]. Using Eq.(14) one nds that in the PT approach the denominator in the Z propagator can be written as

where it is understood that is sj 0 ( $g^2$  is). In order to derive Eq.(15), it is convenient to add and subtract s in the lhs., employ s  $M_0^2 = {}^{ZZ}$  (s) + ( ${}^{Z}$  (s)) ${}^2$ =s + ..., and recall the expression for  ${}^{b}$  given in Eq.(16b) of Ref[3]. Eq.(15) explicitly shows two important properties: 1) as it involves the PT self-energy  ${}^{b}_{1}^{ZZ}$  (s), it is manifestedly independent 2) the zero of Eq.(15) occurs at s = s, so that the pole position is not displaced. For the Z case, the latter property was already derived in the particular case of the  ${}_{i}$  = 1 gauges [5]. As explained in Refs.[5], [6], using the scaling approximation for Im  ${}^{b}_{1}^{ZZ}$  (s) one can transform Eq.(15) into the characteristic s dependent B reit-W igner resonance employed in the LEP analysis, so that the connection with the LEP observables become sexplicit.

One can readily carry out the same analysis for the W self-energy. In this case there are no mixing complications but the R gauge dependence is governed by three parameters  $i \in W$ ; Z; ). One nds

where (i, \$ j) is obtained from the preceding term by interchanging the indices in ( $_{i}$  1)  $_{ij}$  (s). The gauge dependence is contained in F ( $_{i}$ ; s). Following the P-P m ethod we obtain

Again  $_{2}^{WW}$  (s)  $R_{2}^{WW}$  (s) is independent and in the interval is sj  $O(g^{2}$  is ) we not

Alternatively, the  $_{i}$  independence of  $_{2}^{b_{2}^{WW}}$  (s) can be derived by directly evaluating  $_{1}^{b_{2}^{WW}}$  (s) +  $_{2}^{b_{2}^{WW}}$  (s)  $_{1}^{WW}$  (s)  $_{2}^{WW}$  (s) in a general  $_{i}$  gauge [2]. Using Eq.(19) the

propagator's denom inator becom es

in analogy with the Z case.

In sum mary, by restricting s to the neighborhood is sj 0 ( $g^2$  isj) of the propagator's pole one can test the gauge dependence of the Z Z and W W self-energies through 0 ( $g^4$ ). In both cases we not that the P-P method leads to gauge independent amplitudes. Because of our restriction to the resonance region, and our neglect of 0 ( $g^6$ ) terms, this test amounts to a necessary rather than a su cient condition. On the other hand, it is important to emphasize that this domain is of special physical signicance.




Chain of one-loop transverse PT self-energies through 0  $(g^4)$  and a class of related pinch parts.




