Consistency Condition for the Pinch Technique Self-Energies at Two Loops

ABSTRACT

A simple and testable necessary condition for the gauge independence of the Pinch Technique self-energies at two loops is discussed. It is then shown that, in the case of the Z and W self-energies, the condition is indeed satisfied by the Papavassiliou-Pilaftsis formulation.

The Pinch Technique (PT) is a convenient algorithm that automatically rearranges S-matrix elements of gauge theories into modified, gauge-independent self-energies, vertex, and box diagrams. In turn, the new corrections exhibit very desirable theoretical properties. For these reasons, the PT has been frequently employed in recent discussions of QCD and Electroweak Physics [1]. A temporary drawback is that the approach has been fully developed only at the one-loop level. Very recently, however, Papavassiliou and Pilafitsis (P-P) proposed a method to construct PT self-energies at higher orders [2].

Calling b^{ZZ} and π^{ZZ} the PT and R transverse self-energies, respectively, and focusing on the Z case, one has

$$b^{ZZ}(s) = \pi^{ZZ}(s) + (\pi^{ZZ}(s))^P; \quad (1)$$

where the "pinch part" $(\pi^{ZZ}(s))^P$ has the structure

$$(\pi^{ZZ}(s))^P = c_1(s - M_0^2)V^P(s) + c_2(s - M_0^2)^2B^P(s) - R^{ZZ}(s); \quad (2)$$

In Eq.(2) the bare mass M_0 is assumed to be defined in a gauge invariant manner, tadpole contributions are included in $\pi^{ZZ}(s)$, $V^P(s)$ and $B^P(s)$ are the pinch parts from vertex and box diagrams, respectively, and $R^{ZZ}(s)$ is a residual amplitude of $O(g^4)$ proposed in Ref.[2]. It is discussed in detail later on at the $O(g^4)$ level. Because of the limited knowledge currently available concerning multi-loop amplitudes in gauge theories, a general proof that $b^{ZZ}(s)$ is gauge invariant in higher orders is not presently available. One of the aims of this report is to note that by judiciously restricting the domain of s to lie in the neighborhood of s , the complex-valued position of the propagator's pole, one can obtain an expression for which the gauge independence can be tested on the basis of current knowledge. Specifically, we consider the neighborhood $|s - s_j| = O(g^2|s_j|)$, which roughly includes the resonance region. Recalling that $s - M_0^2 = O(g^2)$, through $O(g^4)$ Eqs.(1,2) become

$$b^{ZZ}(s) = \pi_1^{ZZ}(s) + c_1(s - M_0^2)V_1^P(s) + \pi_2^{ZZ}(s) - R_2^{ZZ}(s) + O(g^6); \quad (3)$$

where the indices $i = 1, 2$ denote $O(g^2)$ and $O(g^4)$ contributions. Through $O(g^4)$ the first two terms in the r.h.s. of Eq.(3) equal the one-loop PT self-energy $b_1^{ZZ}(s)$, which is

independent . Its explicit expression [3] is :

$$b_1^{ZZ}(s) = \sum_{i=1}^{ZZ} (s) j_{i=1} - 4g^2 c_w^2 (s - M_0^2) I_{WW}(s) ; \quad (4)$$

where c_w^2 is an abbreviation for $\cos^2 \frac{\theta}{2}$, j_i ($i = W, Z$) are the R gauge parameters and

$$I_{ij}(q^2) = i^{4-n} \frac{d^n k}{(2\pi)^n} \frac{1}{(k^2 - M_i^2) (k+q)^2 - M_j^2} ; \quad (5)$$

On the other hand, $\sum_{i=1}^{ZZ} (s)$ in Eq.(4) is expected to be gauge dependent. Although this amplitude is not fully known, its gauge-dependent part can be isolated by a simple argument. Recalling that the pole position $s = M_0^2 + \sum_{i=1}^{ZZ} (s) + [\sum_{i=1}^Z (s)]^2 = [s_{\text{pole}}(s)]$ is gauge invariant, through $O(g^4)$ we have

$$\sum_{i=1}^{ZZ} (s) = s - M_0^2 - b_1^{ZZ}(s) + c_1 (s - M_0^2) V_1^P(s) - [\sum_{i=1}^Z (s)]^2 = s ; \quad (6)$$

where $b_1^{ZZ}(s)$ is defined in Eq.(4). The amplitude $c_1 V_1^P(s)$ can be gleaned from Eqs.(12b,16d) of Ref.[3] :

$$c_1 V_1^P(s) = 4g^2 c_w^2 [L_{WW}(s) + (\frac{1}{s_W} - 1) s_W(s) = 2] ; \quad (7)$$

where $s_W(s)$ is a i -dependent function defined in Eqs.(2-6) of Ref.[4]. Recalling $s - M_0^2 = \sum_{i=1}^{ZZ} (s) j_{i=1} + O(g^4)$, we have

$$c_1 (s - M_0^2) V_1^P(s) = 4g^2 c_w^2 \sum_{i=1}^{ZZ} (s) j_{i=1} [L_{WW}(s) + (\frac{1}{s_W} - 1) s_W(s) = 2] : \quad (8)$$

On the other hand, using Eq.(8) of Ref.[4], one finds for general i

$$\begin{aligned} \frac{\sum_{i=1}^Z (s)}{s} &= \sum_{i=1}^Z (s) j_{i=1} + g^2 s_W c_w (\frac{1}{s_W} - 1) s_W(s) = s + O(g^6) \\ &= [\sum_{i=1}^Z (s) j_{i=1}]^2 = s + 2g^2 s_W c_w (\frac{1}{s_W} - 1) s_W(s) \sum_{i=1}^Z (s) j_{i=1} \\ &\quad + g^4 s_W^2 c_w^2 (\frac{1}{s_W} - 1)^2 s_W^2(s) + O(g^6) : \end{aligned} \quad (9)$$

Combining Eqs.(6,8,9) we obtain

$$\begin{aligned} \sum_{i=2}^{ZZ} (s) &= \sum_{i=1}^{ZZ} (s) j_{i=1} - 2g^2 (\frac{1}{s_W} - 1) s_W(s) \sum_{i=1}^Z (s) j_{i=1} + c_w s_W \sum_{i=1}^Z (s) j_{i=1} \\ &\quad - g^4 s_W^2 c_w^2 (\frac{1}{s_W} - 1)^2 s_W^2(s) : \end{aligned} \quad (10)$$

The terms proportional to $\frac{1}{s_W} - 1$ and $(\frac{1}{s_W} - 1)^2$ in Eq.(10) represent the i -dependent parts of $\sum_{i=2}^{ZZ} (s)$. It follows that, if the residual contributions $R_2^{ZZ}(s)$ are not included,

Eq.(3) is gauge-dependent in $O(g^4)$. Next we evaluate $R_2^{ZZ}(s)$. Following the P - P method [2], R_2 is the contribution that must be added to the chain of R transverse one-loop self-energies and corresponding pinch parts (Fig.1 (b-d)), in order to convert it into the chain of one-loop PT transverse self-energies (Fig.1a). The explicit construction of $R_2^{ZZ}(s)$ in the $\bar{\mu} = 1$ gauges has been given in Ref.[5]. We must now generalize this procedure to a general gauge. The chain of one-loop PT self-energies is by definition independent and gives a contribution proportional to

$$h \sum_{i=1}^{ZZ} (s) j_{i=1} (s - M_0^2) 4g^2 c_w^2 I_{WW}^{i_2} = (s - M_0^2) + h \sum_{i=1}^Z (s) j_{i=1} (2s - M_0^2) 2g^2 s_w c_w I_{WW}^{i_2} = s; \quad (11)$$

where we have employed Eqs.(16d,16b) of Ref.[3]. On the other hand, using the results of Refs.[3], [4] and neglecting $O(g^6)$, one finds that for $s = s$ and general $\bar{\mu}$ the chain of R one-loop self-energies and pinch parts contributes

$$\begin{aligned} & h \sum_{i=1}^{ZZ} (s) j_{i=1} + (s - M_0^2) 2g^2 c_w^2 (I_{WW} - 1)_{WW} (s) = (s - M_0^2) \\ & + h \sum_{i=1}^Z (s) j_{i=1} + s g^2 s_w c_w (I_{WW} - 1)_{WW} (s) = s \\ & 4g^2 c_w^2 \sum_{i=1}^{ZZ} (s) j_{i=1} [I_{WW} (s) + (I_{WW} - 1)_{WW} (s) = 2] : \end{aligned} \quad (12)$$

The two first terms arise from the self-energy contributions in a general R gauge [4] through $O(g^4)$, while the third involves the contribution of self-energies and pinch parts (Fig.1 (b-d)) in the same approximation. Setting $s = s = M_0^2 + \sum_{i=1}^{ZZ} (s) + \dots$ in Eqs.(11,12) and subtracting the two expressions we obtain

$$\begin{aligned} R_2^{ZZ}(s) = & 4g^2 c_w^2 \sum_{i=1}^{ZZ} (s) + s_w c_w \sum_{i=1}^Z (s) j_{i=1} [I_{WW} (s) + (I_{WW} - 1)_{WW} (s) = 2] \\ & + g^4 s_w^2 c_w^2 s [4I_{WW}^2 (s) - (I_{WW} - 1)^2_{WW} (s)] + O(g^6) : \end{aligned} \quad (13)$$

Comparing Eq.(10) with Eq.(13) we see that the W dependent contributions cancel in the combination $\sum_{i=1}^{ZZ} (s) - R_2^{ZZ}(s)$. Thus, Eq.(3) is indeed gauge-independent through $O(g^4)$ if $R_2^{ZZ}(s)$ is evaluated according to the P - P method. In the neighborhood $j_s \rightarrow s_j$ $O(g^2 j_s)$, Eq.(3) becomes

$$\begin{aligned} b^{ZZ}(s) = & \sum_{i=1}^{ZZ} (s) j_{i=1} + \sum_{i=2}^{ZZ} (s) j_{i=1} - 4g^2 c_w^2 (s - s) I_{WW} (s) \\ & + 4g^2 s_w c_w \sum_{i=1}^Z (s) j_{i=1} I_{WW} (s) - 4g^4 s_w^2 c_w^2 s I_{WW}^2 (s) + O(g^6) : \end{aligned} \quad (14)$$

For $s = s$, Eq.(14) reduces to Eq.(3.16) of Ref.[5]. Using Eq.(14) one finds that in the PT approach the denominator in the Z propagator can be written as

$$s - M_0^2 - b^{ZZ}(s) - [b^{ZZ}(s)]^2 = (s - s) - 1 - \frac{d}{ds} b_1^{ZZ}(s) \Big|_{s=s} + O(g^6); \quad (15)$$

where it is understood that $j_s - s_j = O(g^2 j_s)$. In order to derive Eq.(15), it is convenient to add and subtract s in the l.h.s., employ $s - M_0^2 = -b^{ZZ}(s) + (-b^{ZZ}(s))^2 = s + \dots$, and recall the expression for b^{ZZ} given in Eq.(16b) of Ref[3]. Eq.(15) explicitly shows two important properties: 1) as it involves the PT self-energy $b_1^{ZZ}(s)$, it is manifestly i independent 2) the zero of Eq.(15) occurs at $s = s$, so that the pole position is not displaced. For the Z case, the latter property was already derived in the particular case of the $i = 1$ gauges [5]. As explained in Refs.[5], [6], using the scaling approximation for $\text{Im } b_1^{ZZ}(s)$ one can transform Eq.(15) into the characteristic s dependent Breit-Wigner resonance employed in the LEP analysis, so that the connection with the LEP observables becomes explicit.

One can readily carry out the same analysis for the W self-energy. In this case there are no mixing complications but the R gauge dependence is governed by three parameters i ($i = W, Z, \gamma$). One finds

$$R_2^{WW}(s) = R_2^{WW}(s) j_{i=1} - g^2 R_1^{WW}(s) j_{i=1} F(i; s) + O(g^6); \quad (16)$$

$$F(i; s) = c_W^2 [(W - 1)_{WZ}(s) + (W \text{ } \$ \text{ } Z)] + s_W^2 [(W - 1)_{WW}(s) + (W \text{ } \$ \text{ } \gamma)]; \quad (17)$$

where $(i \text{ } \$ \text{ } j)$ is obtained from the preceding term by interchanging the indices in $(i \text{ } j)$ $i \rightarrow j$. The gauge dependence is contained in $F(i; s)$. Following the P-P method we obtain

$$R_2^{WW}(s) = -4g^2 R_1^{WW}(s) j_{i=1} - c_W^2 I_{ZW}(s) + s_W^2 I_{WW}(s) - g^2 R_1^{WW}(s) j_{i=1} F(i; s); \quad (18)$$

Again $R_2^{WW}(s) - R_2^{WW}(s)$ is i independent and in the interval $j_s - s_j = O(g^2 j_s)$ we find

$$b^{WW}(s) = R_1^{WW}(s) j_{i=1} + R_2^{WW}(s) j_{i=1} - 4g^2 (s - s) - c_W^2 I_{ZW}(s) + s_W^2 I_{WW}(s) + O(g^6); \quad (19)$$

Alternatively, the i independence of $b_2^{WW}(s)$ can be derived by directly evaluating $b_1^{WW}(s) + b_2^{WW}(s) - R_1^{WW}(s) - R_2^{WW}(s)$ in a general i gauge [2]. Using Eq.(19) the

propagator's denominator becomes

$$s - (M_0^W)^2 - b^{WW}(s) = (s - s_0) \left(1 - \frac{d}{ds} b_1^{WW}(s) \right) + O(g^6); \quad (20)$$

in analogy with the Z case.

In summary, by restricting s to the neighborhood $|s - s_0| = O(g^2 |s_0|)$ of the propagator's pole one can test the gauge dependence of the Z Z and W W self-energies through $O(g^4)$. In both cases we find that the P-P method leads to gauge independent amplitudes. Because of our restriction to the resonance region, and our neglect of $O(g^6)$ terms, this test amounts to a necessary rather than a sufficient condition. On the other hand, it is important to emphasize that this domain is of special physical significance.

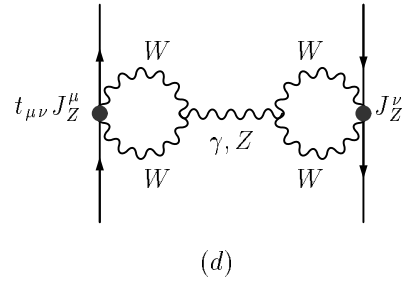
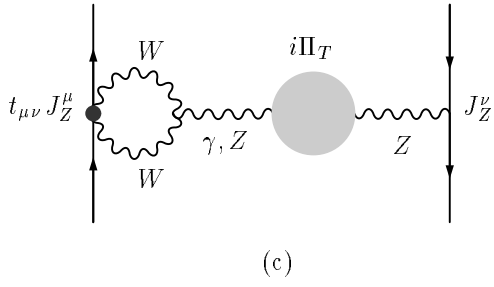
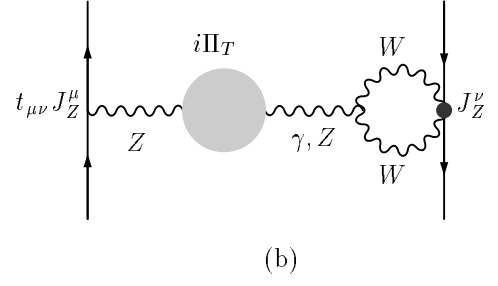
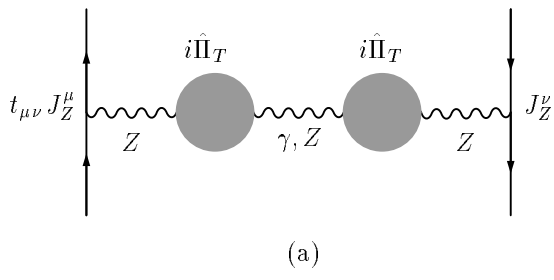
