CHIRAL SYMMETRY AT FINITE TEMPERATURE: LINEAR VSNONLINEAR -MODELS

Abstract

The linear O (N) sigm a model undergoes a symmetry restoring phase transition at nite temperature. We show that the nonlinear O (N) sigm a model also undergoes a symmetry restoring phase transition; the critical temperatures are the same when the linear model is treated in mean eld approximation and the nonlinear model is treated to leading plus subleading order in the 1/N expansion. We also carefully de ne and study the behavior of f and the scalar condensate at low temperatures in both models, showing that they are independent of eld rede nition.

1 Introduction

The O (N) model as a quantum eld theory in d+1 dimensions [1] is a basis or prototype for many interesting physical systems. The bosonic eld has N components. When the Lagrangian is such that the vacuum state exhibits spontaneous symmetry breaking it is known as a sigma model. This is the case of interest to us here. In d = 3 space dimensions the linear sigma model has the potential

where is a positive coupling constant and f is the pion decay constant. The model is renormalizable. In the limit that ! 1 the potential goes over to a delta function constraint on the length of the eld vector and is then known as a nonlinear sign a model.

The classical lim it of the eld theory is obtained by neglecting or freezing out the time variable, leaving a eld theory in d dimensions. In this lim it only the zero M atsubara frequency of the full d + 1 dimensional theory contributes to the partition function, and the temperature acts like a coupling constant. One then has a description of an O (N) H eisenberg magnet in d dimensions which is a model for real material system s. This subject has a vast literature [2, 3].

When N = 4 one has a model for the low energy dynamics of Q uantum Chromodynamics (QCD). More explicitly, it is essentially the unique description of the dynamics of very soft pions. This is basically due to the isomorphism between the groups O (4) and SU (2) SU (2), the latter being the appropriate group for two avors of massless quarks in QCD. The linear sigm a model, including the nucleon, goes back to the work of G ell-M ann and Levy [4]. This subject also has a vast literature. In the last decade much work has been done on chiral perturbation theory which starts with the nonlinear sigm a model and adds higher order, nonrenorm alizable, term s to the Lagrangian, ordered by the dimensionality of the coe cients or eld derivatives [5]. This whole program really has its origins in the classic works of W einberg [6, 7].

F inally, the standard m odel of the electroweak interactions, due to W einberg, Salam, and G lashow has an SU (2) doublet scalar H iggs eld responsible for spontaneous sym - m etry breaking. If one neglects spin-1 gauge elds the H iggs sector is also an O (4) eld theory.

All of these limits are interesting to study at nite temperature. M agnetic m aterials typically undergo a phase transition from an ordered to a disordered state. If quarks are m assless, QCD is expected to undergo a chiral symmetry restoring phase transition [8, 9]. Thism ay have implications for high energy nucleus-nucleus collisions; see especially [10, 11] in this respect. The electroweak theory is expected to have a symmetry restoring phase transition, too, at which point the baryon number of the early universe would have been nally determined [12].

The linear sign a model was studied in the classic papers on relativistic quantum eld theories at nite temperature [13, 14, 15]. The usefulness of leaving N as a parameter

arises from the fact that there is only one other parameter in the problem, the quartic coupling constant (f just sets the scale and is held xed in our considerations). For QCD at least, and perhaps for electroweak theory too (this is not known, it is related to the Higgs mass) the appropriate limit seem stobe 1, possibly even in nity. This limit is the nonlinear sigm a model. The only proposed expansion parameter for this model is $1/N \cdot For N = 4$ the rst few terms in this expansion may not be quantitatively reliable but it is a good start. At least in the theoretical world we can imagine N as large as we wish. Presum ably the physics does not change qualitatively with N as long as it is greater than one.

O ur basic physical interest in this paper is QCD. Am ong the questions that are routinely asked are: Does QCD have a nite temperature phase transition? If so, is it associated with color decon nement, or with the restoration of the spontaneously broken chiral symmetry, or are they inextricably intertwined? W hat would be the order of this phase transition? W hat would be its critical temperature? How do pions, the Goldstone bosons of QCD, decouple as the temperature is raised? How do the quark and gluon condensates behave as functions of temperature? Restricting our attention to N_f avors of massless quarks, there are strong arguments [8, 9] and numerical lattice computations [16] which say that for N_f = 2 there is a second order phase transition and for N_f 3 there is a rst order phase transition. Lattice calculations also suggest strongly that chiral symmetry is restored and color is decon ned at the same temperature [17].

The QCD Lagrangian is invariant under U (N_f) U (N_f) transform ations. This is isomorphic to SU_L (N_f) SU_R (N_f) U_{baryon} (1) U_{axial}(1); that is, left- and right-handed chirality transform ations of the quark elds, baryon number conservation, and the fam ous axial U (1) symmetry. The axial U (1) is broken by quantum e ects, particularly instantons. Baryons can be added to the sigm a model if desired, but we shall not do so. The O (N) sigm a model has no vestige of the axial U (1), although there do exist versions of the sigm a model based on other groups in which it can be incorporated. In general SU (N_f) SU (N_f) is isomorphic to O (N $_{f}^{2}$) only for N_f = 2. O therwise the interactions are di erent. This restricts any potential quantitative results of our analysis of the O (N) model to QCD to N = 4. The very interesting issue of whether the axial U (1) symmetry is restored at high tem peratures or not cannot be addressed here [18].

One must be careful in understanding how sigm a models are being applied to the study of QCD at nite temperature. At very low temperatures one may argue that the only degrees of freedom which are excited are pions. One may then use chiral perturbation theory to study the therm odynam ic properties, as in the classic works of Leutwyler [19]. At the very lowest energies this is just the nonlinear sigm a model. Note that in this domain one is really studying a full 3+1 dimensional quantum eld theory. On the other hand, near the critical temperature one may argue [8, 9] that the soft long wavelength modes of QCD are in the same universality class as the O (4) Heisenberg magnet in 3 spatial directions. Now one is studying a classical eld theory. The parameters of the excite free energy functional near the critical temperature may not be simply related to

the parameters of the sigm a eld theory model at very low tem perature. Support for this point of view comes from lattice QCD computations which show that critical exponents are consistent with those of the O (4) Heisenberg magnet in 3 spatial dimensions [20]. Conversely, it has been pointed out that in certain models with composite bosons these arguments might break down [21] because the compositeness is important near a second order phase transition. A particularly useful observation is that long range correlation functions may be dominated by the soft modes (pions, sigm a meson, ...) near the critical tem perature but the equation of state itself is not [22, 18]; it is dominated by the myriad of other degrees of freedom (Hagedom or Particle D at Book compendium of mesons and baryons or all of the colored quarks and gluons).

We would like to shed some light on just a few of the issues relating to the above discussion. First, from the outset we restrict our attention to the linear and nonlinear sigm a models in 3+1 dimensions. W ithin these con nes we address three speci c topics: the existence and nature of a chiral symmetry restoring phase transition, the low temperature dependence of the \pion decay constant", and the low temperature dependence of the \quark condensate". The rst of these involves folk bre, and the answer, at least in the nonlinear sigm a model, is either obvious to the reader or else very surprising. For the latter two we point out some popular m isconceptions and reproduce the existing results (when N = 4) while showing that they are invariant under eld rede nition.

First consider the linear sign a model. At zero tem perature the elective potential has a shape similar to the bottom of a wine bottle. It is minimized by a nonzero value of the eld; this is the condensate. A s the tem perature is increased, the radius of bottom of the potential shrinks, and goes to zero at a critical tem perature of $T_c =$ 12=(N + 2) f. It is a second order symmetry restoring phase transition. In the nonlinear sign a model j \hat{f} is xed at the value f². Therefore, it would seem, chiral symmetry breaking is built into the Lagrangian and there is no possibility of restoring it at nite tem perature. A nother way of saying this is that there is no order parameter which can go to zero at nite tem perature. At least this is the folklore in much of the nuclear and particle physics community! On the other hand, the critical tem perature in the linear model is independent of in the mean eld approximation, so one can take the limit ! 1 and still have a phase transition! The counter argum ent to this is that the phase transition can go away in the lim it and so nothing special happens at the aforem entioned value of T_c in the nonlinear model. We shall study the nonlinear model directly in section 2 at nite temperature in the large N approximation. To leading order in N we shall show quite straightforwardly that despite the constraint the nonlinear model has a second order phase transition at a critical tem perature equal to that of the linear model. We shall show that this persists to the next to leading order in N, although here we must make an additional high energy approximation. The order parameter is identied as is the nature of the two phases.

Next we study what is meant by \the pion decay constant on nite tem perature". At

zero tem perature a common de nition is

which relates it to the matrix element of the axial vector current of QCD between the vacuum state and a one pion state of momentum p. It is di cult, though perhaps not impossible, to generalize this de nition to nite temperature. Within the linear sigm a model one sometimes sees in the literature f (T) identied with the therm alaverage of the sigm a eld, v = h i = h i, which is the radius of the bottom of the elective potential. In the nonlinear sigm a model this radius is necessarily xed at f. How then can one understand the result of G asser and Leutwyler [23]

which was obtained at low temperature in chiral perturbation theory? (At this order chiral perturbation theory and the nonlinear sigm a model are the same.) This issue is addressed carefully in section 3.

Finally, a quantity of much interest, especially for the application of QCD sum rules at nite temperature, is the temperature dependence of the quark condensate. Gasser and Leutwyler [23] and also Gerber and Leutwyler [24] computed this quantity at low temperature to be

This is obviously a dimension temperature dependence than that of f (T). In addition, one wonders how it is possible to obtain information on quark condensates from a theory which has no explicit reference to quarks? These and related topics are studied in section 4.

Before beginning the technical part we remark that we will deal with vacuum divergences in a simple way: we ignore them. That is, we will always drop temperature independent divergent quantities from our expressions. The linear sigm a model is renormalizable and this neglect can easily be rectiled; it does not change any of the principle results. The nonlinear model is not renormalizable, although one may consider it to be the ! 1 limit of the linear model. The short distance physics of these models in the context of QCD is not correct anyway.

Put another way, it is known that the partition function can be expressed in terms of the vacuum scattering amplitudes, or S-matrix elements, for arbitrary reactions involving n particles going in and m particles coming out [25]. This is the relativistic virial expansion. Consider, for example, a real scalar eld with a quartic interaction [26]. The one loop contribution to the partition function is just the free Bose gas expression. The two bop contribution corresponds to two particle scattering with the amplitude evaluated at the tree level. The three loop contribution corresponds to two particles in and four particles out, plus three particles in and three particles out, plus four particles in and two particles out, with all scattering amplitudes evaluated at tree level. The three loop contribution also has a part which corresponds to a vacuum one loop correction to the two particle scattering amplitude. By dropping all vacuum loop divergencies we are doing a virial expansion with the S m atrix evaluated at the tree level.

An early system atic study of various approximation schemes for the linear sigma model at nite temperature is [27]. An overall introduction to relativistic quantum eld theory at nite temperature is [28]. A somewhat analogous study of the lattice O(N) Heisenberg model is [29].

2 Chiral Phase Transition

It is well known that the linear O (N) sigm a model in 3+1 dimensions has a second order phase transition when treated in the mean eld approximation. We brie y repeat that analysis here as a warm up and precursor to the study of the nonlinear sigm a model which is not nearly as well studied. We must emphasize that the direct quantitative applicability to QCD is limited by at least two factors. The rst is: These sigm a models do not have quark and gluon degrees of freedom and so one can never describe high temperature quark-gluon plasm a with them. In addition, the compositeness of the bosons may even in uence the phase transition itself [21]. The second is: The group SU (N $_{\rm f}$) SU (N $_{\rm f}$) is isom orphic to 0 (N $_{\rm f}^2$) only for N $_{\rm f}$ = 2 and this limits the analogy to two avors of massless quarks. Indeed, lattice com putations of the nonlinear sigm a model in 3 dimensions based on other groups show rst order behavior [30].

The conventions and notation used here are consistent with those of [28].

2.1 Linear sigm a model

The linear sigm a model Lagrangian is

where is a positive coupling constant. The bosonic eld has N components. Rather arbitarily we de ne the rst N 1 components to represent a pion eld and the last, N 'th, component to represent the sigma eld. Since the $0 \ N$) symmetry is broken to an $0 \ N$ 1) symmetry at low temperatures, we immediately allow for a sigma condensate v whose value is temperature {dependent and yet to be determined. We write

In terms of these elds the Lagrangian is

The action at nite temperature is obtained by rotating to imaginary time, = it, and integrating from 0 to = 1=T. (However, we keep the M inkowski metric; hence, $0 = 0 = 0 \times 10^{-10} \text{ m} = 0 = 0 \times 10^{-10} \text{ m} = 0^{-10} \text{ m} = 0^{-10} \text{ m}$.) The action is dened as

At any temperature v is chosen such that h = 0. This eliminates any one particle reducible (1PR) diagrams in perturbation theory, leaving only one particle irreducible (1PI) diagrams.

At zero tem perature the potential is minimized when v = f. The pion is massless and the sigm a particle has a mass of 2 f. The Goldstone theorem is satisticed. Lin and Serot [31] have argued that the sigm a meson should not be identified with the attractive swave interaction in the interaction, which is responsible for nuclear attraction. R ather, they argue that the sigm a meson should have a mass which is at least 1 GeV if not more. This means that is on the order of 50 or greater.

The simplest approximation at nite temperature is the mean eld approximation. One allows for v to be temperature dependent; hence the elective masses are temperature dependent as well. However, interactions among the particles or collective excitations are neglected. The pressure includes only the contribution of the condensate and of the therm almotion of the independently moving particles. Thus

The pressure of a free relativistic boson gas can be written several ways:

This is a relatively simple but surprisingly powerful rst approximation which allows one to gain much insight into the behavior of relativistic quantum eld theories at high temperature. It was used in all the pioneering papers.

O ne expects that as the tem perature is raised, them al uctuations will tend to disorder the condensate eld v, and at su ciently high tem perature it m ay even disappear. If there is a second order phase transition then the correlation length should go to in nity, which is equivalent to the elective sigm a m assigning to zero. With such an expectation one m ay expand the free boson gas pressure about zero m ass to obtain

Since the masses are proportional to the square root of it is generally inconsistent to retain the cubic term in m because there exist loop diagrams which are not included in the mean eld approximation but which contribute to the same order in . Therefore we take

where the pion and sigm a masses have been expressed in term s of , v and f . M axim izing the pressure with respect to v gives

This result is easily understood. Going back to Eq. (7) we can dimensionate $\ln Z$ with respect to v with the result that

The condensate goes to zero at a critical tem perature given by

A bove this tem perature therm all uctuations are too large to allow a nonzero condensate. It is a straightforward exercise to show that the pressure and its rst derivative is continuous at T_c but that the second derivative is discontinuous. This is therefore a second order phase transition.

There are two major problems with the mean eld approximation as described. The rst is that the pion has a negative mass squared at every temperature greater than zero. Not only is the Goldstone theorem not satistical, but there are tachyons as well! The

sigm a particle also gets a negative m ass squared at tem peratures above q = $(N + 2) f < T_{c}$. This violation of basic physical principles is resolved by recognizing that the nite tem perature corrections to the squared m asses are proportional to T^{2} , and that one bop self-energy corrections, not included in the mean eld analysis, are of the same order. This can be understood with the following analysis.

At high tem peratures, when the m asses can be neglected in the loops, the m ean eld result is obtained by combining Eqs. (8) and (13).

The fullone loop self-energies for pions and the sigm a meson are drawn in Figures 1 and 2. If one chooses h i = 0 then there are no 1PR diagrams and the tadpoles should not be included; they are already included in the temperature dependence of v. One may check this by xing v = f and then computing the tadpole contributions to the elective masses. One gets precisely Eq. (17). The diagrams involving the 4-point vertices contribute an amount (N + 2) T²=12 to both the pion and sigm a meson self-energies. When evaluated in the high temperature approximation and at low frequency and momentum the 1PI diagrams involving the 3-point vertices may be neglected. (This follows from power counting. These diagrams involve two propagators instead of one, and so are only logarithm ically divergent in the UV in the vacuum. The other diagram s are quadratically divergent, which leads to a T² behavior at nite temperature.) When all contributions of order T² are included the pole positions of the pion and sigm a propagators move with the result that below T_c

The Goldstone Theorem is satised, there are no tachyons, and restoration of the full symmetry of the Lagrangian above T_c is evident.

The second major problem is that long wavelength uctuations very near the phase transition cannot be treated with perturbation theory because the self-interacting boson

elds become massless just at the transition. A lthough this is a well{known problem in the statistical mechanics of second order phase transitions, exactly how it a ects the critical temperature is not known for the linear sigma model in 3 + 1 dimensions. This is a topic for further study. The result presented here must be accepted for what it is: a one loop estimate of the critical temperature.

2.2 Nonlinear sigm a model

The nonlinear sigm a model may be de ned by the Lagrangian

Because the length of the chiral eld is xed and cannot be changed by them al uctuations it is often said that chiral sym m etry breaking is built into this model and therefore there can be no chiral sym m etry restoring phase transition. On the other hand, the linear sigm a model does undergo a sym m etry restoring phase transition. Taking the quartic coupling constant to in nity essentially constrains the length of the chiral eld to be f just as in the nonlinear model. The critical tem perature, how ever, is independent of

at least in the mean eld approximation. So it would seem that the phase transition survives. If this is true, then one ought to be able to derive it entirely within the context of the nonlinear model. That is what we shall do, although it involves a lot more e ort than treatment of the linear model in the mean eld approximation. Since the only parameter in the model is f, and we are interested in temperatures comparable to it, we cannot do an expansion in powers of T=f. The only other parameter is N, the number of eld components. This suggests an expansion in 1=N.

Begin by representing the eld-constraining delta function by an integral.

A swith the linear model, we denote the rst N 1 components of to be the pion eld and the last component to be the sigma eld. We allow for a zero frequency and zero momentum condensate of the sigma eld referred to as v. Following Polyakov [32] we also separate out explicitly the zero frequency and zero momentum mode of the auxiliary eld b⁰. Integrating over all the other modes will give us an elective action involving the constant part of the elds. We will then minimize the free energy with respect to these

constant parts, which is a saddle point approximation. Integrating over uctuations about the saddle point is a nite volum e correction and of no consequence in the therm odynamic limit. The Fourier expansions are

O ne must remember to exclude the zero frequency and zero momentum mode from the summations. The eld must be periodic in imaginary time for the usual reasons, but there is no such requirement on the auxiliary eld b, hence $!_n = 2 nT$ and $_n = nT$. Since the eld b has dimensions of inverse length squared we inserted another factor of T so as to make its Fourier amplitude dimensionless, as they are for the other elds. The action then becomes

Note that terms linear in the elds integrate to zero because $h_i i = h i = hbi = 0$.

An elective action is derived by expanding exp(S) in powers of b and integrating over the pion and sigma elds. The term linear in b vanishes on account of $\mathcal{B}(0;0) / \mathbf{hbi} = 0$. The term proportional to \mathbf{b}^2 is not zero and is exponentiated, thus summing a whole series of contributions. The term proportional to \mathbf{b}^3 is not zero either and it, too, may be exponentiated, summing an in nite series of higher order terms left out of the order \mathbf{b}^2 exponentiation. The elective action is an in nite series in b. The coel cients are frequency and momentum dependent, arising from one loop diagrams. The coel cient of the term quadratic in b in S_e is jllustrated schematically in Figure 3. In addition, each successive term is suppressed by 1 = N compared to the previous one. This is the large N expansion.

The propagators for the pion and sigm a elds are of the usual form

This is a second order phase transition since there is no possibility of metastable supercooled or superheated states.

It is rather am using that, in leading order of the large N approximation, the elementary excitations are massless below T_c , become massive above T_c , and at asymptotically high temperatures move nonrelativistically.

The result to rst order of the large N expansion provides good insight into the nature of the two{phase structure of the nonlinear sigm a model, but it is not quite satisfactory for two reasons. First, it predicts N massless G oldstone bosons in the broken symmetry phase when in fact we know there ought to be only N 1. Second, the square of the critical tem perature is $12f^2 = N$ whereas it is $12f^2 = (N + 2)$ in the linear sigm a model in mean eld approximation; we expect them to be the same in the limit ! 1. Both these problem s can be rectiled by inclusion of the next to leading order term in N, namely, the contribution of the b{ eld.

It is natural to expect that the b{ eld will contribute essentially one negative degree of freedom to the T⁴ term in the pressure so as to give N 1 G oldstone bosons in the low temperature phase. Therefore we move one of the N degrees of freedom and put it together with the b contribution as

W e leave it as an exercise for the reader to compute the asymptotic behavior of the mass with the inclusion of the subleading terms in N .

The results obtained immediately above used an approximation for which we referred to as a high energy approximation. Relaxing this approximation can be done albeit at the cost of a numerical calculation. We do not attempt that in this paper. Of course, one should also go beyond the mean eld approximation in the linear model.

3 f at Low Temperature

Consideration of correlation functions at nite temperature is more involved than at zero temperature. Lorentz invariance is not manifest because there is a preferred frame of reference, the frame in which the matter is at rest. Thus spectral densities and other functions may depend on energy and momentum separately and not just on their invariant s. A lso, the number of Lorentz tensors is greater because there is a new vector available, namely, the vector u = (1,0,0,0) which speci es the rest frame of the matter.

For a given four-m om entum q it is useful to de ne two projection tensors. The stone, $P_{\rm T}$, is both three- and four-dimensionally transverse,

In general the spectral densities depend on q^0 and q separately as well as on the tem perature. In the vacuum we can always go to the rest fram e of a massive particle, and in that fram e there can be no di erence between longitudinal and transverse polarizations, so that $_L = _T = . W$ e also observe that $P_L + P_T = (g \quad qq = q^2)$. The pion, being a massless G oldstone boson, is special. It contributes to the longitudinal axial spectral density and not to the transverse one. In vacuum

This smears out the delta function into som ething like a relativistic B reit-W igner distribution. Fortunately, the G oldstone T heorem [36] requires that there be a zero frequency excitation when the momentum is zero. (For a proof applicable to relativistic quantum eld theories at nite tem perature see [28].) T his implies that the width must go to zero at q = 0 which results in a delta function at zero frequency. Explicit calculations support this assertion [37, 38, 39]. Therefore it seem s to make sense to de ne

Physically this means that the pion decay constant at nite tem perature measures the strength of the coupling of the G oldstone boson to the longitudinal part of the retarded axial vector response function in the limit of zero momentum.

We shall study the pion's contribution to the spectral density only at tem peratures small compared to f. We shall study both the nonlinear and the linear sigm a models. At low tem peratures the sigm a meson's contribution as a material degree of freedom is frozen out and one might expect the same dynamics to be operative in both models; in other words, one may expect the result to be the same and so independent of . For tem - peratures approaching T_c the problem is more di cult and is left for future investigation.

3.1 Nonlinear sigm a model

The nonlinear sigm a model was de ned at the beginning of section 2.2. One can make a nonlinear rede nition of the eld without changing the physical content of the theory. Various rede nitions may be found in the literature. We will not list the most common ones, and then we will compute f (T) for each of them, thereby illustrating that one always gets the same result. It is interesting to see how this comes about; it is also reassuring that it does.

A convenient way to express the sigm a and pion elds which explicitly contains the constraint is

The (;) representation is cumbersome because of the constraint, although it can be handled by the Lagrange multiplier method of section 2. However, it is inconvenient for exposing the physical particle content and for doing perturbation theory in terms of physical particles. Am ong the three physical representations we choose to work with here, it is interesting to note the range of allowed values of the elds. The magnitude of the p eld can range from zero to in nity, the magnitude of the { eld can range from 0 to f, and the magnitude of the { eld can range from 0 to f. This distinction is important when dealing with nonperturbative large amplitude motion; whether it makes any di erence in low orders of perturbation theory is not known to us.

The rst step in our quest to extract the temperature dependence of f from the theory is to obtain the form of the axial vector current in terms of the chosen elds. Starting from

The nalcontribution comes from the correlation function of a pion at point x with three pions at point y. Again, standard diagram matic or functional integral techniques

m ay be used. To express the answers, we gather together the contributions from the bare propagator, from the one loop self-energy, and from this correlation function, and quote the coe cient of the term $f^2 q^2$ (q^2) in the longitudinal part of the axial vector spectral density.

In all three cases the results are the sam e and am ount to a tem perature dependence of

3.2 Linear sigm a m odel

It is now not surprising to discover that the linear sigm a model gives the same result for f (T) at low temperature as the nonlinear sigm a model. This is because the sigm a meson is very heavy at low temperature and cannot contribute materially the way the pions do. However, the way in which it works out is very diment.

Let us go back to the axial vector current before shifting the sigm a eld.

By maxim izing the pressure (m in im izing the elective potential) with respect to v at each temperature we electively sum all tadpole diagrams, leaving only 1PI diagrams in any subsequent perturbative treatment. If this is done, one's inclination is to identify v(T) with f (T). This is wrong; f (T) has additional contributions, as we shall now see.

The rst contribution to $f^2(T)$ does come from $v^2(T)$ since it involves the cross term of $(a^a(x))$ with $(a^a(y))$. Following the analysis of section 2.1, but at low temperature

rather than high, we simply leave out the contribution of the heavy sigm a meson. This gives

There is another, nonlocal, contribution to the vertex shown in F igure 5, corresponding to the em ission and absorption of a virtual sigm a meson. One m ight think that it is suppressed by the large sigm a mass, $m^2 = 2 f^2$, but in fact this is compensated by the coupling constant in the extra vertex. Evaluation of this diagram gives a contribution to $f^2(T)$ of $T^2=6f^2$.

Finally there is a contribution coming from the dressed pion propagator analogous to the nonlinear sigm a model. The full one bop 1PI pion self-energy diagram swere already shown in Figure 1. We know that the sum of the momentum independent pieces is zero on account of Goldstone's Theorem . We only need the contribution which is quadratic in the energy and momentum of the pion. This can only arise from the so-called exchange diagram involving two vertices, also shown in Figure 5. In imaginary time (Euclidean space) it is

Since T m it is easy to extract the piece quadratic in the momentum. Analytically continuing to M inkowski space (! $_n$! iq_b) it is $q^2T^2=12f^2$.

The residue of the pion pole in the axial vector correlation function can now be obtained by adding the vacuum contribution, the pion self-energy correction, and the tadpole and nonlocal vertex corrections as follows.

is identical to that of the nonlinear sign a model. We remark that this cannot be used to compute the critical temperature since it was obtained under the condition that T f.

4 Scalar Condensate at Low Tem perature

The scalar condensate is de ned as jh ij. Our convention has been to allow the last, N 'th component of the eld to condense, and to refer to this as either v (if the eld is shifted) or h i (if the eld is not shifted). In this section we use the latter convention.

It is interesting to ask what happens to this condensate as a function of tem perature in the nonlinear model. The constraint as an operator equation is $f^2 = 2^2$ and as a therm all average is $f^2 = h^2 i$; it is not $f = \frac{1}{2}h^2 i$. The condensate indeed can change with tem perature. In fact we can quite easily compute it to two loop order. Before doing so, we rst discuss the connection of this condensate with the quark condensate hqqi.

In two avor QCD one offentines associates the sign a and pionelds with certain bilinears of the quark elds.

This association is made because the quark bilinears transform in the same way under SU (2) SU (2) as the corresponding meson elds. The dimensions don't match so there must be some dimensionful coe cient relating them; this coe cient could even be a function of the group invariant $^2 + ^2 (qq)^2 (q_5 q)^2$. Does this particular combination of four{quark condensates change with temperature? The temperature dependence of the four{quark condensates at low temperatures was rst calculated in [41] with the help of the uctuation-dissipation theorem. The contribution of pions alone was later discussed in [42] using soft pion techniques. >From [41, 42] one can read o the two condensates separately:

Therefore there is no correction to this group invariant to order $T^2 = f^2$ inclusive.

This result is consistent with our analysis of the nonlinear sigm a model in sections 2.2 and 3.1.

Now let us return to the business of computing the temperature dependence of the scalar condensate to one and two loop order. In terms of the three representations used in section 3.1 the sigma eld is

To second order in the pion eld all three representations are the same. Using the free eld expression for the therm all average of the eld squared we get

For N = 4, the only value for which we can quantitatively compare with QCD, this agrees with the result of G asser and Leutwyler as quoted in Eq. (3); it was also derived in an independent way by Eletsky [42].

The coe cient of the term which is fourth order in the pion eld di ers in sign and magnitude among the three representations. It would be a miracle if the therm al average of $1 = 2 = f^2$; cos(=f) and the W einberg expression were all the sam e! But regarding the order $(T^2=12f^2)^2$ we must recognize that the term which is second order in the pion eld gets modi ed due to a one loop self-energy. This was computed for each representation in section 3.1 and the results listed in Eq. (77). The term fourth order in the pion eld can be evaluated using free elds. The result is

where the second term in each line comes from the square of the pion eld and the last term comes from the pion eld in fourth order. The sum of all terms is identical in all three representations.

The m iracle happens. It is a consequence of the fact that physical quantities m ust be independent of eld rede nition. W hat is more, for N = 4 it agrees with the result of G asser and Leutwyler quoted in Eq. (3). However, we emphasize once more that this expression should not be used to infer a critical tem perature because it was derived under the assumption that the tem perature is sm all com pared to f .

5 Summary and Conclusion

In this paper we have focussed on the linear and nonlinear versions of the sign a model based on the group 0 (N) at nite temperature. Models of this kind are prototypes for physical theories, such as QCD and electroweak theory. Ourmain goalwas to understand, both conceptually and mathematically, whether the nonlinear model has a symmetry restoring phase transition analogous to that of the linear model. We did show that the nonlinearm odel has a second order phase transition by making use of the 1/N expansion. To leading and subleading orders the critical tem perature is even the same as in the linear model. (This cannot be true in general; eventually there must be some dependence in the linear model on the value of the quartic coupling .) This expansion was facilitated by the introduction of a Lagrange multiplier eld. In this way we could see that there is a condensate at low temperature; this condensate decreases in just the right way so as to conserve the constraint on the eld vector. There is one particular tem perature for which the therm ally averaged constraint is satis ed with no condensate and with all excitations m assless. This is the critical tem perature. W e had to m ake a m athem atical approximation at the subleading order to get an analytical result. We referred to this as a \high energy approximation". It is directly analogous to what one does in the mean eld approximation to the linear model. It would be interesting to relax this approximation; this is left as a future project.

A nother goal was to carefully de ne and show how to compute the \pion decay constant" and the \scalar quark condensate" at nite temperature within the scope of these models. The de nitions also apply to full QCD but, of course, the results will generally be di erent. Only at very low temperatures and for N = 4 will the results be directly applicable to QCD for the reasons discussed in the introduction. Even within the context of the sigm a models, how ever, it would be interesting to compute the next order correction to f^2 (T) at low temperature. It would also be interesting to compute f^2 (T) near T_c . These computations are now underway.

In this paper we have not computed anything more complicated than a one loop diagram. Even the calculation of the \scalar quark condensate" to order $(T^2=12f^2)^2$ only required know ledge of one loop diagram s. W hat other interesting physical quantities can the reader compute in these models to one loop order?

N atural extensions of these m odels to better approxim ate full Q C D m ay be envisioned. Following the philospophy of chiral perturbation theory one may include higher derivative term s in the Lagrangian. One may also add other mesonic and baryonic elds, especially the vector mesons. However, no matter how many extra term s are added, one is still restricted from discussing the quark-gluon plasma.

If the H iggs particle turns out to have an exceptionally large m ass, then a reasonable rst approximation to the electroweak phase transition m ight begin with a nonlinear version of the G lashow {W einberg{Salam m odel. G auging the nonlinear sigma m odel would be a step in this direction. This topic is also under investigation.

We hope to have stimulated the reader to make further progress on these very interesting topics at nite temperature!

Figure 5: Vertex and self-energy contributions to the axial vector correlation function in the linear sigm a model. See Figure 1 for rem arks.









