# D i ractive H eavy F lavour P roduction at the Tevatron and the LH C

#### A bstract

We give predictions for di ractive heavy avour production at the Tevatron and the LHC in leading {order approximation. In the framework of these studies we use three dierent models for the partonic structure of the Pomeron recently proposed by Stirling and Kunszt. These Pomeron models are, despite being the to the same directive deep inelastic HERA data, very dierent in their parton content and taken together provide a powerful tool to probe the structure of the Pomeron. All models satisfy GLAP evolution and show a signicant Q  $^2$  dependence. We give numerical predictions for single as well as double directive cross sections assuming a Donnachie {Landsho {type Pomeron ux factor.}

#### 1 Introduction

Recent observations at HERA [1,2] have provoked a renewed interest in an already long standing concept, the concept of the Pomeron in high energy scattering. This idea was rst introduced by Pomeranchuk in 1958 [3] to explain the fact that in the high energy limit the measured hadronic cross sections remain (approximately) constant. This asymptotic behaviour was explained in terms of a Regge trajectory (jt) with the Pomeron trajectory having the intercept (0) 1.

P resent and future generations of hadron {hadron and lepton {hadron colliders m ay be able to actually observe the Pom eron in di ractive events. We shall characterise an event as single di ractive if one of the colliding hadrons em its a Pom eron. If that scatters o the other hadron. A single di ractive reaction would therefore correspond to

in which the intact hadron iem its a Pomeron (hadron i! hadron i + H) which interacts with hadron j (hadron j + E! X) leading to the reaction of Eq. (1). Hadron i is detected in the nal state with a large longitudinal momentum fraction. Hard di ractive events, events with a large momentum transfer Q (1=Q 1 fm), are also characterised by a second feature: the absence of hadronic energy in certain angular regions of the nal state phase space. These rapidity gaps, reported by the ZEUS and H1 collaborations at HERA, are suggestive of a colour neutral object, the Pomeron, emitted from the incoming proton. Events full ling the conditions of large rapidity gaps and a (highly excited) hadron rem nant in the nal state are called single di ractive to distinguish them from those in which both colliding hadrons remain intact as they each emit a Pomeron, the so{called double di ractive events. The H 1 collaboration reported a fraction of about 6% of deep inelastic scattering events being single di ractive [4]. The HERA data suggest that E has a hard structure. This observation has also been given support in an earlier UA8 experiment. A partonic structure of the Pomeron was rst proposed by Ingelman and Schlein in 1985 [5] to calculate high  $p_T$  (jet production in single di ractive dissociation. The discovery of diffective diffets (high  $p_T$  (jets) with  $p_T > 8$  G eV at the CERN pp (collider in 1988 by the UA8 collaboration [6] tted exactly with their prediction.

In this paper we give predictions for single and double di ractive heavy avour production at the Tevatron pp{collider (  $\bar{s}=1.8$  TeV) and the LHC pp{collider, with a centre{of{m ass energy }  $\bar{s}=10$  14 TeV. By heavy avour we mean QQ production with Q = c (charm), b (bottom) or t (top). Even though several tests of di ractive W , Z or Higgs production [7, 8, 9, 10] have already been proposed, we shall focus especially on QQ states as their cross sections turn out to be typically larger and this makes their observation, especially in the di ractive context, easier in principle. We shall employ di erent aspects all deduced from collider physics phenomenology to create a solid model for di ractive scattering via Pomeron exchange.

The em ission of a Pom eron from a fast {m oving hadron will be treated in the fram ework of the D onnachie{Landsho model [11] of a reggeised, non{perturbative Pom eron. In the literature this type of Pom eron is called soft to discern it from the perturbative (hard) Pom eron. The number of Pom erons em itted by a hadron is described by the ux factor  $f_{\mathbb{H}=i}(x^{\mathbb{H}};\mathfrak{f})$  where i stands for any hadron. The longitudinal momentum fraction  $x^{\mathbb{H}}$  of the Pom eron and the t{channel invariant momentum transfer to the Pom eron fully determ ine the em ission factor  $f_{\mathbb{H}=i}(x^{\mathbb{H}};\mathfrak{f})$ . As will be discussed in Section 2, a Regge factor is imbedded in the ux factor instead of a Pom eron propagator.

The success of this prediction has been exploited to expand the ideas of the parton model to the Pom eron. The Pom eron, being a colour neutral object carrying the quantum numbers of the vacuum, should be made of qq pairs and/or gluons. Factorisation [12] de nes the directive structure function  $F_2^D$  (x;Q²;x<sup>H</sup>; †;) as a product of the structure function of the Pom eron  $F_2^H$ (x;Q²) and the ux factor, i.e.

M easuring the directive structure function  $F_2^D$  and assuming a particular ux (emission) factor  $f_{H=1}(x^H;t)$  gives information on the Pomeron structure function  $F_2^H(x;Q^2)$  and hence on the parton content of the Pomeron. Because factorisation is assumed to give a universal picture of the Pomeron structure, the HERA data on  $F_2^H(x;Q^2)$  can be used to give predictions for hard directive scattering at hadron (hadron colliders. Comparing these predictions with measurements allows the factorisation hypothesis to be tested.

This leads back to the fact that  $F_2^D$  has recently been measured at HERA [13] and thus provides new information on the partonic structure of the Pomeron. The data still super from large errors but nevertheless allow a tofpossible parton distributions inside the Pomeron. This has been done for example in Refs. [8, 14, 15]. In particular, in Ref. [8] three Pomeron models were proposed to trecent H1 data [13]. At this stage it has not been possible to decide experimentally whether the Pomeron is more gluonic or quark (like { deep inelastic scattering (D IS) only gives information on the quark content. Taking this deciency into account, the three models range from pure glue up to pure quark content at the starting scale  $Q_0 = 2 \text{ GeV}$ . While the quark content in each of the three models turns out to be rather similar, the gluon contents dier from soft to hard. No momentum sum rule for the distributions is imposed and an overall normalisation factor is incorporated into the ux factor, as described in Ref. [15]. A more detailed discussion can be found in Section 3.

The aim softh is paper are as follows. We want to show how the combination of Regge theory and factorisation can be applied to calculate diractive cross sections, especially in the light of recent experimental  $F_2^{\,\mathrm{D}}$  data. The theory of this is reviewed in Section 2. So far the theory has been mostly applied to single diractive events. The reason is that

double di ractive cross sections at present and future colliders are generally too small to play a pivotal or even measurable role. But especially after experiences with top quark production and recent measurements of charm and bottom quark total cross sections at the Tevatron [16] and elsewhere, it is worth looking for heavy avour production in both single as well as double di ractive cross sections. Future measurements at high energy hadron (hadron colliders together with our predictions could be a powerful step towards a better understanding of the Pomeron structure, in particular to reveal a gluonic, quark (like or mixed Pomeron. We shall also consider the next (generation collider, the LHC, for this purpose. With a centre (of (mass energy  $\frac{P}{S} = 10 \text{ TeV}$ , we shall show that double direction will be no longer an unmeasurable elect but a paradigm for visualising Pomeron (Pomeron scattering.

We note that the concept of a universal factorisation of Pomeron structure, in particular for hadron (hadron collisions, has recently been questioned, see for example Ref. [17]. Our predictions and further experiments at the Tevatron and the LHC might help to clarify this question.

All num erical predictions for the Tevatron and the LHC are presented in Section 4. The results are critically discussed and the dierent models are carefully discerned. Both absolute values as well as single and double directive ratios are shown. Section 5 sum - marises the results, underlines the most important features and discusses open problems.

#### 2 K inem atics and C ross Sections

In this paper we concentrate on the single  $^{SD}$  and double di ractive  $^{DD}$  cross sections for the production of heavy avour QQ states. What do we mean by diffractive? First let us consider the case of single diffraction, where a Pomeron with momentum  $k_i^H$  is emitted by one of the colliding hadrons as shown in Fig. 1a. The denition of single diffractive means: one hadron, emitting the Pomeron, is being detected (at least in principle) in the nal state. The other hadron scatters of the emitted Pomeron. A typical single diffractive reaction for our purpose at the LHC would read: p+p  $_q!$   $_p+QQ+X$ . The Pomeron parton distribution  $f_{g;q=H}(x_1^H;Q^2)$  is weighted by a ux factor  $f_{H=i}(x_i^H;t_i)$  which gives a measure of the number of Pomerons emitted by hadron i. It is therefore a function of the energy loss of the proton  $t_i=(P_i-P_i^0)^2$  due to Pomeron emission as well as of the momentum fraction  $x_i^H$  carried by the Pomeron. Its form can be modelled by [11]

The coupling of the Pomeron to the proton is assumed to be 3 F  $_1$  ( $t_i$ ) with  $= 1.8 \, \mathrm{GeV}^2$ . The factor 3 corresponds to the number of valence quarks inside the hadron. This is discussed and supported in [11]. In fact it should couple in a point-like form to single quarks. From this point of view the elective Pomeron structure function should contain quark { antiquark contributions. An analogy with the photon structure function emerges from this picture. The elastic form factor of the proton  $F_1(t_i)$  is experimentally determined and well parametrised by [11]

where M  $_p$  is the proton mass. Instead of propagators for the Pomeron, one inserts the Regge factor  $x_i^H$  with the Regge trajectory  $(t_i) = 1 + 0$   $t_i$  with and both deduced experimentally. Latest experiments at the Tevatron [18] showed a slight  $t_i^P$  dependence of as long as  $t_i^0$  is xed. The CDF collaboration studied single directive events  $t_i^P$  and obtained from a data  $t_i^P$ .

They conclude that large screening e ects have to be introduced to save the traditional Pomeron model. An analysis at  $^{P}$   $\bar{s}=20;546$  and 1800 GeV showed a signicant  $^{SD}$  solution dependence for the single directive cross section.

In practice, , introduced as an elective power, measures the deviation of the dierential cross section d  $^{\rm SD}$  =dM  $^2$  from a pure 1=M  $^2$  dependence. On the other hand, taking only the triple{Pomeron diagram as contribution to directive dissociation into account and neglecting screening elects, 1+ can be interpreted as the intercept of a supercritical Pomeron [19].

A lso deduced experimentally by CDF was the sensitivity to  $^{0}$ . A change in  $^{0}$  by  $^{0}$  =  $0.1 \, \text{GeV}$   $^{2}$  results in a change in  $^{SD}$  of only 0.1% and changes at the same time by = 0.011. Neglecting any s dependence, we can x and  $^{0}$  to the standard values [11] = 0.085 and  $^{0}$  =  $0.25 \, \text{GeV}$   $^{2}$ .

According to [11] all these relations should only be valid if we limit the Pomeron momentum fraction to  $x_i^H$  0:1. Thus only a maximum energy loss of 10% for each

hadron is allowed. But assuming the nal state proton is not detected, there will be no energy cut for t, although the ux factor decreases very fast with tj.

The ux factor plays a pivotal role because it directly yields the energy dependent em ission rate of the Pom erons and is therefore extensively discussed in the literature. Bruni and Ingelm an calculated the directive W production rates at the Tevatron using a constant Pom eron {proton cross section of 2:3 mb, obtained from Regge analysis but with a non {Regge param etrisation for the ux factor [9]

tted from single di ractive data. Throughout this work, however, we shall use the Donnachie (Landsho Pomeron ux factor of Eq. (4).

We shall also consider double di ractive events. The procedure is analogous to the single di ractive scenario and is sketched in Fig. 1b. Now both hadrons undergo Pomeron em ission and therefore all hadronic parton distributions are replaced by the parton distributions of the Pomeron via the rule given in Eq. (3). However, the basic formulation of diractive scattering was intended for reactions where one hadron scatters diractively and one hadron is highly excited. The crucial point is that the single diractive cross section of a hadron (hadron collision is assumed to factorise into the total Pomeron (hadron cross section and the Pomeron ux factor [5]. The single diractive event may then be written as

Eq. (7) is the analogue of Eq. (3). Factorisation has also been applied to double di raction, for exam ple predictions for H iggs [10] or W boson production [8, 9] at the Tevatron and/or the LHC. Both colliding hadrons can in principle be detected in the nal state. A gain, a typical reaction at the LHC would look like: p+p! p+p+QQ+X. Double di ractive events thus are characterised by two quasi{elastic protons with rapidity gaps between them and the central heavy avour products.

Using the substitution given in Eq. (3) we can proceed in complete analogy to the single directive case and nally write down the expressions for the total, single and double directive cross sections for QQ production

W e only cite the expressions for the subprocess cross sections in leading{order approximation. W ith =  $4m_0^2$  =\$ they read

where the renormalisation scale is taken to be the subprocess collision energy,  $Q^2 = \$ = x_1x_2s$ . For an analytic derivation of Eqs. (11) and (12) using standard techniques we refer the reader to [22, 23, 24].

One m ight however argue that for the gg! QQ subprocess the  $\hat{t}\{$  and  $\hat{u}\{$ channel contributions should dominate [23], in which case a choice of  $Q^2 = \frac{1}{2}$  (m $_Q^2$   $\hat{t}$ ) + (m $_Q^2$   $\hat{u}$ ) =  $\frac{1}{2}$ \$ m ight be more reasonable. In fact the parton distributions are a ected by the choice of  $Q^2$  in the fram ework of GLAP evolution. But as in [24] we could not not a

signi cant sensitivity of our results to this choice compared to a general  $Q^2 = \$$  for both subprocesses.

A still unsolved problem is the structure of the Pomeron. Nearly all possible scenarios of parton distributions proposed have favoured a more or less gluonic content. In the following section we shall give a very cursory presentation of the most popular Pomeron models at this stage. A pivotal role will be played by three Pomeron models, recently presented and applied to diractive W production at the Tevatron and the LHC by Kunszt and Stirling [8]. They will be the input distributions for the diractive heavy avour production, which we shall deal with in Section 4.

#### 3 M odels of the Pomeron

The Pomeron has been postulated to describe hard directive collider phenomenology. In the framework of Regge theory a colourless object, carrying the quantum numbers of the vacuum, is able to explain the new observations. A pure gluonic composite seemed to be the simplest explanation on the basis of partonic contents and proposed features [25]. The Pomeron was therefore assumed to behave essentially as a hadron and Ingelman and Schlein introduced the concept of a Pomeron structure function [5].

Further collider experim ents, by for example the UA8 collaboration at CERN [6], gave evidence for a hard parton distribution inside the Pomeron but still could not distinguish between a gluon or quark dominated Pomeron.

A nother striking problem , not yet fully resolved, was the character of the Pomeron: should it be treated by perturbative or non {perturbative means? Landsho [26] argued that experimental results are best described by a Pomeron having propagators that are non {perturbative. They must not have a pole at  $k^2 = 0$ . He sum marises the phenomenological features of the so {called soft Pomeron as follows:

it couples to single quarks with a strength =  $1.8 \text{ G eV}^{1}$ ,

it is a simple Regge pole with a Regge trajectory (j.j) = 1 + 0 j.j taking into account an elective power that decreases with increasing  $\frac{p}{s}$ , but very slow ly such that 0.08 at typical hadron collider energies.

Studies at the pp{collider at CERN [6] favoured a more hard quark{ or gluon{like structure function for the Pomeron than a soft one<sup>4</sup>. Even though the Pomeron exchange is a pure gluon exchange, this does not imply that the Pomeron structure function is entirely, or even predom inantly, gluonic.

This was the starting point to give predictions for directive events using dierent Pomeron models, for example for directive W and Z boson production [9] or for directive Higgs production [10].

W hatever the parton distributions looked like, in the original investigations they were assumed to show no evolution with the scale  $Q^2$  at which the Pomeron is probed. They were functions only of the momentum fractions of the partons inside the Pomeron. This situation has changed, since there are now data for the directive structure functions measured at HERA [1, 2] at dierent values of  $Q^2$ . Employing Eq. (2) and assuming factorisation directly yields data for the Pomeron structure function  $F_2^H(x;Q^2)$ , assuming a certain structure for the ux factor. This has been discussed in detail in the Introduction.

We shall focus on the latest set of three dierent Pomeron models, based on recent HERA data [13], provided by Kunszt and Stirling [8]. The main features of these models are:

all three m odels are qualitatively very di erent concerning the partonic contents at the starting scale  $Q_0 = 2 \text{ GeV}$ ,

all three models give satisfactory agreement with the H 1 and ZEUS data,

all models undergo leading {order GLAP evolution as for the usual parton distributions.

In qualitative term s, the three models can be characterised as:

M odel 1: At  $Q_0$  the Pom eron is entirely composed of quarks. G luons are dynamically generated via GLAP evolution;

M odel 2: A m ix of quarks and gluons at starting scale  $Q_0$ ;

M odel 3: A predom inantly hard gluonic content at starting scale, the gluons inside the Pomeron carry large fractional momenta.

An SU (3) avour sym m etry is assumed for all three models, such that a momentum sum rule for  $Q_0 = 2$  GeV can be imposed

to deduce the overall normalisation factor for the data t. Because the quark contents inside the three models are more or less comparable since they are constrained by the HERA data, we show in Fig. 3 solely the Q evolution of the gluon distributions  $xf_{g=H}(x;Q^2)$  for the three Pom eron models.

We shall see later that it is the gg contributions which predom inantly govern the behaviour of the (di ractive) QQ cross sections for the Tevatron and the LHC in the given energy regime. These cross sections can therefore in principle provide important information on the gluon content of the Pomeron, complementary to the constraints on the quark content from DIS structure functions. For a broader discussion of the partonic Pomeron contents and their to the H1 data we refer the reader to [8].

It is very important to have distributions that undergo GLAP evolution, because, ranging from charm to top quark masses, dierent  $Q^2$  scales are probed and, as can be seen in Fig. 3, the distributions evolve signicantly with  $Q^2$ . This is dierent from most of the former static distributions proposed and enables us to give predictions for such a large mass range covered by the heavy avours.

The main features of the three Pom eron models concerning  $xf_{g=H}(x;Q^2)$  can easily be deduced from Fig. 3. The left side shows surface plots of the gluon distributions in the regime 4 G eV Q 50 G eV and 0:1 x 1:0. The corresponding contour plots in the  $x \in \mathbb{Q}$  plane are presented on the right side.

As can be seen in Fig. 3, Model 1 gains only a small gluon distribution via GLAP evolution at Q=4 GeV. Recall that there are no gluons at all at the starting scale  $Q_0=2$  GeV. The gluon distribution is almost at in Q for moderate and high values of x. This fact can also be seen in the contour plot, where for Q>10 GeV there is only a signi cant evolution in the very small x regime. No gluons with x>0:6 are present in this regime.

This is dierent to Model 2, which contains gluons with moderate or even higher fractional momenta. The gluon distribution shows a signicant Q evolution not only for small but also for moderate x (this can be seen clearly in the contour plot), even though the distribution asymptotically approaches zero for higher Q and x > 0.3.

Model 3 nally shows the most dynamical evolution of the gluon distributions not only in Q but also in x. Very hard gluons are present for high values of x. This is due to the basic construction of Model 3 as discussed above. These gluons lose their high momenta at larger values of Q mainly due to quark {antiquark pair production. The depletion of these high fractional {momenta gluons with increasing Q again becomes very transparent in the corresponding contour plot. For a further discussion we again refer the reader to [8].

#### 4 Di raction at the Tevatron and the LHC

For the GLAP evolution of the parton distributions inside the (anti)proton we use the MRS (A<sup>0</sup>) set presented in [27]. One test of the reliability of this set is the comparison of the calculated total inclusive cross section for the production at  $\frac{p}{s} = 1.8$  TeV with the latest experimental measurement [28]. The CDF collaboration measures a total inclusive cross section of  $\frac{T}{\exp}$  (p+p! tt+X) =  $7.6^{+2.4}_{-2.0}$  pb for an experimentally determined top mass m<sub>t</sub> = (176 8 (stat.) 10 (syst.)) GeV, while the MRS (A) set of partons predicts

 $^{\rm T}$  (p+p! tt+X) = 5:81 pb for m  $_{\rm t}$  = 176 G eV . M easurem ents of inclusive cc and bb cross sections at the Tevatron collider yield [16]:

 (p+p!  $\infty$ +X) =  $1152^{+24.3}_{26.8}$  nb;  $_{\text{exp:}}^{\text{T}}$  (p+p! bb+X) =  $30.1^{+17.0}_{17.4}$  nb

form  $_{\text{c}}=1.5\,\text{GeV}$  and m  $_{\text{b}}=4.5\,\text{GeV}$  compared to the leading {order theoretical predictions of  $^{\text{T}}$  (p+p! cc+X) = 98.7 nb and  $^{\text{T}}$  (p+p! bb+X) = 44.2 nb for the same m  $_{\text{c}}$  and m  $_{\text{b}}$ . Even though we are working only in leading {order approximation, the agreement with the experimental results is encouraging. Predictions for the ratios  $^{\text{SD}}=^{\text{T}}$  and  $^{\text{DD}}=^{\text{T}}$ , however, should be relatively insensitive to higher {order perturbative corrections.

#### 4.1 Probing the Pomeron at the Tevatron

We calculate numerically the total inclusive, the single diractive and the double diractive cross sections for heavy—avour pair{production using the MRS( $A^0$ ) set of partons and the three Pomeron models introduced in [8] and discussed in Section 3.0 ur results are shown in Fig. 4. Supplementary we show the pure gluon fusion contribution as dashed lines.

For the Tevatron collider the qq process becomes dominant for  $_{\mathbb{Q}} > 50 \, \mathrm{GeV}$ . This qq dominance is obviously visible in the total cross section but becomes even more striking for the single directive one. Due to this process, the single directive ratio R  $^{\mathrm{SD}}$  dened as R  $^{\mathrm{SD}} = ^{\mathrm{SD}} = ^{\mathrm{T}}$  even increases for  $\mathrm{m}_{\mathbb{Q}} > 70 \, \mathrm{GeV}$  before this process runs out of centre(of(m assenergy  $^{\mathrm{SD}}$  due to the cut(o in the Pomeron spectrum ( $\mathrm{x}_{1}^{\mathrm{H}} = 0.1$ ) and steeply falls to zero. Note that this restriction on  $^{\mathrm{SD}}$  sunfortunately takes place before the top quark production domain is reached. The single directive ratio R  $^{\mathrm{SD}}$  for all three Pomeron models reaches its local maximum at slightly lower masses than the top quark mass. This gives little hope to observe directive top quark events at the Tevatron but is promising for the LHC as will be discussed in Section 42.

At Tevatron energy the threshold for single di ractive events is reached when m  $_{\rm Q}$  = 270 GeV .But single di ractive events m ight be observed only up to m  $_{\rm Q}$  150 GeV with

for m  $_{\rm Q}$  = 150 GeV. This is qualitatively what we expect. Model 3 with the hard gluon content gains more and more qq pairs via GLAP evolution which dominantly contribute to the single directive cross section for higher masses. Model 2 with the quark {gluon mixture dominates for small masses, but at m  $_{\rm Q}$  ' 10 GeV Model 3 takes over. The production rate of the important qq pairs for higher masses increases more rapidly in Model 3. Model 1, however, without any gluons at the initial Q  $_{\rm O}$  = 2 GeV scale, marks

the lower lim it for single and double di ractive scattering over the wholem ass range. The num erical values for the single and double di ractive production of charm, bottom and top are given in Table 1.

Let us now focus on M odels 2 and 3: the ratios for single di ractive scattering range 22% for charm and 15% for bottom quark production and reach their locally lowest values of 2% for  $m_0 = 70$  G eV, before the ratio even increases due to the op contribution in the mass region 70 GeV  $m_{O}$ 150 GeV locally peaking at  $m_0 = 150 \text{ GeV}$  with ratio  $R^{SD} = 5.5\%$  (4.2%) for M odel 3 (2). Qualitatively M odel 1 shows the same behaviour. But with only quarks in the starting distribution, the creation of gluons and gapairs via GLAP evolution proceeds only slowly. This can be seen in Fig. 3. The dierence is expressed in the large gap between Model 1 on the one hand and M odels 2 and 3 on the other hand. So the conclusion is that at least for single di raction a gluon rich Pomeron as input should be more easily detected. Model 1 and Model 3 for example di er by about one order of magnitude. This turns out to be a crucial di erence with such absolutely small diractive cross sections.

Double di ractive scattering seem s to favour a balanced m ixture of quarks and gluons in the starting distribution and during GLAP evolution, as provided in Model 2. This can again be observed in Fig. 4.

Notice that the form er dom inant hard gluon Model 3 quantitatively shows about the same behaviour as Model 1. Why the behaviour of Model 3 in double direction is dierent from that in single direction can be understood by a further analysis of the kinematics among the partons inside the Pomeron and their distributions at dierent mass scales. Models 2 and 3 show a crossing in the case of single directive scattering as can be observed in Fig. 4. Its existence can be immediately explained in terms of the gluon distributions which are shown in Fig. 3. As we have already pointed out, the gluon distributions govern the behaviour of the cross sections at the Tevatron, especially for small quark masses. For small x and Q, the gluon distribution of Model 2 is slightly bigger than that of Model 3. For higher x and/or Q the situation is reversed.

In the case of double di raction, an analysis of the average fractional gluon m om entum  $h\text{xi} = h\text{x}_i = \text{x}_i^\text{H} i$  yields hxi = 0.11 for  $m_Q = 2$  G eV and hxi = 0.24 for  $m_Q = 50$  G eV for all three m odels. In this regime the gluon distribution of M odel 2 again exceeds that of M odel 3. So, no crossing can be observed and M odel 2 dom in at throughout. In fact the crossing would take place at m  $_Q$  80 G eV , shortly before the threshold for double di raction with m  $_Q$  90 G eV is reached.

The relatively broad gap between M odel 2 and M odel 3 appearing in Fig. 4 can again be explained by the same straightforward analysis of the average gluon m omentum. A gain a comparison with the corresponding gluon distributions of M odel 2 and M odel 3 in Fig. 3 shows the absolute dierence of these distributions in the regime 0:1 hxi 0:2.

While directive charm and bottom quark production might be observable at the Tevatron, there is no hope for directive tt pair production being visible at a total centre (

of(m ass energy of  $\bar{s} = 1.8$  TeV. Either the top m ass exceeds the kinematic threshold (double diraction) or the elect of the threshold is already strongly in uencing the process by a steep decrease in the diractive cross section (single diraction near top mass). However at the LHC such heavy avour threshold suppression is less severe, as we shall see in the following Section.

#### 4.2 P redictions for the LHC

The LHC will provide a rich  $\,$  eld of study for diffractive events, even in the top mass regime. With a centre (of (mass energy of at least  $^{\rm P}$  = 10 TeV [29] the double diffractive threshold is reached for m  $_{\rm Q}$  = 500 GeV and the single diffractive one lies at m  $_{\rm Q}$  = 1500 GeV . This upper bound is very promising in particular for diffractive top quark production at the LHC .

At a proton {proton collider, the dom inant process for QQ production is of course gluon {gluon fusion since antiquarks only appear as sea quarks inside the proton. For a top m ass of 176 GeV the pure gg contribution is about 91% of the total cross section in our calculation. This also holds for the single and double di ractive case.

The num erical results are shown in Fig. 5 and the num erical values are again listed in Table 1. The single di ractive ratios  $R^{\text{SD}}$  for the three Pom eron models are between 20 40% for charm and 10 40% for bottom quarks. The maximal and minimal single di ractive top quark rates are

with m  $_{\rm t}$  = 176 GeV. Even though the single di ractive ratios for top production are comparable to the Tevatron rates, the absolute single di ractive cross sections are crucially enhanced. We note an enhancement of about a factor 100 at the LHC. For example Model 2 and Model 3 provide a single di ractive cross section of approximately 5 pb. This is about the total cross section for top production at the Tevatron. So, single di ractive top quark events should be readily detected at the LHC.

The predictions for double di ractive scattering, however, are still not very prom ising. The maxim aldouble di ractive cross section (for Model 2) is 1:86 10<sup>2</sup> pb for top quarks. The qualitative behaviour of the three dierent Pomeron models is the same. Because the centre {of {mass energy at the LHC is larger by a factor of six, one can conclude from the qualitatively similiar behaviour of all three models at the LHC that the gluon distributions in all three models do indeed become similiar at higher Q, as already seen in Fig. 3.

All conclusions that were drawn for the Tevatron still hold for the LHC, except that because of the higher centre (of (m ass energy there are no kinem atical artifacts in the considered avour m ass regime. Even for the top quark m ass, the single as well as the

double di ractive cross section behave rather smoothly. The in uence of the threshold does not seriously a ect the cross sections in this case.

Considering the ratios for single and double di ractive events in Fig. 5 again shows a qualitatively comparable picture to the Tevatron. Again an analysis of the average fractional gluon momentum hxi will explain the dierences in R  $^{\rm SD}$  and R  $^{\rm DD}$ . For R  $^{\rm SD}$ , M odels 2 and 3 are quantitatively equivalent, especially for the charm and bottom quarks. For a bottom quark m ass of m  $_{\rm b}=4.5$  GeV, we obtain as average fractional gluon momentum hxi = 0.42 for Q  $2m_{\rm b}=9$  GeV in the single diractive case. A comparison with the gluon distributions in Fig. 3 shows that they are roughly equal for M odel 2 and M odel 3 in this region of x. This fact becomes even more transparent in the contour plots of Fig. 3.

For the case of double di raction the sam e analysis yields a lower average fractional m om entum for the gluons, due to the energy (cut am ong both P om eron em itting hadrons. A gain for m  $_{\rm b}$  = 4.5 G eV we obtain hxi = 0.22. But in this region of x, the gluon distribution of M odel 3 shows a local m in im um, the hard gluons in this model give a rise of xf $_{\rm g=H}$  (x;Q $^2$ ) only for x > 0.5 in the low {Q regime. The gluon distributions inside M odel 2 also show a local m in im um around x 0.2, but its absolute value is higher than that for M odel 3 in this region. This fact is responsible for the gap between M odel 2 and M odel 3 as observed for R $^{\rm DD}$  in Fig. 5. For higher quark m asses (higher values of Q $^2$ ) all three m odels become om parable concerning the gluon distributions, as already discussed.

M odel 2 and M odel 3 as descriptions of the parton distributions of the Pom eron yield very promising single diractive ratios, at least for charm and bottom quarks. M odel 3 predicts a single diractive ratio of 40% for coand bipproduction. This is quantitatively comparable to the predictions of M odel 2 as can be observed in Fig. 5 and numerically verified in Table 1. Thus about one third of the production of heavy avours at the LHC including charm and bottom quarks should be single diractive. But even M odel 1, purely quark { like at starting scale Q  $_0$  = 2 G eV , gives a single diractive contribution of approximately 20% in this mass regime.

## 5 Conclusions

We have presented predictions for directive heavy—avour production at the Tevatron and the LHC. The input Pom eron distributions [8] were dierent in contents from pure quark starting distributions up to hard gluonic contents at the GLAP starting scale Q $_0=2\,\mathrm{G\,eV}$ . Our predictions can therefore be considered as upper and lower limits for the directive cross sections.

We found that at the Tevatron single and double directive charm and bottom quark production is observable with a single directive ratio  $R^{SD}$  that is between 7% (charm) and 4% (bottom) for Model 1 as a lower limit and 26% (charm) and 13% (bottom) for

M odel 2 as an upper bound. The double di ractive cross section for charm and bottom production lies above the total cross section for the top quark and m ight also be observable. The lower limit is governed by the pure quark { like M odel 1 with \$^{DD}\$ 45 pb for charm and \$^{DD}\$ 18 pb for bottom quarks, whereas having M odel 2 as the underlying Pomeron m odel gives a double directive cross section which is enhanced by a factor of four.

The di ractive cross sections for charm and bottom quarks will be larger by three orders of magnitude at the LHC, and also single di ractive top quark production should be observable. The single di ractive tt cross sections range from 1 pb for M odel 1 up to 5 pb for the hard gluon M odel 3, which is roughly the total top quark cross section at the Tevatron. All predictions are collected in Table 1 and shown in Figs. 4 and 5.

The three Pom eron models presented in [8] and used in our calculations are only a guide to possible Pom eron structures. Their determinations have been made possible by two strong assumptions: rst, the Pom eron has a partonic structure and second, we assume factorisation such that recent measurements of the directive Pom eron structure function give a universal picture of the Pom eron. Only the latter makes predictions for the hadron (hadron collider meaningful.

Our predictions can only be a guide as the calculations are illustrative only. We need a more detailed study with detector acceptance. This will follow as soon as there are rst results on di ractive heavy avour production at the Tevatron. But a study of these events is worthwhile, at least for di ractive charm and bottom production. Di ractive top quark events still will require a higher centre (of mass energy before they can be studied. The LHC will be such a laboratory for di ractive scattering studies. We predict that about 30% of all charm and bottom production events should be single di ractive.

It is not yet certain whether the theoretical fram ework of the Donnachie (Landsho model can be extended to double or even multiple Pomeron exchange. Again, we give predictions for the case of an analogue treatment of double Pomeron exchange that will be interesting to test at future hadron (hadron colliders. Also the parameters used in this theoretical model have to be tted to new high energy collider experiments<sup>5</sup>. Finally future high energy experiments will hopefully more clearly reveal the structure of the Pomeron and answer some questions that were raised in this paper.




Figure 1: K inem atics of the single (a) and the double di ractive scattering (b) events, leading to QQ pair production. The subprocesses taken into account are either qq! QQ or gg! QQ .




Figure 2: The leading{order Feynm an diagram's for the subprocesses qq ! QQ (a) and gg ! QQ (b).




Figure 3: The gluon distributions of the three dierent Pomeron models are shown, starting with Model 1 at the top. For each model we show the surface plot for a given  $x \in \mathbb{Q}$  regime as well as the corresponding contour plot in the  $x \in \mathbb{Q}$  plane.




Figure 4: D i ractive Scattering at the Tevatron: The numerical results of the total, single and double diractive cross sections for the three Pomeron models are shown. The solid lines indicate the subprocess gg + qq! QQ, the dashed lines show solely the contribution from gluon fusion (gg! QQ): (a) gives the absolute numbers for the cross sections (in pb), and (b) gives the ratios ( $R^{SD} = {}^{SD} = {}^{T}$  and  $R^{DD} = {}^{DD} = {}^{T}$ ). The mass regions of the charm (c), bottom (b) and top (t) quarks are indicated. The xed centre(of(m ass energy is 1:8 TeV.




Figure 5: D i ractive Scattering at the LHC: Same as Fig. 4 but now for a centre{of{m ass energy of 10 TeV. The solid lines indicate the subprocess gg+ qq! QQ, the dashed lines show solely the contribution from gluon fusion (gg! QQ): (a) gives the absolute numbers for the cross sections (in pb), and (b) gives the ratios ( $R^{SD} = {}^{SD} = {}^{T}$  and  $R^{DD} = {}^{DD} = {}^{T}$ ).
