R_b and New Physics: A Comprehensive Analysis

A bstract

W e survey the implications for new physics of the discrepancy between the LEP m easurem ent of R_b and its Standard M odel prediction. Two broad classes of m odels are considered: (i) those in which new Z bb couplings arise at tree level, through Z or b-quark m ixing with new particles, and (ii) those in which new scalars and ferm ions alter the Z bb vertex at one loop. W e keep our analysis as general as possible in order to system atically determ ine what kinds of features can produce corrections to R_b of the right sign and m agnitude. W e are able to identify several successful m echanism s, which include m ost of those which have been recently been proposed in the literature, as well as som e earlier proposals (e.g. supersym m etric m odels). By seeing how such m odels appear as special cases of our general treatm ent we are able to shed light on the reason for, and the robustness of, their ability to explain R_b .

1. Introduction

The Standard M odel (SM) of electrow eak interactions has been tested and con m ed with unprecedented precision over the past few years using measurements of e^+e^- scattering at the Z resonance at LEP [1] and SLC [2]. A particularly striking example of the impressive SM synthesis of the data cam e with the discovery, at CDF and D0 [3], of the top quark with a mass which is in excellent agreement with the value implied by the measurements at LEP.

The biggest | and only statistically important | y to be found so far in the proverbial SM ointment is the experimental surplus of bottom quarks produced in Z decays, relative to the SM prediction. W ith the analysis of the 1994 data as described at last summer's conferences [1][2], this discrepancy has become almost a 4 deviation between experiment and SM theory. The numbers are:

The SM prediction assumes a top mass of $m_t = 180$ GeV and the strong coupling constant $_s$ (M $_z$) = 0:123, as is obtained by optimizing the t to the data.

There are other m easurements which dier from their SM predictions at the 2 level: R_c (2:5), A_{FB}^0 () (2:0), and the inconsistency (2:4) between A_e^0 as m easured at LEP with that obtained from A_{LR}^0 as determined at SLC [2]. In fact, since the R_c and R_b m easurements are correlated, and because they were announced together, some authors refer to this as the R_b - R_c crisis." One of the points we wish to make in this paper is that there is no R_c crisis. If the R_b discrepancy can be resolved by the addition of new physics, one then obtains an acceptable to the data. In other words, R_c , as well as A_{FB}^0 () and A_{LR}^0 , can reasonably be viewed simply as statistical uctuations.

On the other hand, it is di cult to treat the measured value of R $_{\rm b}$ as a statistical uctuation. Indeed, largely because of R $_{\rm b}$, the data at face value now exclude the SM at the 98.8% con dence level. If we suppose that this disagreem ent is not an experimental artifact, then the burning question is: W hat D oes It M ean?

Our main intention in this paper is to survey a broad class of models to determ ine what kinds of new physics can bring theory back into agreem ent with experiment. Since R_b is the main culprit we focus on explaining both its sign and magnitude. This is nontrivial, but not impossible to do, given that the discrepancy is roughly the same size as, though in the opposite direction to, the large m_t-dependent SM radiative correction. The result is therefore just within the reach of one-loop perturbation theory.

Our purpose is to survey the theoretical possibilities within a reasonably broad fram ework, and we therefore keep our analysis quite general, rather than focusing on individual models. This approach has the virtue of exhibiting features that are generic to sundry explanations of the Z ! $b\bar{b}$ width, and m any of the proposals of the literature emerge as special cases of the alternatives which we consider.

In the end we nd a number of possible explanations of the e ect, each of which would have its own potential signature in future experiments. These divide roughly into two categories: those which introduce new physics into R_b at tree level, and those which do so starting at the one-loop level.

The possibilities are explored in detail in the remainder of the article, which has the following organization. The next section discusses why R_b is the only statistically signi cant discrepancy between theory and experiment, and summarizes the kinds of interactions to which the data points. This is followed by several sections, each of which exam ines a di erent class of models. Section 3 studies the tree-level possibilities, consisting of m odels in which the Z boson or the b quark m ixes with a hitherto undiscovered particle. We nd several viable models, some of which imply comparatively large modi cations to the right-handed b-quark neutral-current couplings. Sections 4 and 5 then consider loop contributions to R_b . Section 4 concerns modi cations to the t-quark sector of the SM . Although we nd that we can reduce the discrepancy in R_b to 2, we do not regard this as su cient to claim success for models of this type. Section 5 then considers the general form for loop-level m odi cations of the Z bo vertex which arise from m odels with new scalars and ferm ions. The general results are then applied to a num ber of illustrative examples. We are able to see why simple models, like multi-Higgs doublet and Zee-type m odels fail to reproduce the data, as well as to exam ine the robustness of the di culties of a supersymm etric explanation of R_b. Finally, our general expressions guide us to some examples which do make experimentally successful predictions. Section 6 discusses some future experim ental tests of various explanations of the R_b problem . Our conclusions are summarized in section 7.

2. The D ata Speaks

Taken at face value, the current LEP/SLC data excludes the SM at the 98.8% con – dence level. It is natural to ask what new physics would be required to reconcile theory and experim ent in the event that this disagreem ent survives further experim ental scrutiny. Before digging through one's theoretical repertoire for candidate m odels, it behooves the theorist rst to ask which features are preferred in a successful explanation of the data. An e cient way to do so is to specialize to the case where all new particles are heavy enough to in uence Z-pole observables primarily through their lowest-dimension interactions in an elective lagrangian. Then the various elective couplings may be t to the data, allowing a quantitative statistical comparison of which ones give the best t. A lthough not all of the scenarios which we shall describe involve only heavy particles, many of them do and the conclusions we draw using an elective lagrangian offen have a much wider applicability than one might at inst assume. Applications of this type of analysis to earlier data [4][5] have been recently updated to include last summer's data [6], and the purpose of this section is to summarize the results that were found.

There are two main types of e ective interactions which play an important role in the analysis of Z-resonance physics, and we pause rst to enumerate brie y what these are. (Form ore details see R ef. [4].) The rst kind of interaction consists of the low est-dimension deviations to the electrow eak boson self-energies, and can be parameterized using the well-know n Peskin-Takeuchi parameters S and T [7].¹ The second class of interactions consists of nonstandard dimension-four e ective neutral-current ferm ion couplings, which may be de ned as follow s:²

In this expression g_L^f and g_R^f denote the SM couplings, which are normalized so that $g_L^f = I_3^f \quad Q^f s_w^2$ and $g_R^f = Q^f s_w^2$, where I_3^f and Q^f are the third component of weak isospin and the electric charge of the corresponding ferm ion, f. $s_w = \sin_w$ denotes the sine of the weak mixing angle, and $I_L(R) = (1 \ 5)=2$.

Fitting these e ective couplings to the data leads to the following conclusions.

(1) W hat M ust Be Explained: A lthough the measured values for several observables depart from SM predictions at the 2 level and m ore, at the present level of experimental accuracy it is only the R_b measurement which really m ust be theoretically explained. A fter all, some 2 uctuations are not surprising in any sample of twenty or more independent measurements. (Indeed, it would be disturbing, statistically speaking, if all measurements agreed with theory to within 1.) This observation is rejuried to acommodate the R_b measurement, namely the addition of only new elective 2 be couplings, already raises the


con dence level of the tto acceptable levels ($_{m in}^{2}$ =d.o.f. = 15:5=11 as com pared to 27.2/13 for a SM t). We therefore regard the evidence for other discrepancies with the SM, such as the value of R_c, as being inconclusive at present and focus instead on models which predict large enough values for R_b.

(2) The Signi cance of R_z : Since the 1995 sum mer conferences have highlighted the nonstandard measured values for the Z branching ratio into both c and b quarks, it is worth making the above point more quantitatively for the particular case of the discrepancy in R_c . This was addressed in Ref. [6] by introducing elective couplings of the Z to both b and c quarks, and testing how much better the resulting predictions t the observations. A lthough the goodness of t to Z pole observables does in prove somewhat (with $\frac{2}{m \text{ in}} = \text{d.o.f.} = 9.8=9$), it does so at the expense of driving the preferred value for the strong coupling constant up to $_{s} (M_z) = 0.180 - 0.035$, in disagreement at the level of 2 with low energy determinations, which lie in the range 0.112 - 0.003 [8]. This change in the t value for $_{s} (M_z)$ is driven by the experimental constraint that the total Z width not change with the addition of the new Z for couplings.³ O now the low energy determinations of $_{s} (M_z)$ are also included, $\frac{2}{m \text{ in}} = \text{d.o.f.}$ not only drops back to the levels taken in the tonly to elective Z bb couplings, but the best-t prediction for R_c again moves into a roughly 2 discrepancy with experiment.

It is nevertheless theoretically possible to introduce new physics to account for R_c in a way which does not drive up the value of the strong coupling constant. As argued on model-independent grounds in Ref. [6], and more recently within the context of specic models [9][10], an alteration of the c-quark neutral-current couplings can be compensated for in the total Z width by also altering the neutral-current couplings of light quarks, such as the s. W e put these types of models aside in the present paper, considering them to be insu ciently motivated by the experimental data.

(3) LH vs. RH C ouplings: The data do not yet perm it a determ ination of whether it is preferable to modify the left-handed (LH) or right-handed (RH) Z b coupling. The minimum values for ² found in Ref. [6] for a t involving either LH, RH or both couplings are, respectively, $\frac{2}{m \text{ in}} = \text{d.o.f.}(\text{LH}) = 17.0 = 12$, $\frac{2}{m \text{ in}} = \text{d.o.f.}(\text{RH}) = 16.1 = 12 \text{ or } \frac{2}{m \text{ in}} = \text{d.o.f.}(\text{both}) = 15.5 = 11.$

of the $Z \overline{b}b$ couplings $d_{2,R}^{b}$ to Z-pole data from the 1995 Summer Conferences. The four solid lines respectively denote the 1, 2, 3, and 4 error ellipsoids. The SM prediction lies at the origin, (0;0). This tyields $_{s}$ (M $_{Z}$) = 0:101 0:007.

(4) The Size Required to Explain R: The analysis of Ref. [6] also indicates the size of the change in the neutral-current b-quark couplings that is required if these are to properly describe the data. The best t values which are required are displayed in Figure 1, and are listed in Table 1. Table 1 also includes for comparison the corresponding tree-level SM couplings, as well as the largest SM one-loop vertex corrections (those which depend quadratically or logarithm ically on the t-quark mass⁴ m_t), evaluated at $s_w^2 = 0.23$. For making comparisons we take m_t = 180 GeV.

As we now describe, the implications of the numbers appearing in Table 1 depend on the handedness (LH vs.RH) of e ective new physics Z bb couplings.

(4a) LH Couplings: Table 1 shows that the required change in the LH Z bb couplings must

be negative and comparable in magnitude to the m_t-dependent loop corrections within the SM .The sign must be negative since the prediction for the Z ! $b\bar{b}$ width must be increased relative to the SM result in order to agree with experiment. This requires $\frac{d}{d}$ to have the same sign as the tree-level value for g_L^b , which is negative. As we shall see, this sign lim its the kinds of models which can produce the desired e ect. C om parison with the SM loop contribution shows that the magnitude required for $\frac{d}{d}$ is reasonable for a one-loop calculation. Since the size of the m_t-dependent part of the SM loop is enhanced by a factor of m_t²=M_w², the required new physics e ect must be larger than a generic electrow eak loop correction.

(4b) RH Couplings: Since the SM tree-level RH coupling is opposite in sign to its LH counterpart and is some ve times smaller, the new-physics contribution required by the data, $\frac{d}{R}$, is positive and comparable in size to the tree-level coupling. This makes it likely that any new-physics explanation of the data which relies on changing g_R^b must arise at tree level, rather than through loops.

(5) Absence of O blique Corrections: A nal proviso is that any contribution to $\frac{1}{9}$ or g_R^b should not be accompanied by large contributions to other physical quantities. For example, Ref. [6] nds that the best-t values for the oblique parameters S and T are

(with a relative correlation of 0.86) even when $\phi_{\mu,R}^{b}$ are free to oat in the t. Since T offen gets contributions similar in size to $\phi_{\mu,R}^{b}$, these bounds can be quite restrictive.

Notice that we need not worry about the possibility of having large cancellations between the new-physics contributions to the oblique parameters and $\frac{d}{d}$ in R_b . It is true that such a partial cancellation actually happens for $_b$ in the SM, where the loop contributions proportional to m_t^2 in T and $\frac{d}{d}$ exactly cancel in the lim it that $s_w^2 = \frac{1}{4}$, and so end up being suppressed by a factor $s_w^2 = \frac{1}{4}$. We nevertheless need not consider such a cancellation in R_b since the oblique parameters (especially T) almost com pletely cancel between $_b$ and $_{had}$. Quantitatively, we have [4]:

We now turn to a discussion of the circum stances under which the above conditions may be achieved in a broad class of models.

3. Tree-LevelE ects: M ixing

At tree level the Z bb couplings can be modiled if there is mixing amongst the charge $\frac{1}{3}$ quarks, or the neutral, colourless vector bosons. Being a tree-levele ect it is relatively easy and straightforward to analyze and compare dilerent scenarios. Also, since mixing elects can be large, mixing can provide comparatively large corrections to the Z bb-coupling, such as is needed to modify R_b through changes to g_R^b . Not surprisingly, a number of recent models [9][10], [12]-[14] use mixing to try to resolve the R_b (and R_c) discrepancy. Our aim here is to survey the possibilities in a reasonably general way. We therefore postpone for the moment a more detailed phenom enological analysis of the various options.

In general we imagine that all particles having the same spin, colour and electric charge can be related to one another through m ass matrices (some of whose entries m ight be constrained to be zero in particular models due to gauge symmetries or restrictions on the Higgs-eld representations). We denote the colour-triplet, charge $Q = \frac{1}{3}$, quarks in the avour basis by B, and label the corresponding mass eigenstates⁵ by bⁱ. The

m ass-eigenstate quarks, b^{i} , are obtained from the B by perform ing independent unitary rotations, $U_{L,R}^{y}$, an ongst the left- and right-handed elds. The b quark that has been observed in experiments is the lightest of the mass eigenstates, $b = b^{1}$, and all others are necessarily much heavier than this state.

Sim ilar considerations also apply for colourless, electrically-neutral spin-one particles. In this case we im agine the weak eigenstates, Z^w , to be related to the mass eigenstates, Z^m , by an orthogonal matrix, M^{wm} . We take the physical Z, whose properties are measured in such exquisite detail at LEP and SLC, to be the lightest of the mass eigenstates: Z^{2^n} .

A ssum ing that all of the b^i and Z^m (except for the lightest ones, the fam iliar b and Z particles) are too heavy to be directly produced at Z-resonance energies, we nd that the avour-diagonal electric neutral-current couplings relevant for R $_b$ are

where the neutral-current couplings are taken to be diagonal in the avour B basis.⁶

This expression becomes reasonably simple in the common situation for which only two particles are involved in them ixing. In this case we may write $B = \begin{bmatrix} B \\ B^0 \end{bmatrix}$, $b^i = \begin{bmatrix} b \\ b^0 \end{bmatrix}$ and $Z^w = \begin{bmatrix} Z \\ Z^0 \end{bmatrix}$, and take U_L , U_R and M to be two-by-two rotation matrices parameterized by the mixing angles L, R and Z. In this case eq. (5) reduces to

where s_{L} denotes sin $_{L}$, etc. Increasing R_{b} requires increasing the combination $(g_{L}^{b})^{2} + (g_{E}^{b})^{2}$. To see how this works we now specialize to more speci calternatives.

First consider the case where two gauge bosons m ix. Then eq. (6) reduces to

where $(g_z^B)_{L,R}$ is the SM coupling in the absence of Z mixing, and $(g_z^B)_{L,R}$ is the b-quark coupling to the new eld Z⁰ (which might itself be generated through b-quark mixing). It is clear that so long as the Z⁰ be coupling is nonzero, then it is always possible to choose the angle _z to ensure that the total elective coupling is greater than the SM one, $(g_z^B)_{L,R}$. This is because the magnitude of any function of the form $f(z) = A c_z + B s_z$ is maximized by the angle tan _z = B=A, for which $f(f_{max}) = f(A) = c_z f(z)$.

The model-building challenge is to ensure that the same type of modi cations do not appear in an unacceptable way in the elective Z couplings to other fermions, or in too large an M_z shift due to the mixing. This can be ensured using appropriate choices for the transform ation properties of the elds under the new gauge symmetry, and su - ciently small Z -Z ⁰ mixing angles. Models along these lines have been recently discussed in R efs. [9],[16].

3.2) b-Quark Mixing

The second natural choice to consider is pure b-quark m ixing, with no new neutral gauge bosons. We consider only the simple case of 2 2 m ixings, since with only one new B⁰ quark m ixing with the SM bottom quark, eq. (6) simpli es considerably. A swe will discuss below, we believe this to be su cient to elucidate most of the features of the possible b-m ixing solutions to the R_b problem.

Let us rst establish some notation. We denote the weak SU (2) representations of the SM $B_{L_{R}}$ and of the $B_{L_{R}}^{0}$ as $R_{L_{R}}$ and $R_{L_{R}}^{0}$, respectively, where $R = (I; I_{3})$. The SM B-quark assignments are $R_{L} = \frac{1}{2}; \frac{1}{2}$ and $R_{R} = (0; 0)$. By de nition, a B⁰ quark must have electric charge Q = 1=3, but may in principle have arbitrary weak isospin $R_{L_{R}}^{0} = (I_{L_{R}}^{0}; I_{3L_{R}}^{0}).$

In terms of the eigenvalues I_{3L}^0 and I_{3R}^0 of the weak-isospin generator I_3 acting on B_L^0 and B_R^0 , the combination of couplings which controls $_b$ becomes

In order to increase $_{b}$ using this expression, $_{L}$ and $_{R}$ must be such as to make g_{L}^{b} more negative, g_{R}^{b} more positive, or both. Two ways to ensure this are to choose

There are also two other alternatives, involving large mixing angles or large B⁰ representations: $I_{3L}^0 > 0$, with $s_L^2 (I_{3L}^0 + \frac{1}{2}) > 1$ $2s_w^2 = 3' 0.85$, and $I_{3R}^0 < 0$, with $s_R^2 jI_{3R}^0 j > 2s_w^2 = 3' 0.15$. Note that, in the presence of LH mixing, the CKM elements V_{qb} (q = u;c;t) get rescaled as V_{qb} ! c, V_{qb} , thus leading to a decrease in rates for processes in which the b quark couples to a W. Therefore charged-current data can in principle put constraints on large LH mixing. For example, future measurements of the various t-quark decays at the Tevatron will allow the extraction of V_{tb} in a model-independent way, thus providing a lower limit on c_L . At present, how ever, when the assumption of three-generation unitarity is relaxed (as is implicit in our cases) the current measurement of BR (t ! W b)=BR (t ! W q) implies only the very weak limit $j_{tb}j > 0.022$ (at 95% c.l.) [17]. Hence, to date there are still no strong constraints on large LH mixing solutions. Regarding the RH mixings, as discussed below there is no corresponding way to derive constraints on c_R , and so large s_R solutions are always possible.

We proceed now to classify the models in which the SM bottom quark mixes with other new Q = 1=3 fermions. Although there are endless possibilities for the kind of exotic quark one could consider, the number of possibilities can be drastically reduced, and a complete classi cation becomes possible, after the following two assumptions are made:

(i): There are no new Higgs-boson representations beyond doublets and singlets.

(ii): The usual B -quark m ixes with a single B', producing the mass eigenstates b and b^0 . This constrains the mass matrix to be 2 2:

We will exam ine all of the alternatives consistent with these assumptions, both of which we believe to be well-motivated, and indeed not very restrictive. The resulting models include the \standard" exotic ferm ion scenarios [18] (vector singlets, vector doublets, mirror ferm ions), as well as a num ber of others.

Let us rst discuss assumption (i). From Table 1 and eq. (8) one sees that the mixing angles must be at least as large as 10% to explain R_b , im plying that the o -diagonal entries in the mass matrix eq. (10) which give rise to the mixing are of order $s_{L,R} M_{22} > 0$ (10) G eV. If these entries are generated by Higgs elds in higher than doublet representations, such large VEVs would badly undermine the agreem ent between theory and experiment for the $M_w = M_z$ mass ratio.⁷

A coording to assumption (i), the permitted H iggs representations are $R_{H} = \frac{1}{2}$; $\frac{1}{2}$ and (0;0). It is then possible to specify which representations $R_{L,R}^{0}$ allow the B⁰ to m ix with the B quark of the SM :

(1): Since the B^0 should be relatively heavy, we require that $M_{22} \in 0$. Then the restriction (i) on the possible H iggs representations in plies that

(2): To have b{bm ixing, at least one of the o -diagonal entries, M₁₂ or M₂₁, must be nonzero. These terms arise respectively from the gauge-invariant products $R_{\mu} = R_{\mu} = R_{\mu}^{0}$ and $R_{\mu} = R_{R} = R_{\mu}^{0}$ so that R_{μ}^{0} must transform as the conjugate of the tensor product $R_{\mu} = R_{R}$ (L):

Thus the only possible representations for the B⁰ are those with $I_{R}^{0} = 0; \frac{1}{2}; 1$ and $I_{L}^{0} = 0; \frac{1}{2}; 1; \frac{3}{2}$, subject to the restrictions (11)-(14).

⁷ The contribution of these relatively large non-standard VEVs cannot be e ectively compensated by new loop-e ects. On the other hand, beyond H iggs doublets, the next case of a H iggs multiplet preserving the tree-level ratio is that of $I_{3H} = 3$, $Y_H = 2$. We do not consider such possibilities, which would also require the m ixed B⁰ to belong to similarly high-dimensional representations. We also neglect alternative scenarios invoking, for example, more H iggs triplets and cancellations between dimensional vertex such a server e ne-tuning problem s.

As for assumption (ii), it is of course possible that several species of B⁰ quarks m ix with the B, giving rise to an N N m ass matrix, but it seems reasonable to study the allowed types of m ixing one at a time. A fler doing so it is easy to extend the analysis to the combined e ects of simultaneous m ixing with multiple B⁰ quarks. Thus (ii) appears to be a rather m ild assumption.

There is one sense in which (ii) m ight appear to restrict the class of phenom ena we look at in a qualitative way: it is possible to obtain m ixing between the B and a B⁰ in one of the higher representations we have excluded by \bootstrapping", that is, by interm ediate m ixing with a B⁰₁ in one of the allowed representations. The idea is that, if the SM B m ixes with such a B⁰₁, but in turn the latter m ixes with a B⁰₂ of larger isospin, this would e ectively induce a B {B⁰₂ m ixing, which is not considered here. However, since m assentries directly coupling B to B⁰₂ are forbidden by assumption (i), the resulting B {B⁰₂ m ixing will in general be proportional to the B {B⁰₁ m ixing, im plying that these additional e ects are subleading, i.e. of higher order in the m ixing angles. This means that if the dom inant B {B⁰₁ m ixing e ects are insu cient to account for the measured value of R b, adding m ore B⁰ quarks with larger isospin will not qualitatively change this situation.

There is, how ever, a loophole to this argument. If the mass matrix has some symmetry which gives rise to a special \texture," then it is possible to have large m ixing angles and thus evade the suppression due to products of sm all m ixing angles alluded to above. Indeed, we have constructed several examples of 3 3 quasi-degenerate m atrices with three and four texture zeros, for which the B $\{B_2^0 m \text{ ixing is not suppressed and, due to the}\}$ degeneracy, can be maximally large. For example, let us choose B_1^0 in a vector doublet with $I_{3L_{2R}} = +1=2$ and B_2^0 in a vector triplet with $I_{3L_{2R}} = +1$. Because of our assumption of no Higgs triplets, direct B m ixing with such a B_2^0 is forbidden, and M $_{13} = M_{31} = M_{12} = 0$. It is easy to check that for a generic values of the nonvanishing m ass m atrix elements, the induced $s_{L,R}^{13}$ m ixings are indeed subleading with respect to $s_{L,R}^{12}$. However, if we instead suppose that all the nonzero elements are equal to some large mass , then there are two \mathbf{B}_{2}^{0} m ixing angles $\mathbf{s}_{\mathrm{L}}^{13}$ and $m_{b^{00}}$ 1=3 nonzero eigenvalues m bº 2 while the B $\overline{3\text{=8}}$ are unsuppressed relative to $s^{\text{L2}}_{\text{L},\text{R}}$. A though it may be unnatural to and s_{2}^{13} have near-equality of the mass entries generated by singlet and doublet Higgs VEVs, as is needed in this case and in most of the other examples we found, it is still possible that som e interesting solutions could be constructed along these lines.

A part from some special cases analogous to the one outlined above, we can therefore conclude that neither does assumption (ii) seriously lim it the generality of our results.

 $^{^{8}}$ A sm all perturbation of the order of a few G eV can be added to some of the nonzero m assentries to lift the degeneracy and give a nonzero value for $m_{\rm b}$.

All the possible models for B {B⁰ mixing allowed by the assumptions that (i) here are no new Higgs representations beyond singlets and doublets, and (ii) only mixing with a single B⁰ is considered. The presence of LH or RH mixings which can a lect the b neutral current couplings is indicated under Mixing'. Subleading mixings, quadratically suppressed, are given in parenthesis. Equivalent models, for the purposes of R_b, are indicated by a prime (⁰) in the Model' colum n, while models satisfying eq. (9) and which can account for the deviations in R_b with small mixing angles, are labeled by an asterisk ⁽⁾. Large RH mixing solutions are labeled by a double asterisk ⁽⁾, while models 7, 7⁰ and 7⁰⁰ allow for a solution with large LH mixing.


We can now enumerate all the possibilities allowed by assumptions (i) and (ii).

W ith the perm itted values of I_{R}^{0} and I_{L}^{0} listed above, and the requirement that at least one of the two conditions (13) { (14) is satisfied, there are 19 possibilities, listed in Table 2. A lthough not all of them are anomaly-free, the anomalies can always be canceled by adding other exotic fermions which have no elect on R_b. Since only the values of I_{3L}^{0} and I_{3R}^{0} are important for the bineutral current couplings, for our purpose models with the same $I_{3L,R}^{0}$ assignments are equivalent, regardless of $I_{L,R}^{0}$ or dimension in the mass matrix or mixing pattern. A ltogether there are 12 inequivalent possibilities. Equivalent models are indicated by a prime (⁰) in the M odel' column in Table 2.

D ue to gauge invariance and to the restriction (i) on the H iggs sector, in several cases one of the o-diagonal entries M $_{12}$ or M $_{21}$ in eq. (10) vanishes, leading to a hierarchy between the LH and the RH m ixing angles. If the b⁰ is much heavier than the b, M $_{12} = 0$ yields $s_R = M_{21}=M_{22}$, while the LH m ixing is suppressed by M $_{22}^{2}$. If on the other hand M $_{21} = 0$, then the suppression for s_R is quadratic, leaving s_L as the dom inant m ixing angle. For these cases, the subdom inant m ixings are shown in parentheses in the M ixing' colum n in Table 2. Notice that while m odels 2 and 6 allow for a large right-handed m ixing angle solution of the R_b anom aly, the \equivalent" m odels 2⁰ and 6⁰ do not, precisely because of such a suppression.

Six choices satisfy one of the two conditions in eq. (9), and hence can solve the R_b problem using sm all m ixing angles. They are labeled by an asterisk ⁽⁾ in Table 2. Three of these models (10,11,12) satisfy the st condition for solutions using sm all LH m ixings. Since for all these cases $I_{3R}^0 < 0$, a large RH m ixing could alternatively yield a solution but because s_R is always suppressed with respect to s_L , this latter possibility is theoretically disfavored. The other three choices (models 3,8,9) satisfy the second condition for solutions using sm all RH m ixing. It is noteworthy that in all six models the relevant m ixing needed to explain R_b is automatically the dom inant one, while the other, which would exacerbate the problem , is quadratically suppressed and hence negligible in the large m $_{b^0}$ lim it. There are two choices (models 5,6) for which $I_{3R}^0 < 0$ and there is only RH m ixing, and one (model 2) for which $I_{3R}^0 < 0$ and s_R is unsuppressed with respect to s_L . These three cases allow for solutions with large RH m ixings, and are labeled by a double asterisk ⁽⁾. Finally, a solution with large LH m ixing is possible (models 7, 7⁰ and 7⁰⁰) in which $I_{3L}^0 = +1=2$, and $I_{3R}^0 = 0$ im plies no RH m ixing e ects.

In the light of Table 2 we now discuss in more detail the most popular models, as well as some other more exotic possibilities.



ure 2: The experimentally allowed mixing angles for a mirror family. The thick line covers the entire area of values for S_L and S_R which are needed to agree with the experimental value for R_b to the 2 level or better. The thin line represents the one-parameter family of mixing angles which reproduce the SM prediction. Notice that the small-mixing solution, which passes through $S_L = S_R = 0$, is ruled out since $I_L^0 = 0$ implies that any LH mixing will reduce g_L^b and thus increases the discrepancy with experiment.

Vector singlet: Vector ferm ions by de nition have identical left- and right-handed gauge quantum numbers. A vector singlet (model 1) is one for which $I_{L}^{0} = I_{R}^{0} = 0$. Inspection of eq. (8) shows that mixing with such a vector-singlet quark always acts to reduce R_{b}^{0} .

⁹ A Q = +2=3 vector singlet can however be used to reduce R_c [10][12][14], provided that steps are taken, as suggested in Section 2 above, to avoid the resulting preference for an unacceptably large value for $_{s}$ (M $_{z}$)).

M inter family: A m interchanged. Because I_{3L}^0 vanishes, LH m ixing acts to reduce the m agnitude of g_L^b , and so tends to m ake the prediction for R_b worse than in the SM. For su ciently large RH m ixing angles, however, this tendency m ay be reversed. As was discussed immediately below eq. (9), since I_{3R}^0 is negative a comparatively large m ixing angle of $s_R^2 > 1=3$ is needed to su ciently increase R b. Such a large RH m ixing angle is phenom enologically permitted by all o -resonance determ inations of g_R^b [19]. In fact, the b-quark production cross section and asymmetry, as measured in the $\{Z \text{ interference region [21][22], cannot distinguish between the two values <math>s_R^2 = 0$ and $4s_W = 3$, which yield exactly the same rates.¹⁰ Hence this kind of model can solve the R_b problem, though perhaps not in the most aesthetically pleasing way. As is shown in Fig. 2, the allowed range of m ixing angles is limited to a narrow strip in the s_L^2 \hat{s}_L^2 plane.

Fourth fam ily: A fourth fam ily (m odel 4) cannot resolve $R_{\rm b}$ via tree-level e ects because the new B ⁰ quark has the sam e isospin assignments as the SM b quark, and so they do not m ix in the neutral current.¹¹ Two other possibilities (m odels 4[°] and 4^{°°}) yield the sam e $I_{3L,R}^{0}$ assignments as the fourth fam ily m odel, and are similarly unsuccessful in explaining $R_{\rm b}$ since they do not modify the b quark neutral current couplings.

Vector doublets: There are two possibilities which perm it a $Q = \frac{1}{3}$ quark to transform as a weak isodoublet, and in both cases mixing with the SM b is allowed. They can be labeled by the dimension percharge value using the usual convention $Q = I_3 + Y$.

W ith the straightforward choice $I_{3L}^0 = I_{3R}^0 = 1=2 \text{ (m odel 5), we have } Y_L^0 = Y_R^0 = 1=6$. This type of m odel is discussed in Ref. [13], where the isopartner of the B⁰ is a top-like quark T⁰ having charge $+\frac{2}{3}$. Since these are the same charge assignments as for the standard LH b-quark, this leads to nomixing in the neutral current amongst the LH elds, and therefore only the right-handed mixing angle s_R is relevant for R_b . Since I_{3R}^0 is negative a comparatively large mixing angle of $s_R^2 > 1=3$ is needed to su ciently increase R_b , in much the same way as we found for the mirror-family scenario discussed above. The required mixing angle that gives the experimental value, $R_b = 0.2219 - 0.0017$, is

The other way to taQ = 1=3 quark into a vector doublet corresponds to $I_{3_{\rm L}}^0$ = $I_{3_{\rm R}}^0$ = +1=2 (m odel 8) and so Y⁰ = 5=6 [10]. The partner of the B⁰ in the doublet is then

an exotic quark, R, having Q = 4=3. Here f_{3L}^0 has the wrong sign for satisfying eq. (9) and so m ixing decreases the magnitude of g_{L}^b . On the other hand, I_{3R}^0 has the right sign to increase g_{R}^b . W hether this type of model can work therefore depends on which of the two competing e ects in R_b w ins. It is easy to see that in this model the M_{21} entry in the B {B⁰ m ass matrix eq. (10) vanishes, which as discussed above results in a suppression of s_L quadratic in the large m ass, but only a linear suppression for s_R . Hence, s_L becomes negligible in the large m b_0 lim it, leaving s_R as the dom inant m ixing angle in R_b . The m ixing angle which reproduces the experimental value for R_b then is

However, in order to account for such a large value of the m ixing angle in a natural way, the b^0 cannot be much heavier than 100 G eV.

Similarly to the Y⁰ = 5=6 vector doublet case, models 3 and 9 also provide a solution through RH mixings. In model 3, the subdom inant competing e ect of s_L is further suppressed by a smaller I_{3L}^0 , while in model 9 the e ect of s_R is enhanced by $I_{3R}^0 = +1$, and hence a mixing angle a factor of 4 smaller that in (16) is su cient to explain R b.

Vector triplets: There are three possibilities for placing a vector B^0 quark in an isotriplet representation: $I_{3L}^0 = I_{3R}^0 = 1;0;+1$. The last does not allow for b m ixing, if only H iggs doublets and singlets are present, and for our purposes, $I_{3L}^0 = I_{3R}^0 = 0$ (m odel 1^0) is equivalent to the vector singlet case already discussed. Only the assignment $I_{3L}^0 = I_{3R}^0 = I_{3R}^0$

1 (m odel10) allows for a resolution of the R_b problem, and it was proposed in R ef. [12]. If B⁰ is the low est-isospin m ember of the triplet there is an exotic quark of charge Q = +5=3 in the model. A gain in the lim it of large b^0 m assone combination of mixing angles (in this case s_R) is negligible, due to the vanishing of M₁₂ in eq. (10). As a result, s_L plays the main role in R_b . A greem ent with experiment requires

Since the resulting change to g_L^b is so small, such a slight m ixing angle would have escaped detection in all other experiments to date.

Sim ilarly to this case, models 11 and 12 also provide a solution through LH m ixings. In model 11 the unwanted e ects of s_{R} are further suppressed, while for model 12 a LH m ixing som ewhat sm aller than in (17) is su cient to explain the data.

O ur analysis of tree level e ects shows that both Z -m ixing and b-m ixing can resolve the R_b discrepancy. b-quark m ixing solutions satisfying the two assumptions that (i) there are no new H iggs representations beyond singlets and doublets, and (ii) only m ixing with a single B⁰ is relevant, have been completely classi ed. The list of the exotic new B⁰ quarks with the right electroweak quantum numbers is given in Table 2. Solutions with sm all s_R and s_L m ixing angles are possible when the B_R^0 is the member with highest I_{3R}^0 in an isodoublet or isotriplet, or when B_L^0 is the member with lowest I_{3L}^0 in an isotriplet or isoquartet. In all these cases, new quarks with exotic electric charges are also present. Some other possible solutions correspond to $I_{3R}^0 < 0$ and are due to m ixing am ongst the RH b-quarks involving rather large m ixing angles, while for $I_{3L}^0 = +1=2$ we ind another solution requiring even larger LH m ixing. It is intriguing that such large m ixing angles are consistent with all other b-quark phenom enology. We have not attempted to classify m odels in which m ixing with new states with very large values of $I_{3L,R}^0$ can arise as a result of bootstrapping through some interm ediate B⁰ m ixing. Under special circum stances, they could allow for additional solutions.

For some of the models considered, the contributions to the oblique parameters could be problem atic, yielding additional constraints. However, for the particular class of vectorlike models (which includes two of the small mixing angle solutions) loop e ects are su ciently small to remain acceptable.¹² This is because, unlike the top quark which belongs to a chiralmultiplet, vectorlike heavy b^0 quarks tend to decouple in the limit that their masses get large. Introducing mixing with other fermions does produce nonzero oblique corrections, but these remain small enough to have evaded detection. Exceptions to this statement are models involving a large number of new elds, like entire new generations, since these tend to accumulate large contributions to S and T.

4.0 ne-Loop E ects: t-Quark M ixing

We now turn to the modi cations to the Z bb couplings which can arise at one loop. Recall that this option can only explain R_b if the LH b-quark coupling, g_L^b , receives a negative correction comparable in size to the SM m_t-dependent contributions. As was argued in section 2, it is the LH coupling we are interested in because a loop-level change in g_R^b is too small to x the discrepancy between the SM and experiment.

The fact that the R_b problem could be explained if the m_t-dependent one-loop contributions of the SM were absent naturally leads to the idea that perhaps the t-quark couples di erently to the b-quark than is supposed in the SM. If the t quark m ixes signi cantly with a new t⁰ quark one m ight be able to signi cantly reduce the relevant contributions below their SM values. In this section we show that it is at best possible to reduce the

¹² Vectorlike m odels have the additional advantage of being autom atically anom aly free.

discrepancy to 2 in m odels of this type, and so they cannot claim to completely explain the R_b data.

O ur survey of t-quark m ixing is organized as follows. We rst describe the fram ework of m odels within which we system atically search, and we identify all of the possible exotic t-quark quantum numbers which can potentially work. This study is carried out much in the spirit of the analysis of bm ixing presented in section 3. We then describe the possible t^0 loop contributions to the neutral-current b couplings. Since this calculation is very sim ilar to computing the m_t -dependent elects within the SM, we brie y review the latter. Besides providing a useful check on our nal expressions, we not that the SM calculation also has several lessons for the more general t-quark m ixing models.

4.1) Enum erating the M odels

In this section we identify a broad class of models in which the SM top quark mixes with other exotic top-like fermions. As in the previous section concerning b-quark mixing, we denote the electroweak eigenstates by capitals, T , and the mass eigenstates by low ercase letters, tⁱ. To avoid confusion, quantities which speci cally refer to the b sector will be labeled with the superscript ^B. By de nition, a T⁰ quark must have electric charge Q = 2=3, but may in principle have arbitrary weak isospin $R^{0}_{L,R} = (I^{0}_{L,R}; I^{0}_{3L,R})$. Following closely the discussion in the previous section, we make three assumptions which allow for a drastic simplication in the analysis, without much loss of generality:

(i): First, the usual T-quark is only allowed to m ix with a single f quark at a time, producing the mass eigenstates t and t^0 .

(ii): Second, for the Higgs-boson representations, we assume only one doublet and singlets. A dditional doublets would complicate the analysis of the radiative corrections in a model-dependent way due to the extra diagram s involving charged Higgs bosons.

(iii): Finally, certain f-quark representations also contain new B⁰ quarks. We denote the B⁰_L and B⁰_R as exotic' whenever they have non-standard weak isospin assignments, that is, $I_{3L}^{0b} \in \frac{1}{2}$ or $I_{3R}^{0b} \in 0$. As we have already discussed, for exotic B⁰ quarks b{b⁰ m ixing willmodify the bneutral-current couplings at tree level, overwhelm ing the loop-suppressed t{t⁰ m ixing e ects in R_b. We therefore carry out our analysis under the requirement that any b{b⁰ m ixing a ecting the bneutral-current couplings be absent.

Our purpose is now to exam ine all of the alternatives which can arise subject to these three assumptions. A coording to (i), the T {T 0 m ass matrices we consider are 2 2, and

can be written in the general form

Due to our restriction (ii) on the Higgs sector, certain elements of this mass matrix are nonzero only for particular values of the T⁰ weak isospin. Moreover, whenever T_R^0 belongs to a multiplet which also contains a Q = 1=3 B_R^0 quark, the M $_{12}^B$ and M $_{12}$ entries of the B {B⁰ and T {T⁰ m ass matrices are the same. In those cases in which the B⁰ quark is exotic, assumption (iii) then forces us to set M $_{12}$ = 0. In contrast, the M $_{21}^{e}$ entries are unrelated { for example, the choice M $_{21}^B$ = 0 is always possible even if M $_{21}$ $\stackrel{6}{\leftarrow}$ 0 for the T and T⁰ quarks.

In order to select those representations, $R_{L,R}^0$, which can m ix with the SM T quark, we require the following conditions to be satistical:

(1): In order to ensure a large m ass for the f, we require M $_{22} \in 0$. A nalogously to (11) and (12), this im plies

(2): To ensure a non-vanishing t{m ixing we require at least one of the two o -diagonal entries, M₁₂ or M₂₁, to be non-vanishing. This translates into the following conditions on R_{L}^{0} and R_{R}^{0} :

(3): W henever B_{R}^{0} contains a Q = 1=3 quark, and either B_{L}^{0} or B_{R}^{0} have non-standard isospin assignments, we require $M_{12} = 0$. This ensures that at tree level the neutral current b couplings are identical to those of the SM. C learly, in the cases in which the particular R_{L}^{0} representation implies a vanishing M_{21} element, imposing the condition $M_{12} = 0$ completely removes all $t\{t^{0} m \text{ ixing}$.

We now may enumerate all the possibilities. From eqs. (19) { (22), it is apparent that as in the B⁰ case the only allowed representations must have $I_R^0 = 0; \frac{1}{2}; 1$ and $I_L^0 = 0; \frac{1}{2}; 1; \frac{3}{2}$.

Consider rst $I_{L}^{0} = 1$ or $\frac{3}{2}$. In this case, from eq. (21), M₂₁ = 0. Thus, we need M₁₂ \notin 0 if there is to be any t{t⁰ m ixing. The four possibilities for R_{R}^{0} are shown in eq. (22). Of these, $R_{R}^{0} = (0;0)$ is not allowed since eq. (19) is not satis ed. In addition, $R_{R}^{0} = (\frac{1}{2};\frac{1}{2})$ and (1;0) both contain exotic B⁰ quarks ($I_{3R}^{0} = \frac{1}{2}$ or 1) and so M₁₂ is forced to vanish, leading to not t{t⁰ m ixing. This leaves $R_{R}^{0} = (1;1)$ as a possibility, since the B_{R}^{0} is not exotic ($I_{3R}^{0} = 0$). If we choose R_{L}^{0} such that $I_{3L}^{0} = \frac{1}{2}$, then both B_{L}^{0} and B_{R}^{0} are SM -like, and b{b⁰ m ixing is not prohibited since it does not a ect the b neutral current couplings. Thus, the combination $R_{L}^{0} = (\frac{2}{2};\frac{1}{2})$, $R_{R}^{0} = (1;1)$ is allowed.

Next consider $I_L^0 = 0$ or $\frac{1}{2}$. Here, regardless of the value of I_{3L}^0 , M₂₁ can be nonzero. Thus any R_R^0 representation which satis es eqs. (19) and (20) is permitted. It is straight-forward to show that there are 11 possibilities.

The list of the allowed values of I_{3L}^0 and I_{3R}^0 which under our assumptions lead to $t\{t^0 \text{ m ixing is shown in Table 3. There are twelve possible combinations, including fourth-generation ferm ions, vector singlets, vector doublets, and m irror ferm ions. Not all of these possibilities are anom aly-free, but as already noted one could always cancel anom alies by adding other exotic ferm ions which give no additional e ects in R_b.$

It is useful to group the twelve possibilities into three di erent classes, according to the particular constraints on the form of the T {T 0 m ass m atrix in eq. (18).

The rst two entries in Table 3, which we have assigned to group A, correspond to the special case in which the $B_{L,R}$ and $B_{L,R}^{0}$ have the same third component of weak isospin, hence leaving the bneutral current una ected by mixing. Because both B_{L}^{0} and B_{R}^{0} appear in the same multiplets with T_{L}^{0} and T_{R}^{0} , two elements of the B-quark and T-quark mass matrices are equal:

A swe will see, this condition is in portant since it in plies a relation between the m ixings and the m_t, m_t m ass eigenvalues. A lthough outside the subject of this paper, it is noteworthy that for these m odels the simultaneous presence of both $b{b^0}$ and $t{t^0 R H}$ m ixing generates new e ects in the charged currents: right-handed W to charged currents get induced, proportional to the product of the T and B quark m ixings $s_R s_R^B$. C om pared to the m odi cations in the neutral currents and in the LH charged currents, these e ects are of higher order in the m ixing angles [18][19] and, m ost in portantly, they can only change the RH b coupling. But as noted above, g_R^B is far too sm all to account for the m easured R_b value using loop e ects of this kind. Therefore the m ixing-induced RH currents allowed in

Values of the weak isospin of T_L^0 and T_R^0 which, under the only restrictions of singlet and doublet H iggs representations, lead to nonzero $t{t^0}$ neutral current m ixing. The M odel' colum n, labels the m ore fam iliar possibilities for the T⁰ quarks: Vector Singlets, M irror Ferm ions, Fourth Fam ily and Vector D oublets. The other m odels are m ore exotic.

m odels A_1 and A_2 are ine ective for xing the R_b discrepancy, and will not be considered in the remainder of this paper.

For the models in group B, the condition

holds. In the four cases corresponding to $R_R^0 = (1;0)$ (m odels $B_1; B_3$) and $R_R^0 = (1=2;1=2)$ (m odels $B_2; B_6$), an exotic B_R^0 quark is present in the same T_R^0 multiplet. Hence M_{12} has to be set to zero in order to forbid the unwanted tree-level b mixing e ects. In the other three cases belonging to group B, T_R^0 corresponds to the low est component of non-trivial multiplets: $R_R^0 = (1; 1)$ (m odel B_4) and $R_R^0 = (1=2; 1=2)$ (m odels B_5, B_7). For these values of I_{3R}^0 , $M_{12} = 0$ is autom atically ensured, due to our restriction to Higgs singlets

or doublets. Furtherm ore, these representations do not contain a B_{R}^{0} quark, and no B_{L}^{0} quark appears in the corresponding R_{L}^{0} . There is therefore no b{b⁰ m ixing.

We should also remark that in model B₃ no B_L⁰-quark appears in R_L⁰. However, a B_L⁰ is needed as the helicity partner of the B_R⁰ present in R_R⁰ = (1;0). Because of our restriction on the allowed Higgs representations, B_L⁰ must belong to R_L⁰ = (1;0) or R_L⁰ = (1=2;1=2), which in turn contain a new T_L⁰ f T_L⁰. While the rst choice corresponds to a type of T_L⁰ mixing which we have already excluded from our analysis, the second choice is allowed and corresponds to model B₁. Following assumption (i), even in this case we neglect possible T_L⁰ mixings of type B₁, when analysing B₃.

Finally, the remaining three models constitute group C, corresponding to $R_R^0 = (0;0)$. In this group, T_R^0 is an isosinglet, as is the SM T_R , implying that only LH t{t⁰ m ixing is relevant. For C₂ and C₃, R_L^0 does not contain a B_L^0 , while for C₁ the B_L^0 is not exotic. Hence in all the three cases the b neutral-current couplings are unchanged relative to the SM, and we need not worry about tree-level b-m ixing e ects.

4.2) t-Quark Loops W ithin the Standard M odel

Before exam ining the e ect oft{ t^0 m ixing on the radiative correction to $Z \overline{b}b$, we rst review the SM computation. We follow the notation and calculation of Bernabeu, P ich and Santam ar a [11](BPS). The corrections are due to the 10 diagram s of F ig. 3. All diagram s are calculated in 't H ooft-Feynm an gauge, and we neglect the b-quark m ass as well as the di erence $y_{tb}f_1$ 1.


D ue to the neglect of the b-quark m ass, and due to the LH character of the chargedcurrent couplings, the t-quark contribution to the Z bb vertex correction preserves helicity. Follow ing BPS we write the helicity-preserving part of the Z ! bb scattering am plitude as

where represents the loop-induced correction to the Z b vertex. I (s;r) is a dimensionless and Lorentz-invariant form factor which depends, a priori, on the three independent ratios: $r = m_t^2 = M_w^2$, $s = M_z^2 = M_w^2$ and $q^2 = M_w^2$. For applications at the Z resonance only two of these are independent due to the mass-shell condition $q^2 = M_z^2$. Moreover, for an on-shell Z, non-resonant box-diagram contributions to $e^+e^-!$ bo are unimportant, and I(s;r) can be treated as an electively gauge-invariant quantity.

The contributions due to the t-quark m ay be isolated from other radiative corrections by keeping only the r-dependent part of I(s;r). BPS therefore de ne the di erence

In this last equation V P.(s;r) denotes the m_t -dependent contributions which enter $_b$ through the bop corrections to the gauge-boson vacuum polarizations.

The function F^{SM} (s;r) is straightforward to compute. A lthough the resulting expressions are somewhat obscure, the special case s = 0 reveals some interesting features which are also present in our new physics calculations, and so we show the s = 0 limit explicitly here. For s = 0, an evaluation of the graphs of Fig. 3 gives the following expressions:

The picture becomes much simpler after summing the diagrams to obtain the total SM contribution:

There are two points of interest in this sum. First, it is ultraviolet nite since all of the divergences / 1=(n 4) have cancelled. This is required on general grounds since there can be no r-dependent divergences in I^{SM} (s;r), and so these must cancel in F^{SM} (s;r). A similar cancellation also occurs when new physics is included, provided that it respects the SU_L (2) U_r (1) gauge symmetry and that the complete set of new contributions is carefully included.

The second interesting feature of eq. (38) lies in its dependence on the weak mixing angle, s_w . Each of the contributions listed in eqs. (29) through (35) has the form $F^i = (x^i + y^i s_w^2) = s_w^2$; however all of the terms involving y^i have cancelled in the sum, eq. (38). This very general result also applies to all of the new -physics models we consider in subsequent sections. As will be proved in Section 5, the cancellation is guaranteed by electrom agnetic gauge invariance, because the term s subleading in s_w^2 are proportional to the electrom agnetic b-quark vertex at $q^2 = 0$, which must vanish. This gives a powerful check on all of our calculations.

Rather than using complete expressions for F (s;r), we nd it more instructive to quote our results in the lim it r 1, where powers of 1=r and s=r may be neglected. We do the same for the ratio of masses of other new particles to M_w^2 when these arise in later sections. Besides permitting compact form ulae, this approximation also gives num erically accurate expressions for most of the models' parameter range, as is already true for the SM, even though r in this case is only 4. In the large-r lim it F^{SM} (s;r) becomes

where the ellipsis denotes term s which are nite as r ! 1. Several points are noteworthy in this expression.

1: The s-dependent term appearing in eq. (39) is numerically very small, changing the coe cient of $\ln r$ from 3 to 2.88. This type of s-dependence is of even less interest when we consider new physics, since our goal is then to exam ine whether the new physics can explain the discrepancy between theory and experiment in R_b . That is, we want to see if the radiative corrections can have the right sign and magnitude to change $_b$ by the correct am ount. For these purposes, so long as the inclusion of q^2 -dependent term s only changes the numerical analysis by factors < 25% (as opposed to changing its overall sign) they may be neglected.

2: The above-m entioned cancellation of the term s proportional to $\frac{2}{5}$ when s = 0 no longer occurs once the s-dependence is included. This is as expected since the electrom agnetic W and identity only enforces the cancellation at $q^2 = 0$, corresponding to s = 0 in

the present case. Notice that the leading term, proportional to r, is s-independent, and because of the cancellation it is completely attributable to graph (2a) of Fig. 3. All of the other graphs cancel in the leading term. Due to its intrinsic relation with the cancellation of the s_w^2 -dependent terms, the fact that only one graph is responsible for the leading contribution to q^2 still holds once new physics is included. This will prove useful for identifying which features of a given m odel control the overall sign of the new contribution to q^2 .

3: Since the larger lim it corresponds to particle m asses (in this case m_{e}) that are large compared to M $_{W}$ and M $_{z}$, this is the lim it where the elective-lagrangian analysis described in Section 2 directly applies. Then the function F can be interpreted as the elective Z bo coupling generated when the heavy particle is integrated out. Quantitatively, d_{e}^{b} is related to F by

4: The vacuum polarization contributions to $_{\rm b}$ of eq. (28) have a sim ilar interpretation in the heavy-particle lim it. In this case the rem oval of the heavy particles can generate oblique parameters, which also contribute to $_{\rm b}$. In the heavy-particle lim it eq. (28) therefore reduces to the rst of eqs. (4).

4.3) d_{p}^{b} in the t-Q uark M ixing M odels

We may now compute how mixing in the top-quark sector can a ect the bop contributions to the process Z ! $b\bar{b}$. As in the SM analysis, we set $m_b = 0$. In addition, following the discussion in the previous subsection, we neglect the s-dependence in all our expressions. We also ignore all vacuum -polarization e ects, knowing that they essentially cancel in R_b . Finally, in the CKM matrix, we set $j'_{id}j = j'_{is}j = 0$ where $i = t;t^0$. Thus, the charged-current couplings of interest to us are described by a 2 2 mixing matrix, just as in the neutral-current sector. In the absence of $t\{t^0 \text{ mixing this condition im plies } j'_{tb}j = 1$.

For $t\{t^0 \text{ m ixing, independent of the weak isospin of the T⁰, we write$

where $c_{L} = \cos_{L}$, etc.. The matrices $U_{L,R}$ are analogous to the $b\{b^0 \text{ mixing matrices} de \text{ ned in eq. (5) in our tree-level analysis of b mixing.}$

In the presence of $t{t^0}$ m ixing, the diagonal neutral-current couplings are m odi ed:

Eq. (41) determ ines the elective t and t⁰ neutral-current couplings (eqs. (42) { (46)). However, the charged-current couplings depend on the matrix $V = U_L^{Y} U_L^{B}$. Hence we need to consider also b mixing, since, as discussed in Sec. 4.1, in those cases in which the B⁰ quark is not exotic ($I_{3L}^{CB} = 1=2$, $I_{3R}^{CB} = 0$), we have no reason to require $U_L^{B} = I$ (i.e. no b-b⁰ mixing). We then denote the 2 2 charged current mixing matrix

We also note that, by assumption, whenever $V \in U_{L}$ we necessarily have $I_{3L}^{0} = +1=2$ (so that $I_{3L}^{0} = -1=2$) in order to guarantee that the B_{L}^{0} is not exotic. From eqs. (43), (44) and (46), this implies that $g_{L}^{t} = g_{L}^{t^{0}} = g_{L}^{tt^{0}} = 0$, that is, the m ixing elects on the LH t and t^{0} neutral-current couplings vanish.

The Feynm an rules of relevance for computing the Z bb vertex loop corrections in the presence of a mixing in the top-quark sector can now be easily written down:

where are the unphysical charged scalars, and $t_i = t; t^0$. The vertices listed in eq. (48) reduce to the SM Feynman rules in the lim it of nom ixing.

A spointed out at the end of subsection 4.1, in som e groups of models equalities can be found between som e elements of the T {T⁰ and B {B⁰m ass matrices. These have important consequences. In particular, once expressed in terms of the physical masses and mixing angles, the equalities of eq. (23) (which hold in the models of group A) can be written

For the models in group B, the vanishing of M₁₂ implies no b mixing. Then $V = U_L$, and eq. (49) still holds in the lim it V_{tb} ! c_L , V_{t^0b} ! s_L . For the models in group C no particular relation between m asses and mixing angles can be derived. For example, it is clear that in the 4th fam ily model C₁, eq. (50) does not hold. However, for all these models $I_{3R}^0 = 0$. Hence, noting that all the g_R couplings in eqs. (43), (44) and (46) are proportional to I_{3R}^0 , and de ning $r^0 = m_{t^0}^2 = M_w^2$, squaring eq. (50) yields a relation which holds for all models in Table 3:




Figure 4: The additional Feynman diagram swhich are required for models in which the tquark mixes with an exotic, heavy t^0 quark.

How do we generalize the SM radiative correction to include $t\{t^0 \text{ m ixing}?$ First note that for each of the diagram s in Fig. 3, there is also a diagram in which all the t-quarks are replaced by t^0 -quarks. Second, there are 2 new diagram s (Fig. 4) due to the FCNC coupling of the Z to the t and t^0 . So to generalize the SM result to the case of m ixing, three things have to be done:

(i): multiply eqs. (29)-(35) by $\frac{v_{b}^{2}}{b}$ for the t contribution and $V_{t^{0}b}^{2}$ for t^{0} (with r ! r^{0}),

(ii): replace g_{R} by the modi ed couplings in eq. (42), adding eqs. (43) and (44) respectively for t and t⁰,

(iii): include diagrams 3(a) and 3(b) (Fig. 4) corresponding to the FCNC couplings (eqs. (45)-(46)).

A glance at the Feynm an nules in eq. (48) shows that in the rst step (i), a correction proportional to $g_{L,R}^{t,S,M}$, and independent of the $g_{L,R}$ couplings, is generated. This correction is common to all models in Table 3 { it appears even in the case in which the tNC couplings are not a ected (4th family). In contrast, steps (ii) and (iii) generate corrections which di er for di erent models. It is useful to recast them into two types, one proportional to the LH neutral current couplings (/ $V_{ib}V_{jb}g_{L}$), and the other proportional to the RH neutral current couplings (/ $V_{ib}V_{jb}g_{R}$). The LH and RH corrections vanish respectively

for $I_{3L}^0 = +1=2$ and $I_{3R}^0 = 0$, when the corresponding neutral-current couplings are not a ected by the mixing.

In the presence of mixing, the correction due to the diagram s of Fig. 3 involving internal t-quarks becomes

A swe have already pointed out, because of our requirement of no B {B⁰ m ixing when the B⁰ is exotic, only when $I_{3L}^0 = +1=2$ can we have $c_L \in V_{tb}$, $s_L \in V_{t^0b}$. From eqs. (62), (64) and (68) we see that there are only two independent m ixing parameters relevant for the complete analysis of our problem : the LH m atrix element V_{tb} and the RH m ixing s_R . Furtherm ore, note that as r^0 ! r, all the corrections in eqs. (65), (67) and (69) vanish, independent of the m ixing angles. This comes about because of a G M -like m echanism for all the pieces which do not depend on I_{3R}^0 . The I_{3R}^0 -dependent contribution from the RH ferm ions coupling to the Z vanishes in the lim it r^0 ! r as a consequence of eq. (50).

The question is whether it is possible to cancel this correction, thus elim inating the R_b problem, by choosing particular values of m_{t^0} and the m ixing angles. For various values of m_{t^0} , the value of X _{corr} (eq. (58)) is shown in Table 4.

We see that even for $m_{t^0} > m_t$, it is possible to choose I^0_{3L} , I^0_{3R} , and the LH and RH m ixing angles such that the correction is negative. So the discrepancy in R_b between theory and experiment can indeed be reduced via $t\{t^0 \text{ m ixing}.$

Referring to the models listed in Table 4, the optim all choice for the weak isospin of the T⁰ is $I_{3L}^0 = 1=2$ and $I_{5R}^0 = 1$, regardless of the value of m_{t^0} . Furthermore, maximal RH mixing, s_R^2 1, is also preferred. However, even with these choices, it is evidently impossible to completely remove the R_b problem. From the above table, the best we can do is to take $m_{t^0} = 75$ GeV and $V_{t^0b}^2 = s_L^2 = 0.6$, in which case the total correction is $X_{corr} = 3.68$. This leaves a 1.5 discrepancy in R_b , which would put it in the category of the other marginal disagreements between experiment and the SM. However, such a light t⁰ quark has other phenom enological problem s. In particular, CDF has put a lower lim it of 91 GeV on charge 2=3 quarks which decay primarily to W b [24]. Unless one adds other new physics to evade this constraint, the lightest t⁰ allowed is about m t⁰ 100 GeV. In this case, maximal LH mixing ($V_{t^0b}^2 = s_L^2$ 1) gives the largest elect: $X_{corr} = 2.7$. The predicted value of R_b is then still some 2 below the measured number.

A nother possibility is that the charge 2=3 quark observed by CDF is in fact the t^0 , while the real t-quark is much lighter, say $m_t = 100 \text{ GeV}$. A ssum ing sm all t{ t^0 m ixing,

and that the t⁰ is the lightest m ember of the new multiplet, the t⁰ will then decay to W b, as observed by CDF, but the SM radiative correction will be reduced. This situation is essentially identical to that discussed above, in which the LH t{t⁰ m ixing is m axim al, and m_{t⁰} 100 G eV : the SM value of R_b will still di er from the experimental measurement by about 2 . The only way for such a scenario to work is if m_t < M_w. However, new physics is then once again required to evade the constraint from Ref. [24].

For all the possibilities of this section our conclusion is therefore the sam e: it is not possible to completely explain R_b through $t\{t^0 \text{ m ixing}$. The best we can do is reduce the discrepancy between theory and experiment to about 2 , which m ight turn out to be su cient, depending on future m easurem ents.

5.0 ne-Loop E ects: 0 ther M odels

A nother way to change g_L^b at the one-loop level is to introduce exotic new particles that couple to both the Z and the b quark. O ne-loop graphs involving such particles can then modify the Z bb vertex as measured at LEP and SLC. Recall once more the conclusion from Section 2: agreement with experiment requires the LH b-quark coupling, g_L^b , to get a negative correction comparable in size to the SM m_t-dependent contributions since loop-level changes to g_R^b are too small to be detectable.

In this section we rst exhibit the general one-bop correction due to exotic new scalar and spin-half particles, with the goal of identifying the features responsible for the overall sign and m agnitude of the result. We then use this general result to investigate a num ber of m ore speci c cases.

The answer is qualitatively di erent depending on whether or not the new scalars and ferm ions can m ix, and thus have o -diagonal couplings to the Z boson. We therefore treat these two alternatives separately. The simplest case is when all Z couplings are diagonal, so that the one-loop results depend only upon two masses, those of the ferm ion and the scalar in the loop. Then the correction to the Z bb vertex is given by a very simple analytic form ula, which enables us to easily explain why a num ber of models in this category give the W rong' sign, reducing b rather than increasing it.

M ore generally however, the new particles in the loops have couplings to the Z which are diagonal only in the avour basis but not the m ass eigenstate basis, so the expressions become signi cantly m ore complicated. This occurs in supersymmetric extensions of the standard m odel, for example. A fler proposing several sample m odels which can resolve the R_b problem, we use our results to identify which features of supersymmetric m odels are instrumental in so doing.

5.1) D iagonal C ouplings to the Z : G eneral R esults

We now present form use for the correction to the Z bo vertex due to a loop involving generic scalar and spin-half particles. In this section we make the sim plifying assumption that all of the Z -boson couplings are avour diagonal. This condition is relaxed in later sections where the completely general expression is derived. The resulting form use make it possible to see at a glance whether a given model gives the right sign for alleviating the discrepancy between experiment and the SM prediction for R_b .

The one-loop diagram s contributing to the decay Z ! bb can be grouped according to whether the loop attaches to the b quark (i.e. the vertex correction and self-energy graphs of F ig. 5) or whether the loop appears as part of the gauge boson vacuum polarization (F ig. 6). For the types of m odels we consider these two classes of graphs are separately gauge invariant and nite, and so they can be understood separately. This is particularly clear in the lim it that the particles within the loop are heavy com pared to M $_{z}$, since then the vacuum polarization graphs represent the contribution of the oblique parameters, S and T, while the self-energy and vertex-correction graphs describe loop-induced shifts to the b-quark neutral current couplings, $\frac{1}{2}$.

Furtherm ore, although we must ensure that the oblique parameters do not become larger than the bound of eq. (3), eq. (4) shows that they largely cancel in the ratio R_b . We therefore restrict our attention in this section to the diagram s of Fig. 5 by them selves. The sum of the contributions of Fig. 5 is also nite as a result of the W ard identity which was alluded to in Section 3. This W ard identity relates the vertex-part graphs of Fig. 5a, b to the self-energy graphs of Fig. 5c, d. Since this cancellation is an important check of our results, let us explain how it comes about.

We rst consider an unbroken U (1) gauge boson with a tree-level coupling of g_b to the the b-quark. This gives rise to the fam iliar W and identity from quantum electrodynam ics: for external ferm ions with four-m om enta p and p^0 ,

If we denote the vertex-part contributions (F ig. 5a,b) to the elective vertex at zero momentum transfer by g, and the self-energy-induced wave function renormalization of the b quark by Z_b , then at one loop the W ard identity (74) reduces to $g_b(1 + Z_b) \not(p) = (g_b + g_b) \not(p)$, or

This last equation is the more general context for the cancellation which we found in Section 3; it states that the self-energy graphs (Fig. 5c,d) must precisely cancel the vertex part (Fig. 5a,b) in the lim it of zero momentum transfer. Another way of understanding eq. (75) is to imagine computing the elective b-photon vertex due to integrating out a heavy particle. Eq. (75) is the condition that the two elective operators \overline{b} and \overline{b} /b have the right relative normalization to be grouped into the gauge-covariant derivative: \overline{b} /b.

But for the external Z boson, the W and identity only applies to those parts of the diagram s which are insensitive to the fact that the U (1) sym m etry is now broken. These include the $1=(n \quad 4)$ poles from dimensional regularization, and also the contributions to the b neutral-current coupling proportional to s_w^2 , since the latter arise only through m ixing from the couplings of the photon.

We now return to the diagram s of Fig. 5. The rst step is to establish the Feynm an rules for the various vertices which appear. Since we care only about the LH neutral-current couplings, it su ces to consider couplings of the new particles to b_{L} :

In the examples which follow, the eld f can represent either an ordinary spinor (e.g., t) or a conjugate spinor (e.g., t^c). This di erence must be kept in m ind when inferring the corresponding charge assignments for the neutral-current couplings of the f. For example, the left-handed top quark has $I_{3L} = +\frac{1}{2}$, so $g_L^f = \frac{1}{2} - \frac{2}{3}s_W^2$ and $I_{3R} = 0$, so $g_R^f = -\frac{2}{3}s_W^2$. If the internal ferm ion were a top antiquark, however, we would instead have $g_R^f = -\frac{1}{2} + \frac{2}{3}s_W^2$ and $g_L^f = +\frac{2}{3}s_W^2$. The latter couplings follow from the form er using the transform ation of the neutral current under charge conjugation:

W e quote the results for evaluating the graphs of Fig. 5 in the limit where M_z (and of course m_b) are negligible compared to m_f and M , since they are quite simple and illum inating in this approximation. It will be shown that the additional corrections due to the nonzero mass of the Z boson are typically less than 10% of this leading contribution.



denotes the divergent combination $\frac{2}{n-4}$ + + ln (M²=4²) + $\frac{1}{2}$, and n_c is a colour factor that depends on the SU_c(3) quantum numbers of the elds and f. For example, n_c = 1 if 1 or f 1 (colour singlets); p = 2 if f = 3 and f = 3 or 6; $p = \frac{16}{3}$ if f = 3 and 8.

The cancellation of divergences we expected on general grounds is now evident in the present example, because electroweak gauge invariance of the scalar interaction (76) in plies that the neutral-current couplings are related by



Interestingly, it depends only on the axial-vector coupling of the internal ferm ion to the gauge boson W₃ and not on the vector coupling. The function of the masses F (r) is positive and monotonically increasing, with F (r) rasr! 0 and F (1) = 1, as can be seen in Fig.7.



bottom, the functions $F(m_f^2=M^2)$, $F_R(r) = F_s(r)$ and $F_L(r)$ which appear in the loop contribution to the left-handed Z bb vertex, sections 5.1 and 5.3.

It is straightforward to generalize eq. (82) to include the e ect of the nonzero Z boson mass. Expanding to rst order in M $_z^2$, one obtains an additional correction to the e ective

vertex,

To see that this is typically an unimportant correction, consider the limit in which the scalar and ferm ion masses are equal, r = 1. Then the total correction (82)+ (83) is

A lthough the M $_z^2$ correction can be signi cant if $g_L^f = g_R^f$, the total correction would then be too small to explain the R_b discrepancy, and would thus be irrelevant.

5.2) W hy M any M odels D on't W ork

W hat is in portant for applications is the relative sign between the tree and one-loop contributions of eq. (82). In order to increase R_b so as to agree with the experimental observation, one needs for them both to have the same sign, and so $q_{L}^{b} / (g_{L}^{f} - g_{I}^{f}) < 0$ in eq. (82). Thus an internal ferm ion with the quantum numbers of the b-quark has $g_{L}^{f} - g_{I}^{f} = \frac{1}{2}$ and would increase R_b . Conversely, a ferm ion like the t-quark has $g_{L}^{f} - g_{I}^{f} = +\frac{1}{2}$ and so causes a decrease. Moreover, because the combination ($g_{L} - g_{I}$) is invariant under charge conjugation, the same statem ents hold true for the antiparticles: a b running in the loop would increase R_b whereas a twould decrease it.

It thus becomes quite easy to understand which models with diagonal couplings to the Z boson can improve the prediction for R_b . Multi-H iggs-doublet models have a hard time explaining an R_b excess because typically it is the top quark that makes the dominant contribution to the loop diagram, since it has the largest Yukawa coupling, Y_f 1, and the largest mass, to which the function F is very sensitive. However for very large tan (the ratio of the two H iggs VEV's), the Yukawa coupling of the t quark to the charged H iggs can be made sm all and that of the b quark can be made large, as in Ref. [25]. Fig. 7 shows that, in fact, one must go to extrem e values of these parameters, because in addition to needing to invert the natural hierarchy between y_t and y_b , one must overcom e the big suppression for sm all ferm ion masses com ing from the function F.

P recisely the sam e argum ent applies to a broad class of Zee-type m odels, where the SM is supplemented by scalar multiplets whose weak isospin and hypercharge permit a

Y ukawa coupling to the b quark and one of the other SM ferm ions. So long as the scalars do not m ix and there are no new ferm ions to circulate in the loop, all such m odels have the same di culty in explaining the R $_{\rm b}$ discrepancy. Below we will give some examples of m odels which, in contrast, are able to explain R $_{\rm b}$.

5.3) Generalization to Nondiagonal Z Couplings

We now turn to the more complicated case where mixing introduces o -diagonal couplings among the new particles. Because of mixing the couplings of the fermions to the Z will be matrices in the mass basis. Similar to eqs. (42) and (45) we write

where $U_{L,R}^{af}$ are the mixing matrices. An analogous expression gives the o-diagonal scalar-Z coupling in terms of the scalar mixing matrix, U_s^a . Of course if all of the mixing particles share the same value for I_3 , then unitarity of the mixing matrices guarantees that the couplings retain this form in any basis.

This modi cation of the neutral-current couplings has two important elects on the calculation of $\frac{1}{2}$. One is that the o-diagonal Z couplings introduce the additional graphs of the type shown in Fig. 5a,b, where the ferm ions or scalars on either side of the Z vertex have dierent masses. The other is that the mixing matrices spoil the relationship, eq. (81), whereby the term proportional to \mathbb{P}^{e} canceled in eq. (78). But this is only because of the mass-dependence of F and . Therefore the cancellation still occurs if all of the particles that mix with each other are degenerate, as one would expect. Moreover the ultraviolet divergences still cancel since they are mass-independent.

Evaluation of the graphs gives the following result at q^2 = M $_{\rm z}^2$ = 0:

where $G_{diag}=32^{-2}$ represents the contribution involving only the diagonal Z couplings, and so is identical to the previously derived eq. (78). It is convenient to write it as

The remaining terms in eq. (86) come from the new graphs of Fig. 5a,b, where the scalars or ferm ions on either side of the Z vertex have di erent masses, due to mixing:

and x, x^0 are the mass ratios $x = M^2 = m_f^2$ and $x^0 = M^2_0 = m_f^2$. These expressions have several salient features which we now discuss. First, eqs. (87), (88) and (89) are obviously much more complicated than eq. (82). In particular, it is no longer straightforward to simply read o the sign of the result.

Second, the sum of the UV divergences in eqs. (87), (88) and (89),

is basis independent since a unitary transform ation of the elds cancels between the Y ukawa and neutral-current couplings. Thus it can be evaluated in the electrow eak basis where the neutral-current couplings are diagonal and proportional to $g_1^f + g_2^b + g_3$, which vanishes due to conservation of weak isospin and hypercharge at the scalar-ferm ion vertex. We are therefore free to choose the renorm alization scale 2 in $\ln (M^2 = 2)$ to take any convenient value. The M-dependence of makes G 0 look unsymmetric under the interchange of and 0, but this is only an artifact of the way it is expressed. For example when there are only two scalars, G 0 is indeed symmetric under the interchange of their masses.

Third, all the contributions except those of G_{\circ} are suppressed by powers of $m_{f} = M$ in the lim it that the scalars are much heavier than the ferm ions. Thus to get a large

enough correction to g_L^b requires that: (i) not all of the scalars be much heavier than the ferm ions which circulate in the loop, or (ii) the scalars m ix signi cantly and have the right charges so that G_{-0} is nonnegligible and negative. We use option (ii) in what follows to construct another mechanism for increasing R_b .

Finally, even if the two ferm ions are degenerate, one does not generally recover the previous expression (78) that applied in the absence of mixing. This is because D irac mass matrices are diagonalized by a similarity transformation, M ! $U_L^{Y}M U_R$, not a unitary transformation. The left- and right-handed mixing angles can dier even when the diagonalized mass matrix is proportional to the identity. Thus, in contrast to eq. (93), the expression $\int_{ff^0} V_f Y_{f^0 0} [(g_L)^{ff^0}]$ is not invariant under transformations of the elds, because Y_f is rotated by U_R (recall that Y_f is the Yukawa coupling only for the RH f's) whereas g_L is rotated by U_L .

We can get some insight into eqs. (88) { (92) by looking at special values of the param eters. Let us assume there is a dom inant Yukawa coupling y between the left-handed b quark and a single species of scalar and ferm ion, f_1 and $_1$ in the weak basis,

1: If all the scalars are degenerate with each other, and likewise for the ferm ions, then the nonmixing result of eq. (82) holds, except one must make the replacement

where c_s and s_s are the cosine and sine of the scalar mixing angle. The function F_s (r) is positive except at r = 1 where it is zero, and so the sign of $\frac{d}{2}$ is completely controlled by the factor $(I_3^{-1} - I_3^{-2})$. We see that to increase R_b it is necessary that $I_3^{-1} < I_3^{-2}$.

3: W hen there are only two ferm ions, with weak eigenstates f, f_2 and m ass eigenstates f, f^0 both m uch heavier than any of the scalars, then

The function F_{L} has some of the same properties as $F_{s} = F_{R}$, including invariance under r ! 1=r, being positive sem ide nite and vanishing at r = 1. Plots of these functions are shown in Figure 7. Note that the rst line of eq. (100) is the same as (97).

To get som e idea of the error we have m ade by neglecting the m ass of the Z boson one can compute the lowest order correction as in section 5.3. The answer is m ore complicated than for the case of diagonal Z couplings, except when the ferm ions are degenerate with each other and likewise for the bosons. In that case the answer is given again by eq. (84) except that g_R^f ! $(g_R^f)^{11}$ and g_L^f ! $(U_R S_m U_L^Y g_L U_L S_m U_R^Y g_I)^{11}$, precisely as in eq. (97). Thus we would still expect it to be a small correction even when there is m ixing of the particles in the loop.

These simplifying assumptions can be used to gain a sem i-analytic understanding of why certain regions of parameter space are favoured in complicated models, which is often missing in analyses that treat the results for the loop integrals as a black box. The observations we make here may be useful when searching for modi cations to a model that would help to explain R_b . The next two sections exemplify this by creating some new models that take advantage of our insights, and by elucidating previous notings in an already existing model, supersymmetry.

5.4) Examples of M odels T hat W ork

B esides ruling out certain classes of models, our general considerations also suggest what is required in order to explain R_b . Obviously new ferm ions and scalars are required, whose Yukawa couplings allow them to circulate inside the loop. We give two examples, one with diagonal and one with nondiagonal couplings of the new particles to the Z boson.

For our rst example we introduce several exotic quarks F, P and N, and a new H iggs doublet , whose quantum numbers are listed in Table 5. The unorthodox electric charge assignments do not ensure cancellation of electroweak anomalies, but this can be xed by adding additional fermions, like m irrors of those given, which do not contribute to R_b .

where $_{ij}$ is the 2 2 antisymmetric tensor, H is the usual SM Higgs doublet and $Q_L = t_L = t_L$ is the SM doublet of third generation LH quarks. When H gets its VEV, hH i = v,

we nd two ferm ion m ass eigenstates, p and n, whose m asses are $m_p = g_p v$ and $m_n = g_n v$ and whose electric charges are $Q_p = q + 1$ and $Q_n = q$. There are also two new scalar m ass eigenstates, ', whose electric charges are $Q_+ = q + \frac{1}{3}$ and $Q_- = q - \frac{2}{3}$.

In the mass eigenstate basis, the Yukawa interactions with the new scalars are

from which we see that the n couples to the b-quark as in eq. (76).

The weak isospin assignments of the n are $I_{3L}^n = \frac{1}{2}$ and $I_{3R}^n = 0$, so that $g_L^n \quad q^n = \frac{1}{2}$. Therefore, from eq. (82), one obtains $q^0 < 0$. The central value of R_b can be reproduced if $q^0 = 0.0067$, which is easily obtained by taking y 1 and r 1, so that F (r) ' 1. The Yukawa coupling could be made smaller by putting the new scalars in a higher colour representation like the adjoint.

We have not explored the detailed phenom enology of this model, but it is clearly not nuled out since we are free to make the new ferm ions and scalars as heavy as we wish. And since we can always take $m_p = m_n$, there is no contribution to the oblique parameter T. The contribution to R_b does not vanish even as the masses become in nite, but this is consistent with decoupling in the same way as a heavy t quark, since the new ferm ions get their masses through electroweak symmetry breaking. The price we have to pay for such large masses is correspondingly large coupling constants.

Next we build a model that uses our results for nondiagonal couplings to the Z. It is a simplem odi cation of the SM that goes in the right direction for xing the R_b discrepancy but not quite far enough in magnitude. Variations on the same them e can completely explain R_b at the cost of making the model som ewhat more baroque.

O ur starting point is a two-H iggs doublet extension of the SM .W e take the two H iggs elds, $H_d = \begin{array}{c} H_d^0 \\ H_d \end{array}$ and $H_u = \begin{array}{c} H_u^0 \\ H_u^0 \end{array}$, to transform in the usual way under the SM gauge sym m etry. It was explained earlier why this model does not by itself produce the desired e ect, but eq. (98) suggests how to x this problem by introducing a third scalar doublet, = $\begin{array}{c} & & \\ & & \\ & & \\ & & \\ & & \\ & & \\ & & \\ \end{array}$, which m ixes with the other H iggs elds. The charge assignments of these elds, listed in Table 6, ensure that the two elds H_u^+ and $\begin{array}{c} & & \\ & & \\ & & \\ & & \\ \end{array}$

In this model the new scalar eld cannot have any Yukawa couplings to ordinary quarks since these are forbidden by hypercharge conservation. The only Yukawa couplings involving the LH b-quark are those which also generate the mass of the t-quark:

where $y_t = m_t = v_u$ is the conventionally-norm alized Yukawa coupling. We imagine v_u to be of the same order as the single-H iggs SM value, and so we expect y_t to be comparable to its SM size.

The scalar potential for such a model very naturally incorporates H_u^+ mixing. G auge invariance permits quartic scalar interactions of the form $(H_u^y)(H_u^yH_d) + hc$; which generate the desired o -diagonal term s: $(+ H_u^+ v_u v_d + + H_d^- v_u^2) + hc$:

Since the weak isospin assignments are $I_3^+ = p\frac{1}{2}$ and $I_3^{H_u^+} = +\frac{1}{2}$, the colour factor is $n_c = 1$ and the relevant Yukawa coupling is $y = y_t^- 2$, we see that eq. (98) predicts the following contribution due to singly-charged Higgs loops:

with r being the ratio of the scalar mass eigenstates, $r = M^{2} = M^{2}$. Taking optim istic values for the parameters¹³ ($_{s} = \frac{1}{4}$, $2c_{s}^{2}s_{s}^{2} = \frac{1}{2}$, $y_{t} = 1$ and $M = M^{\circ} = 10$), we and $q_{t}^{0} = 0.0043$, which is two thirds of what is required: ($\frac{1}{2}$)_{exp} = 0.0067 0.0021.

In addition to the contribution of the singly-charged scalar loops, one should consider those of the other nonstandard scalar elds we introduced. Since all of the scalars that m ix have the same eigenvalue for I_3 , their contribution is given by eq. (82), which is sm all if the scalars are m uch heavier than the light ferm ions. Then only the t-quark contribution is important. In this lim it there are appreciable contributions only from the three charged

¹³ Note that the charged-scalar m ixing in this model is suppressed if one of the scalar m asses gets very large compared to the weak scale.

scalar elds, one of which is eaten by the physical W boson and so is incorporated into the SM t-quark calculation, and the other two of which we have just computed.

So, for an adm ittedly special region of parameter space, this simplem odel considerably am eliorates the R_b discrepancy, reducing it to a 1 e ect. It is easy to adapt it so as to further increase d_b^b and also enlarge the allowed region of the model's parameter space. The simplest way is by increasing the size of the colour factor n_c or the isospin di erence I_3° I. For instance the new scalar, , could be put into a 4 of SU _L (2) rather than a doublet, and be given weak hypercharge $Y = +\frac{5}{2}$. Then the singly-charged state + has $I_3^{+} = \frac{3}{2}$, making I_3° I. I. = 2, which is twice as big as for the doublet. More new scalars must be added to generate m ixing am ongst the singly-charged scalar states.

A second variation would be let the two new Higgs doublets be colour octets since this gives more than a ve-fold enhancement of q_2^b due to the colour factor $n_c = \frac{16}{3}$. It is still possible to write down quartic scalar interactions which generate the desired scalar mixings. Either of these models has much more room to relax the previously tight requirements for optimal scalar masses and mixings.

5.5) The Supersymmetric Case

Let us now apply the above results to gain some insight into what would be necessary to explain R_b in supersymmetric extensions of the standard model. There are two kinds of contributions involving the top-quark Yukawa coupling, which one expects to give the dom inant e ect. These are the couplings of the left-handed b quark to the second H iggs doublet and the top quark, or to the corresponding H iggsinos and top squarks,

Of these, the second one gives a loop contribution like that of the two-H iggs doublet m odels discussed above: it has the wrong sign for explaining R_b . Since the m ass of the charged H iggs is a free parameter in supersymmetric models, we can imagine making it large enough compared to m_t so that, according to eq. (82), it has only a small e ect on R_b . We therefore concentrate on the H iggsino-squark part. The charged H iggsino m ixes with the W ino, and the right-handed top squark m ixes with its chiral counterpart, so in the notation of (94), we have $f_1 = \tilde{h}_2$, $f_2 = \tilde{W}$, $_1 = t_R$ and $_2 = t_L$. The corresponding charge matrices for the couplings to the W $_3$ are

$$g_{s} = \begin{array}{ccc} \frac{2}{3} s_{w}^{2} & 0 \\ 0 & \frac{1}{2} + \frac{2}{3} s_{w}^{2} \end{array} ; \qquad g_{L} = g_{R} = \begin{array}{ccc} \frac{1}{2} & s_{w}^{2} & 0 \\ 0 & 1 & s_{w}^{2} \end{array} : \qquad (107)$$

Because there are two possible colour combinations for the internal lines of the loops diagram, the colour factor in eqs. (87)-(89) is $n_c = 2$.

Before exploring the full expression for $\frac{1}{2}$ we can discover what parameter ranges are the most promising by looking at the limiting cases described by eqs. (97){(100). The most important lessons from these approximations follow from the charge matrices (107). We do not want the squarks to be much heavier than the charginos because then eq. (98) would apply and give the wrong sign for the correction due to the sign of the isospin di erence between the squarks. The other two cases, where the squarks are not much heavier than the charginos, manifest a strong suppression of the result unless the chargino mixing angles are such that $\sin(L_{1} = \frac{1}{2} R_{1} R_{2})$ is large, where s_{m} is the sign of the determinant of the chargino mass matrix. If on the other hand $\sin(L_{1} = \frac{1}{2} R_{1} R_{2}) = 0$, there is exact cancellation between g_{L} and g_{R} in these equations because of the fact that $g_{L} = g_{R}$ for the charginos. In sum mary, our analytic form ulas indicate that the favoured regions of parameter space for increasing R_{D} are where

$$\tan_{R} \tan_{L} = s_{n} = sign(m_{f} m_{f^{0}}); \qquad (108)$$

and at least one of the squarks is not much heavier than the charginos.

In supersymmetric models the Yukawa coupling that controls the largest contribution to R_b is that of the top quark, and it depends on the ratio of the two Higgs VEV's, tan = $v_2 = v_1$, by

$$y_{f} = \frac{m_{t}}{v \sin}; \qquad (109)$$

where $v = (v_1^2 + v_2^2)^{1=2} = 174 \text{ GeV}$. Therefore it is important to nd tan in terms of the chargino masses and mixing angles. The chargino mass matrix is given by

where is the coe cient of H $_1$ H $_2$ in the superpotential and M $_2$ is the soft-SU SY -breaking mass term for the W ino. It follows that



The above considerations allow us to understand why values of tan near unity are necessary for a supersymmetric solution to the R_b problem. From eq. (111) and the

maximization condition (108) we see that tan is restricted to lie between $j_{f} = m_{f^{\circ}} j$ and $j_{f^{\circ}} = m_{f} j$. Eq. (108) together with (110) also implies

This means that average value of the two chargino masses can be no greater than M $_{\rm W}$, so that the ratio jm $_{\rm f}$ =m $_{\rm f^{0}}$ j cannot di erm uch from unity unless one of the charginos is much lighter than the W boson. Using the LEP 1.5 lim it of 65 G eV for the lightest chargino [26] this would then require that tan < 1.5.

In the case that none of our sim plifying lim its apply, we have searched the param eter

space of the three independent ratios between the two scalar masses and the two ferm ion m asses, and the three m ixing angles $_{\rm R}$, $_{\rm L}$, $_{\rm s}$ to $\,$ nd which regions are favourable for increasing R_b. Figures 8a-d show the shift in g^b_t as a function of pairs of these param eters, using the Yukawa coupling (109) corresponding to a top quark mass of 174 GeV and the theoretical preference for tan > 1 (we implement the latter by setting $g_{i}^{b} = 0$ for parameters that would give tan < 1). As shown in Table 1, one needs $d^{b} = -$ 0:0067 in order to explain the observed value of R_b . The values of the masses are taken to be $M = M_0 = m_f = m_{f^0} = 1$ (in arbitrary units), except for those that are explicitly varied in each gure. In Fig. 8a we look at the situation in which tan $L = \tan_{R} = 1$, in contradiction to condition (108), and vary the scalar mixing angle and the mass of mostly t_{R} scalar in the lim it of zero squark m ixing. The sign of g_{L}^{b} has the wrong value, as predicted by eq. (98). Fig. 8b shows the same situation except that now $\tan_{1} = \tan_{2} = 1$, in accordance with eq. (108). Then the sign of g^b is negative, as desired, and has the right size for substantial ranges of $_{\rm s}$ and M $\,$. In Fig. 8c we keep all the m asses nearly degenerate and set s = 0 to show the dependence on tan L and tan R. It is easy to see that g_{L}^{b} has the correct sign and largest m agnitude (which is also alm ost as large as needed) when condition (108) is satis ed. Finally in Fig. 8d we show the dependence on the masses of the mostly-W ino ferm ion and on $_{R}$ when $_{s} = 0$ and tan $_{L} = -1$, showing again the preference for m ixing angles obeying (108), as well as some enhancem ent when there is a hierarchy between the two chargino masses.

O ne might therefore get the impression that it is easy to explain R_b using supersymmetric contributions to the Z bb vertex. The problem is that to get a large enough contribution one is driven to a rather special region of parameter space, which comes close to satisfying condition (108). As mentioned above, the consequent condition (112) prevents one from making the chargino masses arbitrarily heavy. This, coupled with the suppression in R_b when the squarks are heavier than the charginos, means that all the relevant supersymmetric particles must be relatively light, except the charged H iggs which has to be heavy to suppress the wrong-sign contribution from H^+ -t loops. Thus in the example of F ig. 8c, the preferred values of $c_k = 1$, $s_L = -1$, $s_l = c_l = 0$ imply that $m_f = v sin - and m_{f^0} = v cos$, while $= M_2 = 0$, which are precisely the circum stances of the supersymmetric models considered in Refs. [27] and [28]. F ig. 8d, on the other hand, has its maximum value of R_b at $c_k = s_k = c_l = -s_l = -1$, implying tan = -1 and thus from (112) that $jn_{f^0}j + jn_f j = 2M_w$. Because the lightest chargino mass is constrained by experimental lower limits, there is little parameter space for getting a large hierarchy between the two chargino masses, as one would want in the present example in order to get the full shift of 0.0067 in $\frac{1}{2}$.¹⁴ Our analysis allows one to pinpoint just where the favorable regions are for solving the R_b problem.

We thus see that it is possible to understand m any of the conclusions in the literature $[27]{[31]}$ on supersymmetry and R_b using some rather simple analytic formulas. These include the preference for small values of tan as well as light higgsinos and squarks.

6. Future Tests

If we exclude the possibility that the experimental value of R_b is simply a 3.7 statistical uctuation, we can expect that, once the LEP collaborations have completed their analyses of all the data collected during the ve years of running at the Z pole, the R_b crisis' will become an even more serious problem for the standard model. (O f course, it is wise to keep in m ind that there m ay be a simple explanation, namely that some system atic uncertainties in the analysis of the experimental data are still not well understood or have been underestimated.) In sections 3-5 we have discussed a variety of models of new physics which could account for the experimental measurement of R_b . The next obvious step is to consider which otherm easurements may be used to reveal the presence of this new physics.

The most direct method of nding the new physics is clearly the discovery of new particles with the correct couplings to the Z and the b quark. How ever, failing that, there are some indirect tests. For example, many of the new physics mechanisms which have been analysed in this paper will ect the rate for some rare B decays in a predictable way. The rates for the rare decays B ! X_s ⁺ and B ! X_s are essentially controlled by the Z bs e ective vertex _{bs}, since additional contributions (such as box diagram s and Z { interference) are largely subleading.¹⁵ In the SM, in the approximation made throughout this paper of neglecting the b-quark mass and momentum, a simple relation holds between the dom inant m_t vertex e ects in R_b and in the elective Z bs vertex _{bs}:

¹⁵ D ue to the absence of Z { interference and of large renorm alization-group-induced Q C D corrections, the process B ! X s represents theoretically the cleanest proof of the e ective \overline{z} bs vertex [32].

where i^{SM} is de ned as in eq. (26) with the SM form factor as given in eqs. (27) and (38). The meaning of eq. (113) is that, within the SM, the Z bs elective vertex measurable in Z – mediated B decays represents a direct measurement of the m_t-dependent vertex corrections contributing to R_b, modulo a ratio of the relevant CKM matrix elements. In particular, both corrections vanish in the m_t ! 0 limit. The question is now : how is this relation a ected by the new physics invoked in Secs. 3–5 to explain R_b?

Consider rst the tree-level b^0 m ixing e ects analysed in Sec.3. It is straightforward to relate the corrections of the LH and RH Z bb couplings to new tree-level m ixing-induced FCNC couplings $g_{L,R}^{bs}$. In this case eq. (5) reads

$$g_{L_{rR}}^{bs} = \bigvee_{W}^{X} (g_{W})_{L_{rR}} U_{L_{rR}}^{b} U_{L_{rR}}^{s} M^{W1}$$

Hence $g_{L,R}^{bs}$ involve the same gauge couplings and mixing matrices that determ ine the deviation from the SM of the avour-diagonal b couplings.

It is also true that, for m any m odels of new physics, the loop corrections to the 2 bovertex would change the elective 2 bs vertex in much the same way, therefore inducing computable modi cations to the SM electroweak penguin diagrams. In these models, for each loop diagram involving the new states f; f⁰ and their coupling to the b-quark g_{ff^0b} , there will be a similar diagram contributing to $_{bs}$ that can be obtained by the simple replacement g_{ff^0b} . For example, the general analysis of t-quark mixing elects presented in Sec. 4 can be straightforwardly applied to Z -m ediated B decays. Deviations from the SM predictions for the B ! X s 't' and B ! X decay rates can be easily evaluated by means of a few simple replacements like $j'_{tb}f'$! $V_{tb}V_{ts}$ and $j'_{t^0b}f'$! $V_{t^0b}V_{t^0s}$ in all our equations.¹⁶ To a large extent, this is also true for SUSY models. Indeed, the analysis of the SU SY contributions to the Z bs form factor [34] can teach much about SU SY elects in R b. And once a particular region of parameter space suitable to explain the R b problem is chosen, a de nite numerical prediction for the B ! X s 't' and B decay states can be easily evaluated by means of a few simple replacements like $j'_{tb}f'$! $V_{tb}V_{ts}$ and $j'_{t^0b}f'$! $V_{t^0b}V_{t^0s}$ in all our equations.¹⁶ To a large extent, this is also true for SU SY models. This brief discussion shows that, for a large class of new-physics models, the new contributions to R_b and to the elective k_{bs} vertex are computable in terms of the same set of new-physics parameters. Therefore, for all these models, the assumption that some new physics is responsible for the deviations of R_b from the SM prediction will imply a quantitative prediction of the corresponding deviations for Z-m ediated B decays.

However, this statement cannot be applied to all new physics possibilities. For example, if a new Z⁰ boson is responsible for the measured value of R_b, then no signal can be expected in B decays, since in this case the new physics respects the G M mechanism. This would also be true ifm_b-dependent e ects are responsible for the observed deviations in R_b as could happen, for example, in the very large tan region of multi-H iggs-doublet or SUSY models. More generally, the loop contributions of the new states f; f⁰ can be di erent, since g_{ff^0s} is not necessarily related to g_{ff^0b} , and in particular, whenever the new physics involved in R_b couples principally to the third generation, it is quite possible that no sizeable e ect will show up in B decays. Still, the study of B ! X_s 't ' and B ! X_s could help to distinguish between models that do or do not signi cantly a ect these decays.

Unfortunately, at present only upper lim its have been set on the branching ratios for $B \ X_s$ ⁺ ($\beta 5$]{ $\beta 7$] and $B \ X_s$ ($\beta 2$]. Since these lim its are a few times larger than the SM predicitons, they cannot help to pin down the correct solution to the R_b problem. However, future measurements of these rare decays at B factories could well con m that new physics is a ecting the rate of b-quark production in Z decays, as well as give some hints as to its identity. If no signi cant deviations from the SM expectations are detected, this would also help to restrict the remaining possibilities.

7.Conclusions

Until recently, the SM has enjoyed enormous success in explaining all electroweak phenomena. However, a number of chinks have started to appear in its arm our. There are currently several disagreements between theory and experiment at the 2 levelor greater. They are: $R_b = _{had} (3:7)$, $R_c = _{had} (2:5)$, the inconsistency between A_e^0 as measured at LEP with that determined at SLC (2:4), and A_{FB}^0 () (2:0). Taken together, the data now exclude the SM at the 98.8% condence level.

Of the above discrepancies, it is essentially only R_b which causes problem s. If R_b by itself is assumed to be accounted for by new physics, then the t to the data despite the other discrepancies is reasonable ($\frac{2}{m \text{ in}} = \text{d.o.f.} = 15.5 = 11$) { the other measurements could thus be regarded simply as statistical uctuations.

In this paper we have perform ed a system atic survey of new-physics models in order to determ ine which features give corrections to R_b of the right sign and magnitude. The models considered can be separated into two broad classes: those in which new Z bb couplings appear at tree level, by Z or b-quark mixing with new particles, and those which give loop corrections to the Z bb vertex. The latter type includes t-quark mixing and models with new scalars and ferm ions. We did not consider technicobur models or new gauge bosons appearing in bops since these cases are much more model-dependent.

The new physics can modify either the left-handed or right-handed Z bb couplings, g_L^b or g_R^b . To increase R_b to its experimental value, $\frac{d}{d}^b$ must be negative and have a magnitude typical of a loop correction with large Y ukawa couplings. Thus $\frac{d}{d}^b$ could either be a small tree-level e ect, or a large one-loop e ect. On the other hand, the SM value of g_R^b is opposite in sign to its LH counterpart and is about ve times smaller. Therefore one would need a large tree-level modi cation to g_R^b to explain for R_b .

Here are our results:

(1) Tree-level E ects: It is straightforward to explain R_b if the Z or b m ix with new particles. W ith Z {Z⁰ m ixing there are constraints from neutral-current m easurements, but these do not exclude all models. U sing b{b⁰ m ixing is easier since the experimental value of R_b can be accommodated by b_L { b_L^0 or b_R { b_R^0 m ixing. If the m ixing is in the LH b sector, then solutions are possible so long as $I_{3L}^0 < 1=2$. An additional possibility with $f_{3L}^0 > 0$ and very large LH m ixing, though perhaps unappealing, is still viable. For RH b m ixing, if $I_{3R}^0 > 0$ then small m ixing is permitted, while if $I_{3R}^0 < 0$, large m ixing is necessary. Interestingly, the required large b-m ixing angles are still not ruled out phenom enologically. A number of papers in the literature have appealed to b-b⁰ m ixing to explain R_b . Our \m aster form ula" (8) and Table 2 include all of these m odels, as well as m any others.

(2) Loops: t{tM ixing: In the presence of t{t⁰ m ixing, the SM radiative correction can be reduced, depending on the weak isospin quantum numbers of the t⁰ as well as on the LH and RH m ixing angles. However, we found that it is not possible to completely explain R_b via this m ethod. The best we can do is to decrease the discrepancy between theory and experiment to about 2 . Such a scenario predicts the existence of a light (100 G eV) charge 2=3 quark, decaying primarily to W b.

(3) Loops: D iagonalC ouplings to the Z : W e considered m odels with exotic ferm ions and scalars coupling to both the Z and b-quark. W e assumed that the couplings to the Z are diagonal, i.e. there are no avour-changing neutral currents (FCNC's). The correction d_{L}^{b} can then be written in a simple form, eq. (82). The key point is that d_{L}^{b} is proportional to $I_{3L}^{f} = I_{3R}^{f}$, where $I_{3L,R}^{f}$ is the third component of weak isospin of the ferm ion eld $f_{L,R}$ in the loop. This explains at a glance why m any m odels, such as multi-H iggs-doublet m odels and Zee-type m odels, have di culty explaining R b. Since the dom inant contributions in these m odels typically have top-type quarks $(I_{3L}^{0} = \frac{1}{2}, I_{3R}^{0} = 0)$ circulating in the loop, they give corrections of the w rong sign to R b. However, these considerations did perm it us to construct viable m odels of this type which do explain R b. Two such examples are

given Sec. 5.4, and m any others can be invented.

(4) Loops: Nondiagonal Couplings to the Z: We also examined models with exotic ferm ions and scalars which were allowed to have nondiagonal couplings to the Z. Such FCNC's can occur when particles of di erent weak isospin mix. The correction $q_{\rm c}^{\rm b}$ is much more complicated (eq. (86)) than in the previous case; even its sign is not obvious. However there are several interesting limiting cases where it again becomes transparent. The contributions to R_b of supersymmetry fall into this category, which we discussed in some detail.
