N atural U ni cation with a Supersym m etric SO $(10)_{\text{GUT}}$ SO $(6)_{\text{H}}$ G auge Theory

Abstract

We propose a uni ed model of elementary particles based on a supersymmetric SO $(10)_{\rm GUT}$ SO $(6)_{\rm H}$ gauge theory. This model completely achieves natural unication of the strong and electroweak interactions without any netunings.

It has been long noticed that the quarks and leptons t into complete multiplets of a simple gauge group such as SU $(5)_{GUT}$ [1] and SO $(10)_{GUT}$ [2] which unites the standard gauge group. This grand uniteation (GUT) approach seems to yield an attractive candidate of a united model beyond the standard one. In fact, recent high-precision measurements of the three gauge coupling constants at low energies strongly support reality of the supersymmetric (SUSY) uniteation of this kind [3]. However, as for the Higgs doublet, which also takes a crucial part in the standard model, the uniteation does not work naturally. The doublet tends to be accompanied by its triplet partner due to simplicity of the gauge group, which poses a ne-tuning problem of the doublet-triplet splitting [4].

In this letter, we propose a supersymmetric unied model based on a semisimple gauge group SO $(10)_{\rm GUT}$ SO $(6)_{\rm H}$, and show that it completely achieves natural unication of elementary particles without any ne-tunings [5], keeping all the excellent successes of minimal SO (10) SUSY-GUT's. In particular, the doublet-triplet splitting in the Higgs sector is realized naturally in this model. At rst glance, non-simplicity of the gauge group appears to spoil unication of the standard three gauge coupling constants, which would be achieved by means of a simple gauge group. However, that is not the case. It suces that the SO $(6)_{\rm H}$ gauge interaction is strong enough at the GUT scale [8,9], which needs no ne-tuning (in a gauge theory with asymptotic freedom).

Let us rst consider a SUSY SO $(10)_{\rm GUT}$ SO $(N_{\rm C})_{\rm H}$ gauge theory with eleven avors of hyperquarks Q A = 1; ;11; = 1; C) whigh transform as the vector N C representation under the hypercolor SO $(N_{\rm C})_{\rm H}$. The rst ten hyperquarks Q I (I = 1; ;10) form the 10 representation and the last one Q 11 is a singlet of the SO $(10)_{\rm GUT}$. The reason why we take the SO $(N_{\rm C})_{\rm H}$ (rather than the SU $(N_{\rm C})_{\rm H}$) is that the anomaly-free condition is automatically satistic ed for the orthogonal groups (except SO (6) ' SU (4)) [10]. We also introduce two kinds of SO $(N_{\rm C})_{\rm H}$ -singlet chiral super elds | a 10 H iggs H I and a 54 H iggs $N_{\rm LU}$ (I; J = 1; ;10) of the SQ $(N_{\rm C})_{\rm H}$

All the quark and lepton superelds constitute spinor 16 representations of the SO $(10)_{GUT}$ and singlets of the SO $(N_C)_H$. We choose N_C 6 to guarantee the asymptonic spinor 16 representations of the SO $(N_C)_H$ and Singlets of the SO $(N_C)_H$ and Singl

totic freedom of the hypercolor gauge interaction. In the following, we restrict ourselves to the m in im um case N $_{\rm C}$ = 6.

Im posing a global $U(1)_A$ sym m etry

we forbid such (m ass) term s as H $_{\rm I}$ H $_{\rm I}$ and Q 11 Q 11 in the superpotential. Notice that this globalU (1) $_{\rm A}$ has an anomaly | it is broken by quantum e ects. However, the broken U (1) $_{\rm A}$ still plays a crucial role to guarantee the m asslessness of H iggs doublets [9].

The tree-level superpotential is, then, given by

C lassically there is an SO $(10)_{\rm G\,U\,T}$ -unbroken vacuum, whereas it does not exist quantum mechanically. If $hS_{\rm IJ}i=0$, the low-energy physics below the scale $m_{\rm Q}$ 6 0 would be exclively described by an SO $(6)_{\rm H}$ gauge theory with one massless hyperquark ${\rm Q}^{11}$. For this case $(N_{\rm f} N_{\rm C})$, however, there is no stable SUSY vacuum [11]. Here, $N_{\rm f}$ denotes the number of avors of massless hyperquarks.

We now show that there is indeed a desired SUSY vacuum in the present model. We consider vacua specied by

in which the SO $(10)_{GUT}$ is broken down to the Pati-Salam gauge group SO (6) SU $(2)_{L}$ SU $(2)_{R}$ [12]. The vacuum -expectation value v is dynam ically chosen as $_{Q}v=m_{_{Q}}$ or $_{3}^{2}m_{_{Q}}$ so that there are seven or v=10 we massless hyperquarks, respectively [13]. We adopt the form er vacuum, since the latter has a phenomenological problem [14].

In the vacua $v = m_Q = Q$, the rst four hyperquarks Q^i (i = 1; ;4) are massive and the rest Q^a (a = 5; ;11) are massless. Therefore, we may treat this theory as an S_iQ (6) gauge theory with seven hyperquarks at low energies. Fortunately, the quantum moduli space is the same as the classical one for N_f N_C 1 in the SO (N_C)_H gauge theory [11]. This allows us to analyze the vacua with the aid of the classical theory in Eq.(2), since the numbers of avors and colors for the massless hyperquarks Q^a amount to $N_f = 7$ and $N_C = 6$, respectively.

It is now a straightforward task to seek all of the vacua with Eq.(3). The F-term atness conditions for the vacua are given by

From these equations together with the D term atness conditions, we not the following vacuum:

with Eq.(3). We take the Yukawa couplings $_{\mathbb{Q}}$ $_{\mathbb{S}}$ O (1) and v $_{\mathbb{Y}}$, assuming $m_{\mathbb{S}}$ $m_{\mathbb{Q}}$. The GUT scale v $v_{\mathbb{Q}}$ is suggested to be 10^{16} GeV from the renormalization group analysis on the gauge coupling constants of the low-energy gauge groups [3].

In this vacuum, the Q^{I} condensation in Eq.(5) breaks the hypercolor SO (6)_H gauge sym m etry (i.e. a H iggs phase is realized) and the total gauge group is broken down to the SO (6)_C SU (2)_L SU (2)_L . Here, the unbroken SO (6)_C is the diagonal subgroup of the hypercolor SO (6)_H and the SO (6) subgroup of SO (10)_{GUI}. The quark-lepton super elds

transform as (4, 2, 1) and (4, 1, 2) under this unbroken SO $(6)_{\mathbb{C}}$ SU $(2)_{\mathbb{C}}$ SU $(2)_{\mathbb{C}}$, as they do in the original Pati-Salam model. The gauge coupling constant of the SO $(6)_{\mathbb{C}}$ is given by

In general $_6$ $_{\text{GUT}}$ and hence we do not have the GUT uni cation of the gauge coupling constants of the low-energy gauge groups. However, as stressed before, the GUT unication is achieved naturally in a strong coupling limit of the hypercolor SO (6)_H, i.e. $_{\text{H}}$ 1 [15].

Since the masses m $_{\mathbb{Q}}$ and m $_{\mathbb{S}}$ in the superpotential in Eq.(2) are assumed to be of order the GUT scale, the vacuum expectation value $v_{\mathbb{Q}}$ of \mathbb{Q}^a (a = 5; ;10) also takes a value of the GUT scale. In view of Eq.(2), the colored Higgs H $_a$ (a = 5; ;10) obtain the GUT scale masses together with \mathbb{Q}^{11} but the Higgs H $_i$ (i = 1; ;4) remain massless as long as \mathbb{Q}^{11} i = 0. These massless Higgs multiplets transform as (2,2) under the SU (2) $_L$ SU (2) $_L$. They are identified with two Higgs doublets in the SUSY standard model when the SO (6) $_C$ SU (2) $_L$ SU (2) $_L$ is broken down to the SU (3) $_C$ SU (2) $_L$ U (1) $_L$. The masslessness of H $_i$ is guaranteed by the U (1) $_A$ symmetry in Eq.(1) [9]. On the other hand, the mass term for the colored Higgs H $_a$ and \mathbb{Q}^{11} is allowed since they have the opposite U (1) $_A$ charges each other. Notice that the presence of the vacuum with unbroken U (1) $_A$ in Eqs.(3) and (5) is a dynamical consequence of the present model.

We are now at a point to discuss further breaking of the remaining SO (6)_C SU (2)_L SU (2)_R down to the SU (3)_C SU (2)_L U (1)_L. To this end, we introduce additional Higgs super elds A $_{IJ}$ (45), (16), (16) and a singlet of the SO (10) $_{GUT}$ [16]. Their superpotential is given by

Then, the total superpotential is given by the sum of Eq.(2) and Eq.(7).

In order to show the presence of a desired vacuum , we consider the following forms of $h\!A_{\text{IJ}}i$ and h i:

Here, we have used $v = m_Q = Q$ in Eq.(3). From these equations we and a vacuum

where the total gauge group SO $(10)_{GUT}$ SO $(6)_{H}$ is now broken down to just the standard gauge group SU $(3)_{C}$ SU $(2)_{L}$ U $(1)_{H}$ at the GUT scale.

It is important that the hQ 11 i still vanishes as it does in Eq.(5). Thus, the masslessness of the Higgs doublets H $_{i}$ is maintained in this nalvacuum.

Now, we proceed to the ordinary matter sector. We assign one unit of the U $(1)_A$ charge to the quark-lepton super elds so that the Higgs doublets H_i couple to them and produce their masses after spontaneous breaking of the SU $(2)_L$ U $(1)_R$ symmetry. Then, there are two issues about quark and lepton masses as in the minimal SO $(10)_{GUT}$ models: vanishing mixing angles in the quark sector and mass degeneracy of the neutrinos and up-type quarks.

These issues are resolved by taking into account nonrenormalizable interactions. Let us de ne the U $(1)_A$ transformation of and as

Then, the superpotential of the model may contain nonrenormalizable interactions

where M $_{\rm P}$ denotes the P lanck scale as a cuto and (16) (= 1;2;3) are the three fam ilies of quark-lepton multiplets. The vacuum-expectation value of of the GUT scale gives the right-handed neutrinos M a jorana m asses of the order of f $v^2=M_{\rm P}$ f $10^{1/3}$ GeV, resulting in small m asses for the left-handed neutrinos [18]. Small m asses of the quarks and leptons which generate sizable m ixings m ay be also induced by nonrenorm alizable interactions [19].

It m ight appear that the non-vanishing U (1)_A charges of 's would spoil the m asslessness of the H iggs doublets H $_{\rm i}$ since their vacuum -expectation values break the U (1)_A sym m etry. Fortunately enough, there rem ains an unbroken U (1) sym m etry, U (1)_A $_{\rm o}$, which is a linear combination of the original U (1)_A and a U (1) subgroup of the SO (10)_{GUT}. The global U (1)_A and U (1)_A $_{\rm o}$ sym m etries are physically equivalent since the SO (10)_{GUT} is a gauge sym m etry. Therefore, the H iggs H $_{\rm i}$ are kept m assless by the unbroken U (1)_A $_{\rm o}$ sym m etry.

We conclude that the low-energy spectrum in the present vacuum is nothing other than that in the SUSY standard model with the right-handed neutrinos.

Now, several com m ents are in order.

First, the dangerous dimension-ve operators [20] which induce the proton decay are forbidden in our model by the U $(1)_{A^{\,0}}$ sym metry.

Second, the SO $(10)_{GUT}$ is not asymptotically free above the threshold of the GUT super elds such as S_{IJ} , A_{IJ} and 's. However, the gauge coupling constant $_{GUT}$ may not blow up until the P lanck scale even if all the GUT super elds have the GUT scale masses.

Third, a SUSY-invariant mass term of the Higgs doublets may be generated when the U $(1)_{A^{\circ}}$ symmetry is broken spontaneously at an intermediate scale [21].

Finally, we mention a possibility that the SO $(10)_{GUT}$ is broken down to the SU $(5)_{GUT}$ at the Planck scale. Then our model can be regarded as the SU $(5)_{GUT}$ SO $(6)_h$ theory up to the Planck scale. That is, we may construct another model based on the SU $(5)_{GUT}$ SO $(6)_h$ gauge group which also achieves natural unication of the strong and electroweak interactions, as does the SO $(10)_{GUT}$ SO $(6)_h$ model.
