Leptophobic U (1)'s and the $R_b \{R_c C risis^1$

Abstract

In this paper, we investigate the possibility of explaining both the R_b excess and the R_c decit reported by the LEP experiments through Z-Z⁰ mixing elects. We have constructed a set of models consistent with a restrictive set of principles: unication of the Standard M odel (SM) gauge couplings, vector-like additional matter, and couplings which are both generation-independent and leptophobic. These models are anom aly-free, perturbative up to the GUT scale, and contain realistic mass spectra. Out of this class of models, we not three explicit realizations which the LEP data to a far better extent than the unmodil ed SM or MSSM and satisfy all other phenom enological constraints which we have investigated. One realization, the -m odel coming from E_6 , is particularly attractive, arising naturally from geometrical compactic cations of heterotic string theory. This conclusion depends crucially on the inclusion of a U (1) kineticm ixing term, whose value is correctly predicted by renorm alization group running in the E_6 m odel given one discrete choice of spectra.

1 Introduction & Principles

During the past six years the four experiments at LEP have provided an abundance of data supporting the Standard M odel (SM) of particle physics and its SU (3)_c SU (2)_L U (1)_r gauge group structure. Until recently there has been no signi cant deviation pointing to new sources of physics beyond the SM. However, within the last two years there has been growing evidence that a discrepancy exists between the predicted and measured widths for the b and c-quark decays of the Z boson. In particular, LEP has reported measurements of [1]:

These values di er from the SM predictions, $R_b = 0.2152$ 0.0005 and $R_c = 0.1714$ 0.0001 [2] (for $m_t = (176 \quad 13) \text{ GeV}$ [3] and $s = 0.125 \quad 0.010$), by 3.9 and 2.3 respectively.

If one is willing to accept the R_c discrepancy as statistical, then there are many new sources of physics which can serve to resolve the R_b m easurem ent by only changing the couplings of the third-generation ferm ions. Such a method is naturally provided by low energy supersymmetry (SUSY) with light charginos and stops [4], or by additional ferm ions mixing with, or additional interactions of, the b and t quarks [5]. However, if one interprets the R_c de cit as another signal of new physics, then the scenarios for new physics are more limited [6].

A potential hurdle which one must face with respect to simultaneously explaining the R_b excess and the R_c de cit is that the LEP measurement for the total hadronic width of the Z is in good agreement with the SM prediction ($_{had} = (1744.8 \ 3.0) \text{ MeV}$ at LEP versus $_{had} = (1743.5 \ 3.1) \text{ MeV}$ in the SM), while the sum $R_b + R_c$ is in slight disagreement with the SM prediction. That is, $R_b + R_c = 0.3762 \ 0.0070$ as measured at LEP (with the error correlations properly included), versus a theoretical expectation of 0.3866 0.0005, 1.5 apart.

A clue to solving this conundrum may lie in a simple observation. Dening $_{\rm i}$ as the dierence between the experimental and the theoretical determinations of $_{\rm i}$, one notes that

so that at the 1 level, a consistent interpretation of the data is given by assuming a avor-dependent but generation-independent shift in the hadronic Z -couplings. That is,

Such a pattern of shifts has also been suggested in [7, 8, 9].

A second hurdle in explaining the R_b and R_c puzzles is that unlike the partial hadronic widths of the Z, the well-measured partial leptonic widths are in good agreement with the SM predictions: $_e = 83:93$ 0.14 MeV and $_{inv} = 499:9$ 2.5 MeV, which are within 0.4 and 0.4 respectively of theory. Any source of new physics must preserve the successful predictions of the SM for the leptonic widths.

In this paper we propose to explain the $R_b = R_c$ problem by introducing an additional U (1)⁰ gauge sym m etry. If this new U (1)⁰ is broken near the electroweak scale, there can be signi cant m ixing between the usual Z and the new Z⁰. The physical Z-boson as produced at LEP will then have its couplings to ferm ions altered by an am ount proportional to the Z = Z⁰ m ixing angle times the Z⁰ coupling to those same ferm ions.

A nalyses have recently appeared in the literature [8, 9] that seek to t the LEP data by introducing such an additional $(1)^0$. B oth of these works make a phenom enological t to the data introducing som e num ber of new param eters, such as arbitrary U $(1)^0$ charge ratios, Z Z^0 m ixing angle, and Z⁰ m ass. These analyses do indicate that this class of scenarios has the potential to solve the R_b R_c discrepancy, and are therefore interesting. However, they share som e fundam ental problem s associated with the lack of an underlying, consistent fram ework. For example, the extra U $(1)^0$ is not anom aly free (this is true both for the [U $(1)^0$]³, and m ost seriously, the m ixed SM -U $(1)^0$ anom alies). Further, since the authors of [8, 9] also seek to explain the CDF dijet excess, they are forced to take a high value of the Z⁰ m ass. For such Z⁰ m asses, the U $(1)^0$ -couplings have to be so large that the U $(1)^0$ gauge coupling becomes non-perturbative at m ost a decade above the Z⁰ m ass.

Here we will take a di erent approach. We set forth a few basic principles which we believe any attractive Z⁰-m odel should obey. W ithin this fram ework we will nd that there exist only limited classes of U $(1)^0$ m odels which are phenom enologically viable and theoretically consistent. Each class has a well-de ned prediction for the U $(1)^0$ charges of the SM ferm ions, reducing m uch of the arbitrariness in the couplings. We will not attempt to explain the CDF diget anom aly.

The principles that we dem and are:

The low energy spectrum must be consistent with the uni cation of the standard model gauge couplings that occurs in the minimal supersymmetric standard model (M SSM). This will lead us to consider models which are extensions of the M SSM, with any non-M SSM matter added in particular combinations which can be thought of as lling complete multiplets of SU (5). We allow the possibility of uni cation within a string framework, and do not require the presence of a eld theoretic GUT.

All non-M SSM m atter m ust fall into vector-like representations under the SM gauge groups. Such a requirem ent is consistent with the absence of experim ental evidence for new ferm ions with m asses below the top quark m ass. Further,

note that additional chiral matter is disfavored by the electroweak precision measurements, since, in contrast to vector-like matter it can give very large contributions to the S, T, and U parameters.

The U (1°) charges of the SM leptons must be (to a good approximation) zero. This requirem ent of leptophobia ism otivated by the phenom enology. This alone will eliminate the U (1) factors associated with most traditional GUT groups, since GUT's tend to place leptons and quarks into common multiplets.

Consistent with Eq. (3), we require that the U (1⁰) couplings be generationindependent. This requirement is essential if tree{ level hadronic avor changing neutral current processes mediated by the U (1)⁰ gauge boson are to be naturally suppressed. This also has the advantage of simplicity and economy.

To be precise, the principle of uni cation that we will impose requires that the meeting of the SM couplings at 2 10^{6} GeV is not a coincidence. For simplicity we will not explicitly consider in this article the various string models where the scale of uni cation is increased to the (weak-coupling prediction of the) string uni cation scale M $_{\rm str}^{1 \ \rm loop}$ 5 10^{7} GeV, such as those discussed in [10], although it will be clear that the consequences for our discussion of such a modi cation are slight. (Note that one interesting possibility that could maintain uni cation at 2 10^{16} GeV is the strongly coupled string scenario recently proposed by W itten [11].)

If one takes the uni cation of gauge couplings to imply the existence of a simple GUT gauge group, then the natural candidates with extra U (1)'s and three chiral fam ilies are SO (10) and E₆. However the single additionalU (1) within SO (10) is not leptophobic. In E₆ all linear combinations of the two additionalU (1)'s orthogonal to hypercharge couple to leptons. Nonetheless, we will show that by including an e ect usually overlooked in the literature (U (1)-m ixing in the kinetic term s through renorm alization group ow [12,13]) there exists a unique U (1)⁰ in the E₆ group which is compatible with the data. The E₆ subgroup in question is usually known in the literature as the -m odel and interestingly is the unique m odel which results from E₆ W ilson { line breaking directly to a rank-5 subgroup in a string context [14]. W e will discuss this case in som e detail in Section 4.

F inally, although we assume the MSSM for the purposes of gauge coupling uni – cation, we do not use MSSM loop contributions to the \overline{Z} be vertex in order to explain any part of the R_b anom aly. In particular we do not assume light charginos or top squarks which are the necessary ingredients for such a scenario [4].

$2 Z Z^{0} M$ ix ing

We begin with a brief general discussion of $Z = Z^0$ mixing in the context of an SU (2)_L U (1)_r U (1)⁰ m odel. A more detailed discussion can be found, for example,

in Refs. [15, 16]. The neutral current Lagrangian of the Z and Z^{0} is given by

are the SM vector and axial couplings of the Z, and v^0 , a^0 are the (unknown) vector and axial couplings of the Z⁰. Here g^0 is the coupling constant of the new U (1)⁰ and $s_W^2 = \sin^2 w$.

A fler electroweak and U $(1)^0$ breaking, the Z and Z⁰ gauge bosons m is to form the mass eigenstates $Z_{1,2}$, where we will identify the Z_1 with the gauge boson produced at LEP:

Since such m ixing must necessarily be small in order to explain the general agreem ent between LEP results and the SM, we will throughout this paper use the approximation $Z_1 \cdot Z + Z^0$. We will also assume that the mass of the Z_2 is large enough so that its e ects at LEP, either via direct production or loop e ects can be ignored. Therefore all new physics e ects must appear through the mixing angle . The relevant Lagrangian probed at LEP will then be

Because the \mathbf{Z}_1 is no longer purely the electroweak \mathbf{Z} , the - parameter

where $_{SM}$ is due to loop corrections already present in the SM (such as the top), then the mixing with the Z⁰ contributes to $\overline{}$. Since we will later be interested in taking into account the e ects of further shifts in due to the rest of the M SSM spectrum, we decompose $\overline{}_{=}$ $_{M}$ + $_{extra}$, where $_{M}$ is the part due to mixing with the Z⁰. The value of $\overline{}_{is}$ the quantity that our ts to the LEP data will directly constrain. W riting the Z 0 m ass matrix as

where Q_i^0 is the U (1)⁰ charge of $_i$ and v_Z^2 is the sum of the vev's of the SU (2)_L doublets. Then we may write $_M$ as a simple function of :

W hat is noteworthy about this relationship is that it is connects the two quantities ($_{\rm M}$ and) which are experimentally constrained at LEP (up to $_{\rm extra}$, which we can bound), in a way that is independent of the unknown gauge coupling g⁰ and the Z⁰m ass. Note that m² and in Eq. (18) have opposite signs, so that $_{\rm M}$ is always positive.

2.1 U $(1)_a$ U $(1)_b$ M ixing and RGE's

The discussion so far has echoed the conventional wisdom on the subject of $Z = Z^0$ mixing. However, it was realized many years ago [12] that in a theory with two U (1) factors, there can appear in the Lagrangian a term consistent with all gauge symmetries which mixes the two U (1)'s. In the basis in which the interaction terms have the canonical form, the pure gauge part of the Lagrangian for an arbitrary U (1)_a = U (1)_b theory can be written

If both U (1)'s arise from the breaking of som e sim ple group G ! U (1)_a U (1)_b, then sin = 0 at tree level. However, if the matter of the e ective low energy supersym – metric theory is such that

then non-zero will be generated at one-loop. This is naturally the case when split multiplets of the original non-Abelian gauge symmetry, such as the Higgs doublets in a grand uni ed theory, are present in the elective theory. Since we are interested in a large separation of scales, M_{GUT} and M_Z , we will need to resum the large logarithm s that appear [13, 17] using the renorm alization group equations (RGE's) for the evolution of the gauge couplings including the o-diagonal term s.

Once a non-zero (or m²) has been induced, one needs to transform to the mass eigenstate basis. To do so, one must perform a (non-unitary) transformation on the original gauge elds, A $_{(a)}$ and A $_{(b)}$, to arrive at the mass eigenstates, Z $_{1,2}$:

This transformation results in a shift in the elective charge to which one of the original U(1)'s couples. (One U(1) can always be chosen to have unshifted charges.)

This can be seen by taking the $= 0 \lim it of the above transform at ion. The resulting interaction Lagragian is then of the form [12]:$

where the rede ned gauge couplings are related to the original couplings, g^0 , by $g_a = g_a^0$, $g_b = g_b^0 = \cos$ and $g_{ab} = q_a^0$ tan. The ratio $g_b = g_b$ is a phenom enologically useful parameter, representing the shift in the Z_2 (ferm ion coupling due to kinetic mixing.

The renorm alization group equations for the coupling {constant ow of a U $(1)_a$ U $(1)_b$ theory, including the o {diagonalm ixing, are most usefully form ulated in the basis of Eq. (23). In this basis the equations for the couplings $g_a;g_b$ and g_{ab} are:

where $B_{ij} = tr(Q_iQ_j)$ with the trace taken over all the chiral super elds in the elds elds in the elds theory, and there is no sum over (a;b) in Eq. (24). From these equations we immediately see that even if $g_{ab} = 0$ to begin with, a non-zero value of the o - diagonal coupling is generated if the inner{product $tr(Q_iQ_j)$ between the two charges is non{zero. The advantage of this basis for the RGE's is that the low energy value of the parameter is given directly by the ratio $q_{ab} = q_b$ evaluated at the low scale. (This is not the case for the more symmetrical form of the RGE's given in Ref. [13].)

For the case at hand, we will choose the couplings of the usual Z to be canonical, shifting the charge of the Z⁰. Since it is the B component of Z which mixes through the kinetic terms, the couplings of the Z⁰ to matter elds can be expressed in terms of an elds expressed in terms $Q_e = Q^0 + Y$, where Y is hypercharge. We can translate from Eq. (23) using $g_a = g_2 = G_W$ and $g_b = g^0$ so that $g_{ab} = g_1 \tan_W$ tan and $g_{ab} = g_{ab} = g_b$. The vector and axial couplings that come into Eq. (8) are given by

Note that both and ^c are left-handed chiral elds: Q_e (^c) = Q_e (_R).

In most of the models we will consider, we will work directly with Q_e ; in such models, whether or not Q_e can be expressed as some $Q^0 + Y$ for non{zero will not have an e ect on the analysis. However, when considering the {model coming from E_6 , the di erence between Q_e and Q will have in portant consequences on the observable physics. We reserve further comment on the U (1) mixing in the E_6 model until Section 4.

K ineticm ixing of U (1)'s will also shift the -parameter. In the previous subsection we had assumed that we could write the electroweak Z in term softherm asseigenstates as $Z = \cos Z_1 \quad \sin Z_2$. The coe cient of the Z $_1$ term in Eq. (26) is essentially a wave-function renorm alization for the Z $_1$ and contributes to $_M$ by absorbing part of the explicit m ass shift which came from m ass m atrix m ixing [16]. The net e ect is a negative contribution to $_M$ which subtracts from the positive de nite contribution com ing from m ass m ixing. In terms of ,

where $k = g^0 c_W s_W = g_2$. The important point to note is that, in the presence of kinetic mixing, M can be smaller than had there been no such mixing; in fact, M can be negative.

The kinetic mixing also shifts s_W^2 beyond what was already included in Eq. (15):

2.2 New Contributions to Oblique Param eters

A snoted in the previous Sections, in the absence of U (1) kinetic mixing (i.e., = 0), Z { Z^{0} mixing gives a positive contribution to the {parameter, denoted by M, and no contribution to the S-parameter. Since our numerical ts are sensitive to the total

and S, it is in portant to see if there are corrections from sources other than the $Z \{Z^{0} \text{ m ixing. (Both } -\text{ and } S \text{ are de ned to be zero in the SM for some reference} \}$ top quark and Higgs boson masses which we take to be 175GeV and 125GeV respectively.) The spectrum of the e ective theory in all models that we will consider includes a Higgs sector with two doublets, vector { like states in complete \SU (5) multiplets", and the superpartners of all particles, all of which can in principle contribute to the oblique parameters. The sizes of these contributions depends on the details of the mass spectrum. As we shall see, the scale of the U $(1)^0$ breaking turns out to be relatively low in all models (typically M $_{Z^0}$ 200 $250 \,\text{GeV}$). Therefore the contributions of the additionalm atter cannot be ignored in general. Let us therefore estimate the typical allowed ranges for _{extra} and S_{extra} (S $S_{M} + S_{extra}$, given som e reasonable choices for the spectrum, in particular that depending upon M SSM superpartners, Higgs sector, and additional vector-like m atter.

The superpartner contributions to $_{extra}$ and S_{extra} in the MSSM have been studied in Refs. [18] and [19] respectively. In Ref. [19] it has been shown that such contributions to S_{extra} are generally very small; therefore we will ignore MSSM superpartner contributions to S_{extra} in everything that follows. Likewise it is shown in Ref. [18] that the corrections to e_{extra} from the MSSM sparticle spectrum are small (and positive) with the exception of the stop{sbottom correction which can be sizable depending on the nature of the supersymmetric spectrum.

A lthough the H iggs boson contribution to extra in a general two <math>doublet m odel can be large and negative (as large as 0.01), in supersymmetric m odels there are restrictions on the H iggs sector parameters, resulting in an absolute lower bound of

 $_{\rm extra}$ 0.0015 from the MSSM Higgs sector. However, in the class of models which we will consider in Section 3, this number becomes 0.002 since the Higgs sector in these models is not identical to that of the MSSM. This is because the H_uH_d term of the MSSM will be replaced by H_uH_dS, where S is a SM {singlet eld carrying U (1)⁰ charge. There is also a new contribution to the Higgs potential from the U (1)⁰ D {term . We have analyzed the Higgs spectrum of these models, which resemble the MSSM with a singlet (the NMSSM). In the limit where the singlet vev is large compared to the doublet vev's, but keeping the mass of the pseudoscalar xed, we have numerically examined the most negative extra obtainable from the Higgs sector and found it to be 0.002. Of course, this could be partially o set by some positive contribution from other sectors, such as the stop-sbottom sector. In the model analysis of Section 3.1 we will therefore consider two cases, one in which

extra = 0 and another in which we take extra to have the not unreasonable value 0.001.

As far as the contributions from additional vector-like matter are concerned, we

w illalways consider the simple isospin-symmetric case (i.e., them assess of the $T_3 = \frac{1}{2}$ states equal) where there are no vector-like contributions to $_{extra}$. In this limit, S_{extra} need not be zero. For the various models we will consider, S_{extra} receives potentially large contributions from the multiplicity of lepton/higgsino doublets which arise. There are two natural cases. One, in which the vector-like contributions to the doublet masses dom inate over the chiral contributions, gives S_{extra} ' 0. A lternatively, because the weak scale and the U (1)⁰ scale are quite close, the chiral masses can be of order the vector-like masses; we have estimated, using the results of R ef. [20], the contribution to S_{extra} in this case to be + 0:14 per pair of such doublets.

3 Leptophobic U (1) M odels

Any model which hopes to extend the SM in a minimal fashion must give masses to the SM fermions through the usual Higgs mechanism. W ithin a supersymmetric model, such couplings appear in the superpotential, W. Letting W₀ be the minimal superpotential consistent with the SM, we write¹

The new $U(1)^0$ must also preserve this superpotential. Demanding that the $U(1)^0$ couplings of the leptons be zero allow s us to write the charges of the remaining elds as:

W e next require that the resulting gauge theory have no anomalies. In the case of the SM particle content alone, this implies $C_3 = C_2 = C_1 = C_0 = 0$, where,

At this time we do not concern ourselves with the $[U (1)^{0}]^{3}$, or $U (1)^{0}$ [gravity]² anom alies since these can be saturated with any number of SM gauge singlets. The only solution which cancels all anom alies in Eqs. (34) { (37) is the trivial solution x = y = 0.

Going beyond the MSSM, we wish to add matter in such a way that the unication of gauge couplings that occurs in the MSSM is not upset. To do so we must arrange that the additional matter changes the MSSM one { bop beta { function coe cients in

 $^{^{1}}$ W ith the extended m atter content that we will introduce later in the paper, it is also possible to consider m ore complicated non-m inim al choices for these Yukawa couplings, where the H iggs that couples to e^c and d^c are distinct. We will not analyze these possibilities in detail here.

such a way that $b_2 = b_3 = \frac{3}{5} b_1$. This constraint can be most easily understood as requiring the addition of complete SU (5) multiplets to the spectrum (though U (1)⁰ need not commute with this ctitious SU (5)).

Our principles outlined in Section 1 constrain us further in how we add SU (5) multiplets to the model. Implicit in the requirement of unication is that the gauge couplings remain perturbative up to the unication scale. This implies that we can only add (a limited number of) 5's, 10's, and their conjugate representations. By requiring that all new matter be vector-like under the SM gauge groups, we restrict ourselves further to adding the multiplets in pairs. In combination, these two principles limit us to adding (A) up to four $(\overline{5} + 5)$ pairs, or (B) one $(\overline{10} + 10)$ pair, or (C) one pair each of $(\overline{5} + 5)$ and $(\overline{10} + 10)$.

Consider M odel A with a single pair of (5+5). Because we require neither that the U $(1)^0$ commutes with the ensatz SU (5), nor that the charge assignments be vectorial with respect to the U $(1)^0$, we write general U $(1)^0$ charges for the new states as:

with the additional relations $a_1 = 2\overline{a_2} + 9x$ = 3, $a_2 = \overline{a_2} - 6x$, and $\overline{a_1} = (2\overline{a_2} - 9x)$ = 3. Note that all charges are rationally related, and, further, that for a purely axial choice of U (1)⁰ charges ($a_1 = \overline{a_1}$ etc.), the only solution is the trivial one $x = y = a_1 = 0$. The result Eq. (40) does not depend on the number of ($\overline{5} + 5$) pairs. Thus for this entire class of models, we know the couplings of all the quarks to the Z⁰ through Eq. (33), up to one overall norm alization.

The same exercise can be undertaken for M odelB.Now we add the states in the $(\overline{10} + 10)$ with charge assignments

In the general case the phenom enologically in portant ratio y=x is undeterm ined by the anom aly conditions. However, if we make the very naturals in plifying assumption that the U (1)⁰ charges in Eq. (41) are purely axial ($a_3 = \overline{a}_3$, etc.), then the [U (1)⁰]² U (1)_Y anom aly equation (37) is unmodified and there are only two solutions for the charge ratio:

The associated charges of the extra states are $fa_3;a_4;a_5g = f = 3x=2;3x; = 3x=2g$ and f = 11x=10; = 7x=5;x=10g respectively. In the following we will refer to these models as B(-1) and B(7/5). In the B(-1) model the charges are identical to baryon number, with the Higgs doublet H_u carrying zero charge. At this stage it is important to recognize that both these models have the potential problem that the extra states do not include $(1;2)_{1=2}$ representations which can be used to give a naturally sm all o -diagonal mixing term m² in the $M_{Z;Z^0}^2$ mass matrix Eq. (12). In the B(-1) model, there is no tree{level Z = Z^0 mixing. Even at the one{loop level, no such mixing arises in the simplest version of this model where the $(10 + \overline{10})$ states receive masses from SM singlets only. In the B(7/5) model, on the other hand, there is no del requires additional (negative) contributions to the -parameter to relax the constraint Eq. (18).

M odel C has, in the general case, ten new U (1)⁰ charges corresponding to the ten new states in Eqs. (38) and (41), and again even with the constraints imposed by anom aly cancellation the ratio y=x is not determ ined. However there are two particularly attractive and natural subclasses of these models. In the rst subclass the U (1)⁰ charges of the extra states are chosen to be purely axial. This leads to the charge ratios y=x = 1 or 7=5 as in Eq. (42) (M odels \C (-1)" and \C (7/5)" respectively). Note that since all C -type m odels contain an extra pair of H iggs doublets, they are naturally able to accomm odate a suitably sm all Z Z^0 m ixing. The second attractive subclass of M odel C is de ned by setting the U (1)⁰ charges of the anti-generation (5 + 10) to zero (a₁ = a₂ = $\overline{a_3} = \overline{a_4} = \overline{a_5} = 0$). In this case the ratio y=x is continuously adjustable as is the charge, a₃, of the additional (3;2)₁₌₆ state. Am ong this continuous fam ily, the choice

is especially simple and attractive (M odel C(1)").

In all cases we still need to impose the [U (1)⁰]³ and U (1)⁰[gravity]² anomaly cancellation conditions. It is important to consider an elicient way of achieving this because we will soon see that there is a strong constraint arising from the requirement of perturbativity of the U (1)⁰-coupling all the way up to the GUT scale, and the U (1)⁰ beta {function gets a signi cant contribution from these SM -singlet states (collectively 's). One must also add su cient vector{ like states charged under U (1)⁰ to give all the additional matter (including states both in the $\overline{10} + 10$ and $\overline{5} + 5$'s, and the 's) masses. The derivation of the minimal set (in the sense of reducing their contribution to the beta {function) of states and charges that satis es these conditions is a di cult problem in general. As our interest is only in the value of the minimal U (1)⁰ beta {function coe cient b (including the contributions from the SM -non-singlets states) we just quote the results for b_{min} for the various models in Table 1, and where we have employed an ansatz for the spectrum of anomaly cancelling states². (O ur ansatz is to choose a set of U (1)⁰-charged states, , which cancel

the extra anom alies and simultaneously contribute m in in ally to the U $(1)^0$ -function. We then include a m in in al set U $(1)^0$ vector-like states which give mass to the 's.)

Strictly speaking our \uni cation principle" does not absolutely require the pertubativity of U $(1)^0$ up to the GUT scale { it is only the SM gauge couplings that we require to successfully unify while still perturbative. For instance, it is possible that our extra U $(1)^0$ gauge sym m etry is enhanced into a non-A belian gauge sym m etry well before the GUT scale, in which case the following is (possibly much) too severe a restriction. Nevertheless it is interesting to see the bounds on the mass of the Z⁰ that follow from such a requirement.

The restriction is derived as follows: U sing the Eqs. (9) and (13) for the tted quantities and $_{\rm M}$, we nd that for the x = 1 norm alization choice,

Putting these two equations together leads to a restriction on the Z⁰ to Z mass ratio in terms of the m easured" quantities and $_{M}$, and the coe cient b (for which we have a lower bound given the minimal spectrum of U (1)⁰ charged particles necessary for anomaly cancellation, etc.):

reduced signi cantly the -function coe cients $b_{h\ in}$. Constraints on this possibility come predom in nantly from supernova cooling and to a lesser extent big{bang nucleosynthesis (BBN). If these SM singlets are massless, they will be produced copiously inside supernovae through their Z⁰ interactions. Once produced, they will free stream out of the supernova leading to rapid cooling. Consistency with SN 1987A observation requires that the Z⁰ mass must be greater than about 1 TeV or that the singlet states must be heavier than about 30 M eV.

3.1 Experimental Constraints

Having de ned each class of models, we know that each will, by de nition, be leptophobic. However it remains to be seen if they can describe the physics as observed at LEP any better than the SM. Note that as far as the agreem ent with the LEP data is concerned, the only important feature of a model is the value of the ratio y=x. (In all models except the -model of Section 4 we will choose to normalize the U (1)⁰ gauge coupling g⁰ such that the quark doublet charge x = 1.)

To study this question, we have performed a ² t of each model to the LEP data, broadly following the procedure of Refs. [8, 15]. We take 9 independent LEP observables as inputs: $_{z}$, $R_{v} = _{had} = _{v}$, $_{had}$, R_{b} , R_{c} , $M_{W} = M_{z}$, A_{FB}^{b} , A_{FB}^{c} , and A_{FB}^{c} . Theoretically, the shift in each observable 0 can be expressed as a function of $\overline{}$, x, and y:

However, it is only in the simple case of no kinetic (m ixing that expressions for A_0 and $B_0^{(i)}$ follow directly from those given in Refs. [8, 15]. This is because they take Eq. (15) as the relation between s_W^2 and M; that is, the expressions of Refs. [8, 15] assume that = 0. For $\neq 0$, Eq. (30) holds instead. We then re-express

where $A_0^{(1)}$ includes only the explicit dependence of the observable 0 on $\overline{}$, not the implicit dependence through s_W^2 . The coe cients $A_0^{(i)}$ are easily generalized from the discussion of Ref. [15]; num erical values for the $A_0^{(i)}$ and $B_0^{(i)}$ are given in Table 2. Note that s_W^2 is not a new parameter to be t, since it is simply a function of $_M$,

and through Eqs. (29) and (30). C learly for = 0 the procedure here reduces to that of Refs. [8, 15].

Unlike Ref. [8], we have opted against using the data from SLC.As is well known, the SLC data is approximately 2 from the corresponding data at LEP. This could

be a system atic e ect at LEP, SLC (or both), or a sign of new physics. Here we will take this discrepancy not to be a sign of new physics. Therefore, as the e ects we are studying (R_b and R_c) are in the LEP data, we choose, in this paper, to exclude the SLC data from our ts.

In our ts for the m odels of this Section, we have taken $S_{extra} = 0$ and allowed for $_{extra}$ to be either zero or 0:001 consistent with our discussion in Section 2.2. The negative value of $_{extra}$ in particular leads to a relaxation of the m ass lim its on the Z⁰.




Figure 1: 99% C L. contours for the four basic classes of models labeled by their $Q = u^c$ charge ratio in the (; -) plane. The cross represents the SM.

In Table 3 we have shown the ² for each of the possible charge ratios y=x = 2; 1;7=5, and +1 in addition to the SM; the SM is defined by setting = 0 in the t. For each model, we have given the values of - and - at the minimum ², as well as the value of s in the range 0:110 s 0:125 which produces the best t to the data. For two of the models listed, the best t value of - is negative; however, the t depends only weakly on - so that positive values of - are allowed at relatively low ² as shown in Figure 1.




Figure 2: ² contours for the C (7/5) M odel in the (; $_{\rm M}$) plane. The solid ellipses represent the 95% and 99% C L. bounds on the t. The dashed ellipses represent the corresponding bounds if $_{\rm extra} = 0.001$. The three solid lines are contours of M $_{\rm Z}$ 0 arising from the theoretical constraint of perturbativity of the U (1) 0 coupling up to the GUT scale, and are labeled in G eV.




Figure 3: ² contours for the C (1) M odel in the $(\bar{}; _{M})$ plane. See caption of Figure 2 for explanation.

For the two most attractive models, C (7/5) and C (1), we have included plots in Figures 2 and 3 of iso- 2 contours in the (; M) plane. The solid ellipses represent contours of 2 = 14:1 and 18:5, values which correspond to goodness-of-ts of 95% and 99% respectively for 7 dof, assuming $_{\rm extra}$ = 0. In both cases, the contours in pinge signi cantly into the physical $_{\rm M}$ > 0 region. The dashed ellipses represent the case for which $_{\rm extra}$ = 0:001 as discussed earlier in the text; for this case the allowed values of $_{\rm M}$ are larger.

Figures 2 and 3 also show contours of constant M $_{\rm Z\,^{0}}$ calculated assuming the perturbativity constraints of Eq. (47) and using the values of $b_{\rm m~in}$ tabulated in Table 1. For the C (7/5) m odel, the 95% (99%) C L bound on M $_{\rm Z\,^{0}}$ is 180 (350) G eV for

 $_{extra} = 0$ and 250 (500) G eV for $_{extra} = 0.001$. Sim ilarly, for the C (1) m odel the 95% (99%) C L bound on M $_{Z^0}$ is 150 (300) G eV for $_{extra} = 0$ and 220 (450) G eV for $_{extra} = 0.001$. The B (7/5) m odel has m ass lim its only slightly stronger than those of the C (7/5) m odel: 170 (320) G eV for $_{extra} = 0$. For the remaining m odels in Table 1, the corresponding Z 0 m ass lim its are m uch stronger (w ith the exception of the -m odel of Section 4, which falls into the broad class of m odel A but has sm aller value for the -function coe cient b).

O ne m ight expect that Z⁰-m odels of the type considered here would be strongly constrained by either UA2 or CDF/DO. However, the strongest Z⁰ m ass bounds in the literature depend on observation of the leptonic decays of the Z⁰, which are highly suppressed in these leptophobic models. The dijet decays of the Z⁰, which dom inate its width, are hard to detect above background except for limited ranges of Z⁰ m asses and couplings. In particular, CDF can only exclude Z⁰! jj for M z⁰ roughly between 400 and 460 G eV [21], and then only for SM strength (or stronger) couplings. UA2 has a sim ilar bound of M z⁰ > 260 G eV [22], but here again one requires SM strength couplings. Note that because of the sm all couplings that result from our perturbativity constraint, we tend to nd that the production cross-section for the Z⁰ at a hadron collider is suppressed by at least 40% com pared to the SM Z cross-section. We therefore nd that UA2 does not provide a strong constraint on the Z⁰ m ass in these models.

All of the theoretical mass bounds that we have derived depend strongly on the value of the U (1)⁰ gauge coupling, and thus on the size of $b_{n in}$ and especially on the assumption of perturbativity of the U (1)⁰ gauge coupling all the way up to the GUT scale. If the U (1)⁰ interaction is enhanced to a non-Abelian group at some intermediate scale, then the Z⁰ mass bounds are much weaker; we are investigating this possibility. By either decreasing $b_{n in}$ or decreasing (the scale up to which we require perturbativity), $g^0(M_Z)$ will increase. As g^0 increases the Z⁰ m ass bound increases but the Z⁰ production cross-section at a hadron collider, relative to a Z of the same m ass, also increases. At some m ass, however, the kinematic suppression of the Z⁰ production w ins and the experim ental bound goes away. We will not consider the details of these competing e ects here.

Taking all the phenom enology together, including the possibility of naturally sm all $Z - Z^0$ mixing, we view the C (1), C (7/5), and the -m odel of the next Section as promising Z^0 explanations of the R_b , R_c anom alies.

4 The -model

A swe noted in Section 1, E_6 is a natural, and for our purposes, m inim al, choice for a simple GUT group containing extra U (1)'s. In addition E_6 appears as an underlying feature in m any geometric compactic cations of the E_8 E_8 heterotic string. In either case, the list of possible subgroups into which the E_6 can break is small and well-de ned.

Since E_6 is rank-6, its Cartan subalgebra contains two U (1) generators besides those of the SM gauge groups. At scales just above the electroweak scale, the additional gauge sym m etry could appear either as a commuting U (1)⁰ factor (as we have been assuming up to this point) or as a unication of the SM groups into some non-Abelian group (e.g., SU (4)_c SU (2)_k SU (2)_k). The latter choice cannot describe

the physics at LEP since it cannot be leptophobic. Returning to the form er, we can write the new U $(1)^0$ as a combination of the two extra U (1)'s in E₆, usually denoted as U (1) and U (1):

In Table 4 the charges Q and Q are given for each of the states of the M SSM using the standard embedding into the 27.

No linear combination of U (1) and U (1) is completely leptophobic. The best one can do is to nd models for which the axial coupling of the charged leptons is zero. Since the vectorial contributions for charged leptons appear proportional to 1 $4\frac{2}{5}$ ' 0:07, the Z⁰ coupling to charged leptons could be highly suppressed with respect to the hadronic couplings. However, such models would necessarily have couplings to the neutrinos of order the hadronic couplings. If, after Z -Z⁰ m ixing the net e ect were an increase in inv at LEP, the model could be quickly ruled out. On the other hand, if inv were to decrease, one could in agine that some new source of invisible Z -decays (e.g., neutralinos) could o set the di erence. We consider such a scenario to be ne tuned and do not consider it here.

However, as was discussed in Section 2.1, in an arbitrary U (1)_a U (1)_b model, there is one more free parameter, a mixing parameter g_{ab} for the two groups. In the case of the breaking of some uni ed gauge group, G_{GUT} , at some high scale into G_{GUT} ! SU (3)_c SU (2)_b U (1)_b U (1)^b, the value of g_{ab} will be zero at the high

scale. Nonetheless, through its RGE's, Eq. (24), g_{ab} will be driven to non-zero values for generic particle content. The elective coupling to the Z⁰ is then $Q_e = Q^0() + Y$ where $= g_{ab} = g^0$.




Figure 4: ² contours for general E_6 m odels. The two contours represent condence levels of 95% and 99%. Three canonical E_6 m odels are labeled at the bottom. The two points highlight the -m odel with = 1=3 () and = 0.29 (4).

From the low-energy point of view, is a completely free parameter which must be t to the data just as we did or . Therefore, we have repeated the ² analysis of the previous Section; however the charges of the SM fermions are now completely determined in terms of instead of x and y. Figure 4 is a ² plot in the plane of (;) showing the ts to the LEP data at 95% and 99% C L.At each point in the plane, the ² value is minimized with respect to the remaining two free parameters, and . A long the bottom of the plot are indicated the values of consistent with the , ,

and models (= 0, =2, $\tan^1 5=3'$ 0:91 respectively) commonly discussed in the literature. All previous discussions of these models (with the exception of Ref. [23]) have tacitly taken = 0.

W hat is remarkable about the t is that it picks a very particular model out, for a limited range of . To fall within the 95% C L. region (2 14:1), a model must have = 0:89 0:06 and = 0:35 0:08. Recall that the SM has $a^2 = 22:8$ in the same parameterization. Only one model lies within the region of allowed : the so-called -model. The charges of the M SSM states under U (1) are given in Table 4.

That the best t in the (;) plane lies at $Q^0' Q$ and '1=3 is not surprising. The elective charge $Q_e = Q + Y=3$ is completely leptophobic; in fact it is the only

combination of the three Abelian generators in E_6 which is leptophobic³. Note that the Q charges of the lepton doublet L and the lepton singlet e^c are proportional to their hypercharges. Thus, U (1) is uniquely picked out as capable of describing the new physics at LEP. In Figure 4 we have shown the = 1=3 -m odel with a cross.

If $U(1)^0$ is indeed U(1), there are a number of direct consequences both for theory and phenom enology. First, U(1) does not t into any GUT group smaller than E_6 . Thus, if the unication of the gauge couplings at a scale near 10^{16} GeV is not an accident, it indicates either a true eld-theoretic E_6 GUT (and no SU (5) or SO (10) unication) or string-type unication in which SU (3) SU (2)_L U (1)_K U (1) unices directly at the scale M_{MSSM} = 2 10^{16} GeV. Second, cancellation of the anomalies in Eqs. (34) { (37) requires the existence of three complete 27's of E_6 . Besides the usual states of the MSSM, one can expect three pairs of D and D[°] quarks which are SU (2)_L singlets with Y = 1=3, two additional pairs of SU (2)_L doublets with Y = 1=2, three right-handed neutrinos, $_{1}^{\circ}$, plus SM singlets (at least one of which will receive a vev to break U (1) and will be eaten by the Z⁰).

We can now write them assmatrix of the Z -Z⁰ system . Dening tan $hH_u i = hH_d i$

and g to be E $_6$ -norm alized, the o -diagonal element in the mass matrix is given as in Eq. (12):

where the last equality holds for the case where the only SU (2)_L doublets with non-zero vev's are H_u and H_d. For the completely leptophobic -m odel (i.e., = 1=3), and $_{\rm M}$ are then simply

Unfortunately, such a relationship between $_{M}$ and does not provide a very good t to the data except near the unphysical value of tan '0:6; the best t consistent with Eq. (52) and tan > 1 has ² of 22.0, not much better than the SM ² = 22.8. There is a second related problem : since m ² M_{z}^{2} and we expect (in the absence of tuning) for the Z⁰ m ass to be only som ewhat heavier, we should expect large m ixing angles to result. This is generic problem of U (1)⁰ m odels where the U (1)⁰ is expected to be radiatively broken close to the weak scale [24].

The solution to both problems involves the introduction of additional SU (2)_L doublets, charged under U (1)⁰, which receive vev's near the weak scale. In our case these will play several roles: arranging the -functions of the model to unify at the GUT scale, allowing for small by cancelling the H_u contribution to m², likewise decoupling _M from , and driving > 0.

Consider, for example, extending the minimal -model to include the pair of doublets which t into the [78;16 + $\overline{16}$;5 + 5] of \mathbb{E}_6 ;SO (10);SU (5)], with the doublet in the 5 getting a vev, v, near the weak scale. Then in the leptophobic -model, m² / ($v_z^2 \sin^2$ v_z^2). If a near cancellation can be arranged between the two terms in m², then smallm ixing will result and simultaneously M as needed phenom enologically. Since M²_Z / ($v_z^2 + v_z^2$) and we need v_z and v of the same order, the H iggs vevs, v_u and v_d , which give masses to the fermions will be proportionally smaller. In the case v_d v_u v, the large top-bottom mass ratio is natural and the top Y ukawa is of the same size as one would expect in the M SSM with tan = 1. This is actually still below the top Y ukawa infrared pseudo- xed point, which now takes a larger value (h_t^{xed} / 125) because of the slow running of s in this model.

Imposing on the superpotential of the minimal -m odel a discrete Z_2 symmetry (a simple extension of the usual R-parity) one nds:

Under the R-parity, all the states of the 27 are odd except H_u , H_d and S. This superpotential forbids dimension-4 proton decay; dimension-5 operators are also known

to be unobservably small in the -m odel [25]. There appears in the superpotential a Yukawa mass term for the right-handed neutrino elds, L $^{c}H_{u}$. To be consistent with current neutrino mass bounds, this coupling must be small or zero or the c must have large M a jorana mass term s through some singlets. By ipping the R-parity assignment of the c one can forbid the term altogether, but at the price of introducing into the superpotential the term $^{c}D d^{c}$. Such a term would lead to D $-d^{c}m$ ixing were c to receive a non-zero vev.

O ne can also expect radiative symmetry breaking much as in the M SSM. If the SD D $^{\circ}$ coupling is O (1), the soft mass term for the S - eld, m $_{\rm S}^2$, will be driven negative through its RGE's, triggering U (1) -breaking through hSi $\stackrel{6}{\bullet}$ 0 at a scale just above the electroweak scale. (The electroweak symmetry will similarly be broken by m $_{\rm H_u}^2$ running negative due to the large top Yukawa coupling.) Since the singlet S has no electroweak interactions unlike H $_{\rm u}$, it is conceivable that the mass-squared of the S elds turns negative at a larger momentum scale compared to H $_{\rm u}$. The non-zero hSi will in turn produce a H $_{\rm u}$ H $_{\rm d}$ and a $^{\circ}$ D D $^{\circ}$ term . For SH $_{\rm u}$ H $_{\rm d}$ and SD D $^{\circ}$ couplings of O (1), one expects ; $^{\circ}$ M $_{\rm Z}$. In particular, it is natural for the D and D $^{\circ}$ states to be heavier than the Z . F inally, we note that there is no mechanism within the -m odel for $^{\circ}$ to receive a vev radiatively which does not violate some other constraint (such as neutrino m ass bounds) [25]. Thus D -d^{\circ} m ixing will not occur.

The -m odelwith only three 27's of E_6 does not satisfy all of our initial principles because it does not have gauge coupling unication. As mentioned above, unication can be arranged by introducing one pair of SU (2)_L doublets with hypercharges $\frac{9}{5=3}Q_Y = \frac{1}{2}$. From a string point of view, these may be viewed as coming from a $\overline{27} + 27$ or a 78, the rest of whose states received masses at the string scale [26]. This, along with anomaly cancellation considerations, requires the doublets to have equal and opposite Q. If these doublets also have non-zero elective charges Q + Y, their vev's may contribute to the Z -Z⁰ m ixing matrix as outlined above. A problem may potentially arise in trying to generate vev's for these doublets radiatively; one possibility is to allow couplings of the type H_uH⁰_d through singlets.

(Thism odelhas, beyond the spectrum of the MSSM, three each of (3;1) and $(\overline{3};1)$ and six of (1;2). This is exactly the content of three $(\overline{5} + 5)$'s of SU (5). Note that in terms of the charge ratio y=x, the purely leptophobic (= 1=3) -m odel is equivalent to M odel A of Section 3. However, the presence of kinetic mixing (\notin 0) induces contributions to the oblique electroweak parameters not present in M odel A. A lso unlike the purely leptophobic models of that Section the value of in the -m odel is generically not 1=3, but is instead determined through the RGE's and thus through the low-energy spectrum. Further, its -function is substantially sm aller than that of M odel A with a single $(\overline{5} + 5)$, since for the -m odel the anom aly cancellation is generation by generation, providing a more econom ical set of charges.)

There are two variants of the -m odel for which the value of at the electroweak scale is of particular interest: (i) The m in in al" -m odel that possesses three generations of 27's and one additional vector-like pair of H iggs doublets that arises from

the 78 of E₆. These doublets have charges $5=3Q_Y = 1=2$ and 215Q = 6 under the GUT-normalized U (1)_Y U (1) symmetries; (ii) The \maximal" -m odel with in addition to the states of the minimal -m odel a further elective $\overline{5} + 5$ of SU (5) is added (so that unication is preserved), but which is composed of a second vector-like pair of the doublets in the 78 together with the color triplets D + D coming from the $27 + \overline{27}$. The maximalm odel has the largest eld content consistent with perturbative unication of the gauge couplings at 2 10^{16} GeV. The values of the charge inner products B_{ij} for these two models are given in Table 5. The eld content of both these models is consistent with small m² in the Z-Z⁰ mass matrix.

Running the SM couplings up to the uni cation point and then num erically running the RGE's of Eq. (24) for g_Y , g and g_Y down to the electroweak scale, we nd predictions for in the two models:

Both of these are calculated with $_{s}$ (M $_{z}$) = 0:120. Larger values of $_{s}$ (M $_{z}$) lead to a slight increase in the values of compared to Eq. (54). The threshold corrections to

com ing from m ass splitting of the light states are typically of order 0.01. It is quite rem arkable that the totally leptophobic value of = 1=3 is very nearly predicted by the renorm alization group running of the $\maxim al$ " -m odel. From the one-loop RGE 's, the value of the U (1) gauge coupling at the electroweak scale is g = 0.40.

Given these values of we can now investigate how well the -m odel variants can t the LEP data. As discussed in Section 2.2 we will consider both the case of $S_{extra} = 0$ and $S_{extra} = 0.14$ per pair of higgsino/lepton-like doublets. We will take $_{extra} = 0$. The minimal model is clearly disfavored by the data, having a 2 no better than the SM for both values of S_{extra} . Likew ise the maximal model has 5 doublet pairs giving $S_{extra} = 0.7$ and a minimum $^{2} = 13.9$ at a Z⁰ m ass of 215 GeV; this is within the 95% C L. bounds shown in Figure 4, where the model is indicated by a triangle. At the minimum, S $S_{M} + S_{extra} = 0.1$. Note that the goodness of the t does not depend strongly on the exact value of S_{extra} in the range 0.5 to 1.5; in particular the resulting S only varies within the range 0.1 to 0.1.

Given g and the bounds on $_{\rm M}$ and we are in a position to calculate the bounds on the Z⁰ m ass, using Eq. (13). For the -m odel with = 0.29, we nd that in order to fall within the 95% (99%) C L. lim its for our t, then M $_{\rm Z^0}$ 240 (420) G eV, under the assumption of no additional contributions to $\overline{}$. (New positive contributions to




Figure 5: ² contours for the -m odel with = 0.29 in the $\overline{(; M)}$ plane. See caption of Figure 2 for explanation. A dditional positive contributions to $\overline{(; M)}$ reduce the best t value of the Z⁰m ass.

⁻, which are natural in these models, push the best t Z 0 mass to lower values.) These ts are shown in Figure 5. UA 2 has performed a Z 0 search in the dijet channels, excluding a Z 0 with 100% branching fraction to hadrons and SM strength interactions up to masses of 260 G eV [22]. However, given the value of g = 0.4 and the U (1) charges of the quarks, one can show that the production cross-section for this Z 0 is approximately 1/4 that of the Z, too small to be excluded at UA 2.

W hat is remarkable about this analysis is that the -model, which has been extensively studied in the literature and for which strong bounds on its mixing with the Z and its mass have been published, has been resuscitated by the inclusion of the additional U (1) kinetic mixing e ect. This is even more so, since the value of is correctly predicted in speci c models in which only one discrete choice of matter content has been made!

5 Conclusions

In this paper, we have investigated the possibility of explaining the R_b excess { R_c de cit reported by the LEP experiments through Z -Z⁰ m ixing e ects. We have constructed a set of models consistent with a restrictive set of principles: unication of the SM gauge couplings, vector-like additional matter, and couplings which are both

generation-independent and leptophobic. These models are anom aly-free, perturbative up to the GUT scale, and contain realistic mass spectra. Out of this class of models, we not three explicit realizations (the , C (7/5), and C (1) models) which t the LEP data to a far better extent than the unmodi ed SM or MSSM and satisfy all other phenom enological constraints which we have investigated. The -m odel is particularly attractive, com ing naturally from geom etrical com pactications of heterotic string theory. This is especially so since the value of the mixing parameter, , is correctly predicted given only one discrete choice of matter content.

In general, these m odels predict extra m atter below 1 TeV and 2^{0} gauge bosons below about 500 GeV, though the 2^{0} of these m odels will be di cult to detect experim entally.

N ote A dded

A fter this work was completed two further interesting works concerning the experimental consequences of leptophobic U (1)'s appeared [28][29]. These papers noted that there can exist important low-energy constraints on leptophobic models arising from atom ic parity violation (APV) and deep-inelastic neutrino scattering experiments. In particular, Ref. [28] argued that the aesthetically appealing models that we have constructed in this paper are strongly disfavored by the APV data. W hile this is usually true in the heavy Z⁰ m ass approximation that we have been employing up to now, this conclusion does not hold in the very interesting case of a light Z⁰ $M_{Z^0}^2 > m_Z^2$), as we will now outline.

The APV experiments result in constraints on the so-called weak nuclear charge Q_W of various elements such as Cesium and Thallium with high atom ic and neutron numbers Z and N. The charge Q_W is itself de ned in terms of the product of the axial electron coupling with the up and down type quark vector coupling via $Q_W = 2 fC_{1u} (2Z + N) + C_{1d} (Z + 2N) g$ where

In the case where the M $_{z^0}$ m $_z$, both Z_1 and Z_2 exchange contribute to the coe – cients C_{1i} . In the approximation where the mixing is small 1, but no expansion is made in the mass ratio r ($m_z^2 = M_{z^0}^2$), the expression for the C_{1i} 's is

$$C_{1i} = v_i + v_i^{\circ} (1 r);$$

where the v's and $\overline{}$ are de ned in Eqs. (4) and (9) respectively. It is therefore clear that the constraint from the APV data becomes vacuous as r! 1. Speci cally, we nd that the APV data do not signi cantly increase the total 2 for Z⁰m asses below about 150 GeV.

O nem ay similarly consider the e ect of a leptophobic Z 0 on the neutrino scattering experiments. We not that the parameters $"^{i}_{L}$ and $"^{i}_{R}$ de ned in Ref. [30], are altered by an amount

respectively. Thus the weaker constraints from the neutrino scattering data also disappear for light to moderate Z $^{0}\,m$ asses.

W e will address the full t including these constraints (as well as the SLC and other data), m ore fully in a forthcom ing paper R ef. [31], where we will also discuss the m odels with variant H iggs structure m entioned in the Section 3 footnote.
