CP phases in models with some ferm ion masses vanishing and/or degenerate

A bstract

We count the number of CP breaking phases in models with $SU(2)_L$ $U(1)_Y$ and $SU(2)_L$ $SU(2)_R$ $U(1)_B$ L electroweak gauge groups and extended matter contents with some ferm ion masses vanishing and/or degenerate. Quarks and leptons, including Majorana neutrinos, are treated in a similar way. CP violation is characterized in the mass-eigenstate and in the weak-eigenstate bases. Necessary and sucient conditions for CP conservation, invariant under weak basis redenitions are also studied in these models. CP violating factors entering in physical observables and only invariant under phase redenitions are discussed.

1 Introduction

CP violation is related to the presence of complex phases in the mixing m atrices describing the gauge couplings in the mass-eigenstate basis. (We do not consider other (Higgs) sources of CP violation.) However, not all phases in the mixing matrices are CP violating. Some of them can be elim inated rede ning the ferm ion phases. In the standard model with three nondegenerate quark families the six phases de ning the 3 3 unitary mixing matrix reduce to one after an appropriate ferm ion eld phase rede nition. This was rst realized by Kobayashi and Maskawa [1] and it is the simplest way to account for the observed CP violation [2]. In general if there are degenerate ferm ion m asses, the number of CP violating phases is further reduced. In the standard model with three massless neutrinos the six phases dening the 3 3 unitary m ixing m atrix in the lepton sector can be elim inated. As a m atter of fact not only all the phases but the three realm ixing angles are non-physical. There is no mixing between lepton families and the three lepton numbers are conserved. These two cases are extreme, non-degenerate quark masses and degenerate and vanishing neutrino masses. Here we will examine the interm ediate case. We allow for an arbitrary number of standard families and M a prana neutrinos with some ferm ion masses vanishing and/or degenerate. We consider models with the standard gauge group SU (3)_C SU (2)_L U (1)_Y and with its left-right extension SU (3)_C SU (2)_L $SU(2)_R$ tum. A lthough the number of CP violating phases is more easily counted in the mass-eigenstate basis, CP violation can be also discussed in the weakeigenstate basis [3, 4]. In this basis the mass matrices are in general nondiagonal and necessarily complex if CP is not conserved. The use of an invariant formulation for CP conservation is more convenient in this case. Necessary (and su cient) conditions for CP conservation can be found which are independent of the choice of basis [5, 6, 7, 8]. If one of these conditions is not ful led, CP is not conserved. However, some of them could be trivially satis ed if som e ferm ion masses are vanishing or degenerate. We study this possibility in simple cases. In Section 2 we count the number of CP breaking phases in SU (3)_C SU (2)_L U (1)_Y gauge models with some vanishing

and/or degenerate quark and lepton m asses, including M a jorana neutrinos. $SU(3)_C$ $SU(2)_L$ $SU(2)_R$ $U(1)_Y$ gauge m odels are considered in Section 3. The necessary and su cient conditions for CP conservation are discussed in Section 4 in simple m odels with some vanishing and/or degenerate ferm ion m asses. In Section 5 we comment on the relevance of the invariants under ferm ion phase rede nitions. Section 6 is devoted to conclusions.

2 The standard model with n_L ferm ion fam ilies and n_R neutral ferm ion singlets

The $n_{\rm L}$ left-handed elds transform as SU (2) $_{\rm L}$ doublets, whereas the $n_{\rm R}$ right-handed elds are SU (2) $_{\rm L}$ singlets. Hence, only the left-handed ferm ions interact with the charged gauge boson W .

2.1 The quark sector

Let M $_{\rm u}$ and M $_{\rm d}$ be the $n_{\rm L}$ $n_{\rm L}$ m ass matrices for up and down quarks, respectively, in the weak-eigenstate basis ($n_{\rm L}=n_{\rm R}$). In general they are complex and can be diagonalized by unitary transformations

where $U_{L,R}^{u,d}$ are n_L n_L unitary matrices. Thus, the Cabibbo-Kobayashi-Maskawa (CKM) mixing matrix [1] reads


The matrices $U_{L,R}^{u,d}$ in Eq. (1) are not uniquely determined. We can still perform unitary transformations $V_{L,R}^{u,d}$, which leave unchanged the diagonal mass matrices



How the matrices $V_{L,R}^u$ ($V_{L,R}^d$) look like depends on the properties of (M $_u$) $_{diag}$ (M $_d$) $_{diag}$). Let us assume that (M $_u$) $_{diag}$ ((M $_d$) $_{diag}$) has l_u^0 (l_d^0) vanishing masses, l_u (l_d) > 1 degenerate masses m $_u$ (m $_d$), and n $_L$ l_u^0 l_u (n $_L$ l_d^0 l_d) non-degenerate masses



(analogously for (M $_{\rm d}$) $_{\rm diag}$). Then



where W $_{\mathrm{uL},R}^{0}$ (W $_{\mathrm{uL}}$) are l_{u}^{0} l_{u}^{0} (l_{u} l_{u}) unitary matrices, and analogously for V $_{\mathrm{L},R}^{d}$. Now we can count the number of CP violating phases. The CKM matrix is a n_{L} n_{L} unitary matrix and is parametrized by $\frac{n_{\mathrm{L}} (n_{\mathrm{L}} - 1)}{2}$ mixing angles and $\frac{n_{\mathrm{L}} (n_{\mathrm{L}} + 1)}{2}$ complex phases. Not all of these parameters are physical but we can get rid of the unphysical ones as shown in Eq. (4) with an appropriate choice of $V_{\mathrm{L}}^{u,d}$ in Eq. (6). Although known results [3] can be easily

recovered as we do below, the general case is involved. It looks necessary to treat it with a computer [9].

211. The counting for $\frac{\theta}{d_1d}=0$; $l_{u,d}=0$ is the same as in the non-vanishing, non-degenerate standard case because $V_L^{u,d}$ have the same structure. The number of CP violating phases is equal to the number of phases in a n_L n_L unitary matrix, $\frac{n_L (n_L+1)}{2}$, m inus the number of phases in $V_L^{u,d}$, $2n_L$, plus 1 to avoid double counting of the common phase rede nition

For $n_L = 3$ one recovers the standard model result with one CP violating phase.

where W $_{\rm uL}^0$ is a $(n_{\rm L}-1)$ $(n_{\rm L}-1)$ unitary matrix, and Eqs. (4,6) U $_{\rm C\,K\,M}$ can be made always real, almost triangular and depending only on $n_{\rm L}-1$ m ixing angles. For $l_{\rm d}^0$ or $l_{\rm d}=n_{\rm L}-1$ we use the inverse unitary decomposition to prove that there is no CP violation either.

2.2 The lepton sector

 $n_{\rm L}$ is the number of standard ferm ion fam ilies and $n_{\rm R}$ the number of right-handed neutral ferm ion singlets. Then the charged lepton mass matrix M $_1$ is $n_{\rm L}$ $n_{\rm L}$ and complex, and the neutrino mass matrix M $_1$ is $(n_{\rm L}+n_{\rm R})$, complex and symmetric. They can be diagonalized by unitary transform ations



respectively. The diagonalization conditions in Eq. (9) do not determ ine $U^1_{L,R}$ and U uniquely. One can still perform unitary transform ations which leave unchanged the (diagonal) mass matrices

The form of $V_{L;R}$ and V depends on the ferm ion spectrum (degeneracy). For l_1^0 vanishing, l_1 degenerate and n_L l_1^0 l_1 non-degenerate charged lepton m asses and l^0 vanishing, l degenerate and $n_L + n_R$ l^0 l non-degenerate

The counting of CP violating phases in the lepton sector reduces to count the phases in K because the phases in are not independent (see Eq. (11)). K is de ned by the rst n_L columns of a $(n_L + n_R)$ $(n_L + n_R)$ unitary matrix. Thus it is parametrized by $\frac{n_L (n_L + 2n_R - 1)}{2}$ mixing angles and $\frac{n_L (n_L + 2n_R + 1)}{2}$ phases. But not all of them are physical. Eq. (14) allows to subtract the unphysical ones. The general counting is involved but it can be worked out with a computer [9].

221. If there are no vanishing or degenerate lepton m asses, the number of CP breaking phases is equal to the number of phases parametrizing

If there is one massless neutrino, W 0 is one-dimensional and there is one phase less.

 $2\,2\,2$. If, for instance, $n_{\!\scriptscriptstyle L}=n_{\scriptscriptstyle R}$ and there are $n_{\scriptscriptstyle L}$ m assless neutrinos, the num ber of CP violating phases in Eq. (15) is reduced by $\frac{n_{\scriptscriptstyle L}\,(n_{\scriptscriptstyle L}+1)}{2}$, which is the num ber of phases of the unitary matrix W 0 in V . The subtraction of non-physical phases is more delicate when the $n_{\scriptscriptstyle L}$ neutrinos have a common mass. The real and in aginary parts of K rotate independently because W V is a real orthogonal matrix in this case. Then with an appropriate choice of W $\frac{n_{\scriptscriptstyle L}\,(n_{\scriptscriptstyle L}-1)}{2}$ entries in the $(n_{\scriptscriptstyle L}-n_{\scriptscriptstyle L})$ K upper half can be made real, reducing the number of phases by the same amount. The unitarity constraints and the charged lepton phase redenitions can be chosen to x part of the phases in the K lower half and are already subtracted in Eq. (15). If the $n_{\scriptscriptstyle L}$ massless or degenerate leptons are the charged ones, the number of CP violating phases in Eq. (15) is reduced by $\frac{n_{\scriptscriptstyle L}\,(n_{\scriptscriptstyle L}-1)}{2}$, which is the number of phases in W $_{\scriptscriptstyle L}^0$ or W $_{\scriptscriptstyle L}$ in V $_{\scriptscriptstyle L}$, $\frac{n_{\scriptscriptstyle L}\,(n_{\scriptscriptstyle L}+1)}{2}$, m inus the number of diagonal phases already subtracted in Eq. (15), $n_{\scriptscriptstyle L}$.

223. If $n_L = n_R = 1$ and both neutrinos have a common mass, CP is conserved. K, which is 2-1, depends on 2 complex numbers. With an appropriate choice of the 2-2 real orthogonal matrix W = V the moduli of K_{11} and K_{21} can be made equal. Then redening the charged lepton phase we can always assume $K = \frac{a}{a}$. The phase of a, however, does not stand for CP violation. The lagrangian is invariant under complex conjugation and the interchange of both neutrinos. Similarly for $n_L = 2$; $n_R = 0$, with an appropriate choice of W the moduli of the 2-2 unitary matrix K can be made equal. Then redening the charged lepton phases we can always assume K = 0.

a a . The phase of a does not stand for CP violation either.

The lagrangian is invariant under complex conjugation, the interchange of both neutrinos and the change of sign of the charged lepton in the rst column. If there are the two charged leptons which are degenerate (ormassless), CP is also conserved because in this case V_L in Eq. (14) is an arbitrary 2 2 unitary matrix.

3 Left-right models with n ferm ion families

In this case $n_{\rm L}=n_{\rm R}=n$ and there are left-handed as well as right-handed charged currents.

3.1 The quark sector

W ithout any additional sym m etry M $_{\rm u}$ and M $_{\rm d}$ are arbitrary complex m atrices and the expressions in Section 2 are still valid. However, in addition to the CKM matrix for left-handed currents (see Eq. (2))

Both n n unitary matrices can be rede ned without modifying the (diagonal) mass matrices (see Eqs. (3-6))

The counting of CP breaking phases in U_{CKM}^L is the same as the standard model counting in Section 2.0 n the other hand, the number of CP breaking phases in U_{CKM}^R can be reduced by an appropriate choice of $W_{u;dR}^0$ (see Eq. (6)), for the other entries in $V_R^{u;d}$ are xed by the corresponding entries in $V_L^{u;d}$. However, one may choose to eliminate the non-physical phases in $U_{CKM}^{L;R}$ in a dierent way. What matters it is the combined number of CP violating phases.

3.1.1. CP can be violated in a left-right model even for one family, n = 1, if both quarks are massive. This is so because the phase rede nition in Eq. (18) is the same for U_{CKM}^L and U_{CKM}^R , as there are the same $V_L^u(V_L^d)$ and $V_R^u(V_R^d)$. Thus the number of CP violating phases is 2 1 = 1. Similarly for three generations, n = 3, CP can be broken if there is at least one massive quark of each type.

3.2 The lepton sector

In this sector there are also right-handed currents and there are left- and right-handed mixing matrices (see Eq. (11))

The unphysical phases in K $_{\rm L}$ can be elim inated as in Section 2. The phases in K $_{\rm R}$ can be also elim inated using Eq. (21) but only if there is any freedom left after xing V and V $_{\rm R}$, which is related to V $_{\rm L}$ (Eq. (13)), to reduce the number of K $_{\rm L}$ phases. W hat m atters is the combined number of CP violating phases in K $_{\rm L}$ and K $_{\rm R}$.

32.1. For n=1 there are in general 2 CP breaking phases, of the four phases in K_L and K_R one is xed by Eq. (20) and another one is elim inated by an appropriate choice of V_L ($V_R=V_L$ if the charged lepton has a non-zero mass.) If the charged lepton is massless, V_R is independent of V_L and we can get rid of a third phase. Finally, if one

322. For n > 1 CP can be violated even in the case of n degenerate charged leptons and n m assless plus n degenerate heavy neutrinos.

4 CP sym m etry breaking in the weak basis

In the two previous Sections we have discussed CP symmetry breaking in the mass-eigenstate basis. CP violation can be also studied in the weak basis where gauge interactions are diagonal. CP conservation is then related to the speci c form of quark and lepton mass matrices, M $_{\rm u}$; M $_{\rm d}$; M $_{\rm l}$; M $_{\rm l}$; M $_{\rm l}$, 6, 7, 8]. If these are real, CP is conserved. However, they can be complex and CP be still conserved. This is so because we can perform unitary transformations on the elds which leave unchanged the gauge couplings but rede ne the mass matrices. If there are only left-handed currents, these transformations on quarks and leptons read

These conditions also suggest how to nd other necessary (and su cient) CP invariant constraints which are more useful in practice. In this Section we discuss these constraints when some ferm ion masses are vanishing and/or degenerate (see Section 2,3).

4.1. In the standard model with $n_L = 3$ generations of quarks the necessary and su cient condition for CP conservation is [5, 6]

where m $_{\rm f}$ are the quark masses and U is the CKM matrix. CP can be violated if there is at most one massless quark of each type (case 2.1.1). However, this invariant is identically zero if two up or down quark masses are degenerate (case 2.1.2).

42. For leptons practical, necessary and su cient CP invariant constraints were obtained in Ref. [8] in simple cases . For $n_L=n_R=1$ the constraint for CP conservation is

where m $_{1;2(e;)}$ are the neutrino (charged lepton) m asses and K is the m ixing m atrix. CP is conserved if there is a m assless neutrino (case 22.1) or the neutrinos (charged leptons) are degenerate (case 22.3).

where m $_{1;2\,(e)}$ are the neutrino (charged lepton) m asses and K $_{L\,;R}$ are the m ixing m atrices. CP is conserved if the charged lepton is m assless and there is one m assless neutrino or both neutrinos are degenerate (case 3.2.1). O therw ise, CP can be broken.

As in the form erexam ples we expect that the counting of CP breaking phases in Sections 2,3 will be useful for searching for a set of necessary and su cient, and also practical, CP invariant constraints.

5 Phase rede nition invariants

Physical observables can not depend on ferm ion eld rede nitions. In the mass-eigenstate basis the only ferm ion eld rede nitions left are the unitary transformations in Eqs. (6,13), which leave unchanged the diagonal mass matrices and rede ne the mixing matrices (see Eqs. (4,14,18,21)). Then the corresponding observables can only depend on quantities invariant under these transformations. The simplest of these quantities are

where if i or j stands for a degenerate ferm ion, the sum (as the sum s below) also includes the other ferm ions of the same type with the same mass. O therwise, i and j can be any set of ferm ions and T is any mixing matrix, U;K; . However, these expressions do not depend on any phase, and even if CP is conserved, they are in general non-zero. (Sum s

with $i \in j$ are not invariant because even for non-degenerate M a jorana neutrinos they can transform with a sign (see Eq. (13)).) In left-right models there are also mixed bilinear invariants

where T_L is a left-handed m ixing m atrix, U_L ; K_L ; L, and T_R its right-handed partner, U_R ; K_R ; R. These invariants depend in general on the CP breaking phases. The number of independent CP violating invariants is, of course, nite in speci c m odels. In the left-right m odel in Section 4 with n=1 there are two such invariants (see Eq. (30))

A non-zero im aginary part of these invariants stands for CP non-conservation. In models with only left-handed mixing matrices we have to look for invariants of higher dimensions to observe CP violation. Possible invariants of dimension four are

In the minimal standard model CP violation is characterized by a non-zero imaginary part of one of these invariants, for example (see Eq. (27)) Im $(U_{ud}U_{cs}U_{us}U_{cd})$.

6 Conclusions

We have discussed the number of independent CP breaking phases in models with SU $(2)_L$ U $(1)_Y$ and SU $(2)_L$ SU $(2)_R$ U $(1)_B$ Lelectroweak gauge groups and extended matter contents, paying special attention to the case of vanishing and/or degenerate ferm ion masses. Quarks and leptons, including Majorana neutrinos, are treated in a similar way. We have also revised the necessary and suicient constraints for CP conservation in some simple models. Some of these constraints are identically zero when some ferm ion masses vanish or are degenerate. The knowledge of the number of independent CP violating phases and the study of these particular cases are a useful guide for the search of CP invariant constraints which are not only necessary but suicient for CP conservation. Observables involving well-de ned mass eigenstates depend on factors which are only invariant under phase rede nitions. We study the phase rede nition invariants of lowest dimension.
