H iggs decay into two photons, dispersion relations and trace anom aly

Abstract

We exam ine the contribution of W boson boops to the amplitude of the process H ! within the dispersion relation approach, taking up an issue raised in this context recently. We show that the non-vanishing limit of the relevant form factor for m_W ! 0 is due to a nite subtraction induced by the value of the corresponding trace anom aly. The argument can be turned around and one thus arrives at a dispersive (\infrared") derivation of the trace anom aly.

The decay process H ! occupies an in portant niche in the physics of Standard M odel (SM), and it has been treated in the literature in considerable detail (see e.g.[1] { [6] and further references contained therein). In a recent paper, K omer et al. [7] considered the case of large H iggs m ass and calculated som e twobop contributions to this process, in an approximation relying on the G oldstoneboson (G B) \equivalence theorem " for closed W bops (which presum ably should work in the heavy H iggs lim it { cf. e.g. [8]), and using the technique of dispersion relations. R eproducing rst the relevant one-bop results, the authors [7] pointed out som e peculiar features of such a dispersive calculation, which rem ind one of the \infrared" aspects of the axial anom aly revealed through the in aginary part of the fam ous V V A triangle graph [9], [10]. To put it in explicit term s, let us rst introduce som e notation. Let a (dimensionless) form factor $F_W = F_W (m_W^2 = m_H^2)$ describing the contribution of W boson bops be de ned through

where is the ne structure constant, $v = G_F p - 1^{-2}$ is the electroweak mass scale, and other symbols have an obvious meaning. In what follows we denote the W mass simply as m for brevity. The observation made in [7] consists in the following: If the F_W is calculated within the \G B approximation" by means of unsubtracted dispersion relation, it does not vanish for m_H ! 1 (or, equivalently, form ! 0), while the corresponding in aginary part vanishes in the naive lim it m ! 0. Thus, in the approach [7] one encounters another example of a situation where the suppression factor proportional to a mass is compensated after a pertinent integration; this is indeed closely analogous, at least technically, to the dispersive treatment of the axial anom aly [9], [10] (in particular, a relevant in aginary part becomes proportional to a -function). The lim it recovered in [7] within the GB approximation reads

which coincides with the value given by the exact one-bop calculation [2]. (Need-

less to say, when considering the limit m ! 0, the v is kept xed.)

In this context, one may remember that the SM Higgs boson is coupled to the other elds through the trace of the im proved" energy-momentum tensor [11], i.e. essentially through the corresponding mass terms (this has been noticed already in the classic paper [1]). At quantum level, the trace of the energymomentum tensor is known to be anom alous [12], [13] (i.e. it does not vanish in the massless limit when quantum corrections are taken into account) so one may wonder if the non-zero value of the limit (2) could be related to the well-known trace anom aly.

In the present note an attempt is made to elucidate this issue. We exam ine the dispersion relation (DR) approach to the relevant Feynm an graphs and show that the limiting value (2) is determined by a \sum rule" for the imaginary part of the W boson bops together with the value of the corresponding contribution to the trace anomaly. Later on we will also comment on the G oldstone boson approximation used in [7]. The order of the argument may then be reversed to arrive at a dispersive (\infrared") derivation of (the vector boson contribution to) the trace anomaly. Throughout our discussion we restrict ourselves to one-bop diagram s.

Let us start with an explicit expression for the in aginary part of the form factor F_W (de ned by eq.(1)), corresponding to W loops in the unitary gauge. This can be calculated by m eans of the Cutkosky rules which give the discontinuity associated with the standard cut (4m²;1) w.r.t. kinem atical variable $t = (k + p)^2$ (see g. 1). One gets

fort > 4m², where we have denoted $r = (1 4m^2=t)^{1=2}$. O focurse, the expression (3) coincides with that contained in the widely quoted result for the F_W (cf. e.g. [4], [5]), obtained rst in [2] by a direct Feynm an graph calculation. We refer here to the alternative calculation via Cutkosky rules since one would like to avoid any explicit ultraviolet regularization when adopting the DR approach. With the

im aginary part (3) at hand, one m ay try to evaluate the complete form factor by m eans of a dispersion relation. Let us consider st the unsubtracted form

for an arbitrary value of $q^2 (= m_H^2)$. In view of (3) it is clear that the integral in the last expression is convergent (re exting thus the fact that the total contribution of considered loops is ultraviolet nite in a renorm alizable theory) but one may worry about possible nite subtractions in the considered DR if one wants to reproduce the result of the direct Feynm an diagram calculation [2]. It turns out that such a subtraction is indeed necessary (in contrast with the scalar-loop m ethod adopted in [7]), and its value may be deduced from the W loop contribution to the trace anom aly. To see this, let us consider the lim it of F_W (q^2 ;m²) for q^2 ! 0.0 ne gets

and the integral in the last expression is easily evaluated to give

$$\frac{1}{2} \int_{4m^2}^{Z} Im F_W t; m^2 \frac{dt}{t} = 5$$

On the other hand, the value of F_W (0; m²) is xed by a low-energy theorem (see [1] { [4], [6]), which leads to the conclusion that such a quantity is equal to the coe cient b_W of the -function associated with charge renormalization (due to the charged W bosons in the present context) defined by

Let us emphasize that this is precisely the point where the trace anom all enters the picture: In view of the structure of the SM Higgs couplings, the quantity F_W (0;m²) actually describes a two-photon matrix element of the trace of the energy-momentum tensor (cf. [1]) and this in turn is determined by the relevant - function (see [13]). At one-loop level one has $b_W = 7$ (see [2] and also the

recent paper by K niehland Spira [6]), so we get a \boundary condition" for the DR representation of the form factor F_W :

C om paring now the last result with (5), (6), it is seen that the sum rule (6) does not saturate the value of the trace anom aly manifested in (8); it means that one has to include a nite subtraction in the DR representation of the F_{W} , namely

Using (3), it is not di cult to prove that

$$\lim_{m ! 0} F_{W}^{(un)} q^{2}; m^{2} = 0$$

From (9) and (10) the lim it (2) then follows immediately.

It is worth noticing that one has to make a nite subtraction in the dispersion relation for W boson bops in the unitary gauge even though the relevant integral is convergent (for example, no such subtraction is needed for the contribution of a ferm ion bop to the same process). In a sense, the reasoning presented here bears some resemblance with the dispersive treatment of the axial anom aly: W hen adopting the usual tensor basis for the VVA triangle graph [14], one also has

to include nite subtraction in a convergent dispersion integral for the relevant form factor if the axial anom aly is to be reproduced correctly (or, in other words, if the vector current is to be conserved).

Let us now return brie y to the observations made in [7]. In fact, the technique of \G B approximation" employed in [7] enables one to reform ulate the preceding discussion concerning the trace anom aly in the following way. The contribution of W boson bops may be calculated in a renormalizable ('t Hooff-Feynman) gauge. For $m_{H}^{2} = m^{2}$, the contribution of the unphysical (Goldstone) scalar counterparts of the W is supposed to be dominant and the leading contribution to the form factor F_{W} is evaluated by means of unsubtracted dispersion relation

where, according to [7]

with r being de ned as in (3). Note that the factor of $m_{\rm H}^2$ in the last expression comes from the coupling constant for the interaction of the unphysical G oldstone scalars with physical Higgs boson. (To avoid confusion, let us also stress that the result (12) does not correspond to the expression for \physical" scalar bops usually quoted in the literature | see e.g. [4], [5] | precisely because of a di erent dependence of the relevant coupling constants on the masses involved.) In the limit m ! 0, the expression (12) becomes 2 $m_{\rm H}^2$ (t) (in striking analogy with the calculation of the axial anom aly due to D olgov and Zakharov [9]) and using (11) one then arrives immediately at the result (2). In such a way, the GB approximation provides a natural \infrared" explanation for the nite subtraction in (9): Thism ay be understood as a contribution of unphysicalG oldstone bosons (or, equivalently, of the longitudinal degrees of freedom associated with massive W bosons). Now, with a simple interpretation of the subtraction constant in (9) at hand, one may invoke the sum rule (6) to recover eq.(8). Thus, from this point of view we have an alternative derivation of the \canonical" value of the

W boson contribution to the trace anomaly in terms of dispersion relations and \infrared " properties of the relevant one-loop graphs. O fcourse, such an analysis has one obvious aw: It is not clear a priori that the unsubtracted DR in (11) is the correct form | in fact it is an \educated guess" which, strictly speaking, is only justiled in confrontation with other results. Let us also remark that the G oldstone-boson equivalence theorem has been proved rigorously for the external vector bosons [15] (see also [16] for a recent reference), while its applicability for closed bops of massive vector bosons has only been tested on some specil c examples (cf. e.g. [8]).

In concluding, let us sum marize brie y the preceding considerations. W ithin the dispersion relation approach to W boson loops (in the unitary gauge) the zero-m ass lim it (2) of the form factor F_W is determined by a nite subtraction, which is needed for reproducing the correct value of the trace anom aly xed by a well-known low-energy theorem. In this way, the result (2) emerges as the di erence between the anom aly value and a sum rule for the in aginary part of the F_W (see (5)). On the other hand, using the approximation invoked in [7] one gets an \infrared" interpretation of the lim it (2) as an elect of the (would-be) G oldstone bosons associated with the W. Thus, the previous reasoning can be turned around: U sing the insight provided by the G B approximation [7] together with the sum rule (5), (6) one arrives at an alternative (dispersive) derivation of the W boson contribution to the trace anom aly.
