# H igher-tw ist quark-m ass contributions to deep-inelastic scattering

#### Abstract

In this letter we extend the factorization procedure of the deep-inelastic hadron tensor, proposed by $Q$ iu, to include non-zero quark $m$ asses. The $m$ anifest gauge invariance of both soft and hard parts is preserved. U sing a so-called spurion to generate the quark-m ass term $s$, the sim ple parton $-m$ odel interpretation is also kept. T he calculation of the deep-inelastic transversespin structure function $g_{2}$ is used to ilhustrate the algorithm .


Them asses of the light quarks are $s m$ all as com pared to the typicalhadronic $m$ ass scales. $T$ herefore, in $m$ ost calculations of deep-inelastic scattering (D IS) structure functions they are neglected. In som e cases, how ever, this is not allow ed. A notorious exam ple is $g_{2}$ of a free quark target at tree-level $\left.{ }_{[1]}^{1}\right]$. In that case the tw ist-three quark-m ass term exactly cancels the tw ist-two contribution, yielding $g_{2}=0$. In general, if the ratio $m=M$ is not negligible, one is foroed to keep the quark-m ass contributions.

Let us recapitulate som e historic facts. In Ref. proach to unravel the pow er corrections in $1=Q$ for a w ide class of hard scattering processes. Thism ethod was fully em ployed for the deep-inelastic scattering process by E lis, Furm anski, and Petronzio (EFP) in Ref. [3़1], in which they calculate the tw ist-four corrections to the unpolarized structure fiunctions. Thereto they factorize the diagram $s$ in hard, i.e. perturbative, and soft, ie. non-perturbative, parts. A n essential ingredient in their calculation is the expansion of the parton $m$ om enta around the target $m$ om entum direction, called the collinear expansion. U sing low -energy $W$ ard identities they show that in allm atrix elem ents the gluon eld com bines with a derivative to precisely the covariant derivative. C olor gauge invariance is then $m$ anifest upon inclusion ofso-called link operators. E lectrom agnetic gauge invariance of the hard scattering parts is not $m$ anifest in their approach. $M$ atrix elem ents $w$ th a de nite parton num ber contribute at di erent orders in $1=Q$.

It was Q iu in Ref. [īi $]$ who show ed that, if one uses the concept of the special propagator, one can factorize such that a com plete separation of the hard parts betw een di erent orders in $1=Q$ can be obtained. H ence, the electrom agnetic gauge invariance of these hard parts is $m$ anifest. M oreover, only $m$ atrix elem ents $w$ th a xed num ber of partons contribute to a particular order in $1=Q$. This fact also enables a clear parton $-m$ odel interpretation of the higher-tw ist term s.

Both EFP and $Q$ in neglect quark $m$ asses. Our goal is to include them in such a fashion that both color and electrom agnetic gauge invariance rem ain m anifest. The basics of the $m$ ethod are as follow $s$ : in addition to the collinear expansion, em ployed by EFP, we include a quark -m ass expansion. Q iu's factorization can be extended as well. In order to preserve the parton interpretation we em ploy a spurion particle [h] $]$, which couples only to the ferm ions. $T$ he spurions $w$ ill generate the $m$ ass contributions. O ne $m$ aintains the three advantages of com bining EFP and Q in's techniques, nam ely, (1) the use of color gauge invariant $m$ atrix elem ents only, (2) m anifest electrom agnetic gauge invariance of the hard scattering parts, and (3) a clear parton interpretation at all tim es, also beyond leading order, i.e., each order of pow er suppression $m$ eans taking into account correlation functions $w$ th one parton $m$ ore, where only the good elds [ब్ర-1] contribute.

The algorithm is best explained by applying it to a particular case, therefore we look at polarized D IS up to and including order $1=Q$ (see Ref. $\left[\begin{array}{l}i \overline{1}]\end{array}\right.$ and the references therein). The EFP approach in this context was rst applied by Efrem ov and Teryaev [ibin.

The starting point is the fam iliar diagram $m$ atic expansion of the forward scattering am plitude $T$ (we consider only quarks of one avor for the $m$ om ent)

keeping only the term $s$ contributing up to order $1=Q$. Here, $S$ and are the hard and soft scattering parts, respectively. W e will not consider Q CD corrections, so the hard parts consist ofthe forw ard parton-photon scattering tree graphsw hich are one-particle-irreducible
after shrinking the two photon vertioes to a point. W e indicate explicitly their dependence on the parton $m$ om enta and $m$ asses, but not on the photon $m$ om entum $q\left(q^{2}=Q^{2}\right)$. The soft parts are de ned as

N ote that we have included a color identity and $g$ tim es ta , respectively, from the hard into the soft parts. Thereby the hard parts e ectively becom e Q ED graphs w ith unit charge kival.

The nucleon is characterized by its $m$ om entum, satisfying $P^{2}=M^{2}$, and its spin vector, satisfying $S \quad P=0$ and $S=1 . W$ em ake a Sudakov decom position of the relevant vectors $w$ ith respect to two light-like vectors $p$ and $n$, satisfying $p \quad n=1$,

Here, $x_{B}=Q^{2}=\left(\begin{array}{ll}2 P & q\end{array}\right)$ is the $B$ jorken variable, is the nucleon's helicity, $I$ its transverse spin. A lso, $x$ is the quark's longitudinal $m$ om entum, $k_{T}$ its transverse $m$ om entum . Since target $m$ ass corrections are $1=Q^{2}$ suppressed, we ignore them .

The next step is perform ing a collinear and $m$ ass expansion of the hard parts (keeping only relevant term s):

where the right-hand side of Eq. ( $10-10)$ is e ectively obtained from $S \quad(k ; m)$ by insertion of a zero-m om entum gluon, w th coupling $i i_{i j}$ to the ferm ions. O ne can restore color gauge invariance of these de nitions by introducing path－ordered exponentials called link operators．In the gauge n $A=0$ ，these links becom e unity，if the paths are chosen along the n－direction．In Ref．$\left.{ }_{[1,1}^{\overline{1}}\right]$ it is shown that the ghons in the $p-$ direction，ie．，of the form（ $n$ A）p，can be pulled into the tw o－parton am plitude，generating a link operator，show ing that the gauge n $A=0$ is inessential and color gauge invariance can alw ays be achieved．

The rst term in Eq．（ $\overline{1} \overline{2}$ ）contributes to order $(1=Q)^{0}$ and higher，whereas the latter term s contribute to order $(1=Q)^{1}$ and higher．The new ingredient due to $Q$ in the splitting of the di erent term $s$ into parts which contribute at a speci c order in $1=Q$ ． Let us illustrate how this can be done．The D irac trace in the rst term in Eq．（īiz）can be F ierz decom posed according to
where we used the fact that in the hard part $m=0$ ，such that chirality is conserved．The vector term contributes to the unpolarized scattering only，so we discard it．W e make a Sudakov decom position of the axial－vector projection of the soft part，
 is $Q$ ，whereas the soft parts are assum ed not to contain large scales．This，in com bination $w$ th the fact that $p$ has dim ension 1，and $n$ dim ension 1，leads to the observation that the rst term is the leading one，while the second and third are $1=Q$ and $1=Q^{2}$ suppressed， respectively，so we discard the last one．

The essence of the above derivation is that an frills out a good quark（or anti－quark） from the soft part，whereas a 6 pulls out a special propagator，a good quark，along w th a good ghon or（for non－zero quark $m$ ass）spurion．N ote that for the last trace in Eq．（1in） this im plies the inclusion of four－parton am plitudes，leading to $1=Q^{2}$ suppression．

In order to undo the F ierz decom position，Eq．（1］－1 $\overline{-1})$ ，we use the follow ing relations：

Retuming to the second and third term sin Eq．（12i），from dim ensional argum ents one can again infer that only good elds contribute at leading order．So we m ay include pro jectors in between the hard and soft parts．The crucial step in the $Q$ in factorization is to absorb everything above the projectors into the upper，hard，part（see Figs．＇1，1 and＇ leading order this has no consequences．At sub－leading order，how ever，the m odi ed hard gluonic and spurionic parts read

These results are in agreem ent with the
 di erence. The algorithm can be sum $m$ arized as follow $s$. To obtain the regular contributions
 forw ard 2 -photon $t$-parton cut diagram $s$, where partons can be quarks, antiquarks or gluons; (2) replace allpropagators that do not lie betw een the photon vertioes by specialpropagators; (3) project out the good eldsti, and couple them with t-parton soft m atrix elem ents. The quark m ass term s follow in the sam e way, except that one (orm ore) of the gluon legs that connect hard and soff parts is replaced by a spurion. In the hard parts the partons are kept m assless.

W e have also applied the $m$ ethod to one-hadron-production in $e^{+} e$-annihilation, which essentially only di ers from the above by the fact that the photon $m$ om entum is now tim elike and the distribution functions have to be replaced by fragm entation functions (indicated w ith a hat, e.g., $\mathcal{g}_{\mathrm{T}}^{a}$ ). W e can again express the sub-leading structure function (denoted by $g_{1}+g_{2}$ ) in term $s$ of $g_{T}^{a}$ only, that is, without explicit $m$ ass term $s$. This result di ens from Eq. (38) of Ref. $[1]=1]$, in which $Q$ iu's factorization is also applied, by quark-m ass term s (accom panied by the fragm entation function $\hat{\mathrm{h}}_{1}^{a}$ ). O ur claim is that these term s should not be present.

In this letter we have extended the form alism by Q iu, leading to a factorization of hard and soft scattering parts in a manifestly gauge-invariant way, to include non-zero quark $m$ asses. W e have illustrated the $m$ ethod for polarized D IS at sub-leading order. A nother interesting application would be the calculation of the quark-m ass contributions at tw istfour in unpolarized D IS [ī13]. A lso, one should investigate whether the form alism can be extended to include QCD corrections. W ork in this direction is in progress.
